At this time I will ask approval for 16 17 the minutes from Thursday, April 7, 2011 and 18 Thursday, April 14, 2011. COMMISSIONER WHITE: So moved. 19 20 COMMISSIONER STEWART: Second. 21 COMMISSIONER WARFIELD: It's been 22 properly moved and seconded. All those in favor? 23 COMMISSIONERS: Aye. 24 COMMISSIONER WARFIELD: All those



opposed? Motion carries. At this time I want to

1	announce that the Board of Police Commissioners'
2	office will be closed on Friday, April 22, 2011
3	due to the Good Friday holiday and will be closed
4	also on Monday, April 25, 2011 due to the budget
5	furlough days. The office will re-open on
6	Tuesday, April 26, 2011.
7	Is there a Secretary's Report, sir?
8	SECRETARY ANTHONY: Yes. For the
9	record, George Anthony, Secretary. This is the
10	Citizen Complaint Report. These are for
11	complaints that have been received in March of
12	2011.
13	In 2011 the monthly count of complaints
14	were 143 which represents a 13 percent decrease
15	over the same over March of 2010 which was
16	165.
17	Our year-to-date numbers for 2011 are
18	341 which is a 10 percent decrease over the same
19	period last year of 381. At the end of March,
20	2011 the Office of the Chief Investigator had
21	active investigations of 308, cases that were
22	filed 341 and cases that were closed through
23	March of 2011 548.
24	Of the 143 cases that were filed in



25

March of this year 38 percent involved unknown

1	officers. Of the alleged known units involved in
2	the complaints filed in March of this year the
3	Eastern District had 9 percent while the 12th,
4	6th and 8th Precincts had 8 percent each.
5	Of the 143 complaints filed in March of
6	2011 the allocations were improper procedure 33
7	percent, improper demeanor 29 percent, inadequate
8	service 16 percent and improper use of force 12
9	percent.
10	That completes the Secretary's Report.
11	COMMISSIONER WARFIELD: Any questions
12	for the Secretary?
13	COMMISSIONER RIVERA: Yeah. I've
14	noticed that our demeanor complaints are finally
15	below our procedure complaints; that's good news.
16	SECRETARY ANTHONY: I think so too
17	through the Chair, I think so too and perhaps Assistant
18	Chief Logan could perhaps address some of the
19	changes that have happened or that is happening
20	out in the precincts with the command.
21	ASSISTANT CHIEF LOGAN: Through the
22	Chair?
23	COMMISSIONER WARFIELD: Yes, sir,
24	absolutely.



ASSISTANT CHIEF LOGAN: Assistant Chief

1	Logan. There's a number of things that are going
2	on with regard to demeanor, and hopefully the
3	cumulative effect has been to lower the demeanor
4	complaints through constantly admonishing our
5	officers about their demeanor. We've got a
6	number of classes in the academy that teach
7	verbal judo and the like. It's always at the top
8	of our radar is demeanor.
9	So it's a constant emphasis on
10	demeanor, and it always has been and always will
11	be.
12	COMMISSIONER WARFIELD: Thank you, sir.
13	Are there any other questions regarding the
14	report? Thank you, Secretary, for the report
15	and we will receive it.
16	SECRETARY ANTHONY: Thank you.
17	COMMISSIONER WARFIELD: At this time we
18	want to move to first of all, I recognize that
19	our Chief of Police has joined us, Chief Ralph
20	Godbee. Sir, good to have you.
21	You're up on the agenda next. Do you
22	want to come up or however you want to do it,
23	sir.
24	CHIEF GODBEE: Through the Chair, Chief
25	Godbee. I don't want to be disruptive to the



1	meeting. I have a 4 o'clock meeting with the
2	Monitor, so I just wanted to step in and say
3	hello and get what I could before my appointment
4	with the monitoring team.
5	COMMISSIONER WARFIELD: Thank you, sir,
6	appreciate your presence as always.
7	Assistant Chief Logan, do you have
8	anything?
9	ASSISTANT CHIEF LOGAN: Sir, we don't
10	have any presentation at such today.

12	for the Chief or the Assistant Chief from the

3	COMMISSIONER RIVERA: Motion to
4	approve the resolutions of the retiring officers.
5	COMMISSIONER STEWART: Second.
6	COMMISSIONER WARFIELD: It's been
7	properly moved and seconded. Let me make this
8	comment on that. We certainly it is an honor
9	for us to honor those who have retired from this
10	force and I get more and more excited about those
11	who are retiring in full health with full
12	facilities after their years of service and
13	hopefully in the future we can even do more to
14	recognize and honor them for the outstanding job
15	that they've done and the years of service and
16	commitment that they've done in putting their
17	lives on the line literally day in and day out.
18	So certainly to all those officers that
19	are retiring that are on our agenda for this
20	resolution, we want to say thank you for your
21	years of service.
22	All those in favor of receiving the
23	motion for the resolutions please say aye.
24	COMMISSIONERS: Aye.
25	COMMISSIONER WARFIELD: All those



1	opposed? Motion carries. Also it's not on our
2	list today, but it bears to be mentioned.
3	Officer Myra Gracey who works out of the
4	Northwest District is also retiring. We just
5	haven't had her paperwork yet, but I've worked
6	closely with her over the years and she is an
7	outstanding community officer, and has done a
8	great deal to make sure that the community over
9	there, the Northwest District, is working hand in
10	hand with the Police Department over there.
11	And so I just wanted to acknowledge her
12	accomplishments as well as she prepares for her
13	retirement, and so we certainly want to let her
14	know that we are in support of her and thankful
15	for the work that she's done down through the
16	years.
17	Our next meeting is scheduled for
18	Thursday, April 28, 2011, 3 o'clock right here at
19	Police Headquarters.
20	Before we move to oral communications,
21	I'll turn the floor over to Commissioner Rivera
22	for a statement.
23	COMMISSIONER RIVERA: Thank you. On
24	Tuesday evening a very unfortunate incident
25	happened to a former Detroit Public School music



1	teacher and a senior citizen who suffers from
2	dementia.
3	She came home to find two men in her
4	house and they proceeded to put a jacket over her
5	head, took her into the basement, stole her
6	purse, took her car keys and her money.
7	Fortunately she was not hurt and it
8	turned out to be a couple neighbor kids ended up
9	being the perpetrators in this incident. Her
10	vehicle was recovered after a police chase
11	involving Michigan State Police, although it was
12	wrecked.
13	And I just wanted everyone to know that
14	I made no attempt to intervene in this case. I
15	was not at the scene when it happened. But I was
16	more concerned with the fact of her safety and
17	her health.
18	I do want to say thank you to the
19	Detroit Police Department and the Michigan State
20	Police for the excellent job they did. Also
21	Commander Lee and Commander Welles, thank you for
22	your help in this situation.
23	ASSISTANT CHIEF LOGAN: DC.
24	COMMISSIONER RIVERA: I'm sorry, DC. I
25	keep demoting people. Thank God I don't take



1	your paychecks.
2	Also if there is a story here, the
3	story is about the safety of our senior citizens
4	and how we must take care of each other and
5	especially in view of the fact that usually it's
6	someone you know. In this case it was the
7	neighbors.
8	And the other part of the story is
9	sometimes when the Police Department does their
10	job and they do excellent police work it doesn't
11	get recognized, so I want to thank the Police
12	Department for good old fashioned police work in
13	apprehending these criminals, and in the positive
14	outcome from this story.
15	By the way, the senior citizen was not
16	my mother, it was my aunt, and I'm happy to
17	report that she is doing fine and I guess that's
18	it. Thank God that she wasn't hurt.
19	COMMISSIONER WARFIELD: Thank you,
20	Commissioner, we appreciate that statement. Want
21	to announce to the public that on Tuesday, April
22	26, 2011 from 6 o'clock PM to 8 o'clock PM Chief
2.3	Ralph Godbee invites all of the citizens of the

city of Detroit to join him and members of the

Detroit Police Department for the first quarterly

1	report to the community. That will take place at
2	Charity Lutheran Church which is located at 17220
3	Kelly Road on the east side of Detroit.
4	Also, in addition to that I want to
5	announce that the Detroit Police Chaplain Corp
6	will present their spring gospel concert "Our
7	Hearts Sing" which will take place on Friday,
8	April 29, 2011, 6 o'clock PM, and this will take
9	place at Greater Mount Zion Church, 15600
10	Evanston Street in Detroit, Michigan.
11	Certainly there are flyers to both of
12	those events just outside the room, please make
13	sure you get a copy.
14	Our agenda now calls for oral
15	communications. If you wish to address the Board
16	of Police Commissioners, you may come to the
17	podium, please state your name for the record and
18	spell it for us so we can make sure we have it
19	correct in our record, and then we ask that you
20	abide by a four-minute time commitment so that we
21	can hear as many persons as we can.
22	You may come at this time.
23	MR. ECTER: Good afternoon.
24	COMMISSIONER WARFIELD: Good afternoon.
25	MR. ECTER: My name is Rick Ecter,



1	city of Detroit resident. On Monday, April 18 I
2	held an event on the east side of Detroit. It
3	was an event in which members or shall I say
4	citizens, law-abiding citizens, who had a desire
5	to participate in an open-carry event.
6	By "open-carry", I mean an event by
7	which citizens are exercising their lawful right
8	to openly display a firearm.
9	During that event in my estimation it
10	was well attended by all accounts and it
11	proceeded very well. One consequence of having
12	this event is that a lot of people sought me out
13	to share some experiences with them.
14	A lot of these experiences were
15	negative and these experiences were a result of
16	their interaction with Detroit police officers
17	in terms of harassment, maybe some of those
18	demeanor issues you guys raised earlier.
19	One lady told me of an experience in
20	which she was actually arrested. I'm here today
21	to talk to you all about open-carry in the city
22	of Detroit. Open-carry naturally is a big issue.
23	Michigan is one of the fastest growing states
24	with regards to open-carry.



If more Michiganders are going to

1	participate, it only stands to reason that more
2	Detroiters will be participating. I just want to
3	know with you all if you understand that if
4	citizens have their rights violated, that puts
5	the City in jeopardy of legal action. It also
6	has the individual officer subject to legal
7	action in the civil courts.
8	A lot of people ask me do the City of
9	Detroit and police officers know whether
10	open-carry is legal. And my pat answer to them
11	is, "Well, the Michigan State Police produces
12	documentation such as the Michigan State Police
13	legal Update." Issue Number 86 does a very good
14	job of discussing specific laws that usually
15	apply when we're either talking about citizens
16	concealed carrying with a license or open-
17	carrying whether they have a concealed pistol
18	license or not.
19	I'm aware that open-carry is legal, but
20	a lot of citizens have expressed concerns with
21	their interactions, mostly negative interactions,
22	with police officers. Yeah, I'm aware some
23	police officers don't like the practice, but it's
24	lawful and its legal, and if citizens want to



exercise that right, they should be able to do

1	so.
2	Open-carry is here, it's growing. More
3	folks in the city of Detroit will be doing it.
4	If there's some issues that the police have with
5	open-carry, I would like to extend an invitation
6	to the open-carry community, myself included, if
7	there's some issues in which we can resolve some
8	of these interaction issues with citizens
9	exercising their legal right, their
10	constitutional right to bear a firearm, maybe we
11	can reach a solution as opposed to some of the
12	heavy-handed tactics that a lot of people are
13	complaining about in the streets.
14	I really want to know do all of your
15	officers know that open-carry is legal and do you
16	have an established policy and procedure to deal
17	with citizens exercising that right to
18	open-carry.
19	COMMISSIONER WARFIELD: Assistant
20	Chief?
21	ASSISTANT CHIEF LOGAN: Through the
22	Chair, the simple answer is yes, yes.
23	COMMISSIONER WARFIELD: Thank you.
24	MR. ECTER: That's your answer, yes
25	ves? Okav, got it. Oh, one last thing. Like I



1	said, I just want to repeat, assistance from the
2	open-carry community is available should you
3	desire it because I would hate for the City to be
4	exposed to legal action from citizens exercising
5	their rights.
6	COMMISSIONER RIVERA: Through the
7	Chair, may I just say that for those of you who
8	are not familiar with Mr. Ecter, he has a
9	firearms safety academy that he teaches. He is
_ 0	very pro open-carry.
.1	We are fully aware of the legal right
_2	for our citizens to bear arms and carry them. We
_3	also are aware that some citizens are very
_ 4	uncomfortable seeing that, but we certainly
. 5	respect your Second Amendment rights and we
_6	certainly hope that you don't have any problems
. 7	with this Police Department.
- 8	COMMISSIONER WARFIELD: Are there
9	others who wish to address the Board at this
20	time?
21	MR. MOORE: Good afternoon through the
22	Chair, Commissioners, Assistant Chief and also
23	naturally recognizing our quarterback which is
2.4	our Chief Godbee and also Detroit's finest.

My name is Edward Moore. I'm the

1	liaison for the Honorable Kwame Kenyatta, our
2	Detroit City Councilman. I'd like to say to the
3	retired officers and to the point is that since
4	they have retired, there's still a lot of work to
5	be done in the city of Detroit.
6	Just because that they have given up
7	their badge that they worked 24 hours, we would
8	like them to put some time, as much time as
9	possible, to try to get the city of Detroit back
10	on the map as being one of the safest cities in
11	the state, and that with the help of the
12	Assistant Chief and to our Chief, we want you to
13	continue on doing a good job for us.
14	And to our Commissioner from the office
15	of Councilman Kwame Kenyatta, we are so blessed
16	and happy that your aunt was not harmed and that
17	we hope that she has a speedy recovery verbally
18	as far as her mind because I'm sure that extreme
19	that was a part of her life that she will
20	probably take that with her the rest of her life
21	as far as that ordeal, but from the blessing of
22	Councilman Kenyatta and myself, we wish she have
23	a speedy recovery. Thank you.
24	COMMISSIONER WARFIELD: Thank you,

Mr. Moore.

1	COMMISSIONER RIVERA: Thank you,
2	Mr. Moore.
3	MS. SMITH: Good afternoon.
4	COMMISSIONER WARFIELD: Good afternoon.
5	MS. SMITH: My name is Bernice Smith,
6	political activist. In the paper the other day
7	they stated that the police was pulling out of
8	their duties in regards to investigation of
9	police having their inspection of the firearms
10	and they want to go to other various areas.
11	And I'm wondering what would you think
12	about that, the testing of the bullets and so
13	forth, Chief. They feel as though they're
14	overloaded in doing the testing and they want to
15	go to other areas and they may take some because
16	of the fact you're doing a lot of repairing at
17	the MGM and they feel as though they do not want
18	to go in there.
19	This was in the paper and they're
20	saying that Kim Worthy, she's very upset about
21	this position and they want to know why they're
22	going to do it and can it be stopped.
23	Are you aware of that? Am I making it
24	plain to you?
25	ASSISTANT CHIEF LOGAN: Through the



1	Chair if I might respond to it. I'm aware of the
2	fact that the Michigan
3	MS. SMITH: The Director is John
4	Collins, Forensic.
5	ASSISTANT CHIEF LOGAN: Right.
6	There's been some pullback on previous
7	commitments, but as far as everything that they
8	want to cease doing, I'm not certain. I didn't
9	read the whole article.
10	MS. SMITH: It would hinder the Police
11	Department in their investigation of any of the
12	crimes, in other words, when you send the
13	evidence to their lab and they're saying that
1 4	they're overloaded and the bullets that they
15	receive, they're saying the testing of it, it's
16	not the way that they feel as though it's worth
17	investigating and so forth.
18	They're overloaded and they're down now
19	to they were 20,371 and now they're over
20	10,000 cases that they got rid of. In other
21	words, they're down to 10,000 cases, so they feel
22	as though it's not sufficient enough for them to
23	be investigating.
2 4	That would hinder any of your police



investigation in going to court.

1	ASSISTANT CHIEF LOGAN: On the surface
2	it sounds like it, but I'd have to do some more
3	research before I responded to you.
4	MS. SMITH: All right. Something that
5	I don't know whether you are aware of it or not.
6	It may not apply to the Police Department, but I
7	think it does in a way.
8	We have an order well, it's not an
9	order, but it was a conference in Lansing where
10	your Supreme Court Justice Robert Young, he went
11	to the Governor and stated that we need to reduce
12	our judgeships here.
13	So I think that would be something for
14	you to be concerned about because when you have
15	crime cases going before the Courts, you want a
16	judge there on the bench, you know, so we're
17	going to investigate that a little more because I
18	do know one judge went to Lansing yesterday to
19	conference in regard to this, but it is in our
20	interest for us to find out.
21	You have a representative by the name
22	of John Welch from Livonia, he's Republican, and
23	he is going to try and pass this bill and it's
24	going to be apply to the federal judges, so I



think we should be aware of that and see what we

1	can do to eliminate even that bill coming before
2	the State Legislature.
3	So much is going on in this city, I
4	mean I think that we are at a standstill where
5	we're being challenged to all forces. So I do
6	believe that the Police Department needs more
7	money and if you could convince the Mayor not to
8	cut your budget, we would do a lot better in
9	trying to combat the crimes that we have here
10	that develops in our city.
11	And with your wishes, see if you can
12	get him convince him not to bother with the
13	Police Department and not cut the budget.
14	And as far as this gun I should have
15	known. I'll talk to you each week.
16	COMMISSIONER WARFIELD: Thank you,
17	Ms. Smith. Are there others?
18	MS. HATCHER: Good evening. My name
19	is Dora Hatcher. Good afternoon, Board, good
20	afternoon everyone. You know, the Bible says
21	"Stay ye ready" but I'm human, so I wasn't ready
22	today, but I thank God anyway for what you asked
23	me, but that's okay.
24	I just want to say I had came down
25	today for the reason of I assumed it was your



1	mother because that's what the news said, okay,
2	to say that, you know, it's not only our city,
3	our state, it's our world, it's everywhere.
4	I mean, we got tsunamis and things that
5	are happening that are not being done by humans
6	overseas. Then we've got crime that's being done
7	here in America, but you know, I'm not here to
8	preach, but the Word says that the enemy came to
9	steal, to kill and destroy, but we know that the
10	Word is going to have to stay prayerful and just
11	only just pray, we have to do something about it.
12	As Ms. Parnell and I was discussing
13	today, we know that the Police Department or the
14	officers, they do what they're supposed to do as
15	far as arresting these people, but we also know
16	that the judges let them go, so we have to start
17	somewhere and it may not be but maybe two of us
18	or three of us, but somewhere we have to start
19	letting them know if they put them in, they've
20	got to give them a sentence.
21	We got all this land here in Detroit
22	that's vacant now and they say, "Well, we don't
23	know what we're going to do with it."
24	I say build a bigger jail. I say do
25	like they do in Georgia and Louisiana and



1	Mississippi. Put them out there on a chain gang.
2	My alley needs cleaning, I'm getting old. The
3	streets of Detroit needs cleaning. There are a
4	lot of things that these people, they're eating,
5	they're sleeping and they're enjoying the
6	taxpayers' money in jail. Let's be for real.
7	They must be enjoying it because they keep being
8	repeaters.
9	I was in the Frank Murphy Court on
10	Tuesday. The president of Community Relations
11	and I got to be guests of a judge and I'm looking
12	at a young man who is a five-time repeater. You
13	got people out here on bond and they're steady
14	just repeating, just going back over and over.
15	Why? Because the police is putting
16	them in jail, but the judges are letting them
17	out. So we're going to have to quit talking,
18	including myself, and start working.
19	And I want to say that we have to keep
20	our city still in prayer. Prayer does work and I
21	love all of you.
22	COMMISSIONER WARFIELD: Thank you,
23	Evangelist Hatcher.
24	MS. PANNELL (SP): Good afternoon. My



name is Sharon Pannell, she always say Parnell.

I was at your last commissioners meeting because
she invited me and I came down today because I
want you to know my face.
COMMISSIONER WARFIELD: Yes, ma'am.
MS. PANNELL: When I call, I expect the
police to come out there. I been living in the
city 61 years and I raised two boys by myself.
It wasn't easy, but I did it because I knew I had
to because I had boys, and I raised two men.
And I just expect some type of police
help when I call. When I call over to Fort
Street they say, "Well, what you want? What you
want us to do?" I'm a taxpayer.
They let the same guy out that broke
into my house. I'm not sure who broke into my

I'm a Detroit resident. I'm here to speak about

1	open-carry and my experiences. I've been stopped
2	10 times total over a period of six months, but
3	not always in Detroit, but just in the metro
4	Detroit area.
5	I've been stopped three times in
6	Detroit for open-carrying and just wanted to talk
7	a little bit about the Fourth Amendment. As far
8	as the officers, they don't respect a citizen's
9	Fourth Amendment rights, if they're not doing
10	anything wrong.
11	I'm walking down the street, I'm
12	exercising, they pull up on me and they basically
13	approach me like the Gestapo, demand an ID under
14	the threat of arrest, they take my firearm.
15	I mean, it's not like like I said,
16	I'm not doing anything wrong, I'm just walking
17	down the street and I don't understand and
18	when I try to explain to the officers that
19	Michigan is not a stop-and-identify state, they
20	don't care. They say, you know, "We going to
21	arrest you."
22	And I just that really unnerves me
23	because I'm a huge fan of individual liberty and
24	to have officers of the law trample over my
25	Fourth Amendment rights, that never really sits



1	well with me.
2	So I was just wondering what are the
3	procedures for Detroit police officers as far as
4	approaching law-abiding citizens openly carrying?
5	I was told that yes and yes was the
6	answer. I'm curious as to a little bit of the
7	details.
8	COMMISSIONER WARFIELD: Assistant
9	Chief?
10	ASSISTANT CHIEF LOGAN: Okay, sir.
11	Let me read you a quotation from some of our
12	literature.
13	"A person openly carrying a firearm on
14	foot or in a legal manner when
15	approached by a police officer and when
16	questioned where the only reason for
17	the questioning is because of the
18	openly carried firearm need not give
19	that officer their name or address. No
20	license or ID is required to openly
21	carry a firearm."
22	It is your option to provide either ID
23	or a CPO.
24	MR. COLLINS: Right and that's the
25	thing I wanted to say that a lot of open



1	
1	carriers, they really do want to put the officers
2	at ease and let them know that the firearm
3	belongs to them, they are they're not a
4	convicted felon or anything like that, but at the
5	same time we dig in when our Fourth Amendment
6	rights are not acknowledged at the initial
7	beginning of the stop.
8	So if an officer would just say, you
9	know, "This is a consensual encounter, you can
10	leave at any time," I think that would go over a
11	lot better than, "Hey, why are you carrying that
12	gun?" or, "Get your hands up" and you're
13	immediately disarmed because I have a lot of
14	audio recordings of each stop.
15	And every time I leave the house I have
16	an audio recorder running just in case I get into
17	a self-defense issue or, like I say, a lot of
18	times and I was surprised because when I first
19	started doing this I thought it would be the
20	criminals that I would be needing a recorder for,
21	but it turned out I needed it for the police more
22	than anything else.
23	So I mean that's the thing. And a lot
24	of people, they do want to open-carry in Detroit



25

but they're deathly afraid of being confronted by

1	the police. I've talked to many people and they
2	like once I get past Eight Mile, I just conceal.
3	So I'm out there doing it every day,
4	every time I leave the house and I try to tell
5	people, you know, it's okay, but it's like I'm
6	standing on the beach in front of a tidal wave,
7	so but thank you for your time.
8	COMMISSIONER WARFIELD: Thank you for
9	your time, we appreciate it. And, Mr. Collins,
10	if you could come back for one quick second.
11	Certainly, as the Assistant Chief has
12	stated to you the policy of the Detroit Police
13	Department, if there are instances in the future
14	where you feel your rights have been trampled on,
15	certainly you can call our office, the Office of
16	Chief Investigator and we will certainly
17	investigate those incidents.
18	MR. COLLINS: Very good, thank you.
19	COMMISSIONER WARFIELD: Thank you.
20	MS. LACEY: Good afternoon. My name is
21	Mary Lacey. I would like for someone to respond
22	of this article about Detroit Police reform could
23	take two more years.
24	COMMISSIONER WARFIELD: Is that



concerning the Consent Decree?

1	MS. LACEY: Yeah.
2	COMMISSIONER WARFIELD: I can speak to
3	that, Ms. Lacey, just for a little bit and then
4	the Assistant Chief, certainly, if he wants to
5	chime in, he can as well.
6	Please understand this, that within the
7	last, I would say, 16 to 18 months there has been
8	considerable progress in coming up to code and
9	coming up to standard with the paragraphs, the
10	various paragraphs in the Detroit Consent Decree.
11	The Mayor, from his State of the City
12	speech this year declared that the police
13	department will be in compliance by the end of
14	this year. We're still moving very quickly
15	towards that goal without question.
16	The City has asked for a little extra
17	time as relates to some of the nuances as relates
18	to technology and some more things.
19	Here's what we don't want. We don't
20	want to come into compliance for a short period
21	of time and then after, let's say, December 31st
22	we're out of compliance. We want to make sure
23	that the Consent Decree is literally our policies
24	and procedures on for the Office of Chief
25	Investigator as well as for the Detroit Police



1	Department.
2	We are not whatsoever stepping off the
3	pedal as relates to making sure that we come into
4	compliance this year. That is our goal, that is
5	our mission and that is what we are pushing 100
6	percent for.
7	I think the Chief will tell you that as
8	well as we are telling you that as well.
9	However, what we don't want to do, we don't want
.0	to be disingenuous and let the public know that
.1	there are some technical things that may take a
_2	little bit longer.
_3	However, that does not mean that as
_4	relates to incarceration of prisoners, as relates
. 5	to use of force, that we're backing off of those
_6	paragraphs at all. We are not. We're moving
. 7	full steam ahead with those.
_8	Assistant Chief, do you have anything
_9	to add to that?
20	ASSISTANT CHIEF LOGAN: Sir, through
21	the Chair, I think you've said it all. I think
22	that the two years gives us enough time to not
23	only come into compliance, but have enough time
2.4	left over to show the Department of Justice that



we've had substantial compliance.

1	I don't anticipate it's going to take
2	us two years to come into compliance. We should
3	be in compliance this year. We're moving full
4	speed ahead.
5	I had occasion to talk to the Monitors
6	today. They're excited at the progress we've
7	made or we're making. I've also talked to
8	members of the Department of Justice.
9	They're excited at the progress we're
10	making. No, we're not there yet, but even this
11	week, this week we had members in fact, we had
12	the Mayor, the Chief of Police, the Assistant
13	Chief and a number of other people from the city
14	of Oakland, California who came here this week to
15	see how we're making the progress that we're
16	making.
17	So we're moving full speed ahead and
18	our goal is to be in compliance this year.
19	MS. LACEY: All right. One more
20	question. Who selects the Monitor? I think the
21	new Monitor is from Ireland? No?
22	COMMISSIONER WARFIELD: He might be
23	Irish, ma'am, but I don't think he's from
24	Ireland.



MS. LACEY: I was at the meeting with

1	Judge Cook and I think quite a few of us have
2	been going since the beginning of the Consent
3	Decree and
4	ASSISTANT CHIEF LOGAN: He's from New
5	York.
6	MS. LACEY: Oh, New York. But anyway,
7	like I said, quite a few citizens and we have
8	been making recommendations to the judge, to the
9	Mayor and others that we sure would appreciate
10	someone from the community on some of these
11	positions that can get directly back to the
12	community because it seems to still be a span
13	where the community is not really receiving the
14	information they want when they want it, instead
15	of going to the media.
16	And I had suggested in the beginning
17	when they first started a Ron Scott and even to
18	Judge Cook, so that's my thing.
19	It just caught my attention when the
20	paper said Detroit police reform could take two
21	more years and, like I say, a lot of us have been
22	going to meetings from the beginning of the
23	Consent Decree. Thank you.
24	ASSISTANT CHIEF LOGAN: May I just say,



it's not only the rules and regulations that we

1	have to follow, there's a lot of technical
2	aspects involved in it. There's a lot of housing
3	of prisoners, so until we get all the things
4	ironed out we won't be in full compliance.
5	So it's not just I think a lot of
6	citizens wonder, well, why don't you do this and
7	do that. It's a little bit beyond that. There's
8	probably going to have to be millions of dollars
9	spent to deal with our prisoner problems, so it's
10	not just cut and dry, okay?
11	MS. LACEY: Okay.
12	COMMISSIONER WARFIELD: And, Ms. Lacey,
13	in addition to that, if there are concerns that
14	you have, if you can forward those to us we will
15	love to be able to try and address those for you.
16	So please, ma'am, do that, forward those to us.
17	And in addition, just want to say again, if you
18	look at the span of this Consent Decree which
19	dates back too far for us, for those who are at
20	the table right now and all of us who are at the
21	table right now dealing with this are under two
22	years in our positions.
23	And I think even the Monitors
24	understand and the judge understands, we have
25	made 100 percent improvement in where it was



1	prior to the years before we came on board. And
2	so we're committed 100 percent to get this done
3	to make sure these are our policies as we move
4	forward without question.
5	And at the meeting that the Chief will
6	have on the 26th of next week, I'm sure if there
7	are questions coming from the community then
8	concerning the Consent Decree, he will be more
9	than happy to respond to those questions as well.
10	MS. LACEY: Okay, thank you.
11	COMMISSIONER WARFIELD: Thank you,
12	Ms. Lacey.
13	MR. SCOTT: Ron Scott, Detroit
14	Coalition Against Police Brutality. I didn't
15	intend to speak today, but following up on
16	Ms. Lacey I had to address this.
17	The Consent Decree is not a code item.
18	We fought for it before 1996. I think you
19	remember when we fought for that, raised the
20	question about the intervention of an independent
21	body, justice body and so on.
22	I've been very disenchanted,
23	disappointed and disgusted with the manner in
24	which the judge in this particular case who is
25	often and I'll put it on the record often



1	absent and he should spend more time in Detroit
2	as opposed to South Carolina.
3	In fact, he should let he should
4	make the decisions as opposed to allowing law
5	clerks to write law and to make any involvement
6	in that situation. As far as the Monitor, the
7	Monitor is being paid good money and his
8	responsibility is not only to come and report
9	only to the Department and the Commission, he
10	needs to talk to the people. He needs to do
11	that.
12	I'm saying it on the record, if he
13	doesn't do it, then his responsibility is in
14	question because we shouldn't have to learn about
15	this through the newspaper. We shouldn't have to
16	speak through someone else's voice. We're more
17	than capable of doing that.
18	And so, therefore, it is not a matter
19	it's like in a basketball game. It's not a
20	matter of whether or not you have defined spaces
21	where you can play the game. It's a matter of
22	whether or not the game is reshaped. It's a
23	matter of whether or not we have a different
24	culture in the city.



We could come into compliance and we

1	could still get people who have a real problem
2	with how things are happening. I don't want to
3	see that and I don't believe you want to because
4	I called you the other night and I want to thank
5	you for responding so quickly, Chairman, and I
6	know whenever I interface with any of you you're
7	more than helpful and more than vigilant about
8	what you do.
9	I want to be in compliance too with
10	those officers and those leaders in this
11	department who are trying to get the right thing
12	done, but I have to tell you this. I see among
13	especially some of the younger people coming in
14	this department a departure from the cultural
15	context that's trying to be developed, and we
16	need to address that, we need to address that.
17	I think the evangelist talked about
18	what's happening in the community which she is
19	experiencing. When people are in the same arena,
20	whether or not they happen to have a uniform or
21	they happen to have a hoodie, sometimes they
22	bring with them some of the same cultural
23	problems.
24	And so therefore we have to change that



culture. If we don't do that, we can meet all

1	the i's and the t's and the commas in a Consent
2	Decree, and we can be right back here again.
3	So this city where some people want it
4	to come under Emergency Manager, if we want to be
5	together we have to talk to each other. We can't
6	wait, we can't let the Monitor speak to you and
7	then speak to somebody else and then speak to me.
8	We have to speak to each other first.
9	We're one family and we need to act
10	like it. Now, the Chief who is a Monitor, he's
11	going to get paid. Our payment will be whether
12	or not we have the kind of department and the
13	kind of relationship that we want to have.
14	That's the only thing I want to say and
15	I want to thank you for and Commissioner, I'm
16	sorry to hear about what happened to you because
17	it's happened to me in the past, and I appreciate
18	your diligence; thank you.
19	COMMISSIONER RIVERA: Thank you.
20	COMMISSIONER WARFIELD: Thank you,
21	Mr. Scott.
22	MR. BROWN: Good afternoon. My name is
23	Cortez Brown.
24	COMMISSIONER WARFIELD: Good afternoon,
25	sir.



1	MR. BROWN: I want to touch on what
2	some of the other citizens are saying about
3	what's going on with the police and open-carry.
4	In fact, I think it's Ohio versus
5	Terry, where this is not a stop-and-frisk or
6	stop-and-show ID sort of state.
7	We have officers doing that pretty much
8	as a form of intimidation, intimidation under the
9	color of law. That's a problem. Seizure of a
10	weapon is a violation of the Fourth Amendment
11	right.
12	Now once you do that with the City's
13	financial state now, that officer opens himself
14	up to losing his absolute immunity. If he is
15	violating a civil right or constitutional right,
16	not only can that officer be sued, but so can our
17	city and so can our department.
18	We want to try to make sure that
19	everybody is educated and educated correctly.
20	There's been questions asked are the police
21	informed. I really don't think they are and I'm
22	not putting anybody at fault, but we have
23	problems not only with the police, but with the
24	citizens in general.



A lot of this stuff comes back from

1	Dr. Sweet's 1927 black control where blacks are
2	not allowed to have guns. We still have these
3	ordinances on the books. I was walking around in
4	a public building and I was told that according
5	to the Detroit City Charter I'm not allowed to be
6	armed. I thought I knew everything in the
7	Charter. I went to look for it and I couldn't
8	find it. So I went to go looking through the
9	ordinance. So I went through the city ordinances
10	and ordinances are somewhat current right now.
11	Code of Ordinance, City of Detroit,
12	Part 3, City Code, Chapter 38, Offenses and
13	Municipal Provisions, Article 12, Weapons.
14	Section 3810-2 is permit required to purchase a
15	pistol. The way it reads is subject to the
16	provisions of 3810.12 no person shall purchase a
17	permit without first having obtained to do so
18	from the Chief of Police.
19	And with that, to obtain it from the
20	Chief of Police to get a purchase permit
21	according to our ordinance, this person has to go
22	pretty much through the same thing as the NRA
23	training. This person is required to have four
24	hours of book training, four hours of range
25	training just to get a purchase permit. That's



1	not current any more. That was preempted in 1991
2	by the State of Michigan in our Constitution.
3	Also Section 38-10-4, daily reports to
4	the police for pistol sales. If I sell a firearm
5	I'm required by this ordinance to turn it into
6	the Police Department before 10 o'clock in the
7	morning. If I don't have it turned in to the
8	Police Department by 10 o'clock in the morning, I
9	suffer the consequences of 93 days in jail and/or
10	a fine between \$100 and \$500.
11	A lot of times you can't get there
12	before 10 o'clock in the morning. A lot of times
13	nobody is there before 10 o'clock in the morning.
14	I've tested this over the last couple of weeks.
15	The registration required. The person
16	having received a purchase handgun is required to
17	have that handgun and a proof of purchase to the
18	Chief of Police in five days. That's from 1927
19	too when blacks couldn't have guns. The state
20	requirement is 10 days.
21	Also limits to purchase permit and have
22	registration. Go to Section 38-10-14 Subsection
23	8, Part 7, any person who has a handgun owner
24	does not possess a valid safety training
25	certificate is also in violation, which means if



1	I can't get the permit and I don't have the
2	training, I can't it's a catch-22 situation.
3	You say I got one minute left? I'll
4	close on this. Under the 1990 state preemption
5	law, MCL 123.1102, this ordinance is
6	unenforceable. These ordinances are
7	unenforceable in regards to firearm possession
8	and transportation.
9	Furthermore, the existence of these
10	ordinances being in conflict with the laws of the
11	State of Michigan is misleading I say is
12	misleading to the citizens of the city of Detroit
13	and anybody that visits the city.
14	As a concerned law-abided citizen, I'm
15	requesting that these ordinances be amended
16	within 90 days to comply with the MCL123-1102.
17	Failure to amend this ordinance could be
18	considered an act of malfeasance as it wilfully
19	misinforms the public of what is and is not
20	allowed in the public areas of the city of
21	Detroit.
22	I look forward to your resolution in
23	response to this ordinance as they're amended.
24	Thank you.



COMMISSIONER WARFIELD: Mr. Brown,

1	first of all, thank you for your quite
2	obviously you've done a great deal of research in
3	presenting us with that information, but I'm sure
4	as you well know unfortunately we do not have the
5	authority or the due diligence to change the
6	ordinances of the city of Detroit. That's
7	Detroit City Council.
8	Certainly there are representatives
9	here today from the Detroit City Council and so I
10	would ask that you pass that information along to
11	them as well and certainly, again, we thank you
12	for your presentation.
13	MR. BROWN: Yes and I did that, and I
14	brought that up because most of these ordinances
15	that I summarized or paraphrased are directly by
16	
	the consent of the Chief of Police and everything

14	planted evidence and lied on the stand. I got a
15	letter saying basically my complaint was thrown
16	out, no one investigated no one went and saw
17	the videotape from the ATM.
18	Even in the investigation of it, no one
19	spoke to the witness who spoke to them, told the
20	officers who were robbing the people, even though
21	I told them who the witness was.
22	No one talked to the lawyers who saw
23	the videotape of this officer picking up the
24	evidence and planting it on me, which there's
25	videotape of it, so I'm asking you what is my



1	recourse.
2	COMMISSIONER WARFIELD: Attorney, could
3	you address this for us, please? I'm sorry, we
4	certainly want you to speak with our Chief
5	Investigator, Chief Investigator Orr who's sitting
6	right there next to you.
7	When you say your complaint was thrown
8	out, was it one that I filed with us or was it
9	one you filed with
10	MR. WILSON: Internal Affairs.
11	COMMISSIONER WARFIELD: We would
12	definitely want you to file one with our side as
13	well and we will look into it thoroughly for
14	sure.
15	Assistant Chief, is there anything
16	ASSISTANT CHIEF LOGAN: Would you see
17	through the Chair, Assistant Chief Logan.
18	Would you see Lt. Miles in the back so he can
19	record that information for you also?
20	MR. WILSON: Yes.
21	ASSISTANT CHIEF LOGAN: AND DC Tolbert,
22	would you make sure we look into this issue also?
23	DEPUTY CHIEF TOLBERT: Yes, sir.
24	COMMISSIONER WARFIELD: And, again,
25	make sure we have your name because I want to
