5	afternoon, ladies and gentleman. Welcome to the
6	Board of Police Commissioners meeting. Today is
7	Thursday, January the 27th. My name is Jerome
8	Warfield, chairman of the Board of Police
9	Commissioners.
10	Serving with me today is Commissioner
11	Toney Stewart, Commissioner Reverend Michael
12	Reeves, Commissioner Donnell White. Sitting in
13	for the chief of police is Deputy Chief Tolbert
14	and the chief certainly I believe is on his way.
15	We also have with us sitting at the
16	table our secretary to the Board of Police
17	Commissioners Mr. George Anthony.
18	I'm going to ask if he would introduce
19	the staff from the Board of Police Commissioners.
20	COMMISSIONER ANTHONY: Thank you,
21	Mr. Chair. George Anthony for the record
22	through the Chair.
23	The staff members present are Ms. Celia
24	Banks Washington who is our supervising our



attorney supervising investigator, Ms. Dalph

1	Watson who is our Personnel director, Ms. Tina
2	Orr who is our chief investigator over the Office
3	of Chief Investigations and Mr. Robert Brown who
4	is our office manager.
5	Also present are our recorders for
6	today, Officer Terrence Bell and Mr. Dale Rose
7	who is our court reporter from Hanson Court
8	Reporting Service, and that's an introduction of
9	our staff.
10	COMMISSIONER WARFIELD: Thank you,
11	Mr. Anthony. I also want it to be noted for the
12	record that we have been joined by Assistant
13	Chief Chester Logan. Sir, good to have you.
14	ASSISTANT CHIEF LOGAN: Good to be
15	here.
16	COMMISSIONER WARFIELD: At this time
17	I'm going to ask if Pastor Grimmitt (sp) is
18	available. Is he here today? Good afternoon,
19	sir. Could you come to the podium and lead us in
20	our invocation for today's meeting, sir.
21	PASTOR GRIMMITT (sp): Let's open our
22	hearts in prayer. To the one God, all Creator,

25	justice that is rooted in righteousness and not




1	in the interest of just us. Above all, dear

1	might be. However, I do appreciate the solid
2	support that has come from citizens. I do
3	appreciate the fact that officers even after this
4	heinous crime was committed got up and went to
5	work on the very next shift and reported for
6	duty, and I thank the officers, I thank the
7	citizens, I thank the command staff, the chief,
8	the assistant chief and all of those who led us
9	and even now are still leading us through the
10	midst of this crisis.
11	It is our position as a board that
12	certainly we want to look at this as a teaching
13	moment, yes, even for us. We will be looking at,
14	as I spoke with the chief earlier today, how we
15	engage our citizens in the various precincts and
16	districts that our citizens must visit.
17	Certainly from time to time and
18	probably too often we do hear that some of our
19	citizens are not addressed maybe for an half an
20	hour, even for 45 minutes while in precincts.
21	I think for the safety of our officers
22	and for the servicing of our citizens we will
23	address and engage and look at the policy of
24	engaging our citizens in an effort that we may
25	improve the efficiency in which our citizens are



1	serviced, and at the same time improve the safety
2	and the environment of safety for our officers as
3	well.

Those of us who have had an opportunity to look at the actions that occurred on Sunday saw something that I believe none of us could have ever imagined. It was a barbaric, it was a bombastic, it was a demonic attack, that someone went in with the express intent to kill officers and that in our society can never be accepted and can never be the norm.

And so we thank God for the heroic efforts and for the outstanding training that those officers employed as an effort not only to protect themselves, but to protect others who are in that precinct. And certainly we sometimes we use the word "hero" a little bit too loosely in our society, but without question Commander Davis, Officer Anderson were the personification of hero.

To face that intruder -- I'll call him a terrorist -- who literally attacked that precinct that day and go toe to toe with him in an effort to preserve other lives who were there, that man -- those men are heroes as relates to

They are the standard bearers of how
this city must stand up against any and every act
of violence, not only in stations but throughout
our community. We've seen citizen's groups
answer the call of readiness when it comes to
apprehending or at least getting tips in order
that criminals may be apprehended and we must
allow our righteous indignation to rise and be
louder than those acts of disobedience in our
society.

And if we as a community will continue to do that, then we will have a safer community. Regardless of how many officers are on our streets, if the citizens will come out, if the citizens will sit on the porch, if the citizens will turn in those who are responsible for these type of acts and stay engaged in the process, we will be partners and partners indeed as we fight crime throughout the city and really throughout this nation.

Because certainly this incident is not unique to Detroit. We are grateful to God or to whoever you may pray to that more lives were not lost with the exception of the perpetrator. We



1	are grateful to God that more injuries did not
2	happen because that was a very devastating scene
3	and a devastating event.
4	So in moving forward, we thank, again,
5	the leadership of this department, we thank the
6	steady hand of our chief of police, we thank his
7	command staff who were present and on the scene
8	and the officers who showed up to help and
9	support as well or my fellow commissioners who
10	broke their schedules that night and our staff to
11	be with the officers and to let them know
12	whatever we need to do to keep them safe in that
13	environment, we will do everything possible to
14	make sure that an environment of safety will take
15	place.
16	And so having said that, I just again
17	take my hat off to the men and women of the
18	Detroit Police Department, to the command staff,
19	to the chief, to the assistant chief, as well as
20	to the citizens who have supported us getting
21	through this situation. Thank you.
22	(APPLAUSE).
23	COMMISSIONER WARFIELD: At this time,
24	Secretary, is there a report?
25	COMMISSIONER ANTHONY: No.



1	COMMISSIONER WARFIELD: Assistant
2	chief?
3	ASSISTANT CHIEF LOGAN: Through the
4	Chair, thank you for those kind words, sir. I
5	just wanted to make one correction. That was
6	Officer Jackson involved in that. Officer
7	Anderson was the one who was shot in the head
8	initially, so he went down.
9	I believe we have a presentation by
10	Risk Management. Are we ready for that at this
11	point?
12	COMMISSIONER WARFIELD: Yes, sir,
13	absolutely.
14	ASSISTANT CHIEF LOGAN: And I just want
15	to echo what you just said. We've gotten a lot
16	of support from the community. It was gratifying
17	to see members from the Board of Police
18	Commissioners there that night.
19	I don't have to tell you how the scene
20	looked because you were there, but sometimes
21	during chaos when you look up and see a kind
22	face, it means a lot, and it meant a lot to those
23	officers.
24	I want to we can go around forever
25	thanking people, but I just want to acknowledge



1	Commander Steve Doulant, he came in early. It
2	was just happenstance that he was able to be
3	there that night and he played a pivotal role in
4	helping to lock down that scene and I just want
5	to thank you for that, Steve. Thank you very
6	much.
7	(APPLAUSE).
8	ASSISTANT CHIEF LOGAN: I'd also like
9	to add that Commander Davis has been released
10	from the hospital today. Officer Anderson, he's
11	still there recovering.
12	As you know, two of the officers were
13	released, the two sergeants that were shot, were
14	released later on that evening.
15	But I've been to Vietnam, I've been on
16	this police department for a number of years and
17	I have never seen anything like that, never in my
18	life.
19	The chief promised the media that they
20	didn't have to do a Freedom of Information Act to
21	get the tape from that. We hope to have it
22	ready, Gail, today, to release to he wants the
23	troops to see it, have access to it first and the
24	media second, so when people and I'm certain
25	it's going to be on TV, but it's just a 1 minute

1	and 8 seconds of total chaos, horror and heroics.
2	So that's all I have. Thank you so
3	much.
4	COMMISSIONER WARFIELD: Thank you, sir.
5	We have the Labor Risk Management.
6	CHIEF GODBEE: Good afternoon, Board.
7	For the record, Chief Godbee. If you would allow
8	me, I'm just going to let the AC sit in for me.
9	I'll be here. I have a 4 o'clock meeting with
10	the monitor, so I don't want to be disruptive to
11	the meeting, so just to keep the flow of the
12	meeting, I will be here if you have any
13	questions.
14	COMMISSIONER WARFIELD: Thank you.
15	DEPUTY CHIEF WILSON-TURNER: Good
16	afternoon, Board. DC Wilson-Turner, Risk
17	Management Bureau, for the record.
18	This afternoon I'm going to have my
19	officer in charge of Labor Relations give you a
20	short presentation, but to introduce my Labor
21	Relations staff I will have commanding officer of
22	Legal Affairs introduce everyone.
23	Lieutenant what's your name now
24	Rivers?
25	(Laughter).



1	LIEUTENANT RIVERS: Private joke. Good
2	afternoon. Lieutenant Robin Rivers. I am the
3	commanding officer of Legal Affairs.
4	Legal Affairs encompasses three units.
5	Police Law, Disciplinary Administration and Labor
6	Relations. Today with us will be Sergeant
7	Kimberly Bennett. She is the officer in charge
8	of Labor Relations and will be presenting our
9	presentation. With us is also our labor team.
10	Sergeant Kimberly Bennett, please stand
11	and approach. We have Sergeant David Dehem, we
12	have Sergeant Robert Winkler just raise your
13	hands, and Police Officer Heshma (sp) Green.
14	You also had Sergeant Nancy Mumford who
15	served this department for 25 years and recently
16	retired and we have Lieutenant Mark Bliss who was
17	recently promoted, so we're down by two officers
18	in our unit.
19	SERGEANT BENNETT: Good afternoon. For
20	the record, Sergeant Kimberly Bennett. I'm the
21	officer in charge of labor Relations, Assistant
22	Chief.
23	I'm going to talk briefly about some of
24	the primary functions of Labor Relations. The
25	primary function of Labor Relations is in the



1	administration of three collective bargaining
2	units covering sworn members in the following
3	bargaining units:
4	Detroit Police Officers Association
5	which is also known as the DPOA; Detroit Police
6	Lieutenants and Sergeants Association which is
7	also known as DPLSA and Detroit Police Command
8	Officers Association, which is known as the
9	DPCOA.
_ 0	Labor Relations has four major
1	responsibilities: research, advising, review and
_2	representation. Research is a very important
_3	part of Labor Relations function. Typically
_ 4	Labor Relations will research contractural
_5	provisions, prior arbitration decisions, court
_6	decisions, department files and any other
. 7	resource that may contain information that
_8	supports the department's position in a labor
9	dispute.
20	In addition, we advise, we advise our
21	department execs, our supervisory staff on labor
22	matters confronting them. Their primary task
23	involves identifying, interpreting applicable
2.4	contractual provisions to determine an



appropriate response or action to be taken.

1	In addition, we do reviews. Labor
2	Relations is responsible for ensuring that the
3	department adheres to the regulations governed by
4	the enforcement of the Fair Labor Standards Act
5	as set forth by the Department of Labor.
6	To ensure this, Labor Relations reviews
7	the polices and procedures and they make the
8	appropriate recommendations.
9	And last but not least, we represent
10	the department in all labor matters involving the
11	three collective bargaining units.
12	Representation includes, but is not limited to
13	assisting the department's legal counsel with the
14	preparation of cases brought to arbitration,
15	providing expert testimony during arbitration and
16	preparing responses to grievances brought against
17	the department by the respective bargaining
18	units.
19	Any questions?
20	COMMISSIONER WARFIELD: Thank you. Any
21	questions from the Commission? I just have a
22	few, especially as it relates to representation
23	of officers as relates to arbitration and other
24	matters.



If by chance an officer is charged

1	and/or accused and/or charged with a felony
2	act, are you all still involved in that?
3	SERGEANT BENNETT: Yes.
4	COMMISSIONER WARFIELD: You still
5	represent them?
6	SERGEANT BENNETT: Well, we work we
7	represent the department, we represent the
8	department.
9	COMMISSIONER WARFIELD: Okay, that
10	answers my other questions. Any other questions?
11	Thank you, Sergeant Bennett, appreciate your
12	time.
13	SERGEANT BENNETT: Thank you.
14	COMMISSIONER WARFIELD: At this time
15	I'm going to ask if Commissioner White would read
16	the grants that have been requested from the
17	department that we approve.
18	COMMISSIONER WHITE: As relates to the
19	request to apply for the "Solving Cold Cases with
20	DNA Program" from the United States Department of
21	Justice.
22	The United States Department of
23	Justice, Office of Justice Programs, National
24	Institute of Justice, is seeking applications for
25	funding under the "Solving Cold Cases with DNA



1	Program."
2	Local governments are eligible to apply
3	for an amount to be determined with no cash match
4	for a program where the mission is to identify,
5	review and investigate Uniform Crime Report (UCR)
6	Part 1, Violent Crime "cold cases" that have the
7	potential to be solved through DNA analysis and
8	to locate and analyze biological evidence
9	associated with these cases.
10	The Detroit Police Department's
11	Homicide's Cold Case Unit has been provided with
12	the application instructions and is currently
13	developing a program to fit the guidelines of the
14	grant.
15	The majority of the funding requested
16	would be utilized to cover the expense of
17	overtime for the officers assigned to the
18	Homicide Cold Case Unit. In addition, funds will
19	be requested for investigative travel, laboratory
20	equipment, computer equipment, supplies and
21	training.
22	In the event that approval is granted
23	to apply and the award is received, Sergeant
24	Michael Russell of Homicide's Cold Case Unit will
25	serve as the project director. The deadline for



1	this application is March 8, 2011.
2	With that being said, I will put forth
3	a motion to approve the request to apply.
4	COMMISSIONER REEVES: I make a motion
5	that the department move forward with the board
6	approval.
7	COMMISSIONER STEWART: Second.
8	COMMISSIONER WARFIELD: It's been
9	properly moved and seconded that we approve the
10	department to move forward with this grant
11	request.
12	All those in favor?
13	COMMISSIONERS: Aye.
14	COMMISSIONER WARFIELD: All those
15	opposed? Motion carries. Thank you, sir. Next
16	grant, please.
17	COMMISSIONER WHITE: As it relates to
18	the request to accept a "2011 Electronic Crash &
19	Submission Grant" from the Michigan Office of
20	Highway Safety Planning (OHSP).
21	The Michigan Office of Highway Safety
22	Planning has awarded the Detroit Police
23	Department (DPD) a "2011 Electronic Crash Capture
24	& Submission Grant" in the amount of \$273,977
25	with no cash match. The grant period will run



1	from December 17, 2010 through September 30, 2011
2	and the grant number is TR11-14.
3	The Detroit Police Department will be
4	working collaboratively with a contracted vendor,
5	iyeTek, and Michigan State Police to improve
6	DPD's electronic crash reporting system.
7	As a result of this project, it is
8	anticipated that there will be a decrease in the
9	number of errors in our an UD-10 accident
10	reports, thereby increasing the accuracy of data
11	provided to the State. Within the grant,
12	training and equipment will be provided to DPD
13	officers.
14	If permission is granted to accept this
15	award, Lieutenant Tonya Golfin of Technical
16	Support will serve as the project director. The
17	appropriation number for this grant is 13343.
18	I'm requesting the Board's permission
19	to accept this funding and seek approval of the
20	Honorable Detroit City Council.
21	COMMISSIONER REEVES: Make a motion to
22	ask the department to move forward with approval
23	of the Board.
24	COMMISSIONER STEWART: Second.

COMMISSIONER WARFIELD: It's been

1	properly moved and seconded. I do have a
2	question. Is there someone that can speak for
3	this grant?
4	Can you come to the podium for a
5	second, please, ma'am?
6	I'm sorry, for the record, your name?
7	LIEUTENANT GOLFIN: Lieutenant Tonya
8	Gulfin, Technical Support.
9	COMMISSIONER WARFIELD: Thank you for
10	coming to the podium. It appears just on the
11	face and it must be much deeper than this, that
12	this grant is for correct data entry or more
13	efficient data entry?
14	LIEUTENANT GULFIN: More efficient and
15	accurate, yes.
16	COMMISSIONER WARFIELD: What are the
17	issues now because this is a huge grant for
18	somebody to start typing right?
19	LIEUTENANT GULFIN: Well, right now as
20	far as the accident report, everything is manual.
21	The officers fill out all the information with
22	pencil, pen and when we have humans involved, you
23	have error.
24	COMMISSIONER WARFIELD: Well, that



makes it much clearer. So we're moving from a

1	paper system to an automated system?
2	LIEUTENANT GULFIN: Yes, sir.
3	COMMISSIONER WARFIELD: Great, got you.
4	Thank you, appreciate it. Any other questions?
5	Thank you.
6	All those in favor of accepting the
7	department moving forward with this, say aye.
8	COMMISSIONERS: Aye.
9	COMMISSIONER WARFIELD: All those
10	opposed? Motion carries.
11	COMMISSIONER WHITE: As it relates to
12	the request to apply for the "Intellectual
13	Property Crime Enforcement Program Fiscal Year
14	2011 Competitive Grant" from the United States
15	Department of Justice.
16	United States Department of Justice,
17	Office of Justice Programs, Bureau of Justice
18	Assistance, is seeking applications for funding
19	under the "Intellectual Property Crime
20	Enforcement Program Fiscal Year 2011 Competitive
21	Grant Announcement." Local governments are
22	eligible to apply for up to \$200,000 with no cash
23	match.
24	The specific focus of this program is
25	criminal investigation, prosecution, prevention



1	and education as it relates to intellectual
2	property enforcement. Specifically, this
3	solicitation will fund efforts to:
4	1. Enforce criminal laws related to
5	intellectual property crime, including the
6	reimbursement of expenses incurred in performing
7	criminal enforcement operations, such as overtime
8	payments and storage fees for seized evidence.
9	2. Educate the public to prevent,
10	deter and identify criminal violations of
11	intellectual property laws.
12	3. Establish or expand existing task
13	forces to conduct investigations and forensic
14	analysis of evidence and prosecutions in matters
15	involving criminal laws related to intellectual
16	properly crime.
17	4. Assist state, local and tribal law
18	enforcement officers and prosecutors in acquiring
19	computer and other equipment to conduct
20	investigations and forensic analysis of evidence
21	in matters involving criminal laws related to
22	intellectual property crime.
23	5. Provide training and technical
24	assistance and services in the prevention and
25	enforcement (including prosecution) of



1	intellectual property and closely related crime,
2	including where such crimes are perpetrated via
3	electronic means.
4	The Detroit Police Department's
5	Criminal Investigations Bureau (CIB) has been
6	provided with the application instructions and is
7	currently developing a program to fit the
8	guidelines of the grant. CIB with assistance
9	from Grants and Contracts will submit an
10	application seeking the maximum amount of
11	\$200,000.
12	In the event that approval is granted
13	to apply and the award is received, Commander
14	Robert Ennis would serve as the project director.
15	The deadline for this application is February 10,
16	2011.
17	I am requesting the board's permission
18	to apply for this funding and seek approval of
19	the Honorable Detroit City Council.
20	COMMISSIONER REEVES: I make a motion
21	that the department move forward on this grant
22	with permission of the Board.
23	COMMISSIONER STEWART: Second.
24	COMMISSIONER WARFIELD: It's been
25	properly moved and seconded that the department



1	moves forward with the grant with the Board's
2	approval.
3	All those in favor?
4	COMMISSIONERS: Aye.
5	COMMISSIONER WARFIELD: All those
6	opposed? Motion carries. Thank you, gentlemen.
7	At this time, our agenda calls for old
8	business and we want to look at the issue of the
9	department's budget.
10	As you all know, we have reviewed the
11	budget from the department. I certainly want to
12	thank the chief of police, the assistant chief,
13	Deputy Chief Tolliver, other deputy chiefs and
14	our staff and the commissioners who actually sat
15	down and reviewed the budget and answered all of
16	our questions in regards to the issues that we
17	had with the budget.
18	We go in front of respective budget
19	committees I'm sorry, the Budget Committee,
20	next week in order in an effort to talk about
21	our individual budget, the budget for the Board
22	and the budget for the department.
23	In doing that, we want to approve the
24	budget with the caveat of offering ideas and
25	suggestions for the City to save money. We do



1	understand that the City is entering into this
2	budget period with about \$150 million deficit and
3	in an effort to try and bring that dollar amount
4	down, we want to certainly as a department do our
5	very best to make sure that we do not exacerbate
6	the deficit in the city of Detroit.
7	Having said that, we believe that there
8	are several areas within the Detroit Police
9	Department budget that needs to be reviewed by
10	the mayor and by the City Council in an effort to
11	look for savings, starting with the Board of
12	Police Commissioners.
13	We have in the budget slated for 11 new
14	positions for investigators and certainly we are
15	certainly in desperate need of investigators and
16	we need that in order to live up to our
17	responsibility for the Consent Decree.
18	However, we do believe that we can live
19	up to our obligations of the Consent Decree with
20	eight new investigators and not 11. So one of
21	the things we will ask for is a reduction from 11
22	new investigators to eight which will allow us to
23	be at, we believe, a level that will allow us to
24	carry out our policies.

In addition to that, we will ask the

1	mayor and the City Council to look at those
2	contracts, especially those lease contracts, that
3	are supposed to expire in the year 2012 as
4	further savings because a lot of those buildings
5	will be folded into the new police headquarters
6	that would be opened, so we'll ask the mayor and
7	City Council to look at those areas as well.
8	In addition to that we believe that
9	there are other areas throughout the budget,
10	especially the big whopping \$42 million increase
11	in benefits that hopefully will be negotiated a
12	little bit better in order to look for further
13	savings.
14	And one of the reason that we say this
15	certainly Gary Brown mentioned it at our
16	meeting, but we saw for ourselves that in the
17	last quarter of 2010 the City of Detroit paid out
18	over \$10 million in lawsuits at the hands of
19	that were filed against the police department.
20	If we extrapolate that and we don't
21	know if it's a consistent number but if we
22	extrapolate that over the year we're looking at
23	almost \$40 million if we can extrapolate that
24	that far potential, but bare minimum you know
25	there's at least \$10 million that was paid out.



Τ	we have to do our part to make sure
2	that we are holding ourselves accountable to stay
3	within our budgetary means and our budgetary
4	confines. So as a result of that, we're going to
5	ask the mayor and the City Council to look into
6	those areas as well as making sure that from a 10
7	percent cut of executives that certainly our
8	staff and the staff that are supposed to receive
9	that cut receive the full 10 percent cut as well
10	in an effort again to make sure that our fiscal
11	house stays in order.
12	So having said that, we will prepare a
13	memo asking that the mayor and the City Council
14	look at those areas as potential savings for the
15	Detroit Police Department, but I will entertain a
16	motion to approve the budget as it was presented
17	to us with a memo outlining those areas of
18	potential savings.
19	COMMISSIONER WHITE: So moved.
20	COMMISSIONER REEVES: Second.
21	COMMISSIONER WARFIELD: It's been
22	properly moved and seconded. Is there any
23	discussion on that from the commissioners? Any
24	discussion? Hearing or seeing none, all those in
25	favor of approving the budget with the memo



1	attached, please say aye.
2	COMMISSIONERS: Aye.
3	COMMISSIONER WARFIELD: All those
4	opposed? Motion carries unanimously.
5	At this time I want to announce that
6	our next meeting will be February 3, 3 o'clock PM
7	here at Police Headquarters, 1300 Beaubien. I
8	certainly look forward to seeing you here.
9	At this time our agenda calls for oral
10	communications. If you wish to address
11	COMMISSIONER ANTHONY: If I may,
12	Mr. Chair.
13	COMMISSIONER WARFIELD: I'm sorry, let
14	me go back because we need to deal with
15	suspension without pay issues.
16	COMMISSIONER ANTHONY: Yes, sir. For
17	the record, George Anthony through the Chair.
18	These are suspensions without pay
19	recommendations from the chief's office that were
20	addressed last Thursday. One commissioner was
21	not available at the time and so I would like to
22	read these into the record for his benefit that
23	he may vote on it or so.
24	The Board of Police Commissioners from
25	the chief of police, suspension without pay of



1	Police Officer Tabia Tabb, Badge 3932, assigned
2	to the Eastern District.
3	The facts are these:
4	On May 11, 2010 at approximately 1 AM
5	Police Officers Tabia Tabb, Badge 3932, and
6	Monique Schwartz, Badge 3796, both assigned to
7	the Eastern District, received a police run to
8	11400 Somerset, Detroit, Michigan to assist an
9	EMS unit and to investigate underage drinking.
10	Police Officer Shane Palmer, Badge
11	1070, and Aaron Kraszewski, Badge 684, assigned
12	to the Eastern District, arrived to the scene as
13	backup.
14	During the investigation Officer Palmer
15	encountered a citizen who smelled of intoxicants
16	seated in the driver's seat of a vehicle.
17	Officer Palmer advised the citizen not to operate
18	the motor vehicle. Prior to leaving the scene
19	Officer Palmer advised Officer Tabb about the
20	citizen.
21	Shortly after leaving the scene Officer
22	Palmer observed the citizen driving the
23	aforementioned vehicle westbound on Moross with
24	Officer Tabb following in her scout car.
25	Officer Palmer initiated a traffic stop



1	of the citizen. However, when Officer Palmer
2	approached the vehicle Officer Tabb began to yell
3	at him that it was her investigation and her
4	discretion.
5	Officer Tabb advised the citizen to
6	keep her car window up and instructed the citizen
7	to drive away. The citizen obeyed Officer Tabb's
8	instruction and kept driving. Both scout cars
9	followed her.
_0	Ultimately the citizen stopped in front
1	of her residence. Officer Palmer again attempted
_2	to conduct an investigation for operating while
_3	impaired, but Officer Tabb blocked him with her
_ 4	arms and pushed him, allowing the citizen to flee
_5	inside the residence.
_6	Once the citizen was inside the
. 7	residence Officer Tabb and her partner left the
_8	location. Officer Palmer and Kraszewski called
_ 9	for a supervisor and Sergeant Laura Stanton,
20	Badge S-531, of the Eastern District arrived at
21	the location and assisted in getting the citizen
22	out of the residence.
23	Officer Palmer and Kraszewski conducted
24	a field sobriety test which the citizen failed

investigator's support naming Officer Tabb as the

1	Defendant to Wayne County Assistant Prosecutor
2	Robert Donaldson. On January 4, 2011 APA or
3	Assistant Prosecuting Attorney Michael Woodard
4	signed the investigator's report recommending
5	that Officer Tabb be charged with two felony
6	counts of obstruction of justice and one
7	misdemeanor count of willful neglect of duty,
8	public officer.
9	On this same date Magistrate William
10	Anderson, III of the 36 District Court signed
11	Felony Warrant No. 11055116 for the recommended
12	charges. Also on this date Internal Affairs
13	suspended Officer Tabb at the Eastern District as
14	she reported for on-duty roll call.
15	On January 5, 2011, Officer Tabb turned
16	herself in to Internal Affairs at the 12th
17	Precinct where she was processed. On the same
18	date Officer Tabb was arraigned before Magistrate
19	Anderson. She entered a plea of not guilty and
20	was released on \$5,000 personal bond.
21	The preliminary examination was
22	scheduled for January 14, 2011. Based upon the
23	above facts and circumstances it is recommended
24	that Officer Tabb be charged with but not limited
25	to the following violation of department rules



1	and regulations.
2	Charge: Conduct unbecoming an officer
3	contrary to the Law Enforcement Code of Ethics,
4	this being in violation of the 2003 Detroit
5	Police Department Manual Series 100, Directive
6	102.3-7.9, conduct unprofessional command 1.
7	Due to the seriousness of the conduct,
8	the chief of police is requesting the Board's
9	concurrence with the suspension of Officer Tabb
10	without pay effective January 20, 2011 and unless
11	contravened by this Board the suspension without
12	pay will stand.
13	COMMISSIONER WARFIELD: The suspension
14	without pay will stand.
15	COMMISSIONER ANTHONY: The second
16	suspension without pay the chief has addressed to
17	the Board is that of Police Officer Keith
18	McCloud, Badge 3739, assigned to Narcotics.
19	On April 6, 2010 Internal Affairs
20	received information from the Detroit Field
21	Office of the Federal Bureau of Investigation
22	that Officer McCloud was possibly involved in
23	mortgage frauds committed within the city of
24	Detroit.
25	A property tax search conducted on



1	Officer McCloud revealed that between January,
2	2005 and February, 2007 he purchased 13
3	properties in the city of Detroit. The total
4	amount of the properties purchased by Officer
5	McCloud was \$1,076,500. This information was
6	confirmed by the FBI.
7	The FBI discovered through a series or
8	through a review of real estate documents and
9	bank records that Officer McCloud received
10	illegal payments from the sellers for each of the
11	13 real estate transactions. The payments range
12	from \$3,000 to \$10,000.
13	It was also discovered that Officer
14	McCloud lied on bank loan applications and
15	submitted fictitious documents. It should be
16	noted that all the properties purchased by
17	Officer McCloud have been foreclosed or are
18	currently in foreclosure.
19	On October 28, 2010 the FBI interviewed
20	Officer McCloud at his residence. During the
21	interview Officer McCloud indicated that he
22	approached a former Detroit police officer who
23	asked him about buying rental property. The
24	former officer stated he had some rental

properties for sale and was willing to sell them

1	to Officer McCloud.
2	The former officer instructed Officer
3	McCloud to provide him with copies of his
4	paycheck stubs, W-2s and other documents and that
5	the former officer would take care of the
6	financing. According to Officer McCloud they
7	never discussed the purchase price of the home or
8	the terms of the financing.
9	The former officer told Officer McCloud
10	that he would pay him \$5,000 when the home
11	closed. Subsequently Officer McCloud received
12	\$5,000 for a property at 12142 Mendon and \$10,000
13	for a property at 14244 Rochelle. It should be
14	noted that the former officer is currently
15	incarcerated in federal prison for mortgage
16	fraud.
17	Also, during the interview Officer
18	McCloud advised that he met several people in the
19	real estate field and he purchased properties
20	from them in the same manner as the
21	aforementioned real estate deals.
22	Officer McCloud admitted to receiving
23	payments (kickbacks) after each of the closings.
24	Following the purchase of the property officer
25	McCloud stated that he would make a couple of



1	mortgage payments and then stop paying.
2	The FBI showed Officer McCloud a
3	uniform residential loan application or URLA that
4	he had filled out for a property located at 14511
5	Wilshire. It is documented he earned \$8,100 in
6	rental income and had an account balance of
7	\$56,220 at the T&C Federal Credit Union.
8	Officer McCloud admitted that the
9	information was false. The officer also was
10	shown several other URLA applications and he
11	admitted they contained false information.
12	On December 9 at the United States
13	Eastern District Court in Detroit Officer McCloud
14	was indicted by a federal grand jury charging him
15	with three felony counts of bank fraud, violation
16	of Title 18 USC 1344 and one felony count of
17	conspiracy to commit wire fraud, violation of
18	Title 18 USC Section 1349 resulting in the
19	issuance of felony criminal complaint Number
20	10-CR-20743.
21	On December 16, 2010 Police Officer
22	Keith McCloud, Badge 3739 assigned to Narcotics
23	was charged with three felony counts of bank
24	fraud in violation of Title 18 USC Section 1344,
25	one felony count of conspiracy to commit wire



1	fraud, a violation of Title 18 USC Section 1349.
2	On December 16, 2010 the officer was
3	suspended by the department. On December 17 at
4	the U.S. District Court in Detroit he was
5	arraigned before Magistrate Mona Majzoub and
6	issued a \$10,000 unsecured personal bond.
7	It is recommended by the chief that he
8	be charged with the following: Conduct
9	unbecoming an officer contrary to the Law
10	Enforcement Code of Ethics, this being in
11	violation of the 2003 Detroit Police Department
12	Manual Series 100, Directive 102.3-7.9, conduct
13	unprofessional command 1, and the chief of police
14	Ralph L. Godbee, Jr recommends the Board's
15	concurrence and suspension without pay.
16	Unless the Board contravenes, the
17	recommendation, the suspension without pay, will
18	stand.
19	COMMISSIONER WARFIELD: The suspension
20	without pay will stand. Thank you, sir.
21	At this time we will enter into oral
22	comments. If you wish to address the Board of
23	Police Commissioners you may come to the podium,
24	give us your name and state your case as they
25	say. We ask that we abide with our 4-minute time



1	limit.
2	MR. SCOTT: Ron Scott, Detroit
3	Coalition Against Police Brutality. Pastor
4	Warfield, I echo the statements you made at the
5	beginning of the meeting.
6	And Assistant Chief Logan, if you look
7	back on your cell phone you'll see that I called
8	you that day. I was not able to reach you for
9	obvious reasons, but I wanted to reach out to you
10	at that particular point. I hope I dialed the
11	right number at any rate.
12	But at any rate but you probably had
13	so many calls until it was probably not one that
14	could have probably gotten through at that point,
15	but I just wanted to tell you that on the record.
16	I do want to say that in our other
17	framework of the Coalition Against Police
18	Brutality we have a program which Pastor Warfield
19	is familiar with called Peace Zones for Life and
20	I think this is a time, and we're stating this
21	now, that the coalition very soon is going to be
22	doing some major things related to the whole
23	framework of not just reducing violence, but
24	promoting peace.
25	And so within that context we invite



1	those in this room to join us in that prospect
2	because I suggested to Pastor Warfield that we
3	talk about what circumstances could we do before
4	situations like this happen, how can we not
5	necessarily always predict what people might do,
6	but we certainly can figure out what we might do
7	as a community in terms of how we deal with the
8	circumstances that, in some cases, find their way
9	into our living rooms on television and in
10	newspapers in terms of the violence that's
11	rendered.
12	So I'm just suggesting that we look at
13	a mandate in terms of at one time police
14	officers were referred to as peace officers, so
15	I'd like to get back to that particular component
16	again and so I'm suggesting that you join with us
17	in terms of what we do in terms of Peace Zones
18	for Life activity. I got you two minutes.
19	And then the other thing I wanted to
20	ask was about the monitor's presence here in the
21	city. I had asked at the last meeting or not
22	the last meeting because I wasn't at the last
23	one, the time before last whether or not the
24	monitor will be available specifically to

citizens.

1	I know we had filed a motion to
2	intervene on behalf of the citizens and also
3	mentioned to the Police Commission and the City
4	Council in that some four years ago and that had
5	not been honored by the Court. But we still have
6	the same concerns that we have to have the voice
7	of citizens involved in that if we're ever going
8	to really move to get a full handle on the issues
9	in the Consent Decree, as you said, \$10 million
10	in lawsuits and so forth.
11	And we see ourselves as in terms of
12	what we do aiding in the resolution, shall I say
13	the diminishment of some of those be serving in
14	somewhat of a watchdog capacity. So within that
15	context I would hope that the monitor would want
16	to meet with us and that we can move to do that
17	since they're here in town.
18	I don't know I've seen the monitor,
19	I've seen him on occasions, but I think he needs
20	to be and his group at bodies like this where
21	people can ask them questions, where they can
22	discuss matters and that it not be like an
23	aberration passing through the night. Thank you.
24	COMMISSIONER WARFIELD: Thank you,
25	Mr. Scott, for your comments. Stay there one



1	second because actually I met with the monitors
2	right before coming here to this meeting and I
3	asked them that very question about the
4	opportunity to have a public forum and be
5	present.
6	And it did pose some legal problems
7	because of the position that they're in being an
8	extension of the Federal Court, and but
9	however, certainly is willing to come and to
10	address the Chair as relates to the process and
11	the progress of the Consent Decree and the fact
12	that we either are or are not hitting the targets
13	that have been set out, so we are in the process
14	of doing that.
15	There's also the issue of him becoming
16	the media, there's an issue with the media and
17	his role where he does not want to become a
18	so-called media figure so to speak, and I
19	probably just misinterpreted what he said, but
20	so there are some things that we can work out.
21	But we did discuss that today and we
22	will work something out where he can come and
23	address and update the committee through the
24	Chair what the progress has been and certainly in

the forum like this, the committee or the

1	community can talk to the Board and express what
2	real concerns that the community might have as
3	relates to progress or lack thereof as relates to
4	the Consent Decree.
5	MR. SCOTT: Well, I'm not so much
6	concerned as I am I am obviously concerned
7	about the progress, but I'm really more concerned
8	about a philosophical framework and a cultural
9	context wherein individuals who are paid millions
_ 0	of dollars to not see themselves as by the
1	citizens of the city the Detroit as responsible
_2	and responsive to come before that body and there
_3	was a monitor who's been much maligned because
_ 4	she took a lot of money and was not available.
_5	I have to say that that particular
_6	monitor who was maligned met with us and it was
. 7	privately done, but met with the community too.
_8	And I think that in this circumstance

And I think that in this circumstance the very least — he doesn't have to become a media figure. Chief Warshaw knows all too well that if he wishes to make statements he can make a statement on behalf of the Court or on behalf of his position without necessarily compromising what it is, but I just think the presence, the mere presence would lend clarity, would lend

1	seriousness to what citizens have wanted.
2	And I feel very on a personal level
3	offended because it was we in the amongst
4	the citizens who asked for an involvement to try
5	to provide reform to the department and then now
6	we have to stand on the outside looking in.
7	And I compared this once again and I
8	told the judge in the case earlier said this
9	is very very problematic and if you don't have
10	this citizens saying anything, even if you bring
11	them here to the man who's getting the money, to
12	the people that the City of Detroit is paying,
13	then I don't think we'll have a cultural shift.
14	We talked about cultural shift within
15	the department. I think some of the men and
16	women in the department are interested in making
17	a cultural shift, but we have to make the
18	cultural shift in terms of how they report to us
19	about what they do.
20	COMMISSIONER WARFIELD: Okay, thank
21	you, sir. I hear you loud and clear, but we'll
22	definitely work something out.
23	MR. DAVIS: Good evening. My name is
24	Elder Anthony Davis, Sr from AC Towing. My hat
25	goes off to the Detroit Police Department. I



1	pray for the Detroit Police day and night, Board
2	of Commission, City of Detroit, even the State of
3	Michigan.
4	I have family members that are police
5	officers. I have some that have retired and I
6	love this great city. You know, I came before
7	the board talking about Tow West and Tow East and
8	nowaday on a Tow West they just said that we only
9	can tow in the precinct that we tow for.
10	Two weeks ago I had told you that my
11	driver was sent on a call and we had called
12	dispatch about a car, and then they called us
13	back and said Tow West is not working.
14	That was the young man they found dead
15	in the car, that car was there two weeks ago that
16	my driver that found, you know.
17	We live in that neighborhood and we're
18	real close in the neighborhood and they call us
19	and if they see something suspicious, they call
20	us and we said we can't touch it, we have to call
21	dispatch, which my driver did. He was on the
22	news.
23	And I believe the young man's name was
24	Jim Mullen that they found dead in the car. That



was the car that we couldn't recover. We called

1	and they didn't have nobody Tow West was working.
2	There's a lot of things that AC Towing
3	do in the community and then if we see something
4	wrong, we reports it and it seems like we get the
5	short end of the stick. Now they say we're only
6	first they said we can tow in Tow West. We
7	usually stay in Central District where my
8	business located at, we do 10 and 12.
9	Now, there's a company that can tow all
10	over the city, but now they just handcuffed us
11	only in 10 and 12. It seems like same business,
12	they just move it around, you know, just tighten
13	up because there's a lot of mens that I know that
14	tow for the tow company that's not going to go in
15	that area because they scared. We not scared.
16	God didn't give me the power of fear, but the
17	power in the Holy Ghost. See, I'm not scared of
18	the human race. Some men are and some is not.
19	When we see strange things, we look
20	into it, we call, but the results, it seems like
21	another tow company gets it or we don't even get
22	it, our hands are tied.
23	COMMISSIONER WARFIELD: I know that,
24	Elder Davis, last week you had brought us some
25	concerns regarding Tow East and Tow West and I

1	know that Deputy Chief Tolbert at that time said
2	that they're working on a new system and if we
3	can get an update from that, plus if maybe Deputy
4	Chief Tolbert through the assistant chief it's
5	okay, if you can maybe address his concern as it
6	relates to the car that was on the east side or,
7	better yet on the west side, but being told
8	that he only could tow in the precinct where he's
9	located in.
10	So if you can allow him to come up,
11	he's right behind you.
12	DEPUTY CHIEF TOLBERT: Good afternoon,
13	Deputy Chief Tolbert. In regards to the
14	what's going on, tomorrow the SOPs are due from
15	the various aban officers which will allow us to
16	now sit down and develop a city-wide process in
17	the towing procedures.
18	As to the rules, I'm understanding that
19	you were told what now, that you would not tow
20	outside of the district in which your business
21	resides?
22	MR. DAVIS: Yeah because we found four
23	cars I'm in Central District. They said we
24	couldn't get it.



DEPUTY CHIEF TOLBERT: You couldn't get

1	them at all or you weren't up:
2	MR. DAVIS: No, no, I'm not talking
3	about in rotation. I'm talking the cars that my
4	drivers found. You know, they seen a stolen
5	vehicle and a vehicle or the neighbors will call
6	us, then we're called and they say we'll call
7	dispatch. We asked for Tow West. Tow West is
8	not working. When they did send a driver out
9	I mean a police officer out, we was four blocks
10	on the other side of Schaefer. My driver found
11	three cars. They say you can't get them because
12	that's in Southwest.
13	DEPUTY CHIEF TOLBERT: Well, I would
14	have to say from my understanding the rules, you
15	can only tow in the areas that your business is
16	located. If you were four blocks outside
17	COMMISSIONER WARFIELD: No, not yet.
18	You all told you we couldn't put that in place.
19	DEPUTY CHIEF TOLBERT: If that's the
20	case, let me find out what the issue is, but if
21	I'll find out why.
22	LIEUTENANT ADAMS: Lieutenant Adams
23	from Resource Management, good afternoon.
24	Currently you can only do that as a tower in the
25	districts or precinct that you're authorized to



1	tow in.
2	If you're let's say you're a tower
3	in the 10th Precinct. You can't go recover a car
4	in the 8th Precinct. We want to keep it within
5	the districts that you're currently authorized to
6	tow in as that plan is developed.
7	COMMISSIONER WARFIELD: Okay. May I
8	ask a question and then Commissioner White has a
9	question as well.
10	So what is the criteria for being
11	qualified to tow in a specific area? In other
12	words, what mandates you to a specific area?
13	LIEUTENANT ADAMS: Well, right now
14	we're going under the I'm trying to figure
15	out, I'm at a little loss for words right now
16	we're going under the districts that the towers
17	are currently authorized to tow in.
18	COMMISSIONER WARFIELD: So it sounds
19	like to me that you have implemented the new tow
20	rotation.
21	LIEUTENANT ADAMS: We haven't
22	implemented the new tow rotation. We're
23	currently operating under the rotation that's in
24	place.
25	So the rotation that's in place now, if



1	you're authorized to tow in that district, then
2	you can recover a car in that district, but if
3	you're authorized in 10 and 12, you can't go to 6
4	and 8 and find a car and call Tow East or Tow
5	West to come recover that vehicle.
6	COMMISSIONER WARFIELD: Okay, so I'm
7	going to back up to my question, my first
8	question then.
9	So what qualifies ABC Company to tow in
10	the Southwest District? What are the
11	qualifications?
12	LIEUTENANT ADAMS: The current
13	qualifications or the qualifications we're going
14	to got forward?
15	COMMISSIONER WARFIELD: Current
16	qualifications that prevented Elder Davis from
17	towing somewhere else, the current qualifications
18	right now that you're operating under.
19	LIEUTENANT ADAMS: Because Mr. Davis
20	isn't authorized to tow outside of the districts
21	that he's authorized to tow.
22	COMMISSIONER WARFIELD: No, no,
23	that doesn't answer my question. My question is,
24	what prevents or what qualifies ABC Towing
25	Company to became a qualified tower in Southwest



1	Detroit?
2	What are the requirements?
3	LIEUTENANT ADAMS: From my
4	understanding, the requirements that were put
5	into place years ago before I arrived in Resource
6	Management. That is one of the issues why we're
7	going to implement a new tow rotation because I
8	can't really tell you how those rotations were
9	divided from an administration that was maybe
10	three or four before myself.
11	All I know is I'm going under the
12	rotations that are currently in place.
13	COMMISSIONER WARFIELD: So if nothing
1.4	qualified you to be a tower in a specific
15	district, how can something disqualify you from
16	being authorized to tow if there's nothing that
17	qualifies you to be an authorized tower?
18	LIEUTENANT ADAMS: I understand your
19	question now. When those towing permits were let
20	years ago, you had to prove that you were
21	there were a number of qualifications. Number 1
22	that you had the equipment to do it, that you
23	were zoned to do it, that you had your income tax
24	paid for and maybe Officer Clark could fill me
25	with more of those things, but Officer Clark,



1	was that about 12 years ago?
2	OFFICER CLARK: Yes, sir.
3	LIEUTENANT ADAMS: That there was a
4	list of qualifications that were entered in.
5	Towers were able to apply to the then deputy
6	chief of Management Services Bureau.
7	That rotation and those permits were
8	then granted by the deputy chief of the
9	Management Services Bureau 12 years ago.
10	COMMISSIONER WARFIELD: Everything you
11	said to me just now as relates to those
12	qualifications I believe Elder Davis has met.
13	It does not everything you just
14	said, nothing you've said, from what I've
15	understood, has disqualified him.
16	He's a qualified tower. My question
17	again is, what is the requirement that says this
18	is the only area that you can tow in?
19	Maybe Officer Clark can answer that
20	question.
21	OFFICER CLARK: Officer Clark for the
22	record. Sir, what qualifies him, first of all,
23	is that all of those qualifications that the
24	lieutenant mentioned, he is a qualified tower.
25	However, what makes the distinction is



1	is that he is assigned to a particular area and
2	under Tow East and Tow West within those
3	guidelines he is assigned to that particular
4	area, so he cannot deviate and go outside that
5	area to tow.
6	COMMISSIONER WARFIELD: How does one
7	what is the check-off box? What determines what
8	area you get assigned to?
9	OFFICER CLARK: He's already assigned
10	to
11	COMMISSIONER WARFIELD: That's not my
12	question. My question is, what is the check-off,
13	what is the qualification that says this is the
14	area that you get assigned to?
15	OFFICER CLARK: Those assignments were
16	made
17	COMMISSIONER WARFIELD: That's not the
18	answer. What is the qualification, what is the
19	rule that says this is the area that you're
20	assigned to?
21	I understand this was done years ago,
22	but even if we go back in reference, there has to
23	be something that says there has to be
24	something somewhere I would hope that says you
25	are regulated to tow in this particular area



1	because of these conditions.
2	I'm sorry, deputy chief might want to
3	help me out.
4	DEPUTY CHIEF TOLBERT: Sir, I'm going
5	to tell you, I'm just as confused as you are.
6	COMMISSIONER WARFIELD: Thank you, sir.
7	DEPUTY CHIEF TOLBERT: So it seems as
8	though you're asking what is the criteria that
9	people were assigned the areas and I don't think
10	anybody here can answer that.
11	Can you answer that? So what I will
12	do, we will get those answers for you and we will
13	come back and as much as we can understand what
14	the criteria is that people are assigned, we will
15	let you know.
16	COMMISSIONER WARFIELD: But until that
17	happens, Elder Davis should be able when he
18	finds cars because we don't know what that
19	criteria is, should not be prohibited from towing
20	those cars because we have no criteria that we
21	can talk about or that you can talk about that
22	tells us what stops you from towing from one side
23	of the city to another.
24	DEPUTY CHIEF TOLBERT: And if you put
25	it that plainly, it sounds very much that is



1	correct, but let me make sure that that is the
2	case and if that is the case, then we will make
3	recommendations.
4	However, I can assure this board that
5	one of the reasons why we're looking we have
6	the aban officers coming in to develop the
7	process to implement everything, the rules and
8	the aban process so we will get our arms all
9	around this, but right now I agree with you. It
10	is confusing and we probably need to go back and
11	get someone who knows why these limitations were
12	put on, which I don't think anybody here has that
13	has a single they have no knowledge of why
14	that happened or how that happened.
15	COMMISSIONER WARFIELD: Commissioner
16	White and then Commissioner Stewart.
17	COMMISSIONER WHITE: DC Tolbert, at the
18	previous meeting you stated you needed two weeks
19	to get back to us on the process.
20	Does this new process address the
21	majority of these issues that we're discussing?
22	DEPUTY CHIEF TOLBERT: Absolutely.
23	Tomorrow is the day we meet with the aban
24	officers to develop the new process. Tomorrow
25	will be two weeks to the day and at the next



1	meeting we should have some progress to present
2	to the board as far as the process.
3	COMMISSIONER WHITE: As a
4	recommendation, Mr. Chair, I think a number of
5	the deliberations that may be geared towards
6	towing, if it could maybe be possible to table
7	the majority of that discussion until such a time
8	we've had an opportunity to get that process, I
9	think it will answer the majority of the
10	questions that both the Commission members have
11	and our public has and we can speak to it more
12	and if we could, DC Tolbert, get it prior to the
13	Thursday meeting so we can be abreast of what
14	this new process is.
15	Because I think this has been a
16	recurring theme that's been going since December
17	9 and it's been a recurring theme and I just
18	think we got to get to a point where we have a
19	process a little bit differently, so I have a
20	document and I like to A-B-C and it makes sense
21	to me that way.
22	So I just think it's been a revolving
23	door in terms of what our rules and policies are,
24	so I think this opportunity that DC Tolbert
25	presented at our last meeting for two weeks will



1	give us a clear opportunity to say unequivocally
2	to the public, this is what the rules and process
3	is and if we have challenges to the rules and
4	process, we can begin to implement those at such
5	time, but right now I think we're throwing rocks
6	in the dark and I want to have a clear target.
7	COMMISSIONER WARFIELD: To address your
8	concern, Commissioner White, before Commissioner
9	Stewart speaks, I have a little bit different
10	take on it only from this standpoint.
11	We have and I think the chief did
12	address it appropriately last week that
13	certainly we don't expect the police department
14	to adjust its operations in an effort to follow
15	the towers, we understand that clearly.
16	However, when you do have a tower who
17	is doing their business, is doing their due
18	diligence to help from an environmental
19	perspective, keep the streets clean, keep it safe
20	so that that abandoned vehicle does not become a
21	haven for crime, for potential crime, I think
22	that because we have a lack of direction in this
23	right now, that those towers who find those cars
24	in the interim until we can figure out what it

25

is, those towers who find those cars ought to be

1	able to tow those cars in the interim until we're
2	able to determine what the real policy is, and
3	certainly we understand, we recognize that there
4	is ambiguity at best as relates to a policy or
5	lack thereof, but in the interim while they're
6	doing their due diligence to keep the streets
7	clean, to keep the streets safe and to not allow
8	those vehicles to become safe havens for
9	criminals or criminal activity, it would be very
10	it would be a good olive branch extended to
11	this Board if we could at least in the interim
12	until policy can be defined let them who find
13	those cars tow those cars.
14	DEPUTY CHIEF TOLBERT: And I would
15	defer through the chain, my chain, and I will
16	definitely I'll send that up.
17	COMMISSIONER WARFIELD: But do you
18	think we could get a time frame on when we might
19	get a decision, maybe two or three days or
20	DEPUTY CHIEF TOLBERT: I will be
21	talking to someone when we leave here, sir, so as
22	soon as we can.
23	COMMISSIONER WARFIELD: Thank you, sir.
24	Commissioner Stewart.
25	COMMISSIONER STEWART: Through the



1	Chair, you know I think to clarify what
2	Commissioner Warfield was talking about, even
3	with political politics, you have a district, so
4	you have a map that shows your area and this will
5	clarify everything.
6	If he only could tow a certain
7	distance, you should have maps and stuff that
8	show how far he can go, street lines and stuff
9	like that, then they will know exactly where to
10	go.
11	I don't know if they could do that or
12	what they do, but I know if he says he can't tow
13	four blocks from where he's at, it's got to be
14	some kind of dividing line right there the same
15	as districts, so I think that's what you're
16	trying to clarify.
17	COMMISSIONER WARFIELD: Here's what I
18	don't want. I don't want us to start making up
19	maps now that did not exist then. I want us to
20	research what the policy was, like you said, 10,
21	12 years ago and find out or even two or three
22	years ago to find out how a certain tow company
23	was able to tow either across the city or in a
24	specific area and that would just be very



25

helpful.

1	DEPUTY CHIEF TOLBERT: Like you, I've
2	been hearing that a lot and I don't have the
3	answer and actually that falls under DC Lee's
4	shop, so I will be talking to him about that and
5	make the proper recommendations.
6	COMMISSIONER WARFIELD: Assistant
7	chief.
8	ASSISTANT CHIEF LOGAN: Yes, sir.
9	Through the chair, I just want to ensure that the
10	mandate you've given us through DC Tolbert, that
11	we don't widen the scope of this whole towing
12	issue.
13	I think specifically when DC Tolbert
14	indicated that he was going to get involved with
15	the abandoned car portions, we were strictly
16	talking about Tow East and Tow West.
17	COMMISSIONER WARFIELD: Absolutely,
18	you're right.
19	ASSISTANT CHIEF LOGAN: So that's
20	really I want to make sure that the Board
21	understands that that's our focus. Now, I was of
22	the opinion that we were going to look at that
23	narrow issue and deal with abandoned cars, so I
24	don't want we're not trying to circumvent any
25	rules we've already put in place.



1	We're strictly talking about how we
2	deal with abandoned cars.
3	COMMISSIONER WARFIELD: No oh,
4	absolutely. Yes, sir, we're definitely on the
5	same page with that, how we deal with abandoned
6	cars. But very specifically to that, how we deal
7	with abandoned cars when they are found, then
8	what is the established policy that was in place
9	because it sounds like to me and you all help
10	me if I'm wrong it sounds like to me we're
11	talking two different things.
12	It sounds like to me we're talking
13	about abandoned vehicles, but in an effort to
14	justify or disqualify Elder Davis from towing
15	that vehicle, we're using policy that is not
16	germane specifically to abandoned vehicles, but
17	we're using it to exclude him from towing that
18	car.
19	I mean, that's what it sounds like
20	because, again, if it was an abandoned vehicle
21	policy if it was abandoned vehicle policy only
22	and if it's only Tow East and Tow West, then what
23	happened 10 and 12 years ago under an authorized
24	tower contract then would not necessarily come in
25	play as relates to a location.

1	If it does come in play as relates to a
2	location, I'll go back to my original question.
3	Then what is and we'll find that out of course
4	then what is that requirement that puts you in
5	one district versus another.
6	DEPUTY CHIEF TOLBERT: And we'll check
7	that out because it has to go back to the
8	implementation of the Tow East - Tow West rules,
9	whatever those were.
10	COMMISSIONER WARFIELD: Which weren't
11	really rules or policies we found out last week
L2	which was a pilot program that did not have
13	that was on the record, that did not have any
14	that no one signed off on.
15	It was an experiment from what we were
16	told last week in this meeting. It was an
17	experiment.
18	DEPUTY CHIEF TOLBERT: I understand
19	that.
20	COMMISSIONER WARFIELD: I got you,
21	okay. It wasn't this administration. Here's
22	what we do know. It wasn't this chief, we
23	definitely know that, that it was not this chief
24	that implemented that temporary policy.



So that's why I'm saying we're talking

1	about two different things because we're talking
2	about something that may have started a year and
3	a half ago versus something that started 10, 12
4	years ago.
5	DEPUTY CHIEF TOLBERT: And we're going
6	to look and see if there's any crossover in that.
7	That's then the issue.
8	COMMISSIONER WARFIELD: Yes, sir, there
9	we go. Absolutely.
10	MR. DAVIS: I wasn't just talking about
11	the abans, I'm talking about the stolen recovery.
12	COMMISSIONER WARFIELD: Okay,
13	absolutely.
14	MR. DAVIS: They blackballed me. The
15	old administration, when I was supposed to have
16	been an aban towing company, they kicked me to
17	the side. They said either I can be in rotation
18	or aban tower. That was Clark, not this Clark.
19	I had to be either/or.
20	Then it comes to find out when I saw
21	I'm going to stay in rotation, he put them other
22	companies as aban and they in rotation and doing
23	aban. They just sidebar me right off.
24	COMMISSIONER WARFIELD: Elder Davis, I



think you bring up an excellent point and I think

it's going to be critical the information that
Deputy Chief Tolbert brings back and even Police
Officer Clark as relates to Tow East and Tow West
because Tow East and Tow West deals with all of
those categories.
And so I think you're right, I think we
finally hit a nail on the head and
MR. Davis: I've been going to the
east side, I'm staying on the west side.
COMMISSIONER WARFIELD: Yes, sir, yes,
sir.
MR. DAVIS: I was staying close by
home so I can really clean up the area where I'm
at.
COMMISSIONER WARFIELD: Yes, sir.
MR. DAVIS: Even in 10 and 12. I'm in
Central. When my drivers see something or
people call us, we go over there and check it out
and we call and the other company gets it, but we
don't get it, so you all pray for us and I hope
that I won't be blackballed.
COMMISSIONER WARFIELD: We're going to
do more than pray, we're going to work to get
this thing straightened out.



MR. REGAL: Good afternoon. Greg Regal

1	from Michigan Auto Recovery. I'm a police
2	impound yard for the City of Detroit and happy to
3	be so.
4	If I could explain real simple and
5	easy. When the I'm an aban yard and a
6	rotation yard, okay. When the Communications
7	started dispatching our calls on the control
8	numbers, it put everybody on an even kilter which
9	was excellent.
10	Then there was cars that us towers that
11	were out all day long, out and about, what have
12	you, our drivers, what have you, find stolen
13	cars.
14	So we went to the chief or the Board, I
15	don't remember which one, and we requested that
16	we as towers know where there's a lot of stolen
17	cars, but we're not going to tell nobody because
18	if we're not next on the rotation sheet, this is
19	rightfully so, then we're not going to get the
20	credit for finding it.
21	So a memo came out from the chief of
22	police, Chief Evans, saying that if a tower knows
23	where a stolen car is, it has to be stolen, not
24	aban, "stolen" were the exact words, okay,



stolen, you have a Tow East which was a pilot

1	program which you just said, sir, and a Tow West.
2	You called Communication with a VIN
3	number, they decipher if it's stolen or not. If
4	it is, you sit on it. They let us know it's
5	stolen, we'll send Tow East or Tow West to
6	recover the car and whatever company found the
7	car that's sitting there gets to recover the car
8	with the officer and take it to our yard.
9	There was no we're just talking to
10	Tow East and Tow West only, nothing to do in the
11	abans, don't even go there. This is just Tow
12	East to Tow East with these stolen cars that we
13	find.
14	There was no mention of you have to
14 15	There was no mention of you have to stay in your own precinct or district. Basically
15	stay in your own precinct or district. Basically

you're an aban tower or rotation tower. It could

1	be both or one or the other.
2	But for them particular little cars
3	that you find that requested Tow East or Tow West
4	that they tell you that you're qualified to pick
5	it up and to wait for the officer, you could go
6	to any district or any precinct of your willing.
7	Now, from what I understand they
8	stopped Tow East and Tow West and they're going
9	to institute a program that they're talking with
_0	from what I heard with aban officers to whatever.
1	But all I can tell you is that the City
_2	of Detroit is doing their absolute best to try to
_3	come up with a resolution to these problems so we
_ 4	can move forward.
_5	So that's exactly the whole story about
_6	Tow East and Tow West. It was an overnight
. 7	program and they can diminish it overnight again
_8	immediately. It was a pilot program. Didn't
9	have nothing to do with an aban. If you called
20	the car in under Tow East - Tow West conditions
21	and it turned out to be an aban, you can't touch
22	it. They will call the aban officer and it ain't
23	got nothing to do with you. It goes directly to
2.4	the aban yard of that precinct or what have you.

That's it.

1	COMMISSIONER WARFIELD: Thank you,
2	Greg. Appreciate that, sir.
3	MS. SEMMA: Good afternoon Board and
4	assistant chief, Julie Semma from Seventies
5	Towing.
6	In 2005 there was a rotation that was
7	implemented when the districts changed and then
8	in 2007 overnight a memo occurred and all the
9	changes happened with the exorbitant amount of
10	towers that were able to tow throughout the
11	entire city.
12	Now Seventies, I know several of the
13	tow companies submitted applications to tow in
14	other districts. Seventies is currently located
15	at 5700 East Nevada near the Northeast District.
16	We're within 15, 20 minutes away from towing in
17	the Eastern as well as Central District.
18	We've had numerous times submitted
19	applications in to request for towing in these
20	areas. We receive letters saying that we're very
21	happy with your service, we're doing great
22	service, and unfortunately we don't need your
23	service right now because they have an ample
24	amount of service being served by somebody else.
25	That's been my ongoing problem for the



1	entire time as far as the unfairness and the
2	unequalization as far as towers throughout
3	everybody.
4	And I think that if a yard has almost 7
5	acres and is able to provide service, then why
6	can't a company be able to be able to tow into
7	other districts if they're located on the east
8	side and tow in those areas and that's what these
9	problems are having as we get we're not
10	obligated to tow, but somebody else is.
11	We have situations right now where TEU
12	has been towing. We haven't had a TEU in almost
13	a month and sometimes people haven't had them in
14	two or three months.
15	COMMISSIONER WARFIELD: What's TEU?
16	MS. SEMMA: TEU is Traffic Enforcement
17	Unit where they come and they tow certain
18	vehicles if you don't have insurance or don't
19	have a driver's license, they tow your vehicle.
20	And when they do do those tows, any
21	person who's up for towing is able to tow
22	anywhere from 15 to 20, 30, 40 cars a day. Well,
23	it goes in rotation, but unfortunately three
24	companies owned by one person is in my district,
25	so I only get one to every three he gets. So we



1	haven't had that opportunity to tow again.
2	So this has been an ongoing battle for
3	a long time. So until this whole rotation thing
4	changes and I thought that we were going to
5	hopefully get this rectified I mean, it was
6	supposed to have been done December 30th and here
7	it is almost a month later and still hasn't been
8	done, but this is never going to change if these
9	tows don't if the rotation doesn't change.
10	The one to two tows we haven't
11	currently had a Tow East in two days and we can't
12	tow any cars if we find any because there isn't a
13	Tow East person to recover the cars.
14	So if you guys want to say an extra
15	month, another two weeks, another 30 days, buying
16	more time, you might as well just tell all the
17	towers to shut their doors because we can't do it
18	anymore.
19	COMMISSIONER WARFIELD: Let me say this
20	to our towers to our citizens. Certainly we
21	at the last community meeting we had which was at
22	New Prospect Baptist Church a few weeks ago, we
23	were given the charge to be on a conference call
24	with the Legal Department and to discuss the



rotation and what the attorneys from the City's

1	opinion was, and there was some misconception as
2	related to them being informed initially that we
3	were trying to start something that was new and
4	different that was outside of the scope of the
5	rules that were passed and the mayor and the
6	chief had signed off on.
7	Once they have received the correct
8	information, they sent communications that it was
9	okay to start the rotation. From our conference
10	call that we had, we forwarded the information
11	that we discussed from that conference call to
12	the deputy mayor with the attorney's
13	recommendation, the attorney from the City's
14	recommendation that we move forward in the
15	process.
16	So we did what the attorneys of the
17	City has asked us to do. The great thing about
18	being in this position is that we get an
19	opportunity to work with what we believe is an
20	excellent police force. We do, we think Detroit
21	Police force is excellent. We thank God for our
22	chief and for our command staff.
23	One of the interesting moments about

24

25

setting policy with the Board is that as relates

to the City Charter this Board, to be very frank

1	and honest, does not have the teeth to enforce
2	the policies that we set.
3	We thank God that this department by
4	and large, you know, adheres to the policy that
5	is set without question. However, in this one
6	instance we are still as a board somewhat
7	dismayed I should say very dismayed how
8	about that we are still very dismayed of the
9	fact that the rotation is not in effect and
10	certainly we will be in contact again with the
11	deputy mayor who is, of course, head of public
12	safety in the city of Detroit and ask him to
13	swiftly intervene that we may come to what we
14	believe is an equitable resolution to this
15	situation.
16	So, again, we understand your patience.
17	I don't think any board that you have visited
18	before you have gotten this far.
19	MS. SEMMA: I thank you.
20	COMMISSIONER WARFIELD: We're like on
21	the edge and ready to jump in full steam ahead
22	and we'll get there, we really will get there.
23	You know, whenever you're moving
24	systems and processes unfortunately it takes much
25	longer than we even like for it to take, but we



1	have not forgotten, we are moving full steam
2	ahead and we're using every avenue that we can to
3	do that.
4	We're in front of the City Council
5	Subcommittee, Councilwoman Brenda Jones'
6	subcommittee this week discussing this issue and
7	that subcommittee is in full agreement with us as
8	well.
9	So we are hoping we really are
10	hoping that we move forward with this rotation
11	because it's just the right thing to do in our
12	opinion.
13	MS. REMMA: Two weeks ago I had asked
14	you guys to see if you guys could come up as far
15	as kind of the same question you asked earlier.
16	How did the towing rotation or memo go in effect.
17	Did you guys get those answers?
18	COMMISSIONER WARFIELD: Yes, we did get
19	them and you can see our attorney afterwards and
20	we'll get those to you. Absolutely we have them.
21	Thank you.
22	MS. REEMA: Okay. Thank you.
23	MR. FOSTER: Good afternoon, Board,
24	assistant chief. Barry Foster with Allied JBS
25	Towing.



1	I just wanted to make some
2	clarifications for some past statements that were
3	made. We worked diligently with Chief Evans when
4	he was chief. We were working with his task
5	force and we were able to go anywhere in the city
6	of Detroit to tow a vehicle.
7	After the resignation of him I believe
8	Tow East and Tow West came into play. At that
9	time we were told there is boundaries. I had a
10	short incident that happened with one of our
11	drivers that because we tow for the Northeast
12	District, we were on the borderline in Eastern
13	District and an Internal Affairs officer had
14	pulled up, made our driver drop the vehicle
15	because we were two blocks out of our district.
16	COMMISSIONER WARFIELD: Internal
17	Affairs?
18	MR. FOSTER: Internal Affairs. At that
19	point it was stressed to us that there is
20	boundaries, there is guidelines. You are to stay
21	in Northeast District, you're not to go into East
22	District.
23	And at that time we were aware that
24	there are guidelines and I think everybody's
25	problems that they're having is everyone wants to



1	know how to be able to go and get into another
2	district, and that's not happening.
3	But we did have an incident and we were
4	told when the Tow East and Tow West program was
5	implemented that there are boundaries. You are
6	to stay in your district and that's it.
7	COMMISSIONER WARFIELD: I just have a
8	question. I'm a novice and there are a lot of
9	things I don't know, so I'm asking out of my own
10	personal ignorance.
11	Why would an Internal Affairs officer
12	approach a tow truck and ask a tow truck to drop
13	the car?
14	MR. FOSTER: And the aban officer was
15	there also present and at that time when the
16	Internal Affairs officer I had called I
17	can't think of his name offhand, the commander,
18	Commander Stair, and at that time he told me he
19	was doing to look into it and said that has to
20	look into it, but there are boundaries that were
21	set and at the time we were out of our boundary.
22	And if we were out of our boundary, we
23	took full responsibility for it. We said okay,
24	we dropped the vehicle and they gave it to
25	another tow company which was an Eastern



1	District.
2	COMMISSIONER WARFIELD: Again, could
3	you help me with that? Can somebody help me.
4	Yes, sir, can you come to the mic.
5	Afterwards? Okay, sure. If you can
6	tell me afterwards, okay, sure, I appreciate
7	that. Thank you, sir.
8	MR. FOSTER: My point was, just to
9	clarify that, there were we were told there
10	were boundaries, so I don't know if all the other
11	tow companies were told, but we were told and we
12	stood by that.
13	COMMISSIONER WARFIELD: And from your
14	perspective, that's when Elder Davis, I'm
15	sorry, I can't let you come back that's when
16	Tow East and Tow West in your opinion started
17	because from what I've just heard from you there
18	were two, there was a Tow East and Tow West that
19	started after
20	MR. FOSTER: If I'm correct, yes,
21	because we were working with Chief Evans' task
22	force and at that time we were able to go
23	anywhere in the city to recover.
24	COMMISSIONER WARFIELD: Now, was that
25	during a because when I first came on board



1	there was an issue about a task force.
2	Was that during an Angel Night sweep?
3	MR. FOSTER: That was before all of
4	that.
5	COMMISSIONER WARFIELD: So it was two
6	separate okay, great. Thank you, sir, that
7	helps out. I think that helps a little bit.
8	All right. Next? Thank you.
9	MS. MANNING: Hello, my name is Nentha
10	(sp) Manning. And first thing I want to say is
11	I'm very thankful for the Detroit Police
12	Department, the men and women who serve.
13	I was before the events of last week,
14	but certainly I don't think anyone could not be
15	touched by the position that officers put
16	themselves in when they're on the streets.
17	Clarification about something that I
18	thought I heard today. When you were talking
19	about the budget and there were going to be areas
20	that were going to be cut
21	COMMISSIONER WARFIELD: I indicated
22	that we would suggest to the mayor and the City
23	Council to look into some areas that we could
24	possibly have some cost savings.
25	MS. MANNING: And did I understand you



1	to say that one of those areas that you were
2	going to suggest was the Investigative Unit, you
3	were suggested to have 11, but you were going to
4	suggest that it go down to eight and that would
5	be a cost savings measure?
6	COMMISSIONER WARFIELD: No, actually it
7	was additional. There were in the budget
8	because the chief took one of his assistant chief
9	positions and basically turned it over to the
_ 0	Office of Chief Investigations, that would equate
1	to that one position would equate to three
_2	civilian investigators.
_3	We had already as a board put in for
_ 4	what we needed which was eight. What we need is
_5	an additional eight we currently have 23, but you
_6	need an additional eight in an effort to make
. 7	sure that we are fulfilling the requirements of
. 8	our new procedures that comes out of the Consent
9	Decree.
20	So it was so the additional eight is
21	definitely what we need. Anything over that
22	would be excess.
23	MS. MANNING: So you were approved for
2.4	11, is that what I understood you to say?



COMMISSIONER WARFIELD: We weren't

25

1	approved for anything. These were just
2	MS. MANNING: I heard the term 11.
3	Where did that come from?
4	COMMISSIONER WARFIELD: We weren't
5	approved for anything. This is just
6	recommendations that's going this budget is
7	just a recommendation that's going over to the
8	mayor.
9	When you take the eight that we asked
10	and you take the three that the chief was going
11	is donating from one position that would
12	equate to three investigators, it gives you a
13	total of 11, which really would be excess for us.
14	Again, according to the amount of cases
15	that come in, especially when you do it on a
16	national average, it would put us right where we
17	need to be in an effort to make sure that no
18	cases are backlogged and to make sure that each
19	investigator has a case load that is equivalent
20	to what the national standard is.
21	And so if we add eight investigators to
22	the 23 that we already have, then that will put
23	us at the number we should be which is closer to
24	31.
25	MS. MANNING: This is just a suggestion



1	here.
2	COMMISSIONER WARFIELD: Yes, ma'am.
3	MS. MANNING: If we're paying out \$10
4	million for civil liability, then it would seem
5	to me that it would be pound foolish or penny
6	foolish to cut the number of people who do the
7	investigating that ensures the accountability for
8	the police department.
9	That's just my opinion. Even if it is
_ 0	excess, I would suggest that a police department
1	that's under a Consent Decree, perhaps we need
_2	some express in that department.
.3	COMMISSIONER WARFIELD: Ma'am, we're
4	not cutting anybody, we're not cutting any
_5	investigators, we're adding to the investigators,
_6	ma'am.
. 7	MS. MANNING: Okay.
. 8	COMMISSIONER WARFIELD: I know what
9	you're saying, but we're adding and it will be
20	wasteful, it would be wasteful for
21	MS. MANNING: That your I'm just
22	saying that's your opinion that it would be
23	wasteful.
24	COMMISSIONER WARFIELD: No, ma'am, it's
25	not my opinion, it's a fact. It would be



1	wasteful if we said that let us put three more
2	chairs here for cases where they basically will
3	be sitting twiddling their thumbs.
4	MS. MANNING: Okay.
5	COMMISSIONER WARFIELD: Thank you.
6	Next? Anyone else?
7	MS. HATCHER: Good evening, Board.
8	I'm Evangelist Dora Hatcher and I just want to
9	say, you know what, we all need to pray and, of
10	course, prayer without work, you have to do some
11	work.
12	You know, this fighting I know this
13	is police business to a degree as far as towing,
14	but I hope they get it together because every
15	time I come down there just about this is an
16	ongoing issue, and some type of way it should be
17	able to be resolved where we can all get along.
18	In our police department I need to know
19	if you're somewhere and there's a crime happening
20	and you're out of your district, do you pass it
21	up?
22	ASSISTANT CHIEF LOGAN: Through the
23	Chair. No, you shouldn't.
24	MS. HATCHER: So if our officers can



work together and work out like that, why can't

25

1	our towing people? We're all here together in
2	this city and we're struggling with a lot of
3	things.
4	Look at just what happened the other
5	day at Number 6. Thank God none of our officers
6	were killed and I hope you don't forget this and
7	that I'm from Northeastern District, I'm on
8	the executive board there, and I went by today
9	and I am so happy that have a screener sitting
10	there.
11	And I'm hoping that's everywhere and I
12	hope you all won't eventually say okay, we're
13	just going to let this go. If I'm not mistaken,
14	in Number 9 at one time did someone if my
15	memory serves me right came in bouncing a
16	basketball and then he started shooting?
17	And you see how we let that went by.
18	So let's really really put our thinking caps on.
19	There's a scripture in the Bible that talks about
20	this generation in Proverbs and I want to let
21	you know, we're in that generation they have
22	no morals, they don't have any respect for anyone
23	and they don't care about each other any more.
24	We don't love each other any more. We
25	don't care about each other any more and that's



1	what's wrong, not only with Detroit. It's
2	everywhere. It's all about, "My name is Jimmy,
3	I'll take all you give me."
4	We don't want to help one another and
5	somewhere somewhere we're going to have to
6	start helping one another getting out there like
7	the 300, they're doing, and getting out there and
8	putting forth some effort to help the officers
9	and everybody, our neighbors.
_ 0	We don't even help our neighbors. I'm
.1	one that do and I'm one that I'm not afraid
_2	either because God didn't give me the spirit of
_3	fear as the elder said, but of love and a power
_ 4	and a sound mind and anything that happens in my
. 5	neighborhood, in my block, I stand up.
_6	And we're going to all have to do that
. 7	and I want to let you know, I love you and I'll
_8	keep all of you, AC, in my prayers.
9	COMMISSIONER WARFIELD: Thank you.
20	ASSISTANT CHIEF LOGAN: Thank you,
21	Ms. Hatcher.
22	COMMISSIONER WARFIELD: Are there any
23	more from the audience, any more comments from
24	the audience? At this time we'll close that



portion of our meeting.

1	Commissioner White, you had something
2	for us?
3	COMMISSIONER WHITE: I did, through the
4	Chair. To our command staff, AC and the chief in
5	his absence, I just finished a series of
6	ride-alongs with both Central District and
7	Eastern District. I just wanted to commend our
8	leadership and our men and women.
9	I think and even DC Tolbert over
10	Patrol Operations, I had a glimpse into what our
11	men on the street are going through on a daily
12	basis and simple things in terms of
13	professionalism in dealing with the public, I
14	think you reiterating with the troops the very
15	essence of how we need to deal with the public is
16	permeating to the bottom level.
17	I was very impressed with what I
18	witnessed. I did about 10 hours on both
19	different days, so I was very impressed and for
20	what I saw from an observing standpoint, so
21	and I have some other things that are scheduled
22	where I will visit with some of the other
23	departments as well and I also wanted to lift up
24	your leadership in regards to the recent events
25	at the 6th Precinct to implement a new policy and
