As typical in community meetings, we would like to make reference to the role of the 12 13 Board of Police Commissioners. 14 The Board of Police Commissioners was 15 created by Charter July 1 in 1974. Its composition currently is a five-member appointed 16 17 by the Mayor and confirmed by City Council. 18 Commissioners serve five-year terms and 19 may not serve more than five years consecutively. 20 Commissioners meet once a week 52 weeks out of 21 the year. That's by Charter. All meetings are 22 open to the public and subject to the Open 23 Meetings Act. 24 The duties of the Commission are to 25 establish policies, rules and regulations in

recent news it was stated that the Detroit Police Department, i.e. the Office of the Chief Investigator, was in danger of going into backlog and under a court order it was said that if certain things weren't in order, we would re-visit \$1,000-a-day penalty by Federal Court for not being in compliance.

The Board of Police Commissioners, its 8 9 staff and our investigators have been working 10 very diligently and, again, Assistant Chief, we 11 certainly are thankful for the Chief's assistance 12 in the assigning of investigators from Recruiting 13 and to date we have made significant progress with our backlog status and citizens should know 14 15 we are currently interviewing aggressively for the investigator positions that are open as well 16 17 as the chief investigator position that are open 18 and we look forward to filling those positions in 19 the immediate future.

There is a process that individual candidates need to go to the federal monitors for review before hiring, but we are at the stage of recommending very qualified and capable candidates to join the Office of Chief Investigator to consistently work at bringing



that backlog status into control. 1 2 And just for the record, backlogs are 3 complaints that are filed by citizens of Detroit 4 that have gone beyond a 90-day window which by Consent Decree is not permissible. 5 So we're working very diligently to 6 7 keep a handle on the number of complaints that come in and do our due diligence to turn those 8 9 complaints around and have a full investigation 10 within that 90-day window. 11 So we will report back to you as we 12 continue to have progress within the Office of 13 the Chief Investigator as we move forward. 14 At this time, the Chair will ask for 15 the report of the Secretary. SECRETARY ANTHONY: Mr. Chair, for the 16 17 record George Anthony, Secretary to the Board. 18 There is no report. 19 COMMISSIONER WHITE: Thank you, sir. 20 At this time we'll have a report from the office 21 of the Chief, Assistant Chief Logan. 22 ASSISTANT CHIEF LOGAN: Through the 23 Chair, Assistant Chief Logan. The Chief of Police wanted the community and the Board to know 24 25 that he wasn't able to make it this evening

because he's on standby in case there's some 1 2 movement with contract negotiations, and I say 3 that to seque into the fact that I was just 4 informed that Commander Dolunt of the Eastern 5 District who was due to make a presentation this 6 evening has been called to the Mayor's office, so 7 I don't know what that means. Hopefully it's a 8 good sign, but we've got a capable sergeant who's 9 going to be doing the presentation for the 10 Eastern District and once he or she completes 11 their report, I want to ask Commander Decrease to 12 come forward and give the community and the Board 13 a brief overview of our Virtual Precinct. 14 COMMISSIONER WHITE: Yes, sir. 15 ASSISTANT CHIEF LOGAN: Would you just 16 be patient. He wasn't aware that he was going to 17 have to do the presentation. 18 SGT. GROSS: Good afternoon, everyone. 19 I'm Sgt. Gross, I'm the sergeant in charge of the 20 Community Relations over here at Eastern 21 District. My staff are here, Officer Brad 22 Hawkins and Officer Audrey Curtis. 23 As you know we've knocked our staff down considerably in the last couple of weeks 24 25 and, like someone said earlier, I wasn't prepared

9	The Eastern District located at 11187
10	Gratiot is one of the Detroit Police Department's
11	largest police stations. The Eastern District is
12	comprised of the 5th and the 9th Precinct. The
13	Eastern District encompasses 24 square miles and
14	is bounded on the north by East Eight Mile and on
15	the south by the Detroit River, west by McClellan
16	and east by Alter Road.
17	City of Detroit properties and private
18	property within the Eastern District consists of
19	Coleman Alexander Young International Airport,
20	the Water Works Park, Daimler Chrysler Jefferson
21	North Complex which extends from St. Jean and
22	East Warren to Conner and East Jefferson.
23	According to the results of the 2011
24	Census the Eastern District's total population
25	has reduced over the past 10 years and currently



there are just over 175,000 citizens and just 1 2 over 60,000 of those are juveniles. In the Eastern District there are 55 3 4 teaching facilities, four high schools, seven 5 middle schools, 10 parochial schools and we also have the Go Lightly Technical Center and Wayne 6 7 County Community College, Eastern Campus. The Eastern District has undertaken the 8 9 following steps. On average the Eastern District 10 answers approximately 2,000 9-1-1 calls every 11 week and we've been writing close to 500 tickets 12 every week. The Eastern District is deploying 13 mountain bike and scooter officers in the target areas to help reduce the burglaries and armed 14 15 robberies. The Community Relations Department has 16 17 been contacting and following up with the victims 18 of home invasions and breaking and enterings 19 along with following up with businesses that have 20 been robbed and broken into. We've also been

21 trying to revitalize the block clubs and the 22 community watch movement and we've recently 23 gotten ahold of all the past presidents and block 24 clubs and we're working on forming a partnership 25 with them and recreating a better block club

1	system than what we currently have.
2	We're planning on Police Week during
3	the month of May coming up and that's going to
4	build and strengthen our relationships with the
5	community and we're going to be teaching crime
6	prevention strategies working with neighborhood
7	watches and trying to develop some more citizen
8	patrols at which time we'll be inviting the
9	elementary schools and the middle schools to take
10	tours of our district and we'll have our Special
11	Response Team and our armored personnel carrier,
12	the APC, over there and they'll be given patrols
13	of that.
14	This past August we participated in the
15	National Night Out which we had a very good
16	turnout, had very good results. I'm looking
17	forward to working with that again next year.
18	And is this the point in the
19	presentation we present this award to Ms. Wilson?

3	citizens?
4	SGT. GROSS: We get some pretty good
5	feedback from that. We get a lot of good
6	information, some things we can do differently,
7	some different aspects we need to target and

9	COMMISSIONER WHITE: Thank you for
10	that, and I believe Commissioner Warfield had a
11	follow-up?
12	COMMISSIONER WARFIELD: Sergeant, to

that 4 o'clock cutoff hour? 1 2 SGT. GROSS: Correct. 3 COMMISSIONER WHITE: All right and so 4 the two officers that are still designated as 5 Community officers, how do they operate? Do they 6 still go out on the street, do they stay in and 7 if so, if they are in the station what hours are 8 they there? 9 SGT. GROSS: We typically work 8 to 4. 10 We attend a lot of block club meetings and 11 different community meetings, so our hours vary 12 greatly. And whenever we can get out and meet 13 with the victims of the burglaries and the 14 breaking and enterings and armed robberies. 15 COMMISSIONER WARFIELD: Okay, thank 16 you. 17 COMMISSIONER WHITE: Thank you very 18 much, sergeant. I believe next up is Commander 19 Decrease. 20 COMMANDER DECREASE: Thank you. Good 21 evening, Board and citizens. For the record, 22 Commander Russell Decrease from Tactical 23 Services. 24 I've been asked to give a couple-minute 25 overview of the Virtual Precincts and although

we've made presentations to the Board we're 1 2 constantly looking for any possibility, 3 especially to communicate to the community about 4 our change in service, and that's really what 5 this is. 6 About a year ago we started looking at 7 some of the best practices around the country of how to best utilize our manpower and how to best 8 9 use our resources to give the citizens the best 10 service possible. 11 The model that we had been using within 12 the department was either to send a two-man 13 emergency response unit to calls for service or to refer citizens to a precinct, and we would 14 15 have people in the precinct waiting for the citizens to come in. 16 17 When we looked at best practices around 18 the United States there are a number of major cities that had a different model. 19 They had a 20 group of people, civilians or sworn, who are able 21 to take reports city-wide across the telephone. The city of Detroit had actually been 22 23 doing this for approximately 20 to 25 years. Ιt had been a very large unit that had taken a 24 25 number of calls, but due to manpower cuts the

calls that they had taken and the hours they 1 2 would take had actually been cut down. 3 The Virtual Precinct basically came out 4 of making the Telephone Crime Reporting more 5 responsive to the citizens of Detroit and by 6 doing that we were able to scale back. The 7 general rule of thumb now is that most precincts 8 and districts, there will be two people who are 9 in the front lobby area of the precinct versus 10 previously there would be anywhere between four 11 and six. 12 During the hours of 8 AM to 4 PM there 13 is full service and free access into and out of precincts. After 4 PM there is limited access 14 15 and limited services available. Precincts are not closed at any time. If somebody comes in for 16 17 a police report to a non-serious, non-violent 18 crime after 4 PM they are admitted to the 19 precinct or district and they are directed to a 20 bank of phones over either on a wall or on a desk 21 where they can pick up and they're immediately 22 connected with an operator who can take the 23 report in a more timely fashion. 24 To give you some idea of some of the 25 efficiencies, Number 1, we are able to actually

transfer more officers from desk or non-patrol
 activities back to Patrol.

The second issue is it actually cuts down the wait time considerably. In some instances we would have one report clerk in a particular precinct and we would have three or four people waiting.

8 With this type of model since we're 9 pooling all of the resources together in one 10 place we can have three phones in a particular 11 precinct all going at the same time and it cuts 12 down and makes it more convenient for the 13 citizens.

The second thing is that we had a large 14 15 problem with trying to ask citizens to travel to our precincts and districts in order to make 16 17 reports. It's at times very inconvenient or in 18 some cases like in the instance of a stolen 19 vehicle it becomes very hard for a citizen to 20 come in and make a police report on a stolen 21 vehicle when their vehicle has just been stolen. 22 This type of model allows us to have 23 the citizen be directly transferred from 9-1-1 to 24 Telephone Crime Reporting and they can actually

make the report much quicker and much more

1 efficiently. 2 So far the feedback that we've received 3 has been very positive, not only from the 4 citizens, but also the 9-1-1 operators because it 5 gives them another avenue other than sending a 6 two-person emergency unit to a situation that 7 really doesn't require one. It's still a very serious crime, it 8 9 still needs to be reported and it still needs to 10 be followed up, but it does not require a 11 two-person emergency response unit. 12 That's basically the gist of the 13 Virtual Precincts. Is there any questions from the Board? 14 15 COMMISSIONER WHITE: Commissioner Warfield? 16 17 COMMISSIONER WARFIELD: Yes. Thank 18 you, commander. During the presentation to the Board earlier this week Commander Bettison 19 20 indicated that there were positions that were 21 posted for TCRU operators. Where can a citizen 22 find those postings and those who are interested, 23 where can they submit resumes? 24 COMMANDER DECREASE: Actually based on 25 the Personnel Department within the City what

they're doing is they're making those openings 1 2 available to other City employees who have been 3 laid off, so it's currently not open to citizens 4 at large to apply. 5 COMMISSIONER WARFIELD: Thank you, sir. 6 COMMISSIONER WHITE: Commissioner 7 Taylor? 8 COMMISSIONER TAYLOR: I just have one 9 question. With the Virtual Precincts around the 10 country what type of success have they had? 11 COMMANDER DECREASE: It's multiple 12 things. As I stated, Number 1, you have more 13 people that you're able to deploy to actually 14 respond to calls for service that require an 15 emergency response. Second thing is by pooling all of your 16 17 resources you're able to actually cut down the 18 wait times in some instances because you don't 19 have three people waiting to make a report. So the same successes that we're seeing 20 21 in the same areas are the same successes that had 22 been documented across the country in different 23 major cities. 24 COMMISSIONER TAYLOR: Okay. 25 COMMISSIONER WHITE: Thank you,

Commissioner Taylor. Commander Decrease, for the 1 2 record did I hear you correctly precincts will not be closed? 3 4 COMMANDER DECREASE: Correct, precincts 5 are not closed. This is a change of service model, it is not -- it has been at different 6 7 points in time erroneously reported as a closure. It is not closed. 8 9 If you come up to a precinct after 4 PM 10 what you can expect is a sign up on the wall with 11 a telephone where you pick it up and you mention 12 to the people at the front desk what you are 13 there for. 14 Once you mention what they're there 15 for, they will let you in and it depends on what your business is. You'll either be directed to a 16 17 phone bank or if it's something that they have to 18 handle, they will handle it. Precincts are not closed. 19 20 COMMISSIONER WHITE: So reports by the 21 media and others that have misinformation that 22 precincts are closed, that is completely 23 inaccurate? 24 COMMANDER DECREASE: Absolutely. 25 COMMISSIONER WHITE: Thank you, sir.

Also as it relates to the number of officers that 1 2 will transition from precincts who are normally 3 on the inside to the outside, how many officers 4 can we expect to put on the street versus inside 5 the precincts under this model? COMMANDER DECREASE: Based on the 6 7 estimates I've heard the final gain should be between 100 and 150. 8 9 COMMISSIONER WHITE: And that's 10 city-wide? 11 COMMANDER DECREASE: That is city-wide. 12 COMMISSIONER WHITE: Thank you, sir. 13 Just for the record, the Virtual Precinct model was presented to the Board of Police 14 15 Commissioners at our meeting last week and we did ask for a 30-day progress report update. That 16 17 update will be scheduled for March 8 which is a 18 6:30 community meeting. That meeting will he held at the 19 20 Historic Little Rock Church within the Central District. I do know it's on Woodward Avenue. I 21 22 don't have the exact address, but, again, that 23 Virtual Precinct update statistics, successes, 24 challenges, will be reported out on March 8 at 25 the Historic Little Rock Church which is within

1 Over the years the Court has held both 2 on a local, state and national level that though 3 the Fourth Amendment is being eroded, that there 4 is still a reasonable expectation of privacy, and 5 also reasonable suspicion, while it's allowed certain standards for law enforcement officers to 6 7 do this, it still -- we still have a Fourth Amendment. 8 9 To that end, there is -- I have 10 supported the department in its effort, like we 11 all have, to try to gain a thrust of public 12 safety, but I've disagreed on issues related to 13 strategy. 1 is not a way to deal with an issue. 2 COMMISSIONER WHITE: Thank you, 3 Mr. Scott. AC, do you care to respond? 4 ASSISTANT CHIEF LOGAN: Through the 5 Chair, Assistant Chief Logan. SCOTT: The only thing I raised, 1 2 and if you could give me deference, is that there 3 have been some research that is done and I'll go 4 back and get the exact research and terms of the 5 amount of individuals in the city of Detroit who 6 may have existing warrants. 7 Not all of the warrants that exist are in fact warrants for violent criminal activity or 8 9 whatever. So within that context the question is 10 if the standard is to try to provide a framework 11 of safety for the citizens, I stand strongly on 12 the increasing of mediated resolutions as opposed 13 to locking people up because the standard is if 14 you stop a person for the broken windows theory, 15 if you stop a person for a lesser crime, then usually you will capture people who might 16 17 possibly do a greater crime. 18 And that flies in the face of all --19 many things that have come before courts in terms of prior restraint. In other words, you can't 20 21 restrain me under the assumption that you're 22 going to stop me from doing something that you 23 think I might do. 24 COMMISSIONER WHITE: Point taken, 25 Mr. Scott, thank you.
