- Leach who is our acting chief investigator, Mr.




1	Robert Brown who is our office manager.

7	COMMISSIONER WHITE: Thank you,
8	Mr. Secretary. I would like to note the presence
9	of Deputy Chief Benjamin Lee representing Office
10	of the Chief. Thank you for being with us, sir.
11	DEPUTY CHIEF LEE: You're welcome.
12	COMMISSIONER WHITE: At this time I
13	would ask if Commissioner Jerome Warfield would
14	lead us in an invocation.
15	COMMISSIONER WARFIELD: Let us pray.
16	(INVOCATION WAS GIVEN).
17	COMMISSIONER WHITE: Thank you,
18	Commissioners, before us is the

bit of background or set the background a little
bit for this report for the benefit of the
community and for the benefit of the Board.

As part of the documents that were submitted to the Court in January part of that was the backlog elimination plan, and if you will bare with me there's some requirement as part of that plan that we report to the Board in open session as to how closely we are adhering to the plan.

On January 30, 2012 Judge Cook ordered that the City, quote, submit a written plan which specifically and clearly identified the steps that it will undertake to clear each and every backlog case which is defined as a case that has been within the investigation process for greater than 90-days, and, B, ensure that the backlog does not reoccur, so sustainability is important.

The plan must, A, identify the specific date by which the backlog will be fully eradicated and, B, identify the specific commitment that will identify the percentage of its open cases that will be current, again 90 or fewer days old, by the end of each month between now and the projected backlog elimination date.

1	Development of the plan necessitated
2	the input and approval of the independent monitor
3	and the Department of Justice.
4	So this report out actually falls to
5	Item 4 of the backlog elimination plan which
6	requires that the chief investigator or acting
7	chief investigator will report to the Board of
8	Police Commissioners at the Board's last meeting
9	of each month commencing in March, 2012 the
10	number of pending cases, the number of cases
11	which have been open in excess of 90 days and the
12	steps being taken to complete investigations
13	within 90 days. Chief investigator will also
14	report on adherence to the timelines set forth
15	below.
16	Just for the record, I do understand
17	this is the last meeting in April. Last month
18	was the first month of the plan. Actually the
19	date of the last meeting in March, the month had
20	not completed, so Secretary Anthony's report on
21	the OCI statistics we explained to the monitor
22	who as you know is here visiting, they were okay
23	with us reporting that way, but here on out we'll

There are just generally since I've



be sure that we'll stick to the plan.

24

1	been on board the beginning of February we've
2	made some pretty significant changes to not
3	necessarily the structure of OCI. As you know,
4	the OCI is still without a chief investigator,
5	although those efforts to retain an individual I
6	think are close to concluding, we're all very
7	excited about that.

2.1

But in the meantime we currently have three teams. We have one team that as we promised Judge Cook and the monitors and the Department of Justice those individuals are dedicated solely to the effort of resolving cases that are greater than 90 days.

In actuality they're dealing with cases that are greater than 150 days old. Those people are made up of some very seasoned investigators as well as -- and this is a change -- rather than have or shift cases that are old from those investigators for whatever reason have not been able to keep up with their case logs, those individuals who have not been able to keep up with their case logs go along with their cases to the special assignment team.

That is under the leadership of Senior Investigator Akbar and I'll speak a little bit



1	more to that in just a second. The other two
2	teams are made up of Investigator II, what we
3	call in the regular rotation. We are looking to
4	those people to not only keep their caseloads
5	within the 90 days. If they've got some cases
6	that have gone over 90 days we are putting in
7	place or have put in place since the beginning of
8	March what I'd like to call the equivalent of the
9	Chief's command accountability session.

So every Thursday we're in a room with the supervisors, with the investigators. We're setting very solid benchmarks and not really trying to put anybody on the front, but we do and it's either you meet it or you don't meet it and why.

And Lt. Leach is the acting chief investigator and he's just been phenomenal in developing consistency among the teams. I think the morale has improved, certainly to the extent — today was a first. Commander Girvin is still here with the independent monitor team and actually sat in on our mini command accountability meeting and got a chance to put faces with the names of the report of the people whose report he's been reading for the next two



1	years.
2	Again, he was very impressed I'm
3	happy to report to the Board he was very
4	impressed that OCI is moving in the direction of
5	what he called true case management, so that's
6	encouraging.
7	More specifically with regard to the
8	timeline for eliminating the backlog, as part of
9	the plan that was given to Judge Cook in January
10	we set a couple of benchmarks or guidelines
11	benchmarks in place and through Lt. Leach's
12	steady hand and firm hands we, I'm very happy to
13	report, have exceeded those benchmarks in
14	reducing the backlog.
15	For example, as of March 31, 2012 what
16	was submitted to the judge was there was 534 open
17	cases, at that time there were 290 backlog cases.
18	In real numbers, in March of 2012 we took that
19	534 and reduced the overall caseload to 510,
20	reduced the backlog cases from 290 to 678.
21	In April, although Monday concludes
22	April, our goal was 492 open cases with 198
23	backlog and even as of today we're well ahead of

that benchmark with 408 cases as of today and 222

which we expect will be reduced significantly by

1	April 30.
2	In real terms it may not sound like a
3	huge shift in percentage, but part of what is
4	I'm certainly not the sharpest knife when it
5	comes to math, but the bigger your numbers, the
6	better your percentages look.
7	But because we, as part of our plan,
8	our approach with the investigators is to not
9	just address the backlog, but to keep everybody's
10	feet to the fire on the new cases too.
11	We're kind of squeezing both ends
12	against the middle and we're reducing the overall
13	inventory of cases. So where before where we had
14	700 or 800 cases I believe last year at this time
15	and we were at 78 or percent compliance, now we
16	only have 400, so we're right about 48, 52
17	percent compliant.
18	Again, quality is important. We're
19	really stressing that to the investigators,
20	accountability among the supervisors. There's
21	some other things that we've been working very
22	closely and we've had a number of meetings this
23	week and last week, Commander Romeo and his



staff, and others at DC Tolbert at CRIB to

streamline and really get a good understanding of

24

1	what cases, what court cases, what IA cases
2	should be handled by whom.
3	So we've got a wonderful network and I
4	do acknowledge Chief Tolbert's leadership on that
5	effort. I'm very confident that we're well on
6	our way and we will continue to give reports to
7	the Board every month and the end of the month.
8	COMMISSIONER WHITE: Thank you,
9	counsel. Questions, Commissioner Stewart?
10	COMMISSIONER STEWART: None from me.
11	COMMISSIONER WHITE: Thank you, sir.
12	Commissioner Warfield?
13	COMMISSIONER WARFIELD: Are there any
14	tools thank you, Mr. Chair. Are there any
15	tools that the investigators need that would help
16	increase their productivity that we might be able
17	to advocate for?
18	MS. WASHINGTON: There are some tools
19	and there is one in particular that I believe
20	Mr. Commissioner suggested with regard to
21	software that could take the spoken ward and
22	convert it to typed or to typewritten word. The
23	overwhelming majority of the cases that are over
24	90 days are waiting to be typed, so one might say
25	why can't you just hire typists to do the job,



1	but we've got Investigator Smith who's waiting
2	you know, it's his or her investigation and it's
3	unbelievably time consuming for somebody else to
4	type it and then you get it back and that's not
5	what you said, so that would be a phenomenally
6	helpful tool to the investigators.
7	COMMISSIONER WARFIELD: Have we looked
8	into dictation services that may offer that as
9	well?
10	MS. WASHINGTON: We have not, but we
11	can do that. You mean compare costs?
12	COMMISSIONER WARFIELD: Yeah, compare
13	costs and efficacy because sometimes the
14	talk-to-text software does not take is not
15	culturally sensitive and so we want to make sure
16	that from an efficacy standpoint that we get the
17	most bang for our buck as well.
18	MS. WASHINGTON: We can certainly do
19	that and, again, I've got we had a huge
20	meeting yesterday and a couple of huge meetings
21	this week. I think with the support of the
22	department and the support of the monitor I know
23	these are hard times for the City, for the
24	department, for everybody, but in a situation
25	like this where two years ago we were in a



1	position where we were paying \$1,000 a day
2	because we were not compliant.
3	I think that we can certainly justify
4	spending a little extra to get a little extra.
5	COMMISSIONER WARFIELD: Another
6	question I have the command accountability
7	meeting and listening to the reports from the
8	various commanders at the meetings, especially as
9	relates to CCRs, for the most part they were
10	saying that the CCR complaints were down pretty
11	much across the city and that there are very few
12	if any repeat offenders, which does not mirror
13	at least the repeat offender part does not
14	mirror the things I've see in the cases that I
15	review.
16	Are they looking at the same database?
17	Are the commanders looking at the CCRs that come
18	in to the precinct versus what comes in through
19	the whole pool of CCRs that we get at OCI, how is
20	that vetted out?
21	MS. WASHINGTON: Again, this is based
22	on what I've been told and I'm going to speak
23	with Commander Romeo and Commander White.
24	Basically the information that's
25	presented at the command accountability meetings,



1	in terms of force cases, citizen complaints are
2	command level citizen complaints.
3	At some point I would imagine they all
4	mesh together, but if you're looking for apples
5	and apples when you look for the number of force
6	complaints as opposed to number of force
7	complaints that OCI has, the numbers are not
8	going to be the same.
9	COMMISSIONER WARFIELD: I would just
10	suggest just for transparency purposes moving
11	forward that you and Commander Romeo and whomever
12	else from the department would get together and
13	just make sure that we have, I think, accurate
L 4	numbers that give a full picture of CCR
15	complaints because the citizen attending that
16	meeting and attending our meeting, especially the
17	numbers that our Board Secretary gives out, would
18	have a schizophrenic opinion on which numbers are
19	right, you know, depending on who's reporting.
20	So if you all can work that out, that
21	would be great.
22	MS. WASHINGTON: And we will, and part
23	of that might be remedied, I believe, commander,
24	by the very recent change where CCRs will go into



the MAS right away so we won't have the paper

1	PCRs one place coming in one way getting to us 48
2	hours later and then we're pulling stuff from the
3	website. It will all go in to MAS and Lt. Leach
4	is going to be responsible at this point for
5	pulling those directly, turning them into paper,
6	but it won't be at the end of the journey
7	we'll all be singing from the same hymnal I'm
8	pretty sure.
9	COMMISSIONER WARFIELD: And your force
10	discussions that you had, are you satisfied with
11	the remedy there?
12	MS. WASHINGTON: Am I satisfied?
13	COMMISSIONER WARFIELD: Yeah, we want
14	to know.
15	MS. WASHINGTON: I think
16	COMMISSIONER WARFIELD: Or is this a
17	pilot approach?
18	MS. WASHINGTON: Well, it is a pilot
19	approach. By and large there's no
20	dissension at all between IM Force and OCI. My
21	concern is I just want to make sure that the
22	force investigations are getting the best
23	investigation possible with the best talent pool
24	that's qualified, so Commander Stair and Lt. Topp



and Lt. Leach, we're going to reinstate triage

1	meetings and the department has been, again, very
2	very helpful.
3	This is our meeting last week where
4	there's some things, quite honestly, that if OCI
5	looked at earlier could probably get into better
6	hands.
7	So am I happy? I'm not happy to keep
8	the cases that I was hoping that we weren't going
9	to keep, but I am very pleased we got a wonderful
10	and actually Chief Warshaw was our mediator
11	and by the time he got done splitting the baby,
12	we all felt like we were but it was really
13	really very helpful, so we're on the right track.
14	COMMISSIONER WARFIELD: Wonderful.
15	Thank you.
16	COMMISSIONER WHITE: Thank you,
17	Commissioner Taylor?
18	COMMISSIONER TAYLOR: No questions.
19	COMMISSIONER WHITE: And just publicly,
20	thank you and Lt. Leach, I think you both have
21	done an outstanding job in the stability of OCI
22	in the interim as we continue our search for the
23	next chief investigator as well as fill our open
24	spots for investigators.



MS. WASHINGTON: Oh, I'm sorry. That

1	was one thing that I failed to say and I'm very
2	happy to say that Monday we will welcome three
3	new investigators to OCI. Those positions were
4	posted nationally, career board websites and
5	Career Builder, so we've not three very strong
6	candidates starting on Monday.
7	We've already got pilot training plans
8	in place for them. They're going to start off
9	with a 40-hour in-house training on what OCI
10	does.
11	Some of that may actually involve some
12	typing and then they will move to the commander
13	for Consent Decree training and I think we're
14	well on our way, but we did present that training
15	manual to Commander Girvin.
16	COMMISSIONER WHITE: Thank you,
17	counsel. Mr. Secretary, if you wouldn't mind, I
18	would table your report following the
19	announcements and that will lead us into a closed
20	session for a personnel matter. Thank you, sir.
21	At this time are there any standing
22	committee reports? I don't believe so. There is
23	no new business before us.
24	Under announcements, there will be a



quarterly report to the community. Chief Ralph

1	Godbee invites citizens of Detroit to join him
2	and members of the Detroit Police Department in
3	an open forum about issues affecting our
4	neighborhoods. Chief Godbee wants to begin the
5	summer by speaking directly to you about your
6	concerns and work towards a safer community for
7	all.
8	This meeting is from 6 PM to 8 PM
9	Monday, April 30 at the Triumph Baptist Church
10	2550 South Liddesdale, that's Detroit, Michigan.
11	Also we would like to mention the
12	National Association for Civilian Oversight of
13	Law Enforcement, NACOLE, which all the
14	commissioners are a member of will have its
15	Midwest Regional Meeting held April 27, 2012.
16	That meeting will be held at the
17	Michigan State University campus here in the city
18	of Detroit, 3408 Woodward Avenue. Also under
19	announcements the next meeting and I started
20	off the meeting and did not thank everyone for
21	your indulgence for allowing us to move the
22	meeting to the Central District location versus
23	downtown, but with all of the things,
24	construction and games and the public hearing we

thought this was a better suited meeting location

1	for us, so thank you for your indulgence.
2	And be mindful our next meeting will be
3	tentatively I don't believe we have a game,
4	Mr. Secretary so we are scheduled to be back
5	at police headquarters Thursday, May 3 at 3 PM
6	and that's, again, police headquarters, 1300
7	Beaubien, Room 328-A.
8	At this time we will have our oral
9	communications from the audience. If you wish to
10	address the Board of Police Commissioners we ask
11	that you come forward, clearly state your first
12	and last name and please spell it for the record
13	for the benefit of our reporters and just worth
14	mentioning this is not in collaboration with the
15	public hearing on the towing rules. That will
16	proceed immediately following this meeting.
17	Yes, sir. Good afternoon.
18	MR. HARMON: Yes, I'm Anthony Harmon
19	and I want to testify
20	COMMISSIONER WHITE: And your last
21	name, sir?
22	MR. HARMON: H-a-r-m-o-n. On April 16
23	I go to school, go every Monday four days a week
24	and I'm on my way home from school.
25	About 10 minutes I get up and walk in



1	the door the squats [sic] car, the squats car and
2	the police wagons and squats car and whatever
3	because they (UNINTELLIGIBLE) and they came down
4	the street with the armored truck, they was
5	suited up, guns and everything and five minutes
6	(UNINTELLIGIBLE) walk in the door.

I walked in the door and then everybody want to get outside, see what's going on, what's going on, trying to find out what's going on.

And they jumped out all over, took everybody back out to the corner, to the corner. And from nowhere they swept down, they seen this guy run up in my house, they say they seen this guy run up in my house. They didn't see nobody run up in my house. If they did see anybody run in my house, I told him -- I say if y'all seen anybody run up in my house, why ain't you go up there and get them.

And they ran up in the house and searched and told everybody -- first of all they told everybody come out of the house where I stay at. Me and the kids and -- three -- my two step-sons and my lady friend and they (UNINTELLIGIBLE) they swept it down. They question me and the kids. They ain't got no

1	business questioning any kids have you seen this
2	(UNINTELLIGIBLE).
3	You know and they laugh at me because I
4	speak I'm trying so they show us the
5	pictures that we seen this guy. I say no, I
6	don't know this guy. They ask my step-sons, two
7	of them, they nothing but 9 or 10 years old. Did
8	we see the guy. And the man going to say yes, we
9	did, yes you did, you know him, you know him.
10	I say what, we knowing? They go to
11	telling over and over. And then now with that
12	we've going to have you one by one come
13	downstairs with our hands up one by one, me and
14	the kids handcuffed. Pose on the ground
15	(UNINTELLIGIBLE). We walk from (UNINTELLIGIBLE)
16	to the corner. First they had on the side. I
17	say what this called for, this ain't called for.
18	I supposed to go every Monday and Thursday, you
19	know. They had this block off like everybody
20	looking for something. Like we looking,
21	everybody looking to see what's going on because
22	you ain't (UNINTELLIGIBLE). I don't know what's
23	going on.
24	And kids, they go to school, they ain't



been in school since. They tried to go back to

1	school, me too, I go to school. I'm wondering
2	what's going on next time. I don't know, you
3	know, so I figure they got the right to do all
4	this next them. I'm making a complaint because
5	next time they might just no telling what they
6	might do. They didn't have no reason for all
7	that. I mean, law is right. They supposed to do
8	they job, but they send one guy. I
9	(UNINTELLIGIBLE) squat car and the armored truck
10	for one guy and they were suited up. And they
11	had this from (UNINTELLIGIBLE) blocked off from
12	(UNINTELLIGIBLE) and then they put me and they
13	put all three of us in a car and took us around
14	the block.
15	And then had us on posters. We got
16	they (UNINTELLIGIBLE) do we see this guy, do we
17	know this guy. We didn't know that guy.
18	(UNINTELLIGIBLE). Man going to say yes, we did,
19	you know him. I say you going to tell us we know
20	this guy. And then they going to say we seen the
21	guy going in the house. It 10, 15 minutes before
22	y'all and then I'm going to turn back around
23	and then go and search the house. Search the
24	house.



COMMISSIONER WHITE: Mr. Harmon, I

1	think I have a firm handle on your situation.
2	MR. HARMON: Okay, that's it.
3	COMMISSIONER WHITE: First of all, let
4	me thank you for having the courage and taking
5	the time to come down and inform the Board about
6	this mishap.
7	There is a process where you believe
8	there were some improprieties in terms of how you
9	were treated by the department. That is handled
10	by the Office of the Chief Investigator and they
11	will look further into your situation.
12	I'm going to ask if you can see
13	Lt. Timothy Leach who is the acting chief
14	investigator at the moment and he'll explain that
15	to you and also talk about how we can look
16	further into the situation for you. Okay.
17	Thank you, sir.
18	Are there other communications?
19	COMMANDER ROMEO: Commander Jeff Romeo
20	from the Office of Civil Rights. I just want to
21	take a brief movement just to publicly announce
22	attorney Grant Ha's final week here. He's got
23	sort of a thankless job of handling discipline
24	cases and suspension without pay and I just want
25	to publicly acknowledge him for all his hard work



1	and effort and all the help he's been all the
2	time he's been working with us.
3	(APPLAUSE.)
4	COMMISSIONER WHITE: And, counsel, I
5	don't know if it's within our purview to take a
6	vote to keep Ha, but
7	I know Goldpaugh hates to see him go,
8	right? But attorney Ha, we certainly wish you
9	well in all of your endeavors and I'm sure I
10	speak on behalf of all my colleagues when I say
11	you served the department of this great city
12	well. Thank you very much.
13	Good afternoon.
14	MS. SMITH: Bernice Smith, political
15	activist. Good afternoon to the commissioners
16	and to you, Deputy Chief Lee. You know, I've
17	always stated when I come up here that I am a
18	supporter of our police department and I will
19	repeat again whenever I find a fault with you,
20	I'm going to bring it before you.
21	For the last two weeks the police
22	department has been very disappointing to me.
23	Again this week we find that you have officers
24	that's not doing their job thoroughly.
25	I'm wondering is there any possibility



1	for you to have meetings with your officers
2	before their duties start, something to remind
3	them that they are police officers and what their
4	jobs should be.
5	Deputy Lee, you were interviewed this
6	week and your response was to the questions in
7	regard to what happened at the precinct and this
8	felon that had a key and was able to unlock his
9	handcuffs. You did not give the answer that I
10	guess the reporters wanted, but you did say,
11	"We'll be investigating."
12	Now, that answer was given to me last
13	week about the other incidents that police was
14	involved with. Was that investigation thoroughly
15	looked into and do you have a solution to it or
16	are you still investigating that particular
17	incident? Do you remember?
18	COMMISSIONER WHITE: Ms. Smith, if you
19	could direct your comments to the Chair, please.
20	MS. SMITH: All right, I'm sorry. I
21	don't mean to ignore you because I know you're
22	the Chairman.
23	But anyway, that's one of the things I
24	would like to ask, and also this week, I'm very
25	sorry that police department is not doing their



job the way they should. Not all of them, but
there are some that are lacking and they must pay
attention to the fact whenever they get a felon,
to make sure they search them thoroughly and not
let them be able to get a key and unlock their
handcuffs.

Again, I will state I want them to do a better job than what they're doing. I'm tired of the public talking bad against the police department because, as you know, or as I have stated over and over again, I was a former police commissioner, Number 1, under Coleman Young and I hope to again be reinstated because I think we need some help in regards to helping getting the police department on track.

I know most of you are doing a good job, but there are some that's making it bad for the rest of you, and I do wish for you to contact and let the public know that you're going to do a good job and you're going to investigate your own and not sweep it underneath the rug, which I'm not saying that you're doing it, but I just don't want you to continue to let these bad eggs in the pot do a bad job and making your reputation bad.

That's all I have to say today. Thank



1	you.
2	COMMISSIONER WHITE: Thank you,
3	Ms. Smith. I do believe there were two questions
4	I picked out of that. One was a pitch for an
5	orientation prior to the beginning of a shift and
6	I'll ask Deputy Chief Lee to respond to these
7	questions. The other was in regard to a
8	situation with an individual who had a key. I
9	believe there was some concerns as it relates to
10	search procedures of individuals who are taking
11	into custody.
12	Deputy Chief Lee, would you care to
13	respond to those?
14	DEPUTY CHIEF LEE: Yes, through the
15	Chair. Every day before the officers go out on
16	the streets they attend a 15-minute roll call
17	where they're given instructions and events that
18	have occurred either that day or on previous
19	days. It's a briefing, so that does occur on a
20	daily basis.
21	In regards to the incident at the 9th
22	Precinct regarding the escaped prisoner that is
23	currently under investigation. We arrest, as I
24	said last night on the news, several thousand
25	people without incident. That was an isolated



1	incident. The officers are entitled to due
2	process rights and as soon as the investigation
3	is complete we'll take the proper action.
4	COMMISSIONER WHITE: Thank you, Deputy
5	Chief. Are there any further communications?
6	Any further communications?
7	Yes, sir.
8	MR. BELL: Good afternoon. How you
9	doing? My name is Jerry Bell and I've been a
10	citizen of Detroit for 38 years.
11	Two days ago I had the unfortunate
12	encounter with a police officer that made several
13	threats to me by telephone. I've recorded the
14	messages, I've made a complaint through the
15	Office of the Chief investigator and so far
16	they've been handling the situation very well.
17	But I'm here to say that I would like
18	to make everyone aware of this situation because
19	by right, by law, I have a right to protect
20	myself. Knowing that this is a police officer
21	and the actions that he's bringing towards me,
22	you know, it's almost like he wants to start
23	somewhat of an encounter with me to whereas he
24	can take action.



I have all the recordings from that

1	actual phone call. When I made him aware that I
2	was recording his phone calls, then he then hung
3	up. He told me that he's pretty much
4	threatening me saying, you know, "Go make a
5	report. I wish you would, I wish you would go
6	down there and make a report. I have family down
7	there too. Just make the report, just go in
8	there and make the report and you don't know who
9	you're dealing with. You better do your
10	homework," things of that nature.

That's nothing that a police officer is supposed to say. First of all, there wasn't a crime committed and, second of all, he shouldn't have even been there anyways.

Riding in a one-man scout car and you just want to ride up and say the person that I was meeting looked lost, so that's why you're butting in our business, which it wasn't a situation. It was just that I was meeting her to give her some papers.

And for him to make that threat, I just think that's very unprofessional, but I'm just letting you guys know that whatever I have to do to defend myself, if this officer comes my way I'm just going have to do what I got to do.

1	COMMISSIONER WHITE: Thank you,
2	Mr. Bell, for taking the time again and the
3	courage to come forward.
4	Lt. Leach, are we aware of this case?
5	LT. LEACH: Lt. Leach of the Office of
6	the Chief Investigator. Yes, sir. As a matter
7	of fact, I talked to him Friday of last week that
8	he called, put in a complaint, and then he
9	actually to our office yesterday, heard the
10	recordings and everything like that, so we do
11	have the investigation started.
12	COMMISSIONER WHITE: And Deputy Chief
13	Lee, if someone could speak to how do we
14	acknowledge the validity of the information that
15	was given to us, i.e. the phone calls, and I'm
16	getting towards the question if this particular
17	officer is still in service or what is the status
18	of this officer?
19	LT. LEACH: On duty.
20	COMMISSIONER WHITE: Deputy Chief, is
21	that the protocol on how we would handle such a
22	situation?
23	DEPUTY CHIEF LEE: I would say right
24	now we would actually have Commander Brian Stair
25	be involved in this process, considering that he



1	says there's some threats that have been made.
2	COMMISSIONER WHITE: So, commander, if
3	we could and, lieutenant, if we could make sure
4	that we speak with Mr. Bell so we have the best
5	information, we certainly want to thwart any
6	potential situation from arising further, and
7	again, Mr. Bell, you thank you for taking the
8	time to come forward today.
9	MR. BELL: I just wanted to add one
10	more thing.
11	COMMISSIONER WHITE: Please step
12	forward.
13	MR. BELL: I had gotten a series of
14	phone calls between last night and today,
15	restricted phone calls. A lot of them was
16	hang-ups and then at one point in time there was
17	a gentleman that came on the phone. He said, "I
18	know you, I know your last name," that's pretty
19	much like all he said. I'm like wow, whatever,
20	and hung up. So I just wanted to add that in and
21	I do have those logs.
22	COMMISSIONER WHITE: Thank you,
23	Mr. Bell, and again if you could see the
24	lieutenant and Commander Stair before you leave
25	and Deputy Chief, we would ask if the Commission



1	could have an update on this situation for next
2	week, please.
3	DEPUTY CHIEF LEE: Yes, sir.
4	COMMISSIONER WHITE: Thank you very
5	much. Are there any other communications? Any
6	other communications? Any other communications?
7	Seeing none, at this time we would have
8	the Secretary's report.
9	SECRETARY ANTHONY: Thank you,
10	Mr. Chair. George Anthony for the record. We've
11	received a request for a closed door session, so
12	I'll go into that for convening.
13	As a public body your meetings are
14	subject to the Open Meetings Act, the OMA. The
15	OMA defines a meeting as the convening of a

7	Through their representative DPOA
8	attorney John J. Goldpaugh Officer Austin and
9	Office Medley have requested a closed session for
10	the purpose of contesting the suspension without
11	pay recommendation.
12	The closed session will be called
13	pursuant to MCL 15.268(a) of the Open Meetings
14	Act which states in part,
15	"A public body may meet in a closed
16	session to consider the suspension of

behalf of Lost Cat Towing, LLC. I just want to

1	address the Board. I did file a written
2	submission to the Board and I supplied copies for
3	each of the commissioners and counsel.
4	I just wanted to highlight five what I
5	believe are critical objections, solutions and
6	items that this Board should address.
7	The first of all is Proposed Amendment
8	Number 8. I think every tower here objects to
9	the passage of Proposed Amendment Rule Number 8,
10	reducing the duration of the towing permit from
11	five years to one year, from five years to one
12	year.
13	In fact, if I can present this to
14	Robert to hand to the Board, I'm handing an
15	objection signed by every towing company
16	police authorized towing company here today
17	stating their universal wholesale disagreement
18	and objection to this Proposed Amendment Rule 8.
19	And we'd ask that the Board recognize
20	the prior investment in equipment, personnel that

the prior investment in equipment, personnel that all of these towers have made on the basis of these granted a pre-existing five-year towing permit. So our first objection again is to reducing the duration in Proposed Amendment Number 8 from five years one year towing permit.



1	Secondly, I'd ask we object to
2	Proposed Amendment 7-A which is a prohibition
3	proposed prohibition on the use of brokers and/or
4	independent contractors.

2.1

And I'd ask this Board to carefully consider this matter. Attached as an exhibit or attached as an attachment to our response an objection you'll see a proposed alternative provision and proposed language or rule that we would ask this body to adopt permitting the use of road crews and independent contractors by police authorized towing companies with respect — or with certain essential safeguards in place.

So we'd ask that you guys take a look at those, review those and we'd ask that you pass those and you refuse to implement or pass your Proposed Amendment 7-A.

Next, I just want to highlight your

Proposed Amendment 6-B. We completely object to

the treatment -- well, first of all, to the

proposed language concerning the treatment of

leases. There are leases that tow companies have

authorized or have executed, entered into after

the adoption of -- or after the passage of the

initial towing rules and between that time and

1	the time that these proposed rules were or
2	those proposed amendments were proposed.
3	There is these leases have been
4	basically put on hold for nearly going on almost
5	between six months and a year and there's
6	certainly no basis for it. This rule I believe
7	is contrary to applicable law and as I detailed
8	in our objection we'd ask that, again, you refuse
9	to pass this rule, strike this rule, and permit
10	the leases that have been executed by the
11	parties, which parties have made significant
12	capital investments in and where I think
13	importantly for the body to remember permitted
14	within the prior rules.
15	So, again, for those reasons we could
16	ask that our leases be given effect and that this
17	proposed amendment be stricken.
18	Additionally, we'd ask that your
19	Proposed Amendment 6-A concerning or defining
20	geographic location be amended. First of all,
21	it's fatally flawed in that it relates only to an
22	owned storage lot or there's numerous tow
23	companies, police authorized tow companies,
24	throughout the city's history that do not own



their own storage lots, would rather lease them.

Secondly, this proposed amendment appears to relate solely to a single location city-wide. We'd ask that this definition be altered to recognize the investments that certain companies have made in having multiple locations, multiple operations throughout the city. And this simply would -- this rule, Proposed Amendment 6-A, is simply too restrictive for all the reasons I set forth in my brief. I won't reiterate them here.

Lastly I think most if not all the towers would join me in objecting to your proposed amendment related to the hours. The hours that are proposed in the rules simply just are not feasible. They do not recognize the economic realities of the towing -- police authorized towing companies as well as, as I've highlighted in my submission, our company has tracks their citizen contacts for a certain defined period of time and what we determined based on our own internal review was that the



Page 45 1 bulk of the towing citizen contacts occur Monday 2 through Friday 8 to 6 PM. Very few after 1 PM on Saturday, and hardly at all on Sunday. 3 You get the occasional person, but we'd 4 ask that this Board conform its proposed 5 amendments to reflect the realities and the 6 citizen contact patterns that have emerged 7 throughout the city. I think if any of the 8 9 Commissioners made contact with any of these 10 towing companies and inquired they'll find a similar pattern. 11 12 So we object to these things as well as 13 -- each of these proposed amendments as well as 14 all the additional items that we've put in our 15 submission. Thank you. 16 COMMISSIONER WHITE: Thank you, 17 Mr. Stidham. 3	Towing. I just wanted to put that out there that

7	Smith. I just wanted one question. For the
8	benefits of the towers, those that I know
9	excuse me. Are you leaving, Donnell?
10	COMMISSIONER WHITE: I'm listening to
11	you.
12	MS. SMITH: Oh. For the benefit of the
13	towers I would like to find out from you an
14	answer, are you going to be in support of this
15	Auto Returns that's out of San Francisco that's
16	coming in and trying to take over as a contractor
17	and I know it was a dispute about it a couple of
18	week ago when one of their representatives came
19	here that works here and he wanted to ask you in
20	regards to or he made a presentation to you for
21	benefit of this company in San Francisco.
22	I do hope that you will think about it
23	very strenuously and not have some outsider come
24	in and take over what we can do ourselves. I'm
25	sure you can find somebody in our city or in our



1	state close by Detroit that can do the same job
2	and not strip us of our thing.
3	I'm gone, baby. I'm not going to stay
4	long because I see people weren't listening to
5	you today. But anyway, that's what I want to
6	know, all right. See, Brown, I'm being nice.
7	COMMISSIONER STEWART: The answer to
8	that question, we're not dealing with the
9	management part, we're just dealing with the
10	proposal, amendments.
11	MS SMITH: That's it?
12	COMMISSIONER STEWART: Yes.
13	MR. PERKINS: Good afternoon or good
14	evening. May it please this honorable body my
15	name is Todd Russell Perkins. I represent a
16	couple of independent towers. My impassioned
17	plea to this panel and this body tonight is on
18	behalf of these towers, if I may take the time, I
19	only represent three.
20	Gentlemen, could you come up and
21	introduce yourselves?
22	MR. BENNETT: David Bennet, Detroit
23	Auto Recovery.
24	MR. GAYLE: Dafen Gayle, Detroit Auto



Recovery, JMA, ABA and City Auto.

1	MR. WOODY: Marcus Woody, J&C.
2	MR. PERKINS: I brought these
3	individuals and they've retained my services to
4	make this plea to them, but often times seeing
5	the faces of the individuals that are affected by
6	your decision I think is more impacting than some
7	lawyer in a decent suit making a pitch.
8	It's more than a pitch that I bring to
9	you today in that the decisions and I'll draw
10	recently retained, I will provide my proposed
11	drafting or proposed amendment to what's been
12	proposed already and I cite Amendment Number 7-A
13	that will drastically affect these individuals
14	that stand before you, but not only these
15	individuals, but there's hundreds of towers who
16	are similarly situated as they are that they will
17	not allow they leveraged themselves in
18	positions to ply their trade and now this
19	particular provision will cast doubt as to
20	whether they will be able to continue to do that.
21	These are Detroiters, these are people
22	who pay their taxes, these are people who are
23	hoping that something can be configured, if not
24	this, not applying this, you say well, what else.
25	I believe that there is a means of



1	configuring and finding out what the legislative
2	intent is behind this particular amendment,
3	whether it's to pay taxes, whether it's enforce
4	and ensure that everyone is treated fairly from
5	the towing contract business, but I believe that
6	there's something that can be done to ensure that
7	they are able to continue to feed their families
8	and become or be and maintain their status as
9	viable citizens, productive citizens of the city
10	of Detroit.
11	I thank you for the opportunity to talk
12	a you tonight and I will present my pleadings to
13	counsel forthwith.
14	COMMISSIONER STEWART: We appreciate
15	that.
16	MR. PERKINS: Thank you.
17	COMMISSIONER STEWART: Yes.
18	Commissioner Warfield.
19	COMMISSIONER WARFIELD: Thank you, sir,
20	for coming forth. I just want to say this
21	because you're the second person to comment on
22	that Rule 7-A and I want to be very clear with
23	you and Mr. Stidham and others that the tow rules
24	that we put in place are a very delicate balance
25	and that very delicate balance is predicated on



1	the fact that we want to maintain as much as
2	possible a very equitable tow rotation within the
3	city.

2.1

I understand the concerns that you have. However, here's our issue. It is very easily manipulated the way that you all say we strike that. If we strike that out of the record, we strike leases out of the record. Then we're right back at an unequitable tow system very easily and very quickly.

So we are open to hearing how we can maintain the equitable tow rotations within the system while it cannot be gamed because one of the reasons we're sitting here tonight is because after we approved tow rules, people tried to game the system after the fact.

And so we're open to hear that and so if your proposal presents that, we will absolutely consider it, but we will put it through the litmus test if you will just to make sure that, again, the very delicate balance that has been struck already is still maintained.

And that's the only -- that's the main focus I should say that we have is that that balance stays. So when you're presenting your

1	proposal, just keep that in mind. From our
2	perspective, that's what we're looking for, to
3	make sure that balance is there.
4	I do understand the challenges that
5	some of our towers may have, but in conjunction
6	with that, understand the balance that we're
7	trying to achieve, sir.
8	MR. PERKINS: May I just make one quick
9	comment?
10	COMMISSIONER WARFIELD: Sure.
11	MR. PERKINS: I appreciate that. And
12	being newly retained in this and actually jumping
13	head-in researching these issues, I know what
14	this Board has done in order to bring some
15	balance and has been successful in doing that,
16	and I would just offer that one means and I'll
17	put it into writing, much better seen than spoken
18	sometimes, but I put it in writing that I believe
19	one key aspect to it is transparency and I think
20	that's one thing we hear through municipal
21	relations these days that we also are looking for
22	in our corporate governance is transparency and I
23	think that is going to be the focal point of what
24	I present to you as a body.

1	COMMISSIONER WARFIELD: Thank you, sir.
2	COMMISSIONER STEWART: You're welcome.
3	MR. ERRIGO: Good afternoon, Board. My
4	name is Gregory Errigo, president, Michigan Auto
5	Recovery, police impound yard. The reason why I
6	want to address the Board this afternoon is in
7	regards to the time what the attorney said
8	previous to me, the hours of operation. They're
9	too excessive right now as we all agree or should
10	come together on agreement.
11	I feel doing this in the majority of
12	the time we've been doing this excellent time of
13	hours Monday through Friday 8 to 6, Saturday 9 to
14	1 and closed Sundays so we can go and do our
15	religious beliefs. As we've been opening up on
16	Sunday for the first time ever way back when the
17	Board said we had to open up seven days a week 7
18	to 7. Not even 1 percent or redemption is on
19	Sunday, maybe 5 or 10 percent on Saturday. The
20	great majority is on Monday through Friday.
21	So if we could indulge in these time
22	changes it would be appreciated. It would be
23	less costly to my wallet for people have to sit
24	there looking at TV because they got cable and
25	everything now. But at any rate and then

1	lastly if I could talk briefly about the leases.
2	We did send in writing with the
3	counselor that was up here previous to me and
4	before me, the leases have to be in effect. The
5	leases were a thing that the towers worked with
6	many years and they just can't be stopped or
7	whatever. It's a tool of how we do our
8	day-to-day operation and leases for leasing
9	property, this, that and the other.
10	It was very encouraged it was very
11	encouraged in the past and I don't know why it's
12	not encouraged any more.
13	COMMISSIONER WARFIELD: Do you want to
14	know why?
15	MR. ERRIGO: To go ahead and try to put
16	a company that has property and needs help in
17	another precinct or district, Reverend?
18	COMMISSIONER WARFIELD: You don't know
19	why.
20	MR. ERRIGO: Well, I know why. I know
21	I believe of why, and I guess I really still
22	don't understand why the Board's belief of why.
23	COMMISSIONER WARFIELD: Here's why, if
24	I can, Mr. Chair. Just very clear, I mean,
25	because the other attorney spoke of transparency



1	so I want us to be transparency in this

3	First of all, my hat's off to the
4	towers who tow for the Detroit Police Department.
5	There's going to be a story that's going to
6	appear on Channel 7 tonight and when I got the
7	teaser, I'm like, "Find out who it is" and
8	certainly it's not one of our towers.
9	MR. ERRIGO: It's Area Towing in
10	Taylor.
11	COMMISSIONER WARFIELD: And so my thank
12	God and give hats off to you guys. You guys do a
13	remarkable job.
14	The reason why we had to stop the
15	leases is because after we approved the rules it
16	got out of hand. There were lease deals that
17	were crisscrossing the city that literally threw
18	the tow rotation completely out of whack and then
19	added an unfair advantage to other towers which
20	we did all that work to try to eliminate in the
21	first place.
22	That's the reason why we're having this
23	hearing tonight, because those leases just
24	literally tipped the scales again, and as I said
25	to the other attorneys, if there is a way where



1	we can do that and that very delicate balance
2	stay in place, then fine, if we can come up with
3	a solution with that.
4	But this cross leasing in order to
5	become other than mini mega conglomerate systems,

MR. ERRIGO: Reverend, I guess you misunderstood what I was trying to say. I didn't to do the cross leases, this, that and the other. There's been legit leases that have been legit leases that were fair and equitable for the City and for the towers.

Now, for what the cross sign leases you said over there, whatever, I don't know nothing about that, not was I a part of it, nor I don't think it even matters because a thing that was stopped and what have you, what have you.

I'm talking about a legit lease where is needed in a district or a precinct or whatever and if you could take them into consideration in mind I would appreciate it.

I made it for a positive approach, not for the getting around the corner of another way



1	to get there.
2	COMMISSIONER WARFIELD: Absolutely.
3	MR. ERRIGO: Thank you, Reverend, thank
4	you Board, Chief.
5	MR. MELVILLE: Good afternoon, sirs.
6	Joseph Melville, Melville's Towing, city of
7	Detroit. I believe I have a solution to help
8	clean up the towing in the city of Detroit.
9	I believe that the corruption in the
10	city of Detroit not only in towing and in the
11	police department has just gone way above and
12	beyond. I would like to have a closed session
13	with the Board of Police Commissioners end the
14	City of Detroit and I will bring evidence
15	videotape of police officers and towers
16	committing crimes. I have them, I will bring

7	Detroit keeps their towers who have paid to play
8	or whatever you want to call it. If the City of
9	Detroit Board of Police Commissioners will give
10	me the time and the City of Detroit Police
11	Department, I would be happy to come down and sit
12	with them for hours, days, weeks, whatever it
13	takes to help fix the problem with the city of
14	Detroit.
15	I've been with the city of Detroit
16	towing since 1985. I know it inside and out, up
17	and down. I know every tow company in the city
18	of Detroit, every one of their employees and
19	trucks they have, everything about it.
20	If the Board of Police Commissioners
21	will give me the opportunity, I will bring it
22	forth. Thank you.
23	COMMISSIONER STEWART: Commissioner
24	Warfield.



COMMISSIONER WARFIELD: Mr. Melville,

1	first of all, thank you for coming, we appreciate
2	it. And as you may or may not be aware because
3	we are guided by the Open Meetings Act we cannot
4	have closed sessions, so anything you wish to
5	share you're more than welcome to share in the
6	open.
7	MR. MELVILLE: I don't have a problem
8	with that. I just didn't think the City of
9	Detroit wanted that.
10	COMMISSIONER WARFIELD: Let me ask you
11	this as a bottom line question. When is the last
12	date on the video that you have?
13	MR. MELVILLE: Less than two years ago.
14	COMMISSIONER WARFIELD: The reason I
15	ask that question is because we implemented our
16	tow rules about a year, year and a half ago.

6	MR. MELVILLE: Oh, those are no rumors.
7	COMMISSIONER WARFIELD: I'm just
8	saying, but I will say that the towers who are
9	authorized police towers today have done a
10	yeoman's job in making sure and even they've
11	helped to make sure that rules and regulations
12	were crafted in a way that I believe we have one
13	of the best towing systems now I think there's
14	one critical piece that's needed, but that's
15	coming next week we have one of the best
16	towing systems now and I will put it up against
17	any other municipality in the state.
18	I'm not speaking on what happened in
19	the past. I'm just talking about once the new
20	rules are implemented, but again if you have
21	something that's current, certainly it's an open
22	forum.
23	MR. MELVILLE: I am currently reopening
24	it. I will be currently applying for the city of

2	of which I also have a second place.
3	If City of Detroit won't allow me to
4	reapply and go that route, then I will get
5	permission to purchase a City of Detroit
6	authorized tower, so I'm sure in the future we'll
7	be working a lot together.
8	COMMISSIONER WARFIELD: But you know
9	the tow permit, if you're familiar with the
10	rules, don't transfer over automatically.
11	MR. MELVILLE: I'm aware of that, no
12	problem.
13	COMMISSIONER WARFIELD: Thank you, sir.
14	DEPUTY CHIEF LEE: I'd also like to add
15	if I may, that if he has any information
16	regarding allegations against police officers
17	that he contact Internal Affairs and I will give
18	him that number.
19	MR. MELVILLE: I have Commander Stair's
20	phone number, I'll call them.
21	COMMISSIONER STEWART: Anyone else?
22	Anyone else? This is the last call. If not, so
23	I'll like to make a
24	COMMISSIONER WARFIELD: Sir, I move
25	that we adjourn the public hearing on towing.


