COMMISSIONER WHITE: Let me say good afternoon to everyone, welcome you to the Board of Police Commissioners meeting dated for Thursday, June 7, 2012.

My name is Commissioner Donnell White.
I have the pleasure of serving as Chairman for the Board of Police Commissioners.

Today I'm joined with my colleague Commissioners Jerome Warfield to my right, Commissioner Jessica Taylor and representing the staff for the Board of Police Commissioners, Executive Secretary to the Board, Mr. George Anthony. Mr. Anthony, for the record can you please introduce our staff.

SECRETARY ANTHONY: Thank you,
Mr. Chair. For the record, George Anthony, Secretary to the Board. We have Ms. Dalph Watson who is our director of Police Personnel. We have Lt. Timothy Leach who is the acting chief investigator from the Office of the Chief Investigator.

Our office manager is Mr. Robert Brown.

We have P.O. Dan Dankowski and Sgt. Alan Quinn who are our recorders. We also have Mr. Dale Rose from Hanson Court Reporting Service. That completes the introduction, sir.

COMMISSIONER WHITE: Thank you,
Mr. Secretary. Also would like to note the presence of Deputy Chief Benjamin Lee representing the Office of the Chief. Thank you for being with us, Deputy Chief Lee.

At this time we would ask if Chaplain
Powell will come forward with our invocation.
Good to see you, sir.
(INVOCATION WAS GIVEN).
COMMISSIONER WHITE: Thank you,
Chaplain Powell. At this time the Chair would entertain a motion for the approval of the agenda dated for Thursday, June 7, 2012.

COMMISSIONER TAYLOR: So moved.
COMMISSIONER WARFIELD: Support.
COMMISSIONER WHITE: It's been properly moved and supported. Any discussion? Seeing none, all those in favor?

COMMISSIONERS: Aye.
COMMISSIONER WHITE: Opposed? Thank you very much. At this time the Chair will
entertain a motion for the approval of the minutes dated for Thursday, May 24, 2012.

COMMISSIONER WARFIELD: So moved.
COMMISSIONER TAYLOR: Support.
COMMISSIONER WHITE: It's been properly moved and supported. Is there any discussion? Seeing none, all those in favor?

COMMISSIONERS: Aye.
COMMISSIONER WHITE: Opposed? Thank you very much. I have summer on the brain, I got to apologize. There's no official Chairperson's report at this time, so we'll move for a report from the Office of the Chief.

DEPUTY CHIEF LEE: We have no official report today that I'm aware of, but I do have Deputy Chief Melvin Turner from Community Policing, Commander Frankie Lewis from Criminal Investigation Bureau and Police Officer Monica Evans from CIB.

COMMISSIONER WHITE: Thank you all for being with us today. Mr. Secretary, is there a report from the Secretary today?

SECRETARY ANTHONY: No, sir. COMMISSIONER WHITE: I don't believe we have any standing committee reports, so at this
time under new business I would ask that Commissioner Taylor lead us in the reading of the grant for the request to apply for the Juvenile-Focused Community Policing/Community Prosecution Byrne Justice Assistance Grant (Byrne JAG) Fiscal Year 2013 program from the Michigan State Police.

COMMISSIONER TAYLOR: The Michigan State Police is accepting applications for the Juvenile-Focused Community Policing/Community Prosecution Byrne Justice Assistance Grant for Fiscal Year 2013.

The Detroit Police Department is eligible to apply for $\$ 125,000$ with no cash match. The Juvenile-Focused Community Policing/Community Prosecution Program is designed to foster proactive problem-oriented interventions to combat juvenile delinquency. Acceptable initiatives include youth mentoring and community service activities, evidence-based drug and violence prevention programs, youth academies, counseling services and events that facilitate parent and community engagement.

Strategies should be comprehensive and may also include services for parents or other
caregivers as well. Interactions between law enforcement and youth should be viewed as positive in nature and seen as a reward and not punishment.

Within this proposal DPD will partner with Think Detroit PAL to develop a program for at-risk youth in the Cody Rouge Area. A classroom curriculum as well as recreational activities will be provided.

If awarded, the grant period will run from October 1, 2012 through September 30, 2013. In the event that approval is granted to apply and the award is received, Officer Monica Evans of the Criminal Investigation Bureau would serve as the project director.

The deadline for this application is June 26, 2012. I am requesting the Board's permission to apply for this funding and seek approval of the Honorable Detroit City Council.

COMMISSIONER WHITE: Thank you,
Commissioner Taylor. Before us, Commissioners, is a request to apply for the request to apply for the Juvenile-Focused Community Policing/Community Prosecution Byrne Justice

Assistance Grant request to apply for the Juvenile-Focused Community Policing/Community Prosecution Byrne Justice Assistance Grant for fiscal year 2013 for a program from the Michigan State Police.

What is your pleasure?
COMMISSIONER WARFIELD: Sir, I move that we grant permission of the department to seek approval of this grant from the City Council.

COMMISSIONER TAYLOR: Support. COMMISSIONER WHITE: It's been properly moved and supported. Any discussion? I do have one question. I don't know, Deputy Chief, if we could bring Officer Evans forward.

Officer Evans, specifically why did we choose the Cody Rouge Area? Are we limited to one area?

OFFICER EVANS: Well, as far as the pilot program and identifying what our hot spots were, you use data as far as where we needed the most investment for crimes against children or -victimizers and the victims of youth.

And so that was starting in one area with the funding that we have, we felt along with
the Youth Violence Prevention Initiative that we should stick with the areas that were within some of the other plans that we had as far as our Youth Violence Prevention, and Cody Rouge came up with the higher issues concerning gangs and gun violence for our young people.

COMMISSIONER WHITE: And these types of crimes are --

OFFICER EVANS: We looked at home invasion, we looked at armed robbery, gun violence and gang violence, and then best meeting the needs of the feeder schools into the Cody Rouge Area as well as, you know, if there's an expansion of it then we would probably go into Osborn, Denby Areas. Those are our the highest crime rates right now in those areas for our young people.

COMMISSIONER WHITE: Are we able to quantify the estimated population that we will be servicing in that area?

OFFICER EVANS: What the goal is is that we have six GRET officers, Gang Resistance, Education and Training officers, and in some other proposals we have right now that's going to work on the overtime for those, but that we would
be able to service in those areas at least 1,000 students within that time frame, and being in the classrooms consistently. Like they said, the curriculum is a 13-week curriculum.

This year with just two officers we were able to meet almost 500 students, so we'd like to be able to, with the partnership with PAL, with Boys \& Girls Clubs, broaden that with the students that we're going to effect.

COMMISSIONER WHITE: So the target is 1,000 young people in 2013?

OFFICER EVANS: Yes.
COMMISSIONER WHITE: Any other questions or concerns? Thank you, Officer Evans. Seeing no further questions, all those in favor?

COMMISSIONERS: Aye.
COMMISSIONER WHITE: Opposed? Thank you very much. Under old business is there anything pertaining to the towing hearing?

COMMISSIONER WARFIELD: Yes, sir. I do have some.

COMMISSIONER WHITE: Commissioner Warfield?

COMMISSIONER WARFIELD: Thank you, Mr. Chair. This information that as relates to
the towing hearing stems from the fact that five of our towers had requested and received permission from the Management Services Division to move their facilities without there being any approval from this board, and more particularly when we looked further into this matter there is some outstanding issues that $I$ believe involves further investigation and questioning if nothing else.

Let me be very specific on what I mean by that. And I'm going to ask -- and I'm just going to - if it's okay with you, Mr. Chair, I'm going to ask if I can call Joe Melville to the podium for a moment, and then $I$ don't see anyone here representing Management Services unfortunately, which is unfortunate.

I don't know if Deputy Chief, because some of this was going on right before you left Management Services so I might need you to chime in as well.

And maybe I'll start with Deputy Chief
Lee. Deputy Chief Lee, is it your understanding that when towers hand in their application through the application process that leases and all of their zoning and all the information
should be thoroughly reviewed by those in charge before a permit is issued?

DEPUTY CHIEF LEE: Deputy Chief Lee, through the Chair. Yes, that's the process that we had in place when we initially started accepting applications, that the applications had to be complete and all the information required had to be a part of the package.

If not, we notified the prospective tow company of any deficiencies that they had.

COMMISSIONER WARFIELD: Okay, and just for our understanding here today, is it true that, let's say, if we handed in paperwork, let's say if it's a lease, that it was your department's role to review all that information very thoroughly to make sure that there was nothing that disqualified candidates from obtaining a permit?

DEPUTY CHIEF LEE: Through the Chair, yes.

COMMISSIONER WARFIELD: Thank you, sir. Mr. Melville brought it to my attention three if not four weeks ago that five towers who were on a property that he owned who was leasing that property through court action was evicted from
that property. There were five permitted towers that we have here.

Mr. Melville, could you just tell us -first of all for the record your name and --

MR. MELVILLE: Excuse me, Joseph Melville.

COMMISSIONER WARFIELD: And just one second before you go into what you have to say. When did you file that initial lawsuit, do you remember?

MR. MELVILLE: I believe it was July of 2011.

COMMISSIONER WARFIELD: July of 2011?
MR. MELVILLE: That is correct.
COMMISSIONER WARFIELD: When did you inform -- or did you inform Management Services that there were issues with people who were on your property receiving permits?

MR. MELVILLE: The exact same day. I left the courthouse and went over and spoke to Officer Roland Clark concerning the issues.

COMMISSIONER WARFIELD: In Management Services?

MR. MELVILLE: That is correct, 1300 Beaubien.

COMMISSIONER WARFIELD: And what did
you tell him the issue was?
MR. MELVILLE: I explained to Officer Clark that there was some subcontracting on my property that wasn't approved through me and because of it $I$ was filing an eviction notice and papers to remove them from my property because it wasn't allowed.

COMMISSIONER WARFIELD: Was that language stated in your lease agreement that you had with them?

MR. MELVILLE: Yes, sir. My lease said no subcontracting of any sort without my prior permission.

COMMISSIONER WARFIELD: And is what you're telling us today that you did not approve any sub-leasing?

MR. MELVILLE: That is correct. This is why I pursued the legal actions to have them removed.

following two weeks after $I$ filed the paperwork. They voluntarily moved off our premises. The Courts didn't order them off. The Court still never heard my case in Circuit Court for whatever reason. We had it moved to Circuit Court and it's been 11 months and it still has not been heard today for whatever ungodly reason this is. It should have been heard within 10 days from the removal from 36 th District Court to Circuit Court.

They moved out of the premises on their own because it was pending litigation.

COMMISSIONER WARFIELD: So they did move off the premises?

MR. MELVILLE: Yes. I received keys on May 31st of this year, that is correct.

COMMISSIONER WARFIELD: Thank you, sir. Mr. Chair, several things $I$ want to get into, but first of all it has been -- it was brought to our attention a few weeks ago that this Board did not have, so it was believed, supervisory oversight to deal with this matter, and it was stated on the record that we were "overreaching" as relates to our authority.

I just want to read from the Detroit

City Charter, if $I$ can, into the record the authority that we have in this matter specifically, if that's okay, Mr. Chair.

COMMISSIONER WHITE: Yes, sir.
COMMISSIONER WARFIELD: This is coming
from the new City Charter that was just adopted on November 8, 2011 and it says in Section 7-082 under the title Board of Police Commissioners, "The Board of Police Commissioners has supervisory control and oversight of the Detroit Police Department as set forth in this chapter. The Board of Police Commissioners is comprised..." and it has of course the number of members there. It's also goes on to say -- I'm just doing this just to shorten this section so we won't prolong it too long, sir.

That in Section 7-803 of the Charter that, "In consultation with the Chief of Police and with the approval of the Mayor establish policies, rules and regulations, review and approve the departmental budget before its submission to the Mayor, receive and resolve as provided in this chapter any complaint concerning the operation of the police department and forward all allegations of criminality to the
appropriate internal and external law enforcement agencies for further investigation.

Number 4. Act as final authority in imposing or reviewing discipline of employees of the department" and we'll stop right there for the purposes just to establish again that this Board certainly as established by the Detroit City Charter, the newly revised City Charter, definitely has a mandate to oversee issues that we are discussing right now.

In addition to that, sir, back earlier in the year prior to having the hearings on tow rules this Board voted in an approval vote that we will not make any changes to our tow rotation until after the new rules were to take place, and that was an action that was taken by this Board.

According to the tow rules that are currently in place the permit that's given to our towers, on that permit is the address of where their lot is located. And that permit is not transferable nor is that permit transferable by property or transferable by owners. And it very clearly says that that permit is not transferable in our rules. And that permit is designated for that location and for those owners that have been
inspected.
What has happened, sir, is that our rules, I believe, have been circumvented somewhat to the degree that, first of all, when you look at the fact of the initial submission of the paperwork it was not legal, for lack of a better term, for Management Services to accept the leasing contract of those who are in question now because of the fact that in that leasing contract that was turned in there was no subletting clause in that contract.

And so as a result, those companies should not have received a permit in the first place. Subsequently since the move has occurred as testimony that was given at our public meeting a few weeks ago, it was stated that those companies that are now on a lot, that lot does not comply with what the rules that our current towers had to go through.

Many of them had to either build walls or build new fencing in order that their lots comply with city zoning. The current lot that's located now does not comply with those rules and we do understand that Zoning gave a variance for them to have some time to get that together.

The issue with that is our current towers did not have that favor to be able to do that. It was stated on the record that a lot of money was paid in an effort to get this particular issue moved quickly through either Zoning or wherever the case may be.

And in looking at all of these issues, sir, and unfortunately, again, no one is here from Management Services to answer the questions directly, it's interesting to me that in November of this year -- and let me say this too before I go to that point.

The permits were issued in August of 2011. That was the deadline to get them all in. And Management Services were notified in July of last year that this issue was out there and had occurred, and these permits were issued anyway.

In November of this year Management Services sent a communication to the Board's office that their officers went to inspect this new lot and what's interesting to me is when we asked them why you inspected the new lot and what was their rationale for the move, they gave no rationale for the move to this particular Board. So all of this is very disconcerting to
me. Mr. Chair, as you know and as my colleague knows, Commissioner Taylor, many times folks come to this Board, especially our towers, who we've worked very hard with and have been, we believe, very fair with, some unfortunately still comment the fact that there is still some issues of impropriety within our system.

And certainly I'll vigorously fight against that, but unfortunately it seems to me that there are areas where some things have slipped past the cracks, and so -- and if not, there are just some flat violation of the tow rule process.

And so as a result of that, sir, I think it's incumbent upon us as a Board to act swiftly and decisively and to send a message that this type of behavior just cannot be tolerated, especially as we're moving forward to solidify our rules to make sure, again, it works for everybody.

We didn't pass the rules for a few, we passed the rules for the masses of those who wish to do business with us. And so as a result of that the findings that I've been able to uncover, just those, just the fact that we issued permits
to companies that based on their own leasing agreement were in violation, it's fairly disturbing to me.

And so -- and it does not do justice to those towers that we have that actually did follow the rules and did follow the procedures as it was outlaid -- laid out in our procedures.

Therefore, and $I$ don't know if this is the time for this or we'll open up more discussion on it, but $I$ am prepared to make a motion and I'll leave it up to you if you want me to do it now or later as relates to this particular matter.

COMMISSIONER WHITE: Thank you, Commissioner Warfield. Counsel, would you mind coming forward. I have a couple of questions for you.

Counsel, there is a number of concerns that were raised by Commissioner Warfield and he cited a number of sections in our Charter which speaks to the powers of this body, of which is the ability to subpoena witnesses and gather information.

Some of the improprieties that are being referenced to me would encroach upon an egregious violation of some of the rules that are in place.

What process should we adhere to? Now, I don't know what the motion is that Commissioner Warfield may have, but if it is a matter of -and I don't want to blindside the management either without them having an opportunity to respond to a lot of this by putting the motion forward at this point, but what should the process be as we move forward with this -- the handling of this situation in terms of getting an accurate account of what happened, allowing individuals to articulate their role in this process and in terms of what actually happened so we have an accurate record on the record before this body before we deliberate over this issue? MS. WASHINGTON: Celia Washington, attorney for the Board. Again, this is -- I heard it just as you did just now and Commissioner Warfield is correct in his understanding in his reading of the Board's responsibility and the purview of their authority.

I'd even go a step further. In addition to the Charter provision that

Commissioner Warfield cited there is specific language in the City Code, in the ordinance, that taken together deal even more specifically with towing.

But I think he pretty much hit the nail on the head with respect to the supervisory authority of the Board, so any argument of overreaching, which is one that is certainly not one that this board is not unaccustomed to hearing or being accused of, is certainly not the case here.

But you're correct, the Charter does allow or does provide for the Board to have subpoena power, to bring in witnesses. If it's the Chair or the Board's pleasure we can certainly get those subpoenas issued for the documents, but there's a number of different departments based on what I've just heard the Commissioner say.

There's Buildings \& Safety, there's Zoning, there's City Planning, because somewhere in there, $I$ believe maybe January of this year, there was a zoning change -- a change in the language of the ordinance where Planning kind of redefined what police-authorized storage and tow
yards should look like.
So if this Board would see fit to
launch an investigation, $I$ think all of those things need -- there are reports that were made to that Zoning Board with regard to changes.

You mentioned lot requirements in terms of fencing and encroaching on residential and all this. There's a number of things. But it's certainly within your purview to instigate or initiate an investigation in that regard.

What the Charter did change, the Charter didn't allow the Board to initiate investigations necessarily, and that I'd have to make sure that I'm clear on.

There's some launching of
investigations on its own that the Charter disallowed. I don't think -- I think it's more -- I just need to be sure, I need to take another look at it in terms of initiating because there was one point in the Charter that you could -the Board could initiate an investigation on its own, but if you'll allow me an opportunity to make sure that this is not one of the exceptions to that, $I$ can certainly do that.

But the Board does have subpoena power
and even absent launching an investigation, those subpoena powers were not taken away from the Board, so the Board has every right to ask for Buildings \& Safety records, Management Services records, all of the things that went into the decision to allow this change in address for this particular piece of property to happen.

COMMISSIONER WHITE: Before you leave, counsel. Commissioner Warfield, does your motion speak to the spirit of this conversation? COMMISSIONER WARFIELD: Yes, and probably a little bit even more basic than that. Thank you, Mr. Chair.

I think my notion really speaks to the initial issuing of the permits notwithstanding what has happened since the move, so mine goes back to the very basic beginning of the permits being issued to these companies in the first place, seeing that they were in violation of their own lease agreement from the owner that they were leasing the property from, which would have certainly made them not qualified to have the towing permits in the first place.

So it's even more basic than all of the moves that have taken place.

COMMISSIONER WHITE: Thank you, and counsel, would it be your position or recommendation that we take this situation in its entirety not only how they got the permits, but what happened when they got the permits? You referenced Zoning, Buildings \& Safety and others.

Is there a need to go that far or -MS. WASHINGTON: From a legal perspective, not to interrupt, Chair, I don't think that it's a legal decision as to how you approach this because $I$ think, if I'm understanding what Commissioner Warfield is saying, he's saying from the outset it was flawed.

And I'm not sure what his motion is going to say. I kind of get a feel for what his motion is going to say, but $I$ can't -- it's the Board's pleasure as to whether to take action on these five towers at this time, for lack of a better way to put it, and then to investigate or to do one and then the other or to do them simultaneously.

I don't think that there's a right or wrong legal plan, sir. I think it's the Board's
pleasure.
COMMISSIONER WHITE: But one doesn't preclude us from doing the other based on the sequence that we have?

MS. WASHINGTON: I don't see that, sir.

COMMISSIONER WHITE: Anything further from counsel before you --

COMMISSIONER WARFIELD: NO.
COMMISSIONER WHITE: Thank you.
Commissioner Warfield, on your motion, Chair will entertain your motion at this time.

COMMISSIONER WARFIELD: At this time, sir, Mr. Chair, in lieu of the information that has been presented to this Board, especially as relates to the violation of the lease contract by Mr. Joe Melville, $I$ am recommending that all five companies that were impacted by that lease be suspended immediately from the tow rotation until we can get some final answers as to if they should or should not have been located -- I'm sorry, have received permits.

In addition to that, to look into the move and what happened as relates to zoning and zoning appeals and if there were special things
done to push things through which may or may not have a view of impropriety.

So basically what I'm asking, sir, is
that we suspend all five companies from the towing rotation immediately until we are able to get some criteria, some very direct information, especially considering the fact that the information we have so far suggests that these permits were given out inappropriately.

COMMISSIONER WHITE: Before the Chair calls for a second for that motion to be accurate, Commissioner Warfield, could you please be explicit in which companies you're referencing?

COMMISSIONER WARFIELD: They would be, for the record let me pull the letters from the record. Give me a second, sir.

Mr. Chair, is it okay for the record if
I have can Mr. Melville come up and give me the name of those companies for the record?

COMMISSIONER WHITE: Yes.
COMMISSIONER WARFIELD: Mr. Melville,
could you approach the podium again, please.
State your name for the record.
MR. MELVILLE: Joseph Melville again.

The companies were Detroit Auto Recovery, J\&C Recovery, ABA Towing --

COMMISSIONER WHITE: I'm sorry, you said Detroit Auto Recovery --

MR. MELVILLE: J\&C Recovery. ABA
Towing, Independent Auto brokers, and the fifth company I'm not sure what the name was, Auto City or something to that effect. It should be under Northwest District.

COMMISSIONER WARFIELD: Was it City
Auto Towing?
MR. MELVILLE: That's correct.
COMMISSIONER WHITE: City Auto Towing?
COMMISSIONER WARFIELD: Or City --
MR. MELVILLE: I think it was City Auto
Storage. It was something to that effect. One of the representatives is here, he can answer the question correctly.

COMMISSIONER WARFIELD: City Auto, City Auto.

MR. MELVILLE: That's correct. COMMISSIONER WARFIELD: And for the record, Mr. Chair, the City of Detroit has a listing as J\&C Towing.

MR. MELVILLE: I believe it'S J\&C

Recovery.
COMMISSIONER WARFIELD: I'm just saying the record that the City has, but one of those -same company though?

MR. MELVILLE: Same company, that's correct.

COMMISSIONER WHITE: Thank you, sir. So, Commissioner Warfield, if you could fashion your motion to include the names of these companies.

COMMISSIONER WARFIELD: Sure. Sir, again, $I$ recommend that ABA Towing -- and I'm going off the list from the City Civil Rights Division of businesses that are registered with the City, I'm recommending that ABA Towing, Detroit Auto Recovery, City Auto, J\&C Towing and Independent Brokers be suspended immediately from the tow rotation until further notice after investigation.

COMMISSIONER WHITE: Is there a second on that motion?

COMMISSIONER TAYLOR: Second.
COMMISSIONER WHITE: It's been properly moved and supported. Any discussion? I do have discussion. Counsel, if you could, please.

MS. WASHINGTON: Yes, sir.
COMMISSIONER WHITE: To the Board's ability to suspend these companies and to make sure we do things decent and in order, would the Board place itself in harm's way if we suspended these individuals prior to us having the conversation about what actually transpired?

MS. WASHINGTON: Again, without having -- Celia Washington for the record. Without having the benefit of -- and this is kind of off the cuff -- if you would allow me a bit of time to get an answer together for you because $I$ would like for that to be the right advice because I certainly don't want the Board to move -- or to act out too quickly, so out of an abundance of caution, at least from my perspective, I would ask for at least until the next meeting to give you a formal opinion.

COMMISSIONER WHITE: Thank you,
counselor. Any other discussion? So Commissioners, before us is a motion for the suspension of five companies, Detroit Auto Recovery, J\&C towing, ABA Towing, Independent Auto Brokers and City Auto Towing.

Given that the recommendation of our
counsel, the Chair would ask that you take that into advisement under your vote that this matter might be best suited for our next meeting after we've had an opportunity to have a legal opinion rendered to this body to ensure that we are on solid ground.

So with that being said, and the motion
is already been seconded so it belongs to the body, so if there is a new motion we would need to dispose of this motion first and then deal with a new motion at that time, so if there's no further discussion the Chair will call for the question, all those in favor of this motion, signify by saying aye. Opposed?

COMMISSIONERS: Aye. COMMISSIONER WARFIELD: Negative. COMMISSIONER WHITE: Thank you, sir.

Commissioner Warfield?
COMMISSIONER WARFIELD: Yes, sir.
Thank you, sir. In light of what counsel had alerted us to, I would like us to take this matter up next meeting under old business with the guidance, but can $I$ just give some recommendations to counsel.

I know that in our tow rules, our tow
rules gives us the responsibility and the right to revoke, suspend or remove -- I believe to remove those from our tow lists, so -- but certainly we want to make sure -- and I agree with you -- that we are legally right, but I do want this to be on the agenda for next week and thank you, Mr. Chair, I appreciate that.

COMMISSIONER WHITE: Thank you, Commissioner Warfield. Anything else on our towing? Seeing none, under announcements, our next meeting will be held Thursday, June 14, 2012 at 6:30 PM. Our meeting will he hosted within the Southwestern District at the Southwest Public Safety Center, address 4700 West Fort Street, Detroit, Michigan 48209.

At this time the Chair will entertain oral communications from the audience. If you wish to address the Board of Police Commissioners you would ask that you would come forward, for the record please state and spell your first and last name and be mindful of the two minute allotted time period which is given by Office Manager Brown to my left and your right.

Good afternoon.
MS. McCLELLAN: Good afternoon,

Commissioners. My name is Cecily McClellan and I'm here today because we're very much concerned about an activity that occurred with the police department on Woodward and Calvert that involved our three nephews, three nephews of mine, great-nephews, and it is our opinion that the police treated them inappropriately.

I have one of my nephews here, the one that was interrogated by the police, and I think he needs to share this behavior -- I mean, what happened to him, and this is his father.

MR. McCLELLAN: Miguel McClellan.
TYREN McCLELLAN: I was on Woodward
Avenue -- my name is Tyren McClellan. I was 12
-- I'm 12 years old. I live at (ADDRESS.)
COMMISSIONER WHITE: No address, please.

TYREN McCLELLAN: No address? Okay, I live on Calvert. I was CVS parking lot which is right across the street from my house on Woodward Avenue and we were going home and that's when the police pulled up and I thought it was my uncle so I stopped, and that's when they got closer and they got out and they asked me if they were going to -- if we were going to make them chase us.

So he put me on the car, my arm behind my back and asked me if $I$ was smoking weed and I said no. And I asked him what he was going to do to me and he said that he was going to beat the h--- out of me. I said, "Please don't hurt me". So that's when he started asking me questions like my name, where I live and who I live with. So when I told him I live with my father Miguel McClellan he asked me if he goes by another name and I said no, and then he asked me if I knew Cocomonte McClellan and I said yes. Then he asked me where does he live and I told him I didn't know. Then -- oh, they handcuffed my cousin Tyrese and my nephew Chris on the car and kicked Chris leg so he could spread them, but they left a bruise.

MR. McCLELLAN: All these kids 12 and under.

MS. McCLELLAN: They're 12 years old, okay, and if they were concerned about curfew because it was approximately 10 , but they lived -- you could see the house. And if it was -- we could have respected that. They could have took them right across the street.

But curfew never came up based on their
report and I did have a written report for them from all three children. But $I$ mean it is disturbing to the family.

I am the mother of Cocomonte McClellan and, you know, it just appears that from past issues that these officers are bringing up some issues that happened before. He's trying to get his life together and he's doing fine.

But my concern is that they handcuffed 12 year olds and they hand --

MR. McCLELLAN: And they interrogated them.

MS. McCLELLAN: And handcuffed them to the grille of the car.

MR. McCLELLAN: Unfortunately we don't have no names or badge numbers but --

MS. McCLELLAN: But we're going to write the report up, we will give it to the chief investigating officer and, you know, it's our opinion that if you don't stop this, it will get worse.

COMMISSIONER WHITE: Mc. McClellan, before you leave, and Mr. McClellan certainly Tyren -- first of all, Tyren, we certainly appreciate and salute your courage for being able
to come forward. I would imagine that situation could not be a favorable situation, but we applaud you for your courage to come forward to make sure that your voice is heard in this matter.

This Board and body has a zero tolerance for treating young people or any person for that matter inappropriately. We hold our officers of this department to the utmost professional standard and if whatever the situation may be, if you were in fact treated unfairly, we certainly apologize for the actions of that officer and you have our commitment that we will work diligently to find out -- even though you may not know their names or badge numbers, there is a process that we can put you with.
I'm going to ask parents and
grandparents if you could speak with Lt. Timothy Leach from our Office of the Chief Investigator so we can make sure that we handle this situation appropriately for you. We certainly would appreciate your patience as we move through this process to try to identify the nature of this incident and what
actually transpired that date.
But, certainly, Tyren, we appreciate your coming forward and you have the right to go to school and move back on your way home without being intimidated by anyone including members of this department.

So again, thank you for coming forward today.

MS. McCLELLAN: Thank you.
DEPUTY CHIEF LEE: I do have a couple of comments through the Chair here. Deputy Chief Lee.

And I don't know if you -- was it 10 o'clock you say you were still out?

MS. McCLELLAN: It was 10 o'clock, probably slightly after 10.

DEPUTY CHIEF LEE: Let's just make sure on that avenue of things that the kids are home when they're supposed to be. 10 o'clock is just absolutely too late for 12 year olds to be out.

MS. McCLELLAN: And we agreed, but it was warm and as we indicated you can see their home from the parking lot.

MR. McCLELLAN: They play in the parking lot.

MS. McCLELLAN: And if that was their concern, we could have respected that. You know, we would have expected the police to drive right over there and point and let us know they're over there in the parking lot after CVS closed, but that didn't happen.

COMMISSIONER WHITE: Thank you, sir.
And, Deputy Chief, you brought up an interesting point. What is the actual curfew for minors in the city of Detroit at this point?

DEPUTY CHIEF LEE: I will defer to Officer Evans on that so that $I$ don't misquote it.

OFFICER EVANS: It is 10 o'clock for anybody 16 and under for now, during the summer hours. And then it changes in September after daylight savings.

COMMISSIONER WHITE: So curfew only applies to those who are under the age of $16 ?$

OFFICER EVANS: Correct. 16 and under and then there's -- $I$ believe it's 11 o'clock 17 to 18 depending on -- there's some different articulations concerning going to work and coming to and from work, but yeah, 16 and under.

COMMISSIONER WHITE: And if individuals
are approached who are minors after curfew, what typically transpires in that situation?

OFFICER EVANS: We would normally -personally. I can't speak on behalf of everybody else, but protocol would say that we get their information, the child's name, address and then we would issue them a curfew violation.

Many times we won't take them back to district, we have the option to take them home, issue the ticket, talk to their parents as well or even issue, for the younger children especially, a parental responsibility ticket because they need to be accountable for where their children are.

And so that would be the normal
protocol for that. Otherwise, I believe we are giving -- we're given a little bit -- you know, we have the opportunity or the option to put them in handcuffs or not based on the fear that we might have in the totality of the circumstances.

If the CVS is closed, you know, we might be more cautious because these children might be trying to break in or whatever the case, so really the totality is how we might handle that situation differently, so it's really up to
the officer.
COMMISSIONER WHITE: Sure. Thank you.
MR. ADAMS: How, folks, how are you. My name is Dean Adams, I'm the owner of Marilyn Monroe's down in Greektown, address is 419 Monroe.

On May 4 about 10:35 PM, I entered into my business, went to the second floor and I grabbed the credit card machine and was tying it up.

A young man approached me, grabbed me by my suit collar, put out a . 40 cal Glock, told me he was going to kill me.

There were about 10 or 14 people on the floor that ran for cover. After two or three minutes of telling this gentleman that don't kill me, XYZ, he proceeded downstairs to the first floor.

I got to the first floor suited. There's two bouncers there. One of the bouncers grabbed me and says, "Well, you know, what are you doing?"

I said, "First of all, I'm the owner."
I identified myself as the owner of the business. He responded to me, "Well, I work for the other
individual who grabbed you." I said okay, but of course I started fighting, get your hands off me, let's go.

The other bouncer came behind me, forced me out the front door in front of the building. While myself and the bouncer are going -- the two bouncers, my weapon which is in the pit of my back, goes down and hit the ground.

My weapon is empty. The reason why my weapon is empty is I'm transporting my weapon into my business because prior about a week or so I spoke with Lieutenant State Trooper Roger Williams.

Roger Williams said you can't transport your weapon to your business or your business and your personal protection. I said okay, he said, "But here's that you have to do. You can't take the bullets with the weapon. They have to be separated."

So usually you either take the bullets first or you take the weapon first. I took the weapon and it just so happened on this day all this happened.

Someone called the police, called the police. Again, I'm in Greektown. There's police
everywhere in Greektown. I'm the only black merchant in Greektown.

So the police -- the police -- I'm standing there. A police -- the black police van pulls up in front of Fishbones, they're talking to the gentleman, I guess the bouncer, who just saw what happened.

So after he got down talking $I$ walk to the curb which is like from here to you, Deputy Chief, and I do like this. I said you need to come over here now.

The officer looked at me and just kept driving. So he gets so far. Then the black officer that walks the beat comes to me, I'm standing there, I'm bloody. I mean, I just had a fight. My shoulder is out of place, hematomas here, and I said to the black officer, "I need a police to come here."

He said, "Okay I'll call them." Well, after about 15, 20 minutes my understanding of policing is, the officer that's there can take a report and start the investigation while the investigation is fresh.

The person $I$ had the fight with was standing there, the perp was inside the building
who pulled the weapon on me, and he could hurry up and he could start the investigation, go through the PREP and call the supervisor over and say, "Okay, here's what's happening."

After about 20 minutes $I$ came here to the front door there to do my report. The lieutenant just happens to see me, and I got blood on me. He said, "Go let him in." I go in and clean myself up and $I$ told him what happened. 1300 goes down and speaks to the people inside the building. The bottom line is this. A police officer come, see I got blood on me and I say, "I need the police" and he say he's going to call for one.

When you the police, take out your pad, get started writing until the supervisor get there. That's my understanding of the police. I was public safety for 20 years with DPS. I carried a weapon 20 years. I just stopped carrying a weapon on March, 2010 because I didn't need it any more.

The weapon I did have was a present from my grandfather. You guys had a weapon turned in sale, I went to Agervance Church and sold it and I could have sold it to anybody. I
sold it because I didn't need it any more.
All I'm saying is policing in Greektown
is different. If police officers are there, why do I need to call 9-1-1 when it's my emergency? Why do I need to call 9-1-1 and they're right there in front of me? I don't understand what their purpose is. I don't understand that.

To walk up and down the street or police. I'm just trying to think where the policing part is, that's all I'm saying, but that's it.

COMMISSIONER WHITE: Thank you for coming forward. Deputy Chief, as relates to the protocol -- and you may have a service complaint against the department. I ask that you also speak to our Lt. Timothy Leach, our acting chief investigator for the Office of the Chief investigator before you leave who's right to your left.

MR. ADAMS: Excuse me. I went over to -- I think it's John Bennett, I went over there and filed a complaint also because, again, my think is they in a van, $I$ wave at them and they know what just happened, they going to pass me up.

And then the guy going to ask me, I said, "I need the police," he say he's going to call them. He got a PREP right here. I'm out of service. Get a supervisor here while I do this. The evidence is right here right now.

I just got clearance to go over to the Prosecutor's Office yesterday for tomorrow. Now, I don't know any of the witnesses, I don't know any of the folks. Thank God I had the manager who knew who $I$ was and he was able to come and ask the detective what was going on.

But the detective called me on Mother's Day. I had not spoke to a detective. He called me on Mother's Day. The incidence happened on the 4 th of May. I could have been killed.

I'm sorry, I have to be shot for the police in Greektown to do something? I'm just asking that question now.

COMMISSIONER WHITE: That's certainly not the case.

MR. ADAMS: I hope not.
COMMISSIONER WHITE: But again,
Investigator Timothy Leach, supervising -- I'm sorry, acting chief investigator, Lt. Leach will certainly speak to you following this, but also I
wanted Deputy Chief Lee to speak to the protocol of taking the complaint of a citizen in distress. DEPUTY CHIEF LEE: Deputy Chief Lee through the Chair. Without knowing the totality of all of the circumstances and everything that happened, it appears that there was -- just from what I'm hearing here, some dispute between you and some of the employees there, which are your employees if I'm not mistaken?

MR. ADAMS: Correct.
DEPUTY CHIEF LEE: And I don't know if they knew this gentleman, they didn't know him, and what information they were going to take or what they were in the process of doing in-between.

So I would just defer that we could get the information and also have Deputy Chief Wells take some information from my office because I have the east side of Detroit and Greektown and I'll look into it and we'll see what happens. MR. ADAMS: Thank you, sir. MS. RICHARDS: Good afternoon. Our pastor Jim Holly sent us here to bring our complaint. This is my granddaughter and we need your help.

COMMISSIONER WHITE: And your name for the record.

MS. RICHARDS: My name is Kendretta Richards.

MS. PURRY: My name is Natasha Purry.
COMMISSIONER WHITE: Yes, ma'am.
MS. PURRY: I have two Caucasian neighbors that's really poor and every day he talks to me and calls me if anyone pulls up in my driveway, he calls me. It's just really just our house. We stay on Telegraph and Fenkell and it's just my house and his house.

And Friday, July 1, his father calls me and he informed me that some people are pulling off from my house with all my new appliances, my washer, my dryer, my stove and my refrigerator. So I say okay. He said, "They in a black truck. Do you know anybody?" I know, "No."

So he hangs up the phone. He calls me back and he's hollering and screaming and he says, "I just ran my truck into they trailer." So I said, "Okay, my bothers are around the corner." Just so happened I had called my brothers and they was right around the corner. I say, "They'll be there because $I$ was way in

Madison Heights.
So I gets to the scene, the police are already -- the police, it's two white cops, it's two black cops is in the car, and it's the people, the three people that has all my belongings. And the father of the son that stays next door, the son had ran off.

And the people were telling the police officers that the guy next door told them that I was in a nursing home and that $I$ left all my stuff to them and he sold it to them for $\$ 150$, and he gave them my microwave for free.

So the police officers -- when I -everybody is there already. I pull up, he say, "Ma'am, do you live here?" I said, "Yes."

He says, "Are those your belongings?"
I say, "Yes." He said, "Do you want to press charges on anybody?"

I said, "Yes, I want to press charges on Keith, Sr and Keith, Jr because they sold these people my stuff for $\$ 150$ " because the people hollering, they screaming, they mad because they can't leave. The man done run his truck into they truck trying to pretend as though he was trying to stop them.

So the officer, the two white officers, they're standing there. One of them talking to me and he says to me, "Well, ma'am, I'm getting ready to arrest all y'all."

And I said, "How you going to arrest me?" I said, "That's my stuff they have on that trailer." He said, "Well, listen. I could make a report, but $I$ don't see no reason really because the son is gone and I don't think the daddy have nothing to do with it."

And the young lady who bought the stuff for $\$ 150$, she saying, "Yes, the father do. Him and the son came and got $\$ 40$ earlier, a down payment of $\$ 40$ earlier today, and they told me to bring the rest when we come pick up the merchandise."

So the police officer still doesn't arrest nobody. He helped the father get his truck started, had someone give him a boost to move his truck and then $I$ say, "Well, are y'all going to arrest anybody?"
He said, "No, there's nobody to
arrest." I said okay. So I say, "Are you making a report?" He say, "I really don't see why. The son is gone."

So they gets in their car, something, I'm "What's your badge number because I'm reporting you on my day. I am reporting you."

He wouldn't give me his badge number, so the two black officers they say he's supposed to give you the badge number.

And I ran to his car, me and my brother, and I said, "They informed that you supposed to give me your badge number."

He start hollering out the car, "337, 337." So I'm putting the number in my phone. So then he pauses, he about to pull off, so I guess he think about it because I say, "You know you're going down on Monday."

He started doing the report. He pulls over and started doing some kind of report. He never asked me any questions, he never looked around my house to see how they got in or anything.

So they leave. I'm still there, the police that still has my stuff still there. We waiting on my friend to come with a truck so I can move my stuff because $I$ know the crazy white boy still is out there, and he is psycho.

So the next morning which was
yesterday -- no, yesterday, I goes over there to check on my house. I pulls up. The white boy busting the windows out. He runs off into the woods. I call the police again. The police gets there.

They inform me they don't take a report either because I called Internal Affairs and they say it wasn't no report made. They didn't make the report. They tell me to go talk to the detectives down on Warwick and Plymouth and tell them about it.

So I goes down on Warwick and Plymouth yesterday, $I$ gets to the back. The lady, they still at the desk, nobody never gets up, they talking to each other.

She say, "What you need?" I said, "I really don't know what $I$ need at this point." So the guy comes over to the desk. He like, "Who sent you here?"

I said, "Some police officers came out to my house sent me here." He said y'all better call TRS or $T$ somebody and tell them quit sending people over here, quit sending people over here."

So then the detective call -- I'm sitting out there waiting on the detective, he
say, "Have a seat." I'm waiting on the detective. The detective come in the hallway and he said, "What you need?"

I said, "Well, my house was just broken into, no one was never arrested and the guy was breaking my windows out and the police told me to come here."

He said, "Who." He looking through these paperwork because I had gave him the report number. He say, "It don't say nothing about --" he talking to me in the middle of the hallway -"It does say nothing about them saying that the man was in your house," this, this, that and the other.

I says, "Excuse me, sir, but they called the police. I didn't call the police. The people who had my stuff called the police because he rammed they truck into they trailer."

So he invites me to his desk now. He never asked me to sit down, nothing. He sits down, leave me standing up.

Then he said, "What can I do for you?" I said, "Well, I'm just trying to find out, are y'all going to come out and look for the guy? He right next door. I don't even go home. He done
bust out all my windows in my house, stole all my appliances and you mean to tell me you mad at me because I'm here?"

I say, "Well, from this report it doesn't say that he did anything, that he -- he was in your house." I said, "How was he in my house and the police officer stood there while the people told him that he went in my house, his daddy stood there and he watched him load -- they didn't load my stuff, he loaded my stuff onto they trailer."

He said, "Well you know what, I don't know what to really tell you, but I'll get back with you." He said, "I'm going to investigate this tomorrow."

I sold okay. I said, "You know what,"
I said, "I'll never live in Detroit ever again." I say, "I've never been humiliated. Someone steal -- I'm a single mother with two kids. Come to my house and steal everything I own and you mad at me. You acting like I did something, treating me like the criminal," but which I have been informed by my neighbor Keith, Jr that his cousin works at that precinct. He told me this several times before this incident.

So I'm thinking in my mind the cousin -- his cousin might have been one of the police officers because they were white. So I don't know, but however, he calls me today and he's trying to explain to me that he didn't have nothing to do with it, this, this, that and the other.

He called me blocked ID. Thirty minutes later a police officer claiming to be from the 6th District calls me, wants me to tell him the story over the phone.
"I'm Officer Kongy and I would like you to tell me what happened at your home last Friday."

I said, "No, ask the commissioners because that's where I'm getting ready to go to. I don't have to explain nothing to you."

I said -- and he called me blocked ID.
I say, "Why are you calling me blocked ID" and he hung up the phone.

COMMISSIONER WHITE: Ms. Richards and Ms. Purry, I thank you as well for coming forward. I know it takes an exorbitant amount of courage to come forward, particularly to lodge a complaint against members of the Detroit Police

Department, so we applaud you for that courage, and again apologetic. Certainly that is not indicative of the professionalism that is expected of members of this department.

And again, it appears to be a complaint against service, which is service oriented and if you have not already done so, which is filed a complaint with the Office of the Chief Investigator, Supervisor -- I'm sorry, Lt -- I'm going to get it right one day -- Lt. Timothy Leach, acting chief investigator will be happy to take your information and that body reports directly to the Board of Police Commissioners, not the Detroit Police Department.

So we look into every complaint that comes against the department and, Deputy Chief, I'm not sure if you have someone who would like to address that issue either. I do see Deputy Chief Wells as well.

MS. PURRY: And one more thing.
Basically I can't even go home because this man is right next door to me, him and his daddy and they have not -- I can't go home, he bust all my windows, so $I$ can't even go home.

MS. RICHARDS: And they still probably
taking her things that she --
MS. PURRY: Furnace, no telling.
MS. RICHARDS: And he's been so kind to these people.

MS. PURRY: They had water for three years, I let them use my water hose.

MS. RICHARDS: Water from her house.
COMMISSIONER WHITE: Yes, ma'am.
MS. RICHARDS: So please help her. She needs this help.

COMMISSIONER WHITE: Deputy Chief, anything further?

DEPUTY CHIEF LEE: Yes. I do apologize for what you have gone through and Deputy Chief Wells who has the west side, he will be more than happy to take your information and see to it that you do -- if nothing else, you get some special attention to your house tonight.

MS. PURRY: Thank you.
COMMISSIONER WHITE: Thank you, both of you.

DEPUTY CHIEF LEE: He's standing right in the back.

COMMISSIONER WHITE: To your left here, my right, and Deputy Chief Morris Wells is in the
rear of the room.
Good evening, sir.
MR. SENIOR: Good evening. My name is Konaka Senior. I had a break-in on my house on May 9 or the 11. Officer came out, he responded in a quick amount of time. The gentleman took a report. He said he was going to get back with me and give me the report number.

I wanted a week, I didn't hear anything
from him. I've been coming down here for the past three weeks. Every today I've come down here the computers are down. I'm so tired. My adjuster keeps saying I need the report to finish the claim and it's every day.

I don't know who's over IT Department, but personally they need to be fired. It's embarrassing. I spent -- I paid for the meters so I don't get a ticket. I work two jobs. It's sorry, it's ridiculous.

It's a shame, for three weeks. I just left out of there and the lady told me -- officer told me that you all were having a -- Detroit Police Commission was here today. She said have a talk with you guys because I've been down here for three weeks trying to get a copy of a report
to submit to the AAA adjuster so they can pay me my claim for my homeowner's and it's ridiculous.

COMMISSIONER WHITE: Absolutely, and I'm sorry, your last name?

MR. SENIOR: Senior.
COMMISSIONER WHITE: Mr. Senior, certainly --

MRF. SENIOR: I don't mean to interrupt you. I call believe I come, it's up and running, then it's down and I spent two or three hours down here, the computers were up, they were down. I don't have time for that. I have other things in my life to do besides sitting around trying to get a copy of a report.

And to be honest, you probably hear, I'm out of here.

COMMISSIONER WHITE: Absolutely and we thank you for coming forward today. Deputy Chief, is there some remedy that we can get Mr. Senior in the short term so that he's not inconvenienced any further as relates to obtaining a report number?

DEPUTY CHIEF LEE: Yes. Through the Chair, even though Records is closed, if you stick around I know Deputy Chief Wells is
outside, if we can have your report number, we'll go right to the Central District and have a report printed for you no cost, you can have it today.

MR. SENIOR: Thank you, I appreciate it kindly.

COMMISSIONER WHITE: Thank you for coming down.

MS. LACY: Good afternoon, my name is
Mary Lacy. Okay, I attended the meeting last week and I asked to speak to someone concerning senior safety. However, I never got a call. I realize we're under a new commissioner.

They said somebody -- gave them my number, they said somebody could call. But anyway I don't want to waste my 2 minutes on that question.

I hope I can do my questions and then you guys can submit your answers. I want to know how many Detroit police officers live in Detroit, like somebody who live outside of Detroit, like 50 to 75 percent? That's my second question. My third question is how many times in one year can an officer request representation through City Council. That means free attorneys.

That means the taxpayers pay for their attorneys. So I'm trying to find out how many times can an officer go before City Council requesting lawyer's fees, that's what we call it, but I guess you guys call it representation.

COMMISSIONER WHITE: Thank you, Ms. Lacy. And, first, let me apologize if someone did not follow up with you. I do recall you asking for the request and, Deputy Chief, I believe you were here as well when we made the recommendation that possibly Det. Brian Fountain would follow-up with Mr. Lacy and I don't know if that was Deputy Chief --

DEPUTY CHIEF TURNER: I wasn't here last week, but there certainly will be no problem in getting that presentation together for her.

COMMISSIONER WHITE: So can we make sure, Deputy Chief, that we follow up with Ms. Lacy on that issue today?

DEPUTY CHIEF TURNER: Be talking to her tomorrow.

COMMISSIONER WHITE: Thank you, sir.
Ms. Lacy, also on your residency --
MS. LACY: Excuse me. He say he'll be talking to me tomorrow?

DEPUTY CHIEF TURNER: Well, he's not available today.

MS. LACY: Okay.
COMMISSIONER WHITE: As it relates to
your residency percentage question, Deputy Chief, is that information available?

DEPUTY CHIEF LEE: Deputy Chief,
through the Chair. I don't know if that information is available. It probably would be available through the Personnel. The director may be very able to answer that question.

I don't know where she's at, but I don't know off the top of my head what the percentage is.

COMMISSIONER WHITE: Ms. Lacy, we will work to get that information for you and report back to you next week if you're at this meeting. I don't see our director of Personnel or I would certainly invite her forward at this time.

MS. LACY: Next week they'll be meeting on Fort Street? You have to realize a lot of us don't have chauffeurs.

COMMISSIONER WHITE: We'll be more than happy, Ms. Lacy, to get your information and we can follow up with you and call you with that
information if you would like.
Would that be amenable to you?
MS. LACY: Oh, I have no choice. So third question --

COMMISSIONER WHITE: And your last question as relates to officer, how many times they can request representation?

MS. LACY: Right.
COMMISSIONER WHITE: And, counsel, correct me if I'm wrong. The officers are represented by the Detroit Police Officers Association -- no? Counsel?

MS. WASHINGTON: I believe the cases that Ms. Lacy -- and I'll get your number before you go and I'll get that information to you -the cases that she' referring to are the Law Department, the cases where the City of Detroit is sued and there was an officer involved and the process requires that the officer apply for legal representation, basically indemnification, and I'm not aware that there is a limit, but we can certainly find out. There is no limit. I don't think there is. Back in the day when I used to do it there was no limit.

COMMISSIONER WHITE: Thank you, Ms.

Lacy.
MR. STIDHAM: Good afternoon, members of the Board, Mr. Chair, Deputy Chief, Mr. Secretary. Tom Stidham and I've represented towers for a long time and what I saw today, the actions of the Board in the interest of enforcing the rules were somewhat perplexing and quite dangerous I think and let me explain why I say that.

First of all, the rules, with all due respect to this body, do not -- the towing rules, do not permit this Board to enforce private right of action between two towers or between a land owner and a tower. Simply is not permissible by the rules.

Moreover, the information -- and I don't know what it is -- but the information that was submitted apparently to this Board, there has been no -- the Board referenced an alleged breach. There's been no court determination of any breach to my knowledge, so I would certainly ask this body to go back and take a hard look at that.

Secondly, I think this Board has a duty to all the towers if there's an alleged
violation, because I think the board has opened the flood gates, if there's an alleged violation you have to notify the companies of what that violation is.

What specific -- and I'd ask this body -- what specific rules or towing rules, provisions of the towing rules have been alleged to have been violated in the case that the Board referenced earlier.

But that applies throughout the Board in any case. Moreover, $I$ think now what's going to happen in light of what happened or what occurred or in light of what occurred earlier is towers are simply going to lodge a complaint against a competitor and try and present this body with some information and ask that, you know, this Board take whatever action that these other towers desire.

And I think that when the Board reviews its policies it really has to be mindful because this Board has taken a blind eye with all due respect to some of the things that have gone on with respect to the properties.

For instance -- and I'm certainly not going to name names -- but this Board has sat
back and watched at least one company sit back with its yard closed for nearly one entire year simply so that it can gain a rotation spot.

And then when it gets tipped off, just recently they've put cars back. Now, if you're going to enforce the rules, do it fairly, do it equitably but do it to everybody. Prove to the public that the rules apply to everyone.

And lastly I would note procedurally
that this Board does not have the authority to disqualify or terminate any company without first have a hearing and giving those companies their due process protections.

If that's going to occur, it ought to not just occur without even notifying the companies to be there, notifying them of the alleged violations, giving them an opportunity to respond, giving them a violation -- or giving them an opportunity to present whatever rebuttal evidence or documents that they feel is appropriate that ought to be considered by this Board.

And $I$ certainly will talk to your counsel after the meeting about implementing those kind of protections, but I think today that
this Board should recognize that you've opened Pandora's box in allowing other competitors to try and use this body and your rules as an effort to eliminate the competition.

And this certainly isn't within the spirit of the rules or certainly isn't fair and equitable. So any action $I$ think taken by the Board without ensuring that those due process protections are implemented ought to be deferred until this body can comply with the due process rights of all the parties.

COMMISSIONER WHITE: Thank you, Tom, for your comments and I certainly would hope that what you take away from today's meeting is that this Board moves very deliberately and both cautiously to ensure that we are on solid ground, so comments that we may be moving haphazardly or opening Pandora's box, $I$ would be in disagreement with you.

We are very much dedicated to having a transparent process, a process that is equitable, as you stated, for all towers that are engaged in this process and certainly $I$ think our track record speaks for itself that we haven't done anything haphazardly or without due diligence,
without information being shared and I think that it is exemplified by what you saw transpire here today to rescind a motion to make sure that we are on solid ground, so I would hope certainly that you would take that away from today's meeting.

MR. STIDHAM: I certainly appreciate that, Mr. Chair. What $I$ would say is I'm just saying that it seemed like there was already -and I think the parties involved are probably going to question when a motion has already been made to suspend the companies, the objectivity or once a due process is afforded to the parties of a subsequent decision involving this matter so when you've already made a motion.

So I think there has to be some, I would submit to this body and as counsel some extra due process protection afforded to the parties.

COMMISSIONER WHITE: Thank you, sir. Commissioner Warfield?

COMMISSIONER WARFIELD: For the record -- thank you, Mr. Chair. For the record, I just want to clear up some things for the record.

Mr. Chair, as you appropriately stated,
this is not the first time we've dealt with this issue. This is not the first meeting that we've had concerning this move by these towers as relates to complying with our rules, so certainly we're not moving -- and Tom is a friend of mine -- we're not moving in a manner that is trying to ramrod someone or anything like that.

As relates to the information that was presented to us, it's very clear in the lease that there are clauses in that lease that was violated, period. I saw the lease.

Whether a court ruled on it or not is not the issue for me. The issue for me and this Board I believe is was that lease supposed -- did that lease have those clauses in it and was those clauses violated. It's real simple. It's sort of cut and dry.

As relates to notification, the towers understood this. Again, we made notification before that we were going to have this hearing. It was on for last week. However, a quorum was not established last week so we brought it back this week. That wasn't a surprise to anyone. I mean, it's been on our list.

As relates to us taking a blind eye, I
don't take a blind eye to anything and we investigate every allegation that comes to us, whether it be from other towers. I've been here for almost three years now and since I've been here there's been allegations throwing back and forth amongst the towers. You pick them, you pick the combination, and they've been there and we've investigated all of them fairly and equitably as the Chair said.

So it's not that we're taking a blind eye to anyone. Anything that comes across our desk it is our obligation and duty to do that and I think we've done that.

Now, I understand that you're representing the interests of your clients and $I$ have no issues with that because you're doing exactly what you're supposed to do, so I don't have an issue with that.

I guess $I$ just want to be clear on the record that this was not something that was done haphazardly, this was not something that was done maliciously or viciously.

This was done in an effort to make sure that we uphold the rules, as you say, for everybody, that there are no, you know -- that
there are no favoritisms that we show.
And so, again, we investigate
everything that comes across us.
COMMISSIONER WHITE: Thank you, Tom.
MR. STIDHAM: I just have one
additional comment unrelated to that.
I had received some information from the Board about a particular company and I think we've addressed it. I don't know if you've seen what we submitted or not, but I would like to talk to the commissioners and perhaps its attorney about that as well about that this company was removed from the rotation temporarily, so --

COMMISSIONER WHITE: So, Tom, I would ask that you would speak to our counsel. Unfortunately we wouldn't be able to convene outside of this meeting with all of us a table, but certainly if you share that with our counsel, she could certainly get information to us directly.

MR. STIDHAM: Thank you. COMMISSIONER WHITE: Thank you. MR. MELVILLE: I kind of took exception to what Mr. Stidham had to say. I never stood up
here three weeks ago or a month ago and asked for anyone to be removed. I never casted no stones or picked on any certain tow company.

The question I brought to the Board was I asked if certain tow companies were allowed to move, can $I$ purchase a tow company and move it to my current locations.

I never brought up any allegations, so forth, so forth, so forth. I just stated what's good for one company must be good for them all. If the Board is going to allow the five companies to move, then I request for two companies to be moved onto my premises without me going through the process of applying for a permit.

So as a competitor -- I mean, it was not done any way, shape or form to harm anybody. I just asked for permission for one company is allowed to do for me allowed to do, that's it. COMMISSIONER WHITE: Thank you, sir. Any other communications? Any other communications? Any other communications? Seeing none, again, please be reminded the next Board of Police Commissioners meeting with be held within the Southwestern District on Thursday, June 14, 2012 at 6:30 PM. It will be
held at the Southwest Public Safety Center, 4700 West Fort Street, Detroit, Michigan 48209.

At this time there's no further business before us. The Chair will entertain a motion for adjournment.

COMMISSIONER WARFIELD: Move to adjourn.

COMMISSIONER TAYLOR: Second.
COMMISSIONER WHITE: Properly moved and supported. Any discussion? Seeing none, all those in favor?

COMMISSIONERS: Aye.
COMMISSIONER WHITE: Opposed? Thank you, have a wonderful weekend. (Proceedings concluded at 4:35 p.m.)
