4 CHAIRMAN WARFIELD: Good afternoon, ladies 5 and gentlemen. Welcome to the Board of Police 6 Commissioners Meeting. My name is Jerome Warfield, 7 Chairman of the Board of Police Commissioners. Also 8 serving with me today is Commissioner Donnell White, 9 and representing the Chief's Office is Deputy Chief 10 Benjamin Lee.

We're going to ask if our Board Secretary Mr. George Anthony will introduce our staff at this time.

14 SECRETARY ANTHONY: Thank you, Mr. Chair. 15 For the record, George Anthony, Secretary to the Board. 16 We have present Ms. Pamela Davis Drake who is our Chief 17 Investigator, Ms. Loletha Porter, who is our Director 18 of Police Personnel, Ms. Celia Banks Washington, who is 19 the Attorney to the Board, Mr. Robert Brown who is our 20 Office Manager, Sergeant Alan Quinn who's recording our 21 proceedings, and Ms. Elizabeth Koller from Hanson Court 22 Reporting Services. That completes the introductions. 23 CHAIRMAN WARFIELD: Thank you, sir, I

24 certainly appreciate that. Of course we do not have 25 quorum at this time, so we're going to move forward



1 until we do get guorum with the presentation that we can have and then when we do receive quorum we'll move 2 toward our voting matters at that time. 3 Right now I'm going to ask if Pastor Devay 4 5 Myatt could come and lead us in our invocation. He is 6 also a Chaplain for the Detroit Police Department. Good to see you, sir. 7 8 PASTOR MYATT: Thank you, sir. I'll take this time to bless you. Heavenly Father, we bless you 9 10 and we thank you, God, as we come before you today. We yield our thoughts and hearts to you because you are 11 12 the wise God that knows all things. 13 We pray, God, for your blessing upon this 14 Board. We ask your blessings upon those that have come 15 We ask, God, that you would lead us and direct todav. 16 us in all ways of truth. In Jesus name. Amen. 17 AUDTENCE: Amen. 18 CHAIRMAN WARFIELD: Thank you, Pastor, we 19 appreciate that. Moving onto the Chairman's report and 20 then we will come back to the voting items later. 21 Certainly we want to thank all of you for 22 your patients. We're meeting here today because of the 23 baseball game downtown so that we would not incur an 24 extra hardship on those who wanted to come to the 25 meeting to pay \$40.00 to see us, we think that's a bit



pricey for admission, and so we thank you all for just adjusting your schedules and coming here today. Also we want to say that were very very proud and pleased of the outstanding work that the men and women of the Detroit Police Department are doing.

6 They're operating under some very difficult times without question. But the fact that the reports 7 8 that we receive that they're still, you know, showing 9 up doing their job and doing it in a very professional 10 So certainly we want to thank you to the way. Commanders, Sergeants, Lieutenants, and the men and 11 12 woman on the street that are answering and handling 13 calls in a very professional manner.

14At this time, Mr. Secretary, do you have a15report?

16 SECRETARY ANTHONY: Yes, sir, there's a 17 Secretary's Report on citizen complaints. The citizen 18 complaints received for August of 2012 the monthly count of complaints was for August, 91, compared to the 19 20 same period of 2011 of 132 which represents a 21 48 percent decrease. The year-to-date figures are 882 22 for 2012 and 894 for 2011 which represents a 17 percent 23 decrease.

At the end of August 2012 the Office of the Chief Investigator had open investigations 221, cases

1 filed year-to-date was 882, cases closed year-to-date 2 was 1,361. Of the 91 cases filed in August 2012, 26 involve unknown officers, the alleged known units 3 4 involved leading in complaints filed in August 2012 5 were the 6th Percent at 13 percent, Eastern District at 6 12 percent, and the Northeastern District at 6 percent. 7 The 91 cases filed in August 2012 involve 179 8 allegations where the leading areas of concern were 9 demeanor at 28 percent, procedure at 27 percent, 10 service at 16 percent, and force at 14 percent. That 11 concludes the report. 12 CHAIRMAN WARFIELD: Thank you, Mr. Secretary. 13 Any questions, Commissioner White? 14 COMMISSIONER WHITE: None. 15 CHAIRMAN WARFIELD: I just have a couple. 16 What does our 90 day caseload look like? 17 SECRETARY ANTHONY: Mr. Chair, I think that 18 report is coming, to be coming from our Chief 19 Investigator. She will give us an update on that. 20 CHAIRMAN WARFIELD: Okay. And then I quess 21 also, Chief Investigator, as you prepare for that as 22 well, could you enlighten us again on force as relates 23 to, if you can't maybe Ms. Washington can, because I 24 know she's been in discussions with the monitors and 25 the Department on this as relates to what cases our



1 Investigators are supposed to look into as relates to 2 force allegations? Has that line of demarcation been 3 drawn so that we're very clear on what our 4 Investigators should look into versus which should go 5 over to IA? Okay. Thank you, Mr. Secretary. 6 SECRETARY ANTHONY: You're welcome, sir. CHAIRMAN WARFIELD: I'm going to go over to 7 8 Deputy Chief Benjamin Lee and ask him for his report at 9 this time for us. 10 D.C. LEE: Thank you. We do have a 11 presentation from Sex Crimes from Sergeant Marvin Jones 12 who will be doing the presentation. 13 SERGEANT JONES: Good afternoon, everyone. 14 Sergeant Jones, I'm from Sex Crimes, and I'll be doing 15 a brief presentation regarding the scope of the tasks that we have at Sex Crimes. I don't have a clicker to 16 17 go to the next slide. CHAIRMAN WARFIELD: Can somebody sit at the 18 computer and just click it for us? Thank you, ma'am. 19 20 SERGEANT JONES: Okay. Responsibility for 21 Sex Crimes is to investigate all allegations of sexual 22 assault. Any false felony reports is punishable by 23 imprisonment. What we like to do, we prosecute all 24 offenders. We have a victim assistants program which 25 goes out and assists us with locating our victims,



1 provide them with any kind of counseling they have and 2 they also assist homicide and child abuse and domestic 3 violence.

4 Something that we like to do, someone had to 5 report the crime and it is never to late to report a 6 sexual assault. Wayne County Safe: We are in 7 partnership with Wayne County Safe whereas we have all 8 of our sexual assault victims respond to Wayne County 9 Safe which is in Detroit Receiving Hospital and they go 10 there for their examinations.

When we receive a phone call regarding allegations of a sexual assault the first thing we like to do is a case draft to find out all the pertinent information and find out the proper direction we need to go in.

We complete what we call a crime scene notification which is sent up through our chain through our superiors to notify them of everything that's going on. Once we've completed that mission we head out and talk to all of our victims, any witnesses that we have, and make sure that they seek medical attention.

We then canvas the area, make sure if there's any video in the area, document the time that the video was observed, and if there was anything captured on the video. We then turn the video over to Sergeant Gibson



1 or Sergeant Johnson who retrieves the video for us and 2 they'll make a disc for us and send it back over to Sex 3 Crimes.

4 After we've completed what we call a crime scene investigation package which is for our superiors 5 6 and the Officer in charge of the case which is our Crisnet Report which is the preliminary report that is 7 8 taken from the Officers who responded to the scene, all 9 our witness statements, our sexual assault kit 10 information, medical records, and the package itself is turned over to the Officer in charge with any further 11 work that is needed. 12

In the instance where there's further information that we need and we have the perpetrator in custody, we type search warrants for homes, an buckle swab. A buckle swab is like a giant Q-tip where we utilize to swab the interior of someone's mouth to link them to the possible sexual assault kit that was collected at the hospital.

20 We also complete photo lineups and live 21 lineups. We prefer to do live lineups when someone is 22 in custody. Matter of fact, it's mandatory that we do 23 live lineups when someone is in custody. But when 24 someone is not in custody and we have a person of 25 interest we'll put together a photo array and show it



1 to our victims. 2 We also like to interrogate all our suspects. 3 We have very knowledgeable men and women over at Sex 4 Crimes that can get some pretty good confessions at 5 The last thing that we do is type an times. 6 investigative report that has to go over to the Wayne County Prosecutors Office with all the work that we did 7 8 to build a case against the suspect. 9 Once that is completed, once the person is 10 charged if charged then we'll complete what we call a 11 sexually motivated crime report which goes to the

Michigan State Police and that's how all our offenders end up on the Sex Offender Registry.

14 SAK stands for Sexual Assault Kit and 15 biological evidence to the crime lab which essentially 16 means that our buckle swap that we've obtained, any 17 physical evidences and sexual assault kit we submitted 18 to the lab.

19 Criminal Sexual Conduct in the first degree 20 is a felony and it is punishable by up to life 21 imprisonment. The person had to be at least 13 and 22 under, and at least the age of 16 and above, in 23 addition if the crime is committed during the 24 commission of another felony. For example, if someone 25 doesn't fit the criteria of 13 years old, if it's a

victim that's 16, if a weapon is used then that is also criminal sexual conduct in the first degree. Also if the perpetrator is a family member or in position of authority, i.e., teacher, employers, and things of such.

6 Criminal Sexual Conduct in the Second Degree 7 is essentially like Criminal Sexual in the First Degree 8 but this involves touching. The same rules apply for 9 Criminal Sexual Conduct in the first degree but like I 10 say it involves touching where you're touching vital 11 parts of someone body.

12 Criminal Sexual Conduct in the Third Degree 13 is punishable for not more than 15 years. It's 14 commonly known as statutory rape. The victim here is 15 over the age of 13 years old, it's a known perpetrator, 16 and the age of consent in the State of Michigan is 17 16 years of age, and there's no exceptions to that.

18 Criminal Sexual Conduct: It's a misdemeanor. It is punishable by up to two years in jail, and the 19 20 victim is over the age of 13 years old. The statute of 21 limitation: After May the 2nd, 2002 the statute of 22 limitations have changed. For Criminal Sexual Conduct 23 in the First Degree there is no statute of limitations. 24 For criminal sexual conduct two, three, four, attempted CSC, sexual abuse activity to children when a 25

defendant is known, it is ten years after the incident 1 or the victim's 21st birthday whichever is later. 2 When DNA is from a suspect then there's no 3 4 statute of limitations. When the defendant is identified through DNA, i.e., a CODIS hit, it's ten 5 6 years after the ID of the victim's 21st birthday. Other sexual assault, date rape, GHB, which 7 is gamma-hydroxybutyric acid, is it commonly known as 8 It impairs the victim powerless and they're not 9 GHB. 10 able to think properly when someone has given them that drug and they tend to do things that they don't 11 12 normally do. 13 We also handled quite a few domestic violence 14 marital home rapes whereas we get a call, husband, 15 wife, feel like that he can do whatever he wants to do to the wife and proceeds to sexually assault her. 16 We 17 get quite a few of those here at Sex Crimes. Indecent 18 exposing is just that, when someone exposes their vital 19 parts to anyone out in the general public. 20 These are some of our community initiatives. 21 Like I said, victim assistance which formally was known 22 as rape counseling. Now we're all encompassing the

1	They're a stones throw away from us and we
2	can pick up the phone any time and contact them so that
3	they can actually interview some of our victims when
4	they're having a hard time making a statement.
5	Wayne County Sexual Assault Nurse Examiner
6	which is essentially what we talked about before is
7	Wayne County Safe. They're at Detroit Receiving
8	Hospital. They're also opening up a new facility over
9	at Grace Hospital. Like I said, they do all of our
10	forensic examinations for our victims.
11	The people that are conducting the
12	examinations are called Sexual Assault Nursing
13	Examiners which is the same. They are also licensed
14	nurses, nurse examiners, and they do a pretty good job
15	helping us with our victims.
16	Kids Talk Forensic: Kids Talk is a forensic
17	interview of victims that are 12 years and under and
18	the perpetrator is at least 17 and above. These are
19	for all known perpetrator cases, which they're
20	encompassed over at 40 East Ferry. We'll schedule an
21	appointment for the child. We'll take her over or him
22	where there's a videotaped interview. When we go over
23	we like to have one of the investigators, a prosecutor,
24	and a CPS worker that will sit in on every interview so
25	that no leading questions can be asked to the child and

1 this cuts out the child being interviewed multiple 2 times. That's going to conclude my presentation at 3 4 this time. If you have any questions feel free to ask. 5 CHAIRMAN WARFIELD: Thank you, sir, 6 appreciate that. Commissioner White? 7 COMMISSIONER WHITE: Thank you, Sergeant Jones, for that presentation. One question for you. 8 9 Are you able to articulate sex crimes and department 10 caseload how it's trended over the last two to three 11 years? 12 SERGEANT JONES: Over the last two to three 13 years, now right for cases that have been reported as 14 of last night we were at 1,089 reported sexual assaults. There has been a spike in sexual assaults 15 16 over the past three years for this particular time. Ι 17 believe last year we were around 950 and the year 18 before that we were around 900. 19 COMMISSIONER WHITE: So at this point for the 20 year? 21 SERGEANT JONES: Yes, we're like ten percent 22 over reported sexual assaults. 23 COMMISSIONER WHITE: And annual, what has 24 been our annual number for the previous two years? 25 SERGEANT JONES: Around 1,400 reported sexual



1 assaults. 2 COMMISSIONER WHITE: Thank you, sir. 3 CHAIRMAN WARFIELD: Sir, just a couple 4 questions, as relates. Certainly when you have in your 5 presentation the community outreach that you do is 6 there a number that citizens can call, neighborhood groups, and others if they wanted you or someone from 7 8 your department to come out and talk to them about the 9 subject? 10 SERGEANT JONES: Yes, sir, area code (313) 596-1950. 11 12 CHAIRMAN WARFIELD: Again, that number is 13 (313) 596-1950? 14 SERGEANT JONES: Yes, sir, that's the direct 15 line to Sex Crimes. 16 CHAIRMAN WARFIELD: And do you all talk about 17 prevention as well? 18 SERGEANT JONES: Yes, we do, sir. 19 CHAIRMAN WARFIELD: In addition to that as 20 relates to the virtual precincts model could you talk to us about when you all go out versus when people 21 22 might have to go in and make a report? How does that 23 work? 24 SERGEANT JONES: Well, once someone makes a 25 report, if the Officers are on the scene and they

1 contact us we go out to all scenes. If someone is reporting at the precinct we like for him to come down 2 to the unit or we'll respond to the precinct. 3 4 CHAIRMAN WARFIELD: Refresh us, where's the 5 unit located again? SERGEANT JONES: 1141 Taylor, Building 6. 6 CHAIRMAN WARFIELD: In the Herman Kiefer? 7 SERGEANT JONES: It's on the complex directly 8 9 behind Herman Kiefer the main building. 10 CHAIRMAN WARFIELD: Anything else? Okay. 11 Thank you, sir, we certainly appreciate it. 12 SERGEANT JONES: Thank you. 13 CHAIRMAN WARFIELD: Deputy Chief, did you 14 have anything else? 15 D.C. LEE: No, that concludes the Chief's 16 Report. 17 CHAIRMAN WARFIELD: We are, of course, expecting a quorum. Again, when we do receive a quorum 18 we will go cover the voting matters. 19 20 However, there is something that came up to our attention, Deputy Chief, from Council Member Brenda 21 22 Jones and this is regarding a situation where she was 23 at the car wash and was informed while she was there 24 someone was cutting the wires and trying to steal 25 copper.

1	Unfortunately they did not get a good police
2	response from the Department. And she has this as a
3	line item on their agenda for Monday, October the 8th,
4	and so I'm going to pass this over to you and if you
5	can prepare a response for them and you might want to
6	reach out to them as relates to that particular
7	incident, and it's on that second page.
8	D.C. LEE: Thank you.
9	CHAIRMAN WARFIELD: You're welcome. Again,
10	we'll come back with several matters in a moment after
11	we get a quorum. But at this time we want to open up
12	the floor for oral communications. If you wish to

18	MR. TERRY: Good afternoon, good evening. My

name is Ishmal Terry and I am the CEO of All For One.
We're a nonprofit organization here in the City of
Detroit, Wayne County, and Washtanaw County. We have
the dubious task to be working with President Obama and
their task force. We were chosen to be a part of that
administration and within that we work with Alexis
Shebil from the Department of Justice.



1	She along with that administration is talking
2	with us about the strong city initiative where
3	\$84 million dollars will becoming down to the City of
4	Detroit and we're talking to different organizations
5	and field groups, nonprofits alike to talk about where
6	this \$84 million dollars will be going into the City of
7	Detroit.

8 This is the sixth city initiative that Barack 9 Obama's administration has talking to us. We will be 10 going back November 8th to talk more in details about 11 where this money is going to be used here in the City 12 of Detroit.

13 I know one of the conversations we had was to 14 bring, was to talk about the money not going into the 15 general purpose fund or the Mayor's Office. So I will 16 be there November 8th to talk about how we're going to move this \$84 million dollars here in the City of 17 18 Detroit, and I'll bring you more in that detail with a 19 stronger presentation next time about where the money 20 will be going and things of that nature. I'll have that information for you. 21

22 CHAIRMAN WARFIELD: Thank you. Any 23 questions?

24 COMMISSIONER WHITE: Thank you.

2	MR. TERRY: Washington D.C.

9	SPEAKER: I live at
10	CHAIRMAN WARFIELD: I'm sorry, you name?
11	MS. DARRAH: Cindy Darrah.

14	MS. CINDY: Okay. Well, I just said I don't
15	live directly under the viaduct. It's Second and the
16	Lodge. But I'm interest on my corner it seems like
17	fewer and fewer people out there. I didn't know if
18	you'd taken them to jail or not. But people do come by
19	and I think seven of your Officers arrested one young
20	man the other day and he claims he was beat up after
21	they took him away in a car, but he was out the next
22	day. I don't know.
23	But why I came here is I'd like to know if
24	it's possible somehow that we could go through the
25	people that haven't been officially sentenced that are

incarcerated and register them to vote and allow them
 to vote like they're supposed to be able do.

If they're only incarcerated and they haven't 3 4 been sentenced they legally could vote. But I ask the 5 election commission yesterday. This ballot is really 6 unbelievable. If they don't have ambassadors like they had under Jackie Curry so there's nobody to go out. 7 8 And I don't know if there are young people that I think 9 are registering people whether somebody could allow 10 them to go in.

And then I thought since you've got 11 12 fingerprints, you do, and I think you have positive ID 13 of everybody you got in jail so ID problems shouldn't 14 be a problem where they could actually register and be 15 able to get -- but we need an official thing so it 16 would be just like they went into the Secretary of 17 State or they went into the election commission and 18 showed their ID there. If we could get them to do something like that and at least get absentee ballot 19 request forms where they can request absentee ballots. 20

I don't know if they should be mailed to the, I guess, mailed to the jail in case they're still in there during the election time. They could actually right now they could file it and mail it right back in and have it counted if they're eligible to vote.



1	But I don't have that much time. I've got to
2	go to Kansas. But I was hoping maybe you could help do
3	this because we do want like I told the police the
4	other night when they were taking this young kid, I
5	wanted to know about it. I was asking them.
6	They didn't know the policy. But I said
7	every vote counts. We hope it does anyway, so. The
8	ballot's kind of interesting. It's something that we
9	have to be able to talk about. When I was in jail
10	years ago they wouldn't even allow newspapers. This is
11	Oakland County. No newspapers, no radio, no TV. You
12	could have a magazine, but no books, no books.
13	So anyway it might be good to get some of
14	these sample ballots and circulate so they could have a
15	discussion. Maybe they could figure out more of this
16	stuff than I can when I read the ballot.
17	CHAIRMAN WARFIELD: I'm sorry, ma'am, your
18	name for the record, again?
19	MS. DARRAH: Cindy, C-I-N-D-Y, Darrah,
20	D-A-R-R-A-H.
21	CHAIRMAN WARFIELD: Thank you.
22	MS. DARRAH: I have noticed it's looking more
23	like a ghost town over by where I am. I hope this
24	isn't the way they're going to objectify by putting
25	people in jail.

1	CHAIRMAN WARFIELD: And your location?
2	MS. DARRAH: Petersburg and Second,
3	, between Cass and Second. But we don't have
4	any violence. When I hear all these different violent
5	things. That's why I think we really need to push to
6	have marijuana legalized. It's not a gateway drug. It
7	might actually be a drug that would keep people out of
8	these things like crack that makes people mean, you
9	know, so.
10	CHAIRMAN WARFIELD: I'm going to have
11	Commissioner White respond to your question and then
12	we'll certainly looked into it, as well.
13	MS. DARRAH: Okay. Because we only have
14	until October 9th, you know, that's the last day to
15	register people. Also this thing about the absentee
16	ballot that you can get forms, you know, and they can
17	they don't have the money to mail them in but maybe
18	somebody could be see, Reverend Pinckney went to
19	jail.
20	You have to be careful how you handle
21	absentee ballots. They almost have to be mailed back
22	in. And since they don't have ambassadors unless they
23	are a relative but maybe by being an official of the

25 handle poll books. I would think you could handle some



1 absentee ballots. You might, you know, check with, I 2 don't know who, but maybe the state, too, as well. 3 Okay. Thank you.

4 CHAIRMAN WARFIELD: Thank you, ma'am. Are 5 there others who wish to address the Board of Police 6 Commissioners? Are there others who wish to address 7 the Board of Police Commissioners? All right. Hearing 8 and seeing none we will close that section of our 9 meeting at this time. We will move back toward the 10 beginning of the agenda.

For the record, Commissioner Jessica Taylor,
Vice Chair of the Detroit Board of Police Commissioners
has arrived and, therefore, we do have a quorum.

20	Mr. Secretary, would it be okay, what is your
21	pleasure as far as being able to move forward? I have
22	it on my iPad. I can read the letter if that will
23	help.
24	SECRETARY ANTHONY: For the record, George
25	Anthony, Secretary to the Board. I think if you can



1	just read some highlights or so that would suffice as a
2	resolution to make the promotions, sir, if you have
3	those available to you.
4	CHAIRMAN WARFIELD: Board, what is your
5	pleasure? Is that okay with you?
6	COMMISSIONER WHITE: Yes.
7	COMMISSIONER TAYLOR: Yes.
8	CHAIRMAN WARFIELD: All right. Okay. We
9	want to I'm not going to have them stand up right
10	now because they might be standing for awhile, but we
11	want to deal with the promotions of Senior Investigator
12	Lawrence Akbar from Interim Supervisor to Senior
13	Supervisor, I'm sorry, to Supervisor.
14	And then we also we want to highlight the
15	accomplishments of Investigator Charlotte Jones and
16	promote her to Senior Investigator, as well. Let's
17	give both of them a hand.
18	(Applause.)
19	CHAIRMAN WARFIELD: Mr. Lawrence Akbar has
20	continuously served as Acting Supervisor Investigator
21	since December of 2010. Mr. Akbar supervised OCI
22	Backlog Squad whose sole purpose was to investigate and
23	resolve several hundred citizens complaints that had
24	lapsed into backlog status over years.
25	The Backlog Squad was the product of an



agreement between the Detroit Police Department and the Department of Justice to meet the terms of the consent decree. With the exception of Mr. Akbar, the Backlog Squad consisted entirely of sworn supervisors on loan to OCI from the DPD in February of 2012, one of the OCI supervising investigators went onto extended leave under the Family Medical Leave Act.

The supervisor's caseload and investigator 8 9 were redistributed amongst the three supervisors 10 including Acting Supervisor Akbar who was still supervising the Special Assignment Team formally known 11 12 as the Backlog Squad. Although the redistribution 13 strained the span of the control and supervision the 14 work at OCI has progressed towards compliance with the 15 consent decree.

16 It should be noted that the supervisor on 17 Family Leave Act recently applied for retirement which 18 will become effective at the end of September. Hence, 19 a vacancy will be created at the Supervisory 20 Investigator level.

21 Mr. Akbar meets the approved and published 22 criteria for Supervisor Investigator. In light of the 23 soon to be created retirement and pressing need to 24 maximize disruption at OCI, as a Board we endorse 25 Attorney Washington's recommendation for a status

3	Board, what is your pleasure?
4	COMMISSIONER WHITE: I move for adoption.

8	Akbar, did I say that right, will be moved to permanent
9	Supervisor at OCI. Any discussion?
10	I want to say this, Mr. Akbar actually helped
11	us tremendously over at OCI. Not only has he been
12	called onto help us with the backlog status to reduce
13	the backlog once, I think he did it about three or four
14	times we called on him to do it and every time he
15	stepped up to the plate and he's hit the ball out of
16	the park literally.
17	And so if there's anyone who is deserving of
18	this acolyte it's him. He has been a trooper. He had

this acolyte it's him. He has been a trooper. He had literally weathered every storm that's been there at OCI and has always been above the fray. And as we move forward it's that type of professionalism, it's that type of attitude and foresight that is transferring over to new Investigators as we bring them into literally don't look at what's happening right now but literally look to the ball and the goal that's ahead.



1 We just thank you from the bottom of our hearts for the outstanding job you've done. Could you 2 just stand, sir, and let everybody know who you are? 3 4 Amen. 5 (Applause.) CHAIRMAN WARFIELD: All those in favor of the 6 recommendation, please say aye? 7 8 COMMISSIONERS: Ave. 9 CHAIRMAN WARFIELD: All those opposed? 10 Motion carries. Thank you, sir. 11 Ms. Charlotte Jones. In like manner, 12 Ms. Jones excels as an Investigator and is routinely 13 assigned complex investigations that are generally 14 reserved for Senior Investigators. 15 On the whole, Ms. Jones investigations are 16 timely, thorough and complete. She also finds time to 17 assist other Investigators with their case 18 preparations. She has demonstrated competency in 19 performing the work and her experience is unmatched. 20 Despite the title, Ms. Jones' functions as a Senior 21 Investigator. 22 The proposed change in Mr. Akbar's title created a vacancy at the Senior Investigator level. 23 24 Ms. Jones meets the approved and proposed published 25 criteria for Senior Investigator and has the knowledge,

1 skill, and ability to perform the work. 2 In our opinion as a Board, Ms. Jones would be the ideal choice to fill the position. We, therefore, 3 4 endorse Attorney Washington's recommendation for a 5 status change for Ms. Jones from Investigator to Senior 6 Investigator at OCI. 7 Ms. Jones, would you stand. You may give her 8 Amen. What is your pleasure, Board? a hand. 9 COMMISSIONER TAYLOR: Move to support. 10 COMMISSIONER WHITE: Support. 11 CHAIRMAN WARFIELD: It's been properly 12 supported that we move to adopt this change as well. 13 And certainly, Investigator Jones, we really appreciate 14 your thoroughness and your writings. We appreciate the 15 fact that you are there to really handle those tough 16 cases. 17 What the public may not know is we get some 18 very difficult cases that involves a number of Officers which takes quite a considerable amount of time, skill, 19 20 and talent to investigate those cases. And without 21 question, Investigator Jones has been consistent in 22 performing to the highest level of standard as relates 23 to respecting the citizens right, but also the 24 understanding of police operations to understand where 25 the police may or may not have crossed the line.

DAVIS DRAKE: Thank you, Mr. Chair. 12 Pamela Davis Drake, the Chief Investigator for OCI for 13 the record. Mr. Chair, if you will indulge me I'd like 14 to introduce other members of that staff that are also 15 here. Okay. We have Investigator Rosalyn Banks, Investigator Carolyn Nichols, Investigator Ken 16 17 Paraskevin and Investigator Lisonya Sloan. Thank you, 18 sir. 19 CHAIRMAN WARFIELD: Thank you. 20 MS. DAVIS DRAKE: All right. Our current 21 statistics as of today we have a total of 199 open 22 cases, 27 cases were submitted for closing in this past week actually, and for the past three weeks zero cases 23 24 are 90 days over. I think that's quite an 25 accomplishment.

1 (Applause.) 2 MS. DAVIS DRAKE: We continue to hold our weekly accountability meeting with the individual teams 3 4 on Thursday mornings in addition to the weekly 5 Supervisor's Meetings on Thursday mornings. Because of 6 the backlog now being eliminated we can concentrate 7 more heavily on the quality of the reports as opposed 8 to quantity.

9 To that end, we're holding a training on 10 Wednesday, October 10th for all Supervisors and 11 Investigators on case management and to address any 12 issues that are posed by the Federal Monitors.

We're gearing up to conduct our staff evaluations and hope to have them completed by mid October, October 15th, actually is our target date. In addition to the evaluations of the Investigator Supervisors I will also ask the Board evaluate the performance of the Chief Investigator during the past couple months.

The reduction of the deadline for the reports to be submitted from 90 days to 80 days is working. What we're doing now is taking a concentrated effort and I notice that staff is doing that and they're doing a tremendous job in trying to reach that 80 day mark as opposed to 90 days so that we have more time to



1 evaluate or review those reports as they're submitted for any necessary corrections. 2 As to your question, Mr. Chair, about force 3 4 and who actually initially handles those 5 investigations? From my understanding there's been a 6 lot of discussion surrounding that issue. There is no clear line on that issue. I don't know, 7 8 Ms. Washington, if you would like to add anything to 9 that? 10 ATTORNEY WASHINGTON: Celia Washington. Just 11 very briefly, the consent decree line, if there is one 12 is criminality. If those matters that involve 13 criminality go to IA. Those matters that involve some 14 use of force with demeanor issues come to OCI. 15 We are in something which is a little bit 16 different. We're in constant communication with 17 Internal Affairs to make sure that those cases are 18 properly assigned. 19 CHAIRMAN WARFIELD: Here's my reason for 20 asking that question, I'm reading cases as I'm 21 reviewing them of citizens who have been obviously 22 injured either at the hands of Officers or in the 23 holding cell, and at what point is that an Internal 24 Affairs case and why are we investigating something 25 that just as the case I'm reading it seems like it



1 should be something that, you know, I guess you have to 2 deal with the definition of criminally and what is 3 that?

4 ATTORNEY WASHINGTON: And that is a 5 definition that we're working and have worked with IA 6 and with the Monitor to more clearly identify. There's some other variables and other factors and we had some 7 8 conversations on use of force, reports when those are 9 completed, when those are not completed. And there's 10 some instances that those trigger command responses and 11 some trigger others. But we'll be happy to talk to you 12 about those.

13 CHAIRMAN WARFIELD: If we can get that in 14 writing that would be helpful to all of us as we review 15 some of these cases because some of the claims along 16 with the proof that's in the case to me seems like it 17 probably should be out of our shop and in IA shop.

ATTORNEY WASHINGTON: I strongly agree and I've made that argument a lot. So we can certainly talk more about it.

21 CHAIRMAN WARFIELD: That would be great.22 Thank you.

MS. DAVIS DRAKE: That concludes my report,Mr. Chair.

CHAIRMAN WARFIELD: Any questions for the



1 Chief Investigator? 2 COMMISSIONER TAYLOR: None. CHAIRMAN WARFIELD: Outstanding job. I think 3 4 it's well noted for the record that this is the second 5 straight report that we received there's zero cases 6 over 90 days. That's just outstanding, you know, in a city where it seems like a lot of government entities 7 8 are not working. 9 I think clearly the Detroit Police Department 10 and the Office of Chief Investigators have shown 11 through this consent decree that we are moving to 12 benchmarks that I think are setting pace for the entire 13 county as relates to citizen oversight and the Police 14 Department policy. So thank you so very much you and 15 Ms. Washington and the Investigators that are here as 16 well. 17 MS. DAVIS DRAKE: Here, here. Thank you. 18 CHAIRMAN WARFIELD: Thank you. There are a couple of items that are in front of us. 19 One is a 20 suspension without pay that is not contested. Mr. Washington, could you come to the podium and help 21 22 us with this one, please, ma'am. Or there's a letter 23 we received regarding suspension without pay for 24 Officer Ryan Carruthers. Could you talk to us about 25 this?

1	ATTORNEY WASHINGTON: Again, Celia
2	Washington. I'll just give you the preliminary because
3	I believe Secretary Anthony has the Chief's letter.
4	But just as a matter of course for those who don't know
5	in certain cases where there's suspension without pay
6	requests a recommendations made by the Chief that
7	involve felonies. It's not all. It's not across the
8	board. But in many instances DPOA Counsel will
9	contest, so that's why you don't have this one in
10	closed session. So Secretary Anthony will read it into
11	record and the Board will vote accordingly.
12	CHAIRMAN WARFIELD: Secretary Anthony.
13	SECRETARY ANTHONY: For the record George
14	Anthony, Secretary to the Board. In a letter dated
15	September 27th, 2012 addressed to the Board of Police
16	Officers, subject: Suspension without pay of Police
17	Officer Ryan Carruthers, C-A-R-R-U-T-H-E-R-S,
18	Badge 617, assigned to 8th precinct.
19	On January 5th, 2012 Internal Affairs had
20	been notified that off duty Police Officer Ryan
21	Carruthers, Badge 617 of the 8th Precinct was arrested
22	for possession within intent to deliver marijuana.
23	Internal Affairs responded to the Oakland County Jail
24	to pick up Officer Carruthers and transport him for a
25	Just Cause Drug Screening at the Midwest Facility.

Internal Affairs arrived at the Oakland
 County Jail to retrieve Officer Carruthers, where a
 deputy informed them that the Narcotic Enforcement
 Team, a multi-jurisdiction task force raided an address
 in Southfield, Michigan and arrested Officer Carruthers
 for Possession With Intent to Deliver Marijuana.

7 The deputy further revealed that the business 8 owned and operated by Officer Carruthers as an illegal 9 medicinal marijuana facility. The deputy further 10 advised that Officer Carruthers was being released from 11 custody and the criminal matter would be handled as a 12 not in custody warrant.

Upon completion of the Just Cause Drug Screen, Officer Carruthers was suspended from the Detroit Police Department. On January 26, 2012 the Board of Police Commissioners contravened the request to suspend Officer Carruthers without pay.

18 On August 22, 2011 the Oakland County Prosecutor's Office charged Officer Carruthers with one 19 20 count of Money Laundering - Third Degree, one count of Conspiracy to Commit Controlled Substance -21 22 Deliver/Manufacture Marijuana, and one count of 23 Controlled Substance - Delivery/Manufacture marijuana. 24 On the same date, the Honorable Magistrate 25 Cynthia M. Arvant, A-R-V-A-N-T, of the 46th District

Court signed Felony Warrant Number 12-95833 for the
 recommended charges.

On August 23, 2012 Officer Carruthers was 3 4 arrested and arraigned before the Honorable Judge Susan 5 M. Moiseev, M-O-I-S-E-E-V of the 46th District for the 6 recommended charges. He was released on a \$10,000.00 7 personal bond. Officer Carruthers' preliminary 8 examination date was scheduled for September 24, 2012. 9 Based upon the above facts and circumstances 10 it is recommended that Officer Carruthers be charged 11 with but not limited to the following violations of the 12 Department's Rules and Regulations:

13 Charge: Conduct unbecoming and an Officer, 14 contrary to the Law Enforcement Code of Ethics; this 15 being in violation of the 2010 Detroit Police 16 Department Manual Series 100, Directive 102.3 - 7.9, 17 Conduct Unprofessional, Command 1.

Due to the egregious nature of the conduct and the newly issued criminal charges, Police Chief Ralph Godbee is requesting your concurrence with the suspension of Officer Carruthers without pay effective September 27th, 2012. Signed by Police Chief Ralph L. Godbee, Junior. That completed the reading, sir. CHAIRMAN WARFIELD: Before us is a request

8	Spec 1, that she, Police Officer Shonee
9	McNair, Badge 1429, currently assigned to the Eastern
10	District while on duty and uniform attire did on
11	November 26, 2010, at approximately twelve p.m., at
12	Balfour and Cornwall failed to exhibit a polite,
13	dignified and courteous manner toward a citizen,
14	Mr. Stanley Williams, Jr., by speaking to him in a
15	demeaning manner and being hostile and cold towards him
16	while investigating a hit and run accident. This being
17	in violation of the Detroit Police Department Manual
18	Series 100 Directive 102.3 - 7.9, Conduct
19	Unprofessional Command 4.
20	As a bit of background, Mr. Chair, the Trial
21	Board did convene pursuant to Sections 71107 of the
22	Charter. The Department was represented by

23 Letitia Jones who is present today, Officer McNair was

24 represented by Attorney Stolberg who is also here

25 today. Attorney Stolberg at that time entered a plea



1 of not guilty.

2	The trial board did come back and found
3	Officer McNair guilty as to the one charge and
4	recommended a penalty of one day suspension without pay
5	and benefits as well as mandatory attendance in a
6	verbal judo class and customer service. Counsel?
7	ATTORNEY STOLBERG: Good afternoon. For the
8	record, Donald Howard Stolberg on behalf of the Detroit
9	Police Officers Association and Police Officer Shonee
10	McNair. Your attorney is correct. This was a late
11	filing. The record indicates from what has been
12	provided to me that Officer McNair signed for that
13	trial board decision on about January 16th.
14	Unfortunately our office was not contacted.
15	So near as I could tell from phone records until
16	March 12th, 2012 within eleven days which obviously
17	would have been within the twenty days we did file a
18	petition on Officer McNair's behalf. But clearly it
19	was beyond the twenty day period as provided by the
20	contract.
21	In order to explain if you will why I am here
22	I did send a letter to Officer McNair and tried to
23	contact her by telephone on several occasions prior to
24	today's hearing to determine what, if any, reasonable
25	explanation she may have had for her delay in

1 requesting that an appeal petition be filed. 2 Unfortunately I have not heard from her, so I 3 cannot offer an explanation on behalf of Officer McNair 4 as to why there was a delay which is not to say that 5 she may have had a good explanation. I just don't know 6 and I can't say that, so. 7 CHAIRMAN WARFIELD: For the record, Attorney, is Officer McNair here today? 8 9 ATTORNEY STOLBERG: Not to my knowledge. Ι 10 do not see her present. 11 CHAIRMAN WARFIELD: Okay. Thank you, sir. Attorney Jones. 12 13 ATTORNEY JONES: Letitia Jones, for the 14 record. I'm sorry, 18 bullet point E4 Appeals to the Board of Police Commissioners or to Arbitration must be made within 19 20 twenty calendar days or receipt of the Chief's hearing 21 judgement. Inasmuch, and again, this recommendation 25 has been provided to the Board, as much as Officer



1 McNair received the Trial Board's decision as Counsel said on January 16th, a timely appeal should have been 2 filed with the Board on or before February 5th, 2012. 3 4 The appeal, however, was not filed until on or after March 23rd, 2012. Therefore, based on a plain meaning 5 6 interpretation of the Collective Bargaining Agreement the Department is correct in its contention that this 7 8 matter should be dismissed on the grounds it is no 9 longer a viable claim.

10 Officer McNair's petition offered no 11 justification for the tardiness of the appeal and based 12 on that it's recommended that the Trial Board's 13 findings be upheld in their entirety.

14 CHAIRMAN WARFIELD: Thank you, Counsel. 15 Board, you've heard the recommendation of Counsel in 16 regards the Police Officer Shonee McNair. What is your 17 pleasure?

18 COMMISSIONER WHITE: I move that this Body 19 uphold the Trial Board's findings and that Police 20 Officer Shonee McNair, Badge 1429, appeal in regards to 21 this matter be denied.

Ι 4 just want to say for the record in regards and I don't 5 know if we said this in the reading in the change of status for Lawrence Akbar and Charlotte Jones that 6 their status changes are effectively immediately, for 7 8 the record. At this time we have a grant from the 9 10 Department that they would like for us to approve. Ι will ask Commission White if he would read that grant 11 12 Thank you, sir. for us. 13 COMMISSIONER WHITE: Commissioners, before us 14 is grant for the Proposed Initiative for the Michigan 15 Department of Transportation MDOT to provide funds to 16 pay for work zone traffic enforcement for the M-85 Fort 17 Street Bascule Bridge Replacement over the Rouge River. 18 On September 4th, 2012 the State of Michigan Department of Transportation indicated in the attached 19 20 letter they had funds available to pay overtime costs 21 up to \$160,000.00 with no cash match for the Detroit 22 Police Department Officers to provided traffic 23 enforcement in the vicinity of M-85 Fort Street during 24 the Bascule Bridge Replacement. The existing bridge is 25 in poor condition and it is currently restricted to one



lane in each direction. It is anticipated that the
 bridge crossing will be closed to traffic for 18 months
 to two years.

4 MDOT has deemed this project to be critical 5 to the economic and social viability of the residents 6 businesses in the area. In order to mitigate for increased emergency response times during the closure 7 8 of the bridge MDOT seeks to have two DPD Officers work 9 a four-hour shift, 7 days a week, for or approximately 10 These patrols will be on overtime and would 80 weeks. not exceed the budgeted allowance. The exact start 11 12 date of the enforcement will be communicated to DPD 13 once the MDOT Contractor provides a scheduled date for the closure of the bridge; however the approximate 14 15 start date is May 1, 2013.

16 In order to reimburse the City for their 17 expenses, MDOT would require a summary spreadsheet detailing the Officers that worked the assignment, 18 19 their overtime rate, dates worked, enforcement 20 location, total patrol hours, total traffic stops, 21 total speed citations, total restraint citations, total 22 verbal warnings, total arrests, and total 23 careless/reckless driving citations. Reimbursement 24 will be made to the Detroit Police Department based 25 upon the existing overtime rate for police officers. Α

DPD Sergeant will oversee the project and administrative costs are factored into the funding. And invoice shall be sent to MDOT for review and payment on a monthly basis. Commander John Serda, of the 4th Precinct, would serve as the project director for the initiative.

Approval of this proposal will be a benefit 7 to the City of Detroit in that it will allow for a 8 9 visible increase in patrol presence in the area without 10 impacting the city's budget. This increase in presence 11 and visibility can be expected to impact not only 12 traffic violations, but criminal activity as well. In 13 addition, the safety of workers and residents in the 14 construction area and the nearby vicinity will be 15 enhanced by targeted traffic enforcement. Finally, by 16 providing a closer working relationship between MDOT 17 and the Detroit Police Department, likelihood of the 18 establishment of similar cooperative efforts will be increased. 19
