4	Permission to accept a Byrne Criminal
5	Justice Innovation (BCJI) Detroit Eastern
6	District Initiative (DEDI) Grant from the Detroit
7	Crime Commission (DCC).
8	The Detroit Police Department has been
9	selected to receive a \$365,721.96 grant in
10	funding with no required match from the U.S.
11	Department of Justice, Office of Justice
12	Programs, Bureau of Justice Assistance.
13	Officers from DPD's Eastern District
14	will assist in planning and implementation a
15	Byrne Criminal Justice Innovation (BCJI) Program
16	entitled Detroit Eastern District Initiative.
17	Recognizing that community safety is
18	essential to neighborhood revitalization, BCJI
19	resources are targeted specifically at
20	persistently distressed neighborhoods that have
21	significant crime challenges that generate a
22	significant proportion of crime or type of crime
23	within the larger community or jurisdiction
24	impeding broader neighborhood development goals.
25	The BCJI program requires a consortium



1	of cross-sector partners to include community
2	stakeholders, law enforcement and local research
3	partner. This cross-sector partnership will
4	complete an integrated planning phase to analyze
5	the criminal issue using data and will develop a
6	coordinated response that includes both
7	place-based and community-oriented strategies to
8	address crime issues.
9	The time period for the grant is
10	October 1, 2012 through September 30, 2015. The
11	federal award number is 2012-AJBX-0002.
12	Commander Steven Dolunt of the Eastern District
13	will serve as the project director for the grant.
14	The Detroit Crime Commission will serve as the
15	fiscal agent for the DEDI grant. The
16	appropriation number for the grant is 13591.
17	I move that the department seek City
18	Council's permission to pursue this grant.
19	COMMISSIONER WHITE: Support.
20	COMMISSIONER WARFIELD: It's been
21	properly moved and supported. Any discussion,
22	questions?
23	COMMISSIONER WHITE: Through the Chair
24	and I would ask that the Chief respond, but

certainly, Chief, as we look at potentially

1	rolling out an initiative as such there will
2	certainly be those who would need clarity, i.e.
3	why this part of town if you say Eastern and I'm
4	on the western side of town or if I'm in
5	Southwest or North End, so just for clarity when
6	we say this grant is targeted specifically at
7	distressed neighborhoods, what exactly do we mean
8	when we say "distressed" and also that have
9	significant crime challenges.
10	Just for the record, what type of crime
11	challenges are we identifying?
12	INTERIM CHIEF LOGAN: There are a
13	number of crimes that we're looking at, narcotics
14	trade, street shootings, robberies, break-in's
15	and the like.
16	The Commission took a look at the whole
17	city in its entirety and felt that we could do
18	the most good they felt that they could do the
19	most good in the Eastern District. Now,
20	hopefully this won't be the last grant we'll get
21	and we'll probably take it to the west side then,
22	but the prevailing feeling at the time was that
23	the Eastern District was most in need of this
24	grant.



COMMISSIONER WARFIELD: Ma'am, any

14	Safety Foundation indicated in an attached letter
15	that they wished to donate equipment valued at
16	\$17,888.27 to the Detroit Police Department
17	Canine Unit.
18	DPD Canine has determined that the
19	equipment would be an asset to the department and
20	seeks to accept this donation. An itemized list
21	of equipment to be donated accompanied the
22	letter. There is no cost to the department for
23	this donation.
24	I'm requesting the Board's permission
25	to accept this donation and seek approval of the



1	Honorable City Council.

20	where the I believe this is where the dogs
21	will be trained that needs to be constantly mowed
22	and that's the reason why they included the lawn
23	mower, riding mower.
24	COMMISSIONER WARFIELD: Oh, okay. Who
25	cuts it now?



1	INTERIM CHIEF LOGAN: It's not cut. I
2	shouldn't say it's probably cut whenever they
3	can, but now we'll be able to cut it and have a
4	training course, nice training course for the
5	dogs. I did ask that same question.
6	COMMISSIONER WARFIELD: Any other

17	in an attached letter that they wish to donate
18	equipment valued at \$24,418.75 to the Detroit
19	Police Department Bomb Squad. There is no cost
20	to the department for this donation.
21	DPD Bomb Squad has determined that the
22	equipment will be an asset to the department and
23	seeks to accept this donation. The itemized list

15	COMMISSIONER TAYLOR: Support.
16	COMMISSIONER WARFIELD: It's been

18	the department will seek permission to accept
19	this donation. Any questions regarding this
20	request?

COMMISSIONER TAYLOR: The last grant is

COMMISSIONER TAYLOR: The last grant is proposed initiative for Marathon Petroleum

Company (MPC) to provide funds to pay for work zone traffic enforcement for the M-85 Fort Street Bascule Bridge replacement over the Rouge River.

On December 4, 2012 the Marathon

Petroleum Company indicated in the attached

letter that they had funds available to pay

overtime costs up to \$500,000 with no cash match

for Detroit Police Department officers to provide

traffic enforcement in the vicinity of the M-85

Fort Street during the Bascule Bridge

replacement.

The existing bridge is in poor condition and is currently restricted to one lane in each direction. It is anticipated that the bridge crossing will be closed to traffic for 18 months to two years.

The MPC anticipates that the closure of the Bascule Bridge will hamper response time for emergency services and proposes to assist by funding additional police patrols in the 48217



1	area code adjacent to the MPC Detroit Refinery.
2	Those patrols will consist of two DPD
3	officers working in eight-hour shifts at varying
4	times of the day seven days a week for a minimum
5	of 75 weeks. The duration of the project may
6	vary. These patrols would be on overtime and
7	would not exceed the budgeted allowance.
8	In order to reimburse the City of
9	Detroit for their expenses the MPC would require
10	monthly invoice from DPD. In addition to the
11	invoice DPD would provide information such as
12	daily details, names of the officers that worked
13	the assignment, their overtime rates, dates
14	worked, enforcement locations, arrests, citizen
15	contacts, traffic stops, radio service calls,
16	citations and general community patrol contacts.
17	Reimbursements would be made to the DPD
18	based upon the existing overtime rate for police
19	officers. A DPD sergeant will oversee the
20	project and administrative costs are factored
21	into the funding. Commander John Serda of the 4th
22	Precinct will serve as the project director for
23	the initiative.
24	Approval of this proposal will be a



25

benefit to the City of Detroit in that it will

1	allow for a visible increase in patrol presence
2	in the area without impacting the City's budget.
3	This increase in presence and visibility can be
4	expected to impact not only traffic violations,
5	but criminal accident as well.
6	In addition, the safety of workers and
7	residents in the construction area and the nearby
8	vicinity will be enhanced by targeted traffic
9	enforcement. Finally, by providing a closer
10	working relationship between the MPC and the
11	Detroit Police Department the likelihood of the
12	establishment of similar cooperative efforts will
13	be increased.
14	I'm requesting the Board's permission
15	to accept this funding and seek approval of the
16	Honorable Detroit City Council.
17	Sincerely, Chester Logan, Interim Chief

20	COMMISSIONER WHITE: Support.
21	COMMISSIONER WARFIELD: It's been
22	properly moved and supported to accept this
23	request on behalf of the department. Any



COMMISSIONER WHITE: Mr. Chair, I had

1	one. If I'm not mistaken, this same issue was
2	before us previously, I'm not sure. Is this an
3	additional \$500,000 or does it replace a previous
4	grant that came before this body?
5	COMMANDER SERDA: Commander Serda.
6	Good memory. Actually that's a separate grant
7	under Michigan Department of Transportation.
8	They're providing a certain amount of funds to do
9	basically the same thing and Marathon is adding
10	additional funds to do that same type of
11	endeavor, all based around the Bascule Bridge.
12	And for Marathon they're a critical
13	infrastructure also, so but it includes the
14	entire community.
15	COMMISSIONER WHITE: So, Commander,
16	when we talk in terms of personnel, if this is
17	the same project but additional funds, is this
18	additional personnel?
19	COMMANDER SERDA: It's additional
20	hours, so the officers ideally would be working
21	two officers per day 12-hour shifts, four of it
22	funded by MDOT and eight of it funded my
23	Marathon.
24	COMMISSIONER WHITE: So this additional
25	\$500,000 covers the additional hours that would



1	be added for the life of the grant?
2	COMMANDER SERDA: Right.
3	COMMISSIONER WARFIELD: I have a couple
4	of questions. So basically we're looking at \$1
5	million?
6	COMMANDER SERDA: No, the MDOT one I
7	don't recall the exact amount, but I think it was
8	like \$160,000 and this one is half a million.
9	COMMISSIONER WARFIELD: Okay, so let's
10	say over \$600,000?
11	COMMANDER SERDA: Right.
12	COMMISSIONER WARFIELD: Is this can
13	this be considered secondary employment or no?
14	COMMANDER SERDA: That possibility was
15	explored, but the parties preferred to do it this
16	way because when it's secondary employment, those
17	officers are working for a business entity if you
18	will, and in this case these officers are really
19	patrolling the neighborhood and doing normal
20	police functions.
21	COMMISSIONER WARFIELD: How many
22	officers then will be taken from the
23	neighborhood?
24	COMMANDER SERDA: None will be taken
25	from the neighborhood because these are in



1	addition to our normal patrols since these
2	officers will be on overtime. It's going to be
3	voluntary overtime that they can sign up for and
4	do on their leave days.
5	COMMISSIONER WARFIELD: And how would
6	it be determined which officers could receive the
7	assignment?
8	COMMANDER SERDA: It would be a
9	rotating a rotation based on seniority and
10	also factored into that is when they worked so
11	they're not working 24 hours consecutive, those
12	kind of factors.
13	COMMISSIONER WARFIELD: Okay. Any
14	other questions? All those in favor of the
15	request?
16	COMMISSIONERS: Aye.
17	COMMISSIONER WARFIELD: All those
18	opposed? Motion carries. Thank you, sir,
19	appreciate it.
20	COMMANDER SERDA: You're welcome.
21	COMMISSIONER WARFIELD: It is not a
22	grant on our agenda for today, but we were
23	informed by City Council, Chief, that there is a
24	grant on their table or a donation on their



table to receive several vehicles, about 17

1	vehicles to the department.
2	INTERIM CHIEF LOGAN: Yes, sir.
3	COMMISSIONER WARFIELD: What is that
4	about?
5	INTERIM CHIEF LOGAN: Probably within
6	the last couple of years the General Motors
7	Corporation has provided vehicles, various
8	vehicles, to the department for police use only.
9	These are many of these were like undercover
10	vehicles and what have you.
11	So at some point in time they decided
12	rather than try to get these vehicles back, the
13	Detroit Police Department could have them. I'm
14	not certain how I thought that should have
15	been in front of you also.
16	COMMISSIONER WARFIELD: We had the same
17	
18	INTERIM CHIEF LOGAN: We'll make sure
19	you get that. You should have had it.
20	COMMISSIONER WARFIELD: What we don't
21	want to happen is for you to get to the City
22	Council table and then have to come back to us.
23	INTERIM CHIEF LOGAN: Yes, sir.
24	COMMISSIONER WARFIELD: Thank you, sir.
2.5	INTERIM CHIEF LOGAN. You'll have that



1	today.
2	COMMISSIONER WARFIELD: Great, thanks.
3	Thank you, sir, appreciate that. I did just want
4	to say that we did adjust our schedule a little
5	bit on the agenda only because we pulled
6	Commissioner Taylor out of her sick bed because
7	unfortunately she's not feeling well at all and
8	has a touch of the flu, so we wanted to take care
9	of some voting issues and release her so she can
10	go back and get well.
11	So we just thank her for her dedication
12	and her commitment. At this time, Chief, you
13	have asked this Board to look at some promotions.
14	Today we are prepared, sir, to look at
15	the promotions of police officers to the rank of
16	sergeant. We have done our due diligence, we
17	have looked at disciplinary histories and career
18	achievements of those who are on the list to be
19	promoted and we are ready to make a
20	recommendation, if that's okay with you, sir.
21	INTERIM CHIEF LOGAN: Yes, sir.
22	Certainly that's my request to consider those
23	promotions.
24	COMMISSIONER WARFIELD: I'm going to
25	ask Commissioner Taylor if you could for us,



1	could you read off the names in order as it
2	appears on the sheet of the ones that we will
3	recommend for promotion and then we'll have
4	discussion after that.
5	COMMISSIONER TAYLOR: We have in order
6	Edward S. Brannock, Scott E. Hall, Lashanna M.
7	Potts, Karl Lawson, Adam N. Smith oh, Jeffrey
8	S. O'Keefe, Adam N. Smith, Laurie A. Carter,
9	Derrick D. Griffin, John D. Watkins, Andrew
10	Guntzviler, Franklin D. Hayes, Alfreda Banks,
11	Rebecca L. McKay, Curtis L. Shell, Kerry R.
12	Byers, Wendie L. Collier, and William M. Tzos,

15	COMMISSIONER WARFIELD: Thank you very
16	much and we will provide the list for our
17	recorder. But these are the names that are
18	before us to be promoted from the rank of police
19	officer to the rank of sergeant.
20	What is the pleasure of the Board?
21	COMMISSIONER WHITE: Mr. Chair, I so
22	move that the aforementioned names of officers
23	hereby duly recommended by this body be promoted
24	to the rank of sergeant.

1	COMMISSIONER WARFIELD: It's been
2	properly moved and supported. Any discussion?
3	Chief, certainly we do understand the nature as
4	relates to not only but more importantly we
5	understand the nature of those who are retiring
6	and leaving the department and we understand we
7	want to make sure that we keep our officers in
8	place as relates to the investigative needs the
9	department has as well as the supervisory needs
10	the department has.
11	So certainly we want to do everything
12	we can to make sure that your efforts as relates
13	to making sure you have the right people in place
14	is successful.
15	We'll make sure that that happens for
16	you.
17	INTERIM CHIEF LOGAN: Thank you.
18	COMMISSIONER WARFIELD: And we thank
19	you for bringing these names to us and I want to
20	thank the Board, I want to thank the entire Board
21	just for their due diligence and their efforts in
22	researching this and making sure that the
23	individuals that were on the list were those
24	individuals that will continually make the
25	Detroit Police Department proud and will move



1	this department further.
2	Certainly we do well, we'll talk
3	about that later. Any other discussions about
4	these officers? Hearing or seeing none, all
5	those in favor of promoting these aforementioned
6	names from police officer to sergeant please say
7	aye?
8	COMMISSIONERS: Aye.

19	COMMISSIONER WARFIELD: Thank you for
20	allowing us to do that and, again,
21	congratulations to those officers for
22	well-deserved promotion and, again, we look
23	forward for you to continue to do great things
24	for the Detroit Police Department and the City of
2.5	Detroit



1	Not much from the Chairperson's report.
2	Just want to report that those items that we
3	talked about in our last meeting that we want to
4	follow up on.
5	Just for information of our towers, we
6	did send out another request to the Mayor for
7	facilitation meeting in an effort to try to bring
8	the towing issue to a good resolve.
9	In addition to that we also sent out a
10	request to the Ethics Board for the Ethics Board
11	to look into the matter as well and we have
12	drafted a letter to the towers who did sign up as
13	abandoned towers with this new iteration and we
14	want to hear from the Mayor's office first before
15	we send those letters out.
16	And so we just wanted to make sure that
17	you all were aware of those things.
18	At this point, that's all I have. Is
19	there a Secretary's report?
20	SECRETARY ANTHONY: There is, sir.
21	This is the Secretary's report of citizen
22	complaints that were received December, 2012.
23	The monthly count of complaints for
24	2012 in December was 91 compared with the 2011
25	monthly count of complaints of 125. It



1	represents a 27 percent decrease.
2	The year-to-date figure for 2012 is
3	1,301 compared to 2011 year-to-date 1,586,
4	represents an 18 percent decrease.
5	At the end of December of 2012 the
6	Office of the Chief Investigator had open
7	investigations 217, cases filed 1,301, cases
8	closed 1,784.
9	Of the 91 cases filed in December of
10	2012, 35 percent involved unknown officers. The
11	alleged known units involved leading in
12	complaints filed in December of 2012 were Eastern
13	District at 8 percent, 6th Precinct and
14	Northeastern District tied at 7 percent and the
15	8th Precinct at 6 percent.
16	The 91 cases filed in December, 2012
17	involved 199 allegations where the leading areas
18	of concern were demeanor at 24 percent, procedure
19	at 22 percent, service at 13 percent and force at
20	11 percent, and that completes the Secretary's
21	report for citizen complaints.
22	I would like to add, Mr. Chair, that we
23	are working with the Office of Chief Investigator
24	to address some of Commissioner White's concerns
25	on unknown officers.



1	COMMISSIONER WARFIELD: Any questions?
2	COMMISSIONER WHITE: That was going to
3	be my question, but Secretary Anthony answered it
4	for me.
5	INTERIM CHIEF LOGAN: Thank you.
6	Certainly we do appreciate the fact that the
7	number of complaints are going down, but we also
8	still recognize that there's still quite a number
9	of complaints and still quite a number of issues
10	that we have, and so we will continue to do our
11	Consent Decree policies to make sure that we can
12	do anything and everything that we can to
13	decrease the number of complaints that are coming
14	into the Office of the Chief Investigator.
15	Chief, do you have anything for us?
16	INTERIM CHIEF LOGAN: Just through
17	the Chair, Interim Chief Logan. Just a couple of
18	quick items.
19	Last week Ms. Bernice Smith highlighted
20	a number of criminal cases that she had heard on
21	the news that had occurred around the city and I
22	just wanted to let her know and let the audience
23	know that we made a number of significant arrests
24	within the last week for murder, rape, robbery,
25	but there was one in particular that was very

2.1

heinous and that involved a 22-year-old-man was
taken into custody after he engaged in criminal
sexual conduct on the city's west side. This
gentleman also somewhere around January 1st raped
a 55-year-old female.

I wanted to let you know that we do in fact have him in custody. There's going to be a number -- we're going to be doing a press release or press conference -- I think it's Wednesday where we're going to be highlighting a number of arrests, probably -- well, it's the Mayor's press conference, but you're going to be very pleased at the arrests that are being made out there for these crimes.

Also I'd also like to let the Board know -- I guess it's common knowledge -- that we're up to -- not high enough, we still got a long way to go -- but we're at 88 percent on our Consent Judgment. And it's interesting to note we would have been in full compliance with our Conditions of Confinement had it not been for one little glitch, we would have been there. So hopefully our next card marking we'll get there.

We're also at -- with our Use of Force we're in compliance on 94 of 110 paragraphs which



1	gives us an 85 percent. So overall our
2	compliance rate is in fact at 88 percent.
3	And it goes to one of the conversations
4	which we want to start having is sustainability.
5	And if you look at the complaints that the
6	Secretary read off, you can see that there is
7	room for we can make an argument to the judge
8	about sustainability because if you look at the
9	reduction in the complaints from December of 2012
10	versus 2011 that's significant, especially under
11	the times that we're under right now.
12	So I take my hat off to all the men and
13	women out there who call themselves Detroit
14	police officers and I still think that we have
15	one great community we serve out there. That's
16	my report.
17	COMMISSIONER WARFIELD: Thank you, sir.
18	COMMISSIONER WHITE: Chief, as it
19	relates to complaints, you reference the
20	Conditions of Confinement. I believe I heard a
21	conversation centered around possibly a
22	relationship with Michigan Department of
23	Corrections. Is that moving forward, is that
24	on



INTERIM CHIEF LOGAN: Through the

1	Chair, Interim Chief Logan. That's still under
2	discussion. We're finding that the cost is a
3	little high right now, but what's good to note
4	about that is we're going to achieve compliance
5	with or without the Michigan Department of
6	Corrections. Probably if we could this is
7	something that's going to be coming out later on
8	we'd like Michigan Department of Corrections
9	to fill up some of those jail cells themselves.
10	We've got a tremendous problem with recidivism in
11	our city.

2.1

COMMISSIONER WHITE: Thank you, Chief.

COMMISSIONER WARFIELD: Also, Chief, as relates to the compliance number, and I'm sure we'll talk about this more when the monitors come to town, but it seems like we are extremely close to compliance as relates to maybe one incident here and one incident there being able to tip the scale one way or another.

And it might be an appropriate time to talk about how are we -- and others have mentioned this in the past -- position ourselves we're technically in compliance because anybody can play with numbers, and if there's been a significant change which it has been as relates

1	to the paragraphs and the sentences that were
2	laid off, I think as a department and certainly
3	we stand with you, we need to begin to build the
4	case for coming from under this Consent Decree
5	because when we're talking about one case
6	literally tipping the balance, I think, you know,
7	we need to really look at how do we end this
8	process.

INTERIM CHIEF LOGAN: Through the Chair, Interim Chief Logan. Sir, I'm in complete agreement with you. My goal this time was to achieve 90, so if we had gotten a 90, that's 9 out of 10. If you get a 94, that's still 9 out of 10.

So once we get to that 90 I think we can make a stronger argument. I think the conversation has already begun. The PIO, Public Information Office, shared with me a little while ago we got people — reporters from San Francisco that's coming here, they want to know how did we collectively get where we are.

And I think that's a testament to, you know, you all's due diligence in making sure that we comply with the Consent Judgment. As we emerge from this judgment many other cities

1	around the country are getting into consent
2	judgment, so it makes us really a model for
3	departments around the country because when we
4	got into this, we had the most stringent Consent
5	Judgment in America's history.
6	Certainly if we can emerge from that,
7	other cities can emerge. More importantly, other
8	cities can learn how to not get into it in the
9	first place.
10	COMMISSIONER WARFIELD: Thank you, sir,
11	appreciate that. I'm going to ask if attorney
12	Washington can come to the podium at this time.
13	There is a disciplinary appeal on the agenda of
14	Police Officer Leonard Ball. Ma'am, how are you
15	doing?
16	ATTY. WASHINGTON: Thank you, Mr. Chair
17	Celia Washington, attorney for the Board. On
18	January 11, 2013 the Board received an appeal
19	petition from Police Officer Leonard Ball, Badge
20	No. 973, Discipline File No. 120270, BPC No.
21	12-005D, requesting an appeal of a trial board
22	decision.
23	We did learn actually January 11 was
24	when we were notified that Officer Ball had



retired from the police department, so it should

1	be noted that he has withdrawn his appeal, his
2	attorney has withdrawn the appeal and that
3	there's no need for the Board to address the
4	matter further, but we did need to put it on the
5	record so that we close that.
6	COMMISSIONER WARFIELD: Thank you,
7	ma'am, appreciate it. Our next public meeting
8	will be held Thursday, January 24, 2013 right
9	here at police headquarters at 3 o'clock PM.
10	Certainly looking forward to seeing you all
11	there.
12	At this time and our offices will be
13	closed on Monday, January 21, 2013 for Martin
14	Luther King Holiday. At this time we will open
15	up the floor for oral communications.
16	If you wish to address the Board,
17	please come up, give us your name and spell it
18	for our recorder and we ask that you would abide
19	with our two-minute time limit so we can hear
20	from as many individuals as possible.
21	Please address your comments to the
22	Chair and we will make sure that the appropriate
23	person addresses your concern. You may come at
24	this time, please.

21	you do because I was out of town last week. They
22	got problems too. And by Detroit being a big
23	city, I think you do an excellent job.
