4 CHAIRMAN WARFIELD: Good afternoon, ladies 5 and gentlemen. Welcome to the Board of Police 6 Commissioners meeting. Certainly we are happy and 7 pleased to be here tonight in Southwest District here 8 at the Patton Community Center, and it's so good to see 9 all of you here. My name is Jerome Warfield, Chairman 10 of the Board of Police Commissioners.

4 Thank you very much for having me. I do want 5 to thank a couple people that are not here. I'm not 6 going to call them by name because there's a lot of 7 them. But at Patton Community Center we have a true 8 community spirit and so the decorations you see set up 9 for today, chairs, tables, and the like, were done by 10 one of our two groups Live Action which is our teen council ages 13 to 18, and Action Packed which is a our 11 12 peewee council and their ages twelve and under, so they 13 were responsible for everything today.

11 At this time, I'm going to ask if 12 Commissioner who's the Vice-Chairperson of our 13 Commission would read the responsibilities and the 14 duties of the Detroit Board of Police Commissioners. 15 VICE-CHAIRPERSON TAYLOR: Created by City 16 Charter July 1st, 1974. Composition: Five members 17 appointed by the Mayor confirmed by City Council. 18 Commissioners serve five year terms and may not serve 19 more than five years consecutively, meets once a week 20 52 weeks out of the year and all meetings are open to 21 the public.

The Duties: Establish policy, rules and regulations in consultation with the Chief and approval of the Mayor. Review and approve Department budget, review and approve Department promotions, receive and

resolve complaints concerning the operation of the
 Police Department. Final authority to impose and
 review discipline of Police Department employees.
 Appoint Civilian Personnel Director, prepares an annual
 report of Department activities for the public, Mayor
 and the City Council.

7 Staff: Executive Secretary who serves as 8 Secretary to the Board and attends all Board meetings, 9 Chief Investigator and additional Investigators, other 10 staff as necessary to provided support to the Board. 11 The Police Commission considers itself a liaison 12 between the citizens of the City of Detroit and the 13 Police Department.

CHAIRMAN WARFIELD: Thank you, ma'am, we certainly appreciate that. At this time we will entertain a motion to approve today's Agenda.

17 COMMISSIONER WHITE: So move.

18 VICE-CHAIRPERSON TAYLOR: Support.

19CHAIRMAN WARFIELD: It's been properly moved20and supported without objection. All those in favor?

21 COMMISSIONERS: Aye.

19	the 4th Precinct?

21	COMMANDER MCKISSIC: Inspector Vicky Yost of
22	the 4th Precinct.
23	INSPECTOR YOST: Through the Chair, Inspector
24	Yost, Commanding Officer of the Southwestern District.
25	Good evening.

1	CHAIRMAN WARFIELD: Good evening.
2	INSPECTOR YOST: I'd like to thank you all
3	for coming out to the 4th Precinct. We've got a good
4	presentation. It's a slide show that Lieutenant Pierce
5	put together and she'll be walking you through it.
6	Before we get there I'd like to announce that
7	we have a precinct-wide community relations meeting the
8	second Tuesday of every month with the exception of
9	July and August at the Precinct and we invite all of
10	our citizens to attend. It's at 6:00 p.m.
11	I also want to thank Lieutenant Pierce and
12	our Community Relations staff for the food in the back.
13	It is a local business. They did a really good job
14	with it. So without further ado, Lieutenant Lori
15	Pierce, CO of Number 4.
16	LT. PIERCE: Good afternoon everybody. For
17	those of you that come to these type of meetings,
18	typically do a Power Point Presentation. We tried to
19	do a little something different to show you sights of
20	the 4th Precinct and show you the rich culture at the
21	4th Precinct.
22	Everyone know the Ambassador Bridge located
23	in the 4th Precinct. It is a very busy border
24	crossing. It is the busiest border crossing,
25	international border crossing in American in terms of

1 trade volume.

That is the location of the 4th Precinct known as Southwest Public Safety Center. We're located at Fort and Clark. We also have the Fire Department attached to our building on the other side.

6 This is our staff at the Precinct and we have 7 many Officers of various ethnicity that speak numerous 8 languages to better serve people that come in. Here's 9 our statistics in terms of how we've reduced crime and 10 that's the current year. We're also down in almost all 11 categories last year, as well.

Last year our Officers serviced over 106,000 police runs when they're combined as the Southwestern District. We're both 2nd and 4th Precincts. This is one of the biggest landmarks in the City, the old train station which is also located in the 4th Precinct.

17 That's Roosevelt Park is right in front of 18 the train station. This is River Side Park. There's a 19 lot of activity -- there used to be a lot of activity. 20 I believe it's closed at the moment. The J. Wescott if anyone's familiar with that. As the freighters make 21 22 their travels and -- they do get mail delivered to them 23 through the Wescott. I don't know if there's any old 24 people like me here who remember Boblo? Some more 25 freighters.

1	Does that look familiar to anybody, the
2	drawbridge, which is due to go under construction soon?
3	That was Fort Street. That one's due to go under
4	construction soon. Our Precinct is 14.4 square miles.
5	We have a population of 70,529. We have 34 churches.
6	The 4th Precinct with a couple pictures of them, very
7	old historic beautiful churches, just goes to show you
8	the culture and diversity of Number 4.
9	Anyone who drives to Number 4 will notice a
10	lot of wall murals and graffiti. Some consider it to
11	be artwork, others, not so much. I think everyone's
12	probably seen that at one point or another.
13	We have a lot of businesses, over 1,000
14	business successfully operating in the 4th Precinct.
15	These are some ones that stand out. The best coffee.
16	We all know Telway's, right? We also have what we call
17	critical infrastructures in the 4th Precinct which
18	means that basically in layman terms give very special
19	attention to these locations because they could be
20	locations for terrorist activity or terrorist targets.
21	The water sewage department, the water
22	treatment center is one them. The bridge is another.
23	This is an aerial view of the water treatment center.
24	Another one is the Marathon Oil Refinery. You're all
25	familiar with that at Fort and Schaefer. I think

1	that's a very familiar sight to many of us.
2	We have 17 schools and 12 parks. You are
3	here. A lot of you might know the Kennedy Center. You
4	vote there. And good old 48217. Also Historic Fort
5	Wayne is located in the 4th Precinct. One of our
6	closed fire houses.
7	That's pretty much it. I'll give a little
8	bit of additional information just so you know we're
9	trying hard to reduce crime in the community. Just
10	year-to-date as of the June 2nd we've made 367 felony
11	arrests, 135 misdemeanor arrests, detained
12	69 juveniles, issued close to 3,000 tickets,
13	investigated almost 12,000, over 12,000 vehicles, and
14	initiated 3,284 traffic stops. We're trying our best
15	to keep those crime numbers to come down. And that's
16	it.
17	(Applause.)
18	CHAIRMAN WARFIELD: Thank you. Any questions
19	for the Lieutenant?
20	VICE CHAIRPERSON TAYLOR: I have none.
21	COMMISSIONER WHITE: Thank you, Lieutenant,
22	if there are areas of concern with the Southwest what
23	would you attribute those to as relates to crime
24	patterns?
25	LT. PIERCE: What areas of concern we have?

1 We do try to pay particular attention to the 48217 area 2 on the other side of the bridge near Marathon. Because 3 of the structure of our geography it's very hard to get down there. Basically there's only two ways to get 4 down there by Fort Street or I75. And soon -- it's 5 6 called the Besttoon Bridge, in Detroit, is about to be closed for over a year I believe which posses a 7 8 particular problem because if there's crime going on 9 down there and we have to always have someone down 10 there, but if you need additional reinforcements down 11 there we're going to be hindered in a way. So we do 12 have a plan in place. But basically we do kind of pay 13 extra attention to that area just due to the geography 14 of the area. 15 COMMISSIONER WHITE: For the record, 16 Lieutenant, your boundaries? 17 LT. PIERCE: Our boundaries, we go all the 18 way to Warren. We travel down the Lincoln Park Border 19 like Outer Drive to Fort Street. We have a very 20 crooked border because we border like Jefferson to 14, 21 and Michigan. It's a very crooked border.

22 COMMISSIONER WHITE: Thank you, Mr. Chair.
23 CHAIRMAN WARFIELD: Thank you. Lieutenant,
24 you might be able to answer this question. Inspector
25 Yost mentioned earlier about the business that supplied

9	implemented in this policy.

11	center for people to, if they want to review it and
12	it's also posted online on the City website and at the
13	Districts.

17	for basically for approval.

Τf 2 there's any questions regarding these three Directives? 3 CHAIRMAN WARFIELD: Let me say this in 4 regards to the transfers, I know this is the first time 5 that I have seen them, I can't speak for my colleagues, 6 I would like to look over it and may be another week I 7 feel comfortable --SECRETARY ANTHONY: 8 We can wait. 9 CHAIRMAN WARFIELD: We're going to table this 10 one. 11 LIEUTENANT BLISS: Just to give you a brief 12 overview of the changes. 13 CHAIRMAN WARFIELD: Yes, sir. LIEUTENANT BLISS: All the information 14 15 contained in the transfers are based on the current CBA 16 which is the Collective Bargaining Agreements with the 17 City. They've been in place for years. There has been 18 no major change to the transfer process. The only 19 thing that we did add other than minor grammar and 20 punctuation is the MAS process and that is that when a 21 new Command gets personnel they're required within a 22 certain time period to update there MAS profile that 23 they've been transferred to that new Command. 24 It was not in there prior and we were holding 25 Commands responsible for doing that, but it was never

His skills in crime analysis has 6 been a great asset in identifying several crime 7 patterns, and strategies to help combat those issues. 8 He is a Central District Crime Analysis Officer who is 9 a respected Officer of the Downtown Detroit Partnership 10 Safety and Security Committee and is well respected. 11 His input has been valuable in making the 12 Downtown area and Central District a safer place. He

has been instrumental in several investigations which have resulted in the closing of numerous larcenies, and motor vehicles cases that occur within the central business district.

17 Officer Borkowski did not use any sick time 18 during this quarter. He is reliable, neat, and always 19 well groomed and has an excellent understanding of the 20 Detroit Police Department rules and regulations. His 21 demonstration of that knowledge and skills which is 22 typically associated with a veteran officer. Officer 23 Borkowski diligence and dedication to duty maintains 24 within the highest standards of the Detroit Police 25 Department where he remains a role model and asset.

6	District Police Officer Chancellor Searcy and his

10	to the Detroit Police Department on November 21st,
11	2008. Officer Charles Lynem was appointed to the

13	They have consistently performed their duties

16	demonstrate enthusiasm as they patrolled the streets of

19	have demonstrated to the public by answering and
20	responding to 100 police runs.

6 So I just want to bring awareness that Tamale 7 Wells is missing and I don't know who else to reach out 8 to. If it was your child or anybody's child we go as 9 high as we go to go to bring our children or our family 10 or our loved ones back home safe.

I understand this is a real high epidemic here. And as I ride through the streets of the City of Detroit anything can happen, you know. And I just want to bring awareness so that I can get some type help in this matter. So if there's anyone I can talk to afterwards I appreciate it.

17 CHAIRMAN WARFIELD: Thank you, Ms. Davis, 18 could you stand there for one second, ma'am, please. 19 We want to try and get you some help right now.

20 COMMANDER MCKISSIC: Tell me where she's 21 missing from?

MS. DAVIS: 19703 Appleton was the last known that I know that she was supposed to left there. That was her home. She stayed with her boyfriend for fifteen years. So it was kind of like shaky. When the



little girl call you early in the morning August the 7th and tell you her mother didn't come home, you're in Florida, she's in Detroit, kind of raised some type of suspicious(sic). For five days I spoke to this little girl, my granddaughter, over the phone to reassure her that everything will be okay, but it wasn't, and it still hasn't been.

8 Now, the boyfriend never got on the phone to 9 call me to tell me something happened, he made a police 10 report, any concerns. This is a boyfriend that she had 11 been with for 15 years. I want to know why didn't you 12 get on phone?
