Stephens, at this time the 15 acting commanding officer for the Office of 16 Public Information and we will just give you a 17 brief overview of what our office do daily. 18 Before I begin I would like to introduce members of my staff. I have the 19 20 civilian Ms. Yvette Walker, Police Officer 21 Christine Rozier, Police Officer Phillip Cook 22 and two members who are not present today would 23 be Police Officer Donald Donakowski and Police

1	The Public Information Office, areas of
2	responsibility and service. Citizens'
3	information, we issue, for example, missing
4	alerts. Media relations, we will put together
5	press briefings and conferences. The web
6	Internet-based communication, that's our Sgt.
7	Alan Quinn and Officer Cook who pretty much will
8	be the overseer on that and Sgt. Quinn also
9	handles our video production.
10	The Public Information Office consists
11	of two sergeants, myself and Sgt. Quinn, four
12	police officers and one civilian. Citizens'
13	requests for information. Our PIO staff responds
14	to approximately 500 calls and e-mails per week,
15	that's 26,000 per year and we operate Monday
16	through Friday 9 AM to 6:30 PM, but I am on call
17	24/7 except for vacation.
18	The general information, we receive our
19	requests, FOIA, Freedom of Information Act
20	inquiries, referrals to various Detroit Police
21	Department units and our mission is to provide
22	professional service and reliable information.
23	Media relations, our core values would
24	be, we try to be direct we are direct and



honest with the media and members of the public

1	and provide reliable and courteous service, even
2	though it's sometimes hard when we're dealing
3	with individuals like Charlie LeDuff, but we will
4	try.

Working on building public confidence in Detroit Police Department and its officers by providing positive stories to media. Keep in mind that the media when we provide them positive stories if it's not happening like right then and there, they pretty much won't air it.

A lot of times it takes time to process a case and once the case has been -- come in to the prosecutors the warrant has been signed, if it's -- we submit it to the media. They probably won't air if it didn't take place right then and there.

(Commissioner Taylor arrives.)

SGT. STEPHENS: We also aim to be part of Detroit Police Department's overall crime reduction effort, whereas promoted CrimeStoppers, educating the public on crime issues. We now post our 24-hour major crime summaries letting the citizens know about crime that's happened within the last 24 hours. We share information with our community partners via e-mails and

Media relations. Renewed focus on
promoting Detroit Police Department successes and
initiatives. Our major law enforcement partners
were now we have Detroit 1 which is a violent
crime reduction initiative, homicide reductions
which the homicide reduction I believe is a
credit to the work of our officers and our law
enforcement partners and our investigators.

As you know, the business community has stepped up where we're going to receive approximately 100 new police cars and the new basic recruit class to begin in the near future where we're going to have officers who are going to be signing up to became Detroit's finest in the future.

The website. Responsible for updating all content and information on the internal Detroit Police Department website. This is not the City of Detroit web which is open to the public. This is just an in-house website for our police officers.

Video production is Sgt. Quinn. He has pretty much recorded our Board of Police

Commissioners community meetings, special



1	projects, requests for department units. Our
2	success stories, videos are aired on our YouTube,
3	videos for DPD Academy, events, officer award
4	program and crime prevention safety tips which we
5	do post.
6	The YouTube channel promotes the
7	department. Videos of recent successes and
8	community initiatives give viewers a chance to
9	see more than just what makes the news, a look
10	inside aspects of DPD.
11	Thank you and do you have any
12	questions?
13	COMMISSIONER WARFIELD: For the record,
14	I just want to state for the record that
15	Commissioner Taylor has joined us.
16	COMMISSIONER TAYLOR: Hi. I just have
17	one. Are any of these videos available and if
18	so, how can you get them?
19	SGT. STEPHENS: Sgt. Quinn, our YouTube
20	videos?
21	SGT. QUINN: Well, they're all
22	available on the web and I think YouTube Sgt.
23	Quinn for the record, I'm sorry.
24	I think they have a feature where you



can download them from YouTube, but if anybody

1	wants specific ones, we can make them available.
2	Additionally, all media conferences
3	that we have for the police department that we're
4	involved in, we put them in their entirety on
5	YouTube, so you don't just get the two seconds or
6	five-second snippet, but we can see the whole
7	picture, you can understand the context of the
8	conversation.
9	COMMISSIONER TAYLOR: Okay, thank you.
10	COMMISSIONER WARFIELD: Just a couple
11	of questions, Sgt. Stephens. As you know, I
12	think you do a very good job, so thank you for
13	all of your hard work. You've been in some
14	stressful situations and I think you've pulled it
15	off very very well, so kudos to you and to your
16	staff for what you do.
17	SGT. STEPHENS: Thank you.
18	COMMISSIONER WARFIELD: A couple of
19	questions I have though. Let me just I can't
20	remember the first one, so I'll go to the second
21	one. A few weeks ago there was a story that was
22	out regarding an operation that was going on at a
23	gas station with a purse snatching.
24	SGT. STEPHENS: Yes.



COMMISSIONER WARFIELD: Whose idea was

it to put the media at that scene, Channel 4?
SGT. STEPHENS: Yes, it was Channel 4's
idea who came to us and asked if they could use
two of our officers to play role. One officer
was going to be the suspect and another member
no, just one officer and you had another member
who was just going to give an overview of what it
would take for a citizen to be a great witness.

And they've done them in the past and we've had no problems. By this chance there was just an FBI agent who was there. He never pulled his gun. He was in motion to go towards the purse snatcher, the officer, but then we had a plainclothes — I mean we had a uniformed officer who was there who said, "Hold on, we're play rolling", so now we know if we more in the future that we're just going to have to have a tighter hold on our scenario compared to what happened in the past.

Because the thing is, they want to catch the citizens' reaction. They didn't want to plant the seed, they didn't want to do anything to let the citizens know that this is occurring, and so we saw what can happen in real life whereas if you're planning something and a

1	crime occurs, even though we know that hopefully
2	the officer wouldn't have been shot just for a
3	purse snatching, but you never know.
4	COMMISSIONER WARFIELD: You never know.
5	SGT. STEPHENS: So it was a learning
6	experience for us and we'll know what to do as we
7	move forward if this should occur again.
8	COMMISSIONER WARFIELD: I would just
9	ask and I'm sure this Chief and the new Chief
10	will have a policy in place as a result of that
11	that we think probably two or three times before
12	we put forth scenarios with TV camera news crews
13	as relates to either actual criminal activity or,
14	you know, staged criminal activity in the midst
15	of a public setting because, as you I think
16	appropriately said in your press release you just
17	don't know who's watching, you don't know who's
18	standing around and anything could jump off.
19	So I would just hope that in the future
20	moving forward we will be very careful about
21	allowing news crews, whether it's a staged event
22	in the public or whether it's a criminal event
23	like the 48 Hours which we know don't happen any
24	more, move forward.



SGT. STEPHENS: And just let me say in

the past we have not had a problem and if the FBI
agent wasn't there it would have went off smooth,
so I believe and taking in what you're saying,
I just believe that next time we're just going to
have identify the individuals, block off the
scene so no one can go in and out to make sure
that you're going to be participating as a player
in this skit and they're just going to have to
have knowledge to know that it's going down.
COMMISSIONER WARFIELD: All right.
SGT. STEPHENS: So yes, most definitely
as we move forward we probably would have more
perimeters intact to ensure that doesn't happen
again.
COMMISSIONER WARFIELD: Okay. The
other question, I do remember what it was.
Obviously, with the fireworks coming upon us on
Monday and we expect a number of people to be
here in the city of Detroit and as I think I sent
you an e-mail that the tow rates have changed and
I think it would be beneficial if somehow mass
communication could go out to all of the media,
print and video if that's a term, and alert
citizens that they need to park properly or they

will spend bare minimum \$215 to get their car

1	from a towed situation.
2	SGT. STEPHENS: Yes.
3	COMMISSIONER WARFIELD: And so I mean
4	that needs to be spread out across the city,
5	across the suburbs that it's going to cost you
6	\$215 if your car is towed because of it being
7	illegally parked on fireworks night.
8	So if we can put that press release out
9	I think it may save some frustration of those who
10	watch some of the local news channels and media.
11	SGT. STEPHENS: Yes, and just so you
12	know, the Mayor's Office, they've issued a
13	release and they're going to be setting up some
14	interviews from now probably beginning tomorrow
15	through the weekend and so the areas will be the
16	tow, where there will be an emergency curfew and
17	also that Belle Isle will not officially open
18	until 2.
19	COMMISSIONER WARFIELD: Right.
20	SGT. STEPHENS: And then also in Hart
21	Plaza you won't be able to begin to set up until
22	2.
23	COMMISSIONER WARFIELD: Right.
24	SGT. STEPHENS: So those are key things
25	that we will be pushing and the River Walk will



1	not be open either to the public.
2	COMMISSIONER WARFIELD: Right, exactly.
3	SGT. STEPHENS: So yes, sir, we will.
4	COMMISSIONER WARFIELD: Okay, great. I
5	just the sticker price needs to be out there
6	so people can know it. We don't need to be hiding
7	that because we will face the burden of that if
8	we try to hide it and sweep the sticker price
9	under the rug.
10	SGT. STEPHENS: Oh, yeah, I agree.
11	COMMISSIONER WARFIELD: Anything else,
12	ma'am?
13	COMMISSIONER TAYLOR: No, I don't have
14	anything.
15	COMMISSIONER WARFIELD: Thank you so
16	very much. Again, I do appreciate your job
17	because we are not the most benign city as
18	relates to worthiness. We kind of busy, we jump
19	all over the place and you're called into action
20	often, be it while you're here or you have to

22	you for your due diligence in what you do.

25	know you do. Thank you. Sir, anything else?

Officer Clark and Lt. Adams had drafted some proposals that we were going to talk to the City about to address the evidence vehicles and the forfeiture vehicles. We had a meeting scheduled for that today, but that didn't transpire.

The City came out -- Andre Duberry came out with a letter that I received in e-mail form and I guess it went out to the editorials as well that stated until they come up with a new protocol or a new fee for evidence and forfeiture vehicles everything will remain status quo, so right now the way it was in the past is the way it is right now.

COMMISSIONER WARFIELD: I talked with him as well and basically he did tell me the exact same thing, that it was not addressed, so one of the things that I think we have to do is — and I know one of the reasons they put a tower on the Tow Rate Commission hopefully they can vet that stuff out before we're in the position we are right now.

So we probably need to talk to the Tow
Rate Commission. Maybe we can have Jack Morton
or somebody from the Tow Rate Commission to come
and address the issue if it was addressed in
their deliberations and if that was part of their
deal or not, and we can go from there.
My only thing is and we've talked
privately about this so you know
CMDR. LOVE: Yes, sir.
(Commissioner Stewart arrives.)
COMMISSIONER WARFIELD: I'm very
cautious about changing fees and formulas that an
elected body like the Detroit City Council
passed. I do think there's precedent and
protocol that is in place and Andre I'm sorry,
Director of Purchasing, Mr. Duberry, did say that
this was something that we would do from now
until we can get this straightened out.
So and if that's the position that
you all take, certainly we can support that.
However, I do want us probably sooner than later
to hear from the Tow Rate Commission as well as
Purchasing and we can move forward with this so
that everybody is on the same page.



I know there's a bunch of towers here

1	who want to comment on this as well and we want
2	to hear from them, so if you could just hang
3	loose and we can if there's some questions we
4	may have of them as well.

2	Commissioner, at our last meeting
3	regarding transfers I stated the only major
4	change was just the implementation of the MAS
5	procedures and then regarding 203.7, the
6	Organized Crime, Vice and Narcotics, it's
7	essentially the same. We took out some old
8	paperwork references that are no longer being
9	used, but the core of the directive, the core
10	policies, are exactly the same.
11	COMMISSIONER WARFIELD: Okay, thank
12	you, sir. Any questions or comments for Lt.
13	Bliss?
14	COMMISSIONER TAYLOR: None.
15	COMMISSIONER STEWART: None.
16	COMMISSIONER WARFIELD: All those in
17	I'm sorry, I will entertain a motion to adopt
18	Directives 203.7 and 401.2.
19	COMMISSIONER STEWART: So moved.
20	COMMISSIONER TAYLOR: Support.
21	COMMISSIONER WARFIELD: Any discussion?
22	Hearing or seeing none, thank you, sir. All
23	those in favor?
24	COMMISSIONERS: Aye.
25	COMMISSIONER WARFIELD: All those



1	opposed? Motion carries. Appreciate it, thank
2	you.
3	LT. BLISS: Thank you.
4	COMMISSIONER WARFIELD: Appreciate you
5	sticking around. All right. At this point we
6	will open up the floor for oral communication.
7	If you wish to address the Board of
8	Police Commissioners we ask that you come at this
9	time, give us your name and we ask that you abide
10	by our two-minute time limit so that we may hear
11	from as many folks as possible.
12	You may come at this time.
13	MS. ROBINSON: Good afternoon. I am
14	Katrice Robinson, president of Midwest Civil
15	Council Block Club.
16	I had just a couple of questions that
17	concerns one in regards to the Powerpoint. I
18	noticed that I wanted to know how often do you
19	recruit new officers, and my other concern is I
20	heard her mention that the River Walk is going to
21	be closed during the fireworks and if we're going
22	to have tourism during that time, then how will
23	we generate revenue if all the activities are not
24	going to be available to them.



COMMISSIONER WARFIELD: Thank you,

1	Ms. Robinson. I think I can address both of
2	those concerns, and Director Porter, you help me
3	if I get messed up.
4	As far as the recruiting phase, we
5	recruit all the time. Our doors are always open
6	to receive those who are interested in Detroit
7	Police Department and there are members of the
8	department that go out to recruit as well.
9	So that's an ongoing thing for us, so
10	it's not just like in these months.
11	MS. ROBINSON: A seasonal.
12	COMMISSIONER WARFIELD: Right, exactly,
13	it's ongoing. On the second thing, that's the
14	Mayor's decision. I think it's going to be open
15	up to a certain point and I think after a certain
16	point, and you can correct me, sir, that they're
17	going to close it down, that no new traffic can
18	go on the River Walk, but that's a mayoral
19	decision that comes pretty much from that office.
20	I know they confer with us as well
21	because here's the issue. The issue is how do
22	you, to the very best of your ability, in light
23	of what has happened in Boston and other areas,
24	make sure that if there's 700,000 or a million
25	people downtown how do you do the very best you



1	can to prevent any potential acts that might mar
2	that event.
3	We have layers of security that the
4	public will never see. However, we do know that
5	there are some things that we can do as relates
6	to crowd control that helps even further enhance
7	security. And so that was one of the measures
8	that was being taken. Now, Deputy Chief might
9	have a little bit more to say about it.
10	DEPUTY CHIEF TOLBERT: And you're
11	absolutely right. Through the Chair, you're
12	absolutely right, Commissioner.
13	Our concern is being able to manage the
14	people in a way that we can safely do so for the
15	sake of the people and the sake of the officers.
16	When you have more area to cover, you
17	have to spread it out more, so if we can and
18	then a couple other things. Obviously if you've
19	been down by the River Walk during the time of
20	the fireworks there's a lot of debris that falls
21	too.
22	So you have to be careful, you can't
23	have it open in certain areas of the River Walk
24	anyway because of the debris that falls from the



fireworks, so that's a concern.

1	And also the coverage of the area, all
2	of the River Walk. So and it will be open
3	prior to the day so that we're not interrupting
4	anybody who wants to go down there and enjoy it
5	during the day, but just at some point after
6	approximately right after working hours it
7	will be closed down, we'll clear it out and then
8	we will go forward with the fireworks and then
9	after the fireworks it will open back up.
10	MS. ROBINSON: Well, see, I understand
11	that, but and I understand the safety as well
12	but when you have crowds of people I think as a
13	deterrent that you should allow some type of
14	activity, especially when there's a lot of
15	children for they to do something other than just
16	running around and bothering other people and
17	disturbing people that are down there to enjoy
18	the fireworks, so there needs to be some type of
19	activity.
20	And every time we have a convention or
21	something and people go out to eat as you said
22	after business hours, then everything is closed
23	down, so how do we generate revenue if everything
24	is closed?

COMMISSIONER WARFIELD: Well, I'm sorry

1	if I gave that indication that everything is
2	closed down.
3	MS. ROBINSON: Well, no, I'm not saying
4	that everything will be closed for the fireworks,
5	but with special attention you're saying about
6	the River Walk, and I understand that it would
7	have to be closed during the fireworks session,
8	but from 2 o'clock until that time are you saying
9	that it's going to be open?
10	COMMISSIONER WARFIELD: Yes, it would
11	be open, if I'm not mistaken, up through I think
12	right after is it 4?
13	DEPUTY CHIEF TOLBERT: 4 o'clock we
14	start closing. It will be open all day long.
15	MS. ROBINSON: But see, people can't
16	come down until 2 o'clock, they can't set up shop
17	until 2.
18	DEPUTY CHIEF TOLBERT: They can't set
19	up shop on the River Walk, but they can what
20	you want during the daytime when people come to
21	Hart Plaza and enjoy themselves and to come for
22	lunch, we don't want to stop that.
23	We don't want people setting up at 10
24	o'clock in the morning at Hart Plaza and
25	therefore people who come there and try and enjoy



1	the day, they can't do that.
2	So we're going to limit the time
3	individuals can set up, and plus once you set up
4	in Hart Plaza we still have the safety concerns,
5	so once it's cleared out, then we have people who
6	want to bring packages in, we want to inspect
7	those packages.
8	If we have people setting up all day,
9	we won't have a clean zone and we want to start
10	off with a clean zone and keep it clean once we
11	close the plaza and inspect packages coming up
12	because people will be set up, we'll have
13	hundreds of thousands of people set up in Hart
14	Plaza.
15	So we want to make sure the zone is
16	clean and it's clean as we go forward for the
17	fireworks.
18	MS. ROBINSON: Okay, and I understand
19	that, but along with your media person when you
20	go to mention those hours, can you also mention
21	the hours that the River Walk would be available
22	so that people can plan and have things to do
23	other than disturbing, you know.
24	COMMISSIONER WARFIELD: Yes, ma'am.
25	We'll send that note over as well.



1	MS. ROBINSON: Thank you.
2	COMMISSIONER WARFIELD: Thank you, good
3	points, thank you, ma'am.
4	MR STIDHAM: Good afternoon, Mr. Chair,
5	Commissioners, Mr. Secretary and Deputy Chief.
6	Tom Stidham and I'm here to address two distinct
7	issues.
8	One, Commissioner Warfield, with
9	respect to the proposed tow rate changes that are
10	being bandied about by the Administration, I just
11	want to be clear.
12	I attended every single Tow Rate
13	Commission meeting and evidence and forfeiture
14	vehicles certainly were discussed, deliberated
15	and considered. In fact, the plain language of
16	the resolution that was passed by the Tow Rate
17	Commission and the Detroit City Council clearly
18	states that these rates apply to each tow to any
19	any private or city-owned storage lot.
20	So and I think the effort by whoever
21	I don't know if it's coming from the
22	Administration or perhaps within the department
23	or elsewhere to adjust the rates, it has to
24	simply go through the Tow Rate Commission and the
25	City Council.



1	And until that happens, I think that
2	the memo that was written is clearly in error.
3	Secondly, about a month ago I believe
4	someone I forget precisely who it was that
5	came before this Board to discuss and celebrate
6	the success that a specific narcotics program had
7	been making in the community.
8	As part of that and Deputy Chief, I
9	can't remember the name of that.
10	DEPUTY CHIEF TOLBERT: NIP-IT.
11	MR. STIDHAM: NIP-IT, yes, thank you.
12	As part of that report they discussed about 1,800
13	approximately 1,800 cars have been towed as
14	part of that program over a 10-week period. I
15	have clients here that have towed one car a day
16	for a prolonged period of time and that program
17	was occurring in some of their areas, the hot
18	spots.
19	I'm simply trying to wonder if or
20	ask if this board can assist us in getting some
21	idea of who towed all those vehicles
22	COMMISSIONER WARFIELD: Sure.
23	MR. STIDHAM: pursuant to the NIP-IT
24	program and who's continuing to tow those

vehicles and how long -- or how many have they

1	towed in the last 10 to 20 weeks. Thank you.
2	COMMISSIONER WARFIELD: Stay there for
3	a second. Let's do the second one first.
4	Do you think it's possible to get that
5	information who towed?
6	DEPUTY CHIEF TOLBERT: Absolutely, sir.
7	COMMISSIONER WARFIELD: We'll get that,
8	we'll get that information for you. That's not a
9	problem.
10	And your information certainly on the
11	tow rate discussion is very timely and certainly
12	I was not at all of those meetings so I just flat
13	out did not know and that certainly was one of my
14	concerns is that if this was brought up in that
15	discussion and if they had bantered this topic
16	about and decided and deliberated that it's going
17	to be for every tow, then we need to know that so
18	that, you know, the practices of the past will be
19	understood in light of what this new tow rate is,
20	and so if possible, do you know if they kept
21	minutes?
22	MR. STIDHAM: I believe some minutes
23	were kept. I'm not certain.
24	COMMISSIONER WARFIELD: So here's what
25	we're going to ask. We want to either ask to see

1	some minutes or to invite somebody here from the
2	Tow Rate Commission next week, see if we can get
3	somebody to come next week, to give us some
4	understanding because I think that will settle
5	the argument right there and I think and then
6	of course the question then will be what to do
7	with those fees that either were or were not paid
8	since the new rate has been in force.
9	And so we will cross that bridge when
10	we get to it obviously, but we definitely need to
11	have someone from the Tow Rate Commission because
12	Mr. Duberry wants the same information.
13	Our guestion is, who has the authority

Our question is, who has the authority to change what an elected voting body has done and was this topic broached in their deliberations, and apparently according to you, sir, certainly they have been, so thank you because your information is very helpful.

MR. STIDHAM: I would submit not only was it, but I think if one just reviews the plain language of the resolution that was passed by the Towing Commission and Council, again it says any city lot or privately owned lot.

7	memo regarding the fee for the fireworks?
8	MR. STIDHAM: Well, it covers
9	appears to cover more than just fireworks, but it
10	addresses the evidence and forfeiture vehicles.
11	COMMISSIONER WARFIELD: For that,
12	again, we'll discover that. I mean, we'll take
13	this issue up and probably make a definitive
14	decision next week once we hear from those who
15	actually did the deliberating on that matter as
16	relates to the forfeiture and evidence vehicles.
17	So we can do that next week.
18	As far as the fireworks, I'm not sure
19	what you're referencing.
20	MR. STIDHAM: Well, is there any
21	first of all, is there any special detail for the
22	fireworks or are they doing any in a rotation
23	system? I don't know, I haven't heard of
24	anything.



COMMISSIONER WARFIELD: I think they're

1	doing rotation unless there's something special.
2	Commander?
3	MR. STIDHAM: Thank you.
4	COMMISSIONER WARFIELD: Thank you, sir.
5	CMDR. LOVE: Cmdr. Love, Resource
6	Management again for the record. I'm going to
7	bring Officer Roland Clark up and defer this
8	question to him because he's my tow expert in my
9	office.
10	COMMISSIONER WARFIELD: Plus he hasn't
11	been up to the mic in a long time.
12	CMDR. LOVE: Absolutely.
13	OFFICER CLARK: Good afternoon,
14	Commissioner. Officer Roland Clark for the
15	record. We are having a tow program for the
16	fireworks. We're going to have there will be
17	two locations. There will be one operating from
18	2121 West Fort Street and the other one will be
19	on Belle Isle.
20	All towers were invited, if you will,
21	to participate. Of the 24 companies I believe we
22	had I want to say eight that agreed to
23	participate. I believe what Mr. Stidham is
24	referring to is the rates.
25	We sent out a letter describing the



1	rates based upon what happened in previous years.
2	However, we met with some resistance, so we
3	changed it. The rate will be \$125. The rate is
4	supposed to be \$125 plus a \$75 administrative
5	cost plus \$15 a day which is \$215. That's the
6	rate, that's what we'll pay the towers and that's
7	what we'll collect.
8	COMMISSIONER WARFIELD: Question, sir.
9	In the letter that you had sent out inviting
10	towers to participate, was a revised rate in that
11	letter?
12	OFFICER CLARK: The second letter, the
13	revised rate was in the second letter.
14	COMMISSIONER WARFIELD: Which probably
15	is why some towers opted not to participate?
16	OFFICER CLARK: Yes, sir.
17	COMMISSIONER WARFIELD: And I don't
18	know how it was done in the past so I'm not
19	trying to throw any resistance in, but I do know
20	that well, I think it would be fair if an
21	invitation went out to all the towers again.
22	OFFICER CLARK: It has, sir.
23	COMMISSIONER WARFIELD: Did you give
24	them a deadline to respond?
25	OFFICER CLARK: I give them a deadline



1	of tomorrow?
2	COMMISSIONER WARFIELD: When did the
3	letter go out?
4	OFFICER CLARK: The letter went out day
5	before yesterday I believe, it was faxed to all
6	the towers.
7	COMMISSIONER WARFIELD: That's Tuesday
8	or Wednesday Tuesday. So it went out Tuesday
9	and we asked them to respond by Friday?
10	OFFICER CLARK: Yes, sir.
11	COMMISSIONER WARFIELD: Okay, cool.
12	All right, so just for the record so we're clear
13	then a revised letter went out basically saying
14	that the rate is going to be \$125 for the two,
15	\$75 administrative fee and \$15 for storage.
16	The \$15 for storage now, what's
17	interesting where is the \$15 for storage going to
18	go to? Is that going to the City?
19	OFFICER CLARK: It's going to the City.
20	COMMISSIONER WARFIELD: Because it's
21	going to be towed to basically city property.
22	OFFICER CLARK: Yes.
23	COMMISSIONER WARFIELD: Not a problem
24	with that. So the towers will get their \$125 tow
25	fee?



Page 36 1 OFFICER CLARK: Yes, they will. 2 will make out a bill per tow. Every tow that they drop at either location they will present us 3 with an invoice and we will go through the normal 4 5 process to get them paid. 6 COMMISSIONER WARFIELD: And the City will receive \$90? 7 8 OFFICER CLARK: Yes. 9 COMMISSIONER WARFIELD: Okay, all 10 right. So again, hear ye, hear ye, to dispel any 11 rumors or myth a letter did go out to all of the towers inviting all of the towers to be part of 12 13 the fireworks towing. 14 Now, my question is how do you rotate 15 them? Say if all 27 towers say, "Count me in" 16 17 OFFICER CLARK: Well, every tower --18 every officer is assigned one or two towers and 19 so one officer may tow 10 cars, and one officer 20 may tow five cars, but we try to make it as fair

But when you have -- when you have that many people in a tow operation, it's almost impossible to line up every tower and say you get this one, you get the next one, you get the next

1	one and so on and so forth.
2	It's almost possible to do that.
3	COMMISSIONER WARFIELD: All right. You
4	say every officer will be assigned two towers?
5	OFFICER CLARK: At least two towers.
6	COMMISSIONER WARFIELD: And I'm not
7	going over I certainly don't want to get into
8	security numbers, but I'm throwing a figure out,
9	all right.
10	I'm just throwing this out top of my
11	head. 1,000 officers are downtown, I'm just
12	throwing this out. I know it's not 1,000. I'm
13	just throwing this out. I'm just telling you
14	what I heard.
15	OFFICER CLARK: I don't mean like every
16	officer that's assigned to the fireworks detail.
17	Every officer that's assigned to the tow detail
18	will be assigned a number of trucks because we
19	don't know we didn't know how many people
20	how many tow trucks or companies had signed up,
21	so once we get a number, then we can assign those
22	trucks per officer that's assigned to the detail.
23	COMMISSIONER WARFIELD: How many tow
24	detail officers do you have are you going to
25	have I should say?



1	OFFICER CLARK: We have approximately
2	six per location.
3	COMMISSIONER WARFIELD: So the location
4	on Belle Isle and the location at Fort?
5	OFFICER CLARK: Yes.
6	COMMISSIONER WARFIELD: Can we get
7	together on this because that sounds confusing to
8	me?
9	OFFICER CLARK: Sure.
10	COMMISSIONER WARFIELD: Can we get
11	together with staff like tomorrow
12	OFFICER CLARK: Sure.
13	COMMISSIONER WARFIELD: and sit down
14	and go over some logistics because just from a
15	logistics standpoint because here's what I don't
16	want to deal with.
17	I don't want to deal with or I don't
18	want us I don't want us as a department to put
19	something out there where the detail, the tow
20	detail, seems to be not fair. I know it's not
21	nobody's intent, that's not anybody's intent.
22	I just want to make sure that it's
23	clear that towers know this is the process and if
24	we have to line them up in alphabetical order, if
25	we have to give them tow numbers to tow cars,



1	whatever we have to do, I want to make sure that
2	we go the extra mile to make sure that there is a
3	rotation, you know, an equal distribution of
4	rotation.
5	Now, I'm not saying you criss-cross
6	lots, so if you're assigned to this area, then
7	that's where you're going to tow from.
8	OFFICER CLARK: Right.
9	COMMISSIONER WARFIELD: If you're
10	assigned to this area, that's where you're going
11	to tow from.
12	And then there is a distribution
13	because you know who will be at those lots. And
14	so if there's three officers over here and three
15	officers over here, somehow or another in the
16	calling of those towers there ought to be a list
17	or something, a check-off, that says okay, ABC
18	got this one, XYZ gets the next one and LMN gets
19	the next one, if that makes sense.
20	OFFICER CLARK: It does.
21	CMDR. LOVE: And I just want to chime
22	in. Cmdr. Love again for the record. It makes
23	total sense to me, so we can talk tomorrow with
24	your staff and I understand we don't want any



25

towers to be left out of a rotation and if we can

1	do it by area, then that should be sufficient
2	enough to send them out in a certain order.
3	COMMISSIONER WARFIELD: Yeah and how do
4	you split them up by area? I mean, I just want
5	them to be equal, because our charge as you
6	know, Commander, our charge as a board is to make
7	sure there's equalized distribution of tows and I
8	just want to make sure that that happens somehow.
9	CMDR. LOVE: I agree and two things I
10	want to clarify. Officer Clark, his resistance
11	come from me, not this body.
12	You know, in the past they did things a
13	certain way. I changed it this time, so the
14	resistance came from me, not the body.
15	Second of all, the letter that went out
16	to the towers, it indicated the amount they would
17	get. It didn't indicate the whole tow fee
18	amount, because it said you will get \$125 for
19	this particular detail per tow, so it didn't
20	specify the storage fee, the maintenance fee and
21	all that in the letter.
22	COMMISSIONER WARFIELD: Okay, sure.
23	This is why I love members of this department
24	like you because you were so politically correct.
25	"No, the resistance came from me." That's the



1	truth, the resistance came from me.
2	CMDR. LOVE: On this level it came from
3	me.
4	COMMISSIONER WARFIELD: Absolutely and
5	I thank you, Sgt. Clark, because again we just
6	sat down and had a conversation and that's how
7	it's resolved, they just had a conversation.
8	Officer Clark had a conversation about, you know,
9	what we needed to talk about and it was done, so
10	that's why I thank you all very much for just the
11	hard work that you put in.
12	I know what you and Adams do is not
13	easy and I know you all get pulled on from
14	everybody and I know you guys do the very best
15	you can with what you have to work with and
16	certainly I thank you all for being
17	accommodating, it means a lot, and I just want to
18	make sure that on Thursday, next Thursday, you
19	know, the towers are pleased, the citizens of the
20	city are pleased about what happened that day,
21	and that's why it's going to be critical for you
22	all too that we get that out there that it's
23	going to cost you \$215 if you park illegally and
24	get towed, so thank you.

There may be some more from towers, so

1	if you could stick around a little longer.
2	Next.
3	MS. FELDER: Hello. My name is Temia
4	Felder. I was here approximately 90 days ago
5	February 28 and I addressed the board pertaining
6	to an incident that took place in my home
7	involving my children and the Detroit Police
8	Department.
9	As I stand here today I'm still waiting
10	on some information to find out what took place.
11	I tried to call yesterday to try to get some
12	information. There's a letter that's coming in
13	the mail for the last four weeks, so as a parent,

23	will know before you leave out those doors what

14	this particular point a plan to clarify all of
15	the different agencies who are going to be
16	involved in the security activities at both of
17	these events, at the march and also at the
18	fireworks because I know there were several
19	agencies both in terms of outside of the realm of
20	Detroit in terms of the suburban entities and
21	also maybe national and local security agencies,
22	police agencies, so I wanted to know how that was
23	configured.
24	COMMISSIONER WARFIELD: Thank you.
25	Deputy Chief?



1	DEPUTY CHIEF TOLBERT: For the record,
2	Deputy Chief Tolbert. On your first question,
3	why the 2 PM closure closure until 2 PM on
4	Belle Isle. Obviously our again, our biggest
5	thing is to make sure we have enough manpower to
6	adequately provide services that we need to for
7	all the citizens and visitors, so therefore when
8	you know at the amount of manpower we use in
9	Bells Isle when it's closed, we decided to keep
10	it closed once we close it until 2 o'clock so
11	that we can take that manpower and have that
12	manpower available when we open the island and
13	therefore we'll have more people there.
14	As for the people who have who
15	require access because of the yacht club, we're
16	not going to deny them access. They will be able
17	to come on because they're going to the yacht
18	club. What we will not allow is anybody in the
19	area of the viewing area on the east end of the
20	island to set up prior to 2 o'clock.
21	There will be nobody setting up on the

2	For your other events, we're in the
3	process of we have multiple units or multiple
4	agencies that will be assisting the department.
5	This year is unique. In fact, last year if you
6	recall we actually reimbursed some of the other
7	agencies that assisted in the fireworks. We're
8	not doing that this year, so obviously that
9	participation is down.
L 0	But, again, in the spirit of
11	cooperation with a lot of other agencies,
12	federal, local and state agencies, they're coming
13	together without charging us and they're going to
L 4	assist us with providing the services and
15	security for the fireworks and I think we're
16	going to have a very nice event.
L 7	MR. SCOTT: Can I ask just a couple
18	follow-up questions? One is, are not some of the
19	agencies who will be involved required or would
20	naturally make it their concern, i.e. Homeland
21	Security, in terms of their involvement so
22	therefore we wouldn't be paying them anyway if it
23	were Border Patrol. I mean, we would be paying
2.4	them twice Technically that's their



responsibility.

1	DEPUTY CHIEF TOLBERT: And I'm not
2	going to go into the specifics of who we paid and
3	who we didn't pay, but rest assured it costs
4	everybody to deploy manpower anywhere, no matter
5	what agency, so and we can't force them to
6	come and help.
7	Everyone that's going to be there is
8	helping on their own volition and we're not
9	paying anybody, so that's really a mute point,
10	but
11	So we're satisfied with our partners,
12	we applaud their participation and we look
13	forward to working with them.
14	MR. SCOTT: Just a final question.
15	It's always been it's been a sore point of
16	mine in terms of potential 14th Amendment
17	violation in relationship to individuals who are
18	members of private clubs and who have access to
19	where citizens wouldn't have in terms of equal
20	protection and disparate treatment, so that's
21	always been my question.
22	I understand what you're saying, that
23	the yacht club members can come on, but I think
24	what's fair for the goose is fair for the gander.
25	I mean, if they want to come on the



1	island, they should come when everybody else
2	comes and they should leave when security
3	dictates that they leave.
4	I'm just stating that for the record
5	because I think that it has been far too long and
6	I was thinking about becoming a member of the
7	yacht club, but I would not want to have other
8	considerations ironically enough on the eve of
9	the civil rights march that other citizens didn't

12	have to understand that's a private entity on the
13	club and if they have they're going to a
14	private area of the island and we just can't
15	control or deny them access to their basically

19	was denied the opportunity to become involved in
20	the Detroit Golf Club because it was presumed to
21	be private and subsequently they had to allow him

23	the citizens of Detroit can become members of the

24	weeks ago. Nobody said let's close it down and
25	open it up at a certain time. And my thing is



1	and just as a citizen, that and I've been on
2	the island for fireworks and I know the crowds
3	that's there for fireworks and certainly there
4	are minor incidents wherever you go I guess, but
5	I've never known any major incidents that
6	occurred on the island.

And so I just think — and this is the Mayor, not to the department, I think more so to the Mayor, whoever else made the decision that we got to be careful — and let me just get on my little soapbox and get off — where we treat ourselves differently than what we treat other folk at the end of the day.
