1	chairperson's report, but I will be giving a full report
2	next week well, the next meeting, talking about how
3	this Board is going to be moving forward and what we
4	plan to do and how we do it. Now, the secretary, do you
5	have a report?
6	SECRETARY ANTHONY: Yes, ma'am. This is the
7	report of citizens complaints that were received in May
8	of 2013. The 2013 monthly count of complaints for May
9	was 130. And that's compared to the 2012 monthly count
10	of complaints at 117. So, there is an 11 percent
11	increase over last year. The year to date figure for
12	2013 is 475; for 2012, 539 which represents a 12 percent
13	decrease. At the end of May of 2013, the office of the
14	chief investigator had open investigations at 237, cases
15	filed 475, cases closed, 453.
16	Of the 130 cases that were filed in May of
17	2013, 41 percent involved unknown officers. The alleged
18	known units involved leading in complaints filed in May
19	of 2013 were the Second Precinct and communications at 6
20	percent, the Eastern District and traffic enforcement at
21	6 percent, the Sixth Precinct and Twelfth Precinct at 5
22	percent. The 130 cases filed in May of 2013 involved
23	233 allegations where the leading areas of concern were
24	demeanor at 31 percent, procedure at 29 percent, service
25	at 14 percent and force and harassment at 7 percent.

1	Also, if you note, that of those 233
2	allegations that were filed with regards to unknown
3	officers, there were 98 allegations filed against
4	unknown officers in May of 2013. That completes the
5	secretary's report.
6	CHAIRPERSON TAYLOR: Are there any questions?
7	Okay. If not, then we will move to our next report
8	which is OCI monthly report.
9	CHIEF INVESTIGATOR DAVIS-DRAKE: Thank you,
10	Madame Chair. For the record, Pamela Davis-Drake, chief
11	investigator. Just a brief report on mostly
12	statistical. The report date, Tuesday, July 2, 2013.
13	We have a total of 276 open cases; 14 of those cases
14	have been submitted for closing. We have 0 cases over
15	90 that are currently due or currently have been
16	committed. Just a brief observation. The trend over
17	the last couple years has been that during the summer
18	months, we have an increase of CCR's. And that is
19	largely due to the fact that we have more citizens out
20	on the streets and likely more police contact. But we
21	do see a spike in the May numbers and likely a spike in
22	the June and July and August numbers as well I'm sure.
23	And that concludes my report.
24	CHAIRPERSON TAYLOR: Are there any questions?



COMMISSIONER WHITE: Chief, I think it was

1	referenced at a previous meeting that we were taking a
2	closer look at complaints that originated behind an
3	entry search warrant or entry. Are we still tracking
4	that or have we compiled any data to date?
5	CHIEF INVESTIGATOR DAVIS-DRAKE: I believe
6	you're referring to the cases that were from drug busts
7	entering homes and search and seizure. Yes, we are
8	continuing to track those, sir.
9	COMMISSIONER WHITE: Is there a date
10	foreseeable where some data would be available that we
11	can look at?
12	CHIEF INVESTIGATOR DAVIS-DRAKE: I can have
13	some for you for the next meeting.
14	COMMISSIONER WHITE: Thank you.
15	CHAIRPERSON TAYLOR: All right. Okay, so if
16	there's no other questions, thank you.
17	CHIEF INVESTIGATOR DAVIS-DRAKE: Thank you.
18	CHAIRPERSON TAYLOR: Now we will have a report
19	or presentation from DC Tolbert.
20	DEPUTY CHIEF TOLBERT: Good afternoon, Madame
21	Chair. There is no report or presentation today from
22	the DPD.

Some don't have names, some do. But they are causing trouble. They're in large numbers causing trouble. They expressed to us that if we had something to do — and we asked them, if we get you a job, you know, will you come out. They said yeah, they will do it. Every kid is going to need something. And this is an age group we feel we can really help somebody. And they usually don't get it from police. This is a positive piece. A lot of people say, well, cops aren't happy. 1	COMMISSIONER WARFIELD: This is Thursday, July
2	11, 2013? Should the kids bring anything with them?
3	OFFICER OWENS: No. There is going to be food
4	for them. We just need a head count on how many
5	students or young adults are attending.
6	COMMISSIONER WARFIELD: Would they be able to
7	interview for a job even?
8	OFFICER OWENS: Yes. It's going to be on site
9	interviewing with the local restaurants that are
10	attending.
11	OFFICER COLEMAN: Also for those that can, we
12	encourage them to dress to impress. But for those that
13	can't, we pray that we are going to help them get to
14	where they can impress. They can wear their best.
15	That's good for us.
16	COMMISSIONER WARFIELD: I'd like to see you
17	all afterwards because I have a list of young kids that
18	I can't hire. I mean, I'm hiring about 205 of them.
19	But I have a list of about 500 that I can't hire. So, I
20	would want to forward that information on to you so you
21	can invite them.
22	OFFICER OWENS: We'll invite them.
23	OFFICER COLEMAN: We also need to link up with
24	you for a bus so we can make sure they get there.

1	absolutely. Thank you, ma'am.
2	MS. PANNELL: Good afternoon, Sharon Pannell.
3	I'm just letting you know that the Detroit Police
4	Citizen Academy is having a picnic next Wednesday. It's
5	Shelter 8. Lunch should be at 12. That's all.
6	CHAIRPERSON TAYLOR: All right. Thank you,
7	Ms. Pannell.
8	MR. MORSON: Good afternoon, everyone. I'm
9	truly thankful and honored to be here once again before
10	this Board and amongst the people here in our city. I
11	just would like to express some heartfelt feelings that
12	I prepared, something that I thought
13	CHAIRPERSON TAYLOR: Sir, your name for the
14	record?

18	just read what I have here. As a native Detroiter, I
19	need to believe that our city and residents is promised

22	approval, who honor, devote and dedicate themselves to
23	the challenges, demands and commitments, sworn officers
24	who regularly step up to face and meet the severe
25	threats and seemingly never ending potential life

altering challenges in order to thwart dangers birthed,
produced, created, mastered and carried out by the
unfortunate struggles and troubled lifestyles produced
by criminal minds and criminal elements, carried out by
the unwanted threats of our legal and justice system
that violates people's rights and freedom and liberties.

These very fine fearless men and women in blue who without any hesitancy put their lives on the line each and every day at the sound of a simple distress call, to those men and women in blue, I'd truly like to take this opportunity to applaud you and salute you for what it is that you do. I want to make sure that I made that very much known. However, as I continue to mention at the last meeting, I traveled back here specifically because of an incident that happened May the 1st, 2013, at 8:00 p.m. on Gratiot and 8 Mile that I spoke about at the last meeting, that I'm still not satisfied, happy and/or optimistic at this moment about the progress in the situation, the Detroit Police Department's efforts.

I had an opportunity to meet with DC Tolbert.

I was promised a phone call. Unfortunately, I didn't receive that phone call. I am here again speaking about this same incident that happened on May the 1st that involved an off-duty transit police officer. It is at this point in my opinion, that this officer was -- well

off duty transit officer specifically should have been
remanded and in custody today for his unjustifiable
actions that occurred on that particular evening that
involved my nephew. With all due respect, I see the
time limit is up. I'm respectfully asking that I may
have an extension of a couple more minutes if that's
okay with everybody here in this body.

CHAIRPERSON TAYLOR: Go ahead, sir.

MR. MORSON: Okay. And continuing with my concern, there has been conversations and little thereof of movement and motivation in trying to in my opinion bring this matter to some type of resolve. So, what I am attempting to do is before this particular commission and the deputy chief is to get some answers, clearly some answers. And I'm putting this here on this record to insure that it's being heard and that you guys are made aware of what my concerns and the family concerns are. And that is that the unnamed officer who was involved with this particular matter that we are unaware of. And under the Freedom of Information Act, we are entitled to that information, yet it has not been provided.

Number two, when will this person be arrested regarding this unjustifiable murder, open murder, homicide? The next thing is where is this person



1	employed? Is he still employed? What's the status of
2	this person that continues to walk the streets of
3	Detroit among these citizens who are unaware that this
4	person took the life of somebody in this particular
5	city? And this somebody was listed as a John Doe. But
6	his name wasn't John Doe. His name was Jordan Burnell
7	West Morson, which was my nephew, an up and coming
8	rapper from the City of Detroit with an 18-track CD
9	ready to come out, a person that behind the scene
10	unbeknownst to you used to go to juvenile centers with
11	his father to mentor the juveniles as well as the prison
12	ministries, a 26-year-old kid that unfortunately didn't
13	make it to 27 June the 14th.

As of 8:05 yesterday, July the 1st, marks 60 days that nothing has been in my opinion moved forward. So, again, the questions that I am asking of this Commission and of Deputy Chief Tolbert as well is that we need to know this person's name under the Freedom of Information Act. We need to know where this person is employed. Is this person still working? We want to know why at the scene there was an officer who shared his concern at that moment about the shaky testimony given by this particular person in custody. And if that officer was unclear or uncertain about this testimony given by this particular shooter -- and I'd

1	like to call him a coward I would like to know why
2	did he release him if he had witnesses and information
3	that could have detained and remanded this particular
4	into custody.
5	CHAIRPERSON TAYLOR: All right, sir. I think
6	that we heard you last week or a week before last.
7	MR. MORSON: Yes, ma'am, you did.
8	CHAIRPERSON TAYLOR: And I know Commissioner
9	Warfield had asked for a report at this meeting that we
10	haven't had an opportunity to get yet because the
11	meeting is still going on. But, you know, I don't
12	understand, you know, understand the case. I don't know
13	the case. I'm going to turn this over to DC Tolbert.
14	DEPUTY CHIEF TOLBERT: Yes, ma'am. Through
15	the Chair, Mr. Morson, again, hello. After we talked, I
16	immediately talked to homicide and our special
17	assignment squad which handles shootings of this nature.
18	I talked with Inspector Dwayne Blackmon who is the head
19	of homicide. He informed me that he had actually had a
20	conversation with you prior to you coming here. He
21	or you maybe talked to Sergeant Davis. But there was
22	some communication. After I heard that, obviously there
23	was some issues about who was talking to who. So, I
24	think the best person to talk to you would have been
25	Inspector Blackmon. And I'm hearing this is the

1	first time I'm hearing that he did not call you because
2	he should have called you last week right after the
3	meeting on Thursday.

Understanding that, you know, obviously we had some change in leadership this past week. But I actually, since I saw you here, I text him to determine who — in fact was he coming. I think he thought the meeting was still on Thursday, that that's why he is not here. We all — the reason why I am late is because we were in a meeting with the new chief. And he is at that meeting. But I will ask him to come here. Now I have text him. And once hopefully before this is over with he will be here. And you and I and him will sit down, and we will have a conversation.

But to your question is, it's my understanding that a warrant package is being prepared, was prepared, and was submitted to the prosecutor's office last week.

If not -- and we will confirm that when we sit down with Inspector Blackmon. Understand this. Because we submit a warrant package does not mean it's going to be signed. And it has to be reviewed by the prosecutor's office.

That might take some time. I don't know.

MR. MORSON: Sure.

5 CHAIRPERSON TAYLOR: And I'm going to ask DC
6 Tolbert if you could just keep the Board informed of the
7 progress of the case.

8 DEPUTY CHIEF TOLBERT: Yes, ma'am.

CHAIRPERSON TAYLOR: Thank you.

MR. MORSON: Thank you all very much. And welcome and congratulations to you.

12 CHAIRPERSON TAYLOR: Thank you. Are there any other communications?

MS. ROMANO: Good afternoon. Anna Romano. DC Tolbert, I don't know if you can answer this question or not. But as a community, we have seen what a successful impact Nip-It has had in our community and our neighborhoods. Do you know if it's going to continue on through the summer months underneath this new chief?

DEPUTY CHIEF TOLBERT: As I just said, through the Chair, again, as I just said, we are just coming from a meeting with the chief with all the executives.

It's just our first meeting. He has absolutely expressed a desire and a need to continue aggressively enforcing crime. The model in which he will roll it



1	out, will it still remain Nip-It, I don't know. But
2	that process from what I can hear is going to continue.
3	And I just can't speak for the chief on how he's going
4	to roll it out. But he absolutely said a Nip-It type
5	operation would continue in the City of Detroit in order
6	to combat the crime issues that we have based on the
7	crime data that we have and deployment.
8	So, I would assume you shouldn't assume.
9	But based on the information I have heard, it appears to
10	me that there still will be some type of rapid
11	deployment that will be available for the crime patterns
12	that arise on a daily basis, and he is going to go
13	forward with that type of unit, which is the same thing
14	as what we do with Nip-It.
15	MS. ROMANO: Thank you.
16	CHAIRPERSON TAYLOR: At this time, I'd like to
17	acknowledge that Commissioner Tony Stewart has come in.
18	So, I'd just like to make that clear. Okay. Any more
19	communications?
20	MS. SMITH: Good afternoon, Bernice Smith,
21	political activist. I'll be very brief.
22	Congratulations to you, Chairman. It's wonderful to see
23	a woman sit up there. To you, DC, good seeing you
24	again. Time is coming for a change around here.



Anyway, what I'm going to ask you, will there be any

1	outlines that the chief spoke to you about, Chief
2	Tolbert, that we will be interested in knowing what he
3	is going to do with the precincts? I understand at one
4	time that the precincts will be opened again. And any
5	plans that you can tell us right now or later on, what
6	plans does he have for the precincts in the
7	neighborhoods?
8	DEPUTY CHIEF TOLBERT: As I said before,
9	through the Chair, there are absolutely some plans the
10	chief has. However, I'm going to let the chief make
11	those. But I'm sure you will be very receptive to what
12	the chief has planned. And we just had a brief meeting.
13	He mentioned some of the things, and they will be in
14	line with your frame of thinking as regards to the
15	precincts.
16	MS. SMITH: Also, there are other questions
17	that I want to present to him. Do you think he'll be at
18	the meeting that we are going to have at Focus Hope or
19	he is going to be at the following meeting? Do you know
20	that, what his program is or schedule?
21	DEPUTY CHIEF TOLBERT: Through the Chair, I
22	really don't know the chief's schedule. But I will make
23	a note that and I'm sure if he can get there, he'll
24	be there. He is absolutely one of the things he also

said -- Deputy Chief Turner is here. He is a big

1	proponent of police community services and community
2	policing. So, I envision that you're going to see a
3	lot of the chief out in the community. So, I don't
4	think that's
5	MS. SMITH: You mean at the meetings?
6	DEPUTY CHIEF TOLBERT: At the meetings and in
7	the community.
8	MS. SMITH: Because I'm looking forward to
9	asking him several questions.
10	DEPUTY CHIEF TOLBERT: I don't think you're
11	going to have a problem at all. It sounds like he's
12	doing to be very accessible.
13	MS. SMITH: Do you have a new number for the
14	headquarters as of yet, telephone number, sir?
15	DEPUTY CHIEF TOLBERT: The numbers are the
16	same.
17	MS. SMITH: Okay. Thank you.
18	CHAIRPERSON TAYLOR: Ms. Smith? Sergeant
19	Stevens?
20	SERGEANT STEVENS: Just to let you know, if
21	you have any questions, you can e-mail them to our pub
22	info, and we can forward them to the chief also. You
23	can forward your e-mail questions.
24	MS. SMITH: I might want to ask
25	CHAIRPERSON TAYLOR: Ms. Smith, and also the



1	Board is going to be working with the chief on community
2	things too.
3	MS. SMITH: Wonderful. More closely, right?
4	CHAIRPERSON TAYLOR: Yes, ma'am.
5	MS. SMITH: He will be at the meetings?
6	That's what we're looking forward to. We love you, DC.
7	But, you know, since he is coming in, he got to make
8	that money, you know, that 225. I'm oh, it's getting
9	to me. I can't understand that. But that's all right.
10	I will discuss it with him, not you, Stevens.
11	CHAIRPERSON TAYLOR: Yes, ma'am. Okay. Are
12	there any other communications?
13	MR. HASKA: I'd like to address the Board. My
14	name is William Haska, H-a-s-k-a. Approximately a month
15	ago I came before you because I have been getting
16	harassed, and someone is trying to extort money from me.
17	Well, it's still continuing. As of last night, I got 36
18	phone calls from this person, 13 texts from this person.
19	They burnt down the garage on one of my rental houses
20	that cost me \$8,000 to repair. And they're still
21	threatening to burn down my house and where I live.
22	Now, my girlfriend wants to move out of the
23	City. I have lived here since 1985. She wants to
24	leave. And I'm a New Yorker, and I want to fight. But
25	I don't like sleening with a shotgun every night I



1	have phone numbers from the person that's texting me and
2	calling me. I have been able to get no response from
3	the detective tracking down these phone numbers. I
4	don't know what we need to do. But if this person is
5	going to drive out another citizen of Detroit because
6	he and I say to her, so if I move, they're still
7	going to burn down my house. They're still going to
8	burn down my garage. They're still going to burn down
9	my rental properties. This has been going on since May
10	16. I have indigestion, I have hiccups. I have
11	anxiety. I have been going crazy for two months now.
12	Somehow this needs to be addressed. I don't know how.
13	Somehow this needs to be addressed because like I told
14	the detective, if I have to set up the meeting with this
15	individual, then you're going to be arresting me.
16	CHAIRPERSON TAYLOR: Okay. Let's listen to
17	what DC Tolbert has to say, and we will make sure that
18	something is done.
19	MR. HASKA: I don't know what we can do, but
20	this has been going on for two months.
21	DEPUTY CHIEF TOLBERT: Through the Chair,
22	Mr. Haska, from the last time we talked, no one has
23	contacted you?
24	MR. HASKA: I have spoken to the detective

once.

1	DEPUTY CHIEF TOLBERT: One of the things we
2	were able to determine from the information, just from
3	the information you gave me when I think I said this
4	last time, because of the knowledge of the person who is
5	doing this that they have, it's obvious that they know
6	you. So, there's some issues there. It's obvious that
7	when we have to get these this information on
8	telephones, it takes quite a bit of time to get that
9	because the places we send this, the way we process it,
10	there has to be a period of time before we can get that
11	information. Sometimes it's as long as six weeks to get
12	that. So, if they send that information out to try to
13	get information about the phones, it's going to take
14	some time.
15	But again, what I will do is, I will before
16	you get out of here, if you could talk to Sergeant
17	Harris and tell him again because I can't remember off
18	the top of my head who you talked to. I'll get with
19	them, and they will give you a call tomorrow.
20	MR. HASKA: Thank you very much.
21	CHAIRPERSON TAYLOR: Thank you. Any other
22	communications?
23	DEPUTY CHIEF TOLBERT: Madame Chairperson, I
24	have Inspector Dwayne Blackmon, and he can talk about
25	the case in which Mr. Morson was talking about. And



1	Mr. Morson, I don't know if you met him, Inspector
2	Blackmon. And he can bring the Board up to speed on
3	this investigation.
4	CHAIRPERSON TAYLOR: All right.
5	INSPECTOR BLACKMON: Good afternoon, Inspector
6	Dwayne Blackmon, homicide. And just so that you know,
7	to clarify some issues, our investigators have been in
8	constant communication with the Wayne County
9	prosecutor's office. We will be submitting a warrant as
10	early as probably tomorrow, no later than Wednesday.
11	And one of the things that we were we had to do is to
12	ensure that all the things that they were requiring us
13	to do were being done. And so, I'm not sure whether or
14	not, Mr. Morson, whether or not you know that or not.
15	Do you know if you had that information? Have you had
16	communication with the investigator?
17	MR. MORSON: About what again?
18	INSPECTOR BLACKMON: About the warrant being
19	issued.
20	MR. MORSON: No. This is the first I heard of
21	it.
22	MR. BLACKMON: We have been it's this
23	particular I think to give you just a small brief
24	history of what's the deal with this particular case, is
25	that this is a city employee. He is not a certified law



1	enforcement officer. He does not have the right to
2	carry a weapon by the State of Michigan. So, there are
3	some things that have to be taken care of. And there
4	are a lot of different other issues that they are
5	looking at to insure that they have the proper
6	information so that they can make decisions on what
7	charges are going to be levied if any.
8	CHAIRPERSON TAYLOR: Okay. And Mr. Morson, do
9	you have any questions for Inspector Blackmon?
10	MR. MORSON: I'm truly elated by you coming
11	first of all and sharing what you're sharing with us. I
12	mean, I'll share it back with my brother who this was
13	his only son and his mom, that what you guys shared
14	here today, that there's a warrant should be
15	forthcoming. And I will truly that's all we ask, you
16	know. I mean, if this was any of you guy's children,
17	you would be doing the some thing that we are doing.
18	So, I don't think I'm asking for anything out of the
19	ordinary but with the exception of this guy should be
20	behind bars. I don't care who he is, a badge or no
21	badge.
22	But at the same time, he openly killed my
23	nephew who was simply there with permission, sold his
24	CD's, 18 track CD coming out. There's just a loss. It



was a beacon of light in the community. And I truly

1	appreciate what it is that you guys doing. I truly
2	respect you guys in opening up your ears to even listen
3	to our concerns. So, this is all I'm here for.

4 CHAIRPERSON TAYLOR: Okay. That's -- I guess 5 that is all.

DEPUTY CHIEF TOLBERT: Inspector, can we talk about not just homicide but what's the process of how do we keep families informed because one time we were appointing a family representative. And what do we normally do on homicides because I know sometimes we got a lot of people asking about a singular homicide. And just can you go over this briefly?

INSPECTOR BLACKMON: Just on the investigative position, there should be a family point person that the investigator is communicating with in regards to the case. And in this particular case, I know I spoke with the mother and the father directly. And they do have my phone number.

And just on a lot of the cases, I am readily accessible for anyone who wants to call me. They have my number. They can call me at any time. I personally can talk to them because a lot of my investigators are not at their desk. Sometimes they are on the street doing investigations. But I'm always there inside the office. So, that's one of the ways that we can -- and I

Τ	can relay whatever information to the investigators.
2	But in the future, one of the thing that we
3	are trying to do is to get our Citizens Police Academy
4	personnel involved with that liaison. We've laid
5	together some type of foundation right now so that they
6	will have a method of communication. They can reach out
7	to these individuals, and they will be accessible for
8	them so that if they have questions and they can't get
9	in touch with an investigator, they can get in touch
10	with them, and they can in turn return that information
11	to the investigators. So, I do know that there is a
12	problem with the communication and sometimes lack of it
13	And that's one of the things that I'm trying to
14	establish at this point.
15	CHAIRPERSON TAYLOR: Thank you, Inspector
16	Blackmon. At this point, George, would we go back to
17	our finished business?
18	SECRETARY ANTHONY: Yes, ma'am. For the
19	record, George Anthony, Secretary to the Board. There
20	was one unfinished item left over from last week. It
21	was a suspension without pay recommendation from Chief
22	Logan and in regards to Police Officer Lawrence
23	Mitchell, Badge 1005. Commission Stewart was not here
24	last week. So, we need to register his decision on the
25	record.
