The 2013 monthly count of 21 complaints were 113 compared to the 2012 monthly count 22 23 of complaints at 135. So, it represents a 16 percent The year-to-date figures were 584 for 2013, 24 decrease. 25 674 for 2012. And that's a 13 percent decrease.

| 9  | communications at 6 percent. The 113 cases filed in      |  |  |  |
| 10 | June of 2013 involved 177 allegations where the leading  |  |  |  |
