 $\star$ 1 2 CHAIRPERSON TAYLOR: Good afternoon, I'm Jessica Taylor. And I'm joined by my co-partners, 3 4 Dr. Jerome Warfield and --5 COMMISSIONER WARFIELD: That's an honorary 6 degree. 7 CHAIRPERSON TAYLOR: And Commissioner Donnell 8 White, the vice chair. And at this time, we'll 9 introduce the Assistant Chief White. And, Mr. George, 10 would you introduce the rest of our staff. 11 MR. ANTHONY: Thank you, Madam Chair. For 12 the record, George Anthony, secretary to the board. We 13 have present Mr. Robert Brown who is our office manager 14 seated to the right. We also have recording our 15 proceedings Sergeant Alan Quinn and Ms. Trisha Houpt 16 from Hanson Court Reporting Service. That completes 17 the introduction. 18 CHAIRPERSON TAYLOR: I'm going to ask the pastor if he would give us a word of prayer. Oh, is 19 20 there a Chaplain? 8	Mr. Secretary? All those in favor for the agenda?
9	COMMISSIONERS: Aye.
10	CHAIRPERSON TAYLOR: All opposed? So
11	carried. Chairperson, are you ready to give the
12	report? We have no report?
13	MR. ANTHONY: Madam Chair, under the
14	secretary's report, we have three suspensions without
15	pay recommendations from the Chief of Police for Police
16	Officer Steven Townsend, Badge 4180; Police Officer
17	Steel Goss, B3065; and Police Officer Tony Goins, Badge
18	1051. Through their attorney they have requested
19	closed-door sessions, ma'am.
20	CHAIRPERSON TAYLOR: Okay. This is for the
21	chief. Do you have a presentation or report?
22	Assistant Chief White: No presentation.
23	This is the only report, the information on the
24	suspensions.
25	CHAIRPERSON TAYLOR: Okay. And no standing



committee reports. No new business. Under the old 1 2 business, I'm going to ask that the -- that we tell --3 commissioners, we have a discussion, the approval of 4 the revised standard operating procedures for the 5 office of the chief investigators -- office of chief 6 investigator. Is there a motion for that? So move. 7 MR. ANTHONY: COMMISSIONER WHITE: 8 Support. 9 CHAIRPERSON TAYLOR: It is moved and seconded 10 that we approve the revised standing operating 11 procedure for the office of the chief investigator. 12 Any discussion? 13 COMMISSIONER WARFIELD: Just for the record, 14 ma'am, unfortunately I have not had a chance to review 15 those so I will sustain. But I do want the vote to 16 continue. Abstain. I'm sorry. Abstain. 17 CHAIRPERSON TAYLOR: Okay. And I would have 18 the chief investigator -- could you come and give us an overview of the revision. 19 20 CHIEF INV. DAVIS DRAKE: Absolutely. Thank you, 21 Madam Chair. Good afternoon, Board. Pamela Davis 22 Drake, chief investigator, for the record. 23 Just to give you a little bit of a 24 background, during the quarterly monitor visits in 25 October 2012 and January of 2013, the OCI management



1 team, which included Monitor John Girvin from the federal monitoring team, along with all the supervisors 2 at OCI, myself, and at that time Attorney Celia Banks 3 4 Washington, reviewed the SOP for any revisions that may have been needed at that time. Largely it was just a 5 revision of some outdated information, some grammatical 6 7 type changes. But I'd like to bring three of those changes specifically to your attention. I can give you 8 9 pages, page numbers. You may not have the documents 10 right in front of you.

11 But I will tell you this, senior investigator 12 position was added. That was not added before. The title for the job description was in the original 13 document. The OCI progressive disciplinary action plan 14 15 was added. And also a summary investigation which is probably the most critical to our operations was added. 16 17 It was determined that in certain cases or certain types of cases we don't necessarily need to have 18 interviews with the officers if we already have 19 electronic evidence at our disposal. And that would be 20 21 tapes, videotapes, audio tapes that give us the 22 information that we need. That was the biggest change. 23 It is a practice that they're currently using in Oakland. The monitors actually brought it to our 24 25 attention. It would expedite case processing, and it



Page 7 1 would give the investigators an opportunity to close the case out and get the findings to the citizens more 2 3 quickly. 4 CHAIRPERSON TAYLOR: Okay. 5 CHIEF INV. DAVIS DRAKE: Are there any questions? COMMISSIONER WHITE: 6 None. 7 CHAIRPERSON TAYLOR: Any questions? Thank you. 8 9 CHIEF INV. DAVIS DRAKE: Thank you. 10 CHAIRPERSON TAYLOR: Okay. give your name and limit your comments to two minutes. 1 MS. STOKES: Okay. I'll just read it. Okay. 2 My name is Dorothy Stokes. I'm the mother of Jonathan 3 4 Michael Stokes who was murdered on July the 31st, 2013, at approximately 10:30. My son was murdered. My son's 5 6 murder took place on the south side of Seven Mile at 7 the corner of Weston Street in front of the old Don 8 Massey Cadillac building.

9 One of the most horrified things that can 10 happen to a mother is getting woke up by a phone call 11 in the middle of the night with one of her children 12 screaming a blood curdling scream that one of her 13 children had been murdered. It has shaken me to the 14 core. Me life has changed forever. There's been a 15 hole that can never be filled.

16 It is my understanding that Michael left the 17 home of an acquaintance with whom he had verbal 18 confrontation with. As my son was walking down Seven 19 Mile, three men drove up in a black SUV truck, and one 20 man produced a gun and shooted my son multiple times.

I have been in contact with Crime Stoppers in an effort to offer a reward for any information on the crime. I understand that there's a code of silence in the inner-city community, that some people may be afraid to speak up and do the right thing. Therefore,



1 my family and I are offering a \$30,000 cash reward for 2 any information leading to the arrest of the person or 3 persons responsible for my son being murdered. We have 4 placed posters directly on buildings where Michael was 5 murdered, and every other day we go back and check the 6 poster and they're gone. In particularly, the spot 7 exactly where he was murdered.

8 I want to know is it his murderer or his 9 acquaintance that are ruining the signs. Why can't 10 this area be surveillanced and the people responsible 11 for removing the sign investigated or interrogated.

12 I have had little contact with the detectives 13 that are supposed to be handling my son's case. I feel 14 angry, frustrated, and in unbelievable pain over what 15 has happened and what is being done. I am prayerful 16 that Michael will not be considered just another murder 17 in the city and he'll -- and we'll get to it when we 18 can type of attitude. My fear is that my son's case is sitting on some desk already collecting dust. 19

I am already feeling that if Michael's murder ever gets solved, it is only due to someone walking into the -- walking the evidence into the precinct, handing in the evidence -- I'm sorry. Handing the evidence to the detective. It's extremely difficult trying to work with the homicide department when you're

not informed of anything. I don't expect to know 1 information that will jeopardize the case, but it would 2 make significant difference if phone calls were 3 4 returned in a reasonable amount of time with reasonable updates. We have heard rumors and do not know if 5 6 they're true or what to do with the rumors. We need to feel that someone wants to listen to us. We need to 7 8 feel that Michael's murder is being handled as if it 9 were one of your son's.

10 CHAIRPERSON TAYLOR: Thank you, ma'am. And 11 first I want to say that we're so sorry for your loss. 12 And Assistant Chief, Deputy Chief --

13 ASSISTANT CHIEF WHITE: Yes. Ma'am, my son 14 was exactly -- my condolences to you and your family. 15 And I agree. I make no excuses for you not getting a 16 returned call. That's unacceptable. I'm going to 17 assure that you get in touch with a detective. I'm 18 going to give you the commanding officer of internal as well as the commanding officer of homicide to contact. 19 20 Sergeant Harris, could you please -- he's in 21 the back of the room. He's going to provide you with 22 the information that you need. 23 And also give her my number.

And if they don't call you back, please call my office.



1	MS. STOKES: Okay. If I get calls back, I
2	still don't know what's going on. I mean, I'm not
3	being communicated to at all.
4	ASSISTANT CHIEF WHITE: We're going to ensure
5	that you are. And if you are not, please give me a
6	call. But we're going to take you to or give you
7	the information that you need to get to the boss that
8	runs the shop. Okay?
9	MS. STOKES: Okay.
10	ASSISTANT CHIEF WHITE: And if they don't
11	satisfy your questions, please give me a call.
12	Obviously we can't jeopardize the investigation.
13	MS. STOKES: I understand.
14	ASSISTANT CHIEF WHITE: But giving you a
15	status update to where we are, that's a reasonable
16	request.
17	MS. STOKES: Okay.
18	ASSISTANT CHIEF WHITE: All right. Thank
19	you, ma'am.
20	MR. BLACKWELL: Good afternoon, Board. My
21	name is Charles Blackwell. I started the police
22	academy back in July, and I resigned within a week's
23	time of starting the police academy when it started
24	July the 22nd. About a week after resigning I had
25	submitted a letter of reinstatement. I understand that



5
the letter for reinstatement is a privilege, not a
guarantee. It has been a month since I have submitted
that reinstatement letter. I have called recruiting to
get a status update to see who is assigned to it. I
get told to not call, to wait for a phone call from
someone. I believe that my file will be the easiest
thing sitting on someone's desk since I was recently
finished through the process. And I'm left in the dark
really about the process now.
CHAIRPERSON TAYLOR: Sir.
ASSISTANT CHIEF WHITE: Again, through the
chair well, there's a multilayer issue hire. And I
really can't speak to it without having any information
in front of me with regards to your application.
What's interesting is that you were once in the
academy; is that correct?
MR. BLACKWELL: Yes, sir.
ASSISTANT CHIEF WHITE: And you resigned?
MR. BLACKWELL: Yes, sir.
ASSISTANT CHIEF WHITE: Well, there's a
process that we have to go through for reinstatement so
I don't know exactly where you are in that process.
But it's not the same as everyone else's process. It's
a little bit different. So when the sergeant comes
back in, I will have him give you the right person to



1 contact. In fact, the sergeant that was in the back of 2 the room that just walked out. I don't know if you saw 3 him.

4 MR. BLACKWELL: I didn't see him. 5 ASSISTANT CHIEF WHITE: When he comes back 6 in, he'll be at the back of the room. He works at recruiting so he's the person you need to talk to. 7 8 MR. BLACKWELL: Thank you, sir. 9 ASSISTANT CHIEF WHITE: All right. 10 CHAIRPERSON TAYLOR: Thank you. Are there 11 anymore comments? 12 MS. ROMANO: Good afternoon. Anna Romano. 13 This morning in eastern district and tomorrow morning 14 -- interim inspector Rochon is honoring the officers 15 with a breakfast for their hard work and dedication. 16 Also, on September 12th, interim inspector Rochon will 17 host a luncheon for safe routes for principals and 18 students and businesses. On September 4th, northeast 19 district is taking the seniors to the Detroit Zoo for 20 senior day for activities, train rides, silver

21 sneakers, different entities supplying information to 22 all the seniors.

Also, this morning there was a home invasion hostage situation in southwest Detroit. A job well done by all the officers and the special response time



1 in apprehending the three suspects. Thank you so much 2 for all your hard work and dedication to all the officers and a job well done. 3 4 CHAIRPERSON TAYLOR: Thank you. MS. ROMANO: And I wish everyone a safe 5 6 holiday weekend. 7 ASSISTANT CHIEF WHITE: Thank you. CHAIRPERSON TAYLOR: 8 Thank you. 9 COMMISSIONER WHITE: Thank you. 10 MS. 13 MS. SMITH: Uh-huh.

14 ASSISTANT CHIEF WHITE: We're starting --15 utilizing the data that we have based on crime trends 16 and patterns, we're focused on specific crime in 17 specific areas. But it is our intention to hit every 18 neighborhood with this information. But right now 19 we're being guided and directing resources based on the 20 crime trends. And we've got a high density of auto 21 thefts, for example. That's an area that we're looking 22 at deploying the HEAT strategy along with some other 23 stuff that I don't want to get into right now. Car 24 jackings, as well.

MS. SMITH: Yeah. That's the main thing what

1 I'm really interested in because so many people are 2 fearful because of the fact that they don't know whether they're going to be high jacking or not, like 3 4 the young lady of 16 years old the other day. She was 5 waiting for the mother to come out of the gas station. 6 She was, you know, told to get out of the car. So we're having such a high rate of crime as far as 7 8 jacking is concerned. People are constantly calling us 9 at the radio station and speaking about it. And I just 10 only tell them that you're doing the best you can and you are working on it. That's my response to them. 11 So 12 I just want to make sure that we take care of it and 13 get control of it because it's really getting out of 14 hand. 15 ASSISTANT CHIEF WHITE: We appreciate that. 16 And there are some strategies that we're deploying this

17 weekend, as a matter of fact.

18 MS. SMITH: All right.

ASSISTANT CHIEF WHITE: Again, I don't want to get into the intricacies. But we do need the public's help because people know who's in the neighborhood, who's doing what. And we just need you to feel confidence in calling the police and knowing that your information is not going to be shared with anyone.



1	MS. SMITH: Well, we thank you very much for
2	what you're doing. Take care.
3	MS. PANNELL: Sharon Pannell. I just want to
4	piggyback on her about the HEAT program. When are you
5	coming to the west side? We also have car jackings.
6	And everything that's going on on the east side, we
7	have it on the west side, too.
8	CHAIRPERSON TAYLOR: Okay.
9	ASSISTANT CHIEF WHITE: Through the chair
10	once again, we are on the west side with the program.
11	I think what you saw is the fact that we were out, the
12	media was there when we deployed the program on the
13	east side. But rest assured, anyplace, City of Detroit
14	or otherwise, you can call that number. The reward is
15	valid. If you have information on car theft, if you
16	have information on car jackings, it's available city
17	wide.
18	MS. PANNELL: Will you be distributing the
19	packages of the HEAT information to all the precincts?
20	ASSISTANT CHIEF WHITE: Yes. Yes.
21	MS. PANNELL: Okay.
22	ASSISTANT CHIEF WHITE: In fact, they should
23	already have it.
24	MS. PANNELL: Okay. Thank you.
25	ASSISTANT CHIEF WHITE: Yep.



1	MS. IRVIN: Good evening. My name is
2	Ms. Phyllis Irvin. And I have two concerns. One of
3	them is yesterday the state police came to my house and
4	searched my house without a warrant and they harassed
5	me and insisted that I give them my cellphone because
6	they were looking for my brother. And they didn't have
7	a warrant, and they really upset me and my little great
8	niece. And I also told them they asked who was my
9	little niece. I said this is my great niece. And I
10	told them who she was. I told them her father was a
11	sergeant. I don't know if you're familiar with
12	Sergeant Thomas Taylor. The police department? Thomas
13	Taylor? He's a sergeant. And, you know, I told you
14	know him?

15

### COMMISSIONER WHITE: Yes.

16 MS. IRVIN: I told him this is his daughter. 17 And they harassed her for his phone number. And they 18 insisted on getting my cellphone to get the number out 19 for my brother and for Officer Thomas Taylor. And I 20 told them I didn't have it because I wasn't giving them 21 my cellphone and I didn't have to. They didn't have a 22 search warrant. And they just harassed me. I didn't 23 have on many clothes and I told them, but they didn't 24 care.

CHAIRPERSON TAYLOR: I'm going to have you



1 talk with -- go ahead. 2 COMMISSIONER WHITE: Thank you, Madam Chair. Unfortunately, this body does not have jurisdiction 3 4 over MSP. However, I would be happy to share some 5 information with you in terms of how you can go before either --6 7 MS. IRVIN: I was informed by my pastor, 8 Reverend Holly, that I can come to this meeting and 9 express my concerns. 10 COMMISSIONER WHITE: Yeah. And we appreciate 11 that. And I wanted to 13 know who's taking charge and why haven't I heard 14 anything, why they haven't tried to contact me, not 15 once. You know, Detective Collins, he was my 16 detective. CHAIRPERSON TAYLOR: Okay. I'm going to ask 17 18 you, Chief, if you would get her information for me. 19 MS. IRVIN: Thank you. 20 CHAIRPERSON TAYLOR: You're welcome, ma'am. 21 MR. STIDHAM: Good afternoon, Madam Chair, 22 Assistant Chief, members of the commission. Tom Stidham. 23 I have two distinct issues to address the board today.

24 The first is I did over the last week reach out to 25 certain people of the administration concerning their

1 -- whether or not they could reach out to this body concerning trying to merge their body's respective 2 interests together to -- with respect to the towing. 3 Ι 4 just wondered, first of all, whether or not this body has received any response or efforts to reach out to. 5 And secondly, and this is -- secondly, I have some 6 clients that are -- this is unrelated to the first 7 8 But I have some clients that haul certain issue. 9 commercial loads to a certain location or locations in 10 the City of Detroit. And these clients are -- have 11 always partnered with the police to reduce crime in 12 their respective areas. Unfortunately, it's mushroomed 13 over a period of probably six to eight months with the 14 traffic enforcement officer who seems to be -- who is 15 very aggressively enforcing apparently city ordinances 16 around these businesses and it's affecting my clients. 17 And we've reached out to the command structure 18 previously to try and address those issues. Or if we could 22 seek some sort of moderation with respect to this 23 particular officer's enforcement. I'm happy to give 24 you his name and information.

So I -- I'll 7 8 need to understand exactly, you know, without getting 9 into specific detail as to what we're talking about. 10 You know, on the surface, it would be difficult for me to talk about relief to enforcing ordinances. 11

MR. STIDHAM: Well, I guess we believe it's becoming excessive. It's affecting all these people that are essentially law abiding citizens through this traffic enforcement officer, Officer Bragg's enforcement.

17 ASSISTANT CHIEF WHITE: Well, let's have a --18 let's have a discussion on this particular issue, if it's okay, outside of this body, just to find out 19 20 exactly what's going on. And we can bring you back 21 before the body. But, you know, certainly law enforcement is law enforcement and I couldn't, you 22 23 know, subscribe to anything that would suggest 24 otherwise.

15 Through their representative, DPOA attorney 16 John J. Goldpaugh, Officers Townsend, Goss, and Goins 17 have requested closed sessions for the purpose of 18 contesting the chief's suspension without pay recommendations. The closed session will be called 19 20 pursuant to MCL 15.268A of the Open Meetings Act, which 21 states in part a public body may meet in a closed 22 session to consider the suspension of or hear charges 23 brought against an employee. A simple majority vote or 24 quorum of three is required to close a session for this 25 purpose.
