I'm Commissioner Jessica Taylor, and I'm 7 joined with Commissioner Vice Chair Donnell White and 8 9 the past Chair, Jerome Warfield. And also joining us is 10 AC James White from the Chief's office. And George, can you introduce the rest of our 11 staff? 12 13 SECRETARY ANTHONY: Thank you, Madame Chair. COMMISSIONER WARFIELD: Let us pray. Father, we thank you once again for just your presence with us throughout this day and for getting us to this portion of our day. 1	CHAIRPERSON TAYLOR: The motion has been made
2	and supported to approve the minutes for the dates that
3	Commissioner White just said. So, if there is no
4	discussion, then the motion carries. Is there an OCI
5	report?
6	CHIEF INVESTIGATOR DAVIS DRAKE: There is,
7	Madame Chair. Good afternoon.
8	CHAIRPERSON TAYLOR: Good afternoon.
9	CHIEF INVESTIGATOR DAVIS DRAKE: I'm shuffling
10	too many papers here. Excuse me. All right. We
11	currently have our statistics as of today. I'm sorry.
12	Pamela Davis Drake for the record, chief investigator.
13	Currently our statistics as of today total 312 open
14	cases. 21 cases have been submitted pending closing,
15	and we have no cases over 90 days. There are currently
16	81 applications in for the position of police commission
17	investigator. As you know, Board, we have three
18	positions to fill.
19	I would like with the Board's permission to
20	start interviewing those people depending on your
21	schedules of course for next week and the subsequent
22	week. Of course, we'd like to get them up and running
23	as soon as possible. So, whatever the Board's pleasure,
24	I would like to get started.



Also, we have scheduled training sessions

1	coming up for all investigators. Conducting canvasses
2	will be held on this Friday. Tomorrow, at 10:00,
3	summary investigations and how to use those practically
4	will be also at 10:30 tomorrow. Effective time
5	management, we are looking at that training on
6	Wednesday, November 13th, at 10:00 a.m. And the OCI
7	administration retreat tentatively is for Friday,
8	December 13th.
9	As you all know, the RFP process for the
10	renovations for the Merrill Plaissance location is under
11	way. We have been OCI has been very involved in
12	that. I had an opportunity along with
13	Commissioner Taylor and Mr. Anthony and a couple of the
14	supervisors to go look at the property. From what the
15	scope of services detailed, it looks like that they will
16	do exactly what we need them to do. And it will be a
17	very nice location once it's completed. So, I
18	appreciate their assistance and also the assistance of
19	DPD for keeping us involved and keeping us abreast of
20	what's going on. We very much appreciate that.
21	As you know, OCI believes in giving back to
22	the community. And as a result of that, our 2013
23	strategic plan clearly outlines that we will develop a

community outreach committee. We have done so. Our

first project for the committee will be a canned food

1	drive. You all do I believe have copies of a flyer in
2	your packets. We are going to be hopefully donating
3	enough food for ten baskets for needy families in the
4	community.
5	We want to get those out prior to the
6	Thanksgiving holiday. And we're looking at turkeys, all
7	canned goods, non-perishable items. So, of course
8	you're welcome to provide any canned goods or
9	non-perishable items that you would like. It's a team
10	effort. We kind of did it as a competition so that it
11	will be more fun for the staff. The team that donates
12	the most will get a prize. That completes my report.
13	Are there any questions?
14	CHAIRPERSON TAYLOR: Thank you.
15	CHIEF INVESTIGATOR DAVIS DRAKE: Thank you,
16	Madame Chair.
17	CHAIRPERSON TAYLOR: AC White, is there a
18	report or presentation from the Chief's office?
19	ASSISTANT CHIEF WHITE: There is no report.
20	We do have a couple of policies that Captain Bliss will
21	be speaking to. And I have a followup from two meetings
22	ago where a couple questions were posed regarding the
23	scout cars. I'd like to there was two questions.
24	The first question was what funding was being used for
25	the new scout cars



1	And I'm paraphrasing somewhat. I don't
2	remember specifically the terminology that was used.
3	But in general, that's the question. The Chargers that
4	we are receiving is part of a 2009 JAG grant. And those
5	vehicles will be owned and maintained by the police
6	department and follow all the practices and procedures
7	of any vehicle that's owned by the police department.
8	Those vehicles will not have the wrap on them. They
9	will have the more traditional logo on those vehicles.
10	There's a total of 50, 10 of which will be assigned to
11	traffic enforcement; and the remaining 40 will go to
12	patrol, particularly special operations.
13	Then there's the vehicles that are under the
14	Penske Group. And that's the vehicles that have that
15	big wrap on them with the markings, the pictures on
16	them. And the question on that was what happens if
17	there's damage to that vehicle and who pays for the
18	damages. The damages to the vehicle are paid for by the
19	city like any other patrol vehicle. However, the wrap
20	itself will be provided by the Penske Group.
21	CHAIRPERSON TAYLOR: Does that conclude your
22	report? Commissioner Warfield?
23	COMMISSIONER WARFIELD: You said the wrap
24	would be covered by the Penske Group. But what about

25

maintenance? I remember hearing at the initial press

1	conference that maintenance for those cars was going to
2	be taken care of by the Penske Group. Has that changed?
3	ASSISTANT CHIEF WHITE: I don't remember that
4	being stated at the press conference. It was always my
5	understanding that we would handle maintenance.
6	COMMISSIONER WARFIELD: Okay.
7	ASSISTANT CHIEF WHITE: That is in fact what I
8	found out, and it was confirmed that we would handle
9	maintenance.
10	COMMISSIONER WARFIELD: Thank you, sir.
11	COMMISSIONER WHITE: Thank you, Madame Chief.
12	Assistant Chief, with the Penske Group, the number of
13	cars, I heard you say 50 of the Chargers were from the
14	2009 JAG grant. What are the number of cars to that
15	relationship?
16	ASSISTANT CHIEF WHITE: The Penske Group cars,
17	I believe there are 100 Penske Group vehicles. And the
18	delivery schedule, we are roughly averaging around 10 to
19	15 a month that are being completely outfitted and put
20	in the field.
21	CHAIRPERSON TAYLOR: Okay. Commissioner
22	Warfield has
23	COMMISSIONER WHITE: Also, thank you, Madame
24	Chair. And also as with the Chargers, you noted that
25	they are owned and maintained by DPD. As relates to the



1	100 cars via the Penske Group, the ownership?
2	ASSISTANT CHIEF WHITE: Yes. The ownership is
3	the Detroit Police Department. It's a donation.
4	However, there is an agreement that for a period of
5	time and I apologize, I don't know what the precise
6	period of time that any damages to the vehicles are
7	reported to the Penske Group. And so, if there's an
8	accident, you would notify Penske that there's an
9	accident. You would repair the vehicle, and then you
10	would send it to them to have the wrap reinstalled on
11	it.
12	COMMISSIONER WHITE: But ownership resides
13	with the department?
14	ASSISTANT CHIEF WHITE: That's correct.
15	COMMISSIONER WHITE: Thank you, sir. Thank
16	you, Madame Chair.
17	CHAIRPERSON TAYLOR: Commissioner Warfield?
18	COMMISSIONER WARFIELD: This is on the same
19	but also somewhat different matter, Assistant Chief.
20	And thank you for the update regarding the equipping of
21	these vehicles with video and with mics because we know
22	that all of them are non thank you for the schedule
23	there. However, we also note that there are some 30
24	series cars that are still not equipped. And the reason
2.5	that I bring that up is because when our investigators



1	receive reports from citizens or complaints from
2	citizens regarding alleged impropriety on behalf of some
3	of the 30 series officers, there is not a good way for
4	the investigators to look to see if there's video, audio
5	that could help, you know, exonerate the officers or,
6	you know, help the citizens.
7	ASSISTANT CHIEF WHITE: Yes, sir.
8	COMMISSIONER WARFIELD? Can they expect that
9	in the future and when?
10	ASSISTANT CHIEF WHITE: Yes, sir. The 30
11	series vehicles will be the new Chargers that we are
12	replacing. We are replacing the old Crown Vics.
13	Unfortunately, what happened with the old Crown Vics is
14	that it didn't make we had the old video audio system
15	in the 30 series vehicles. Those vehicles are I
16	think that fleet is '06-'07. It's very hold. Lot of
17	models on those cars. And it didn't make sense to put
18	the new system in an old vehicle that you'd have to take
19	it out of when you got the new vehicles.
20	So, consequently, we have a lot of system
21	failures with audio video in the 30 series vehicles.
22	The new vehicles, when they roll out, those vehicles
23	will be equipped with the new audio video system.
24	COMMISSIONER WARFIELD: Good. Thank you, sir.



Thank you. Ma'am.

1	CHAIRPERSON TAYLOR: There is no standing
2	committee reports, no new business. Do you have
3	COMMISSIONER WARFIELD: Under standing
4	committee I'm sorry, under report, the last a few
5	meetings ago, the attorney for one of the towers groups
6	came and inquired about ABAN tows and the fact that
7	contracts had been signed to tow ABAN's. And those
8	that opportunity was not given out to all of the towers,
9	was not afforded to all of the towers.
10	I have since met with the director of parking,
11	Norm White. And he scheduled a meeting with the
12	representative from the DATA Group, from Tom Stidham's
13	group, that we may come together to resolve the issue.
14	And he is interested in opening up again those contracts
15	so that everybody who wants to tow ABAN's can do that,
16	plus we can talk about we will talk about rather
17	towing in Detroit as relates to how we get it done
18	effectively and efficiently and the possibility of
19	looking at a management system, putting a management
20	system in place. So, that will take place on Wednesday,
21	the 6th, at 1:30 in Mr. Norm White's office. And the
22	towers have been notified.
23	CHAIRPERSON TAYLOR: Okay. Thank you. Do you
24	have any questions?



COMMISSIONER WHITE: No, ma'am.

1	CHAIRPERSON TAYLOR: Okay. Under old
2	business, we have Directives that have been out there
3	for a while. Mr. Secretary?
4	SECRETARY ANTHONY: Thank you, Madame Chair.
5	We have three Directives that have been published, I
6	think probably two of them since April and the last one
7	at least for the last month and a half. The Directives
8	are 203.4, Missing or Lost Persons; Directive 204.1,
9	Crash Investigations; and Directive 202.2, Search and
10	Seizure. And I see Captain Bliss is at the podium.
11	CAPTAIN BLISS: Yes, Commissioners, Assistant
12	Chief White, Captain Bliss from training. These three
13	have been out for quite some time. We have been going
14	back and looking and seeing if there's been any public
15	comments. To my knowledge, there has not been any. But
16	that being said, I'll just give you a quick synopsis of
17	each of them. I know that the presentation was already
18	done. But because they've been out there, I just want
19	to refresh everybody's memory on them.
20	The 203.4, the Missing or Lost Persons, it was
21	revised to include the new way that we report missings.
22	We now report them through the CRISNET System. It was
23	something that was done a while back. But we are now
24	making sure that it's in the policy. And of course we
25	have updated the definitions and the procedures for

1 doing that.

The second one, 204.1, Crash Investigation, it
used to be termed Traffic Crash Investigation. We have
added definitions. And one of the units that's primary
responsibility was to investigate fatal crashes has now
been absorbed into the homicide section. And critical
injuries, industrial accidents, airplane accidents, we
have now included those in the Directive. Some time ago
in the policy section, they were mentioned; but there
was really no procedures. We have made those changes.
Also, the department has a computerized traffic accident
crash system that we now use instead of the paper
UD-10's, which is the state way, for a traffic crash.
We have incorporated that in here also and the
responsibilities for a supervisor to check and update
and approve those type of reports.

The last one, 202.2, Search and Seizure, basically that Directive when we did it was in concert with at the time our legal advisor, former Deputy Chief Falvo. Basically, we updated it to all the constitutional rights that a person has. We talk about the types of stops, the informational stops, what you can, what you cannot do. Stop and frisk, we clearly indicate what you're allowed to do constitutionally and what you cannot do.

1	We also talk about vehicle searches and really
2	kind of spell it out for the officer. And it's an
3	update. Everything that we have here is just based on
4	the current law and what an officer can constitutionally
5	do. It's nothing new. It's just making sure that we
6	are all on the same page and that it's updated to
7	reflect such.
8	CHAIRPERSON TAYLOR: Is there any questions?
9	COMMISSIONER WHITE: A couple quick questions,
10	Madame Chair. Thank you, Captain Bliss. My question
11	is and I have a comment for Captain Bliss. But my
12	question is for Secretary Anthony. Mr. Anthony, I know
13	there were some questions particularly as it relates to
14	Directive 202.2, the Search and Seizure, as related to
15	the uniformity of the definitions, surrounded by a
16	number of the different paragraphs. Are you comfortable
17	that those issues have been resolved?
18	SECRETARY ANTHONY: Those issues have been
19	clarified, and I am satisfied, sir, yes.
20	COMMISSIONER WHITE: Thank you, sir. And,
21	Captain Bliss, I just want to commend you. I think the
22	Directive on search and seizure, the way it was written
23	from an instructional standpoint, particularly the

sections that speak to what you can and cannot do, the

do's and don'ts, I think that was very helpful and will

1	help in clarifying some of the things for members of the
2	department. So, I just wanted to commend you and those
3	that had a hand in adding that component.
4	CAPTAIN BLISS: Thank you, sir.
5	COMMISSIONER WHITE: Thank you, Madame Chair.
6	CHAIRPERSON TAYLOR: Any other questions?
7	COMMISSIONER WARFIELD: Just have one. Just
8	for the public's sake because I think it's probably
9	and this is just the laws probably across the country
10	could you help us or help the public understand because
11	there's a section in there that says if it looks like
12	you're about to commit a crime or if it looks like you
13	have committed a crime, that they can stop you. What is
14	that look, for those of us who just have no idea?
15	CAPTAIN BLISS: Well, you know, basically
16	where that and again, where it stems from is
17	basically the Terry stop. And as an officer, what
18	you're looking for is what is out of place. And that
19	comes through experience. That comes through time on
20	the job, being involved. It's not something that an
21	outsider who is not involved in law enforcement can
22	really articulate.
23	But a seasoned officer can make those
24	articulations based on experience. And the courts have
25	ruled in their favor based on their experience. But

again, it is something where based on the initial case		
for Terry, a person is walking back and forth in front		
of a store front. And then he stops and looks and then		
goes back again, stops and looks. A normal person who		
is just walking by a store front wouldn't do they		
wouldn't have that type of curiosity. But being a		
seasoned officer and being able to articulate that		
and what we train on is being able to not only identify		
that, but you have to be able to explain it.		

I have to be able to stand like I am today and look at you and explain what separates that from being normal. And that's where the experience, paying close attention to what you're doing and being able to say a normal person in my experience, from my experienced point of view, would not do that or how if a person is carrying a weapon, how they would maybe, you know, have a draped hand or how they would shift their body. That takes years. It takes time to be able to identify that.

It's very rare that for instance a new recruit comes out and just knows. It takes time. So, that being said, when we say it looks like they are about to commit or they have just committed, certain demeanors, certain gestures, certain expressions. Again, it's not illegal for me to say, excuse me, sir, can I talk to you for a second? But maybe some of the things, how you

respond to me collectively with other things that I have pointed out in my mind can be taken as such, something must have happened or could have happened.

But again, what's important is the articulation. And that really -- I mean, it can't be not stressed enough is being able to articulate. And as I have told officers, what can you do when you look at somebody, how do you separate that from a normal person, from a normal person just walking by that shop, what separates that? So, it's hard to define. It is. And I wish I could give you a very clear way. But then I think I would be limiting it.

ASSISTANT CHIEF WHITE: If I may through the Chair respond a little more on that. I just want to make sure that we clarify that that doesn't give you carte blanche, however, to search and to -- I mean, there are other factors, not just the initial stop. So, when we talk about -- I think the actual term that's used in Terry is, "Crime is afoot." So, how that would be defined is I get a dispatch run to, you know, 1301 Third. And out front, there's a white male in a suit and a dark tie with a crow bar, okay? And when I pull up, there's a white male matching that description walking away with say a crow bar. And then I look over, and the window is broken. Crime is potentially afoot.

1	So, now, I can say, sir, can I talk to you for
2	a minute? The fact that you have the crow bar, I can
3	say, sir, you need to drop the crow bar. I need to
4	speak with you for a moment. So, it builds on itself.
5	It's not simply, you know, I drive up the street and
6	where there's obviously abandoned homes and broken
7	windows. And I pick the first guy I see and say, hey,
8	stop you know. And if he doesn't stop, I throw him on
9	the ground and pat him down. That's not the intent of
10	Terry, nor is that the intent of this policy.
11	COMMISSIONER WARFIELD: Thank you, AC.
12	Through the Chair, thank you, AC, for that clarification
13	because here is my concern. And I'll just give you two
14	instances real quick. I was driving down Fenkell on my
15	way to the church a few weeks ago. Saw a guy on the
16	side of a house, looked like he was at the window. Saw
17	a lady coming out of her porch going towards the side of
18	the house. Turned around, and I asked her if she needed
19	help because it seemed like that was a situation that
20	crime may have been afoot.
21	However, I have also seen gangs or, I'm sorry,
22	groups of young people walking together maybe with
23	sagging pants and T shirts walking down the street. And
24	so, without any description coming over the radio
25	channel saying look out for these people, can they

1	legally be stopped?
2	CAPTAIN BLISS: No, sir.
3	COMMISSIONER WARFIELD: And I guess that's
4	where for us and for the public the rubber meets the
5	road is that there and I know it's a bunch of gray
6	area. And I understand the gray area. But there has to
7	be some type of lines of demarcation where a young
8	person and we had a case on this, two young people
9	walking down I think it was if it wasn't Chalmers, it
10	was Harper at 12 midnight walking down the street
11	minding their business, was stopped; and a whole bunch
12	of other extra stuff happened as a result.
13	And those are the cases I think we have to be
14	really careful when I mean, we don't want to stop the
15	police or handcuff the police in protecting the
16	citizens. Please understand that. But at the same
17	time, we don't want to be a New York.
18	ASSISTANT CHIEF WHITE: Absolutely. And our
19	position is that we are not a New York and that we
20	certainly consider the rights of the community. If I
21	may, because this is such a sensitive issue for so many,
22	using the scenario you gave, the first one, a police
23	officer who is driving up the street. And this has
24	happened. It's happened to me. And when a person sees



the shadow of your car, they start walking from the side

1	of the house. I will stop them. Am I going to pat them
2	down? No. But I'm going to stop them to engage them in
3	conversation to gauge their reaction to walking from the
4	side of the house.

Frankly, it could be their house, but I don't know. They may have walked away because they saw a police car. Now, that conversation is, you know, hey, how's it going? What's going on? Nothing. You live around here, that type of thing. It builds on itself. Now, in that particular case I'm citing, I say how is it going. He says it's going okay and took off running. So now, you know, I'm going to chase him. And it builds on itself.

And then the other scenario about the group of young people walking up the street, there's no prohibition for a group of people to walk up the street unless we are under curfew or unless we have a description that a group of young people of any race had just committed a crime or done something illegal and we are looking for them. But simply walking up the street when we are not under the emergency curfew, it's not a problem.

Now, we do have an ordinance -- one last thing. We do have an ordinance, walking in the street where a sidewalk is provided. And that ordinance is

1	investigated. But we do monitor that ordinance for
2	abuse because it is a catch 22. We recognize that. But
3	we do monitor it.
4	CAPTAIN BLISS: Again, this Directive is
5	really based upon the current state and federal law.
6	So, it's clearly defined for constitutional type
7	policing.
8	CHAIRPERSON TAYLOR: Okay. Thank you.
9	George, did you have something?
10	SECRETARY ANTHONY: No. I think Captain Bliss
11	just hit upon it. The Directive does meet the legal
12	standards of federal and state law. And I think that's
13	what the Board is looking at is whether that standard is
14	met within this policy.
15	CHAIRPERSON TAYLOR: Okay.
16	COMMISSIONER WHITE: Madame Chair, I would
17	just add and not to belabor the point. But I do
18	think this issue warrants such deliberation, there is a
19	need for articulable suspicion. The chief has already
20	went on the record and said we would prosecute those
21	that violate it, the Constitution. But we would not
22	handcuff those who are following the Constitution. And
23	I understand his vantage point as well.
24	With the Directive and through the Chair to

the assistant chief, I think herein lies an opportunity

1	for us to showcase our world class training and
2	department by going a step further beyond just the
3	release of a new Directive to our members and doing more
4	information both with members and community wide so that
5	we are covering our bases. We are educating the public,
6	we are educating members. And I think it could be
7	beneficial to both sides.
8	And so, beyond our normal release of a new
9	Directive to a teletype or whatever it may be, I think
10	herein lies an opportunity for us to go above and beyond
11	given what we have seen across the country surrounding
12	this particular issue. Thank you, Madame Chair.
13	CHAIRPERSON TAYLOR: Okay. Thank you. The
14	Chair will entertain a motion to approve of the
15	Directive 203.4. And before I go on, Mr. Secretary,
16	should the Board actually should do you want to do
17	these collectively?
18	SECRETARY ANTHONY: I think it's the Board's
19	wishes whether they would like to entertain each of
20	these separately or if they can be dispatched
21	collectively.
22	COMMISSIONER WHITE: As a recommendation,

some specifics that I think we need to be concerned
about. As Commissioner White so eloquently put it, the
Charter gives us the mandate to operate in the positions
that we have. We all lifted our hands and swore to
uphold the Charter. And so, we believe that that is our
mandate, that is the basis in which we operate.

It is somewhat disheartening when this Board is not even given the opportunity as a Board to hear and to review those who are wishing to be promoted and/or appointed, even as it relates to the hiring and firing of our own personnel director, who by Charter is hired and/or dismissed from duty by this Board. And so, I will go again and seek further clarification from the emergency manager or whomever as to why these infringes upon the power of this Board as relates to the city Charter have taken place because this Board has not fought against the change.

We have always sought to work with the administrations of the Detroit Police Department and with the citizens of the city of Detroit. And we believe that we have done a very effective job in doing that. Truth of the matter is one of the reasons we have a new Chief of Police is because this Board fought through the Charter to make sure that process happened when others were delaying the process. And so, it's --

1	you know, for Boards to come, for people who serve on
2	this Board after we are long gone, it's important that
3	we uphold the integrity of the Charter process so that
4	the citizens' wishes and dictates as voted on by the
5	citizenry are carried out in a way that they expect it
6	to be carried out.

The other thing is in terms of the search and seizure, I know that Mark Fancher (phonetic) of the ACLU as part of a coalition that we have been involved in, has asked this body and asked the police department to provide via FOIA, information regarding the stops which have occurred and are occurring in relationship to search and seizure. Plus, we have also given him some of the information regarding the cases in which we've been involved to see whether or not the matters that are occurring are in fact constitutional as articulated or

as specified in this document because I think it's one
thing to say that. It is another thing in terms of
qualitatively what actually happens when stops are
occurring.

I don't want to go over the litany of horror stories. But I think that there is some need for questions to be raised because I think it's sort of sanitized in terms of the question of just constitutionality because things can — as I think one of the commissioners said, can go wrong very quickly. And when they do, it's hard to deescalate, de-accelerate that process. And usually there are some challenges that are involved.

So, I think we need to make sure that the ACLU gets that information that they have requested so we can actually see how the policy is being implemented and what the understanding is because when some of us appeared before the COMSTAT (phonetic) program, we only had a few minutes to actually respond to this. So, maybe it would be good to have another meeting, once we see how this is going, to have the chief and representatives report back to this body as to the kind of stops that has occurred and what is being done. I think that would be a reasonable reflection of the research as opposed to, you know, just the policy in and

1	of itself.
2	And just finally, I'm glad that you're
3	continuing to focus on the towing. I think that has
4	been the bane of the existence. Once again, I want to
5	compliment the members of this body because it would
6	have been easy for you for step away from that. I think
7	it needs to be resolved as quickly as possible. So,

18	week for towing or for the Detroit towers.
19	We have learned a couple significant things
20	that I'm not sure I wanted to share with the Board, and
21	one of which the first of which is that it came to
22	light that earlier this week there was a hearing before
23	the Detroit Board of Zoning Appeals on a petition filed
24	by the Municipal Parking Department. And that petition
25	sought to legalize the use at the Caniff Number One

Pound because and it came out through the hearing,
the city or Municipal Parking acknowledged that the use
was not technically legal. And they have been utilizing
that yard for quite some time, obviously, I believe
since December 17 of last year, Municipal Parking has.
That no decision was rendered that date and the matter
has been taken under advisement by the Board of Zoning
Appeals.

Also, in order -- also, the second item that came before the Public Health and Safety Standing

Committee on Monday of this week was a request for an expenditure of \$500,000 to remodel and provide upgrades to the Caniff towing yard. And I know I was there,

Reverend Warfield, you were there in those meetings when we talked about the framework by which the \$75 administrative fee would be imposed. And it has been.

And my understanding from all those meetings over months and months and months was that those funds were going to be used by the police department to offset administrative costs related to towing by the police department, not by Municipal Parking or any other agency in the city.

And certainly, what came to light before the city council was that -- at subcommittee rather was that these approximately I think he said somewhere between

2.1

six and \$700,000 in a fund somewhere presumably, I mean,
I believe being held by Municipal Parking, which
represents the \$75 administrative fee. And they are
purporting to use that money, that pot of money, to fund
upgrades to the Number One Towing Yard.

Certainly, that doesn't offset the cost of the towing because as they admittedly admitted at the hearing that that yard right now is being used to house first ABANS from the police department; and secondly, boot and tow tows from Municipal Parking which have nothing to do with police towing. So, we are kind of on a crash course now. And we certainly would welcome the Board's input and assistance.

I know you mentioned a conference with Mr. White that's upcoming. Again, this ought to be put on the agenda. And I know that, Chief, the media has been buzzing also about the story asking how can the city spend all this money on a piece of property when, you know, certainly this money could be used to fund I believe five or six more police officers.

So, again, I would ask that the police administration revisit that matter as well. You can save a lot of money and put some more officers on the street simply by allowing the towers to take their vehicles back to their yards on the ABAN's. And so,



1	having said that, again, I'm sorry.
2	COMMISSIONER WARFIELD: I will let you finish.
3	MR. STIDHAM: Having said that, I'd again ask
4	this body to assist us, the towers, and also the
5	administration to take a hard look at the policy in
6	effect right now or how it's being implemented because
7	we believe that we can put some more office on the
8	street or offset the cost of the towing and still take
9	the cars back to our yards, save the city some money.
10	CHAIRPERSON TAYLOR: Commissioner Warfield?
11	COMMISSIONER WARFIELD: First of all, Tom,
12	thanks for updating us. Did not know of all these
13	issues. It's interesting and just astonishing to me
14	that we are towing cars to a lot that is not even
15	legally zoned. That is just I mean, and considering
16	the fact that there are cars who have come up missing ir
17	that lot, stolen out of that lot. Just puts the city at
18	further liability as relates to first of all, you're
19	towing cars to a lot that it's not even zoned properly
20	in the first place.
21	We took our towers through a massive zoning
22	process to make sure that they spent literally
23	collectively millions of dollars to update their lots to
24	make sure they comported to every condition of the
25	city's zoning ordinances. And this is what geared to

me, when councilman at the time Gary Brown made this
comment that there is shady stuff going on with towing.
This is what we were trying to point out to him, that
opening up that lot for this purpose, these things would
just be revealed.

And so, now to take a half a million dollars that should be going directly back to the police department for fighting crime in this city is now going to -- now is proposed to be spent on fixing up an illegal lot, it's just unconscionable. It's like, who is in charge, and who is still doing this stuff? We know it's not the chief. We know it's not the police side. So, who is it downtown that's allowing this type of crazy stuff still to go on? And what back room -- and I'll say it on the record. MR. STIDHAM: In fact, Reverend, about three
weeks ago there was an article in the Detroit News about
the Number One Pound and featured chief operating
officer Gary Brown. And he was lamenting in the article
about how the very problems, stolen cars, missing parts,
poor lighting, inadequate security, all of those items
he talked about or discussed in that article.

COMMISSIONER WARFIELD: So, we'll deal with it. We will keep fighting the good fight of faith, and we will keep moving this forward. But, I mean, this is just ridiculous. So, certainly I know you got the notice about the meeting next week, that you will be there to represent your towers as well. But this will definitely be on the agenda. Thank you, sir.

MR. STIDHAM: Just one final operational matter. Chief, I don't know if you saw that article in the Detroit News. I think the Chair saw it. I know I gave it to the Chair. But at or within that article, Mr. Brown mentioned that he wanted to take and remove over 2,000 cars off from the streets, abandoned vehicles, but he couldn't do it 'cause he didn't have any place to take them. And I can just offer on behalf of my clients anyways, we have the room. And collectively, we have over 2,000 spaces. You can take

documentation for you guys for the record of everything
that has happened in the last week for your information
as far as advertisements that were done for the 5997
address of Caniff, which has always been advertised as
6311 Caniff because of a building apparently that was
found on the property because when we were looking for
6311 Caniff, nothing was popping up. And we were kind
of curious why was this happening.

So, I actually went to the zoning hearing on Tuesday. And when I questioned the zoning person who is in charge of — that was handling the meeting was Tony Stapleton as well as James Canty who is in charge of municipal parking as far as the zoning laws and everything, they indicated the property was zoned vacant property and has been for all these years. And I asked them, you know, when did they put this application in. They indicated in May of 2013.

Well, one of the requirements that all of the towers when you guys put in place was that we had to have these zoning documentations in place, as well as other things that we have been doing diligently for several years. As business owners, as tax dollar

payers, we have done our job and our due diligence	for
conducting business the proper way in the city of	
Detroit and followed all the city guidelines, every	thing
that you guys have put in place as well as the poli	се
department as well as zoning clearances.	

And the part that I don't understand is in the past three years, one of our towing members was actually disqualified for not having their zoning in place for a period of time, not to mention other towers that were applying and could not be current towers due to the fact they didn't have their zoning ordinance in place.

So, not only does the city not abide by certain rules, the police department is allowing this to happen because Management Services went to every single facility, including our facilities, and looked at all the different yards to make sure that we were all compliant. So, if we are willing and able and doing everything properly, how does the city of Detroit and Management Services allow a lot that is now being operated by Municipal Parking — under the guidelines, if we have to follow those guidelines, apparently they're doing business in the city of Detroit, they have to — they should be abiding by those same guidelines.

So, to state that if a current tower was disqualified and either all the cars had to have been

either, A, moved or stopped towing, then that shouldn't
have gotten the same effect. So, my question to the
zoning person was, if this has already happened to a
current tower in the past three years, why isn't it
happening with Municipal Parking? And she indicated to
me that she could not enforce it. She was not the

do so. And I said, well, six months ago the police
department went around to different businesses and
actually padlocked businesses that were not in
compliance. So, how is that not being in compliance?

continue doing business there. We have been doing
business there, and we will continue doing business
there. The city of Detroit needs to make money. The

police department needs to make money.

So, with saying that, if we're going to sit
there and have six or \$700,000 sitting in an account
that's going to qualify for officers and I believe it
was city department cars as well as any officer
assisting program, that's what we all agreed to do, not
to have a building being brought up to code at our
expense, our tax dollars, being spent for a building
that is unnecessary because all of us towers have an
adequate amount of parking in all of our facilities.

I currently own seven acres a mile and a half away from where the facility is at. And I'm only one tower. So, we have ample amount of ABAN storage to be towed. So, how does somebody perform for the last six months, not get paid for services they have already done and waiting for the city of Detroit to pay them? If I


