1	I am going to have the Secretary Report
2	first.
3	SECRETARY ANTHONY: The Secretary's Report is
4	citizen complaints received May 2014.
5	The monthly count of complaints for May was
6	131, compared to May of 2013, at 130; represents a
7	1 percent increase.
8	The year-to-date figure through May 2014 is
9	586. Year-to-date for 2013, as a comparison, is 475;
10	this represents a 23 percent increase.
11	At the end of May 2014, the Office of the
12	Chief Investigator had open investigations, 276; cases
13	filed, 586; cases closed, 584.
14	Of the 131 cases filed, 37 percent involved
15	unknown officers. The alleged known units involved:
16	Leading in complaints filed in May of 2014, were the
17	8th precinct, at 8 percent; the 9th precinct, at
18	8 percent; and Communications at 7 percent.
19	The 131 cases filed in May of 2014 involved
20	269 allegations, where the leading areas of concern
21	were procedure, at 33 percent; demeanor at 26 percent;
22	service at 10 percent; and property at 7 percent.
23	Closed complaints: There were 140 citizen
24	complaints that were closed in May of 2014. And those
25	complaints involved 287 allegations where the findings



Page 7 were not sustained at 49 percent; unfounded at 1 2 16 percent; exonerated at 11 percent; and sustained at 11 percent. 3 The leading areas of concern in the 140 4 5 closed cases in May were procedure at 36 percent; demeanor at 24 percent; force at 13 percent; and 6 7 service at 8 percent. And that completes the Secretary's Report. 8 9 And there is a map, and on the map there is a chart on the other side showing those closed cases. 10 CHAIRPERSON TAYLOR: All right. Thank you, 11 12 Mr. Secretary. 13 At this time, we will have the Chief 14 Investigator from the OCI's Office, the monthly report. 15 CHIEF INVESTIGATOR DRAKE: Thank you, Madam Chair. Pamela Davis-Drake, Chief Investigator, for the 16 17 record. 18 Currently, as of today, our statistics, we 19 are at 283 cases. Seventeen cases have been submitted 20 for closing, and we have no cases that have been submitted over 90 days. 2.1 22 As expected, our numbers are increasing. 23 We are currently gearing up for vacation. 24 And we are scheduling out so that we have appropriate

coverage.

1	We also have one expectant mom who is going
2	to be out in September on maternity leave, so we are
3	planning accordingly.
4	And finally, I am working on some research
5	that was actually posed, brought to my attention by
6	Commissioner Taylor with regard to possible mediation
7	for some of the cases. I will be including, of course,
8	the Department on that at some point, and also
9	providing a report to the Board, as soon as the
10	research is concluded and I have a viable proposal to
11	give to you.
12	And that concludes my report. Are there any
13	questions?
14	CHAIRPERSON TAYLOR: How is it looking with
15	the I know you have got to do the report, but is it
16	looking pretty good?
17	CHIEF INVESTIGATOR DRAKE: It is looking very
18	good. Like I said, the last thing that we have to do
19	obviously is include the Department to make sure that
20	it is viable for them, and to also make sure that they
21	are included in this process. The research right now
22	is being conducted. I am putting some things on paper.
23	But it does look very viable.
24	There are at least three other states,
25	Oregon, California, and Washington, D.C., that have

Since the Chief 23 Investigator has been in place, we have seen considerable improvement across the board; most 24

16	Let's move to the Chief' presentation, report
17	for Civil Rights.
18	MS. SIMS: Good afternoon, Madam Chair,
19	Commissioners.
20	COMMISSIONERS: Good afternoon.
21	MS. SIMS: My name is DeShaune Sims. I am
22	the Commander assigned to the Civil Rights Division.
23	We are responsible for ensuring compliance with the
24	Consent Judgments that were we were sued by the
25	Federal Government.



1	My staff I have is Lieutenant James Domine,
2	and I have Audit Division Audit Manager, Angie Harvey.
3	In 2000, the Department of Justice launched
4	an investigation of the Detroit Police Department based
5	on complaints they received. And they looked to see
6	whether or not there was a pattern of practice of
7	behavior of violating individual civil rights.
8	So in 2003, July 18th, we signed two
9	agreements. One was Conditions of Confinement; the
LO	second was Use of Force, Arrest and Witness Detention.
L1	And that was the first time in the history of
L2	a law enforcement agency where a Department received a
L3	Conditions of Confinement Consent Judgment from the
L 4	Federal Government. Usually those judgments were given
L 5	to jails or prisons. And so Detroit was one of the
L 6	first precincts to receive a Conditions of Confinement
L 7	Consent Judgment.
L 8	The Conditions of Confinement judgment was
L 9	initially a two-year decree. You know, looking at the
20	language that was written, we didn't think there would
21	be an issue or problem for us to come into compliance.
22	It took us a little bit longer. We had an extension
23	filed going into 2013. We did file three different
2 4	extensions. The final one was ended July 18th of 2013.
25	And I just want you guys to know that we did come into

The Use of Force Decree was a five-year requirement. We did not, again, reach sustainability within those five years. We did file two separate extension requests. The last extension is set to expire July 18, 2014. We are working with the judge now to determine the transition process and what we are going to do going forward, looking at whether or not we are going to file for an extension or just file a Transition Agreement.

There was a meeting held today. We have a new judge in place, Federal Judge in place. Judge
Julian Cook had been on this case for 10 -- since 2003, so 11 years now almost. He retired. We were assigned Judge Avern Cohn, and so there was a meeting with the Federal Judge, the Department of Justice, the
U.S. Attorneys' Office, and our attorney that's assigned to our case today to discuss what we are going to do going forward. So we don't know what it will look like in the future, but we are hoping that

something that's more amenable or agreeable to us will take place.

And just for your information, we have 110 paragraphs that we are working with on the Use of Force and Arrest and Witness Detention. We have been in compliance with 89 of those paragraphs for two years or longer. There are nine paragraphs that we have never had. So when you look at 110 paragraphs, and to have 89 be in place for two years or longer, I think that's a tremendous accomplishment for the Department. We didn't think for a long time we would be able to get there, but we are getting there.

Some of the provisions of the Conditions of Confinement Judgment was to develop and implement a comprehensive fire detection program. We didn't have anything in place to identify how we would evacuate detainees if there was a fire or some type of event that occurred within a holding facility. And we didn't always practice evacuating the building in case something happened. So we had to put something in place to make sure that those things were done properly.

A medical and mental health screening program, and making sure that we had appropriate clothing for suicidal prisoners. We had to remove all

1	hazardous equipment from the holding cells. Some of
2	the holding cells had what they call devices that would
3	allow prisoners to hang themselves from. So we had to
4	make sure those things were removed.
5	We had to make sure that we did adequate
6	checks. We started doing 30-minute checks and
7	documenting those checks to make sure that everybody
8	was okay that we were detaining.
9	And then we had to put a process in place for
10	receiving and reviewing complaints that were lodged.
11	And usually those complaints were turned over to the
12	Office of the Chief Investigator for investigation.
13	In addition, the most important thing was
14	revising our policies. We had some policies in place.
15	We were not always following those policies. Those
16	policies were not always updated.
17	I know when I came on the job in 1996, we had
18	policies from 1987 that we were, you know, following
19	and adhering to. So we weren't keeping up with best
20	practices. And so this judgment forced us to do
21	research and continuing to do research of other
22	agencies to find out what's currently happening in
23	those places and looking to see if we could implement
24	those practices here in the Department.

We also didn't have a device -- a weapon to

When a person was detained, sometimes we kept them longer than they should have been detained. I know for a long time in Homicide it was customary if you witnessed a homicide, they would just take you down to Headquarters and keep you on the 8th or 9th floor until you talked. We were violating civil rights.

And so now we have to make sure that we have you presented before a magistrate within 48 hours. And if we are not able to, we have to document that and the reasons for the exception. And we find generally those exceptions come from the Prosecutor's Office, and that we have to go out and get additional information. But we don't keep people beyond 72 hours.

Again, the Consent Judgment required us to make sure we had accountability and oversight, which is something that we didn't always do consistently. So not only consistent, we have processes in place to make sure investigations are conducted, investigations are reviewed and approved through their chain of command up to the Captain. And if there is any discrepancies of those things, go back for clarification and/or corrections.

We have mandatory in-service training

The Monitor's role in terms of the Consent

Judgment provided oversight and technical assistance to

make sure that we are complying with the mandates of

the consent judgement.

The impact it has had on the Department, it has made us a better Department. You know, we have agencies come to us now asking, what do we do in order to get into compliance? Just yesterday I received an e-mail from Maricopa County in Arizona. They are going to send some of their representatives here in the next couple of weeks to sit down and talk with us to see what we have done right to help them move along in their process. That's important because for a long time we didn't have people coming to us. You know, back in the '70s, maybe, we were a premiere Department, but we kind of lost our way, and nobody was really coming to us to say, what are you guys doing right? want to follow your example. But now we have that in place, and people want to come to us and say, we want to be like you. So that makes me feel good. I don't know about A.C. --

A.C. WHITE: No, I feel good about it.

MS. SIMS: -- but it makes me feel good to

And it is important that the City support us, and we have received tremendous support from the City and from the Board in making sure that we are, you know, a constitutionally-based Police Department and doing the things that we have to do to ensure the rights of the citizens.

We have a Compliance Team. The Compliance

Team is a liaison between the Department and our

monitoring team. They collect the information that is

utilized by the Monitors to determine whether or not we

are in compliance.

They also review that information, and if we find areas where we are not in compliance, we relate that back to those commands and have them submit a Corrective Action Plan on what they are going to do to ensure that they come into compliance and remain in compliance.

Our Audit Team is comprised of all civilians. We have an Audit Team Manager and we have six civilian auditors. When we had both Consent Judgments, we were conducting over 264 audits every year. We are now conducting around 195 audits, because each audit paragraph has subparagraphs.

1	And we audit because we want to make sure
2	that we are doing what we are supposed to do. If we
3	find through our audits that something is continuing to
4	occur, more often than it should, it may be that the
5	policy is not clear. So we will make recommendations
6	for policies to be updated or amended.
7	And then what we audit is use of force, and
8	prisoner injuries, arrests and custodial detention,
9	employee performance, we look at that with our risk
10	management system, we look at citizen complaints, stops
11	and frisks, vehicle pursuits.
12	And as of the Monitor's last report, that was
13	for the period ending December 30th, we are waiting on
14	the next report to come out now that covers January to
15	March of this year, we were at 86 percent. And again,
16	we have been in compliance with 89 paragraphs for two
17	years or longer, so we are at 89 percent. The highest
18	level of compliance for the Use of Force Consent
19	Judgment was at 89 percent, which occurred in the
20	15th quarter.
21	Are there any questions?
22	CHAIRPERSON TAYLOR: Commissioners, do you
23	have any questions?
24	COMMISSIONER MOORE: Madam Chair, I do have a

question.

1	Commander, you stated that we needed an
2	intermediate weapon between the pepper spray and the
3	handgun?
4	MS. SIMS: Yes.
5	COMMISSIONER MOORE: Pepper spray isn't an
6	intermediate weapon itself?
7	MS. SIMS: Well, we didn't have anything
8	else. It is a less lethal weapon than a handgun, yes.
9	But we didn't have anything between those two. Those
10	were the only two options. And more often than not, at
11	that time, officers were choosing to utilize their
12	weapon. So we needed something else in place that they
13	could utilize.
14	COMMISSIONER MOORE: Got you. Thank you.
15	CHAIRPERSON TAYLOR: Any more questions?
16	COMMISSIONER BELL: Madam Chair, I just want
17	to say, Commander Sims, that we have come a long way,
18	and this is really a drastic improvement in reference
19	to handling, you know, people that we encounter, and
20	innocent until proven guilty, and more humane. And I
21	just want to commend the Department and the Chief and
22	Assistant Chief in reference to moving this along.
23	Is there a timeline that we might see the
24	light at the end of the tunnel as far as being under
25	this type of scrutiny Consent Decree?



1	MS. SIMS: Well, we are looking at maybe
2	another 12 to 18 months, but we are not sure. Again,
3	we have to prepare a Transition Agreement that the
4	Judge is going to look at because the Judgment does
5	expire next month. So once we submit that Transition
6	Agreement, we will know better what we are looking at,
7	but we are looking at another 12 to 18 months, and we
8	are hoping for 12.
9	COMMISSIONER BELL: One more question,
10	perhaps to both in terms of supervision, the sergeant
11	and lieutenant, especially the sergeant, are they able
12	to respond to the scene more so than in the past? I
13	know as a working sergeant, lieutenant, we was bogged
14	down with paper a lot of times with deadlines and, you
15	know, has that cleared up a little bit more to give you
16	flexibility to really respond? Because I think once
17	you arrive on the scene, you can be interaction,
18	supervision. Especially when I went back in the
19	precinct, a young Department, we did not have that many

A.C. WHITE: By policy, when we use force, there must be a supervisor that responds, every time force is used. If a supervisor does not respond, that is a violation and is dealt with with corrective action. So the answer, short answer to your question

senior officers. You know what I am speaking about?

1	is, yes, supervisors are able to respond, but we also
2	mandate that a supervisor respond, which I think when
3	you were on, like when I first came on, that wasn't
4	mandated.

The other piece of that is we have a span of control now where in your time, you got as many police officers as they could fit on the sheet that you -- were assigned to you. Now we strictly regulate that there are ten police officers to every one sergeant. And that sergeant has to know, has to rate, has to evaluate that police officer.

So in times past, I am sure you remember, you get your service rating, you never met the sergeant before. They call you in, they say, here, sign this.

Right?

COMMISSIONER BELL: Right.

A.C. WHITE: Well, now the sergeant knows
you. He or she is out with you. They are interacting
with you on a daily basis. And so as a result of that,
we are seeing a lot less of the complaints we used to
see because the sergeants can track behavior. With the
management awareness system, say you have got an
officer who routinely gets citizen complaints, and you
can — because you know him, you know, why does this
guy always get complaints when he is talking to women?

1	Or why does he always get complaints when he is talking
2	to black males versus white males? You are able to
3	aggregate the data, look at it, and see what's going on
4	with the officer. We have what's called monitoring, so
5	if we have a problem with an officer, with a particular
6	demographic, we can do some things, we can monitor
7	them, we can send them to conflict resolution, we can
8	send them to what's that course?
9	MS. SIMS: Verbal judo and customer service
10	training.
11	A.C. WHITE: verbal judo, customer
12	service, so we are able to do a lot of different things
13	now that we weren't able to do even ten years ago.
14	MS. SIMS: And the supervisors are
15	required if the person is identified for
16	intervention, the supervisors are required to respond
17	to those runs and observe the interactions with the
18	officers and the citizens.
19	COMMISSIONER BELL: You hit the nail right on
20	the head. That's really good news. Thank you.
21	MS. SIMS: Thank you.
22	COMMISSIONER CRAWFORD: I have a question

MS. SIMS: For this team, we are paying over a million dollars. That is a reduction from what we paid from the previous monitoring team. That monitoring team was getting 2 point something million dollars a year.

With the proposal going forward, if we are able to have set aside those 89 paragraphs, and because we no longer have Conditions of Confinement, we are asking that the monitoring fees be lowered. So, again, that's going through the courts and we are going to see what comes out of that.

COMMISSIONER CRAWFORD: Yes, ma'am. I want to commend the Department as to where we are today, because I know where we were when, and I do know the activism in the City is the cause of this, that brought all this to light and exposed it, community, Coalition Against Police Brutality, Ron Scott and many of us officers were there too, brought about this change. And it was activism and its impact that brought this about. I agree it has been very costly, and it has been a very long journey here, but I am so glad to see, and I want to commend the Department on the movement that we have that we are experiencing from ten years

1	ago.
2	MS. SIMS: And regardless of how we got here,
3	it has made us a better Department.
4	A.C. WHITE: It has. And I agree, you know,
5	the Coalition Against Police Brutality and other groups
6	that have identified problems, you know, it would be
7	easy to say, well, we weren't that bad. That would be
8	a lie. We were that bad. And we are most certainly a
9	better policing organization now than we have ever
10	been, certainly in my career. I am proud of the men
11	and women out there. We are doing things the right
12	way. Do we make mistakes? We certainly do. But we
13	have processes now in place where if we make a mistake,
14	we admit it, we show it, and we correct it.
15	So thank you.
16	CHAIRPERSON TAYLOR: Are there any other


