12	James Craig.
13	CHIEF CRAIG: Thank you, sir.
14	COMMISSIONER WHITE: Thank you for
15	being with us. Also, Mr. Secretary, if you
16	could, please, introduce the remainder of the
17	staff.
18	SECRETARY ANTHONY: Thank you,
19	Mr. Chair. We have seated in the front
20	Ms. Pamela Davis-Drake who is our Chief
21	Investigator. We have Mr. Robert Brown who is
22	seated to my left, he's our office manager; Sgt.
23	Alan Quinn who's recording our proceedings and
24	Mr. Dale Rose is taking a transcript, he's from
25	Hanson Court Reporting.



1	That completes the introductions.
2	COMMISSIONER WHITE: Thank you,
3	Mr. Secretary. We're certainly happy to be in
4	the 4th Precinct today here at the Southwestern
5	Church of God. We would ask I believe it is
6	Pastor Hill who's with us today Pastor, if you
7	could come and give us a warm greeting on behalf
8	of the Southwestern Church of God, please.
9	PASTOR HILL: I'm Assistant Pastor Fred
10	Hill, Sr. On behalf of the Southwestern Church
11	of God family, Pastor Perkins is our senior
12	pastor, we welcome you here. We thank the Lord
13	for you so we welcome you and hope you have a
14	very pleasurable time here; God bless you.
15	COMMISSIONER WHITE: Thank you. At
16	this time I'd like to note the presence of
17	Commissioner Wendell Byrd who has joined us and
18	also Chair of the Board of Police Commissioners
19	Commissioner Jessica Taylor.
20	At this time I'm going to ask if
21	Commissioner Moore would read the duties and
22	responsibilities of the Board of Police
23	Commissioners.
24	COMMISSIONER MOORE: The Board of
25	Police Commissioners is composed of 11 members,

seven of whom shall be elected from non-at large
districts, four members appointed by the Mayor
subject to the approval of the City Council.

Appointed commissioners serve five-year terms and may not serve more than five years consecutively. Meets once a week and may recess during Thanksgiving, Christmas and New Year holidays. All meetings are open to the public.

The Board of Police Commissioners has supervisory control and oversight of the police department as set in the 2012 City Charter adopted by a vote of the people on November 8, 2011.

Our duties are to establish policy, rules and regulations in consultation with the Chief and the approval of the Mayor, review and approve department budget, review and approve department promotions, receive and resolve complaints concerning the operations of the police department, act as a final authority in imposing or reviewing discipline of employees of the department, and last but not least prepare an annual report to the Mayor, the City Council and the public of the department's activities during the previous year.



1	The Board appoints a Board Secretary
2	who attends all Board meetings, a Chief
3	Investigator and additional investigators, other
4	staff as necessary to provide support to the
5	Board.
6	The Police Commission considers itself
7	a liaison between the citizens of the city of
8	Detroit and the Detroit Police Department.
9	COMMISSIONER WHITE: Thank you,
10	Commissioner. Before we turn it over to our
11	Chair for approval of our agenda and minutes
12	Pastor, if you wouldn't mind giving us an
13	invocation today.
14	I apologize, during your greetings we
15	failed to ask for an invocation today.
16	Thank you.
17	PASTOR HILL: Let us look to the Lord.
18	(INVOCATION GIVEN.)
19	COMMISSIONER WHITE: And I will now
20	turn it over to Madam Chair.
21	COMMISSIONER TAYLOR: Thank you. Good
22	evening, everyone. I apologize for being tardy,
23	but couldn't help it, but anyway at this time I'm
24	going to call for a motion to approve the agenda
25	for today.



1	COMMISSIONER BELL: So moved.
2	COMMISSIONER MOORE: Second.
3	COMMISSIONER TAYLOR: It's been moved
4	and supported, any discussion? All in favor.
5	BOARD MEMBERS: Aye.
6	COMMISSIONER TAYLOR: Opposed. Agenda
7	stands approved. At this time I'd like to ask
8	for approval of the minutes for from June 12
9	I'm sorry, June 2 I don't have my glasses,
10	I'm going to quit pretending I can see.
11	So what's June 5, 2014. I'll get it
12	together in a minute.
13	COMMISSIONER CRAWFORD: So moved.
14	COMMISSIONER SHELBY: Second.
15	COMMISSIONER TAYLOR: It's been moved
16	and seconded. Are there any discussion?
17	COMMISSIONER WHITE: Madam Chair, under
18	discussion under roll call I do see my name as
19	being listed as not present, I do believe I did
20	arrive for the meeting last week. I would ask
21	for this to be approved as amended.
22	SECRETARY ANTHONY: I'm sorry, I didn't
23	hear I'm sorry.
24	COMMISSIONER WHITE: The attendance
25	shows Commissioner White as not present.



SECRETARY ANTHONY: Not present for
roll call. It's explained that seven
commissioners were present for the roll call and
the remaining two came and it's acknowledged
further in the minutes your presence.
COMMISSIONER TAYLOR: So it's okay, all
right. Then we'll call for a motion to approve
the minutes for June 2 as written June 5 as
written.
COMMISSIONER CARTER: So moved.
COMMISSIONER BELL: Second.
COMMISSIONER TAYLOR: It's been moved
and supported so all in favor?
BOARD MEMBERS: Aye.
COMMISSIONER TAYLOR: All opposed?
Minutes stand approved as written. Under the
officer's report tonight we have I guess last
week if you remember Attorney Simpson came before
the board and he had some issues and complaints
with the Mound Road facility or the Detroit
Detention Center and I told him last week that we
would have the answers to the questions that he
was asking, but before he comes up is he here,
Warden Stewart? Okay.



But before you come up I would like to

1	ask Aliyah Sabree who is the attorney to the
2	Board to come up and give our summary because we
3	went over to the Mound facility and toured the
4	facility and I'm going to have her do a summary
5	and I believe Capt. Russell and also Capt.
6	Russell Solano, he's going to stand in for
7	come up, sir, and take about two minutes and give
8	Comm. Sims' report.
9	So Ms. Sabree, if you could give a
10	little summary to the Board.
11	ATTORNEY SABREE: Good evening to the
12	Board, good evening to the Chief. Briefly on
13	June 6, last week Commissioner Taylor and I did
14	visit the Detroit Detention Center on Mound Road
15	and we met with Warden Stewart. We also met with
16	several of the staff members and during our visit
17	we were able to tour the entire grounds and
18	during our visit we were able to see the
19	technology that was used there as well as the
20	surveillance equipment, see the booking area.
21	We were able to watch someone actually

1	with that.
2	We also saw the male and female side
3	and we observed the nurses' area where they took
4	care of individuals who had medical issues. So
5	the main point is when we visited in our
6	observation the facility was clean and it was
7	well run and efficient and we thanked Warden
8	Stewart for opening his doors to us and being
9	transparent throughout the whole process.
10	Thank you.
11	COMMISSIONER TAYLOR: Capt. Solano?
12	CAPTAIN SOLANO: Yes, ma'am. Comm.
13	Sims couldn't be here, so she asked me to stand
14	in for her and verify that she in fact
15	accompanied the group through the our
16	facility. And the complaints are relatively
17	unfounded from what she relayed to me.
18	And me working there, that's my
19	assignment. I visit Building 500 probably twice
20	a week and Building 500 and 100 are kept
21	exceptionally clean.
22	Warden Stewart makes sure of that, the
23	deputy warden, they're constantly asking is there
24	something you need, something that needs to be
25	cleaned If there's any issues they take care



1	of it right away.
2	COMMISSIONER TAYLOR: Okay, thank you,
3	sir and I concur with that. I didn't see this
4	is my second time touring that facility and it's
5	one of the cleanest I go to a lot of prisons
6	and jails and that's the cleanest jail or prison
7	I've ever seen, it's really nice, and the warden
8	is very very open and I'm not going to talk, but
9	I'm going to let him come up, Warden Stewart, if
10	you would come up now. Also accompanying him is
11	Russ Marlin who is a spokesperson for the MDOC.
12	WARDEN STEWART: I'd like to thank you
13	for inviting me. I'd like to say regarding
14	Detroit Detention Center it's been a pleasure
15	working with the Detroit Police Department.
16	For those who don't know, we entered
17	into an inter-agency agreement back in August of
18	last year for centralized booking and to work
19	towards getting Detroit out of that Consent
20	Decree.
21	Specifically our role was that as it
22	relates to conditions of confinement. So we
23	looked at sanitation, we looked at having
24	transparent systems in place.
25	Some of the things we have with regards

to currency, nobody handles money. The money
goes in the Kiosk system and that money is then
transferred to a receipt. Once that money is
placed in the receipt DPD command staff then
types in that number, it's swiped on a card,
automatically uploaded and that money that
receipt and that debit card is then placed in
evidence.

With regards to medical coverage, I know there was some concerns about our medical system. The Detroit Detention Center is staffed with 24/7 RN coverage so our medical nurses take care of 90 percent of all emergent situations at Detroit Detention Center.

All non-emergent needs are handled there resulting in only 10 percent going to the hospital. The benefit in that is we recently had a meeting with DPD and Wayne County and they were indicating -- Wayne County indicated that they was looking at between 800 and 900 medical runs a month.

Last month we had 97 runs, so that's a tribute to the medical staff at that particular facility. Those RNs are able to deal with diabetes, blood pressure and a lot of issues that



1	are typically or that were typically
2	transported to the hospital because DPD didn't
3	have those medical personnel in those precincts.

So I have nothing but good things to say about our collaboration. I've looked at it as a great partnership. We're constantly meeting, we meet weekly. We started off meeting weekly, then we went monthly, now we're meeting quarterly and we're constantly looking at how we can improve our system to make it better for the staff, the detainees and to reduce any type of litigation that could come to the City.

Russ?

MR. MARLIN: Thank you, Ms. Taylor. I know you have been to a lot of prisons and we appreciate the good work that you do in our correctional facilities. I just would echo what Warden Stewart said that it was a little over a year ago when DPD and our department began conversations about the use of this prison that we closed in January of 2012, came to an agreement to allow our staff to do what we do every single day at our 31 prisons across the state and close five DPD lockups and move police officers back onto the street.

1	That facility, as Anthony indicated,
2	opened August 1 of last year and he touched on
3	the decrease in the emergency room runs, but we
4	have five RNs that work at that correctional
5	facility or at the Detroit Detention Facility and
6	that staffing has allowed for since the
7	facility opened over 4,200 fewer emergency room
8	runs that was previously the case when the five
9	lockups were in operation.
10	So we're seeing cost savings, we're
11	seeing greater efficiency. As you mentioned, the
12	facility is very clean, run very well and also
13	having one central lockup I think the Chief will
14	probably comment on this, it allows more creative
15	law enforcement techniques, you know, these
16	sweeps, these large arrest things where five
17	lockups you couldn't accommodate those types of
18	operations, and now with one 200-bed central
19	lockup that is something that we can do.
20	We'd be happy to answer any question
21	that you have.
22	COMMISSIONER TAYLOR: At this time do
23	you have any questions, Commissioners? If you
24	could hold for a minute, I'm going to have the



Chief to come on and do his report because he has

1	to leave, so then you can come back and you can
2	entertain any questions the Commissioners have.
3	Thank you.
4	Chief?
5	CHIEF CRAIG: Thank you, Madam Chair,
6	and I apologize in advance. We had a crisis in
7	the Detroit Police Department this afternoon and
8	I'll update you on that situation, but as I begin
9	my remarks I would ask that we have a moment of
10	silence for Police Officer Anna Hamilton.
11	(MOMENT OF SILENCE.)
12	CHIEF CRAIG: Thank you. Today we
13	received notification around 1:30 this morning
14	that a 16-year veteran police officer Anna
15	Hamilton assigned to the 6th Precinct was
16	murdered in her home in what we believe based on
17	the information we have that her husband was the
18	suspect.
19	That crime took place in the city of
20	Redford Township and is currently being
21	investigated by the State Police, so as you can
22	imagine being assigned to the 6th Precinct she's
23	well known throughout the department, many are
24	grieving.



I had an opportunity to go over with

1	City Council President and I went both to the
2	residence and to the station and met with the
3	afternoon shift, talked to the officers. We have
4	clergy present, we have other support personnel
5	and so I'm planning to when I leave here to
6	attend the next two roll calls.
7	She was a Platoon 1 officer and so our
8	plan is to relieve those officers and replace
9	them with officers from other stations across the
10	city because as you can imagine there's a lot of
11	pain associated with this.
12	Before I go into my crime report are
13	any questions again, a news report has some of
14	this. I think they may have released her name.
15	We asked the media to hold off as long as they
16	could and they obliged us, but I think her name
17	has been released as of now.
18	So thanks to Commissioner Donnell, I
19	did have a chance to brief him from the scene on
20	what was occurring. If anybody has any
21	questions?
22	COMMISSIONER TAYLOR: Commissioners, do
23	you have any questions for the Chief before he
24	leaves? If not, thank you, Chief.



CHIEF CRAIG: I'll give my crime report

1	and then Chief Darryl Brown will continue on.
2	First of all, I know that Capt.
3	Chambers is here, he's going to give a crime
4	report that's encouraging in this specific area.
5	Before I get into that, I did want to give you an
6	update.
7	As you also know, there is a very
8	high-profile crime that occurred in the city. I
9	want to first acknowledge the men and women of
10	DPD who worked so diligently on this case and
11	this is involving the tragic death of a mother of
12	two children. Our investigators worked around
13	the clock and based on our investigation we
14	learned that the suspect left the city and was in
15	Atlanta, Georgia.
16	Because of our relationship with our
17	federal partners, certainly Atlanta, Georgia,
18	Fulton County, we were able to locate the suspect
19	who is now a suspect, but then was a person of
20	interest based on his relationship to the mother.
21	During that initial contact our sole
22	purpose was to try to find out where the children
23	were located. To date we have not done that.
24	After other information came we



arrested a second -- well, a first suspect who

1	gave us some additional information on the crime.
2	We then got a warrant signed from the
3	Prosecutor's Office and we responded to Atlanta,
4	Georgia. And our investigators are there now and
5	we are making a diligent attempt to try to locate
6	the children. That has not been done.
7	So the husband has been arrested for
8	murder and a second suspect has been arrested for
9	accessory to murder. So this investigation is
10	still continuing, but our focus continued to be
11	on locating the children.
12	As you can see, this is a very tragic
13	situation, but again I certainly applaud the
14	great work by Detroit Police Department, Michigan
15	State Police who assisted, the FBI who has been
16	with us and certainly and not least the Wayne
17	County Prosecutor's Office because we had a
18	prosecutor with us from the beginning until
19	current, and so it's worked out well.
20	Any questions in that case?
21	COMMISSIONER TAYLOR: Chief, if I can,
22	I don't know if you can answer specifically, but
23	did the husband say he did have the children or,
24	you know, did the children leave with him

because I was assuming that maybe he took the

1	kids when he left Detroit. So he's saying he
2	doesn't know where the kids are?
3	CHIEF CRAIG: Respectfully, given that
4	this is a very active investigation I can't go
5	into details on that. We believe he has
6	knowledge and so we're continuing to pursue that.
7	COMMISSIONER MOORE: I have a question.
8	Chief, initially there was a question about an
9	Amber Alert being issued. Can you kind of
10	expound upon that?
11	CHIEF CRAIG: I ordered that, in my
12	judgment it was not an issue. In fact, looking
13	at the criteria for an Amber Alert it didn't
14	necessarily meet that. I know that was hard for
15	some to accept. It certainly didn't undermine or
16	take away from the investigation.
17	In fact, because we work very closely
18	with the federal government and certainly the
19	outside agencies not only did we put out missing
20	exploited children, in fact we know that our
21	partners in Atlanta, Georgia were very much aware
22	of this critical missing case. They had the
23	information.
24	And based on the investigation again



I can't go into details, but it would not have

1	changed the outcome. I think looking back at
2	this investigation because the mother went
3	missing several weeks prior to her body, we look
4	at was there something that would have indicated
5	there was trouble. Unfortunately it appeared
6	there was a voluntary absence based on the
7	discord in her home, but nothing that would have
8	risen to the level of what we later learned.

And so I know there was a lot of conversation by both the family and certainly the media and I made a point of advising the media many times when we have these high-profile cases and you talk to family members who are rightfully emotional and who want closure and certainly they want the children, sometimes erroneous information is placed out.

And our goal and focus is to find and locate these children. And certainly what we didn't want to do is really the person who we believe to be the suspect at the time, we certainly didn't want to cause alarm to the suspect. That would have negatively impacted our investigation, so I'm confident that what we did, the partnerships and collaboration, that there was a wholesale effort, certainly the case was

1	solved in a matter of days once we became aware
2	of her murder which has been consistent on some
3	of our high-profile cases.
4	But again we don't see where that had a
5	negative impact based on what I know about this
6	investigation.
7	COMMISSIONER MOORE: Thank you.
8	COMMISSIONER TAYLOR: Any more
9	questions for the Chief? Thank you, chief.
LO	CHIEF CRAIG: In terms of crime, I
11	always I know that Capt. Chambers is going to
12	elaborate, in this area that we're physically in
13	this candidly is viewed as one of the safest
L 4	areas in the city of Detroit. Scout Car 4-15
15	year to date, no homicides, robberies are down,
16	aggravated assaults, burglaries.
17	And so the area based on in comparison
18	to other scout car areas in the city, and Capt.
19	Chambers certainly can elaborate on the issues
20	that are going on in the community, and his
21	neighborhood police officers are here, so at the
22	appropriate time he would like to introduce for
23	those who may not know.
24	But overall city-wide in the city of



Detroit some good news is that when you look at

1	our violence crimes year-to-date we're down
2	overall 9 percent.
3	In property crimes year-to-date we're
4	down 23 percent with an overall reduction of 20
5	percent Part 1 crimes which includes both violent
6	and property.
7	Some key points: Homicides are down 20
8	percent, non-fatal shootings are down 13 percent.
9	Robbery which is the most significant reduction
10	and typically robbery is a crime that really
11	drives our violent crime numbers is down 35
12	percent.
13	And the sub-category in robbery,
14	carjacking, and we've talked a lot about
15	carjackings. First time this year the steepest
16	reduction, we're sitting on a 25 percent
17	reduction in carjacking incidents.
18	And so that's great news. The one area
19	that we are up, we are up very slightly in the
20	area of aggravated assaults and it's not because
21	of our non-fatal shootings because as I pointed
22	out we're down 13 percent in non-fatal shootings,
23	but domestic violence we're up 13 percent.
24	And so when I started to look at



domestic violence incidents it caused me a lot of

1	concern. You know, one of the things that we try
2	to look at domestic violence is what we can do in
3	a proactive way because even when we look at the
4	two most recent incidents, the tragedy involving
5	our officer and certainly the tragedy of the
6	mother, in this case that we're currently working
7	both are domestic violence incidents.

So we're looking for ways to proactively when there's signs and problems that we can act sooner than later instead of reacting to a fatality.

But with that said, the other part of the analysis that really hasn't been talked a lot about, when I arrived here 10 months ago I was very candid, we talked about response time being 59 minutes. We talked about clearance rates about 11 percent. We talked about calls being held between shifts in some districts.

By way of example, I remember vividly in the Eastern District one day 40 to 60 calls being held between shifts. And so when you look at 40 to 60 calls being held between shifts and on top of that many of these 40 to 60 calls were never being responded to.

Clearly there were a lot of unanswered

calls in the city of Detroit	. When I came	here
many of the community members	s reported out	to me
that, "Why call the police,	they don't com	e?"

Even my dad when I was still the police chief in Cincinnati and his car -- was attempt vehicle theft, and the first question I had as, "Well, did you call the police?" My dad said, "For what?" I thought that was odd.

So then later, only two months later I then become police chief so I remembered that and so clearly when we talk about 40 to 60 calls, I can't even tell you what percent of those calls were unanswered, we were talking about this the other day at ComStat.

Conservatively 30 percent probably got handled, if that. With that said, how many of those calls unanswered were domestic violence incidents? I would suggest that probably a good number of them, so there was underreporting, and now that we see this uptick because we go to every call. Good news is right now year-to-date we look at our Priority 1 calls for service, we're sitting on roughly a 10-minute response time average. Some of our higher priority calls, shootings in progress, we've seen two to three



1	minute response times.
2	So with fewer officers, and we do have
3	fewer officers than we had even 10 months ago,
4	we're more efficient in responding to calls for
5	service. And so we've seen a drop in crime,
6	we've seen the response time and really I have to
7	give credit to many of the men and women we see
8	here today, the command staff, who really provide
9	the kind of leadership because they understand
10	the importance of serving the city of Detroit.
11	So we've seen that reduction, but I
12	must believe that that uptick in domestic
13	violence is because now we respond to everything
14	and we take reports. It doesn't minimize it
15	because it's still critical and so we will
16	continue to find solutions to how we can reduce
17	domestic violence incidents.
18	So that concludes my crime report and
19	ask if there's any questions?
20	COMMISSIONER TAYLOR: Any questions,
21	Commissioners?
22	COMMISSIONER CRAWFORD: Yes, through
23	the Chair. Chief, recall a couple of months
24	back, might have even been three months ago, you
25	were concerned you expressed to us about the

domestic violence and I think then there was an
uptick then and also there seems to be a national
trend some of the most heinous crimes not only in
Detroit but also across the country are spawned
from domestic violence.

Is the department looking at doing a TSA or anything like that involving counselors or something of that nature or informational things to get out to the community in terms of the women and even the men to make the perpetrating of domestic violence, disrespect the men you disrespect the individual, disrespect a women you disrespect a nation because the women are the nurturers and the teachers, first teachers of our children.

I was just as an informational piece —
I'm willing to work in any way or bring forth any
information that I'll work with you and the
department on any type of project because it is a
real issue in not only this community, but also
across the country.

CHIEF CRAIG: Through the Chair in response, yes, we are looking to do something very different and I think it's very key to remember -- I wish we had accurate statistics to

I have had a conversation with Councilwoman Saunteel Jenkins who's very interested in working with the department on domestic violence in a pro-active way. Wayne State is going to be part of that dialogue and we're looking for a pro-active response.

I know when I was police chief in Portland we had social service workers embedded in the department so anytime it was a call for service involving a domestic violence incident, whether it was just an argument, screaming, social service workers would respond out and start the intervention at that point, not after the fact.

We know that when the domestic violence incidents may result in fatalities that is not the first time the police were called, so we want to be proactive instead of reactive so we're going to be rolling out hopefully sooner than



1	later an initiative and we certainly welcome your
2	involvement in that.
3	COMMISSIONER CRAWFORD: Thank you, sir.
4	COMMISSIONER TAYLOR: Any more
5	questions, Commissioners?
6	COMMISSIONER BELL: Madam Chair, I just
7	want to say to the Chief I know your heart is
8	heavy. Our hearts are heavy in reference to a
9	loss of a Detroit police officer and also a
10	high-profile case with the mother and missing
11	kids and I just want to commend you for coming
12	out tonight and reporting out to the community
13	because this is crucial and your professional
14	demeanor at all times.
15	And I just want to also mention that
16	your relieving the officers tonight, that is
17	another positive step because their hearts are
18	heavy. I've been in that situation working
19	through that process, it's hard to work, so I
20	think that is really admirable in terms of your
21	approach to this matter; thank you.
22	CHIEF CRAIG: Thank you for that.
23	(APPLAUSE.)
24	COMMISSIONER TAYLOR: Are there any
25	more questions for the Chief? If not, Chief



1	CHIEF CRAIG: Thank you all.
2	(Chief Craig leaves.)
3	COMMISSIONER TAYLOR: And if you don't
4	mind, before we do the presentation, 4th Precinct
5	presentation, I'd like to bring Warden Stewart
6	and Russ Marlin back up for questions.
7	Board, do you have any questions for
8	Warden Stewart or Russ Marlin?
9	COMMISSIONER SHELBY: Once a detainee
10	comes to your facility how long before someone
11	can call and get a notification of that subject
12	being in your facility?
13	MR. MARLIN: The actual intake portion
14	of the DDC is handled by the Detroit Police
15	Department. We do the holding process which is
16	the mugshots, LiveScans and then we facilitate
17	the arraignments, so that's probably a better
18	question for the Detroit Police Department.
19	CAPT. SOLANO: Excuse me, what was the
20	question?
21	COMMISSIONER SHELBY: The question was
22	when a detainee comes into the facility and a
23	loved one comes into the facility to inquire
24	about that detainee, how long does it take to get
25	them into the system so they are able to respond



1	to them?
2	CAPT. SOLANO: Probably within half
3	hour to an hour, and they can call right away.
4	We wouldn't be able to tell them a whole lot
5	except the fact that they were there and maybe
6	initial charges, but there would be information
7	available.
8	COMMISSIONER SHELBY: Okay.
9	COMMISSIONER TAYLOR: Just let me just
10	acknowledge before we go on Commissioner Burton
11	has arrived earlier, I don't think we
12	acknowledged him.
13	COMMISSIONER CRAWFORD: Through the
14	Chair, and this is for the DDC captain, there is
15	a real communication problem in terms of the
16	telephoning information. I know for a fact
17	because I worked for the Wayne County Sheriff's
18	Department and I worked Wayne County Jail and
19	I've worked the desk on numerous occasions.
20	The complaints that I get from people
21	who call the county jail who have called the DDC
22	is that no one never answers the phone. We
23	continuously tell them to call and give them the
24	phone numbers.



Also too there is an issue -- and it's

1	not on the part of DPD or Wayne County, and that
2	is if information is given that the person has
3	left DDC and they're in transit to the Wayne
4	County Jail, a lot of citizens don't understand,
5	they walk in at this very moment to our registry
5	downstairs in the Wayne County Jail it's probably
7	two or three hours to book that individual in.

2.1

So we have no information because it's not logged into the computer from the time they walk in for approximately two or three hours, maybe four hours sometimes.

So that's not anything on DPD or Wayne County, but they seem to sometimes not grasp that information because they continuously call. But one of the main complaints were that the phone is just ringing and ringing.

CAPT. SOLANO: Right, absolutely, and you're right, it does. We get, you know, I want to say, hundreds of calls daily regarding -- we process approximately 400 -- over 400 prisoners a month -- excuse me, detainees a month.

This past month we did over 1,800. So yeah, we get a massive amount of calls. We get people coming through the door looking for information for somebody who may have been



1	arrested, who has been arrested and looking for
2	bond information, so yes, that is a problem.
3	We are very limited as far as people
4	that can answer these phones, but we do try to
5	answer as soon as possible and, you know, give
6	people the best information we have available,
7	but you're absolutely right, the calls come in.
8	I stand behind that desk and I answer
9	phones, it just it's nonstop.
10	COMMISSIONER CRAWFORD: Yes, sir.
11	DEPUTY CHIEF BROWN: DC LeValley, you
12	want to add something?
13	DEP. CHIEF LeVALLEY: Yes, sir. David
14	LeValley, Deputy Chief, Support Services. I know
15	last week there was some issue brought up about
16	the Detroit Detention Center and about the
17	information that was available on the City's
18	website for people who were trying to figure how
19	to what the process is when their loved one
20	gets locked up.
21	I did check and the phone numbers are
22	all listed on the website. They're not really
23	easy to get to. I talked to Comm. Sims, she's
24	putting together like a FAQ, frequently asked
25	questions, where it will go through the process



	_
1	and explain the process and then she's going to
2	have that information posted on the website so
3	that it's easily visible to anybody that logs
4	onto the City's website, they will be able to hit
5	a link to see the jail information.
6	We can work toward getting information
7	on the detainees to where they could look
8	something up, but if that happens that will be
9	far out, but immediately she's going to be
10	putting together the FAQs and basically a process
11	map as to what happens when somebody gets brought
12	in, what the process is for figuring out what
13	their bond is, and like you said, the transfer
14	from Detroit Detention Center to the Wayne County
15	Jail so that those questions would be able to be
16	answered on the website if they can't get
17	somebody on the telephone.
18	COMMISSIONER CRAWFORD: Through the
19	Chair, I'd like to get a copy of that so I can
20	distribute that.
21	DEP. CHIEF LeVALLEY: Certainly, we'll
22	have it soon.
23	MR. MARLIN: Just to put it into
24	context, since the facility opened we've



processed over 15,000 detainees in and not one

1	single person has been in there more than 72
2	hours, so they're arraigned, released or
3	transferred to the Wayne County Jail.
4	COMMISSIONER WHITE: Madam Chair, I
5	just want to do a follow-up to Dep. Chief
6	LeValley's comments. I applaud the department
7	for their forward thinking and information
8	sharing. If I heard the captain correctly, us
9	increasing the amount of information into the
10	public is only going to increase potentially the
11	number of calls coming in for questions.
12	So if I'm hearing correctly, that we do
13	not have the manpower to physically answer those
14	calls, what are some of the solutions that we can
15	look to in terms of getting those men and women
16	some support that they can physically respond to
17	the influx of calls that could be coming in.
18	DEP. CHIEF LeVALLEY: We routinely put
19	some of our restricted-duty officers onto the
20	desk at the Detention Center so when officers on
21	the street have a short-term injury, they hurt
22	their ankle or something like that, we can take
23	them, move them to the Detention Center.
24	So we've recently added, I believe, two
25	on each shift restricted duty officers to solely



1	work the desk. We can increase that a little
2	bit, but that's the idea behind the frequently
3	asked questions and behind having the information
4	on the website is so that a lot of those
5	questions could be answered via the Internet
6	versus having to call somebody on the phone to
7	get the answers.
8	So the idea behind the FAQ section
9	would be that you can answer those questions
10	without having to have the phone call.
11	COMMISSIONER TAYLOR: Are there any
12	other questions for any
13	COMMISSIONER CARTER: The complaint a
14	couple of weeks ago had to do with medication and
15	the person not getting their medication upon
16	arrival at the DDC, so how long does if a
17	person arrives without medication, how long does
18	it take for that person to get the medication
19	that they need?
20	WARDEN STEWART: Our nurses have the
21	ability to, depending on what the medication is,
22	make that call. If it's something outside their

realm, then they're sent to Detroit Receiving via

DPD and have medication, so there shouldn't be

any case where someone is in need of medication

1	and not getting medication.
2	COMMISSIONER CARTER: Thank you.
3	COMMISSIONER TAYLOR: Any other
4	questions?
5	COMMISSIONER CRAWFORD: Yes, ma'am. I
6	have a question for the Warden or basically a
7	statement. Your facility I've been in there,
8	I agree it is clean.
9	As a matter of fact, often times most
10	of these detainees when they come in when they
11	come into the Wayne County Jail they're really
12	glad to get out of our facility.
13	I've been in every prison in the state
14	of Michigan including Ojibway which is a half
15	hour away from Wisconsin. I do know that there
16	are 43,000 inmates in the correctional system in
17	the state of Michigan and I do know that there
18	are 2.4 million people incarcerated in America,
19	the largest prison population in the world and I
20	believe it's about 16,000 come through the Wayne
21	County Jail and they average about 31,000 a year.
22	Yes, your facility is clean. I also
23	was there when they built Ryan and Mound. I live
24	in that area, that's my district. I look forward
25	to having further communication with you.



1	I did work the Ryan 10 escapees and I
2	think you've had so far two escapes in the last
3	year or so from your facility.
4	WARDEN STEWART: Actually no, we had
5	one absconder and that's really a point that
6	really needs to be made. There's a big
7	difference between an individual on parole
8	absconding and a prisoner escaping.
9	What we had was an individual got to
10	remember I'm the warden at Detroit Detention
11	Center, but also the warden at Detroit Re-Entry
12	Center and that was an individual at the Detroit
13	Re-Entry Center where 70 percent of my population
14	actually 90 percent of my population are
15	parolees; only 10 percent are prisoners, so these
16	individuals are on gate pass work groups.
17	And that individual walking away from a
18	gate pass work group is no different than an
19	individual being on parole on the street and not
20	showing up to see his parole agent.
21	What we call them is an absconder so
22	just for clarification, that's what we had at
23	Detroit Detention Center.
24	COMMISSIONER CRAWFORD: Didn't go over



the wall or cut a hole in the fence?

1	WARDEN STEWART: Absolutely not, no,
2	no. What he did was he got driven out of the
3	perimeter, he got sent out to do his yard work
4	and he walked away.
5	COMMISSIONER CRAWFORD: All right.
6	Thank you.
7	WARDEN STEWART: You're very welcome.
8	Look forward to talking to you in the future.
9	COMMISSIONER CRAWFORD: Oh, definitely.
10	That community around there, you know, you know
11	they have concerns about the security also and
12	also to living in the community and also working
13	part of the system, there's always concerns about
14	as to how the detainees are treated; okay.
15	WARDEN STEWART: One thing just to
16	speak to that, is one of the things when we
17	designed Detroit Detention Center and re-purposed
18	it from a prison to a detention center is we
19	really looked at and what Commissioner Taylor was
20	referring to was our camera system. I really
21	wanted transparency and that speaks to not only
22	the Kiosk system with the money, because also our
23	surveillance system.
24	From the time an individual in a squad



car pulls up to our side door to the time that we

1	hand them off to Wayne County out the back door,
2	there's not one portion of the time that
3	individual is in our area that they're not under
4	surveillance.
5	COMMISSIONER CRAWFORD: I've been to
6	your back door numerous times, numerous times.
7	COMMISSIONER TAYLOR: Commissioners, do
8	you have any other questions of any of these?
9	And let me just say that there was
10	three questions that Attorney Simpson had. There
11	were three questions that Attorney Simpson asked
12	and I do if he's here or anyone else here from
13	the ACLU, I do have a copy of those. The warden
14	has already answered those so I'm going to give
15	him a copy of it when you see him, so you do have
16	that.
17	So Commissioner White, if you think you
18	should read them because I can't see.
19	COMMISSIONER WHITE: Madam Chair, I do
20	believe these questions were covered in the
21	warden's presentation very thoroughly and very
22	thoroughly followed up by a number of different
23	Commissioners and put into additional questions
24	and I don't think there's a need to re-visit
25	this.

Michael Chambers, I've been a captain here 12 at the 4th Precinct since December. I'm going to 13 do my presentation. 14 Before I start, I just want to thank 15 the Southwest Church of God and Pastor Perkins 16 and Asst. Pastor Hill for the use of their 17 facilities tonight, we truly appreciate it. The 4th Precinct is located at 4700 18 19 West Fort and encompasses approximately 15 square 20 miles and is bound on the north by Michigan 2.1 Avenue, east by 14th Street, south by Detroit 22 River and west by Outer Drive. 23 According to the 2010 Census the 24 precinct has a total population of approximately



71,000 people of which 56.3 are Hispanic or

1	Latino, 21.5 percent are black or
2	African-American and 19.6 are white.
3	The 4th Precinct borders the
4	neighboring communities of Melvindale, Lincoln
5	Park, Dearborn and River Rouge. There are 22
6	schools of various levels in the precinct.
7	Some of the notable locations,
8	businesses and organizations in the 4th Precinct
9	include Patton Park, Clark Park, the Detroit Salt
10	Company, Southwest Solutions, the Detroit
11	Southwest Business Association and Marathon Oil.
12	At this point I'd like to mention the
13	outstanding work being done by the 4th Precinct
14	officers. As the Chief spoke to earlier, we have
15	over a 10 percent reduction in the 4th Precinct
16	as compared to last year at this time for violent
17	and property crimes.
18	Officers at the 4th through yesterday
19	had actually made 379 felony arrests, 169 adult
20	misdemeanor arrests, 44 combined juvenile felony
21	and misdemeanor arrests. They've recovered over
22	50 guns total this year, investigated over 5,500
23	vehicles, 15,000 people and issued over 4,400
24	tickets.



They've also boarded over 1,100 buses

1	and responded to over 10,200 calls for service
2	year-to-date. While the officers are doing an
3	outstanding job of crime fighting we understand
4	that additional strides can be gained by
5	partnering with outside entities.
6	Regular Detroit 1 and Southwest ComStat
7	meetings meeting are held during the month to
8	discuss crime trends, strategies and problematic
9	offenders. These meetings are attended by
10	representatives from law enforcement like Detroit
11	Public School Police, Michigan State Police, the
12	Corrections, FBI, U.S. Customs and the U.S.
13	Attorney's Office.
14	Additionally non-law enforcement
15	organizations attend these meetings to share
16	information and provide additional resources to
17	combat issues occurring in the 4th Precinct.
18	While not all inclusive, some of these
19	groups include Wayne State University Center for
20	Urban Studies, Congress of Communities, Urban
21	Neighborhood Initiatives, Black Family
22	Development, the Detroit Hispanic Development
23	Corporation, and Detroit Southwest Business
24	Association.



Information sharing is occurring on a

1	daily basis between precinct officers and our
2	stakeholders in the community. In addition to
3	the outstanding police enforcement being
4	conducted at the precinct officers are very
5	engaged in the community. We're very active with
6	community groups and meet monthly at various
7	locations throughout the precinct, many of which
8	I see here this evening.
9	Some of these groups include the
10	Springdale Block Club, Congress Communities,
11	Bridging Communities, United Citizens of
12	Southwest Detroit and Friends of Patton Park.
13	The neighborhood police officers along
14	with other officers who are assigned to the
15	precinct meet with them to address different
16	concerns and issues in the areas.
17	Currently the precinct has three
18	neighborhood police officers. If you would just
19	stand when I call your names, the officers are
20	Officer Juan Lebron, Officer Alfonso Luis and
21	Officer Thomas Denmark. Officer Lebron's area
22	consists of the northern part of the precinct
23	which is from John Kronk to Michigan Avenue.
24	Officer Luis, he covers the middle area



which is between West Fort and John Kronk and

1	Officer	Denmark	handles	the	south	area	which	is
2	south of	E West Fo	ort.

Over the past few months the NPOs and other officers have participated in a number of community events. Some of these include the Urban Safety Program's Board-Up Project around Harms Elementary, a community leadership luncheon, a health screening that was held at the 4th Precinct. We also attended some at Cesar Chavez School for a speaking engagement, Merritt Street clean-up. I have a long list here, but we've been doing a number of different things, pitch, hit and run at Patton Park, Picnic in the Park at Springdale Greendale Park, Motor City Makeover and the list goes on.

As you can see, the 4th Precinct understands the importance of collaboration with community organizations, businesses and residents. We know that collaboration with community organizations, business and residents, we cannot do it alone and we need to partner with the groups.

We feel we have strong partnerships here in the 4th and we're thankful to have the opportunity to share information in regards to



1	our community and precinct.
2	I just want to just thank everyone for
3	coming out and also I wanted to just let you know
4	at the conclusion when we're all over there is
5	more refreshments downstairs and I'd like to
6	thank Marathon and Ms. Robalo for laying it out
7	downstairs for us as well.
8	So at this point I would just open it
9	up for questions.
10	COMMISSIONER TAYLOR: Before you have
11	questions, I just want I don't know if you
12	said it before I got here, Commissioner, but this
13	district is unique in that both the appointed
14	Commissioner, that would be me, and Commissioner
15	Carter, the elected Commissioner from this
16	district, so that you know that.
17	Okay, are there any questions?
18	Commissioner WHITE: Yes, I did have
19	one brief question. Thank you, captain, for your
20	report. Arguably you have the furthest distance
21	to travel as relates to time to the DDC as we
22	were talking about.
23	What are your average times for
24	officers to transport and get back into service?
25	CAPT. CHAMBERS: Well, it would really



1	depend. I guess well, the processing there at
2	the precinct, if there was a backup there was a
3	number of different arrests that were in the
4	lobby, but if there's no one in the lobby the
5	officers convey them over there, they can process
6	quickly. They should be able to get back out
7	within an hour.
8	COMMISSIONER WHITE: Thank you.
9	COMMISSIONER TAYLOR: Yes, sir.
10	COMMISSIONER SHELBY: In regards to
11	safety in the community, how often do you meet
12	with the officials at Marathon Oil?
13	CAPT. CHAMBERS: How often? Well, we
14	have representatives come to our ComStat meeting,
15	I speak with them on a regular basis. We have
16	different officers that patrol down there,
17	they're doing some bridge construction. We stop
18	in and around that bridge construction, do some
19	different traffic enforcement, different things
20	like that.
21	We also come down to the original
22	Southwest Citizens meetings that's down here off
23	of Beecher, so we're active down here in this
24	community, in the 48217 community.
25	COMMISSIONER TAYLOR: Let me just



1		acknowledge that.
2		COMMISSIONER CRAWFORD: Yes, ma'am,
3		through the Chair. My question is to
4		Commissioner Carter do we have an update on that
5		evacuation plan for Marathon or that meeting
6		hasn't taken place yet?

8		process of setting up a date, so everything

Another individual who came to us specified even though there are many nurses there that in cases, specifically in his case of police misconduct that he was asked to take essentially Valiums or Vicodin or whatever, but was not conveyed to a hospital facility or an emergency facility. This was his contention.

But I think we need to have a public hearing or some other discussions and as for the young woman who can't be here, to question as to whether or not there is actual adequate sleeping

2	who've come to me who raised questions about
3	having to sleep on the floor.

11	that they're asked, probably 40 questions. I
12	don't know the exact number, but those questions
13	then trigger certain responses and medical
14	screenings and as the warden mentioned before,
15	there's registered nurses on duty 24 hours a day
16	that are reviewing the medical conditions that
17	detainees come in with.
18	They are able to dispense certain
19	medications, not higher level narcotic
20	medications. Those medications are being
21	dispensed regularly.
22	Today we send we then send anybody
23	that they can't treat at that level to the
24	emergency room. As recent as today we had a
25	meeting where we're working on a process to put



1	Telemedicine in place where the nurses when they
2	have the discussion with the detainee they're
3	then able to call a doctor 24 hours a day that's
4	on duty that can then prescribe certain
5	medications over the telephone to ensure that
6	everybody who comes in received their proper
7	medication.

And then any issues that they can't deal with we will continue to transport people to the emergency room. That is a win for us and a win for Wayne County, and this will be done through Wayne County because the County actually pays the bill every time we send somebody to the hospital. So an example we sent somebody in for an Albuterol when they have asthma, the County gets a bill for about \$2,200 from Detroit Receiving Hospital for one person.

COMMISSIONER TAYLOR: DC LeValley, we want you to be thorough and I'm going to -- Mr. Crawford, if you don't mind, have the gentleman do his two minutes because I don't want to hold him up and then I want you to stay because your information --

15	We right now dispatch them to the
16	Detention Center to pick up a detainee, take them
17	to the hospital, sit with them and then come
18	back, so we keep officers on the street answering
19	calls, the County gets a lower bill for their
20	hospital visits and we still ensure that
21	everybody at the Detention Center gets adequate
22	medical treatment, quality care.
23	With regard to Mr. Scott's statements,
24	if there are any particular individuals that had



issues with the Detention Center, we certainly

1	welcome any complaints and we will thoroughly
2	investigate those. I know that your staff at the
3	Chief Investigator's office will investigate
4	those and make recommendations.

3	abused, we stop. That individual has to go to
4	Detroit Receiving and be evaluated before they
5	even get to us in booking. So there's a
6	pre-booking phase where a lot of these questions
7	come up.

Now, what you got to remember, our population, as opposed to a prison -- why I keep saying Detroit Detention Center, because I think when we say Mound it confuses a Mound prison with a lockup, and I'm just saying that to speak to the bedding situation. You don't have beds in a lockup because you can be there anywhere between 2 hours to 72 hours. That in a prison long term situation.

So I got to keep saying Detroit

Detention Center because we're not Mound

Correctional Facility. With regards to our

medical, 15,000 since August1, not one individual
