24	CHAIRPERSON BELL: Thank you, sir.

1	Commissioners, you have the minutes from Thursday,
2	June 26, 2014. What is your pleasure?
3	COMMISSIONER TAYLOR: So moved.
4	COMMISSIONER MOORE: Second.
5	CHAIRPERSON BELL: It's been properly moved
6	and second. Ready for the question? Those in favor?
7	COMMISSIONERS: Aye.
8	CHAIRPERSON BELL: Those opposed? Motion
9	carried. We making great progress this afternoon.
10	COMMISSIONER TAYLOR: Yes, sir.
11	CHAIRPERSON BELL: As far as the chairperson's
12	report, I just want to acknowledge the past chair,
13	outstanding young lady, Commissioner Taylor, of her work
14	for the past year. I know she is relieved, somewhat.
15	But I just want to give her a round of applause and
16	thank her.
17	We are in transition. I had the opportunity
18	to meet with Commissioner Taylor this week. And she was
19	so kind to buy lunch. So, I love her. So, we are in
20	the process of this transition. I would hope that you
21	would bear with us and as we go through. Nothing is
22	going to change in terms of the thrust of this Board.
23	We have a great Board. And I'm looking forward to
24	working with them as far as being the Chair.
25	And my vice Chair is to my right, Commissioner



1	Carter. Let's give her a round of applause. Thank you
2	And one of the things I'd like to do at our next
3	community meeting is to give the commissioners the
4	opportunity to introduce themselves, to give a little
5	background to our community. I think that's sort of
6	crucial that they introduce themself, give a little
7	background in terms of their involvement with the Board
8	of Police Commissioners, et cetera. So, prepare
9	yourself for the community meeting.
10	I just want to have all the commissioners
11	would have that opportunity at the next meeting to
12	interact with the community initially to give them a
13	little background as far as their involvement because
14	one thing, all you need to know is a person one on one
15	in terms of just dialog. So, that is my brief report.
16	I will move forward in terms of reporting out in the
17	future. Thank you.
18	And now we are going to hear from Assistant
19	Chief Hall.
20	DEPUTY CHIEF HALL: Good afternoon. The
21	Chief's office does not have a report for today. But I
22	can continue to report that we are seeing double digit
23	reductions in crime. We are down approximately
24	29 percent as it relates to car jackings, 34 percent as

relates to robberies. We are continuing to see trending

1	down in the areas of crime. I just want to thank this
2	Board for your support, your continued support of the
3	Chief of Police and entertain any questions that you may
4	have.

I know that there's a different person that sits here very often. So, some followup questions you may have -- but I will entertain any questions and answer anything to the best of my ability.

COMMISSIONER CARTER: Through the Chair, can you tell us a little bit about the conference this past weekend?

asked about that. We had a wonderful neighborhood policing officers conference. About 178 community members came out, the Detroit Police Department, along with we were supported by the University of Detroit Mercy. And we held conferences on neighborhood policing issues, whether it was broken windows, just anything that related to community, all the community.

Mr. Welborne, you were there. Commissioner, you were there. We just thank you for your support.

We got a chance to interact, dispel some myths, introduce all the neighborhood police officers to their respective community members and just deal with the issues. This is part of Chief Craig's huge push to

1	wrap our arms around the community and for us to work
2	together. We recognize our dwindling numbers, although
3	we continue to try and increase our numbers, our
4	officers are leaving not because they are unnecessarily
5	unhappy but better opportunities.
6	Some people are reaching 25 years and
7	retirement. And we recognize that we are a lot smaller
8	than we were actually 15 years ago when I came on the
9	Detroit Police Department. So, with that in mind, we
10	know that it takes a village. And we are just reaching
11	out, wrapping our arms around the entire city, working
12	together with police, businesses, community, clergy,
13	everyone working together to continue to reduce crime.
14	It was a great summit. We had a great time,
15	lunch, breakfast. And we talked about real serious
16	issues and quality of life issues and problem solving
17	and solving those issues, not just talking about them as
18	a whole but actually what we are going to do and motions
19	that are put in place to solve neighborhood problems.
20	So, that was what we did this Saturday, and it was very
21	successful.
22	COMMISSIONER CARTER: Thank you.
23	CHAIRPERSON BELL: Commisisoners, any other
24	questions or concerns? Assistant Chief Hall, you might



want to introduce any other staff members or command

1	officers in the room.
2	DEPUTY CHIEF HALL: Deputy Chief, but I'll
3	take the promotion. We have Commander Johnnie Thomas in
4	the audience. He is from our internal control what
5	is it, professional standards Bureau as well as
6	Lieutenant Misel (phonetic). I don't know her official
7	title.
8	LIEUTENANT MISEL: Planning.
9	DEPUTY CHIEF HALL: Planning. I'm sorry. We
10	change a lot. So, we're planning. So, that's who is
11	here today.
12	CHAIRPERSON BELL: Thank you. Any other
13	remarks or comments from the commissioners? I think at
14	this time, before we move into the next item of business
15	as far as reports, please, do we have Chief Investigator
16	Drake, do you have anything to share with us?
17	CHIEF INVESTIGATOR DRAKE: Not today, no,
18	thank you, sir.
19	CHAIRPERSON BELL: Any other reports? I would
20	like to ask our Board secretary, George Anthony, to
21	respond to the issue that came up by Commissioner Burton
22	at the last meeting in reference to a quorum for the
23	Board of Police Commission meeting. I think it's sort
24	of crucial that we put something on the record in terms
25	of clarification to that matter.



1	And Board Secretary Anthony prepared a
2	two-page detailed letter in reference to that. And I
3	would like him to highlight some of these concerns for
4	the public and for the commissioners to be informed in
5	reference to how we conduct business in terms of
6	election by Charter and by the mandate and bylaws of the
7	Board of Police Commissioners.
8	SECRETARY ANTHONY: Thank you, Mr. Chair.
9	This is a letter addressed to you dated July 2, 2014.
10	And it regards the quorum for the Board of Police
11	Commissioner meetings.
12	"Dear sir, last week the following issue was
13	presented before the Board of Police Commissioners,
14	whether the Board could conduct elections for new
15	officers in the absence of a full Board as defined by
16	the 2012 Detroit City Charter. In response, Board
17	members were advised that the issue was not whether
18	there was a full Board present to conduct business, but
19	whether there was a quorum present to carry on the
20	official business of the Board. This letter responds to
21	your request for a formal response.
22	As indicated above, the Charter provides for
23	an 11-member Board. However, Roberts Rules of Order
24	requires a quorum of a commission or assembly to conduct

business. The 11th edition of this publication states

2.1

in pertinent part the following: Quorum of members.
The minimum number of members who must be present at the
meeting of a deliberative assembly for business to be
validly transacted is the quorum of the assembly. The
requirement of a quorum is a protection against totally
unrepresentative action in the name of the body by an
unduly small number of persons. That's found in
Chapter 11 or Chapter 2, Section 3.

The Board has adopted Roberts Rules as the governing authority for its meetings, Article 11. The Board's bylaws define a quorum as a simple majority of its members. In addition, the bylaws state the vote of a majority of the members present at a meeting at which a quorum is present constitutes the action of the Board, except for otherwise prescribed by the Charter or applicable law, Article 6, Section 7.

In applying the formula, it seems clear that the Board can conduct business with at least six members present. Caveat, in some disciplinary matters, a two-third majority vote of the Board is required; that is seven members. Thus, the nine members in attendance last week constituted a quorum of the Board, permitting it to carry on the official business of the Board.

Another issue, although not discussed, was the requirement to elect new officers for the ensuing term,



1	2014-2015. Section 7-802 of the City Charter provides
2	in pertinent part that the Board shall elect a
3	chairperson annually. A member of the Board may not
4	serve consecutive terms as chairman. In addition, the
5	Board's bylaws state the following: The members of the
6	Board shall elect officers annually from its membership
7	by majority vote. The term of office is for one year or
8	until the successor has been elected.

Newly elected officers shall take office on July 1. The chairperson may not serve consecutive terms. Please note the provision in the bylaws that allow for the extension of time for a sitting Chair to temporarily remain in office pending the election of his or her successor. This provision seems designed to prevent a gap in leadership. It also prevents a chairperson from serving consecutive terms.

Accordingly, if a quorum is present, the Board is required to elect new officers annually by majority vote, and newly elected officers shall take office on July 1.

At its regularly scheduled meeting last week,

June 26, 2014, the Board with a quorum of nine members

selected new officers for the 2014-2015 term. In my

opinion, the actions taken by the Board was appropriate

and in conformity with the Charter and the bylaws of the

1	Board. Respectfully submitted."
2	CHAIRPERSON BELL: Thank you, Mr. Anthony.
3	What is the pleasure of this Board to receive that
4	communication?
5	COMMISSIONER MOORE: Mr. Chair, I move that we
6	accept the legal opinion of Secretary Anthony.
7	COMMISSIONER TAYLOR: Second.
8	CHAIRPERSON BELL: It's been properly moved
9	and second. Questions? Discussion? Those in favor?
10	COMMISSIONERS: Aye.
11	CHAIRPERSON BELL: Those opposed? Motion
12	carried. Thank you. That indicates that Madame Chair
13	Taylor conducted the meeting according to the Charter
14	and the bylaws, and it was in order, it was proper. So,
15	I just we just wanted to make sure of that, it's on
16	the record in terms of what transpired from that meeting
17	last week. So, we are in good order. And that's a good
18	thing because we always want to be in good order in
19	terms of following the Charter and the process.
20	New business. Any new business that we need,
21	Commissioners, any new business? Any old business?
22	COMMISSIONER CRAWFORD: Yes, sir. Mr. Chair,
23	under old business, there were two issues that were
24	brought before this Board in previous weeks. One was a
25	request and also it was voted on by the Board, that was



1	due July 1st, in terms of employees of the Board or
2	appointees of the Board, that they in writing a
3	justification and assessing for the use of a city
4	vehicle. We received that in writing today from Board
5	Secretary, George Anthony, and also Chief Drake of the
6	Chief Investigator's Office. And I'm going to thank
7	them for their response.

Also, just for matter of record, I read both responses. And I differ with a little bit of some of what Chief Drake wrote. But that's kind of here nor there. But my stance on the issue of vehicles — and this goes back to 1990 when the abolishment of residency occurred by the State of Michigan and I came before the Board of Police Commissioners on several occasions and stated on the record — it's in the archives — go back to the spring of '90 in terms of my stance on how I feel about vehicles driven — used and driven outside the City of Detroit.

However, this occurred before this Board was present. So, maybe perhaps -- and it's not -- let's just say the Board, since it's already occurred, then maybe it should stay the way it is perhaps. As you well know, there's been a lot of issues about vehicles even most recently with my council member in my district, Scott Benson and also, too, beginning when I took a seat

1	on this Board, there was always I was always raising
2	the issue of driver's license, people not owing tickets,
3	the use of vehicles, et cetera, et cetera. So, that's
4	I just want to thank you for the response. And we do
5	have the information. It's in writing.

16	thank you. I don't know where they came from. I don't
17	know if it was Number 11, Number 6, Number 2. I don't
18	know. They were beautiful.
19	DEPUTY CHIEF HALL: On behalf of the police
20	department, you're welcome.
21	MS. WELLS: They were beautiful, absolutely
22	impressive. The second thing I'd like to bring to your
23	attention is that I was robbed at gun point. I, by my
24	trade, do things a little differently than a regular
25	citizen. So, I got a real good look at him. And I have


