2	CHAIRPERSON BELL: Good afternoon. Welcome
3	to the weekly meeting of the Board of Police
4	Commissioners. It's good to see all your smiling
5	faces. This is another day of our business at hand. I
6	am Willie bell, your chair of the Board of Police
7	Commissioners. And at this time, I'm going to ask
8	Commissioner Vann to do the opening prayer, please.
9	(Invocation given.)
10	CHAIRPERSON BELL: Thank you. Commissioner
11	Vann, thank you for the prayer. The meeting is called
12	to order. I'm going to ask our board secretary George
13	Anthony to introduce the rest of the board.
14	SECRETARY ANTHONY: Thank you, Mr. Chair.
15	For the record, George Anthony, secretary to the board.
16	Vice Chair Lisa Carter?
17	Commissioner Willie E. Burton?
18	COMMISSIONER BURTON: Present.

- Mr. Chair, you have a quorum.
- 14 CHAIRPERSON BELL: Thank you, sir. And to my
- 15 extreme left is sitting in for the Chief of Police,
- 16 James E. Craig, his assistant Chief Steve Dolunt. Good
- 17 to see you, sir.
- ASSISTANT CHIEF DOLUNT: Good afternoon, sir,
- 19 and board.
- 20 CHAIRPERSON BELL: Would you introduce the
- 21 staff of the Board of Police Commissioners.
- 22 SECRETARY ANTHONY: Thank you, sir. Seated
- 23 in front is Ms. Pamela Davis Drake, our chief
- 24 investigator. Next to her is Attorney Linda Bernard,
- our attorney to the board. Mr. Robert Brown is our



- 1 office manager seated to my right. Sergeant Allen
- 2 Quinn is currently standing at the podium. He's
- 3 recording our proceeding. And Ms. Trisha Cameron from
- 4 Hanson Court Reporting Service is taking the official
- 5 transcript. That completes the introduction.
- 6 CHAIRPERSON BELL: Thank you, sir.
- 7 Commission, you have before you an agenda for
- 8 this meeting. The chair would entertain a motion.
- 9 COMMISSIONER VANN: Move for the adoption,
- 10 Mr. Chair.
- 11 COMMISSIONER MOORE: Second.
- 12 CHAIRPERSON BELL: It's been properly moved
- 13 and seconded. Discussion? Those in favor?
- 14 COMMISSIONERS: Aye.
- 15 CHAIRPERSON BELL: Those opposed? Motion
- 16 carried for the agenda.
- 17 The next item of business would be minutes
- 18 from Thursday, January the 15th, 2015. You have the
- 19 minutes from that meeting, a summary of the minutes.
- 20 The chair would entertain a motion to approve the
- 21 minutes.
- 22 COMMISSIONER TAYLOR: I move.
- 23 COMMISSIONER MOORE: Second. Just a comment
- I have for the record. There was a memoranda, if I
- 25 understand, requested during last week's meeting. They



- 1 weren't included, so I just wanted to amend the minutes
- 2 to include the --
- 3 CHAIRPERSON BELL: I assume by a count of
- 4 consent the body would entertain that notation on the
- 5 minutes in terms of -- do you follow, Mr. Anthony, that
- 6 he requested from the department --
- 7 SECRETARY ANTHONY: Is it my understanding
- 8 that you wanted the memorandum included with the
- 9 minutes; is that the substance of it?
- 10 COMMISSIONER MOORE: Just include that it was
- 11 a part of the meeting and it wasn't included in the
- 12 secretary's notes. So just add that in there.
- 13 SECRETARY ANTHONY: Oh.
- 14 CHAIRPERSON BELL: So we all on the same page
- 15 now? The chair would entertain a motion. Those in
- 16 favor?
- 17 COMMISSIONERS: Aye.
- 18 CHAIRPERSON BELL: Motion carried. Thank
- 19 you, for that clarification, Mr. Moore.
- I just want to say before we get into the
- 21 rest of the meeting, I'd like to recognize the
- 22 Honorable Donald Milhouse from --
- MS. MILHOUSE: Donna. Donna.
- 24 CHAIRPERSON BELL: What did I say?
- MS. MILHOUSE: It's Donna.



- 1 CHAIRPERSON BELL: I'm sorry. Okay. Thank
- 2 you for coming out for this special occasion. Any
- 3 other -- all of you are VIPs. But any others that we
- 4 failed to recognize or would like us to recognize?
- If not, it's good to see all of you here once
- 6 again. Thank you. As far as my report, I would just
- 7 reserve some brief comments as we move right along in
- 8 terms of the agenda items.
- 9 The secretary's report, you can move right
- 10 into that, if the secretary is prepared.
- 11 SECRETARY ANTHONY: Thank you, Mr. Chair.
- 12 This is the secretary's report for citizen complaints
- 13 received in December of 2014. The monthly count of
- 14 complaints for December 2014 was 87, compared to the
- same period in 2013 of 89. It represented a 2 percent
- 16 decrease.
- 17 The year to date figures for 2014 January to
- 18 December was 1290 compared to the same period for 2013
- 19 of 1298. That represented a 1 percent decrease.
- 20 At the end of December 2014, the office of
- 21 the chief investigator had open investigations, 193;
- 22 cases filed 1290; cases closed 1371. Of the 87 cases
- 23 filed, 38 percent involved unknown officers. The
- 24 alleged known units involved that were leading in
- 25 complaints filed in December 2014 were, the 12th



- 1 precinct at 11 percent; 7th Precinct at 7 percent; the
- 2 8th precinct at 5 percent.
- The 87 cases filed in December 2014 involved
- 4 187 allegations where the leading areas of concern
- 5 we're demeanor at 28 percent; procedure 23 percent;
- 6 service 16 percent; force 10 percent.
- 7 Closed complaints. There were 98 cases
- 8 closed in December of 2014. And they involved 194
- 9 allegations where the findings were not sustained at 49
- 10 percent; exonerated at 18 percent; unfounded at 18
- 11 percent; and sustained at 11 percent. The leading
- 12 areas of concern in the 98 closed cases were in
- 13 December of 2014 were procedure at 44 percent; demeanor
- 14 at 28 percent; service at 10 percent; and force at 5
- 15 percent.
- 16 That concludes the report on the citizen
- 17 complaints that were received in 2014. And as usual,
- 18 there is an analysis of the unknown officer
- 19 allegations, also part of your package.
- 20 CHAIRPERSON BELL: Commissioners, any
- 21 comments or questions in reference to the board
- 22 secretary's report? I assume that we can move on then.
- 23 Thank you, sir.
- 24 SECRETARY ANTHONY: Thank you, sir.
- 25 CHAIRPERSON BELL: Assistant Chief Dolunt, we



- 1 are now at item No. 10 as far as the Chief of Police.
- 2 And you as assistant chief can respond.
- 3 ASSISTANT CHIEF DOLUNT: Okay. On behalf of
- 4 the chief, he couldn't be here. We had an officer take
- 5 his own life this morning from the 12th precinct, and
- 6 the chief's been out in the field of the 12th and the
- 7 9th Precinct. And we've had people out with the
- 8 family, and we're grieving right now. So I'm here.
- 9 He's not.
- 10 A couple other things is tomorrow at 10:00 at
- 11 Greater Grace we have the graduation of a new class.
- 12 We have appointments to detective. And we have people
- 13 that have been promoted over the last few months to
- 14 deputy chief, commander, and captain being recognized
- 15 tomorrow, as well as the graduates of L pack and S pack
- 16 tomorrow. I believe it's eight lieutenant's and I
- 17 think sixteen sergeants. And that's tomorrow.
- 18 All of our crime is down except for
- 19 homicides. Now, granted last year we had, I don't
- 20 know, a foot of snow and 10 below zero, but I still
- 21 don't like that. I'm not happy about that at all.
- 22 Again, all other crimes are down except for homicide,
- 23 and we're actively pursuing that.
- Most of the cases -- actually, 75 percent of
- 25 the cases have been no perpetrators, just a matter of



- 1 (inaudible). So that's where we're at up to date.
- 2 So far, knock on wood, no problem at the Auto
- 3 Show, and we've had a good presence out there. I think
- 4 that's about it.
- 5 CHAIRPERSON BELL: Commissioners, any
- 6 questions or comments for the assistant chief?
- 7 COMMISSIONER MOORE: Through the chair.
- 8 Assistant chief, how many FBI investigations are
- 9 currently taking place within the Detroit Police
- 10 Department, whether initiated by the chief's office or
- 11 by the FBI?
- 12 ASSISTANT CHIEF DOLUNT: Honestly, I don't
- 13 know for sure. I don't know if this is the right forum
- 14 to mention that. So I think we have to talk offline
- about that because I don't want to give you the wrong
- 16 figure because I don't really know all the correct
- 17 figures because the chief deals with the FBI, I don't.
- 18 We can talk offline about that. No problem.
- 19 COMMISSIONER VANN: Mr. Chair, I don't know
- 20 what the protocol of this board has been, but I just
- 21 think it would be an honorable thing for us to do to
- 22 have a moment of silence for the fallen officer. It
- 23 doesn't matter to me what the circumstances are. I
- 24 think that this board ought to show recognition and
- 25 regard for that person's service.



- 1 CHAIRPERSON BELL: I agree with you.
- 2 Commissioner Vann, a motion of silence for the deceased
- 3 officer.
- 4 (Moment of silence given.)
- 5 CHAIRPERSON BELL: Thank you. And keep the
- 6 officer's family and the other compadres in prayers for
- 7 the circumstance surrounding this bereavement period
- 8 time. So thank you, Commissioner Vann.
- 9 Commissioner Shelby?
- 10 COMMISSIONER SHELBY: Through the chair, this
- is a note of contention. As a former commanding
- 12 officer in the internal affairs division, whenever
- 13 there is an investigation taking place within the
- 14 police department, especially involving grand jury, no
- one is allowed to talk about that until public comment
- 16 has been made from the attorney general.
- 17 COMMISSIONER MOORE: I concur with that. At
- 18 the same time, I've read two different stories in the
- 19 newspaper publicly, but it wasn't introduced here at
- 20 this board in this forum. So I was wondering exactly
- 21 how many are taking place. Thank you.
- ASSISTANT CHIEF DOLUNT: Well, there's an old
- 23 statement that says loose lips sink ships. And if the
- 24 FBI wants to release things they're investigating, they
- 25 can. Again, though I'm the assistant chief in charge



- 1 of enforcement operations, I do not have a direct line
- 2 to the public corruption unit of the FBI. I've talked
- 3 to the FBI myself. I said if you have investigations,
- 4 you need to move forward because historically the
- 5 federal government moves at a snail's pace. And I
- 6 think that sometimes people carry an undue burden for a
- 7 long time when they either are the subject or even
- 8 ancillary part of the investigation, and I don't think
- 9 that's fair to the individual or the department.
- 10 So, again, if the chief wants to tell you,
- 11 that's cool. I don't really know. I'm sorry,
- 12 Commissioner Moore. I just don't know the answer.
- 13 CHAIRPERSON BELL: Thank you, sir. Any other
- 14 response? Assistant chief, would you introduce others
- in your command or other officers with DPD, please.
- ASSISTANT CHIEF DOLUNT: Well, Mr. Milhouse
- 17 is here. Are you mister now, or are you officer still?
- 18 Aren't you getting an award or something? That's why
- 19 the family is here?
- MR. MILHOUSE: My wife is here.
- 21 ASSISTANT CHIEF DOLUNT: Are you mister or
- 22 are you still officer?
- MR. MILHOUSE: Still officer until January
- 24 30th.
- ASSISTANT CHIEF DOLUNT: You hope.



- 1 Seriously, congratulations.
- 2 MR. MILHOUSE: Thank you.
- 3 ASSISTANT CHIEF DOLUNT: Thank you for
- 4 showing up, Mrs. Milhouse.
- 5 Celia Washington is here, she's our legal
- 6 advisor. She hates when I talk to her. Who else is
- 7 here, Perkins is here, Bettison, Deshaune Simms. What
- 8 is your title, Hayes, Scott Hayes.
- 9 MR. HAYES: Director.
- 10 ASSISTANT CHIEF DOLUNT: Director. And Jack.
- 11 And Jack, the contractor. Okay. Way in the back, we
- 12 have the entire PIO. We have a new director. June
- 13 West, right? Is she civilian deputy chief? We have --
- 14 I don't know if you guys knew that. We have a new
- 15 director. June West used to work for Wayne County.
- 16 COMMISSIONER CRAWFORD: Yeah, I know her.
- 17 ASSISTANT CHIEF DOLUNT: Oh, you know her?
- 18 Her title is director of media relations.
- 19 CHAIRPERSON BELL: Is that part of the media
- 20 reporting out?
- 21 OFFICER BETTISON: Second Deputy Chief.
- ASSISTANT CHIEF DOLUNT: Oh, that's part of
- 23 that?
- OFFICER BETTISON: I just wanted to give the
- 25 correct title. Second Deputy Chief.



- 1 ASSISTANT CHIEF DOLUNT: She's deputy chief?
- 2 OFFICER BETTISON: Yes.
- 3 ASSISTANT CHIEF DOLUNT: She's not here?
- 4 OFFICER BETTISON: No.
- 5 ASSISTANT CHIEF DOLUNT: Anyway, okay. So
- 6 that's it.
- 7 CHAIRPERSON BELL: Thank you, sir. And now
- 8 we going to hear from the media relations section or
- 9 department.
- 10 SERGEANT WOODY: Good afternoon, AC Dolunt.
- 11 Sergeant Woody from media relations. I want to take a
- 12 quick second just to introduce part of my staff.
- I apologize. The rest of my staff is absent
- or upstairs working very diligently and hard for the
- 15 citizens.
- I have Officer Madera and Officer Nicole
- 17 Kirkwood, key members of my staff. They're very
- important to what we do upstairs, and I would be
- 19 completely useless without them.
- So moving on to a little bit of what we do in
- 21 our areas of responsibility here at media relations.
- 22 We obviously respond to a lot of citizen and media
- 23 queries. A lot of times we get phone calls, questions
- 24 regarding events, things that happen inside the police
- 25 department. So we work with those entities, including



- 1 the assistant chief, the chief, and the heads of all
- 2 the departments, to make sure that we get the accurate
- 3 information out to the citizens as quickly as we
- 4 possibly can.
- 5 We arrange and manage interviews for the
- 6 chief and department executives. We do a ton of
- 7 research, a ton of research, to make sure that what we
- 8 are saying is accurate and complies with the standards
- 9 across the country.
- 10 We do web and internet-based communications.
- 11 What I mean by that is that we -- we're responsible for
- 12 a number of social media things, and I think I'll talk
- 13 a little bit more about that later on in the
- 14 presentation. But we use -- we use things such as, you
- 15 know, Facebook, Twitter, YouTube.
- Recently when I first began about almost 17
- months ago, we had approximately 5,000 Facebook
- 18 followers. I tasked my team with getting those numbers
- 19 up as quickly as possible and getting the word out that
- 20 we had a new team onboard and we were going to be as
- 21 transparent as we could and answer questions and
- 22 communicate with our public. And I think within about
- 23 six months we were up over 10,000. Six months after
- that and currently to date we're up over 23,000
- 25 followers. That's just on our Facebook. When you add



- 1 in our Twitter, which is over 12,000, YouTube is
- 2 somewhere around 6,000 right now -- and then of course,
- 3 you know, recently, last December, early December, we
- 4 released police -- a new smart phone application called
- 5 DPD Connect, which I'll talk a little bit more about
- 6 later on.
- 7 So some more of our areas of responsibility.
- 8 We deal with some citizen complaints. And I don't mean
- 9 them in a typical fashion where they have complaints
- 10 about specific officers or demeanor or procedure.
- 11 Those ones we make sure that we document and refer to
- 12 the appropriate entity for investigations, and those
- 13 are forwarded on.
- 14 What I mean are those complaints where a
- 15 citizen has an issue and they do call the police
- 16 department and for whatever reason they feel like their
- issue wasn't resolved as efficiently as they thought it
- 18 would be. So what our officers will do in media
- 19 relations is we try and make sure they're facilitated
- 20 with proper information and get them to the proper
- 21 agency or entity that will handle their complaints.
- 22 And generally we're very successful. We have a very
- 23 good success rate, and they call back and thank us for
- 24 it.
- Usually we get -- you know, we answer the



- 1 phone, they're pretty hostile with us. By that point
- 2 they've been given the runaround. We're usually -- we
- 3 have a very open mind and keep a -- very patient, very
- 4 good level of patience with them. So they do like to
- 5 speak to us, and we have good personality up there. We
- 6 have a lot of good officers that are willing to help.
- 7 So that gets done.
- 8 So we do image and branding for the
- 9 department as well. You'll see a lot of our stuff out
- 10 there right now. For example, we're currently working
- on some issues with our logos. And at the very
- 12 beginning you saw an image that we're currently using
- 13 for -- this is our 150th year. This is our birthday
- 14 celebration.
- We are actually throwing a silver and blue
- 16 gala ball. I don't know if you've seen that or heard
- of this yet. There's been fliers and a lot of hubbub
- 18 going around. When we initially started that program,
- 19 we thought there would be about 300 participants. We
- 20 didn't know there would be such a big response. By the
- 21 time we opened up the sales of tickets, we had to
- 22 change venues. And we now are close to 1,000 attendees
- 23 at this point. We had the venue moved, and now we're
- 24 having it at Cobo Hall. So it will be very exciting,
- 25 and there's a lot going on in that presentation as



- 1 well.
- In that capacity, media relations will be
- 3 responsible for producing a historical video. Again,
- 4 we do a lot of the research. So we're not so much
- 5 keeper of the record, so to speak, but we do -- my team
- 6 is very good at doing research. They're very specific
- 7 on the research and scholarly on their research. So we
- 8 were tasked with a lot of that stuff.
- 9 We keep current on newsworthy events. So
- 10 just about every channel, every newspaper, whether it
- 11 be cable, print, magazine articles, whatever it is, we
- 12 scour 24/7 looking for news articles that are relative
- 13 to Detroit. Whether they happen in Detroit or it's
- 14 something that could happen in Detroit, we're always
- 15 trying to stay ahead of the mark, make sure that
- 16 whatever concerns are happening across the country we
- 17 are taking proactive measures to ensure that they do
- 18 not happen again. Or if it's something in a positive
- 19 manner, that we reach out and see if we can bring it
- 20 here, such as with the program that we're talking about
- 21 launching very soon which is called nextdoor.com.
- This is a web-based application that will
- 23 connect our NPOs, our neighborhood police officers,
- 24 with community-based organizations, our block clubs,
- 25 radio patrols, that sort of stuff. It's kind of like a



- 1 Facebook really. It also is an app that you could put
- 2 on your smart phone as well. So something that was --
- 3 started across the country, and we saw it starting to
- 4 pick-up steam. And I believe Commander Bettison
- 5 brought it to us, and we started researching it. And
- 6 we have been working with their team and we're ready to
- 7 go. So hopefully we'll see that very, very soon out
- 8 there.
- 9 Currently media relations consists of -- I'm
- 10 sorry. I apologize. I had June West as a director. I
- 11 just found out she's a Second Deputy Chief. My
- 12 apologies for that. She just started two and a half
- 13 days ago. But we're welcome to have her here. She
- 14 comes with a ton of experience working in private and
- 15 public sector. So we're looking very forward to having
- 16 her experience on our staff. As you are aware, we have
- 17 officers. We are all police officers, so having that
- 18 dual role and dual function on our staff will be
- 19 extremely beneficial.
- Then you have one sergeant, four officers,
- 21 and we took on three students interns, two from Wayne
- 22 State and one from U of M. And they all specialize in
- 23 journalism, that's their main area. One of them is
- 24 actually a graduate of Wayne State. And her degree is
- 25 in journalism, and I believe she also has a secondary



- 1 in fine art photography. So they are -- just in the
- 2 two weeks they've been here have taught us a ton just
- 3 in imaging alone and just in writing, really. I mean,
- 4 again, we're cops so everything is always write this,
- 5 observe that, a lot of jargon. So they're teaching us
- 6 a lot. It's been a pleasure to have them as well.
- 7 So some of the citizen requests that we get
- 8 at media relations, just general information really.
- 9 If you were to Google the Detroit Police Department
- 10 information line, you'll see public information come
- 11 up, which is what we used to be called. We just
- 12 recently changed our name to media relations because
- more specifically that's exactly what we're supposed to
- 14 be doing. That's exactly what we try to do more so.
- 15 But the office of public information's phone line is
- 16 still our line. So that's kind of like the 411 line
- 17 for the department, so to speak.
- So when people call and they just have
- 19 general information questions, who can I call about
- 20 this, who can I call about that. So we try and get
- 21 them in the right area.
- We also talk about referrals to various DPD
- 23 units. Again, the complaints -- we answer the chief's
- 24 line as well. A lot of calls that come in on the
- 25 chief's line are -- they're a lot of citizens that call



- 1 him wanting to thank the department, they want to just
- 2 reach out and see what they can do to help us out. So
- 3 we always make sure that they get connected with the
- 4 right people.
- 5 It's amazing and it's very humbling to hear
- 6 the community that we serve give us a call and tell us
- 7 thank you and where can we fit in, what can we do, how
- 8 do we help. And so we're always looking for those
- 9 people that are willing to engage with us, and we get
- 10 them connected with the right people as well.
- We do the media interview requests obviously
- 12 and again social media engagements. We also strive to
- 13 support the department's overall crime reduction
- 14 efforts. We do this by informing and educating our
- 15 public. What I mean by that, again, is we want to make
- 16 sure that -- you know, I apologize if there's any media
- 17 news fans in here. But always -- they don't always get
- 18 it right. So we always try to make every effort to
- 19 ensure that our citizens and our public gets the most
- 20 accurate information in whatever method we can deliver
- 21 that to. We want to make sure that we engage them in
- 22 dialogue, we give them a voice, we want them to be
- 23 heard, and we want -- we also want to be heard. So we
- 24 feel that that reduces a lot of the misunderstandings
- 25 and the conflicts between us and our community. And we



- 1 feel that that -- that drives a lot of positive
- 2 relationships throughout our city.
- 3 We work by changing the perceptions about the
- 4 Detroit Police Department. Again, how we go about this
- 5 is we try and find those stories that most impact the
- 6 neighborhoods and the communities. I mean, I know that
- 7 there's a lot of great things going on in the downtown
- 8 area and we're very grateful for that. There's also a
- 9 lot of great things going on in the neighborhoods.
- So what we do on a daily basis is we have
- officers when they come in first thing in the morning,
- 12 they start scouring for those occurrences overnight
- 13 that we got the -- you know, we got a band of
- 14 carjackers off the street, and we get that information
- out to our citizens and specifically those
- 16 neighborhoods as quickly as we can to let them know
- 17 hey, look, we got these guys, you can feel safe, we did
- 18 it, thank you for your help, thank you for your
- 19 involvement, and this is what we're doing. We believe
- 20 that builds some confidence in us and changes
- 21 perceptions about our department. Again, being
- 22 completely transparent.
- 23 When Chief Craig first started his tenure
- 24 here, that was one of the things he was adamant about,
- 25 being quick, being transparent with our information,



- 1 getting it out there as quickly as we can so that the
- 2 public -- you know, we don't hide behind things.
- 3 Making sure that they have all the accurate information
- 4 as quickly as they could get it.
- 5 So increasing positive attention through all
- of these resources here, local news media, print,
- 7 television, radio, national press coverage, Facebook,
- 8 Twitter, and of course DPD Connect, which is one of
- 9 mine because that was kind of a baby of mine. I was
- 10 very proud of it. Actually, my team put in a lot of
- 11 hard work into that in designing that. It is a phase 1
- 12 app. I know it's very -- it's very elementary. But it
- 13 -- it gets a lot of good positive feedback for the
- 14 department. And citizens are actually quite shocked to
- 15 learn about it. They love it and they use it. And it
- 16 -- it does really help. There are a number of apps
- 17 that the city does offer that we try to push out there
- 18 for the citizens to engage, not just the police
- 19 department but city services in general. So we're
- 20 always working with them to make sure they have the
- 21 most current information.
- 22 And, again, these are our YouTube channels,
- 23 Facebook channels, Twitter, and of course DPD Connect,
- 24 which is available in iTunes and Google Play stores
- 25 ready for downloads, free download. So anybody can get



- 1 it. And the DPD Connection has four different sections
- 2 to it. There's a news section, which we constantly put
- 3 in our major crime summary reports. We post wanted
- 4 posters, missing persons posters. We update the
- 5 citizens in the community on what's going on in their
- 6 neighborhoods with flyers of events that police are
- 7 hosting. For example, coming up in February we have a
- 8 precinct that's hosting an elderly citizens dance. So
- 9 they'll be arranging for rides for them. So we posted
- 10 that flyer up on our Facebook page, so that it can get
- 11 out to the citizens so we can get some attendees and,
- 12 you know, not just the younger citizens but some of our
- 13 elderly a time to get out relax and enjoy the city as
- 14 well. So we post things like that.
- 15 One of the other sections that there are is
- 16 an anonymous tip section, which is our biggest section.
- 17 Now on here, on that section, you can go in there and
- 18 submit an anonymous tip and it truly is anonymous. It
- 19 comes to us completely scrubbed out. We don't have any
- 20 identifying information, no cellphone numbers, e-mail
- 21 addresses, and you can leave a tip about a crime. It's
- 22 not usually -- it's not intended for a crime in
- 23 progress. And if you open up the app, when you look at
- 24 it, it's one of the first things on there that says
- 25 please do not use this for z crime in progress, that is



- 1 what 911 is intended for. And we have a button which
- 2 will dial 911 for you inside the app. It's highlighted
- 3 in red, and it's rather large. And I'm all thumbs so I
- 4 know it works well.
- 5 Another one of those sections in there is it
- 6 provides a phone directory for the entire department
- 7 and the neighborhood police officers in every single
- 8 precinct. I wanted to give out their home addresses,
- 9 but they were a little reluctant. So it gives out
- 10 their phone numbers, e-mail addresses. And it makes
- 11 them acceptable to the citizens they serve as well. It
- 12 also gives out the location of the precinct, and it
- 13 will dial the phone number for you if you wish.
- 14 So the DPD Connect app is available. We are
- working on a phase 2 for it, which hopefully will be
- out sometime in late spring or early summer, which we
- 17 plan will have a lot more upgrades to it to include
- 18 being able to submit photographs along with your tips,
- 19 being able to have Geocoding for mapping, basically hit
- 20 a button and find out where you're at and where the
- 21 closest precinct is at. So it comes with a lot of
- 22 things. We're still currently reviewing a lot of the
- 23 comments and reviews.
- As of check this morning, we had over 8,000
- downloads so far which is a pretty good benchmark if



- 1 you ask me for only being in -- available for two
- 2 months. So I think we're doing well.
- 3 That's pretty much it for media relations.
- 4 Thank you. Any questions?
- 5 CHAIRPERSON BELL: Could we just pause. I
- 6 just want to acknowledge our vice chair joining us
- 7 approximately 15 minutes ago, Commissioner Carter, and
- 8 Commissioner Mallet joining us. He's sitting back. He
- 9 joined us about five minutes ago. Thank you. Good to
- 10 see you.
- 11 Commissioners, do we have any questions,
- 12 concerns in reference to Sergeant Woody reporting out?
- 13 COMMISSIONER SHELBY: What's your office
- 14 number.
- 15 SERGEANT WOODY: My office number is
- 16 596-2200.
- 17 COMMISSIONER SHELBY: A couple questions. Do
- 18 you feel as if the major news organizations that report
- out to the Detroit Police Department (inaudible.)
- 20 SERGEANT WOODY: I'm kind of bias so I think
- 21 -- I think that they -- here's my honest opinion is
- 22 this. Sir, my honest opinion is that we in Michigan,
- 23 the media market here in Michigan -- I've had training
- out on the west coast as well, so I've seen the markets
- 25 across the country. I can tell you that here in



- 1 Michigan we subscribe to the east coast news market,
- 2 which is basically tabloid journalism. They get theirs
- 3 from across the pond in England. So the -- the more
- 4 drama that's involved in a news story the better.
- 5 Factual information tends to escape them.
- The things that are really important, I think
- 7 that -- I think they're doing an injustice to some of
- 8 our citizens, and I think they are doing an injustice
- 9 to the city and the department. Absolutely. But
- 10 that's why you have a team like I have, because we are
- 11 able to make those relationships with our media
- 12 partners and we foster them and we have those
- 13 conversations.
- 14 Sometimes we debate like an old married
- 15 couple with a lot of them. But we get our points
- 16 across, and it's important that we do those things
- 17 every once in a while, respectfully so. But it's
- 18 important that we have those conversations with them so
- 19 that we can, you know, make sure that they put out the
- 20 accurate information that needs to be -- needs to be
- 21 put out there.
- Detroit is -- you know, it's -- Detroit is a
- 23 national story. Everybody wants to know about Detroit
- 24 right now, and it's important we get the right
- 25 information out.



- 1 COMMISSIONER SHELBY: That's kind of my
- 2 concern. You know, you may report on a lot of positive
- 3 stories. But, you know, if the public doesn't get wind
- 4 of it, it's kind of like --
- 5 SERGEANT WOODY: We've began actually --
- 6 we've began to train -- we have an officer that's
- 7 actually learning how to -- she's working with Sergeant
- 8 Quinn here at graphic arts and central photo to learn
- 9 how to do software editing. So that we're going to
- 10 start putting out our own PSAs. We're going to start
- 11 developing our own stories and our own PSAs to send out
- 12 to the public. So we can draft and get our message out
- 13 to them, so that -- it's not to bypass the media
- 14 because we're always going to need our partners in the
- 15 media. They just reach a much broader base than what
- 16 we will be able to do. But it's to say that, you know,
- 17 we want to make sure, for example, when this honorable
- 18 commission is being filmed, we would like the whole
- 19 story to be put out there. So we put it unedited, or
- 20 we would, we don't, but we would put it up on our
- 21 YouTube link so that everybody can see it, not just a
- 22 90-second turnaround piece about some inflamed comments
- or commentary that was made. But they get to see the
- 24 entire process and how it works.
- So we do things like that quite often to make



- 1 sure that our public gets the full view of what's
- 2 actually happening.
- 3 CHAIRPERSON BELL: Commissioners, any other
- 4 comments?
- 5 COMMISSIONER CRAWFORD: Through the chair. I
- 6 just have a comment. Sergeant Woody, sir, are you
- 7 aware that the bias media is here?
- 8 SERGEANT WOODY: Yes, I know. And I do
- 9 appreciate them.
- 10 COMMISSIONER CRAWFORD: Yeah. Well, just
- 11 want to thank you for your opinion and your comments,
- 12 being so transparent. That's all.
- 13 SERGEANT WOODY: Thank you.
- 14 CHAIRPERSON BELL: Sir -- any other
- 15 commissioner?
- ASSISTANT CHIEF DOLUNT: Can I ask something?
- 17 This is chief Dolunt through the chair. Who are the
- 18 four officers? I know there's Madera, Kirkwood,
- 19 Marino.
- SERGEANT WOODY: And then Beasley.
- 21 ASSISTANT CHIEF DOLUNT: Beasley is the one
- 22 learning how to --
- 23 SERGEANT WOODY: Yes. Beasley is the one.
- 24 She's currently on maternity leave right now.
- 25 ASSISTANT CHIEF DOLUNT: I wondered where she



- 1 was at.
- 2 SERGEANT WOODY: Yeah. Each one of our
- 3 officers is responsible for an area. Officer Kirkwood
- 4 is actually responsible for the city website. And
- 5 Marino does the app. And Beasley does the social media
- 6 piece and is also learning the --
- 7 ASSISTANT CHIEF DOLUNT: I got to tell you
- 8 something, as politically as -- incorrect as I am, you
- 9 guys have helped me out immensely. I'd be a heck of a
- 10 lot worse without you guys, at least for me. So I just
- 11 want to thank you guys publically.
- 12 SERGEANT WOODY: Thank you, sir.
- 13 CHAIRPERSON BELL: I have a couple questions
- 14 in reference to the newly appointed Second Deputy
- 15 Chief, June West.
- 16 SERGEANT WOODY: Yes, sir.
- 17 CHAIRPERSON BELL: Is this something that
- 18 she's going to be over the media relations that are
- 19 newly formed?
- SERGEANT WOODY: Yes.
- 21 CHAIRPERSON BELL: Will we have an
- 22 opportunity for the Second Deputy Chief to come before
- 23 this body?
- 24 SERGEANT WOODY: Yes, sir.
- 25 CHAIRPERSON BELL: And explain the duties and



- 1 responsibilities? I think that would be appropriate if
- 2 she's going to be the Second Deputy Chief of the media
- 3 relations. Would that be appropriate?
- 4 SERGEANT WOODY: Yes, sir. I will definitely
- 5 make note of that, sir.
- 6 CHAIRPERSON BELL: I guess my second question
- 7 is in reference to -- what role do the Board of Police
- 8 Commissioners play in reference to media relations with
- 9 the Detroit Police Department? I can think of a whole
- 10 lot of instances that we as commissioners find out
- 11 through the media -- basically just like you mentioned,
- 12 Second Deputy Chief, we were not aware. And we have
- 13 requested over and over again to be included in the
- 14 process.
- 15 SERGEANT WOODY: Yes, sir.
- 16 CHAIRPERSON BELL: You know, and that is not
- 17 your job description. That is more or less to the
- 18 Second Deputy Chief, assistant chief to the Chief of
- 19 Police, that I think it need to be more of a working
- 20 relationship interns of the media and the Board of
- 21 Police Commissioners. When you're talking about the
- 22 150 years --
- SERGEANT WOODY: Yes, sir.
- 24 CHAIRPERSON BELL: I think the commission
- 25 been around even before the Detroit Police Department



- 1 was created. Are you aware of that?
- 2 SERGEANT WOODY: No, sir.
- 3 CHAIRPERSON BELL: Yes. I think you need to
- 4 do a little research. The board of commission was
- 5 appointed by the governor and the police department
- 6 came thereafter, according to my research.
- 7 I think in some instance that the filtering
- 8 of information is somewhat crucial too because I just
- 9 have people see stuff right off the top and I know you
- 10 don't have all the information but you make a solid
- 11 comment sometimes in reference to that. People give us
- 12 feedback in reference to what is the truth, what is not
- 13 the truth. Then you've got to -- you know what I'm
- 14 talking about, where you make comments?
- 15 SERGEANT WOODY: Yes, sir.
- 16 CHAIRPERSON BELL: And I have witnessed that
- 17 over the years. Some chiefs take a low profile, some
- 18 chiefs -- this chief take a very high profile in
- 19 reference to the media. Then I think there was some
- 20 dialogue that we as commissioners have, and there's
- 21 some instance where the department was trying to
- 22 respond. I think that's a mistake. I don't think that
- 23 we want that type of dialogue. I think normally we
- 24 don't scrutinize what you have put out there. And in
- 25 the same instance, I think this commissioners have an



- 1 opportunity to speak to citizen concerns. It might be
- 2 disagreeable. But that is spokesperson or the position
- 3 of the -- not even on the board. But just somebody's
- 4 comments to that. I think that's something that we
- 5 need to pursue in the future in reference to even on
- 6 the public forum. I know we got into that type of
- 7 dialogue in terms of what the chair say, what the chief
- 8 said, and all that good stuff, you know.
- 9 SERGEANT WOODY: Yes, sir.
- 10 CHAIRPERSON BELL: But I just think we could
- 11 do a better job. And I'd like for us to see the 150
- 12 celebrate -- are we included in that?
- SERGEANT WOODY: Yes, sir, you are.
- 14 CHAIRPERSON BELL: Are we invited to that?
- 15 SERGEANT WOODY: Yes, sir, you are.
- 16 CHAIRPERSON BELL: Can we come to the party?
- 17 SERGEANT WOODY: Absolutely. I look forward
- 18 to it, sir. Just for -- you know, just so you're all
- 19 aware, I apologize, we do communicate. Second Deputy
- 20 Chief West is new. I am currently working on her bio.
- 21 Nobody really knows about her just yet. This is only
- 22 her third day. So I am working on her bio to get it
- 23 out to the general media and to the public so that they
- 24 are aware of her and her presence here. I apologize
- 25 for her not being here, and I will make sure that she



- 1 comes before the board to introduce herself to you and
- 2 give an opportunity for her to be able to -- to be able
- 3 to, you know, present to you what her duties will be.
- I am always available to the honorable
- 5 commission for whatever advice or counsel. I gladly
- 6 take any -- I am not of the mindset that my way is the
- 7 correct way. I learn very quickly. I make my
- 8 mistakes. I move on. So if by any means this
- 9 commission would like to sit down and have a discussion
- on how or what we can do to better our relationship,
- 11 I'm all ears.
- 12 CHAIRPERSON BELL: I think we would welcome
- 13 that because we are, as you know, not full-time
- 14 commissioners. We're not here, you know, Monday
- 15 through Friday 9:00 to 5:00 or whatever that is. But
- 16 we do have a board secretary. We do have a staff. So
- 17 you do a great job communicating with the public, but I
- 18 think we need to be included in terms of that process.
- 19 But I'm not -- I'm not bombarding you, you know.
- 20 SERGEANT WOODY: I understand.
- 21 CHAIRPERSON BELL: I'm just trying to --
- 22 hoping that assistant chief hear me also because that's
- 23 part of the command chain. So I just want to get those
- 24 points out there in reference to -- this is 2015.
- 25 You're bringing on somebody brand new. I think it's a



- 1 new day. I just wanted to echo those concerns in terms
- 2 of my opinion.
- 3 SERGEANT WOODY: Yes, sir.
- 4 CHAIRPERSON BELL: Any other comments from
- 5 the commissioners, final thoughts or concerns?
- 6 ASSISTANT CHIEF DOLUNT: I made a note of
- 7 that. I got that.
- 8 CHAIRPERSON BELL: Yes, sir.
- 9 ASSISTANT CHIEF DOLUNT: Got it. You going
- 10 to update that book, the history of police department?
- 11 SERGEANT WOODY: Yes, sir.
- 12 ASSISTANT CHIEF DOLUNT: You going to put in
- 13 another edition?
- 14 SERGEANT WOODY: Yes, sir.
- 15 ASSISTANT CHIEF DOLUNT: Some of us guys
- 16 should be in there, pictures.
- 17 COMMISSIONER MALLETT: From 150 years ago,
- 18 you right.
- 19 ASSISTANT CHIEF DOLUNT: Mr. Bell was the
- 20 only one here 150 years ago. Everyone else is coming
- 21 after that. So you need to update that.
- 22 SERGEANT WOODY: I will definitely do that.
- 23 Thank you.
- 24 CHAIRPERSON BELL: The reason I say that is
- 25 when this commission was formed in 1973, the first



- 1 panel in 1974, those commissioners, I guess Reverend
- 2 Butler, the four or five individuals, they made a
- 3 significant impact in reference to the Detroit Police
- 4 Department. And people take that for granted. And I
- 5 -- but I know that's not the case because I know the
- 6 mandate was clearly from Mayor Coleman A. Young in
- 7 reference to the reforming and the integrating, all the
- 8 efforts that we went through, Detroit is rather unique,
- 9 and I say that all the time. It's not your LAPD. We
- 10 change the whole concept of policing in America in
- 11 Detroit. And that -- that was not by accident. It
- 12 took a whole lot of work of the mayor and the
- 13 commissioners to engage in that process. So I just
- 14 want to just make sure the public is aware of that. I
- 15 think we need to take on that responsibility too but we
- 16 don't have the staff, you know, to do all of that. But
- 17 I think we can do more in terms of sometime to tell you
- 18 the history in terms of your involvement. I want to
- 19 take the opportunity and thank you for the excellent
- job in presenting to this board. Any other comments?
- 21 Okay.
- 22 SERGEANT WOODY: Thank you all very much.
- CHAIRPERSON BELL: Thank you, sir. The next
- 24 item would be standing committee reports. Any
- 25 committee reports?



- I just want to -- since there's no committee
- 2 report -- just remind you that we are looking at the
- 3 committee assignment. I guess the board secretary will
- 4 send those committees out to all the commissioners. We
- 5 have another commissioner onboard so I think it's all
- 6 in good timing to look at that.
- 7 I just want to report out on January the
- 8 20th, the justice assembly at the Pleasant Grove
- 9 Missionary Baptist Church at 5:00. And considering the
- 10 weather and all that, we had a pretty good turnout.
- 11 The panel was excellent. And I want to thank the
- 12 Commissioner Moore and the Commissioner Shelby and
- others and some of the individuals in the room and
- 14 retired officer. City wide was represented and others.
- 15 It was a forum that we had an opportunity to get a
- 16 great deal of support as we go forth in 2015 to make
- more people aware of the Board of Police Commissioners.
- 18 I think it was excellent to have an opportunity for the
- 19 Michigan United Coalition of Ministers support us. And
- 20 I assume that we will be reporting out more so in our
- 21 newsletter in the future. And I want to get together
- 22 as commissioners to share that dialogue with you. So
- 23 that was worthwhile.
- 24 And Attorney Linda Bernard allowed me to
- 25 attend the Rainbow Push Project at Cobo Hall sponsored



- 1 by Rainbow. And that was under the leadership of the
- 2 Reverend Jesse Jackson and his team and Dr. Martin
- 3 Luther King celebration on the evening at 5:00 at Cobo
- 4 Hall. And it was just an excellent forum. As you well
- 5 know, Reverend Jackson is one of the living legends as
- 6 part of that struggle. And he gave us a history lesson
- 7 in reference to what took place at Selma and then some
- 8 insight in reference to the movement with Dr. King and
- 9 others. And it was just an excellent format. I wish
- 10 more commissioners -- but it was like a last minute
- 11 notice. And we had Cass Tech choir that was there and
- 12 also Martin Luther King High School dance workshop that
- 13 was excellent. It was well attended, and I just think
- 14 that any opportunity we have to -- this is Dr. King
- 15 week in terms of the legacy. And we talk about the
- 16 whole issue about civil rights and also the part that
- 17 law enforcement played in that. So I think history is
- 18 something that's ongoing. So I appreciate the
- 19 opportunity and Attorney Bernard inviting me to attend.
- So on that note, we have new business. We
- 21 have two resolutions.
- 22 Officer Moore -- I mean, Commissioner Moore
- is going to present one to Milhouse, and Dr. Moss is
- 24 going to be by Commissioner Shelby.
- 25 COMMISSIONER MOORE: Just acknowledgment,



- 1 Mr. Chair, that Officer Milhouse is in the house. I'm
- 2 going to have him stay seated -- you want him to come
- 3 up now?
- 4 CHAIRPERSON BELL: Yes. Please come forward.
- 5 Please. Still Officer Milhouse, right?
- 6 COMMISSIONER MOORE: I'll read it as you walk
- 7 up. Okay. Resolution honoring retired police officer
- 8 Otis Milhouse.
- 9 Whereas, Otis Milhouse was appointed to the
- 10 Detroit Police Department on January 17th, 19935. Upon
- 11 graduating from the Metropolitan Police Academy,
- officer Milhouse began his career at the Fourth
- 13 Precinct. And whereas, Officer Milhouse attended
- 14 Easter Michigan University where he's received his
- 15 bachelor's degree. His other assignments included
- 16 public information, planning and inspections, the
- 17 fiscal management bureau, and grants and contracts
- 18 where he remained until his retirement. And whereas,
- 19 Officer Milhouse was the deserving recipient of
- 20 numerous awards and honors, including two perfect
- 21 attendance awards and ten perfect driving awards, a
- 22 major league baseball all star recognition award, the
- 23 Rosa Parks funeral recognition award, the Super Bowl XL
- 24 recognition award, and numerous letters of commendation
- 25 from citizens, business leaders, and superiors. And



- 1 whereas, Officer Milhouse has tirelessly served the
- 2 Detroit Police Department, the citizens of Detroit and
- 3 its neighboring communities for twenty years. His
- 4 professionalism, commitment to public service,
- 5 integrity, and dedication has been a credit to the
- 6 Detroit Police Department. He is highly respected as a
- 7 consummate professional throughout the law enforcement
- 8 community.
- 9 Now, therefore, be it resolved that the
- 10 Detroit Board of Police Commissioners, speaking for the
- 11 citizens of Detroit and the Detroit Police Department,
- 12 award this resolution to Police Officer Otis Milhouse
- 13 for his twenty years of dedicated and diligent public
- 14 service. His professionalism, integrity, and standard
- of commitment to the City of Detroit and its citizens
- 16 merit our highest regards and best wishes for continued
- 17 success. We salute and congratulate you, Police
- 18 Officer Otis Milhouse. The Detroit Board of Police
- 19 Commissioners.
- 20 CHAIRPERSON BELL: Come forward and stand.
- 21 Judge Milhouse, would you come forward and stand with
- 22 your husband. Thank you.
- 23 OFFICER MILHOUSE: I just want to say thank
- 24 you to the commissioners, the chief, the City of
- 25 Detroit, and the citizens of Detroit. It's been a



- 1 pleasure serving and protecting. Thank you.
- 2 CHAIRPERSON BELL: Officer Milhouse, come
- 3 back to the mic, please. That was a brief thank you.
- 4 What is your career path next? What is life beyond
- 5 DPD?
- 6 OFFICER MILHOUSE: I'm going to sit down.
- 7 MRS. MILHOUSE: He has some duties around the
- 8 house.
- 9 OFFICER MILHOUSE: You know, I still have a
- 10 few years left in me so I'm going to sit down and
- 11 evaluate and I'm going to do something else for five
- 12 more years at least.
- 13 CHAIRPERSON BELL: I have one suggestion for
- 14 you, don't stick around the house. The honey-do list
- 15 will add up.
- OFFICER MILHOUSE: That's why I know I have
- 17 to get back out there because I know, it's already
- 18 adding up.
- 19 CHAIRPERSON BELL: I want to thank you for
- 20 your years of service too and it's a blessing to see
- 21 you standing there. And you're going to make that
- 22 career choice, you know, whatever you're going to do
- 23 next. So on behalf of the board, thank you again.
- 24 COMMISSIONER CRAWFORD: Excuse me. Through
- 25 the chair, I've known Officer Milhouse for years, and I



- 1 just want to thank you for your service. I also want
- 2 to thank you as a person because we've had numerous
- 3 conversations over the years and, you know, you're a
- 4 really good person and the city is -- it's a real
- 5 benefit to the city and this department, your service.
- 6 OFFICER MILHOUSE: Thank you.
- 7 CHAIRPERSON BELL: Thank you, sir.
- 8 Commissioner Shelby.
- 9 COMMISSIONER SHELBY: I'm going to read the
- 10 resolution honoring Dr. Thomas E. Moss, Senior.
- 11 Now, therefore, be it resolved that the Board
- of Police Commissioners speaking on behalf of the
- 13 citizens of the great city of Detroit and the Detroit
- 14 Police Department honor and solute Dr. Thomas E. Moss,
- 15 senior, for his unserving dedication to public service.
- 16 He leaves behind an outstanding legacy and will always
- 17 be remembered for his dedication, compassion, and never
- 18 ending love for the City of Detroit. Detroit Board of
- 19 Police Commissioners.
- CHAIRPERSON BELL: Thank you, sir. Now, the
- 21 chair would entertain a motion to receive these two
- 22 resolutions at this time.
- 23 COMMISSIONER MALLETT: So moved.
- 24 COMMISSIONER MOORE: Second.
- 25 CHAIRPERSON BELL: It's been properly moved



- 1 and seconded. Ready for the question? Those in favor?
- 2 COMMISSIONERS: Aye.
- 3 CHAIRPERSON BELL: Those opposed? Motion
- 4 carried.
- 5 Next item would be any old business.
- 6 COMMISSIONER CRAWFORD: Yes, sir. Through
- 7 the chair, under old business, last week's meeting, I
- 8 was tasked with the assignment of communicating with
- 9 the metropolitan -- president of the Metro Cab Driver's
- 10 Association. And there was an issue pertaining to, I
- 11 guess, what's occurring with the cabs and the lack
- 12 thereof of cab stands in Detroit and kind of a host of
- 13 issues.
- And, of course, the department and Chief
- 15 Craig and attorney Washington have been working on this
- 16 issue for a number of months. And I also attended a
- 17 few of the meetings. But one of the meetings in
- 18 particular, I had -- I had communicated or talked with
- 19 the president of that association, Mr. Kenneth Kabaka
- 20 Reynolds. And he informed me today, as a matter of
- 21 fact, that there is a meeting and that's for the
- 22 Metropolitan Cab Drivers Association and its members,
- 23 which are cab drivers, Monday, January the 26th.
- 24 That's Monday, January the 26th, 6:00 p.m. to 8:00
- 25 p.m., at Whole Foods. And that's in their community



- 1 room, and that's at Woodward and Mack Avenue.
- 2 Also, there is another meeting where they go
- 3 before City Council on Wednesday, January the 28th, I
- 4 believe it's 10:00 a.m. in the morning, January 28th.
- 5 And that's before Detroit City Council.
- And also I was e-mailed a letter, actually a
- 7 few days ago, but it's dated January the 15th, and this
- 8 letter is from the president of the association,
- 9 Mr. Reynolds, and it's to the Detroit City Council.
- 10 And in short, the letter communicates the issue of the
- 11 public vehicle license where they're requesting an
- 12 extension, and they're going to present this before
- 13 city council. And also -- which was, by the way,
- 14 suspended for 30 days and they want an extension on
- 15 that in terms of renewing their public vehicle license.
- But also in the letter too, it's an
- 17 appreciation or thank you basically to the Detroit
- 18 Police Department for the special event cab stand that
- 19 was set up in front of -- well, somewhere around
- 20 proximity of Cobo Hall for the -- Cobo Center, as it is
- 21 now, for the auto show. And I'll leave you with a
- 22 copy, and perhaps the secretary can later distribute it
- 23 -- a copy of it to the other commissioners.
- 24 COMMISSIONER MALLETT: So, Mr. Chairman --
- 25 CHAIRPERSON BELL: Yes, sir.



- 1 COMMISSIONER MALLETT: My wife made me
- 2 promise that I would come to this meeting and be quiet,
- 3 but she's not here. So I'm trying to understand -- and
- 4 I mean this with a great deal of respect. Everybody
- 5 here is a public servant doing this work for a very
- 6 long time. I see Otis and Donna. I've known them
- 7 since they were kids, which tells you how old I am.
- But I'm trying to figure out our role. And
- 9 I'm trying to figure out -- and this is the taxi
- 10 situation. And my slurring has to do with the
- 11 Novocain, thank God, the dentist used on my tooth.
- But there is a line, isn't there,
- 13 Mr. Chairman, across which as a board of advisors and
- 14 oversight -- it's not that we can't cross it. We can
- 15 do anything we want. But that there would be a --
- there's a line that as an oversight board we would be
- 17 expected to stay a little bit behind.
- So I'm just wondering -- and I'm glad our
- 19 attorney is here. At a certain point -- and I know
- 20 that commissioner is very, very appropriately concerned
- 21 about taxi cab service and his interest in this issue
- 22 is genuine, but I wonder where the responsibility of
- 23 the executive Detroit Police Department and City
- 24 Council come in managing issues like this. If the taxi
- 25 cab drivers come, Mr. Chairman, and present as they



- 1 did, certainly we encourage that. Once they come and
- 2 present and we take the notes and we then give it to
- 3 the police department and we give it to the -- and they
- 4 pass it on to the mayor, this is the issue, you need to
- 5 deal with it, we would like to have a report back as to
- 6 the resolution on and on and on. But I wonder is there
- 7 -- are you comfortable, is the board comfortable with
- 8 our attending meetings, our going to the meetings and
- 9 offering advice? I'm wondering, as individuals are
- 10 certainly entitled to define their duties and
- 11 responsibilities, I'm just wondering what direction you
- 12 would give me in terms of that kind of activity because
- I -- I -- what I -- what I am concerned about, that our
- 14 presence, individually or collectively -- and again,
- 15 I'm not trying to control anybody. Everybody here is
- 16 either appointed or elected. They can do anything they
- 17 want. I am not their supervisor or anything like that.
- 18 But I just wonder is there a set of duties and
- 19 activities that we're responsible for and -- or not. I
- 20 mean, if -- through the chair, if that's the correct
- 21 protocol.
- I mean, Ms. Bernard, do you have a comment on
- 23 whether or not our participation in a police department
- 24 meeting with the constituents and group over which they
- 25 have regulatory authority is appropriate? I just



- 1 wonder what your view on that is.
- 2 ATTORNEY BERNARD: Commissioner Mallett, it's
- 3 right on the back of our agenda. Oh, I'm sorry. And
- 4 the chairman may want to respond.
- 5 CHAIRPERSON BELL: I'll let you speak. I'm
- 6 sorry. Then I can respond.
- 7 ATTORNEY BERNARD: Commissioner Mallet, this
- 8 agenda that's written that has the City of Detroit
- 9 green man on the front, Spirit of Detroit, right on the
- 10 very back of it is --
- 11 COMMISSIONER MALLETT: Mine is plank.
- 12 ATTORNEY BERNARD: It's not supposed to be.
- 13 Would you pass him yours, if you don't mind, George.
- 14 COMMISSIONER MALLETT: I walked up and --
- 15 ATTORNEY BERNARD: There it is. The duties
- and responsibilities of the commission are set forth in
- 17 the Detroit City Charter. On every committee -- excuse
- 18 me. On every commission board meeting those duties and
- 19 responsibilities are copied on the back of the agenda.
- 20 So it gives you a very clear framework with respect to
- 21 what the duties and responsibilities are pursuant to
- 22 the charter, which was just voted in, as you know, in
- 23 2012.
- It substantially increased the role of the
- 25 Board of Police Commissioners to one of oversight, to



- 1 one with respect to budgetary issues, to one with
- 2 respect to appointing the personnel director for the
- 3 police department, etcetera.
- 4 More recently because of the emergency order
- 5 No. 11, pursuant to which Chief Craig was appointed and
- 6 then later emergency order No. 42, which really was the
- 7 exit strategy for the emergency manager, some of those
- 8 duties have been suspended.
- 9 The board has requested a formal legal
- 10 opinion from the corporation counsel, Butch Hollowell,
- 11 on the legality of that continuing suspension in view
- of the fact that the board is, as you know,
- 13 Commissioner Mallet, one of the three elected bodies in
- 14 the city, the mayor, City Council, and of course the
- 15 Board of Police Commissioners.
- So the other two bodies have had all of their
- 17 powers and duties restored. The only one that does not
- 18 at this point is the Board of Police Commissioners.
- 19 I contacted Butch's office today and spoke to
- 20 Chopa, Choppa. I'm sorry. His assistant. And again
- 21 requested the opinion. She said our request for the
- 22 opinion had been forwarded to the ordinance division in
- 23 the law department, which I found interesting. But in
- 24 any event, that's where it was forwarded. And she
- 25 would get back to me with the date on which we could



- 1 expect an opinion.
- 2 But those are the duties set forth right
- 3 there.
- 4 COMMISSIONER MALLETT: And I don't see
- 5 attendance at the department meetings for citizen
- 6 groups here. Again, you can do anything you want.
- 7 Listed out, though, Mr. Chairman, I just
- 8 don't -- I don't see that we have an active day-to-day
- 9 role associated with the management of these kinds of
- 10 issues. It's just not there.
- Now, it can be there because the English
- 12 language -- Linda is one of the finest attorneys I
- 13 know. You can make the English language manipulate any
- 14 way you want to achieve any result you want to achieve.
- 15 And, again, this is America. You can go anywhere you
- 16 want, and you can do anything you want in the matter of
- 17 a public meeting.
- But I think that individually and perhaps at
- 19 some point, Mr. Chairman, collectively we need to
- 20 figure out as these duties and responsibilities are
- 21 defined, what it is that we expect from each other.
- 22 Right now I'm just raising the question.
- 23 CHAIRPERSON BELL: Yeah. I think it's a good
- 24 question of concern. I think it's sort of crucial as
- 25 soon as possible with you being recently appointed and



- 1 Commissioner Vann you being appointed -- we have
- 2 another commissioner -- three new commissioners, and we
- 3 have past commissioner who has served almost going on
- 4 her -- her term ending this year, and Commissioner
- 5 White. I think we need to have that type of discussion
- 6 not at this forum here, but I think we need to have
- 7 that discussion in the next two weeks or so in terms of
- 8 scheduling that type of meeting, so we can have that --
- 9 COMMISSIONER MALLETT: Why don't we have it
- 10 next week because I'm also concerned that the frequency
- of these -- if we're going to come together for an hour
- 12 once a week, we should come together for two hours
- 13 twice a month and -- no. And the reason is -- it's not
- 14 just my time because I can manage my schedule. But
- 15 we've got one, two -- we've got police officers out
- 16 here and we are short staffed.
- 17 You know this, Mr. Chairman. Preparing for a
- 18 board meeting, no matter how short it is, is a pain.
- 19 CHAIRPERSON BELL: Yes, sir.
- 20 COMMISSIONER MALLETT: Because I've got a
- 21 bunch of boards and every -- preparation for them, no
- 22 matter how simple the agenda, requires time and
- 23 attention. And so if -- and if our agenda is going to
- 24 be as light as this one, then we should do it every two
- 25 weeks as opposed to once a week, number one. Number



- 1 two, if we do need to meet more often, we can do that
- 2 at the call of the chair when an emergency presents
- 3 itself because what I'm concerned about, again, it's
- 4 not the commissioners' time. We signed up for this.
- 5 CHAIRPERSON BELL: That's correct.
- 6 COMMISSIONER MALLETT: But I'm desperately
- 7 concerned about the appropriate use of the police
- 8 officers' time. And I just wonder if this is -- if
- 9 this is how we want to require them to help us manage
- 10 -- do our job effectively. I just put that out there.
- 11 CHAIRPERSON BELL: I agree wholeheartedly
- 12 with you. But, however, this board is mandated by a
- 13 city charter, and that's been in existence since 1973
- 14 with the first panel meeting weekly. And it's clearly
- been amended a couple times, as recently as 2012. That
- language still remains there in terms of requiring us
- 17 to meet weekly. I echo that on my arrival. But I was
- 18 familiar with the charter. And even with us trying to
- 19 perhaps not even meet and take care of some committee
- 20 business, there was some feedback from the commissioner
- 21 well, the charter say this. However, the charter is
- 22 there. But we're also are operating under emergency
- 23 act order No. 11 and emergency order No. 42 where we're
- 24 not fully empowered by city charter.
- 25 So those -- those debates we have had



- 1 informal and formally in reference to those concerns.
- 2 I agree with you. But that's something that how we
- 3 alter that and not be in conflict with if someone want
- 4 to challenge, you're not meeting your duly charge
- 5 charter responsibility of meeting weekly, then I think
- 6 that raises a red flag.
- 7 COMMISSIONER MALLETT: Could we do this then.
- 8 We could meet weekly. And I wonder could we do it then
- 9 just with Ms. Bernard and our secretary and not have
- 10 the police department here because if all we're going
- 11 to do is administrative administerial kind of things,
- then what we also have a responsibility to do is to
- 13 manage the resources associated with law enforcement as
- 14 effectively as we can.
- 15 CHAIRPERSON BELL: Those decisions -- I don't
- 16 think we can make it at this time. But I'm willing to
- 17 have that type of discussion. But by the charter, the
- 18 Chief of Police or designee is required to be at these
- 19 forums and also the public. It's a public forum. So
- 20 they have the opportunity. When we meet, it's open
- 21 forum for the public to attend those meetings. We're
- 22 not as flexible in terms of how the counsel meet and
- 23 Wayne County Commissioner meeting, that somewhere along
- 24 the line we are locked -- and it's been since --
- 25 Commissioner Vann can speak to that. He served four or



- 1 five years on this committee, and that was the same
- 2 issue in terms of they only had five. They couldn't
- 3 get a quorum. So now we have eleven.
- 4 COMMISSIONER MALLETT: I'm not saying we do
- 5 anything -- I'm sorry.
- 6 CHAIRPERSON BELL: But we should have that
- 7 type of discussion and we can even schedule that next
- 8 week after our weekly meeting. We talk about a couple
- 9 things. We just postpone. But I think we need to
- 10 bring all the commissioners on one page to understand
- 11 our mandate and get those pros and cons because there's
- 12 not one within the purview of the chair to alter
- 13 certain things and the body approving that. So that's
- 14 a dialogue we can have. And I -- you're correct. We
- 15 can have that meeting as soon as next Thursday, if the
- 16 people put it on their schedule. Everybody is here
- 17 except for one commissioner, that's Commissioner White.
- 18 ATTORNEY BERNARD: I won't be here then. But
- 19 I --
- 20 CHAIRPERSON BELL: That's right. You'll be
- 21 out of town.
- 22 COMMISSIONER CRAWFORD: Yes, sir. I just
- 23 want to say through the chair, in terms of the concerns
- 24 about the meeting, that meeting came about because the
- 25 cab drivers came to us.



- 1 COMMISSIONER MALLETT: I was at the meeting.
- 2 COMMISSIONER CRAWFORD: No. But previous
- 3 meetings before you were even here, sir, with all due
- 4 respect. There was this constant coming before us
- 5 talking about the ticketing. And we were invited as
- 6 commissioners to that meeting which took place in a
- 7 church with community activists, cab drivers. The
- 8 chief was there and some other people from the
- 9 department, officers, captain from downtown civic
- 10 events, Captain Petty. And that's the reason why we
- 11 attended, why I attended that meeting, because we were
- 12 all invited.
- And then attending that meeting, everybody
- 14 did their presentation, said what they wanted to say.
- 15 And I was asked is there anything I wanted to say. No.
- 16 I said no. I took notes. I took notes on what
- 17 occurred at that meeting. And the chief and the
- department attorney Washington have been working with
- 19 the president of the cab drivers association to try to
- 20 resolve these issues. I've had no input in terms of
- 21 that.
- 22 COMMISSIONER MALLETT: Okay. And I'm just
- 23 raising the question.
- 24 COMMISSIONER CRAWFORD: Yes, sir. I
- 25 understand.



- 1 COMMISSIONER MALLETT: Jealous of the time
- 2 that you have available to make those kinds of forums.
- 3 COMMISSIONER CRAWFORD: I really don't have
- 4 any time available. But I make a lot of meetings
- 5 because of my background as being an activist in this
- 6 city. I've been to a lot of meetings.
- 7 COMMISSIONER MALLETT: So have I.
- 8 COMMISSIONER CRAWFORD: I know you have. But
- 9 I've been -- I've been ground level, you know.
- 10 COMMISSIONER MALLETT: So have I.
- 11 COMMISSIONER CRAWFORD: Yes, sir.
- 12 CHAIRPERSON BELL: But I'm glad you brought
- 13 those concerns public because we have informally have
- 14 had those type of discussions and -- but I think as
- 15 commissioners that have served in the past, I think we
- 16 need to have that type of discussion engaging that we
- 17 will not be violating our meeting act. So we've been
- 18 advised on all that how we can approach this with the
- 19 exception of a charter amendment, you know, in the
- 20 future.
- I agree with you, some of that language is
- 22 bad in terms of meeting schedule. But the time -- you
- 23 know, just require the chief and any other department
- 24 official that we request or want to attend, that's
- 25 getting back to the flexibility of the Chief of Police.



- 1 Some people are offended that the chief not attending
- 2 every meeting. You hear that type of discussion as you
- 3 well know.
- They want -- they think that by a charter, it
- 5 say the Chief of Police supposed to be at these
- 6 meetings. We have looked at that in the past. Other
- 7 chiefs have been great attendees and some haven't, you
- 8 know.
- 9 But Chief Craig was hired under emergency
- 10 order No. 11. This body had no bearing in reference to
- 11 him being Chief of Police or reporting out. It's been
- 12 an informal process that continues today in reference
- to the Chief of Police under the emergency order 342
- 14 continue to operate under 11. So those discussions we
- 15 need to enlighten you on in reference to even our
- 16 dialogue with the mayor, Mayor Duggan, in reference to
- 17 our -- in terms of he looked at it last year. Well,
- 18 I'm not going to appoint people because there's no
- 19 reason to because I'm not over the police department.
- 20 That changed a couple months ago. And that's why he
- 21 arrived at the decision he made about -- but basically,
- 22 we in a political posturing. But I don't want to
- 23 belabor or that. But I think we need to have that
- 24 discussion and make sure that you understand our role
- 25 in reference to --



- 1 COMMISSIONER MALLETT: I understand. You
- 2 know, Mr. Chairman, the -- I read the charter too, not
- 3 as closely as you because I missed the section about
- 4 having that weekly meeting. I wish I had.
- 5 CHAIRPERSON BELL: You didn't want to read
- 6 that.
- 7 COMMISSIONER MALLETT: I skipped it. That's
- 8 why George Cushingberry asked me are you going to
- 9 available for all the meetings. Then when it turned
- 10 out they were every week, I said good Lord. But I'll
- 11 be here, Mr. Chairman, I promise. But it is -- it's a
- 12 conversation worth having, and I appreciate your
- indulgence. And I won't take anymore time.
- 14 CHAIRPERSON BELL: Okay. Thank you. So,
- 15 commissioner, by common consent that we will have that
- 16 informal discussion outside of -- when we finish our
- 17 board meeting next week. Normally it's going to be a
- 18 short agenda in the lack of participation.
- But my understanding, I know from personal
- 20 experience, when they met at the headquarters, that
- 21 room was packed with people. When they made the
- 22 transition over here, the attendance drastically
- 23 dropped.
- But even to get people out to our community
- 25 meeting, we are concerned. That was one of the



- 1 concerns counsel raised, how many people attend your
- 2 meetings, you know. And I think they already knew the
- 3 answer.
- 4 COMMISSIONER MALLETT: I think the community
- 5 meetings -- I agree with you, community meetings are
- 6 tremendously important. We need to be present, we
- 7 absolutely need.
- 8 CHAIRPERSON BELL: But that's getting back to
- 9 the charter. But we don't have to continue. Thank
- 10 you.
- 11 ATTORNEY BERNARD: I just want to say that
- 12 Commissioner Mallet is also the best Supreme Court
- 13 Justice I've ever known.
- 14 COMMISSIONER MALLETT: Thank you, sweetheart.
- 15 ATTORNEY BERNARD: And he wrote the last
- opinion and the last case that I argued before the
- 17 Supreme Court and we won.
- 18 COMMISSIONER MALLETT: Glad to hear that.
- 19 CHAIRPERSON BELL: Come up with the language
- 20 how we can make this adjustment with the charter and
- 21 feel comfortable with it, you know, that's getting back
- 22 to some of the commissioners. But we can move on.
- 23 Thank you, by all means. I'm glad you brought that up
- 24 because that's been a concern we have had.
- 25 Any other old business?



- 1 Announcements. Our next community meeting is
- 2 going to be on February the 12th at Nature Human
- 3 Service Center. That's on 13560 Six Mile Road, and
- 4 that's in the area of Gratiot and Six Mile Road for you
- 5 westsiders. And that's a 6:30 p.m. meeting.
- And we are trying to work up the agenda where
- 7 we have more people that would come out. And we made a
- 8 request for the 36th District chief judge and also
- 9 circuit court chief judge to come out for those issues
- 10 raised at our last meeting about bonds and all that.
- 11 So we hope that we get a commitment. I think that type
- of forum, once we make people aware, it brings interest
- 13 versus the standard format that we have in reference to
- 14 here at the department. But those issues came before
- 15 us from the public forum.
- The our next meeting would be next week on
- 17 the 29th at 3:00, Public Safety Building. And that's
- 18 the announcements.
- 19 Any other announcement that the commissioners
- 20 might want to make in reference to any other issues at
- 21 this time?
- Oral communication from the audience. Please
- 23 give your name, and you have two minutes to be brief.
- 24 Be respectful. And I thank you.
- MS. SMITH: Bernice Smith. I'D like to know



- 1 what in the world is that car that's stolen outside
- 2 when I came through the gate. If you look out, if it's
- 3 still out there. I reported it. There's a stolen car
- 4 on our premises. A Chrysler.
- 5 CHAIRPERSON BELL: Who did you report it to?
- 6 MS. SMITH: A gentleman and Steve. Steve
- 7 when I got up here.
- 8 CHAIRPERSON BELL: Okay.
- 9 MS. SMITH: I'm just saying how much nerve
- 10 people have to bring a car -- Illinois plate. The door
- of the panel was open, and there was a lot of
- 12 literature laying there on the floor. I came through
- 13 that gate.
- 14 CHAIRPERSON BELL: You made that observation?
- MS. SMITH: Excuse me?
- 16 CHAIRPERSON BELL: You made that observation?
- MS. SMITH: I'm on police property. I'm very
- 18 observant because -- being experienced and knowing
- 19 things and what's going on -- I guess I am too nosey.
- 20 But anyway, I normally come through that gate. And I
- 21 circled around because I park in the handicap. So I
- 22 saw the panel door open, and I'm wondering what the
- 23 door -- nobody was in it. And I backed up, and that's
- 24 when I saw the papers scattered. And an Illinois
- 25 plate. Being from Illinois, I'm always nosey about



- 1 people from Illinois coming to our city. But
- 2 seriously, though, I did report downstairs. But I was
- 3 more hurt and surprised. And people have nerve. Do we
- 4 not have any kind of mechanism where we can check our
- 5 premises around here?
- 6 CHAIRPERSON BELL: My understanding is
- 7 private security officers -- I'm going to use that term
- 8 loosely. But private security staff monitor the lot.
- 9 In fact, they monitored me for parking in the lot. So
- 10 I'm hoping they'll do a better job of who's bringing
- 11 cars and dropping them off. That's a security breach.
- 12 But I'm sure assistant chief can address it.
- ASSISTANT CHIEF DOLUNT: I'm all over it.
- 14 MS. SMITH: Steve going to take care of it.
- 15 I went to the right man. That man downstairs didn't
- 16 know how to talk about it.
- Oh, Brown. I'm going to get through.
- 18 CHAIRPERSON BELL: That's an informal
- 19 concern. We won't have the clock start until she start
- 20 speaking.
- 21 MS. SMITH: Thank you. I through. That's
- 22 all I was worried about. Do we have -- you know --
- CHAIRPERSON BELL: Yes, ma'am.
- MS. SMITH: And then I know Steve going to
- 25 take care of it. He take care of all my problems I



- 1 have.
- 2 The mayor is going to be next Tuesday on the
- 3 air with Malik Shabazz. And we will be there in
- 4 attendance. And I'm going to ask him about the
- 5 commission and what his duties is going to be in the
- future about what he's going to do about the commission
- 7 and if he's going to stop interfering or whatever he's
- 8 doing now. I don't know. Maybe that's the wrong word.
- 9 But I won't -- I'm just asking him what the -- you
- 10 going to do. You got enough I imagine in the office to
- 11 take care of. Start leaving the commission alone.
- 12 Because, you know, you're my problems and I -- I like
- 13 to -- I'm not going to say babies. But anyway, I like
- 14 for you to be treated accordingly to what's going on as
- 15 far as -- because it hasn't been found yet that I was
- 16 the first Police Commissioner on the board in '73. But
- 17 he haven't found it yet. But anyway, maybe I'll find
- 18 it before I close my eyes and let you know what it was
- 19 like during 1973. His dad was present. But it was a
- 20 wonderful board. We had Blunt that came before us, and
- 21 he was a hell of a policeman. He didn't like us
- 22 questioning him at all. So I never forget that, and I
- 23 know most of you remember Commander Blunt. He was
- 24 something else. So that let's you know I know what I'm
- 25 talking about. When you go before the board, you have



- 1 to know what you are saying.
- 2 And it's good to see you again, Conrad.
- 3 COMMISSIONER MALLETT: Always good to be
- 4 seen.
- 5 MS. SMITH: And, Jessica.
- 6 COMMISSIONER TAYLOR: Yes, man.
- 7 MS. SMITH: Love you.
- 8 COMMISSIONER TAYLOR: About that car --
- 9 MS. SMITH: Thank you for listening to me.
- 10 COMMISSIONER TAYLOR: About the car, I have a
- 11 rental car with Illinois plates.
- 12 MS. SMITH: You're not in the corner, are
- 13 you?
- 14 COMMISSIONER TAYLOR: In the corner? No.
- 15 ma'am.
- MS. SMITH: This is in the corner and papers
- 17 was all strewn around, the door open. I don't think
- 18 she's absent minded enough to leave the door open.
- 19 It's a Chrysler.
- 20 COMMISSIONER TAYLOR: Oh, okay.
- MS. SMITH: It's a Chrysler.
- 22 COMMISSIONER BELL: I want to make one
- 23 correction. Our faith is not in the hands of the
- 24 mayor, Mayor Duggan, it's not.
- 25 The counsel by the emergency order, they can



- 1 vote us back in in December of this year. That will be
- 2 the one year expiration date of the bankruptcy matter.
- 3 We met with the mayor. The only thing that concerned
- 4 us with that is he indicated he want to make us review
- 5 board, that he didn't like the oversight. And that was
- 6 a recommendation that came forth in reference to the
- 7 Chief of Police, that he think that it's too much power
- 8 for the board, and the individual would not want to
- 9 work under that type of manner. Even though from 1974
- 10 going back all the way to this chief, I wouldn't say
- 11 the -- last chief was Chief Logan. We doing a survey
- 12 now. And even with Ike McKinnon, you know, deputy
- 13 mayor, there's been a good working relationship. And,
- in fact, I was familiar with all the commissioners
- 15 going back to '73, '74. That's always been a working
- 16 relationship over the years. And if you ask
- 17 Commissioner Vann, I think that history continue. But
- 18 we understand the emergency order act No. 11. But we
- 19 do not want to be a review. We want this present forum
- 20 by the city charter, and that's something we making the
- 21 public aware. Most people are not even aware that.
- MS. SMITH: That is true.
- CHAIRPERSON BELL: That we're not in power to
- 24 continue. Just like when the mayor got their power
- 25 back, Mayor Duggan got his power back, council back.



- 1 We had that type of dialogue. And there was a legal
- 2 opinion they rendered to the counsel, that nothing they
- 3 can do at this time. But one year, they can revisit
- 4 this.
- 5 MS. SMITH: So in other words, we just have
- 6 to wait for the time to expire?
- 7 CHAIRPERSON BELL: Yes. That's correct. We
- 8 are -- as you heard, our attorney, we're looking for a
- 9 legal opinion in reference to all of this, legal, to
- 10 make sure we're on the right track. But that's getting
- 11 back to the corporation counsel because he is the
- 12 enforcer of the city charter. If there's any violation
- or any issue, those are the concerns we have drafted
- 14 for over 30 days. We're waiting on that response even
- 15 this afternoon. We trying to get him to respond. So
- 16 hopefully we have that type of legal response. But
- 17 that's -- we've been through the formalities in terms
- 18 of going before the mayor and the counsel.
- 19 And Mr. Mayor has stated that it's Mr. Orr in terms of
- 20 emergency order 42 that continued to keep us not fully
- 21 in power. So that's where we stand. But we going to
- 22 have that discussion with all the commissioners next
- 23 week.
- MS. SMITH: It will be all right once it's
- 25 taken care of.



- 1 CHAIRPERSON BELL: It will come down to a
- 2 vote. Mr. Crawford.
- 3 COMMISSIONER CRAWFORD: Yes, sir. Through
- 4 the chair, my contention anyway that I personally
- 5 believe that emergency manager order 42 is in violation
- of the city charter. Also too that the -- well, this
- 7 commission has been around for 41 years now, going on
- 8 the 41st year. And we as elected officials by this
- 9 district per the new city charter, it speaks in the
- 10 charter as to exactly how it's supposed to go.
- In terms of like Commissioner Bell, the
- 12 chairperson said, we're seeking legal opinion on all
- 13 this. But in terms of what has occurred, I just feel
- 14 it's a bridge to the voters in the City of Detroit in
- 15 my district, the third district, who elected me, you
- 16 know, to sit on this board. So we'll see what happens
- in terms of the legal aspect of it. I think that's one
- 18 of the best avenues to pursue. But in terms of
- 19 changing the charter or amending the charter, that
- 20 would have to be through the voices and the voters --
- MS. SMITH: The voters.
- 22 COMMISSIONER CRAWFORD: -- of the people.
- MS. SMITH: Uh-huh.
- COMMISSIONER CRAWFORD: So in terms of any
- 25 review board or changes like that, that has to be put



- 1 on the ballot for the people to vote.
- 2 MS. SMITH: Thank you for your response. So
- 3 don't say nothing to the mayor then, huh?
- 4 CHAIRPERSON BELL: Well, I didn't say that.
- 5 I didn't say that. You have the right as a citizen.
- 6 And this is an issue before the community and the
- 7 citizens in reference to the role of the board of the
- 8 police commission.
- 9 MS. SMITH: Aren't we still short one member?
- 10 Patsy didn't show.
- 11 CHAIRPERSON BELL: She's not -- I know she's
- 12 not -- Mr. Secretary, would you give commissioner --
- 13 SECRETARY ANTHONY: Commissioner Eva
- 14 Dewaelsche has just been approved by counsel.
- MS. SMITH: What's her background?
- 16 SECRETARY ANTHONY: She was a former member
- 17 of the board.
- MS. SMITH: Thank you very much.
- 19 CHAIRPERSON BELL: I just want to give
- 20 clarity. But by all means you can say --
- MS. SMITH: Where is she?
- 22 SECRETARY ANTHONY: She was just approved
- 23 Monday by counsel.
- MS. SMITH: She was just approved. So she'll
- 25 be at our next meeting?



- 1 CHAIRPERSON BELL: I can't say that. But she
- 2 has the opportunity. She is commissioner now.
- 3 MS. SMITH: Okay.
- 4 CHAIRPERSON BELL: Okay.
- 5 MS. SMITH: Thank you.
- 6 CHAIRPERSON BELL: Any other comments from
- 7 the audience? Yes. Dr. Divers.
- 8 MR. DIVERS: Mr. Chairman, I'm Dr. Arthur
- 9 divers. I'm the liaison representative for the
- 10 Honorable George Cushingberry, City Council. I just
- 11 have a concern here. You have just had a police
- 12 officer who has retired who had twenty years of
- 13 service, and he retired with all of his senses and
- 14 everything working properly. The reason I'm concerned
- 15 about that is because you can go out there any day and
- 16 not return. He worked twenty years. And I would think
- 17 that we ought to have had a service here or some
- 18 program which would highlight his contribution to the
- 19 city and to this community. I know that you gave him a
- 20 certificate, but I don't think that's enough for his
- 21 twenty years of service to this community. And I would
- 22 think that, you know, as a difference between reality
- 23 and perception, reality is factual, but perception is
- 24 what people see and they think they see but it may not
- 25 be truthful. So if you -- you want to be sure. You



- 1 had a man here with public relations, background. And
- 2 this ought to be on front page, the news, the Free
- 3 Press, all of that. They should have been here for
- 4 this man's retirement. All I'm saying, I hope that --
- 5 in the future you're going to have other officers
- 6 retiring and give them the full glory of what they have
- 7 done for this city because they've paid a heavy price.
- 8 And I just don't think they were recognized for what
- 9 they have done for this community as it is today.
- 10 CHAIRPERSON BELL: Dr. Divers. I think
- 11 Commissioner Crawford want to respond.
- 12 COMMISSIONER CRAWFORD: With all due respect,
- 13 there is going to be a ceremony. I believe it's
- 14 January the 30th, if I'm not mistaken. And the flyer
- is posted in every elevator in this building. Matter
- of fact, I noticed one today when I came in for Officer
- 17 Milhouse. And so there is a ceremony. And I believe
- 18 it's -- well, I know it's the 30th. I think it's,
- don't quote me on the time, 1:00 or something like
- 20 that. We don't have copies of the flyers. But I
- 21 notice that every elevator in this building there's a
- 22 flyer posted recognizing Officer Milhouse and the date
- 23 and time of the ceremony that's occurring. And you're
- 24 right, that is appropriate, sir.
- MR. DIVERS: Thank you.



- 1 CHAIRPERSON BELL: I just want to say that
- 2 retirements take place quite often, and you just heard
- 3 a resolution that this body bring forth to recognize
- 4 that. That resolution might be presented in ceremony.
- 5 But each officer, their command would have a ceremony.
- 6 If that officer care to, they can go through the
- 7 formality of a retirement party. They call it
- 8 traditional coffee and cake. We witness that weekly
- 9 quite often. So that's pretty much the process. This
- 10 is not the forum that we conduct it, but the department
- 11 take care of that. But we do give recognition. If
- 12 they way want a resolution, most times the department
- initiate it and sometimes we initiate it. And they
- 14 have an opportunity -- most cases they don't even
- 15 attend for the resolution. But it might be given to
- 16 them at a later date. They don't come out to this
- meeting here. But he came out, and I'm impressed with
- 18 that. And the judge came out. So that's why we
- 19 conducted that part. We get retirement weekly. We get
- 20 10 or 12 names of retirement and that's how that --
- 21 that's the history how that works. So we're not, you
- 22 know -- we're not not trying to recognize that. But we
- 23 appreciate that. That's why we responded in the manner
- 24 we responded. Because about four or five of us retired
- 25 from the police department. So thank you for bringing



- 1 it to our attention, sir.
- 2 MR. DIVERS: Thank you.
- 3 CHAIRPERSON BELL: One final announcement.
- 4 Graduation ceremony as you heard will take place at
- 5 Greater Grace at 10:00.
- 6 ASSISTANT CHIEF DOLUNT: Yes, sir.
- 7 CHAIRPERSON BELL: At 10:00 a.m. The
- 8 Commissioners are invited to attend. The public
- 9 invited to attend. And I think it's going to be a
- 10 tremendous ceremony because we got the deputy chief all
- 11 the way down to the graduating class. And we had an
- 12 opportunity to speak to that class on Tuesday morning,
- 13 myself and Lawrence Akbar, representing OCI. And
- 14 George Anthony, the board secretary. It was a good --
- 15 we initiated that to have that type of dialogue for
- 16 each class that come out. It's one thing to have two
- 17 minutes to speak to them at the graduate ceremony. But
- 18 I think it's important that they understand the role of
- 19 the police commission and officer the chief
- 20 investigator. So we welcome that format that we
- 21 initiated that. But this year we've been engaging. I
- 22 want to look them in the eye and have that type of
- 23 dialogue with those officers and welcome them a little
- 24 bit more extensively versus the graduation. You only
- 25 see them for two minutes and all the pomp and



- 1 circumstance. But I'm pleased with the class that's
- 2 coming out. We had a good 45 minutes to exchange that
- 3 information. We shared some war stories. We missed
- 4 the PowerPoint, but we going to work that up and modify
- 5 it anyway.
- I just wanted to acknowledge our chief
- 7 investigator Pamela Davis Drake, keep her in your
- 8 prayers. We funeralized her mother last Saturday. It
- 9 was a great service. And your mother is not only a
- 10 great person, but just great to see all the Inkster
- 11 individuals in the house. And they showed up and the
- 12 holy spirit was just -- you're blessed, and you know
- 13 that, to have a mom that loved the Lord. And that
- 14 carries over to you and your family. So I just want to
- 15 continue to lift you up and the rest of the
- 16 commissioners too and as we move forward because
- 17 commissioner Crawford's mom passed not to long ago too.
- 18 So we going to keep you in our prayers.
- 19 So the chair, the board stand for
- 20 adjournment, if there's no other business coming before
- 21 this body. What is your pleasure?
- 22 COMMISSIONER MOORE: So moved.
- 23 COMMISSIONER SHELBY: Support.
- 24 CHAIRPERSON BELL: Ready for the question?
- 25 Those in favor.
