He is serving in the capacity of working with -- I won't say working for, but I will say working with Council George Cushingberry. He is serving on his staff. So I just want to appreciate him. And he attends quite a few meetings in terms of

I won't tell you age but --3 So Mr. Secretary, I assume we can go forward 4 with Assistant Chief report. Would that be 5 permissible? 6 7 SECRETARY ANTHONY: If you don't mind, I would just like to introduce the staff that are here. 8 CHAIRPERSON BELL: That would be -- we can do 9 10 that staff, certainly, by all means. SECRETARY ANTHONY: Thank you, sir. 11 Ms. Pamela Davis-Drake, our Chief 12 13 Investigator, is seated in front. CHAIRPERSON BELL: Yes. 14 15 SECRETARY ANTHONY: Mr. Robert Brown, our 16 Administrative Assistant, is in back recording the 17 proceedings. Good to see all of you, in terms of --2.1

22 Any audience member want to introduce
23 themselves? Just stand up, please. So we on
24 housekeeping right now.
25 MR. CORLIN: Yeah, Chief White may not



1	remember me. I am actually a visitor from Los Angeles,
2	but native Detroiter.
3	CHAIRPERSON BELL: Yeah.
4	MR. CORLIN: I actually volunteer about a
5	hundred hours a month to the Los Angeles Police
6	Department's Criminal Gang Homicide. We met a few
7	years ago when I first started when the Chief first
8	started here. And I haven't had an opportunity to come
9	back.
10	One of the things that I am looking forward
11	to possibly coming back here
12	CHAIRPERSON BELL: I am sorry, give your name
13	to the mic so she can catch it. I'm sorry.
14	MR. CORLIN: Yeah, my name is Arnie Corlin,
15	it's C-o-r-l-i-n. I am a native Detroiter who is
16	living in Los Angeles. I volunteer about a hundred
17	hours a month to the Los Angeles Police Department's
18	Criminal Gang Homicide.
19	One of the things that I have done as a
20	rental property owner, I've put up over 130 cameras
21	that the L.A.P.D. has used in 27 homicides, resolved
22	five use of force complaints against officers. And
23	like I say, I know Chief White may not remember me, but
24	we met briefly, and this gentleman here, I don't
25	recall. But I am looking forward to just coming back

1	here and kind of sharing what I have learned. My
2	properties are all in Watts, if anybody is familiar
3	with South Los Angeles, I have got 10,000 gang members
4	in ten square miles, and yet, I can explain why I no
5	longer have the gang activity, any shootings. And we
6	did it without arresting or evicting everybody. So if
7	anybody is interested, I will be glad to share.
8	CHAIRPERSON BELL: Okay. Thank you for
9	coming out and attending our meeting. That should be
10	interesting, what's happening in L.A.
11	So I assume that at this time we can have
12	Assistant Chief report out, so that's not an action
13	item at this time.
14	A.C. WHITE: Good afternoon, Board.
15	CHAIRPERSON BELL: Good afternoon.
16	A.C. WHITE: I am here sitting in for the
17	Chief who is out today.
18	It has been a very, very eventful couple of
19	weeks in the city. Very sad and violent week, with
20	regards to a lot of the shootings that have happened.
21	We have met as a team. We continue to meet
22	to try to curtail this uptick in violence.
23	Ironically, we continue to trend in other
24	crimes in the right direction, down. But the violent
25	crime, the ones the crimes that people, you know,

quality-of-life-type issues certainly are the ones that
we are focused on. And they are trending in the wrong
direction as it relates to some of the recent
shootings.

We are implementing a lot of strategies that I am not going to go into right now, but I will tell you that the Chief is aware, is engaged. He has engaged all of us, and we will not be reactive. We will attempt to be proactive. And as everybody here knows, we as the police cannot do it alone. This is a community issue. This is a life issue. And we really need the help of the community.

Most recently, with the street parties or the community parties, and the shootings that have happened there, we have not received much support from the community as it relates to who is doing what. A couple of these people are local heroes in the community. And as such, there are people reluctant to say what's going on. So we continue to pound the pavement and look for these folks who are terrorizing our community.

I guess I just want to assure the Board that we are engaged. And that, you know, we are not asleep at the wheel. The Chief is out there, as you know, you see him out there. We are out there. And this is just a real bad time for us. And we are hoping to get a

1 handle on this very s	on.

The other issue, I am sure everybody saw, was
the 500-pound pig in the basement. And that could have
been a lot worse than it was first reported. Because
that was actually reported as a homicide. There was an
allegation that the gentleman I use the term
loosely was murdering and feeding his victims to the
pig. So you could imagine our surprise when we got
there to find the pig in the basement with no stairs at
approximately 500 pounds. Obviously having eaten
something. So we had to go through and see exactly
what we were dealing with.

Animal Control, they get beat up a lot, but they did a phenomenal job, Mr. Ward, in particular, and his team, being in a hot basement, covered, and you can only imagine trying to get a 500-pound pig for approximately ten hours out of the basement. So just a phenomenal job.

And fortunately for us, there was no evidence that that was a homicide scene. The guy was a hoarder. He has everything in his backyard from caskets to, what else? radiators, and you name it, just an unbelievable scene. So we got the pig out.

And then you saw yesterday that he has another property in Highland Park. And now Highland



1	Park has a 300-pound pig in their basement.
2	So it has been a very eventful week, as I
3	indicated. And we continue to fight crime, to try to
4	engage the community, and get through this hopefully
5	temporary uptick.
6	That's it.
7	CHAIRPERSON BELL: Any questions or concerns
8	to Assistant Chief?
9	COMMISSIONER MOORE: Through the Chair, just
10	a quick question.
11	In regards to blight and lights in our city,
12	have there been any conversations with the Mayor's
13	office in regards to the correlation between crime and
14	the lack of light in certain areas and blight?
15	A.C. WHITE: Yes. There has been. And the
16	discussion has come up often. There are actually quite
17	a few programs going on right now. One is the I am
18	trying to think of the name of it, it has got a very
19	unique name to it. But it has to do with graffiti, and
20	lighting, and cameras. They are all working together.
21	And I was a part of that on the initial onset, but
22	A.C. Dolunt's office is managing that. And Scott Hayes
23	is working on that, as well.
24	Also, I don't know if you all know, when the
25	Mayor does his presentations once a month in the

1	communities, he talks about his strategic lighting
2	program. And because I don't have it in front of me, I
3	hate throwing stuff out that I might not be on point
4	with, but I do know that they are ahead of schedule on
5	lighting up the city. And he actually gives a date
6	certain that the city should be a hundred percent lit.
7	I don't have that date with me, so I don't want to just
8	throw it out there, but so yes, there has been
9	discussion. And the plan does consist of lighting
10	areas, you know, how that reacts to crime and other
11	things. And the Police Department is engaged in that
12	conversation, as well.
13	COMMISSIONER MOORE: Because the concern I
14	had was with the Dexter/Webb shooting, even today the
15	streetlights are still not on on Dexter. And the
16	Detroit Police Department had to contact the Detroit
17	Fire Department for lighting. So now you have three
18	City entities on one issue. So that's where the
19	question arises from. But I have always, you know,
20	rose that question. And then pass. So thank you,
21	Chief.
22	A.C. WHITE: You are welcome.
23	CHAIRPERSON BELL: Chief, you need to report
24	out on what took place last Thursday on Van Dyke and
25	Kercheval. So if you would share an awareness of



1	Butzel, I don't have the proper title, but I know
2	SECRETARY ANTHONY: Family Center, Butzel
3	Family Center.
4	A.C. WHITE: Oh, you know, we have had so
5	many issues. That's a good one. Wait a minute, I
6	don't have that in my notes.
7	No, yeah, that was a great day. And
8	unfortunately, it did not get the pub it should have.
9	We probably had about a thousand people there. The
10	police were there. Community members were there. The
11	Board was there. And the kids really had a great time
12	interacting with everybody. A noneventful event in
13	terms of crime or problems or fights and things like
14	that.
15	Commander Bettison, who is usually here, I
16	wish was here, could really speak
17	Can you get ahold of Bettison? Maybe he can
18	join the meeting before
19	But it was just a great event by all. The
20	Police Department was there. We had the officer who
21	I don't know if anybody saw the video that was
22	downtown dancing. The Chief thought, you know, it
23	might be a good idea for him to engage the young people
24	and brought him in. And he kept the young people
25	engaged. And it was just a very positive event. And I



Page 16 thought it was a great thing. I wish I had saw it on 1 2 the news. You had a thousand young people in one area with no problems. That's something that should have 3 been headline news. 4 5 CHAIRPERSON BELL: And they were there early. A.C. WHITE: They were there early. And what 6 7 happened was, the younger kids came in at the beginning of the event, the onset of the event, the 5- through 8 9 10-year-olds. And then as the day progressed, you had 10 your teenagers. And by the end of day, you had a cross-section of the entire community there. 11 CHAIRPERSON BELL: I just -- I know stopping 12 13 by to witness that type of interaction, that's something they should have reported out in terms of all 14 15 three stations, but it really was a good forum and 16 good, you know, peaceful, healthy, and folks, you know, 17 all individuals were there really -- they were really enjoying themselves. And I saw the officer do his 18 19 little thing up on stage before I left, so that was --20 I mean, it really was a great day. The weather 2.1 cooperated. 22 A.C. WHITE: Yes. 23 CHAIRPERSON BELL: I just want to commend the 24 Department to have that type of interaction.

10	Commander Bettison show up, we will definitely give him
11	that opportunity to share some more dialogue in that
12	forum and that kind of fashion, so
13	Young lady, since we are doing a little
14	housekeeping, and we don't have a quorum, would you
15	want to come up and give us an update in terms of your
16	interaction, anything you want to I can't, I am
17	sorry, I apologize for not knowing your name, but you
18	can introduce yourself at the mic.
19	MS. FARMER: Sure. My name is Alexis Farmer,
20	again, from Data Driven Detroit.
21	I don't have too much of an update other than
22	that I am still waiting on getting some data collected.
23	So I have been working with Ms. Pamela Davis to get
24	some of the complaint information up, as well as
25	talking to Garlin Gilchrist who is the Deputy Director

1	for Technology and Civic Engagement for the City. And
2	so we are kind of working together to get that
3	information on the City's open data portal so that Data
4	Driven Detroit can take that information, and make a
5	more comprehensive analysis of it. So it's still kind
6	of in the waiting stages. And I am waiting to hear
7	back from the Chief as far as whether or not it has
8	been approved.
9	CHAIRPERSON BELL: Maybe you can give us a
10	little background because of the people were not here
11	when you spoke earlier. Can you give us a little
12	background if you don't mind?
13	MS. FARMER: No.
14	CHAIRPERSON BELL: Okay. Thank you.
15	MS. FARMER: Okay. So I am working on the
16	Police Data Initiative, which is borne out of the White
17	House, to have like two streams of work. One of them
18	being releasing open data, so at least three data sets
19	that are aren't currently released to the public,
20	things like use of force, officer-involved shootings,
21	pursuits, including information that could be the age,
22	the race, and gender of both the defendants and the
23	officers. And also another tracking more internal
24	accountability, so being able to use some of that



information to inform some of the decisions that police

1	officers make, and do like some type of early warning
2	analysis with some of the officers. So that's kind of
3	the premise of the initiative.
4	CHAIRPERSON BELL: Any questions or concerns?
5	We appreciate it.
6	Oh, yes, sir.
7	COMMISSIONER CRAWFORD: Yes, sir. Through
8	the Chair.
9	Well, I guess it was weeks ago when we met
10	too, I said that well, it is my intention to check
11	back often in terms of the Department, you know, the
12	progress of this or lack thereof. Because I think it
13	is a good initiative. So thank you.
14	MS. FARMER: We are definitely working on
15	getting some of the big data, and then just in the
16	meantime working on some of the data that is available,
17	like complaints, some of kind of the information that
18	was in the report from last meeting about like the
19	applicant hires.
20	So if some of you all are available, I do
21	have a few questions to ask about how I can access some
22	of the things that are like currently out there, even
23	just like the Districts that you all represent, some of
24	the Police Department Districts and Precincts and those

offices, and how I can get that information to get that

1	on the city report, as well.
2	CHAIRPERSON BELL: Thank you. Appreciate it.
3	COMMISSIONER CARTER: I have a question.
4	CHAIRPERSON BELL: Yes.
5	COMMISSIONER CARTER: I am sorry, through the
6	Chair.
7	CHAIRPERSON BELL: Yes.
8	COMMISSIONER CARTER: How long is the
9	initiative?
10	MS. FARMER: How long is it?
11	COMMISSIONER CARTER: Yeah. When did it
12	start and how long will it continue?
13	MS. FARMER: So it officially launched in
14	May. It had been in the working since about November
15	of 2014. And then there was an event at the White
16	House in April, early April, where there were about I
17	think maybe about a hundred or so people, a collection
18	of police officers, chief technology officers,
19	information officers both from departments different
20	like University staff that could kind of help data
21	analysis experts. And we gathered it together to
22	figure out how we can really make this initiative work.
23	And so right now as of day like 21 communities are
24	already signed up, and so I am just trying to get
2.5	Detroit to be another initiative, another city. So



1	there is like kind of ongoing things and different
2	cities are releasing data just kind of at their own
3	will.
4	COMMISSIONER CARTER: How many people are
5	working with you or are you by yourself in the city?
6	MS. FARMER: Okay. I can answer that in
7	different ways. I was an intern at the White House
8	while this was going on. So I worked on it while I was
9	there. And so I do still have some support from the
10	presidential innovation fellows that like warned this
11	initiative. So I am in communication with them. I do
12	work with Garlin Gilchrist a lot about like kind of
13	where the data should be stored. And then my staff at
14	Data Driven Detroit has been very supportive and
15	helpful in the process, as well.
16	COMMISSIONER CARTER: Thank you.
17	CHAIRPERSON BELL: Thank you. Appreciate it.
18	(Commissioner Taylor entered at about 3:25
19	p.m.)
20	CHAIRPERSON BELL: I want to welcome
21	Commissioner Jessica Taylor to the Board meeting. And
22	you are star of the afternoon. Because you give us a
23	quorum.
24	COMMISSIONER TAYLOR: Oh, all right. Okay.
25	CHAIRPERSON BELL: Okay. We appreciate your



1	attendance, and your involvement.
2	COMMISSIONER TAYLOR: Thank you.
3	CHAIRPERSON BELL: Commissioner Jessica

20	The Chair would entertain a motion to
21	approval of the minutes from Thursday, June the 25th,
22	2015. The minutes have been circulated and you have in
23	your package. They was e-mailed to you also. So what
24	is your pleasure in terms of a motion?
25	COMMISSIONER WHITE: Mr. Chair, I do have an



1	amendment to the minutes
2	CHAIRPERSON BELL: Yes, sir.
3	COMMISSIONER WHITE: as presented. On
4	page 2, under number 10, where it references
5	Commissioner White advised that the Feds have set aside
6	\$50,000 for witness protection. Actually, my comments
7	arised out of I believe that through Wayne County,
8	there is only a budget line item for \$50,000 for
9	witness protection efforts. And which may lead us to
10	some conversation that we should explore forfeiture
11	funds and others to look at bolstering that account.
12	CHAIRPERSON BELL: So we have the corrections
13	to the minutes.
14	COMMISSIONER WHITE: Move for adoption.
15	CHAIRPERSON BELL: It's been moved.
16	COMMISSIONER MOORE: Second.
17	CHAIRPERSON BELL: Those in favor, aye?
18	COMMISSIONERS: Aye.
19	CHAIRPERSON BELL: Those opposed?
20	Motion carried.
21	Thank you, Commissioner White, for that
22	correction. It has been duly noted. And therefore you
23	will get that correction.
24	We already heard from the Chief of Police.
25	At this time, we can move forward with

2	at the last meeting reference to perhaps Board
3	Secretary, sort of highlight those concerns that we had
4	at that meeting, I would appreciate it.
5	SECRETARY ANTHONY: I think Commissioner
6	Carter asked about the purpose of the forfeiture fund
7	and expenditures out of the forfeiture fund and things
8	of that nature. And yeah, I think that was basically
9	it, just to the expenditures, and where does the money
10	go for the most part.
11	CHAIRPERSON BELL: Thank you, sir.
12	Commissioner Carter, that's pretty much what
13	you concerns?
14	COMMISSIONER CARTER: Pretty much.
15	CHAIRPERSON BELL: Okay. You are here.
16	Good.
17	Good to see you, D.C. Tolliver.
18	D.C. TOLLIVER: Good afternoon. Second
19	Deputy Chief Tina Tolliver.
20	So the first question is, what is the purpose
21	of forfeiture dollars?
22	So we have the ability to collect funds from
23	operations that result from seizures or forfeits of
24	property or cash. We have local forfeiture, and we
25	have federal forfeiture. The category is dependent



1	upon who we are partnering with during the operation.
2	There are about 19 permissible uses for
3	forfeiture funds. But the primary purpose is for law
4	enforcement purposes. That can include equipment, that
5	can include uniforms, that can include vehicles.
6	There are also impermissible uses that can be
7	found and that we follow, but all of those items are or
8	the Department of Justice's website.
9	If you would like, we can forward a copy of
10	those permissible and impermissible uses to you.
11	As far as collections, from 2000 up
12	through 2014, for three years, over a three-year
13	period, we collected about \$6 million.
14	Again, we used those dollars across the
15	board. One of our largest recent purchases was the
16	armored vehicle. That was about a half million
17	dollars.
18	Then you also have the piece where there are
19	forfeits for operations such as OTE, you know, the
20	offer to engage for prostitution. And then forfeits
21	that are related to narcotics-related vehicle seizures.
22	In those cases, the claimant has an
23	opportunity to retrieve their vehicle for \$900. And
24	depending on why the vehicle was seized, the City will
25	get a portion of the \$900.

1	If it is an OTE operation, the City gets \$650
2	out of the 900. And if it is the other operation, we
3	get I believe \$700. \$750.
4	There is usually about a one-month turnaround
5	between the time that the \$900 is paid to the County
6	and the time that we get those funds.
7	Our last checks that we received were delayed
8	because they had some personnel issues at the County,
9	but I think we are back on track. And I think those
LO	are the primary areas that we get those funds from.
11	COMMISSIONER MOORE: Through the Chair, where
L2	are the funds housed? Are they in the City's general
13	fund, or are they housed someplace else?
L 4	D.C. TOLLIVER: No. The forfeiture dollars
L5	by law have to be kept separate. So they are in a
L 6	separate fund, in a separate bank account.
L 7	COMMISSIONER MOORE: Thank you.
L 8	CHAIRPERSON BELL: Any other questions or
L 9	concerns?
20	COMMISSIONER WHITE: Thank you, D.C.
21	Do we have a responsibility to spend those
22	funds annually to zero balance, or does it carry over
23	year to year?
24	D.C. TOLLIVER: Depending on the type, they



can carry over. I can't remember which one, but it is

1	several years. It is several years. And every year,
2	we have to submit a report to the Department of Justice
3	on our expenditures, and then some other law
4	information that they require from us, as well. And we
5	have not had any findings from the DOJ.
6	COMMISSIONER WHITE: And for the funds, if I
7	may, for the funds that are not able to be carried
8	over, is that forfeited back to the DOJ if it is not
9	spent here? Or what happens to those funds?
10	D.C. TOLLIVER: I wouldn't know that. I
11	would have to I would have to find out what would
12	happen because we haven't had that issue.
13	COMMISSIONER WHITE: Okay. Good.
14	CHAIRPERSON BELL: Go ahead, sir.
15	COMMISSIONER CRAWFORD: Through the Chair, so
16	I realize you said \$6 million over the last three
17	years.
18	D.C. TOLLIVER: Three years.
19	COMMISSIONER CRAWFORD: So what do we have
20	today at this moment in the fund? What do we have?
21	D.C. TOLLIVER: Well, I would not count the
22	current year, only because, for example, with the
23	federal forfeits, the claimant has an opportunity to go
24	to court and get those funds back. And sometimes it
25	can take a long time. So accounting-wise, those funds



1	are called refundable deposits that we cannot touch
2	until the case is adjudicated. And so when we get the
3	court order, we send the claimant there, whatever we
4	have been ordered to do. We also pay legal fees out of
5	that fund, and the Wayne County Prosecutor fees, as
6	well.
7	COMMISSIONER CRAWFORD: Yes, ma'am. So
8	pardon me. We still, aside from that, you talked about
9	the funds, and I do understand that in terms of that
10	may be involved in some litigation or something like
11	that or they have the opportunity to come back and
12	perhaps through court maybe get their money back. So
13	aside from that, do we have a balance of that's
14	separate from that?
15	D.C. TOLLIVER: I am sorry, I was leading up
16	to say the current year, we will not close out the
17	funds that we have collected for this year until we go
18	through our end of the year process, for that very
19	reason. So I would not feel comfortable giving the
20	current year number.
21	COMMISSIONER CRAWFORD: Yes, ma'am. Okay.
22	D.C. TOLLIVER: But I can give you for sure
23	our collections through 2014.
24	COMMISSIONER CRAWFORD: Yes, ma'am.



D.C. TOLLIVER: Because typically by now,

1	funds received through July '13 through June 2014,
2	would have already been adjudicated. And it can take
3	several months for these things to go through court.
4	COMMISSIONER CRAWFORD: Yes, ma'am. Thank
5	you.
6	D.C. TOLLIVER: You are welcome.
7	CHAIRPERSON BELL: Any other questions or
8	concerns?
9	I just have one question. I think I raised
10	this question last year, in reference to the forfeiture
11	law stipulates, and you can correct me if I am wrong,
12	in reference to drug education prevention, and I didn't
13	do a follow-up in reference to pursuing that with the
14	Department, but I know at one time, we used to engage
15	in drug education prevention. The most noteworthy
16	person was Michael Officer Mike Lemon, doing a whole
17	lot of that in the schools and community, wherever.
18	And so where do we stand today in reference to first
19	of all, is that part of the law, I mean, the ordinance
20	dealing with that in terms of are we engaging in drug
21	education prevention, which is part of that criteria?
22	I know at one time quite a few churches and
23	community groups, etcetera, etcetera, received funding.
24	And there was a whole lot of gray areas because they
25	was not utilizing those funds properly, and then

1	borderline criminality, etcetera, etcetera. So I know
2	they shut it down for a period of time. But where are
3	we today with those, if that's something that we should
4	be engaging in, are we engaging in today?
5	D.C. TOLLIVER: Well, I know that the
6	Department is reviewing all of the permissible uses.
7	And we are coming up with a plan on what we want to use
8	the funds for. That's how the armored vehicle came
9	about and things of that nature.
10	We have to be very careful in what we do

15	To your point, one of the permissible uses is
16	drug and gang education and awareness program. So yes,

19	respond is that we are not indulging we are not
20	engaging in terms of manpower or spending monies in
21	that area? Would that be your respond?
22	D.C. TOLLIVER: No, my response is that is a
23	permissible use in that we are reviewing some of the
24	areas that we are going to spend the funds on going
25	forward.

7	youth-related programs.

19	that the Department really should look at because I
20	don't you say for several years.

22	One of the programs is called D.A.R.E.
23	CHAIRPERSON BELL: I understand.
24	D.C. TOLLIVER: And but what I am saying
25	is at this moment, I cannot say if we are using



1 forfeiture funds for that project.

A.C. WHITE: If I may, through the Chair, the two programs that we used to fund was D.A.R.E. and GREAT, the Gang Resistance Education and Training program. Those two programs over the years have not been as active as they were. And we have found that really, we weren't getting the best use of our funding through those programs. So as the D.C. indicated, we have so many needs and there's been such a lack of investment in the Department for a number of years, we found that using our forfeiture funds differently was more beneficial for us.

We are still engaged, though, however, in those practices, but not using forfeiture funding. So we are still engaging the youth. The program that we just did last week was a youth engagement program. And there are many other youth engagement programs. They do a youth camp every year. But specific to forfeiture funds, no, we have not line item a forfeiture fund for gang resistance education or drug resistance education. Have we provided equipment over the years for gang intel, things like that? Yes. And that's some of the things we are looking at now, how can we enforce the law specific to those groups, get more people in those areas, get more equipment in those areas, more

Charrenson bell: I would nope that we
not in compliance, and that ordinance, I mean, that law
would specifically, you know, address that could I
am familiar with it, because we work with it, we didn't
get funding from DPD, we got funding through
temporarily through Wayne County government, you know,
through the Sheriff Department, through Wayne County
Commissioners. So that area I would hope that we would
engage, because it is targeted for that drug education
prevention awareness. And surely we have people still
engaging, that has not ceased, that continue down that
line.

I just hope that we can do some type of monitoring and you can report out, you know, at some point in time how we should be in compliance with that, you know, when all these issues dealing with -- I know middle school and high school, you have got to start early, that type of awareness, like campaign, no smoking, no drinking, you know, we just lost two outstanding young people from Cass and King, in terms of -- on Connor, as you well know, I visited the scene, we had about 120-some parents there, you know, speeding, whatever that went down, but basically is that I am sensitive to that we should be working in



1	that area.
2	A.C. WHITE: Yes.
3	CHAIRPERSON BELL: I just want to share that.
4	A.C. WHITE: Yes, and if I may just as a
5	by way of follow-up, and I apologize if I am not
6	CHAIRPERSON BELL: I understand.
7	A.C. WHITE: framing it in the correct
8	manner. There are a couple of issues. As it relates
9	to compliance, we are not noncompliant
10	CHAIRPERSON BELL: Okay.
11	A.C. WHITE: with regards to the
12	forfeiture funds. There is an opportunity in the
13	forfeiture fund to fund those programs. And what I am
14	saying to you is over the past couple of years, we have
15	not focused on funding those programs. But I don't
16	want to leave you with the impression that there has
17	been no programming. Those are totally different
18	concepts. We are actively engaged with our youth in
19	the community. We are actively engaged with our youth
20	in the schools. We are installing right now a police
21	program in a school. Assistant Chief Stair is working
22	on assisting with a training and teaching program that
23	will talk about drug resistance education and funnel
24	those kids into the Police Department and the Fire
25	Department should they choose these careers. So we are

Τ	constantly actively engaged. And again, Commander
2	Bettison is working on a number of programs.
3	Now, as it relates to forfeiture, because
4	of you know, and I am not blaming everything on the
5	bankruptcy, but the bankruptcy is what it was. And
6	there was a lack of investment in the Department, so
7	because there was such a significant need, we have
8	focused a lot of our forfeiture dollars on those other
9	opportunities that forfeiture avail to us to, you know,
L 0	building use for 2121 Fort Street, where we house our
L1	forfeiture vehicles, those types of things. But the
12	investment in the youth is not lacking. It is just not
13	being funded through forfeiture.
L 4	Lastly, we are already engaged in planning
15	our forfeiture dollar structure for the next year,
L6	right now. And we will certainly take into
L 7	consideration what you have brought to the table today.
L8	CHAIRPERSON BELL: I appreciate that clarity,
19	and I think that would be really worthwhile in terms of
20	hearing as you develop that. I appreciate you giving
21	that clarity. And I know you are engaging young people
22	because I witnessed that on several different
23	opportunities.
24	Commissioner Crawford?

the spirit by which your commentary just arised. I do
believe, which is evident in our last election process,
that there is some work that this body should do in the
interim. The only concern I would forecast is that so
far in advance, you still would not have the will of
your body at that time. And so if members are if we
vote for a date specific now, that date could
ultimately down the road not be the most optimal date
to hold an election process. But seeing that we know

1	we can pursue what you just suggested, whether it be 60
2	days, or 90 days, but as you well know, the far out
3	you cannot predict what's going to happen next year,
4	but there are dates of elections scheduled for next

4	And I know I have a great deal of respect in terms of
5	serving in that capacity in terms of the advancement of
6	colored people and people of color. That's very
7	meaningful because it is something that people call on
8	NAACP, well, I know they are there, they have got to
9	respond to my charge now, but they are not members or
10	anything like that, but the NAACP has played a role. I
11	know when we got laid off back in the '70s, we filed a
12	lawsuit. And the NAACP took up that lawsuit. They
13	filed a lawsuit. And we worked hand in hand with the
14	executive director and others in terms of winning that
15	lawsuit. So
16	And myself and Herman I know are life
17	members, we led the charge at the time to get as many
18	members as to be life members. And I thought that was
19	one of the proudest moment of my life to be a life
20	member of NAACP. And hopefully others have taken up
21	the banner through the churches and NAACP. Without the
22	NAACP and other civil right organization, we would not
23	be where we are today in terms of serving in this
24	capacity.

So I just want to thank you over and over as

1	you go forward in terms we are going to be leaning
2	on you, we going to be calling you, we are going to
3	your words and wisdom is not going to be wasted on us.
4	So we really appreciate your role.

And we have some light refreshment. And we have a nice picture of these two young people here. You get to share some personal remarks. And we are going to share with others. And eventually going to give it to them as a keepsake. So I just want to thank you. Thank you. May God bless you, with Godspeed, keep you well, keep your family well. 
