

JOB POSTING: POLICE INTERN (Summer 2015)

City of Detroit Police Department

The Detroit Police Department (DPD) is accepting applications for a Police Summer Intern Program. This program has been designed to prepare and develop students who intend to enter a career in law enforcement as well as support their successful completion of a college education. Interns will learn about the functions and duties of a metropolitan police department, how to develop their career, and receive hands-on experience in various divisions of the DPD. Through the DPD Summer Intern Program, students will gain valuable work experience, on the job training, and have an opportunity to develop a professional networking base for future positions in government or law enforcement.

Schedule: 35 hours per week

Unpaid; if funding is made available, the internship may be a paid position.

Work hours depend on assignment

Duration: June 9, 2015 through August 14, 2015 (10 weeks)

Minimum Qualifications:

• GPA 2.3 (based on 4.0 scale)

- Major area of study: Criminal Justice, Law or related area
- Age 18 or older
- Strong desire to pursue a career in law enforcement
- Citizen of the U.S.A.

Requirements:

- Submit an essay of between 150 and 250 words re:
 - 1) Why an internship with the DPD important to me and my career goals
 - 2) My future goals and ambitions related to a career in law enforcement
- Complete application packet with transcript and submit to college internship coordinator

To become a DPD Intern, applicants must successfully pass a police background check, drug test, provide a photo ID and Medical Certification of Fitness from their physician. Candidates will be required to sign Confidentiality Agreement and Release of Liability forms at time of hire.

Description of Duties:

- Learn about all aspects of the Detroit Police Department through observation, education and hands on experience
- Work side by side with police personnel in performing and assisting with multiple police duties
- Experience police work through assignments in patrol/precinct duty and special interest areas
- Participate in ride-alongs with officers
- Perform administrative support as requested
- Assist police with cases and investigations
- Participate in Career Development learning experiences and Town Hall sessions

Candidates will be selected from recommendations by college/university internship coordinators. Candidates will be ranked and selected for oral board interviews conducted by Detroit Police Officers.
