This Amendment No. 1, effective on September 22, 2011, is executed by and between the City of Detroit, a Michigan municipal corporation (hereinafter referred to as the "City") and Detroit Belle Isle Grand Prix, Inc., a Michigan not-for-profit corporation (hereinafter referred to as "DBI") is made relative to the holding of the Detroit Grand Prix Races and closing of city streets related thereto.

WITNESSETH:

WHEREAS, the City and DBI entered into that certain contract between the City of Detroit and Detroit Belle Isle Grand Prix, Inc. and permit for the Detroit Grand Prix Races and Temporary Closing of City Streets effective on November 1, 2006 (the "Agreement"); and

WHEREAS, the City Council of the City adopted a resolution (the "Resolution") declaring the Racing Events (as defined in the Agreement) to be for public purposes, including the promotion of commerce and tourism and for the benefit of the citizens of the City; and

WHEREAS, the City Council of the City, by the Resolution, authorized the issuance of a permit to DBI, pursuant to the City Motor Vehicle Racing Act of 1981 (the "Act"), and authorized the Mayor of the City to enter into the Agreement, on behalf of the City, to effectuate the terms of the Resolution; and

WHEREAS, DBI's plans for the 2009, 2010 and 2011 Grand Prix Races were suspended due to the general economic conditions prevailing in Michigan and the rest of the United States of America; and

WHEREAS, as a result of improving general economic conditions, DBI, one of whose Board of Directors members is Roger S. Penske, intends to conduct Grand Prix Races in the City on certain City streets in 2012, 2013 and 2014, subject to the terms of the Agreement; and

WHEREAS, DBI and the City are agreeable to amending the Agreement to provide for DBI's conduct of the 2012, 2013 and 2014 Grand Prix Races in the City, subject to the terms of the Agreement; and

WHEREAS, the City Council of the City has adopted a resolution (hereinafter referred to as the "2011 Resolution") declaring the 2012, 2013 and 2014 Racing Events to be for public purposes, including the promotion of commerce and tourism and for the benefit of the citizens of the City; and

WHEREAS, the City Council of the City, by the 2011 Resolution, authorized the extension of the permit issued to DBI pursuant to the Act, and authorized the Mayor of the City to enter into an amendment of the Agreement on behalf of the City, to effectuate the terms of the 2011 Resolution.

NOW, THEREFORE, in consideration of the premises, the mutual undertakings, and benefits to accrue to the parties and the public, the parties hereby agree as follows:

1. Section 2.01 of the Agreement is hereby amended to: (A) delete the words "and 2011," and to substitute the phrase ", 2011, 2012, 2013 and 2014," and (B) delete the words "including 2011." and to substitute the words "including 2014."
2. Section 3.01 of the Agreement is hereby amended to include 2012, 2013 and 2014 for the racing event.
3. Section 7.02 is hereby amended to add the following to the existing chart:

"

On the Payment Date following the conduct of the Racing Event specified below:	The sum of
2012	\$150,000
2013	\$175,000
2014	\$200,000

4. The references to "2011" in Section 10.02 are changed to "2014".
5. Section 16.01 is hereby amended to delete the references to "2010", "2012 through 2015" and "December 31, 2010" and to substitute "2014", "2015 through 2018" and "December 31, 2014", respectively.
6. Exhibit F of the Agreement is amended to delete the references to "2009", "2010" and "2011" and to substitute "2011", "2012" and "2013", respectively.
7. Other than as set forth in this Amendment No. 1, the Agreement shall continue in full force and effect.
8. This Amendment No. 1 may be executed in any number of counterparts and all of said counterparts taken together shall be deemed to constitute one and the same instrument. Promptly after the execution thereof, the City shall submit to DBI a confirmed copy of this Amendment No. 1.
