- 4** Make necessary repairs to the water damaged walls and ceilings in the following areas; south east entrance; girls' restroom at south entrance; rooms 108, 110, 111, 112, 202, 205 and 206; teacher's lounge; library and gymnasium. (Sec. 9-1-303)
- 5** Scrape and paint the following areas; rooms 109, 111, 112, 202, 207, 209 and 211; nurse's office; Assistant Principal's office; main storage room and teacher's lounge. (Sec. 9-1-304)
- 6** Make necessary repairs to inoperable/loose or missing lighting in the following area(s); northwest entrance. (Sec. 9-1-310)
- 7** Make necessary repairs to the missing ceiling tile at first and second floor hallways, boys' and girls' restrooms at south end on first floor and auditorium. (Sec. 9-1-303)
