- 1 Scrap and repaint the following areas: Custodian Closet, Conference Room, 2nd floor Staff Bathroom, room 103, and room 207. (Sec. 9-1-304)
- 2 Make necessary repairs to floor covering in rooms 200, 210 and the stage. (Sec. 9-1-304)
- 3 Replace missing and damaged ceiling tiles at Auditorium and rooms: 103, 200, 203, and 206. (Sec. 9-1-301)
- 4 Make necessary repairs to the roof at south end of building to abate the elements. (Sec. 9-1-206)
- 5 Make necessary repairs to water damage ceiling, walls, and floor at Teachers' Lounge and Computer Lab. (Sec. 9-1-303)
- 6 Submit by the compliance date an approved report by a competent workman confirming the structural integrity of the masonry stack. (18" or more diameter and 25' or more in length) (Sec. 9-1-35.10)
- 7 Make necessary repairs to masonry on smoke stack due to loose and missing bricks. (Sec. 9-1-205)
- 8 Make necessary repairs to walls and ceiling at 1st floor girls' bathroom. (Sec. 9-1-303)
- 9 Make necessary repairs to skylight at room 102 to abate the elements. (Sec. 9-1-212)
- 10 Secure the required annual "Certificate of Compliance" from this department. (Sec. 9-1-36a)
