- Scrape and paint the following areas; first, second and third floor hallways; rooms 4-310, 322, 317, 8-208, 222 and 213, cafeteria; auditorium; north and south stairwells. (Sec. 9-1-304)
- 5 Make necessary repairs to the defective floor covering at the following location; gymnasium. (Sec. 9-1-304)
- Make necessary repairs to the ceiling at room 103. (Sec. 9-1-303)
- 7 Submit an approved report by a competent workman confirming the structural integrity of the masonry stack (18" in diameter and 25' or more in length). (Sec. 9-1-35)
