BOARD OF ETHICS ACTIVITY INFORMATION

ACTIVITY DESCRIPTION: BOARD OF ETHICS

The Board of Ethics investigates and resolves complaints regarding alleged violations of the Ethics Ordinance by public servants and to issue advisory opinions regarding the meaning and application of provisions of the Charter, City ordinances or other laws or regulations establishing standards of conduct for public servants. Advisory opinions shall be rendered upon written request by a public servant. Advisory opinions shall be published by the Board annually in a report to the Mayor and City Council. The Board is charged with monitoring and recommending improvements in the disclosure requirements, and in the standards of conduct under the Ethics Ordinance, in order “to promote an ethical environment within City government, and to ensure the ethical behavior of public servants.” All meetings of the Board shall be open to the public; unless an individual involved in the matter to be addressed requests in writing that the meeting be closed; or unless otherwise provided by ordinance or by statute.

GOALS:

1. Receive and respond to inquiries, complaints and requests for advisory opinions.
2. Conduct investigations related to conduct of elective officers, appointees and employees.
3. Conduct hearings where warranted regarding complaints.
4. Issue advisory opinions within the time prescribed by the Ethics Ordinance.
5. Publish an annual report.
6. Develop educational and training programs for public servants.
7. Perform other functions essential to ensure the integrity of City government.

MAJOR INITIATIVES FOR FY 2005-06 and FY 2006-07:

- Develop material and information to increase employee and general public awareness of the Ethics Ordinance and its requirements.
- Enhance and upgrade Web Page
- Meet with community groups as requested to educate the public about the existence of the Ordinance and its importance of promoting an ethical environment in City government.
- Develop and conduct employee educational programs regarding the role of the Board of Ethics, standards of conduct, complaints and resolution procedures.

PLANNING FOR THE FUTURE FOR FY 2006-07, FY 2007-08 and BEYOND:

- Revise the Boards Administrative Rules and procedures as necessary in order to implement the Amendments to the Ethics Ordinance if adopted.
- Continue to review the current Ethics Ordinance in order to make recommendations for improvement.

DETROIT CABLE COMMUNICATIONS COMMISSION ACTIVITY INFORMATION

ACTIVITY DESCRIPTION: CABLE COMMUNICATIONS AND GOVERNMENT ACCESS

The Detroit Cable Communications Commission (“Cable Commission”) was established by ordinance in 1981 to operate as the City of Detroit’s local cable franchising authority with direct responsibility for the negotiation, administration, and regulatory compliance of the Cable Franchise Agreement between the City and Comcast Cablevision of Detroit. The daily programming; operation and management of Government Access Channel 10; and Education Access Channel 22, are collateral functions that result from the Franchise Agreement. Local programming for Government Access Channel 10 is typically developed and prepared for broadcast by the Cable Commission’s Media Production Services Division by working with City Departments, Mayor’s Office, City Council and other community organizations. The goal is to present programming that is informative, educational, entertaining and/or newsworthy for the Detroit viewers.

Another key administrative and regulatory compliance function is the management and permitting of telecommunications providers that seek and obtain access to and ongoing use of the City’s rights-of-way for telecommunications facilities. Detroit’s telecommunications ordinance and the State of Michigan’s Metropolitan Extension Telecommunications Rights-of-Way Oversight Act (2002 PA 48 or “METRO Act”) provide the framework for this activity.

Currently, in excess of seven (\$7) million dollars is generated annually for the City of Detroit as a result of the Cable Commission’s cable and telecommunications regulatory activities. The Cable Commission is a member of and provides management services for the City’s Wireless Telecommunications Site Review Committee.

GOALS:

1. Improve the Financial Health of the City
 - Execute and implement the Franchise Renewal Agreement between the City of Detroit and Comcast Cablevision of Detroit.
 - Facilitate the business development and expansion of the wireless telecommunications and wireless service providers within the City of Detroit.
 - Facilitate the use of cable access channels with City departments to diversify communication mediums.
 - Work with city and state officials to ensure that Detroit receives appropriate revenue from telecommunications providers’ use of the rights-of-way.
2. Accelerate Economic and Business Development
 - Continue to promote availability and impact of broadcast resources, and to work with the Mayor’s Office, City departments, City Council and others to develop and broadcast relevant local programming.
 - Work with telecommunications providers and State of Michigan officials to ensure that telecommunications facilities are properly managed in the City and potentially provide increased revenue for the City.
3. Improve Public Safety
 - Facilitate the cable drop process (franchise agreement) to ensure that facilities for Police, Fire, EMS and the new Communications Center have completed cable drops for access to telecommunication services.
 - Realign programming to balance resources with priority programming from public safety organizations (What is important to air from public safety perspective?).
4. Improve Key Stakeholder Relationships with Citizens, Employees, City Council and Business Community
 - Develop template for revenue generation from City Departments and others on how to budget for use of media production services.
 - Consult with the City government organizations to develop strategic programming and potential underwriting for “how to” work with identified key agencies.
 - Initiate Educational Consortium to address local programming and continue to partner with the Detroit Public Schools on airing educational programming.
 - Oversee municipal, education, community (MEC) committee process to address issue driven programming from broader perspective.

NON-DEPARTMENTAL (35)

MAJOR INITIATIVES FOR FY 2005-06 and FY 2006-07:

The predominate goal for the 2006-07 Fiscal Year is the implementation and/or execution of the Cable Franchise Renewal Agreement between the City of Detroit and Comcast Cablevision of Detroit.

The Cable Commission is not operating in a ‘blue sky’ environment when it forecasts deliverables for the 2006-07 Fiscal Year. The Cable Commission is now forced to scale its operations toward the effective management of its- core services, regulatory compliance of the franchise and telecommunications agreements, ordinances and statutes while sustaining media production and programming services that anchor the broadcasts on Channels 10 and 22. Potentially, over 100,000 cable subscribers may turn to Channels 10 and 22 for government and educational programming.

Under the ambiguous clouds of pending state and federal legislation, new federal rulings, opposition along with challenges from concerned third parties about the City of Detroit’s business dealings with Comcast, the convergence of technology, and entry of aggressive telecommunications providers (voice/phone) into the cable (video) marketplace, etc., the Cable Commission must complete the Renewal Franchise Agreement and Ordinance Amendment process with Comcast, and secure its approval from Cable Commissioners and the Mayor’s Office along with the respective ratification and adoption by the Detroit City Council.

Once the renewal process has been completed, the Cable Commission’s Regulatory and Compliance Staff, and Comcast will begin implementation of key time sensitive provisions in the Agreement with the goal of maximizing the accessibility of negotiated components for municipal, educational and community stakeholders, and others. In November 2005, City Council voted to extend the existing franchise agreement through April 30, 2006.

The lack of broadcasting of local programming on Educational Access Channel 22 surfaced as a significant gap in the 2005-06 Fiscal Year. Therefore, the closure of this gap is also another major initiative for the 2006-07 Fiscal Year. Cable Commission Staff and Commissioners will network with the Detroit Public Schools (DPS) and other educational institutions to establish new relationships and to identify new resources for the acquisition of local educational programming so that viewers and educational providers can receive the diverse benefits associated with local educational programming.

Although not categorized under the local programming umbrella, the GED [VideoClassroom@Home](#) Project provides a recognizable educational resource in the community and will be aired in the upcoming 2006-07 Fiscal Year.

Increasing departmental familiarity with and facilitating the use of the Cable Commission’s media production and broadcast services depict the third major initiative. Further, the value of the Cable Commission’s production services and its affiliated broadcast capabilities on two cable access channels needs to be continuously communicated to City departments in order to ensure that messages about City services, projects, events, etc. are regularly and thoroughly covered via the City’s broadcast medium. To strategically exploit the use of the City’s cable access channels, departments must include media production and broadcast services in their plans to communicate important information to potential viewers. When departmental communication plans are inked, the Cable Commission should be viewed as an essential, consistent partner in getting messages out to affected populations.

The fourth and related major initiative for the 2006-07 Fiscal-Year pertains to the identification and obtainment of alternative sources for revenue generation to support the Cable Commission’s media production services and programming activities. During the past two fiscal years, the Cable Commission has upgraded its technology through the acquisition of an automated broadcast system, cameras and editing equipment. However, it now has a shortage of human resources dedicated to media production services and will have in the foreseeable future unless diverse funding sources are identified.

NON-DEPARTMENTAL (35)

PLANNING FOR THE FUTURE FOR FY 2006-07, FY 2007-08 and BEYOND:

The Detroit Cable Communications Commission will align its budget, structure and service delivery capabilities and options with decisions made legislatively and administratively.

The cable and telecommunications legislative environment is plagued with uncertainty as national telecommunication players such as AT&T, Verizon and others jockey for entry into the cable/video services marketplace. The battle is being waged at the state and national levels where legislators are being encouraged to eradicate franchising at the local or municipal level, and in its place, pass legislation that supports either state or federal franchising agreements.

Although the Cable Commission has partnered with other key stakeholders [(e.g., Michigan Municipal League, Michigan Chapter of the National Association of Telecommunications Advisors and Officers (NATOA) and PROTEC)] to aggressively preserve existing municipal rights, funding and services, and to elevate issues (such as build-out requirements and redlining), the future structure and service delivery capabilities may, in part, depend upon enacted legislation.

The City's ultimate communications structure will also impact service delivery related to media production services. Increasing departmental familiarity with and facilitating the use of the Cable Commission's media production services and broadcast capabilities on two cable access channels (currently working on activating a third channel) is key to ensuring that messages about City services, projects, events, challenges, etc. are strategically communicated to targeted audiences. Broadcast communications' planning and funding should be a part of each department's commitment to reaching its constituency. Underwriting opportunities for programming will continue to be examined and exploited whenever possible to help promote relevant programming.

The Detroit Call Center will continue oversight of the City's "311" call system to ensure the integrity in reporting and managing caseloads, and providing quick and easy access to Detroit City services and information to our citizens, businesses, and visitors. The Call Center will enable City departments to improve service delivery by focusing on their core missions; and also serve as a tool to improve City government through measurement and analysis of Citywide service delivery.

MAJOR INITIATIVES FOR FY2005-06 AND FY2006-07

The Detroit Call Center will pursue more aggressive community outreach through a series of open house forums where citizens can voice their concerns and issues.

PLANNING FOR THE FUTURE FOR FY2006-07, FY2007-08 and BEYOND

The Detroit Call Center continues to seek ways to enhance its reporting mechanisms to ensure prompt customer service that leads to both internal and external customer satisfaction.

DETROIT BUILDING AUTHORITY ACTIVITY INFORMATION

ACTIVITY DESCRIPTION: DETROIT BUILDING AUTHORITY

The Detroit Building Authority (DBA) is primarily responsible for administering capital projects from start to completion in accordance with the Mayor's strategic priorities. Critical functions include encumbering funds through contracts of lease; distributing bid documents and request for proposals; issuing contract awards; securing required Human Rights Clearances; advising contractors of Executive Orders 2003-3, 2003-4 and 2003-5 requirements; preparation and execution of all contract documents; review and approval of contract invoices; actual payment to vendors; monitoring design development and construction for each capital project managed by the DBA. Funds are made available from city departments' capital improvement budgets as a result of bond sales, capital grants or general funds.

GOALS:

1. Improve public health through development of City facilities to create a healthier environment for employees and citizens to grow Detroit.
2. Comply with ADA requirements for City departments/citizens
3. Improve business climate by attracting and utilizing Detroit based Detroit headquartered businesses.

MAJOR INITIATIVES FOR FY 2005-06 and FY 2006-07:

- Web based program management/project management is a software tool used to manage multiple projects or single projects in real time. This software allows the user to quickly assess the current status of multiple projects or a single project, to review budgets between project types or locations, to review pictures of the project, to document and exchange information between project members. This tool will help to provide a single source for the deposit of project information. This tool can also eliminate redundant work processes thereby, providing more efficient use of staff time. Other activities managed by software include: payment approval process, project milestone and schedule tracking, centralized access to information 24/7, reduce cycle time for decisions and approvals, project scheduling, project reporting, cost tracking, and archiving.
- Continue to implement a DBA pilot program utilizing nationally recognized guidelines to maintain facilities as capital asset. This methodology known as "Facilities Asset Management" establishes a systematic process for maintaining, upgrading, and operating facilities.
- Contractor Outreach Workshop.

PLANNING FOR THE FUTURE FOR FY 2006-07, FY 2007-08 and BEYOND:

The Detroit Building Authority is working with city departments to Grow Detroit through the implementation of city departments' capital projects. The development of capital projects for city departments can be long and time consuming. It is important to quickly begin this process for any given project to maximize progress/completion in a timely manner. To the extent possible, Master Plans should be shared with the DBA as soon as possible, even if the funds are not yet available. The longest process is not the construction, rather, it is the financial process required to fund a project.

ACTIVITY DESCRIPTION: GREATER DETROIT RESOURCE RECOVERY AUTHORITY

The Greater Detroit Resource Recovery Authority (GDRRA) provides efficient, environmentally responsible waste disposal service(s) to the residential, commercial and industrial sectors of Detroit. This includes the acquisition, construction, improvement, enlargement, extension and operation of solid waste disposal facilities. The Authority's activities encompass one or more parts of a total waste management system (post collection) including transportation, recoverable materials marketing (recycling), generation and sale of waste derived fuel energy products (steam and electricity), and disposal. The Authority is a component unit and is legally separate from the City of Detroit.

GOALS:

1. Optimize quantity and quality of the facility's waste supply through economies of scale operation.
2. Increase efficiencies in our energy production and financial processes through improved collections and new revenue sources.
3. Minimize environmental impacts of Authority's waste management activities through proactive environmental quality initiatives and maintaining emission standards from our current state-of-the-art air pollution control system.
4. Maximize utilization of progressive management techniques and technology in performance of Authority business.
5. Improve efficiency and effectiveness in customer service delivery.

MAJOR INITIATIVES FOR FY 2005-06 and FY 2006-07:

Expand our ongoing Chene-Ferry Recycling Program through the inclusion of our Electronic Waste (E-Waste) program that meets the standards of the Department of Environmental Quality through a collaborative effort with Goodwill Industries.

PLANNING FOR THE FUTURE FOR FY 2006-07, FY 2007-08 and BEYOND:

GDRRA will continue to develop on-going strategies for alternative, efficient, and cost effective waste management continuing through the expiration of the sale-lease back transaction agreement in the year 2009.

PROGRAM MANAGEMENT OFFICE-HR PAYROLL PROJECT

ACTIVITY DESCRIPTION: PROGRAM MANAGEMENT OFFICE- HR PAYROLL PROJECT

The DRMS function, previously recorded in a separate agency, is merged into the Program Management Office- HR Payroll Project. Two staff positions from the DRMS function: General Manager-Finance and Head Clerk, were transferred to Program Management to continue support for the Help Desk and training. In FY 2005-06, a separate organization was established to implement the Program Management – Human Resources Payroll Project and to more accurately monitor the revenues and expenditures of the project. One aspect of the project is the implementation of a front-end time capture system utilizing the Workbrain Time and Attendance software. Workbrain, Inc., will provide professional support for technical and end-user training. Implementation of the time capture system requires an interface with Oracle HRMS module. This is an ongoing project and funds will be carried forward until the project is completely implemented. The department estimates the time period for completion as October 2007.

MAJOR INITIATIVES FOR FY 2005-06 and 2006-07

Program Management Office-HR Payroll project function will continue the implementation of HR Payroll with the installation of equipment and advanced benefit software.

PLANNING FOR THE FUTURE FOR FY 2006-07, 2007-08 and BEYOND

With the implementation of the new payroll system, there is an increased need for training and education. The Program Management Office- HR Payroll Project is prepared to provide the necessary instruction to all users of the system to optimize the maximum utilization, effectiveness, and efficiency of the system.
