**and The City Clerk’s Office Monday – Friday 9:00 a.m. – 4:00 p.m.**  
**Saturdays will be scheduled based on demand.**

- As a registered voter, you may obtain an absentee voter ballot if you are:
- Age 60 years of age or older
  - Unable to vote without assistance at the polls
  - Expecting to be out of town on Election Day
  - In jail awaiting arraignment or trial
  - Unable to attend the polls due to religious reasons
  - Appointed to work as an election inspector in a precinct outside of your precinct of residence

## Election Day UPDATE

On Tuesday November 7, 2017, a General Election is scheduled for the purpose of nominating candidates for the offices of the Mayor, City Clerk, City Council At-Large/Districts, and Police Commissioner. A Special Election in State Representative District 1 and two proposals will also appear on the ballot.

I am happy to report that the August 8, 2017, Municipal Primary Election was a huge success. Based on the report from the Wayne County Board of Canvassers, the challenges experienced in the 2016 Presidential Election have been resolved!

As you may know more than 600 new state-of-the-art voting machines were purchased. The new machines along with extensive hands on training provided to our Election Day pollworkers played a major role in the positive outcome voters experienced during the 2017 Municipal Primary.

On Election Night, 100% of election results were uploaded and available by 10:30 P.M. The tabulation of more than 28,000 absentee ballots were completed by 10:00 P.M. Election Night.

Though, we seek to administer “perfect elections” there is always more work to be done. We are recruiting and training more millenials as pollworkers. As our voting process become more computerized, the recruitment of millenials will be helpful.

In 2016, we launched **Democracy Day in The “D,”** to encourage businesses and non-profit and community organizations to allow their employees to work the polls. This resulted in over 185 new pollworkers. You can help by spreading the word about our efforts to recruit additional pollworkers to your family, neighbors, students and friends. MAYOR Vote for not more than 1	AN INITIATIVE TO ENACT A MEDICAL MARIHUANA FACILITIES ORDINANCE This proposed ordinance would amend Chapter 24, Article XII, of the 1984 Detroit City Code, <i>Medical Marijuana Caregiver Centers</i> , to opt into the Michigan Medical Marijuana Facilities Licensing Act, Public Act 281 of 2016, to provide for standards and procedures to license and regulate medical marijuana facilities through the Building, Safety Engineering, and Environmental Department and to impose conditions for operation and local specifications for schools, public libraries, religious institutions, and other medical marijuana facilities.	A PROPOSAL TO AMEND THE DETROIT ZONING ORDINANCE, CHAPTER 61 OF THE DETROIT CITY CODE, CONSISTENT WITH THE MICHIGAN MEDICAL MARIHUANA FACILITIES LICENSING ACT The proposal would amend the Detroit Zoning Ordinance, Chapter 61 of the 1984 Detroit City Code, Article III, Division 12, Sections 61-3-351 through 61-3-354, to establish land use standards and procedures for the regulation of medical marijuana facilities consistent with the Medical Marijuana Facilities Licensing Act, 2016 PA 281, to provide definitions, to designate medical marijuana facilities, including growers, processors, provisioning centers, safety compliance facilities, and secure transporters, as permitted uses subject to site plan approval and use regulations in specified zoning districts, to require compliance with zoning district standards, and to authorize fees to the City.

NON-PARTISAN ELECTION

TO VOTE: Completely darken the oval opposite each choice as shown: 

IMPORTANT: To mark your ballot, use only a black or blue ink pen. **DO NOT USE ANY OTHER INK COLOR!**


**DO NOT** vote for more candidates than indicated under each office title.

**WRITE-IN CANDIDATES:** To vote for a candidate whose name is not printed on the ballot, write or place the name of that candidate in the blank space provided and completely darken the oval. Do not cast a write-in vote for a candidate whose name is already printed on the ballot for that office.

**CHECK BOTH SIDES OF THE BALLOT:** This ballot may have two sides. Be certain to check the reverse side of the ballot.

**WHEN YOU HAVE COMPLETED VOTING:** Place the ballot in the secrecy sleeve so that votes cannot be seen and the numbered stub is visible. Return the ballot to the election official stationed at the tabulator. (If voting by absentee ballot, follow the instructions provided by the clerk for returning the ballot.)

**NOTE:** If you make a mistake, return your ballot to the election official and obtain a new ballot. Do not attempt to erase or correct any marks made in error.

**PARA VOTAR:** Llene completamente el ovalo opuesto a cada una de sus elecciones  como se muestra:

**IMPORTANTE:** Para marcar su voto, use tan solo bolígrafo de tinta negra o azul. **NO USE NINGUN OTRO COLOR DE TINTA.**

**NO VOTE** por más candidatos de los indicados bajo el titulo de cada posición u oficina.

**CANDIDATOS ESCRITOS:** Para votar por candidatos cuyo nombre NO está impreso en la boleta, escriba o ponga el nombre de ese candidato en el espacio en blanco y llene completamente el ovalo. **NO** escriba el nombre de un candidato cuyo nombre ya está impreso en la boleta para esa posición u oficina.

**CUANDO TERMINE DE VOTAR:** Ponga su boleta dentro del sobre de manera que sus votos no puedan ser vistos y que el talón numerado sea visible. Entregue su boleta al oficial de la elección que se encuentre en el tabulador. (Si está votando con una boleta de ausente, siga las instrucciones dadas por el encargado para regresar su boleta).

**NOTA:** Si comete un error, regrese su boleta al oficial de la elección y obtenga una boleta nueva. **NO** intente borrar o corregir ninguna marca hecha en error.

**الإقتراع:** ظلل تماما الشكل البيضاوي المقابل لكل إختيار كما هو في الشكل. 

**هام:** إستخدم فقط قلم حبر باللون الأسود أو الأزرق، لا تستخدم أي لون آخر.

**لا تقترع** لمرشحين غير المشار إليهم لكل منصب.

إذا رغبت في الإقتراع لمرشح ليس موجودا إسمه على قسيمة الإقتراع، اكتب إسم هذا المرشح في المكان الفارغ المعد وظلل الشكل البيضاوي. لا تكتب إسم مرشح موجود على لائحة الإنتخاب.

**تفحص كلا الوجهين من قسيمة الإقتراع:** هذه القسيمة لها وجهان، تأكد من فحص الوجه الخلفي للقسيمة.

**حين تنهي إقتراعتك:** ضع القسيمة في الظرف السري بحيث لا أحد يستطيع رؤية إقتراعتك وبحيث يكون الرقم ظاهرا، ثم أعد القسيمة إلى المسؤول الواقف إلى جانب ماكينة الإقتراع (إذا كان الإقتراع غيايبا، إتبع الإرشادات الموجهة من الموظف حين تعيد القسيمة).

**ملاحظة:** إذا قمت بخطأ، أعد القسيمة إلى المسؤول واحصل على قسيمة جديدة، لا تحاول التصليح والشطب.
