**Class Information:**

**Division & Age** – Age determination for boxers is by November 12<sup>th</sup> of the current year.

- Open Age: 17-34 years
- Novice Age: 17-34 years
- Senior Age: 15-16 years
- Intermediate Age: 13-14 years
- Junior Age: 11-12 years
- Bantam Age: 8-10 years (all bantams welcome)

**Weight Classes:**

- Open and Novice weight classes: 108, 114, 123, 132, 141, 152, 165, 178, 201, 201+



- Senior, Intermediate, and Junior weight classes: 80, 85, 90, 95, 101, 106, 110, 114, 119, 125, 132, 138, 145, 154, 165, 176, 176+
- Bantam weight classes: Any beginning weight with five pound increments:
- **Seed Boxers** – Open boxers rated in the top ten of the United States Amateur Boxing Ratings will be Seeded in the tournament prior to the DRAW.
  
- **Entries** – the boxer's completed entry form must be received in the office of the tournament director by November 1, 2011 by 5pm. The boxer's entry form must include the complete United States Amateur Boxing Validation Sticker Number. The entry form may be duplicated as needed and is available online at:

- **Entry Fee** – the entry fee for each contestant is \$5.00. Checks written for insufficient funds will be handled through your State Boxing Association. Entry fees are not refundable. **Make cashier's checks or money orders payable to: RECREATION ACTIVITY FUND (RAF) NO PERSONAL CHECKS ACCEPTED**
- **Invitation/Entry Limitations** – Participation in this showcase is by invitation only. All invitations are extended to the team coaches. The coach is required to be a United States Amateur Boxing certified coach, duly registered in his respective United States Boxing Association. The tournament director reserves the right to limit the number of entries for each team. All weight classes are welcome. Female weight class is in accordance with USA Boxing rules.

#### **Equipment and Apparel:**

- **Mouthpiece** – All boxers are required to wear an individually fitted mouthpiece. Referees shall disqualify boxers who enter the ring with anything other than a fitted mouthpiece.
- **Headgear and Boxing Gloves** – USA Boxing approved, competitive headgear and thumb-attached gloves are mandatory for all contestants. USA approved no-foul protectors are required for all male boxers. All weight classes will use 12 ounce gloves.
- **Boxing Shirts** – Boxers are required to wear a boxing shirt (sleeveless) while competing in the tournament. The boxer's legal name may also be included on the boxing jersey.

#### **Grooming:**

- Boxers must be CLEAN SHAVEN before the weigh-ins and tournament. A neatly trimmed mustache is permissible. Hair must be cut in such a manner as not to interfere with the vision of the boxer. Sideburns are not permitted to extend below earlobe. Boxers who do not report to the weigh-ins groomed as required will be denied permission to weigh-in.



### Medical:

- Medical Authorization Forms – Coaches are responsible for bringing a signed and notarized medical treatment authorization form for each boxer under the age of 18 years (included in this packet). Coaches are required to keep these treatment forms on site at all times during the tournament for quick availability.

### Officials:

- All boxing officials, judges, referees, and timekeepers will be registered with the United States Amateur Boxing and will have current certificates for 2011 in their possession.

**Team Representation** – Boxers shall be required to represent the club in which they are registered.

**United States Amateur Boxing Passbooks** – All boxers are required to present their 2011 United States Amateur Boxing Passbook prior to being permitted to weigh-in on November 12, 2011. Boxers will **NOT** be permitted to register for United States Amateur Boxing Passbooks at the weigh-ins. United States Amateur Boxing Passbooks must be secured in the boxer's United States Amateur Boxing Association district. There will be no exceptions **MADE!**

In addition, I also understand and appreciate that participation in sport carries a risk to me of serious injury, including permanent paralysis or death. I voluntarily and knowingly recognize, accept, and assume this risk.

### DIRECTIONS

**From Woodward Ave. heading South:** Turn left (East) at Mack Ave., Travel eastbound over I-75, travel 2 blocks to Russell St and turn right (south) (Milano Bakery is on the corner) go down about 3 blocks Bert's is on the Right.

**From US-10 (Lodge) heading South:** South on the John C. Lodge (M-10) to I-94 East, To I-75 South, Exit at Mack Ave. (Exit 52), Turn left (East) at Mack Ave., travel 2 blocks to Russell St. and turn right (south) (Milano Bakery is on the corner) go down about 3 blocks Bert's is on the Right.

**From I-75 (Chrysler) heading South:** I-75 South, Exit at Mack Ave. (Exit 52), Turn left (East) at Mack Ave., Travel eastbound over I-75, travel 2 blocks to Russell St and turn right (south) (Milano Bakery is on the corner) go down about 3 blocks Bert's is on the Right.

**From I-75 (Chrysler) heading North:** I-75 North, to Mack Ave.(Exit 52) and turn Right on to Mack travel 2 blocks to Russell St. and turn right (south) (Milano Bakery is on the corner) go down about 3 blocks Bert's is on the Right.

**From I-94 heading East:** I-94 East, To I-75 South, Exit at Mack Ave. (Exit 52), Turn left (East) at Mack Ave., Travel eastbound over I-75, travel 2 blocks to Russell St and turn right (south) (Milano Bakery is on the corner) go down about 3 blocks Bert's is on the Right.

**From I-94 heading West:** I-94 West, To I-75 South, Exit at Mack Ave. (Exit 52), Exit at Mack Ave. (Exit 52), Turn left (East) at Mack Ave., Travel eastbound over I-75, travel 2 blocks to Russell St and turn right (south) (Milano Bakery is on the corner) go down about 3 blocks Bert's is on the Right.

**From Downtown via Gratiot:** Heading North-East on Gratiot, go over I-375, make a left at Russell St., (traffic light) travel north approximately 4 blocks, Bert's is on the Left.

**From Windsor via the tunnel:** Heading straight north out of the tunnel on Randolph, proceed 6 blocks to Gratiot Ave. and turn right. Travel North-East on Gratiot, 3/4 mile and over I-375 make a left at Russell St., (traffic light) travel north approximately 4 blocks, Bert's is on the Left.
