As a result, the Demolition (3D)
Department created the Vacant
Property Unit. This unit will use Prop
N funds to clear out & secure vacant
homes.

Working with City Council, 3D is looking to award contracts for removing debris from inside and outside of vacant homes, while an in-house team secures each exterior entrance.
