The former Charles Hanneman Elementary School, located in Detroit's District 6, opened in 1918. The school closed in 2007 as part of the Detroit Public Schools consolidation process (reference: historicdetroit.org). In February 2024, the vacant building became the 100th commercial demolition by the City's Construction & Demolition Department in an effort to remove long-standing commercial blight.
