
Guess Who's Moving Next Door!

Let There Be Lights!

On February 4, 2014 Mayor Duggan presented the Public Lighting Authority (PLA) public lighting plan for the City of Detroit to City Council. Some highlights of the plan include: 11,400 mid-block lights will be added to streets 300-600 feet in length; alley lighting will remain in place until they expire, at which time residents may contract with DTE to maintain them. All lighting will be replaced with new LED lights and full
