4 COMMISSIONER BELL: Good evening. I want to  
5 say good evening again. Welcome to the monthly  
6 community meeting of the Board of Police Commission. I  
7 am the Vice Chair Willie Bell. Our Chair is en route.  
8 She should be here shortly but we want to start the  
9 meeting in a timely manner as always, so I'm going to  
10 ask our Apostle Robert King? Right?

11 MR. KING: Yes.

12 COMMISSIONER BELL: To come forward. He's  
13 going to lead us in open prayer. Before we do that. I  
14 would ask a special prayer for the family of a  
15 long-term councilman, reverend who served this  
16 community for many many years and that's the late  
17 councilman Dave Eberhard. As you well know, his  
18 funeral is, I think, tomorrow and I've had interaction  
19 with him, as many others, over the years as pastor and  
20 also as a councilman. So on that note, would you lift  
21 up in your prayer his family. Thank you.

22 PASTOR KING: We welcome you to our house and  
23 our district here in Northwest Detroit and we honor  
24 you, Police Commission, and the officers. We prayer  
25 for you regularly and we honor your presence and your

1 work.

2 (Invocation Given)

3 COMMISSIONER BELL: At this time, we have a  
4 tradition. When the Board Police Commission we have  
5 our community meeting that commissioner allow to  
6 introduce themselves and any other brief remarks, they  
7 might want to bring to the meeting so I want to start  
8 to my left. I should say my far left.

9 COMMISSIONER CRAWFORD: Commissioner Reginald  
10 Crawford District 3.

11 COMMISSIONER BURTON: Police Commissioner  
12 Willie Burton District 5.

13 COMMISSIONER BELL: Commissioner Willie bell  
14 District 4.

15 COMMISSIONER BROOKS: Commissioner Elizabeth  
16 Brooks.

17 COMMISSIONER MOORE: Commissioner Ricardo  
18 Moore, District 7 on behalf of Commissioner Richard  
19 Shelby which could not be here to represent District 1.

20 COMMISSIONER SANDERS: Commissioner Derrick  
21 Sanders, appointed.

22 COMMISSIONER DEWAELSCHÉ: Commissioner Eva  
23 Garza Dewaelsche, appointed.

24 COMMISSIONER BELL: Thank you. We have  
25 excused absence, Commissioner Richard Shelby as

1 mentioned excused absence, Commissioner Edgar Vann,  
2 those are the excused absences. I need to look to my  
3 left, extreme left sitting in for chief Craig, he needs  
4 no introduction, but Assistant Chief Dolunt.

5 A.C. DOLUNT: Good evening.

6 COMMISSIONER BELL: Steven Dolunt.

7 A.C. DOLUNT: Good evening again.

8 COMMISSIONER BELL: Thank you. I'm going to  
9 ask our attorney to the Board, Linda Bernard, to  
10 introduce the staff of the Board of Police Commission.

11 MS. BERNARD: Thank you, Mr. Chairman. Ms.  
12 Gail Oxendine is the Director of Police Personnel.  
13 She's not yet present. Ms. Pamela Davis-Drake from the  
14 office of the Chief Investigator, she is the Chief  
15 Investigator. Mr. Lawrence Ackbar also from her staff,  
16 supervising investigator from the Office of the Chief  
17 Investigator. Mr. Robert Brown to my right is the  
18 Administrative Assistant to the Board of Police  
19 Commissioners, and Sergeant Alan Quinn is handling our  
20 recording today along with Media Services from the City  
21 of Detroit and our court reporter on the first row to  
22 the left is Miss Mindy Womack from Hanson Court  
23 Reporters. That concludes the introductions, Mr.  
24 Chairman.

25 COMMISSIONER BELL: Thank you, Madam

1 Attorney. And if Assistant Chief Dolunt would  
2 introduce DPD personnel, we would appreciate it at this  
3 time.

4 A.C. DOLUNT: Most of them are in the back so  
5 you're going to have to stand. So would you stand?  
6 You all are allowed to come into a house of God, you're  
7 going to have to sit in front. Commander Pritchett  
8 doesn't want to stand probably and Captain Worboys is  
9 in the front. Sit down. Officer Hope is in back.  
10 Okay. Who we got here? Commander Wilson's in the  
11 back. Commander Mounsey. Commander Sroka. Sit down.  
12 Who do we have next? Commander Kyriacou, sit down.  
13 Captain and Commander Walton together again. Captain  
14 Mahone. I'm sorry Captain Balinski. Okay. Captain  
15 Jarvis, Commander Williams, Captain Hope. Captain  
16 Bliss and looks like Captain Patterson. Captain  
17 Chambers. Is that you back there Tiffany? I can't  
18 see. That's it.

19 COMMISSIONER BELL: Thank you. And we want  
20 to pause to introduce Commissioner Conrad Mallett, Jr.  
21 If you want to make some brief remarks like the other  
22 Commissions, feel free at this time.

23 COMMISSIONER MALLETT: Please excuse my  
24 tardiness, Mr. Chairman it's been a busy week. I'm  
25 glad to be here with all my friends in northwest

1 Detroit. I do know the west side. I can't say that  
2 I'm lost this late.

3 COMMISSIONER BELL: Thank you for your  
4 presence, sir.

5 I'd like to if we have any elected officials  
6 or representatives, elected officials, please stand and  
7 introduce yourselves at this time.

8 MS. WESLEY: Hi, I'm Linda Wesley from Brenda  
9 Jones's office.

10 COMMISSIONER MALLETT: Welcome.

11 COMMISSIONER BELL: Thank you.

12 MS. BROUGHTON: Theo Broughton, for 13, the  
13 most important part of the election process.

14 COMMISSIONER BELL: I agree with you. Any  
15 others. And thank you for your attendance. Thank you  
16 council president for your attendance. Always  
17 appreciate your communication, networking and sharing  
18 with us what's going on in the city, and not just the  
19 city but city government and different entities that  
20 you bring to our attention. Appreciate that.

21 At this time, I want to thank Apostle Robert  
22 King and Harvest Church family for extending this warm  
23 invitation to host this meeting. The first meeting  
24 being here we're not going be a stranger. Hopefully,  
25 we could come back in the future. If we have any

1 church members, would you please stand. We want to  
2 acknowledge you. And thank you for your attendance.  
3 Thank you.

4 Commissioners, before you is the agenda for  
5 tonight's meeting, May the 12th. What is your pleasure  
6 in terms of approving the agenda?

7 COMMISSIONER: So moved.

8 COMMISSIONER: Support.

9 COMMISSIONER BELL: It's been properly moved  
10 and supported. Discussion? Those in favor aye?

11 COMMISSIONERS: Aye.

12 COMMISSIONER BELL: Those opposed? Motion  
13 carries.

14 Next item, approval of minutes from Thursday  
15 May 5th, 2016.

16 COMMISSIONER MALLETT: Move adoption.

17 COMMISSIONER MOORE: Support.

18 COMMISSIONER BELL: Been properly moved and  
19 supported. Discussion? Those in favor, aye?

20 COMMISSIONERS: Aye.

21 COMMISSIONER BELL: Those opposed? Motion  
22 carries.

23 The Chair would probably be reporting out a  
24 little bit later in terms upon her arrival. And we're  
25 looking forward to that type of interaction. I know

1 she took a little week off, so as we move on, going to  
2 move to Assistant Chief Dolunt at this time.

3 A.C. DOLUNT: Okay. Thank you.

4 So we had a pretty bad weekend. We had a  
5 terrible weekend. We had 21 nonfatal and seven fatals.  
6 It's not for lack of trying to stop crime, it's a lack  
7 of respect among ourselves which causes a lack of  
8 respect for our neighbors. People committing these  
9 crimes don't have much respect for life. It's very  
10 disheartening. It's very discouraging but we're  
11 trying. In spite of all that, we're at the same rate  
12 we were last year for homicides. That's nothing to  
13 brag about. It's still 98 year-to-date. Okay. 98  
14 year to date. That's where we were last year.

15 Out of three of the last five weeks we've had  
16 bad weekends so we're the same place overall. We're up  
17 2% in nonfatal shootings, which is up seven total.  
18 Robberies are down 80 or 8% carjackings are down 23 or  
19 17%.

20 This weekend was bad. Is was more prevalent  
21 to me too because I had to go to the scene, it was the  
22 five-year-old that died that night. Was it accidental?  
23 Little girl picked up a weapon. We can't stress enough  
24 if you're going to have guns in the house that you keep  
25 them unloaded or put a lock on them. This wasn't a



1 home that I've come to see too many times in the city  
2 where a young child has died. These were two  
3 grandparents that had a neat home. They were  
4 babysitting the kids. The children's parent had jobs,  
5 from my understanding, hard working people, and it's an  
6 unfortunate accident. But unfortunately, we've had too  
7 many not just here, but around the country, so we're  
8 pleading with everyone out there you do have the right  
9 to bear arms, but our children have a right to be safe  
10 in their own homes. So please either get a gun lock or  
11 keep the gun unloaded or in a safe spot.

12 Also this week and last week different  
13 precincts are doing Police Week activities. I  
14 understand this weekend they'll be putting Sergeant  
15 Joseph Abdella's name and former Lieutenant Greig and  
16 the trooper actually on the wall in Washington D.C. I  
17 believe that they're doing their memorial tomorrow.  
18 Yes? No? Maybe? All right. Yes. What time? 3:00  
19 we're going to do a memorial service to put up a  
20 memorial wall at the precinct for the fallen officers  
21 and we'll have different activities at different  
22 precincts, so please feel free to partake and meet and  
23 talk to officers. Sorry to be so somber, but it hasn't  
24 been a good week. Are there any questions from the  
25 Board? I'm sorry.

1 COMMISSIONER BELL: Board members questions  
2 or concerns to Assistant Chief? Yes, sir.

3 COMMISSIONER CRAWFORD: Through the Chair.  
4 Assistant Chief, I've been on vacation for a couple  
5 weeks and I'm back now. I just want to say in terms of  
6 what has occurred in the last weekend, as you just  
7 stated, was really horrific. Want to call it  
8 cataclysmic event with all those getting shot and  
9 killed, but I do recall Ron Scott, who's no longer with  
10 us, a number of times expressed publically and he and I  
11 had the conversation. Matter of fact, he came before  
12 this Board and he talked about the responsibility of  
13 those who have guns and he also was not opposed in any  
14 way to gun ownership or anything like that, but when  
15 you often talk about the responsibility of those of us  
16 in law enforcement to -- and the truth, those who  
17 advocate and it is okay, it's first amendment right,  
18 you know, freedom to bear arms he often talked about  
19 the responsibility on law enforcement, what he felt was  
20 law enforcement's part to advocate gun safety. And I  
21 do realize in the past over the years, a number of  
22 churches, along with the Detroit Police Department,  
23 passed out gun locks, etcetera, but we haven't -- and  
24 this is something Ron and I talked about a year or so  
25 ago in terms of PSA's, perhaps, from the Police

1 Department in terms of advocating, you know, people  
2 exercising responsibility in terms of gun safety.

3 Some of these acts recently, particularly  
4 with children, self-inflicted gunshot or killed because  
5 of the irresponsible act of the gun owner having a gun  
6 in the house and it not being secured. So I just want  
7 to express that. And I certainly hope that perhaps in  
8 the future, maybe there will be some PSA's or something  
9 even with those who think -- there was something I  
10 read, I recall reading something in the media the other  
11 day, I think is it was Mr. Rick Ector, who's an  
12 advocate. As a matter of fact, he's a firearms  
13 instructor, of people of gun ownership. I have yet to  
14 see him do any PSA's in terms of -- and I realize  
15 firearms instructing exercising safety and stuff, but  
16 to the general public, because everybody's not going  
17 to, obviously, getting CPL's or going through classes  
18 for training in terms of handling and security of  
19 firearms.

20 COMMISSIONER BELL: Any other comments,  
21 remarks for the Chief, Assistant Chief? If not, Chief  
22 Dolunt, you mentioned that we had a grand opening for  
23 one of the precincts on the east side of Detroit.

24 A.C. DOLUNT: I did forget that. I'm sorry.  
25 That was Monday over on Chene in the 7th precinct. A

1 very nice grand opening. It was unfortunately dampered  
2 a little by the weekend, but they're excited. It's my  
3 understanding officers are happy about it, and if I'm  
4 not mistaken, and correct me if I'm wrong, someone's  
5 donating a clock to go out front. Is that true?  
6 Shinola's going to donate one of those big clocks.  
7 Very nice. You can stand, I know you can stand up,  
8 trust me. In fact, come to the microphone and tell the  
9 Board. Come to the microphone and tell the Board.  
10 Please. Thank you.

11 COMMANDER WILLIAMSON: To the Board, thank  
12 you. So Monday on the 16th we're going to be at  
13 Shinola. They're going to do a walkthrough of our  
14 precinct, the 1st precinct, and then they'll discuss  
15 where they're going to put it.

16 A.C. DOLUNT: That's very nice of them to do  
17 that. Is it going to be like the ones downtown or is  
18 it going to be inside the building?

19 COMMANDER WILLIAMSON: We don't know yet.

20 A.C. DOLUNT: But you're pleased with the  
21 facility.

22 COMMANDER WILLIAMSON: I am.

23 A.C. DOLUNT: Tell the Board that.

24 COMMANDER WILLIAMSON: The address of our  
25 facility is 3501 Chene. We are pleased with it. It

1 does need some more cosmetic work when we open the  
2 doors. It is a temporary facility, so we are looking  
3 for a more permanent base. My understanding is if they  
4 can't find us something permanent in the next 90 days,  
5 Five Mile one into this, which would really improve  
6 what we have.

7 A.C. DOLUNT: Because it's an old school,  
8 correct?

9 COMMANDER WILLIAMSON: That's correct. The  
10 last department that utilized that facility was the  
11 water department. So anything else I should say,  
12 Chief?

13 A.C. DOLUNT: That's up to the Board.

14 COMMISSIONER BELL: Thank you. Commander  
15 Williamson. Thank you Captain hope for your allegiance  
16 and work for the last couple years, three years that I  
17 know in terms of this Board. I want to thank also  
18 Commissioner Willie Burton. I know he was in  
19 attendance. Commissioner Burton, want to share some,  
20 then, on your observations?

21 COMMISSIONER BURTON: Sure. Thank you, Mr.  
22 Chair. It's always great to serve a precinct opening  
23 up in the community. It's a wonderful facility in the  
24 7th precinct. I talked to many of my constituents, lot  
25 of them were there, especially the seniors. They're

1 very engaged, very informed. They're excited. So  
2 looking for great things to continue to happen in the  
3 7th.

4 COMMISSIONER BELL: Thank you.

5 COMMISSION SANDERS: Through the Chair?

6 COMMISSIONER BELL: Yes, sir.

7 COMMISSIONER SANDERS: I also had a  
8 walkthrough in the 7th precinct with Captain Hope and  
9 it was pretty nice. But what I do see is they do need  
10 some copier machines. They do need some items. So  
11 hopefully they get those items more quickly than later.

12 COMMISSIONER BELL: We can identify with  
13 that. Thank you, Commissioner Sanders.

14 And I think one more item we need to mention,  
15 the outstanding memorial service last Friday was  
16 outstanding. I was informed that the worship leader,  
17 that young lady standing there, she closed it out with  
18 Amazing Grace and tears came to my eyes. I was so  
19 moved. And perhaps we can close it out here with  
20 Amazing Grace. That would be appropriate. We're in  
21 the house of the Lord and the Board would entertain it  
22 because it was a very moving service, and I'm wearing  
23 my pin. I think it's very important to lift up  
24 officers who have fallen in the line of duty and  
25 families and the whole Commissioner Brooks was there,

1 Commissioner Sanders, I think was his first memorial  
2 service. Commissioner Brooks was it your first?

3 COMMISSIONER BROOKS: Yes.

4 COMMISSIONER BELL: First. And was just  
5 really outstanding. So you're on call before we close  
6 out and we want to recognize you by name and by  
7 service. So thank you for bringing to our attention as  
8 we move forward on the agenda.

9 So one of the things that I wanted to share  
10 with you, we had East English Village meeting, about a  
11 hundred people, and Commander Eric Ewing spoke about  
12 Police Week, and I think it's very very important that  
13 we lift up officers, especially in this timeframe, you  
14 know, it had to be rough last weekend and witness all  
15 of that. And 24/7 they're out there serving and  
16 protecting. So we need to go out of our way to lift up  
17 these officers. If you can just do nothing but wave  
18 and say hello, I think that would be just appreciated.  
19 So I just want to put that on your heart and mind to do  
20 that. By all means, if you get a chance to visit a  
21 police station, that would really be a extra measure in  
22 terms of reaching out and touch them. So I just want  
23 to encourage you to keep that in mind as we celebrate  
24 Police Week as we move forward. So on that note. Was  
25 there anything else, Assistant Chief Dolunt?

1 A.C. DOLUNT: It was a nice ceremony. And  
2 Amy's been a chaplain for how many years Amy? 18  
3 years. We met 18 years ago. Her and I met at a party  
4 store. She changed my life and apparently that changed  
5 hers and there she is.

6 COMMISSIONER BELL: Great. Okay.

7 COMMISSIONER BROOKS: I'd like to compliment  
8 the police on the River Walk. There are all kinds of  
9 people that walk the River Walk, families, teenagers,  
10 but there are police out there and they make us feel  
11 very comfortable. And I always stop and say hello and  
12 thank them for what they're doing in the City of  
13 Detroit. So this is my first time just saying thank  
14 you to all the policemen, but especially those that  
15 walk the River Walk.

16 COMMISSIONER BELL: Thank you. Committee  
17 reports? Any standing committee reports or reports at  
18 this time? If not. The next. Any new business?

19 COMMISSIONER MOORE: Through the Chair.

20 COMMISSIONER BELL: Yes, sir.

21 COMMISSIONER: Can we hear from the 8th  
22 precinct?

23 COMMISSIONER BELL: They're not on my agenda,  
24 but we can hear from them.

25 COMMISSIONER MOORE: I think they have



1 something to say.

2 COMMISSIONER BELL: That was an oversight on  
3 the agenda. They're not listed here. I'm glad you  
4 brought that to my attention. Is the commander in the  
5 house? Please. You've been promoted commander of the  
6 8th precinct. And thank you for responding. You can  
7 talk about gun locks. Your remarks to the report, I  
8 watched it. Gun locks are available for no cost at any  
9 precinct. I think we need to reemphasize that.  
10 There's no cost.

11 COMMANDER PRITCHETT: Jacqueline Pritchett,  
12 Commander of the 8th precinct. P-R-I-T-C-H-E-T-T.  
13 What we're doing at the 8th precinct, the NPO's are a  
14 very important part of the gun safety awareness. What  
15 they have been doing and going to do even more is go to  
16 the daycare centers, to the schools and start educating  
17 on gun safety because it's my thought that if the  
18 parents are not in the home or her grandmas or uncles,  
19 as commander of 8th precinct, I can't take anymore kids  
20 being shot and killed by their own hands, anyone's  
21 hands, in my precinct. So it's incumbent upon me to  
22 make sure that they're educated about if you see a gun,  
23 call an adult. And the thing to do, as far as NPO,  
24 someone from Wayne County is getting an abundance of  
25 locks, gun locks to put in the precincts, station

1 number 8. And what we're doing, when we go to the  
2 schools to educate, we're asking the parents to be  
3 there in attendance and we're giving the parents gun  
4 locks if they are gun owners or not. So it's something  
5 that we're doing there to hopefully to prevent what  
6 happened to little Mariah early Wednesday morning won't  
7 happen again. So the good Captain here is going to get  
8 his feet wet so he's going to report out tonight for  
9 number 8.

10 COMMISSIONER BELL: Thank you, commander.

11 CAPTAIN WORBOYS: Afternoon. Captain Kurt  
12 Worboys, 8th precinct. W-O-R-B-O-Y-S. So report on  
13 8th precinct, start with the borders. The north border  
14 is Eight Mile Road from five points to Greenfield.  
15 Eastern border is Greenfield from Eight Mile to  
16 Schoolcraft. Western border is five points from  
17 Puritan to Eight Mile, and then Telegraph from Finkel  
18 to Puritan. The southern boarder is Puritan from five  
19 points to Telegraph, Finkel from Telegraph to  
20 Evergreen, and Schoolcraft from Evergreen to  
21 Greenfield.

22 Population in the 8th precinct is  
23 approximately 86,000 people. The 8th precinct is home  
24 to three high schools, three middle schools, six  
25 elementary schools and approximately 200 churches.

1 There's 400 business, including 60 gas stations and six  
2 nursing and senior homes.

3 We've undertaken the following community  
4 initiative in the 8th precinct. As the commander spoke  
5 about just briefly a minute ago, gun safety is a  
6 priority, and especially the incidents that have  
7 occurred recently. We moved it to the top of our list  
8 of things to address. We, in the past, and are going  
9 to continue with a program called Eco Gun Safety  
10 Program, and this is taking information to the schools,  
11 elementary schools and informing kids on the proper  
12 treatment of guns and what to do if they come across  
13 them.

14 We also have many youth programs within the  
15 8th precinct such as Cops Read to Kids, coat drive,  
16 health fair, career day and an NPO of anti-bullying  
17 campaign. We also do senior awareness within the 8th  
18 precinct. It's basically a crime prevention program  
19 that informs seniors about staying safe and alert. The  
20 City of Detroit Senior Services also participates by  
21 providing information on various programs and assisting  
22 with medical services.

23 We have many community programs that were  
24 conducted in the 8th precinct, 55 active community  
25 organizations and block clubs within our precinct

1 borders. We have four active CB patrols and our  
2 Neighborhood Police Officers interact on a daily basis  
3 with these different groups and organization, address  
4 issues such as abandoned vehicles, illegal dumping,  
5 blight, noise and quality of life complaints.

6 We have a blight committee, blight committee  
7 that meets every Thursday -- excuse me. Third Thursday  
8 of each month and hold blight community meetings. We  
9 have a Coffee With a Cop. It's a bimonthly meeting  
10 where residents get to come in to the station, talk to  
11 the commander and myself, meet their NPO's and get a  
12 cup of coffee.

13 We also have one of our NPO's puts together a  
14 movie in the park. It's an opportunity for children of  
15 all ages to come out and enjoy a movie in one of the  
16 neighborhood parks in the precinct.

17 Some of our crime control strategies that we  
18 are conducting, we do what we call a wrap around. We  
19 have our NPO's and special operations units going out  
20 to those areas and following up with the people in the  
21 neighborhood providing homeowners and businesses with  
22 enhancements to their existing security, giving  
23 information about cameras, speaking up and passing out  
24 fliers for like Crime Stoppers and things of that  
25 nature.

1                   We've also set up Eyes and Ears Community  
2 Partnership through neighborhood block programs trying  
3 to get out there and get past the point where snitching  
4 is considered a bad thing. Instead of being called  
5 snitching, we want people to be aware what's going on  
6 in the block. Look out your window twice a day. Talk  
7 to your neighbors. Introduce yourself. Get to know  
8 your community. Get to know the people that live on  
9 your block. If you see something that's out of the  
10 ordinary, make a phone call. Call your NPO. Call the  
11 station and let them know what's going on. Seems to be  
12 a reoccurrence of strange activity, write something  
13 down. Take a license plate. Just be aware of what's  
14 going on in your neighborhood.

15                   We also, as you all know, have medical  
16 marijuana facilities opening up throughout the city.  
17 There's quite a few of them in the 8th precinct. Right  
18 now the NPO's are walking along with BC enforcement  
19 doing checks of the current city ordinances to make  
20 sure that the establishments that are opening up are in  
21 compliance with state law. It's very initial at this  
22 point, but it's a slow process, but as we go along,  
23 eventually we'll be able to eliminate the dispensaries  
24 that are in our neighborhoods that don't belong and  
25 limit it to the ones that are doing it the right way.

1                   Finally, we also have an Aftercare program.  
2                   So after doing our enforcement and taking the police  
3                   action that needs to be taken, we're offering these  
4                   individuals, victims and the suspects an opportunity to  
5                   meet with pastors, see what the root causes of their,  
6                   you know, that might have caused these activities,  
7                   being a assault, a robbery, whatever. Sometimes people  
8                   just need a helping hand to get past that point, maybe  
9                   eliminate the conflict that started the whole situation  
10                  to begin with. Could be, you know, they don't have a  
11                  job, they don't have food for their children at this  
12                  point and it starts an argument, starts other instances  
13                  where they need to go out and try to get something to  
14                  feed their children. So we're offering services. They  
15                  can come in, make a phone call and talk to the pastor,  
16                  talk to somebody that can help them out, maybe diffuse  
17                  that situation and prevent illegal activity.

18                  Some of the significant information for this  
19                  year so far in the 8th precinct statistically wise,  
20                  we've had 633 arrests, we seized 99 guns, 100,000,  
21                  approximately \$100,000 worth of narcotic proceeds, 230  
22                  grams of cocaine, 309 grams of heroin and 132,000 grams  
23                  of marijuana, street value of approximately two million  
24                  dollars.

25                  This year the 8th precinct has serviced over

1 9,000 calls with 2,400 of those being priority one  
2 calls and we are currently at about a 15 minute  
3 response time in our precinct.

4 And just to state, overall our crime rates  
5 are down in Number 8. We are -- for violent crime,  
6 we're down, year-to-date we're down, let's see here.  
7 Where did it go? 28% in priority one crimes and 9% in  
8 property crimes. Is there any questions?

9 COMMISSIONER BELL: Commission, questions or  
10 concerns?

11 COMMISSIONER MOORE: Through the Chair. Good  
12 presentation, Captain. How many medical marijuana  
13 facilities do you have in number?

14 CAPTAIN WORBOYS: I'd have to let you know.  
15 I don't know off the top of my head.

16 COMMISSIONER MOORE: And you have the  
17 neighborhood police officers enforcing or doing the  
18 administrative work?

19 CAPTAIN WORBOYS: That's coordinating part of  
20 the organized crime. They are working with PC. I  
21 think it's probably six a week right now through  
22 citywide. So they're starting with the dispensaries  
23 that are in drug-free zones that definitely should not  
24 be opened and going and doing those inspections of  
25 those places first. I don't have the list of the

1 order.

2 COMMISSIONER MOORE: Finally, are the NPO's  
3 behind on their regular assignments?

4 CAPTAIN WORBOYS: No. Not that I'm aware of.

5 COMMISSIONER MOORE: Thank you.

6 COMMISSIONER SANDERS: Through the chair.  
7 I'd just like to commend the commander just got a  
8 raise. Also some other house issues. We did not  
9 mention Sergeant Quinn at Media Service or Mindy  
10 Womack, court reporter. So I'll mention that now.

11 COMMISSIONER BELL: I'm sorry could you  
12 repeat that, please?

13 COMMISSIONER SANDERS: It's all right. Go  
14 ahead.

15 COMMISSIONER DEWAELESCHE: Through the Chair.  
16 All that you're doing in this community, it's such a  
17 comprehensive program of activities for the community.  
18 Very impressive. And I was particularly interested  
19 when you talked about the different programs that you  
20 have at the schools and with the different community  
21 centers, the seniors. It seems like you're covering  
22 every part of the community, you know, in all of your  
23 efforts. My question is, do you see an increase or  
24 have you made some impact on the substance abuse issue  
25 that, you know, has been prominent in a lot of our



1 communities or even nationally? You know, we  
2 constantly hear about the heroin epidemic. Is that  
3 something you see that we're making a difference with  
4 all these different programs that you have that we're  
5 having an impact?

6 CAPTAIN WORBOYS: Well, I've only been in the  
7 precinct for four weeks but I did come from major  
8 violators, which is the narcotics section. So my  
9 interaction there and then I'll be here Number 8. I  
10 see it definitely makes a difference when you're out  
11 there talking to the community and young people that  
12 have not yet gotten to that point where they're in the,  
13 drug, drug trade, drug -- taking drugs. It's a huge  
14 problem for sure, and the more interaction that we have  
15 with the young, young people and neighborhoods, the  
16 better off we'll be in the long run. By just ignoring  
17 a problem and letting it fester is not going to solve  
18 it. You have to start early and get the message out  
19 that that's the wrong path to take. From my four weeks  
20 here, I don't know how much of a difference it's made  
21 from last year, but definitely something needs to be  
22 done and I hope that we're addressing it.

23 COMMISSIONER DEWAELESCHE: And I think with  
24 all the programs that you have, you're giving young  
25 people a lot of options so that they don't go down that

1 path, so I commend you for that. Thank you.

2 COMMISSIONER BELL: Comments? Questions?

3 Thank you, Captain. Any other comments, commander?

4 Anything else you want to share?

5 COMMUNITY MEMBER: Just number 8 as far as  
6 the community, we're definitely engaged in all the  
7 concerns. With the Aftercare program we address the  
8 substance abuse as well. A lot of times they're drug  
9 addicted and they're not working and they come, the  
10 wife or the girlfriend comes home from work and he's  
11 there and smoking marijuana all day and she's upset,  
12 they start fighting and creates a -- start fighting and  
13 police is called.

14 So what Aftercare does, we offer help for  
15 substance abuse as well. The workers, they talk to the  
16 captain. In fact, the captain takes his time to be  
17 instrumental in the program as well. He goes out with  
18 the officers and he spiritual prayers. He helps them  
19 find jobs, jobs for felons and just gives them a little  
20 hug and tell them I love you. I understand what you're  
21 going through. You're not the only one. It's okay.  
22 It means a lot to them. And we have seen a reduction  
23 in aggravated assault, domestic violence in our  
24 precinct and I attribute that to the Aftercare program.  
25 Lieutenant from the afternoon shift, it's his project,

1 and without Aftercare in the precinct, I know our  
2 numbers would be a lot higher. They want to get home  
3 and they're up at night, they might want to hit their  
4 wives, they call the chaplain. She prays for them.  
5 It's a wonderful thing in the 8th precinct.

6 COMMISSIONER DEWAELESCHE: I'm glad you  
7 explained that because when he first said Aftercare, I  
8 thought you were talking about an after school program.  
9 You're talking about a follow up.

10 COMMUNITY MEMBER: We have programs for  
11 children on weekends. A lot of partners who are on  
12 board with number 8 Aftercare helping or offering  
13 services for free to these young boys who want to be  
14 young men. We got programs for women, little girls who  
15 want to be women. Just small things you can do that  
16 can change a lifetime.

17 COMMISSIONER DEWAELESCHE: That's very  
18 creative. Thank you.

19 COMMISSIONER BELL: Any other comments? I  
20 just want to commend you too, commander. Always trying  
21 to share that this is a new day as far as law  
22 enforcement exploring the avenues in terms of  
23 prevention and how can we help. It's almost like  
24 extending yourself as social workers.

25 COMMUNITY MEMBER: That's what we do.

1                   COMMISSIONER BELL: And with all the cutbacks  
2 with the counselors in school, etcetera, etcetera, I  
3 tell people now you can reach out and touch a police  
4 officer practically 24/7 by phone call, text, e-mail.  
5 This is just a whole new concept of policing in  
6 Detroit, something the people in Detroit really, really  
7 should appreciate and spread the news in terms of  
8 what's happening in law enforcement. I can't speak  
9 what's happening in New York or Chicago, but I have  
10 witnessed what's happening in the City of Detroit.

11                   COMMISSIONER DEWAELESCHE: Thank you.

12                   COMMISSIONER BELL: On that note, the next  
13 item for business would be new business, and we have  
14 resolutions. We have two. First one Annette L. Day.  
15 Is she here? So Commissioner Moore read the entire  
16 resolution. She's not here.

17                   COMMISSIONER MOORE: Do you have a copy? I  
18 have it.

19                   COMMISSIONER BELL: You have it. Okay. I'm  
20 to ask Commissioner Brooks to chair the resolution.

21                   COMMISSIONER MOORE: Resolution honoring  
22 Annette L. Day.

23                   WHEREAS: Mrs. Annette L. Day, lifelong  
24 Detroiter began her career in the City of Detroit on  
25 March 31st, 1981. Mrs. Day was hired by the City as a

1 special project assistant for city council president,  
2 Erma Henderson.

3 AND WHEREAS: Mrs. Day's diligent work and  
4 demonstration and with increasing responsibility was  
5 appointed to administrative assistant.

6 AND WHEREAS: Mrs. Day continued to progress  
7 in her career and was transferred to the Detroit Police  
8 Department as a typist from December 1st, 1986 to June  
9 of 1997.

10 AND WHEREAS: Mrs. Day transferred to the  
11 Gang Enforcement Unit Administrative office in June of  
12 1997 where she was promoted to office assistant. Mrs.  
13 Day's Gang Enforcement Unit code name, Sleuth.

14 In recognition of her outstanding work ethic  
15 and professional work, she was awarded the Civilian  
16 Award, five Perfect Attendance awards, the Spirit of  
17 Detroit award.

18 AND WHEREAS: Mrs. Day was promoted to  
19 communication section on July 7, 2007, and as an  
20 emergency service operator 911 where she remained until  
21 her retirement.

22 AND WHEREAS: Mrs. Day retired on January 4,  
23 2016 after 34 years of outstanding and meritorious  
24 service in the City of Detroit of which 29 years was  
25 dedicated to the Detroit Police Department.

1                   And now, therefore, be it resolved that the  
2                   Detroit Board of Police Commissioners speaking on  
3                   behalf of the citizens of the City of Detroit and the  
4                   Detroit Police Department recognize and acknowledge the  
5                   lifelong commitment of Mrs. Annette L. Day, her pride  
6                   and dedication have been valued assets to the City of  
7                   Detroit and the Department and merit our highest  
8                   regard. We thank you for your achievements, Annette L.  
9                   Day. Detroit Board of Police Commissioners.

10                   COMMISSIONER BELL: The Chair will entertain  
11                   motion to that effect.

12                   COMMISSIONER DEWAELESCHE: I move for a  
13                   motion.

14                   COMMISSIONER MOORE: Support.

15                   COMMISSIONER BELL: It's been properly moved  
16                   and supported for the resolution of Mrs. Annette L.  
17                   Day and she's probably in Phoenix or Florida somewhere  
18                   enjoying her retirement, and I can understand why she's  
19                   not here, but we wish her the best.

20                   Discussion? Those in favor aye?

21                   COMMISSIONERS: Aye.

22                   COMMISSIONER BELL: Those opposed? Motion  
23                   carries.

24                   The next business would be Pastor Cory J.  
25                   Chavis. Would you please come forward and Commissioner

1 Brooks come around.

2 COMMISSIONER BROOKS: WHEREAS: Pastor Cory  
3 James Chavis is dedicated and committed supporter of  
4 the City of Detroit's 8th precinct. Pastor Chavis  
5 serves as the senior pastor of Victory Community Church  
6 in Detroit. Pastor Chavis is the overseer of deacons,  
7 Armors Bearers, and his membership to the Kingdom  
8 Alliance of Covenant Fellowship.

9 AND WHEREAS: Pastor Chavis displays and  
10 example of the type of citizen that most residents of  
11 his community would want as a next door neighbor.  
12 Pastor Chavis graduated from the University of Detroit  
13 receiving a Bachelor of Science and Engineering Degree.  
14 After graduation, he began his career as a teacher at  
15 the Rutherland Middle school. He has taught math and  
16 science at the Wayne County Juvenile Delinquent  
17 Facility, and currently teaches language, art, social  
18 studies, math and science at the University Preparatory  
19 Academy.

20 AND WHEREAS: A pillar in the community,  
21 Pastor Chavis reveals his sincerity and devotion to his  
22 neighborhood, but emphasizes his commitment in  
23 assisting the Detroit Police Department in any way he  
24 can. Examples would be his role as chairperson of the  
25 Detroit Community Clergy Alliance, involvement with the

1 roll out of Detroit Ceasefire Program, a Detroit Police  
2 Chaplain Commander and member of Youth Violence  
3 Prevention Initiative.

4 AND WHEREAS: Pastor Chavis is enthusiastic,  
5 hard working, high energy clergyman with a wonderful  
6 passion for serving others.

7 Now, therefore, be it resolved that the  
8 Detroit Board of Police Commissioners speaking on  
9 behalf of the 8th precinct and citizens of the of City  
10 of Detroit acknowledge the dedication and service  
11 spirit of Pastor Cory J. Chavis, his commitment to  
12 teaching and preaching has been an inspiration to all  
13 who serve the city and its citizens. We thank and  
14 congratulate you, Pastor Cory J. Chavis. Board of  
15 Police Commissioners.

16 A.C. DOLUNT: Okay. Ready? More stuff.  
17 This is big time. Okay. Spirit of Detroit Award is  
18 presented herewith and expression of gratitude and  
19 esteem of the Citizens of Detroit. Past Cory J. Chavis  
20 recognition of exceptional achievement, outstanding  
21 leadership and dedication to improvement of quality of  
22 life. The city council of Detroit. And then Detroit  
23 Police Department presents the Certificate of  
24 Recognition to Pastor Cory J. Chavis resident of the  
25 City of Detroit, appreciate your contribution,



1 involvement in the community and service to the City of  
2 Detroit and for the spirit and commitment that is  
3 worthy of recognition and it's signed by the Chief.  
4 Congratulations. Let's pose for a picture. All right.

5 PASTOR CHAVIS: Thank you so much. First of  
6 all, let me say I really want to thank the Board of  
7 Police Commissioners and representation from the  
8 Chief's office. Also want to just appreciate Commander  
9 Pritchett and the 8th precinct and all they're doing  
10 really just working. I believe this is a part of what  
11 ministry is all about. I see Commander Bettison and  
12 all the officers. I served as a chaplain, been the  
13 chaplain for about eight years trying to learn from  
14 commander -- I'm sorry. Deputy Chief Chaplain Amy  
15 Kamm. She moved up. I moved into the 8th precinct,  
16 and it's been a great time.

17 NPO's I want to say, Brother Copeland is here  
18 also. I've served at number 12, served at number 4 and  
19 now at number 8. Really just want to say to all the  
20 officers in the room, this is really about you. The  
21 changes that are happening are because of your  
22 diligence, your hard work, and we stay on our knees  
23 praying, ask the Lord just cover you and watch over  
24 you. Anything we can do, we give glory to God. We  
25 just ask that the Lord get more people involved with

1 the labor. You guys do the hard work. We stay on our  
2 knees to lift you up. So appreciate it and thank God  
3 for all you do.

4 COMMISSIONER BELL: Have your daughter come  
5 up. Photographers, come back and take a picture. I  
6 think it's important that you be part of this also.  
7 Let's give this man another round of applause.

8 COMMISSIONER MOORE: I move for adoption for  
9 the resolution to honor Pastor Cory J. Chavis.

10 COMMISSIONER MALLETT: Support.

11 COMMISSIONER BELL: It's been properly moved  
12 and supported. Discussion? Those in favor aye?

13 COMMISSIONERS: Aye.

14 COMMISSIONER BELL: The motion carries.  
15 Thank you. May God bless you.

16 COMMISSIONER BURTON: Through the Chair. I  
17 just want to add to those that are watching. Earlier  
18 today I'd given a press conference in front of police  
19 headquarters basically stating that parents must be  
20 responsible for securing their guns when children are  
21 in the home. It can be seen on 2, 4 and 7, but too  
22 many children in the City of Detroit have been shot in  
23 preventable incidents. We must protect our children  
24 and secure all weapons. No child should have access to  
25 a gun. No child. As adults, we must be responsible.

1 Secure those firearms when children are in the house.  
2 Reach out to your police department, your neighborhood  
3 police officers. Request for a gun lock. They're  
4 available free of charge.

5 There's also an app, which is DPD Connect,  
6 allows you to contact your precinct or local precinct  
7 as well as locate an NPO. If there happens to be a  
8 shortage of gun locks, the NPO or myself as a  
9 commissioner or any other commissioner, we'll located  
10 one for you.

11 COMMISSIONER BELL: Thank you, Commissioner  
12 Burton. Remarks? Old business.

13 COMMISSIONER CRAWFORD: Yes. Through the  
14 chair.

15 COMMISSIONER BELL: Yes, sir.

16 COMMISSIONER CRAWFORD: As I stated earlier,  
17 I was on vacation for two weeks and I received a couple  
18 of communiques in my packet and also via e-mail. One  
19 was from the DPOA and the most recent one from  
20 Lieutenant and Sergeants Association.

21 The is kind of funny. The DPOA letter  
22 expresses, I believe, states something to the effect  
23 that commissioners were mentioning officers names as  
24 the Commission, meaning it's not Commissioners, it's  
25 me, Commission Crawford. So I would appreciate it if

1 the DPOA would -- they can name my name. I don't have  
2 a problem with that.

3 But in terms of inquiring about officers in  
4 terms of we have a system in place, and I think it's a  
5 great system, the Detroit Police Department, I think  
6 one of the best in the country in terms of tracking  
7 officers. They have multiple complaints. And just to  
8 mention a name and ask of the Department what's being  
9 done about this particular officer, I personally see  
10 that as an affront to free speech. The police can't  
11 police free speech. They can't police and will not be  
12 involved in policing freedom of assembly or freedom of  
13 expression.

14 If someone had mentioned the name, and I'm  
15 going to give a little history here, it goes way back  
16 many years of Ben Turpin on the east side and was very  
17 brutal to the citizens of Detroit. We didn't have a  
18 Police Commission then. Had someone mentioned the name  
19 of Officer Peterson who worked the stress unit, stopped  
20 the robbery and enjoy safe streets, and that was pre  
21 the Police Commission coming into existence, perhaps  
22 the 13 that had been killed, maybe that wouldn't have  
23 happened. Killed 12 -- actually killed 13. On the  
24 13th, one cat hair was found on his knife that he  
25 planted on the victim and he was charged, Officer

1 Peterson.

2 Someone had mentioned the name of Officer  
3 Eugene Brown who shot and killed I think several  
4 people, shot a few others and his name did come up  
5 later at that commission meeting but, you know, those  
6 that already been injured and killed prior to that.  
7 And I consider it very insulting that the DPOA would  
8 use this and say something about protecting officers.  
9 We must protect the privacy of officers. And I, for  
10 one, used to be a DPOA member for a few years. I'm not  
11 surprised by this because it's suppression or trying to  
12 shut down free speech.

13 When Nevers and Budzyn were charged with the  
14 murder of Malice Green, the DPOA represented Nevers and  
15 Budzyn. No problem with that. We're all dues paying  
16 members, but we're all -- we're entitled to equal  
17 representation. When Ira Todd and Rico Hardy, two  
18 black police officers, unfortunately, killed a  
19 Mexican-American in Mexicantown, he was also unarmed.  
20 They were not afforded that same representation.  
21 Neither one went to the DPOA. Half of them were drunk.  
22 600 of them, half were drunk over there in the Polish  
23 Century Club. The voice protested. They're not  
24 getting and equal fair representation. This is how  
25 it's reported. In that meeting, he refused to be given

1 a mic. That's suppression of free speech that I had to  
2 literally take the floor and express my point, leave  
3 that meeting, start a protest against the DPOA, marched  
4 on their offices over there on Lincoln Street with some  
5 community people. As a matter of fact, two or three  
6 churches were there and also community groups, most  
7 notably Theo Broughton, who's here today.

8 Out of that protest, out of all that, what  
9 came about was any time any officer in the Detroit  
10 Police Department is involved in a high profile  
11 incident, he or she is entitled to the best  
12 representation that the membership's money could buy.  
13 Oh, by the way, they refused to pay Ira Todd and Rico  
14 Hardy for the attorney fees, but ultimately they had to  
15 because of that protest.

16 Out of that protest is written into the  
17 bylaws when one wants to speak on the floor, you have  
18 to give them a mic. So when we talk about supporting  
19 unions, I've been a supporter of unions all my life,  
20 and rights, not only police officers, rights of the  
21 citizens also too. When the DPOA have an election, we  
22 have people want to come to us, and I say us, black  
23 officers, so to speak, how are the black officers going  
24 to vote, we formulated a group and had a political  
25 action committee that was very powerful because we told

1           them when they asked us, well, when they tested us,  
2           what do you want us to do for your organization. We  
3           can buy a block of tickets to your cabaret. We don't  
4           want a block of tickets. Have a seat. We'll tell you  
5           what we want. What we want is we want you to give out  
6           scholarships to the community. We want you to give  
7           scholarships to you, to sons and daughters of police  
8           officers and to the community. We want to use some of  
9           that dues money, since we are the Detroit Police  
10          Department in the City of Detroit, for the community in  
11          terms of resources and services. That's what came out  
12          of all of that.

13                        And so those being afforded the best  
14          representation, including today's president, Mark Diaz,  
15          when he was indicted --

16                        COMMISSIONER BELL: Commissioner Crawford?

17                        COMMISSIONER CRAWFORD: In the 4th precinct.

18                        COMMISSIONER BELL: Commissioner Crawford? I  
19          propose that we can close this out.

20                        COMMISSIONER CRAWFORD: Commissioner Bell,  
21          can I stay on the floor?

22                        COMMISSIONER BELL: To a certain point. We  
23          can't just go on and on. I'm going to ask you can you  
24          close it out.

25                        COMMISSIONER CRAWFORD: I'm giving true,

1 factual history here.

2 COMMISSIONER BELL: I understand that.

3 COMMISSIONER CRAWFORD: Information.

4 COMMISSIONER BELL: But the chair is asking  
5 for --

6 COMMISSIONER CRAWFORD: I'm not going to be  
7 suppressed on free speech, not going to be suppressed  
8 by any commissioner or DPD police, with all due  
9 respect, sir.

10 So including the current president of the  
11 DPOA who was once indicted and found not guilty, he was  
12 entitled the best representation that money could buy.  
13 So I'll just take -- I consider this an affront. Also  
14 too, Commissioners, if you agree and -- by the way,  
15 Commissioner Bell, this was addressed to you February  
16 24th, 2015 seeking legal opinion from corporation  
17 counsel and Butch Hollowell responded that there was  
18 legal representation for first amendment and free  
19 speech and his opinion negated by a number of rules in  
20 the pattern here.

21 And again, when we want to talk to about not  
22 mentioning names, it was more appropriate, and I will  
23 commend the commander of number 8 and also the captain  
24 for the holistic approach that you're taking in your  
25 precinct what your captain just stated in terms of



1 trying to bring -- get forth information from the  
2 community about some of the heinous crimes and how we  
3 say don't snitch, just tell. Well, you know what the  
4 community says, the police aren't telling on police, so  
5 why should we tell anything. I hear this so often.  
6 You see it in the media. They say it so often. Well,  
7 you all not telling on each other, so why should we  
8 tell you anything. And again, it is a responsibility  
9 here, so I'm not letting them get away with that one  
10 because they do -- if something occurs in the  
11 community, they should. They don't have to snitch, but  
12 just tell us. But that's applicable to the police too.

13 So that's what I get in the community. So,  
14 like I said, I am not the one, I just want everybody to  
15 know I'm not the one and, you know, I have been a  
16 staunch supporter of unions and staunch supporter of  
17 people's rights and that's the way I want to remain.  
18 Thank you.

19 COMMISSIONER BELL: Thank you, Commissioner  
20 Crawford.

21 The next item of business would be  
22 announcements. The next meeting of the Board will take  
23 place on Thursday, May 19, 2016 3 p.m. at the Public  
24 Safety Headquarters on Third and Michigan. And our  
25 next community meeting would be on June 9th and that

1 would be in the 4th precinct. Location is forthcoming.

2 And before we move to oral communications,  
3 any other comments that any other Commissioner might  
4 went to make before we invite the public to speak?

5 COMMISSIONER MOORE: Through the Chair. I  
6 was remiss in my duties. I forgot to announce that  
7 Commander Nick Kyriacou is in the house representing  
8 District 7. Commander Brian Mounsey, Captain Tiffany  
9 Steward from the 6th precinct. Did I forget anyone? I  
10 just want to say thank you for your service and thank  
11 you for the citizens of Detroit in District 7.

12 COMMISSIONER BELL: Thank you, sir. If not,  
13 we can move on to oral communication from the audience.  
14 You have two minutes to speak. Please give your name  
15 and be respectful as we are respectful to you in terms  
16 of the time. And keep in mind, you're speaking to the  
17 Board. Any others, perhaps please stand up and we can  
18 get out of here. If we have any other speakers. Okay.  
19 Thank you.

20 MS. BROUGHTON: Happy Thursday, everybody.

21 COMMISSIONER MALLETT: Thank you. Happy  
22 Thursday to you.

23 MS. BROUGHTON: Thank you. My name is Theo  
24 Broughton and I am the cofounder of Hood Research.  
25 First, I'd like to thank Commissioner Reginald Crawford

1 for always having the courage to speak truth.

2 The reason that I came, or one of the reasons  
3 I came this evening is to ask about progress. I heard  
4 that the testing was over I believe in the 5th precinct  
5 of body cameras, and I'd like to know what the progress  
6 is of the body cameras. I was told at that particular  
7 meeting that it would take until December. I don't  
8 happen to believe that it takes that long.

9 Number two, I would like to know about the  
10 propped cars, that cars that have cameras to them to  
11 catch those that are stealing automobiles. I  
12 understand that the Wayne State Police have such  
13 vehicles. But it also appears that the area in which  
14 the Wayne State is placed has all kinds of services,  
15 shall we say. I'd like to know about the rest of the  
16 city. Do we have any of those kinds of vehicles to  
17 ward off those who want to steal the vehicles of the  
18 residents in the rest of the City?

19 COMMISSIONER BELL: Assistant Chief Dolunt,  
20 do you want to respond? I think it's two or three  
21 questions that were posed. The first one would be the  
22 body cameras.

23 A.C. DOLUNT: I'll have to defer to -- that's  
24 Assistant Chief White's area, his expertise. And I  
25 don't know, I was at the meeting and they said

1 December, so I will have to look into the progress of  
2 the body cameras. I believe there's a couple of  
3 vendors, and I will have them give you an answer by  
4 next week.

5 As far as the decoy vehicles used by Wayne  
6 State, we do use decoy vehicles, a private entity that  
7 supplies to both us and Wayne State and they've been  
8 fairly effective.

9 MS. BROUGHTON: Are the decoy vehicles the  
10 ones with, I'll say, police officers or are they empty  
11 vehicles of any kind of doll it looks like a human  
12 person to catch those who are trying to break in?

13 A.C. DOLUNT: No. The vehicles we use,  
14 ma'am, are unoccupied, and I don't believe we have a  
15 doll or anything of they nature inside the vehicle. We  
16 just part it in an area where there's a lot of car  
17 thefts, yes.

18 MS. BROUGHTON: Do you know how many the  
19 Detroit Police Department use?

20 A.C. DOLUNT: Again, they don't belong to the  
21 Detroit Police Department. A private entity allows  
22 us to -- they supply several vehicles for us to use so  
23 I don't have the exact number in front of me.

24 MS. BROUGHTON: Does that mean that you rent  
25 them?

1 A.C. DOLUNT: No. They let us use it free of  
2 charge.

3 MS. BROUGHTON: Okay. My last question has  
4 to do with the green light setups in the gas station.  
5 Can you give us any progress on that?

6 A.C. DOLUNT: Total of 22 green light  
7 locations. They're either gas stations, liquor stores,  
8 or McDonald's. Excuse me, Mike's Fresh Market is not a  
9 liquor store. It's a supermarket. So there's 21 right  
10 now throughout the city. We are continuing to recruit  
11 people to do that. Matter of fact, ideally, by the end  
12 of the year we'd like to roll into neighborhoods as  
13 well, anyone that's wishing to do that. Right now, 21  
14 and is growing, appears, every week.

15 MS. BROUGHTON: And this is the expense of  
16 the gas stations or liquor stores, etcetera.

17 A.C. DOLUNT: That's correct.

18 MS. BROUGHTON: And are they manned by police  
19 officers who are off duty, or I guess you don't call it  
20 moonlighting?

21 A.C. DOLUNT: We have a crime intelligence  
22 unit that monitors everything 24 hours. It's like a  
23 virtual patrol and it actually benefits us. It allows  
24 us to put one person watching several cameras as  
25 opposed to putting two people in a car and driving

1 around just on routine patrol. If an alarm goes off in  
2 this area, and one virtual patrol officer can relay  
3 that information to people on the street. It enhances  
4 our ability to investigate the crime and apprehend the  
5 perpetrator.

6 MS. BROUGHTON: All right. Thank you.

7 COMMISSIONER BELL: Thank you, ma'am.

8 COMMISSIONER CRAWFORD: Through the Chair.

9 Ms. Broughton, also too I don't personally think that  
10 we can't get body cams fast enough, as far as I'm  
11 concerned. Ms. Stinson was charge with filing a false  
12 felony report. The Defendant, if you recall, listening  
13 to the media saying the allegation that two Detroit  
14 police officers had sexually assaulted her simply  
15 because they drove her for whatever location home, and  
16 what brought the charges was the dash-cam or camera  
17 that was in the car. The charges are appropriate.

18 And if you recall, I think it was couple  
19 years ago, Assistant Chief, we had an allegation that  
20 two -- or that one officer pulled a gun on a citizen  
21 and, thanks to you, you brought in the actual car  
22 dash-cam and that never even occurred too. So it  
23 levels the playing field. It's one of the things  
24 that's protecting the officers, also protecting the  
25 citizens too. Thank you.

1 COMMISSIONER BELL: Yes, ma'am.

2 MS. MORRIS: Good afternoon, Commissioners.

3 My name is Tawana Morris. I am a retired Detroit  
4 Police Officer. I am a licensed investigator, and I  
5 did the investigations for the Detroit Coalition  
6 Against Police Brutality. I'm now retired. I am proud  
7 to tell you that I am still committed with police  
8 officers too and what retirees do. You just can't  
9 stop. Once you retire, you still keep going.

10 I'm happy to say that through the Department  
11 of Justice, we have been collaborating, a group of us,  
12 concerning the shooting that happened in the city of  
13 Dearborn involving two mentally ill and public  
14 shootings. And our group, our name is The Bi-City  
15 Concerned Advisory Council, and we are collaborating  
16 between Dearborn and Detroit to bring unity in the  
17 community. I'll be happy to forward you our documents  
18 and the guidelines for our group, but I believe it's a  
19 beautiful thing and it is bringing the neighboring  
20 communities at the border of Dearborn and resolving  
21 issues bringing the community and both law enforcements  
22 together. So I'm committed. I'm looking forward to  
23 working with the commissioners as well as the Detroit  
24 Police Department and I'm looking forward to talking to  
25 Chief Craig. Thank you.

1 COMMISSIONER BELL: Thank you, ma'am.

2 COMMISSIONER CRAWFORD: Excuse me,  
3 Commissioner Bell, through the Chair. Have you talked  
4 to Chief Haddad?

5 MS. MORRIS.

6 COMMISSIONER CRAWFORD: In Dearborn?

7 MS. MORRIS: Yes. He wasn't part of our  
8 collaboration, with Deirdre McGhee from Department of  
9 Justice.

10 COMMISSIONER CRAWFORD: Okay. Thank you.

11 COMMISSIONER BELL: Yes, ma'am.

12 MS. MOORE: Good evening. My name is  
13 Jacqueline Moore. I'm a resident of the Lord and  
14 welcome to our neighborhood this evening. As this is  
15 my first time at this session, I may ask questions that  
16 you've heard several times, so bear with me.

17 First question. As this is a busy area, an  
18 area of growth, Seven Mile and Telegraph, is there any  
19 opportunity that our police would consider mini  
20 stations? We're doing so much to try and grow and  
21 develop the neighborhood, but that is something that I  
22 think would be of great benefit. We have City of  
23 Detroit, Southfield that has access, Redford and  
24 Livonia and so there's a lot of traveling and a mini  
25 station I think would serve, to really need something



1 dealing with the neighborhood that would help our  
2 growth. That's the first question I want you to  
3 answer.

4 Secondly, when our Commissioner brought up  
5 the medical marijuana facilities, my question is, as we  
6 have so many, and I'm not sure if we expected for them  
7 to take so much of our time as far as our police force  
8 having to man things that are taking place, my concern  
9 is since we have still so many issues within our  
10 neighborhood that are drug related, what is the  
11 priority? How are we doing that? We are actively  
12 trying to clean up our block. It's still present in  
13 our neighborhood where we're trying to grow, but now we  
14 have the medical marijuana facilities and I believe may  
15 be taking a greater priority. If you could speak to  
16 that as well.

17 COMMISSIONER BELL: Ma'am, the first part  
18 about the mini station, you have four officers, NPO's,  
19 for your station. They are much more mobile than a  
20 mini station ever would be.

21 MS. MOORE: Is any of those people I could  
22 see after the session?

23 COMMISSIONER BELL: Yes. Get with your  
24 commander. Trust me, they are due diligent 24/7 almost  
25 so you just need to interact and identify your NPO's.

1 They are your mini station.

2 MS. MOORE: Okay. I appreciate that.

3 COMMISSIONER BELL: Yes, ma'am. And the  
4 second part of your question I guess A.C. Dolunt can  
5 respond to, but it's been an ongoing debate. The city,  
6 the council been reporting out, they addressed this  
7 issue, and I don't think it's no more taxing than what  
8 we do in law enforcement, but A.C. Dolunt can respond.

9 A.C. DOLUNT: Through the Chair. If you have  
10 any narcotics issues, please bring them to the  
11 attention of the captain and commander of the precinct.

12 As far as the medical marijuana, that is  
13 going through City Council. They've come up with a new  
14 order.

15 COMMISSIONER MALLETT: Let me help.

16 A.C. DOLUNT: Go ahead. Thank you very much.

17 COMMISSIONER MALLETT: Jackie, it's good to  
18 see you.

19 MS. MOORE: You too.

20 COMMISSIONER MALLETT: So the audience knows,  
21 if I seem particularly familiar with this woman, she  
22 worked for me at Sinai-Grace Hospital for many years.

23 So Jackie, Celia Washington, who is the legal  
24 advisor to the Chief and to the Department, gave us a  
25 report last week. The process is as follows. What we

1 are doing, Police Department and members of the Detroit  
2 Building and Safety are going to each of the medical  
3 marijuana facilities on a regularized basis. They're  
4 picking out sections of the city doing a section at a  
5 time. They're going in being sure whether or not  
6 they're in compliance with the ordinance that was  
7 passed. Those that are not then are being sued, not  
8 ticketed, sued because the goal of the mayor is to shut  
9 them down, not just have them pay a fine.

10 Attorney Washington reported that there were  
11 about 110, 111 lawsuits already filed and the process  
12 is going to continue along those lines. I don't think  
13 it's taxing the Police Department per se, unless it's a  
14 citizen complaint alleging drug activity, which is  
15 different than there's a place up the street that is in  
16 violation, we believe it's within a thousand feet of a  
17 school or a church or something like that. So it's a  
18 ministerial process that I think is being managed  
19 according to attorney Washington very effectively. The  
20 lawsuits are being filed, sections of the city are  
21 being reviewed, and the process to get these things out  
22 of our neighborhood will continue.

23 MS. MORRIS: Thank you.

24 COMMISSIONER BELL: Thank you, Commissioner.  
25 Bernice Smith.

1 MS. SMITH: Good evening, A.C. Bernice  
2 Smith. Good evening to you A.C. and commissioners.  
3 Last week I brought to you a problem. Last week I  
4 brought to you, I brought before you a problem, and I  
5 would like to let you know everything worked out real  
6 well. The Police Chief's people, they've taken care  
7 of -- they took care it, rather, and the fact that the  
8 lady in question and her two children were able to find  
9 a residence. We gave them a week to get a residence so  
10 she was very happy because of the fact that the police,  
11 as I may say, Sergeant Jenkins, Sergeant Wyatt, they  
12 were very cordial. They helped with the moving of this  
13 individual, and also some of the neighbors that were  
14 surrounding. So I'm very happy, and I do wish that you  
15 would relay, A.C. to Sergeant Jenkins and Sergeant  
16 Wyatt that we're very happy with their performance and  
17 hope that they will forever continue to be the police  
18 that we expect them to be, like I expect all my police,  
19 and I love them all. Take care. Thank you.

20 COMMISSIONER MOORE: Through the Chair.

21 COMMISSIONER BELL: Yes, sir.

22 COMMISSIONER MOORE: Mother Bernice, was that  
23 the second precinct that a problem occurred?

24 MS. SMITH: Second precinct? Well, that's  
25 where they're from, and we thank them very much and I

1 just want the Commission to know. Well, anyway, you  
2 got their names, Jenkins, Sergeant Jenkins Sergeant and  
3 Sergeant Wyatt. I wish to speak with them whenever I  
4 go over there.

5 COMMISSIONER BELL: You can always put that  
6 in writing.

7 MS. SMITH: Would you?

8 COMMISSIONER BELL: You can put that in  
9 writing. Write them a letter of support. That always  
10 looks good in their personnel file.

11 MS. SMITH: Yeah, it does. All right. Thank  
12 you much.

13 COMMISSIONER BELL: Thank you, Mother  
14 Bernice.

15 D.C. Coleman.

16 D.C. COLEMAN: Thank you for coming here  
17 today. I want to let you know we have food in the  
18 back, one is given to us from Victory and the other is  
19 Captain Jays in the Meijer's lot. Welcome you all to  
20 the community. Glad you chose us. Glad you're here.  
21 Feel free to come back here. Hurry up. Get this food  
22 before it gets cold.

23 And one last thing. Last time you were here  
24 I had to take home carts for a year. Nobody knocks on  
25 my door. It's no problems. If more officers took it

1 home it would be a problem. If more officers lived in  
2 Detroit, we'd have less problems, but that's a whole  
3 other story. I'd buy a bigger house in Detroit. More  
4 cops in Detroit. I don't know how you plan to do that,  
5 but make it happen.

6 COMMISSIONER BELL: Thank you, sir. Any  
7 other comments?

8 MS. SEMMA: Good evening, Commissioners.  
9 Julie Semma from 7-D's Towing. I was just wondering if  
10 the Commission has set a date or time if we could  
11 possibly meet with the towers, and the police  
12 authorized towers in the City of Detroit before our  
13 contract comes up?

14 COMMISSIONER BELL: I would hope that we  
15 can -- Chair was out of town last week and we can have  
16 that discussion this week and set a date and time to  
17 have that forum, and we need to do that as soon as  
18 possible because I know the clock is ticking. So I'm  
19 glad you brought that before us in terms of reminding.  
20 And we can set a date and time when that hearing is  
21 going to take place, that forum is going to take place.

22 MS SEMMA: Sure. If you guys would, I'll  
23 leave my number after the meeting so you can contact me  
24 and I can contact the other towers.

25 COMMISSIONER BELL: Thank you. Any other

1 comments?

2 COMMISSIONER BURTON: Through the Chair. I'd  
3 like to take the time to announce former state rep Mary  
4 Waters and Sandra Warmack.

5 COMMISSIONER BELL: Could we, the Chair would  
6 probably entertain a motion for adjournment, but we can  
7 take the motion, but I want all of us to pause and the  
8 young lady is going to come forward for Amazing Grace.  
9 And this is Police Week and I think it's appropriate  
10 that we lift up in a positive note. With all that's  
11 going on with officers and families, I think would be  
12 something that we visit and appreciate doing those in  
13 terms of that type of ministry. Would you share that,  
14 your name?

15 MS. KAMM: I'm Deputy Chief Amy Kamm,  
16 Chaplain. Thank you very much to this man for  
17 inspiring me to become one.

18 COMMISSIONER BELL: He did something good for  
19 a change.

20 COMMISSIONER MALLETT: I move for  
21 adjournment.

22 COMMISSIONER MOORE: Support.

23 COMMISSIONER BELL: Been properly moved and  
24 supported. Those in favor aye.

25 COMMISSIONERS: Aye.
