1 I think overall it went extremely well. There 2 was no hard questions. There was no major issue in terms of the budget that I'm aware of, and there was a good 3 4 dialogue in terms of coming forward. And thereafter Chief 5 Craig and his team presented the DPD budget. And we as 6 Board of Commission was pleased, more than pleased, to 7 approve and endorse the DPD budget and the dialogue with 8 the commissioners. But the chief might want to elaborate 9 in his own way in reference to what we underway in terms of 10 budget and in terms of dealing with public safety. And I 11 think, as you well know, the council are very very 12 important in terms of the role they play with public 13 safety, and especially the budget. So we're looking to a 14 positive outcome. Nothing to be taken away. If they want 15 to add, so be it. That'll be a plus plus.

16 The other item I want to mention is that there 17 is an announcement of Crain's Detroit Business concerning 18 one of our police commissioners. Conrad Mallett, Jr. has 19 been named interim CEO of DMC Huron Valley-Sinai 20 Hospital. So that is quite an achievement in terms of --21 they do a search. But he's serving in that capacity, and 22 that might be the reason why he's not here this evening. 23 Thanks for sharing this with us. We want to commend 24 Commissioner Mallet for his ongoing role. As we know 25 about health care, it's on the table throughout.

And we're hearing 24 that these things are happening right now here in our 25 community.

a eighteen month review and issue recommendations for
 police oversight and policy, laws to reduce crime and
 increase safety, and change the race confidence in the
 system.

As you well know, we all have issues with the 5 6 criminal justice system. And I think I want to have our 7 staff send states -- U.S. Senator Peters a letter 8 supporting this effort. It's bipartisan. Off the ground. 9 And he reintroduced it. And I heard him speak on one of 10 the radio programs, and it's something that's long overdue. 11 I think the last report, about 50 years ago -- that's going 12 back to my day. The Carter's report. So this is rather 13 timely, as we well know, as we look at the criminal justice 14 system and all aspects of it. And perhaps we will have an 15 opportunity to participate and review on the policies set.

16 So please pay close attention and let 17 congressman -- I mean, U.S. Senator Peters know that 18 you're aware and that you are in support of this effort 19 to initiate. And I'm just amazed that he got bipartisan 20 support. And he don't think that's going to go away 21 after, you know, the whole issue; because they are 22 concerned about criminal justice in America. So when we 23 talk about the issues that we are having in this day and 24 age surely this is an opportunity to take a serious look 25 at it from a broad base, and they won't complain. And



1 IUCP has endorsed this and the police unions across the 2 Board, NAACP, has endorsed this effort; so you're going 3 to hear more about it as we move forward. And that is my 4 brief report. COMMISSIONER CRAWFORD: Mr. Chair. 5 COMMISSIONER BELL: Yes, sir. 6 COMMISSIONER CRAWFORD: Was that a motion on the 7 8 table that the commission supports this? Is that a motion or --9 10 COMMISSIONER BELL: I can't make -- you can 11 entertain -- you can make a motion. COMMISSIONER CRAWFORD: Okay. Okay. Yes, sir. 12 13 Well I would like to introduce it as a motion that the 14 commission wholeheartedly supports this -- Senator Gary 15 Peters. You got the 24 mic. 25 CHIEF CRAIG: Thank you, Mr. Chair. As I always

1 like to start out with crime. Overall part one crime, 2 which includes both violent and property offense, was still 3 down five percent. Violent crime down six percent, and 4 property crime down five percent. Up until yesterday we 5 really began to close the gap on homicides and nonfatal 6 shootings. I think we were up compared to last year. 7 Seven nonfatal shootings, and up one homicide. And 8 certainly we had the fatality, the fatal fire, yesterday 9 where four people lost their lives. It was determined that 10 it was an arson, and so that bumped our homicide rate up 11 But overall crime, as I reported, is down. some. 12 The last thing I wanted to talk briefly about is 13 today, this afternoon, we had our sixth installment of what we call DPD Television, real talk with the police chief. 14 15 That event was held in the Tenth Precinct. I want to thank 16 Commissioner Moore who did come out and had to leave. I 17 want to also acknowledge our gracious hosts, Commander 18 Kyriacou and Captain Slappey of the Tenth Precinct. 1 Police Investigator investigates allegations of police 2 misconduct that are posed by citizens that are noncriminal 3 in nature. Anything that is criminal, any allegations that are criminal would go to Internal Affairs. Some examples 4 5 of those would be like procedure, demeanor, service, harassment. Those types of things. There are a number of 6 7 ways in which you can file a complaint. You can do so online. You can use the Board of Police Commissioners 8 9 website. You can go to the Detroit Police Department's 10 website. You can come and see us in-person. We are 11 actually temporarily located at the Detroit Public Safety 12 Headquarters. You can come and visit us. We will greet 13 you, and we will take your report there. Or you can call 14 us, which is probably the easiest and most convenient way 15 to do it. You can call us at (313) 596-2499 and we will 16 take your information; we will create a file and a report 17 for you and give you at that time a case number that will 18 follow your case throughout the duration. Keep in mind 19 that our cases are -- they can be -- it can take up to 90 20 days to complete an investigation. Those investigations 21 are done very thoroughly by a very competent group of 22 staff. If we're going to take longer than 45 days we will 23 notify you either by letter or by phone and let you know the status of your case. 24

1 90 day period or shortly before, once the supervisor has 2 signed off and the investigator has signed off, the chief 3 investigator, me; I would look at it, review it and approve 4 it. Then it goes on to the Board. Actually there is a subcommittee of the Board. Three members of the Board 5 review every single case that is investigated by the 6 7 office. Once the Board approves it and signs off on it then it -- we send a case finding letter out. That's what 8 9 we call it. It is a summary of the allegations and the 10 findings. So we send that to the citizen, to the command 11 and to the officers. Also, finally, the police chief or a 12 designee reviews all of our cases. And at that point then 13 the case is officially closed. 14 If you're dissatisfied with a complaint we do 15 have an appeals process. 1 Planning personnel not only serve as department liaisons 2 with our business partners to help facilitate most of our 3 major events, but they also serve as the liaisons with other units of the government when major activities occur. 4 5 They handle filming of motion pictures, commercials, music videos that occur in the City of 6 7 Detroit. They handle funerals of fallen officers and city 8 dignitaries. Last year Planning generated over \$1 million 9 in revenue for the city general fund. 10 Our traffic units conduct vehicle and pedestrian 11 traffic control for morning and afternoon rush hour traffic in the downtown area, and they also help with special 12 13 events. These officers successfully ensure the safe and 14 orderly flow of traffic; and more importantly, safety for 15 spectators attending events. 16 Downtown Motor Club RiverWalk provide escorts for 17 funerals and traffic details; provide proactive enforcement 18 around the night clubs in Downtown Detroit. They conduct 19 traffic and weight measures on trucks. And they respond 20 and investigate traffic crashes involving motor vehicle 21 accidents. 22 Our neighborhood police officers complete the 23 following tasks: They work in partnership with beat 24 officers, businesses, community groups, clergy and neighborhood support. They liaison with our residents and

3 Our Gaming Operation monitors the safety and the 4 welfare of casino patrons; patrolling the exterior of all 5 three casinos, hotels and casino parking structures. Thev assist with loiterers, pan handlers and the homeless. Our 6 7 2016 year end stats for the business district ended in no 8 homicides, 14 sexual assaults, 75 robberies, 106 aggravated 9 assaults, 483 simple assaults, 42 burglaries, 1,046 10 larcenies, 231 stolen vehicles, 268 damage to property, and 11 57 dangerous drugs, and zero arsons.

Downtown 2017 initiative consist of the following: Proactive enforcement, warrant enforcement, narcotics, green light, liquor vice inspections, pan handling blitz, and homeless initiatives, and to strengthen private and public special relationships.

17 In regards to proactive warrant and narcotics 18 enforcement Operation Opa Phase I and II was developed. 19 The purpose of Operation Opa Phase I, which occurred last 20 Saturday, was to arrest individuals who have outstanding 21 warrants for their arrest; arrest those who participate in 22 illegal sale of narcotics; inspections of liquor license 23 holders in essential business districts; provide heavy 24 traffic enforcement in a business district, and enforcement of curfew ordinances in the Greektown area. 25

1 In an effort to minimize breaking and entering of 2 vehicles in Downtown Detroit, on September 26, 2017 a 3 parking lot assembly was conducted with parking lot owners. They were informed that they must be in compliance with 4 5 Chapter 39 regarding parking lots in the City of Detroit. What would be the purpose to do this? So what 6 7 we're asking the owners to do is basically make sure that 8 they have proper lighting, fencing and attendant on duty at 9 all times to prevent and curb B&E of autos in Downtown 10 Detroit. This initiative was generated between myself and 11 Captain Petty and Captain Szilagy of the Third Precinct. 12 Another program to get closer to our community is 13 the Community Eyes and Ears Program. This program was 14 designed by the Crime Prevention Program that assisted 15 local businesses, residents and quests to deter and detect 16 crime and reduce opportunities for crime. The purpose of 17 the program is to get our chief neighborhood liaison 18 citizen police academy involved by asking them to 19 participate and sit in a local business in the downtown 20 area for four hours for a 90 day rotation to see if it 21 helps deter larcenies and crime. They will also be 22 equipped with the lighthouse radio. 23 As you guys know, a lot of business partners in 24 downtown have lighthouse radios, and we're able to monitor it from our base at 20 Atwater. This initiative was 25

proposed last night at the assistant police academy meeting by neighborhood police officer Shank. We have received some phone calls, but we are still waiting to develop a list and actually put it in play.

Homeless initiatives. I have attended 5 Councilwoman Mary Sheffield's homeless meetings with other 6 7 private sector organizations for strategies to minimize 8 homeless in Downtown Detroit. In addition, we've met with 9 Southwest Solutions and other housing and community 10 outreach for the homeless. As we see it, homeless is a 11 socioeconomical issue not to just be approached from an 12 enforcement strategy.

13 What we have done as neighborhood police officers 14 in the downtown area have went out and tried to identify 15 those who are in fact homeless and to identify are they 16 working with private sector organizations to get the 17 assistance they need. What we plan to do is identify those 18 who are pan handlers and, of course, provide enforcement 19 action. But those who are in fact homeless, help them find 20 job placement, literacy, and housing through the help of 21 the private sector. So we've offered our services as a 22 partner to help curb homeless in the downtown area. Of 23 course we know this is not a short-term remedy. This is a 24 long-term problem that we are faced. However, if we can 25 change five to ten lives we have a start ahead.



1	In conclusion, there are multiple facets that
2	make up Downtown Services. Each entity provides services
3	that make up the unit as a whole. The city continues to
4	add its residential population and businesses continue to
5	relocate downtown. We the men and women of Downtown
6	Services stand to prepared to do whatever we can to ensure
7	Detroit's comeback is sustained.

9 COMMISSIONER BELL: I think it's good to bring 10 this to this type of forum where you can hear it directly. 11 And now the chief is aware and we are aware, then we can 12 address the issue in a civil manner in terms of trying to 13 take care of your issue about vending in the City of 14 Detroit.

MS. BINNS: Hello. My name is Keshia Binns. I'd like to open by saying, thank you to each and every one of you who put on a uniform everyday and a badge. I'm here --I came with the vendor group, but I'd just like to speak to the demeanor of the officer.

Ninety-nine percent of my encounters with Detroit Police has been positive. Let me say that. I've never had any issues ever until Valentine's Day, February 14th, with Officer Knox. I'd just like to say to that demeanor goes a long way. And not just with the City of Detroit police,

1 but with most people that you encounter in life. You 2 often, or you are taught to just respect others; and so you 3 look for that in return. And I want to also say that I know a lot of officers and police officers, and I have nothing against
