The Detroit Utility Users Tax Annual Return, Form D-U1A, serves as an annual account reconciliation for the calendar year. Every account must file an annual reconciliation on Form D-U1A. The due date is April 30, 2016.

Page 2 — For each month enter the tax and the tax paid from the monthly returns, Form D-U1. The amounts must agree with the D-U1's filed. The totals are brought forward to page 1. Page 1 — Enter the account identification and address information. On line 1, enter the total tax paid from page 2, line A. On line 2, enter the total tax from page 2, line B.

If line 2 is greater than line 1, payment must accompany Form D-U1A.
