Grant Fraud

A grant is one of the ways the City can fund ideas and projects to provide public services and help the economy. Grants are usually for a specific amount of money and is given to an organization or person for a particular purpose such as home improvements, starting a business, or education. Grant fraud may occur when an award recipient attempts to deceive the City about their spending of grant money.

Red Flags May Include:

- Falsifying the information provided in grant applications or proposals.
- Influencing City employees to award a grant or contract to a particular company, family member, or friend.
- Charging personal expenses as business expenses against the grant.
- Charging for costs that do not relate to the grant.
- Charging for inflated labor costs or hours.
- Charging for labor costs that were not incurred such as charging for fictitious employees, contractors, or consultants
- Billing more than one grant for the same work.
- Misrepresenting a project's status to continue receiving City grant funds.

As always, these red flags should not be taken alone as evidence that fraud is occurring. However, please contact the OIG if you see any of these red flags.

Waste: Hotel Rooms for City Employees at Mardi Gras

The Office of Inspector General for the City of New Orleans conducted an investigation into an allegation that the Orleans Parish Sheriff's Office (OPSO) improperly obtained hotel rooms at the Omni Royal Orleans Hotel for Command Staff during Mardi Gras in 2023.

To increase parade route security at Mardi Gras, the City of New Orleans requested that the New Orleans Police Department (NOPD) and outside law enforcement agencies assist with parade security and other law enforcement functions during Mardi Gras. Under a cooperative endeavor agreement between the City and OPSO, the City would pay for single lodging expenses for officers from outside law enforcement agencies who traveled more than 35 miles to work the Mardi Gras Detail from February 16, through the day after Mardi Gras Day, February 22, 2023. However, under the agreement neither NOPD personnel nor OPSO Command Staff were to be provided lodging expenses.

The OIG issued a subpoena for hotel reservation records on the hotel pertaining to the rooms reserved by the Orleans Parish Sheriff's Office. According to the records, OPSO reserved 13 rooms for 7 nights from February 14, 2023 to February 22, 2023, which means 90 nights were purchased. Of the 90 nights secured and paid for by the OPSO, 37 nights were used by OPSO staff. Four employees stayed six nights or more, three employees did not occupy a room at all, and six employees stayed three nights or less. The total charge for the rooms was \$18,174, while the total charge for the unused rooms was \$11,046. The OPSO Director of Finance Elizabeth Boyer confirmed that the OPSO credit card was used to pay for the hotel rooms. And the credit card will be paid using the general funds of the OPSO.

The OIG interviewed several staff from the Orleans Parish Sheriff's Office. As found during the investigation, former Assistant Sherriff Kristen Morales spearheaded the idea for rooms to be provided to OPSO Command Staff and Sheriff Susan Hutson approved it. Some OPSO employees did not use the rooms, some employees believed the rooms were unnecessary, and other employees felt the length of stay was excessive. A consensus during the OIG interviews regarding the hotel rooms pertained to the incorrect assumption the New Orleans Police Department provided rooms for their command staff.

The OIG found that the Orleans Parish Sheriff's Office use of the hotel rooms constituted a wasteful and unnecessary use of public funds. The OIG recommended future expenditure of taxpayer or public funds be scrutinized in order to ensure the funds are appropriate and relate to the successful completion of any OPSO mission. According to the OIG, "the wasteful expenditure of any funds, taxpayer or public, must be prevented."

To increase transparency, the OIG recommended that the OPSO adopt the Budget, Requisition, and Accounting Services System (BRASS) replacing the OPSO's Enterprise Resource Planning (ERP) system which is an outdated purchasing system.
