- 1 COMMISSIONER BERNARD: Good evening, ladies and
- 2 gentlemen. Again, I'm Commissioner Linda D. Bernard. I
- 3 represent the 2nd District, and as you know, part of this
- 4 District is in my District, District 2, as well. It's a
- 5 pleasure to see you all this evening, and I look forward
- 6 to hearing from many of you through public comment. As
- 7 you know, if you want to speak during public comment and
- 8 you have 2 minutes, you have to give this gentleman to my
- 9 immediate right here, a piece of paper. There should be
- 10 pieces of paper there, or we have them at the front desk.
- 11 Okay? So just put your name on it. We don't need any
- 12 other identifying information, just who you are to speak,
- 13 and you'll be given that opportunity to speak. As you can
- 14 see, we do not have a quorum yet, but we're going to
- 15 start with the information items related to the
- 16 commission. So as not to hold you up unduly on this rainy
- 17 Thursday evening, I'd like to open the meeting, call the
- 18 meeting to order, and I'd request that Chaplain DeShante
- 19 Ervin Sr., provide us with that invocation. And I'd ask
- 20 everyone to please be silent and or bow your head. Thank
- 21 you.
- 22 CHAPLAIN ERVIN: Amen. Heavenly Father, we thank you
- 23 for this another day, a day that you have allowed us to
- 24 gather in this place. We come lifting up before you this
- 25 evening, our city, ask that you continue to watch over it



- 1 and keep it safe. Lift up our mayor before you and the
- 2 City Council and our police chief, and all the many
- 3 officers that are on patrol, we ask that you continue to
- 4 watch over them. Cover this board of commissioners
- 5 tonight, God, and continue to bless them and watch over
- 6 them. Touch this meeting and allow the agenda that is
- 7 already set forth to be accomplished tonight. Bless the
- 8 people that are here and allow this meeting to go forth
- 9 according to your will. In Jesus' name we pray. Amen.
- 10 COMMISSIONER BERNARD: Amen. The next item on the
- 11 agenda that does not require a quorum to be present is
- 12 the board secretary's report. The gentleman immediately
- 13 to my right, Mr. Robert Brown for your information, has
- 14 been with the commission for more than 20 years. He is
- 15 currently the Acting Board Secretary. Mr. Brown.
- MR. BROWN: Madam Chair, there are currently 7
- 17 incoming correspondence under my report. The resignation
- 18 of Mr. Roy Gamble to administrative leave without pay
- 19 ADPOA grave grievance, for your request. And last but not
- 20 least, OCI weekly inventory report.
- 21 COMMISSIONER BERNARD: Thank you Mr. Brown. I'd like
- 22 to indicate that we're being joined by my sister
- 23 Commissioner Tamara Liberty Smith and she does represent
- 24 this District in its entirety. Ms. Smith, it's good to
- 25 see you this evening. The next item on the agenda will be



- 1 the Community Impact Report by Reverend Jerome Warfield,
- 2 who is also the head of our Office of the Chief
- 3 Investigator. Mr. Warfield.
- 4 CI WARFIELD: Good evening, Madam Chair, and thank
- 5 you so very much.
- 6 COMMISSIONER BERNARD: Good evening.
- 7 CI WARFIELD: I want to give an update on where we
- 8 are a year later from coming to the Office of the Chief
- 9 Investigator. Last week we celebrated our one year
- 10 employment there with the Office of the Chief
- 11 Investigator. So I want to give some highlights. In your
- 12 binder, you do have the numbers for the month of April.
- 13 We'll go over some of those, but I want to talk about
- 14 some of the challenges and some of the progress, a great
- 15 deal of progress that we've been able to make during this
- 16 time period.
- 17 COMMISSIONER BERNARD: Please feel free to speak
- 18 directly to our audience. Thank you.
- 19 CI WARFIELD: Thank you, ma'am. As always, I always
- 20 like to mention that the mission of the Office of the
- 21 Chief Investigator is to fairly effectively and
- 22 objectively receive, investigate, and make
- 23 recommendations regarding the complaints concerning the
- 24 Detroit Police Department and its personnel. And it is
- 25 the goal of the Office of the Chief Investigator to



- 1 assist in improving the quality of law enforcement
- 2 services by instilling citizen confidence in the
- 3 integrity of the Detroit Police Department. One of the
- 4 things we want to do is just highlight some of the things
- 5 that we were able to accomplish within these last 12
- 6 months. We are very happy and pleased that we have hired
- 7 a number of new investigators. As a matter of fact, by
- 8 the end of this month, we should be at full capacity as
- 9 it relates to our investigators. We should have 23
- 10 investigators. We've been operating on average with about
- 11 12 investigators in our office, so we've been at 50, just
- 12 under 50%, we're right at 50%, and so by the end of this
- 13 month, we should be at full capacity.
- We also, in an effort to make sure that we wanted to
- 15 be more efficient, we created and implemented an
- 16 automated report form that reduced the time to actually
- 17 type our reports from 7 hours to about an hour and a
- 18 half. And that makes it a lot easier for our
- 19 investigators, not only to get their report done and
- 20 finished on time, but also to start working on the very
- 21 next report. In addition to that, we started and
- 22 developed a timeliness initiative plan to make sure that
- 23 we are addressing those concerns. That came out of the
- 24 Office of the Inspector General's report. When we came
- 25 into the office a year ago, there were four



- 1 investigations going on related to the Office of the
- 2 Chief investigator, and one of those investigations is
- 3 still underway, but we've already started to address a
- 4 number of those concerns from those investigations and
- 5 make improvements.
- 6 Additionally, we've dedicated a backlog group of the
- 7 new investigators who are doing just an outstanding job
- 8 in tackling the backlog cases in our offices. That came
- 9 from the Office of the Inspector General. In their
- 10 report, they indicated that there were 705 cases that
- 11 were closed, but yet not fully investigated. We reopened
- 12 all of those 705 cases. We sent letters out to all 705 of
- 13 those constituents, and we are in the process of
- 14 reinvestigating those cases. And then we are also in
- 15 final negotiations now for a new case management system.
- 16 We are told that sometime in June, we are hoping that our
- 17 Wing Swept Case Management System will be before the City
- 18 Council, and we will be able to even add more
- 19 efficiencies in our office as it relates to how we are
- 20 processing our investigators. I mean, processing our
- 21 cases.
- I just want to give you an overview of our staff
- 23 right now. Right now we have 3 supervising investigators,
- 24 4 senior investigators, 1 quality assurance reviewer and
- 25 that person makes sure that our cases are nice and



- 1 accurate before they come to the board. And as of today's
- 2 date, we have 18 investigators, and we're expecting 6
- 3 more to come on board by the end of this month. When we
- 4 look at our April numbers, our April numbers are actually
- 5 trending. Well, really the first 4 months of this year
- 6 are trending higher than they were last year, at the
- 7 exact same period of time. Last year we received a total
- 8 of 442 citizen complaints, and this time last year we saw
- 9 335 allegations. This year, the numbers are a little bit
- 10 higher. We've seen 575 citizen complaints, and out of
- 11 those 575 citizen complaints, we've closed 189 cases this
- 12 year alone.
- So our investigators are working extremely hard to
- 14 make sure that we leverage all of the resources that we
- 15 can moving forward. Right now to date, as of the end of
- 16 April, we have 1,910 total cases in our office. Of those
- 17 1,910 cases, 375 of those are current, meaning they're
- 18 between zero and 90 days, and 1,535 cases are what's
- 19 considered backlog. And of course, included in that
- 20 backlog figure are the number of cases that came back to
- 21 us that we had to reopen from the office of the Inspector
- 22 General. So, all in all, I believe that we are certainly
- 23 moving in the right direction. We're making significant
- 24 progress, ma'am, and to the citizens, we're making
- 25 significant progress to make sure that all complaints and



- 1 concerns are being addressed appropriately in the office.
- 2 COMMISSIONER BERNARD: Thank you very much, Reverend
- 3 Warfield. Ladies and gentlemen, I'd like to acknowledge
- 4 the presence of 3 additional commissioners who've joined
- 5 us. First and foremost, our Chairperson Mr. Pressley, to
- 6 my immediate left next to him is our Vice Chairperson,
- 7 Tamara Liberty Smith, and next to Tamara is Jesus
- 8 Hernandez, also a member of the Board of Police
- 9 Commissioners. We still don't have a quorum, but the
- 10 Chairman is going to take over now, and thank you for
- 11 your attention. CHAIRPERSON PRESSLEY: Thank you so very
- 12 much, Commissioner Bernard for leading our meeting this
- 13 far. And again to each of you who've come out today, we
- 14 don't yet have a quorum, and so we remain in our amended
- 15 agenda. And because we don't have a quorum, we can't ask
- 16 any questions of like for the Chief Investigator. And so
- 17 we'll return to that section once we do indeed have a
- 18 quorum. Moving forward with our amended agenda, we'll
- 19 receive our announcements from our Acting Secretary.
- MR. BROWN: Yeah, good afternoon, Mr. Chair.
- 21 CHAIRPERSON PRESSLEY: Good afternoon.
- 22 MR. BROWN: The next BOPC meeting will be Thursday,
- 23 May 16th, 2024, 3:00 PM, which will take place at Detroit
- 24 Public State, the headquarters 1301 Third Street. The
- 25 next community meeting would be Thursday, June 13th at



- 1 6:30 PM with the 7th Precinct hosting with their location
- 2 to be determined. The monthly committee meetings: Policy
- 3 Committee meeting meets Tuesday, May 14th at 5:00 PM;
- 4 Citizen Complaint Committee meeting meets Tuesday, May
- 5 21st at 5:00 PM. All those meetings take place at Detroit
- 6 Public Safety headquarters, and you can also view them on
- 7 Zoom. Announcements.
- 8 CHAIRPERSON PRESSLEY: Thank you so very much for
- 9 those announcements. And again, noting what we can and
- 10 cannot do. We can move forward at this moment to provide
- 11 certificates for those who we are honoring and
- 12 appreciating, although we can't move forward with the
- 13 resolutions certificates, we can move forward at this
- 14 time. And so I'll turn that over to Vice Chair Tamara,
- 15 Liberty Smith.
- 16 VICE CHAIR SMITH: Good afternoon.
- 17 CHAIRPERSON PRESSLEY: Good afternoon.
- VICE CHAIR SMITH: I am Vice Chair Tamara Liberty
- 19 Smith, representing District 1, over at the 8th Precinct.
- 20 Today, I have 2 Certificates of Appreciation. One will be
- 21 for Officer Baron Coleman. Officer Coleman, are you
- 22 present?
- OFFICER COLEMAN: Yes.
- 24 VICE CHAIR SMITH: Well, Officer Coleman, you know me
- 25 and you go way back. I love you dearly. He has truly been



- 1 my ride or die has been rooting me off of just from being
- 2 a community activist to where I am today. Officer
- 3 Coleman, we would like to appreciate you for developing
- 4 strong ties with the residents and community
- 5 organizations and enhancing police community relations
- 6 for a better public safety in the 8th Precinct. We love
- 7 you, we appreciate you. I heard that you had some health
- 8 challenges, and you are here and healthy and present. I
- 9 love you.
- 10 OFFICER COLEMAN: Thank you so much.
- 11 VICE CHAIR SMITH: Next I have a Certificate of
- 12 Appreciation for the Detroit Police Department, the
- 13 entire agency. We appreciate you for your unwavering
- 14 dedication, and tireless efforts during the 2024 NFL
- 15 Draft. Three days of commitment to ensuring that the
- 16 public safety of our residents and community during the
- 17 NFL Draft while fostering positive police community
- 18 relations in the City of Detroit is commendable. Thank
- 19 you for your service and your invaluable contribution to
- 20 enhancing public safety. We appreciate you. Thank you.
- 21 CHAIRPERSON PRESSLEY: Vice Chair Smith, I'm going to
- 22 ask that you remain down there because I don't want you
- 23 to have to come back and forth. Yeah, just if somebody
- 24 can grab it for her. I just don't want you to have to go
- 25 up and down. Now that we do have a quorum, we can move



- 1 through the beginning of our agenda, then you can go to
- 2 your resolution. Thank you. Okay, so now we do indeed
- 3 have a quorum and so we're going to move towards our
- 4 formal agenda. And so we'll do so by the introduction of
- 5 commissioners by our Acting Secretary, Mr. Brown
- 6 MR. BROWN: Chairperson Pressley Here.
- 7 MR. BROWN: Vice Chairperson Smith Present.

- 13 MR. BROWN: Commissioner Carter asked for an excuse
- 14 absent.
- 15 MR. BROWN: Commissioner Moore President
- 16 representing District 7.
- 17 MR. BROWN: Commissioner Hernandez Present.
- 18 MR. BROWN: Commissioner Woods Present.
- 19 CHAIRPERSON PRESSLEY: Alright. With that, we do
- 20 indeed have a quorum. We'll now move on to the approval
- 21 of the May 9th, 2024 agenda. Is there any objection to
- 22 this agenda being approved? Hearing no objections, the
- 23 agenda is approved. And now we'll move on to the approval
- 24 of the minutes for the May 2nd, 2024 meeting. Is there
- 25 any objection to those minutes being approved? Hearing no



- 1 objection, those minutes are approved. We had several
- 2 closed sessions last week, and so now we'll move on to
- 3 the approval of the minutes for those closed sessions.
- 4 First the approval of closed session minutes for Police
- 5 Officer Abdullah Nasser of May 2nd, 2024. Is there any
- 6 objection to the approval of those minutes? Hearing none,
- 7 those minutes are approved. Now, we'll move on to the
- 8 approval of the closed session minutes for Police Officer
- 9 Kayla Roe from May 2nd, 2024. Any objection to those
- 10 minutes? Hearing no objection to the approval of those
- 11 minutes, those minutes are approved. Now, we'll move on
- 12 to the approval of the closed session minutes for Police
- 13 Officer Brandon Jordan, May 2nd, 2024. Is there any
- 14 objection to the approval of those minutes? And finally
- 15 the approval of closed session minutes for Police Officer
- 16 Anthony Darling. May 2nd, 2024. Is there any objection to
- 17 the approval of those minutes? Hearing none, those
- 18 minutes are approved. We'll now have the introduction of
- 19 BOPC Staff, Chief of Police, Elected Officials and
- 20 Representatives, as well as Community Leaders by

- 23 present. We have Chief Investigator Jerome Warfield,
- 24 Attorney Stephanie LaBelle on Zoom, Supervising
- 25 Investigator LiSonya Sloan, Ms. Jasmine Taylor, Jonya



- 1 Underwood, ASL sign language interpreter, Ms. Yakata, and
- 2 Dr. Stephanie Beatty, Senior Investigator Tiffany
- 3 Stewart. And our VIPs are Ms. LaDon Davis, Office of
- 4 Council Member Fred Durhal III Office, and Ms. Marie
- 5 Overall, Office of State Representative Tyrone Carter.
- 6 CHAIRPERSON PRESSLEY: Thank you. And again, we're
- 7 grateful everyone's participation in attendance and our
- 8 hope is that it adds to the productivity of our meeting.
- 9 Now we're back at the Board of Police Commissioner's
- 10 Officers Report where again, I'll turn it over to Vice
- 11 Chair Tamara Liberty Smith as she provides resolutions.
- 12 VICE CHAIR SMITH: Thank you Chair. My first Resolution

- 6 Resolution, ladies and gentlemen, for Nicholas A. Radden,
- 7 Jordan A. Radden, and Dr. Louis Radden DO, II. Are they
- 8 present? Well, can you come forward please to the podium
- 9 where my colleague is? Okay. Alright. Thank you Tamara
- 10 for standing there with them while... I'll come down right
- 11 after we finish this.
- 12 WHEREAS one family, a shared vision and three
- 13 enlightened black men, equals Nuggets Cannabis Company, a
- 14 Detroit legacy in the making. After years of research and
- 15 development and a two year freeze in construction due to
- 16 COVID, Nuggets broke ground in 2022.
- Nuggets opened its 6,000 foot retail facility at
- 18 18270 Telegraph Road in the 8th Precinct in 2023. 80% of
- 19 Nuggets employees are local community residents, and 95%
- 20 are African Americans. Nuggets strongly supports DPD and
- 21 the city by adopting a family and being actively engaged
- 22 in the community. Nuggets is the only known retail
- 23 marijuana operation in Michigan and even the USA headed
- 24 by a physician together with his two sons, Nicholas
- 25 Armand, Miami International University, and Jordan



- 1 Alexander, University of Miami; and
- WHEREAS Dr. Louis Radden, II DO, a native Detroiter
- 3 is a board certified spine surgeon and graduate of
- 4 Michigan State University College of Medicine and Duke
- 5 University Spinal Fellowship residency program. As the
- 6 founder of Spine Specialists of Michigan Inc. SSM, he
- 7 treats thousands of Detroit residents and is frequently
- 8 seen in television ads. Because Dr. Radden is committed
- 9 to "Patient wellness and pain management," without
- 10 addictive narcotic drugs, he has a laboratory onsite at
- 11 Nuggets and can prescribe cannabis-based remedies for
- 12 pain that do not risk addiction or other side effects.
- 13 Nuggets is unique in that it is vertically integrated as
- 14 a State licensed manufacturer, grower and wholesaler to
- 15 other licensed retailers and processors in its 9,000
- 16 square foot facility called Harvest in Lansing, Michigan.
- 17 There are plans to build a third state-of-the-art
- 18 facility on the adjacent two acres in Lansing for
- 19 service, manufacturing, wholesale and distribution
- 20 related enterprises; and

- 7 physician, businessman and job creator is worthy of
- 8 recognition by the commission and law enforcement. We
- 9 thank and congratulate you Nicholas Armand Radden, Jordan
- 10 Alexander Radden, and Dr. Lewis in Radden II. "The head
- 11 of the herd, for your service to Detroit and mankind." We
- 12 thank and congratulate you. Thank you.
- 13 CHAIRPERSON PRESSLEY: The Chair entertains a motion

- DC Good afternoon. Good afternoon. My name is
- 19 Jacqueline Pritchett. I'm the Deputy Chief of Western
- 20 Operation.
- 21 CHAIRPERSON PRESSLEY: I think they're working it
- 22 out. Let's try that again.
- DC PRITCHETT: I'm Jacqueline Pritchett, Deputy Chief
- 24 of Western Operations. There is still feedback. So
- 25 there's an update on two injured officers. There are



- 1 currently two department members who are disabled and
- 2 recovering at home due to an on-duty injury. The two
- 3 detectives are from SPU Domestic Violence. On May 2nd,
- 4 2024, the detectives were rear-ended by another vehicle
- 5 while driving an unmarked department vehicle. The
- 6 detectives sustained multiple injuries and one was
- 7 admitted to the hospital. Both are now at home resting
- 8 for the crime data as the 582024.
- 9 CHAIRPERSON PRESSLEY: Let's see. Commissioner Moore,
- 10 can you see if she can use your mic and see if that might
- 11 aid us here?
- DC PRITCHETT: Okay. So yeah, sounds better. Much
- 13 better feedback. Thank you. So the crime data is 582024,
- 14 the homicides are down 22%, and non-fatal shootings are
- 15 down 27%, our robberies are down 28%, a total part one,
- 16 violent crimes are down 11% and our carjackings are down
- 17 50%. We had a drag racing detail that started back in
- 18 April every weekend. So the enforcement for the past
- 19 weekend was 45 people investigated. There were 6 traffic
- 20 stops, 6 citations issued, 11 vehicles investigated; 4 of
- 21 those vehicles were impounded. There was one felony
- 22 arrest, one weapon recovered. They responded to 2 block
- 23 parties and they issued 16 spectator tickets.
- So, year to date, mental health related calls for
- 25 service, we have had 5,178 calls for service year to date



- 1 compared to 5,017 last year. So as of yesterday's date,
- 2 we had 161 more calls for service for mental health. So
- 3 there are some significant incidents that we are seeking
- 4 the community's help in solving these crimes. The first
- 5 incident occurred on Saturday May 4th at 11:10 AM.
- 6 Officers were dispatched to the 2,600 block of Blaine to
- 7 investigate a dead person. Officers arrived and observed
- 8 the victim suffering from a wound to the right shoulder
- 9 in the back of the head. Medic 14 and Fire 39 arrived at
- 10 the scene and provided medical assistance. The victim,
- 11 however, was pronounced deceased by medics. Further
- 12 investigation revealed that the 911 call came from a
- 13 nearby gas station. After reviewing the video from the
- 14 gas station, it was determined that the person who made
- 15 the 911 call was a male wearing a dark hoodie and gloves.
- Detectives are still attempting to identify that
- 17 person and the circumstances surround the incident. The
- 18 incident is still under investigation. Detectives are
- 19 asking anyone additional information to contact Crime
- 20 Stoppers at 1800 SpeakUp, or to Detroit Rewards TV. The
- 21 second incident was a triple shooting that happened on
- 22 Sunday, May 5 , at 1:53 PM. Officers were dispatched to
- 23 the 3,800 block of 33rd Street to investigate a shooting.
- 24 When the officers arrived, they observed medics providing
- 25 medical attention to victim 1, who was suffering from a



- 1 gunshot wound to the throat. Officers went into the
- 2 location to check additional victims, and discovered
- 3 victims 2 and 3 suffering from gunshot wounds to the
- 4 head. Both were pronounced deceased at the scene.
- 5 Officers, I'm sorry, detectives determined the witnesses
- 6 heard several shots being fired in a location and that
- 7 after the shooting, the suspect entered a gray Dodge
- 8 Durango and drove north on 33rd Street.
- 9 The suspect was described as a black male with a
- 10 skinny build, short hair, and wearing a white T-shirt.
- 11 This incident is still under investigation. So once
- 12 again, we are seeking assistance from the community to
- 13 provide any information to contact Crime Stoppers at 1800
- 14 SpeakUp and or Detroit Rewards TV. And the final was
- 15 another fatal shooting that occurred on Sunday, at around
- 16 4:15 AM. Officers were dispatched to Henry Ford Hospital
- 17 to investigate a shooting. When they arrived at the
- 18 hospital, they were notified by security that the victim
- 19 had expired from a gunshot wound and that the victim was
- 20 transported to the hospital by witnesses who were waiting
- 21 in the area. The witnesses stated that they were at a
- 22 block party in the area of Stansberry and West McNichols
- 23 when they heard shots being fired. Shortly after, the
- 24 victim ran to them stating he was shot. They conveyed him
- 25 to Henry Ford Hospital.



- 1 Officers and detectives responded back to the area
- 2 and discovered evidence of a shooting in the 16,000 block
- 3 of Stansberry. They canvas the area and check for
- 4 available video. This incident is still under
- 5 investigation, but once again, detectives are asking
- 6 anyone with additional information who might have been in
- 7 the area of Stansberry and West McNichols early Saturday
- 8 morning, to please contact Crime Stoppers at 1800 SpeakUp
- 9 or Detroit Rewards TV. There are some positive notes as
- 10 well as some of the bad news. So today, we had a
- 11 dedication ceremony for fallen members whose plaques were
- 12 placed on our memorial wall at headquarters. The
- 13 following members were honored: our Lieutenant Frederick
- 14 Bowens, Sergeant Almondo Greer-Travis and Police Officer
- 15 Isam Qasem. So tomorrow May 10th, Chief White will attend
- 16 and speak to Wayne State University. Mike Ilitch School
- 17 of Business, DPD Leadership Academy graduates. 16 DPD
- 18 members will be graduating from the 9 month program with
- 19 the graduate certificate in business. The certificate
- 20 equates to almost half the credits needed to achieve an
- 21 MBA. So Precinct events. The 5th Precinct yesterday had
- 22 biked to school day, which they rode with the 200 kids
- 23 from 3 DPS schools to local parks. I heard there was a
- 24 great turnout. So today, the 6th Precinct had Career Day
- 25 in Maybury Elementary School, and Tuesday on 5/7 was



- 1 Coffee with a Cop at the 10th Precinct. So those are the
- 2 reports for the Chief's report for this board.
- 3 CHAIRPERSON PRESSLEY: Thank you. Are there any questions?
- 4 Commissioner Moore?
- 5 COMMISSIONER MOORE: Thank you Mr. Chairman. Chief, I
- 6 just need you to do a follow up for me with Assistant
- 7 Chief Eric Ewing. About a month ago, I asked him about
- 8 some crime statistics as related to justifiable
- 9 homicides, vehicular homicides, as well as suicides. And
- 10 the reason why I would like to see that information is
- 11 because there's been a comparison between 1966 and the
- 12 current crime statistics as it relates to homicide. I'm
- 13 acutely aware that in 1966, all of these different
- 14 categories were grouped together. So I just want to make
- 15 a comparison for myself. So if you could follow up with
- 16 assistant chief, you and I appreciate it
- 17 DC PRITCHETT: Through the Chair. You said
- 18 justifiable homicide, vehicular homicides, it was the
- 19 third one?
- 20 COMMISSIONER MOORE: And suicides as well. And how
- 21 the grouping as far as how many occurred in 2023. And a
- 22 question you may or may not know, and this is kind of a
- 23 couple weeks old, how many arrests were made during the
- 24 NFL Draft, if you know?
- DC PRITCHETT: I don't know the information. I'm not



- 1 sure.
- 2 COMMISSIONER MOORE: That's fine. Thank you ma'am.
- 3 CHAIRPERSON PRESSLEY: Alright, are there any further
- 4 questions? I have one. At our last community meeting,
- 5 which was last month, we were made aware of a non-fatal
- 6 officer involved shooting that took place on Remo and
- 7 Fenkell. It was told to us that again, there was a
- 8 suspect who was 16 years old, who allegedly pulled a gun
- 9 from his side and an officer shot two shots, striking the
- 10 suspect, once in the leq. I'm mentioning this because it
- 11 had been the custom of the department to provide us a
- 12 critical debriefing that, I don't know if I missed
- 13 anything, but I hadn't been made aware of that critical
- 14 debriefing so the commissioners could review the body-
- 15 worn camera footage and to get any updates on where we
- 16 are, and then also to see if the department is in line
- 17 with the 45 days that the Chief has offered when those
- 18 videos will be released. So again, I think that the date
- 19 of that incident was on April 4 , and now here we are on
- 20 May 9th, and have yet to hear anything. And so if we can
- 21 get some follow up on what's occurring with that non-
- 22 fatal officer involved shooting that would be appreciated
- DC PRITCHETT: Through the Chair. I'm going to make
- 24 sure the Chief gets your request tomorrow morning.
- 25 CHAIRPERSON PRESSLEY: Thank you.



- 1 DC PRITCHETT: Provide an update for you.
- 2 CHAIRPERSON PRESSLEY: Okay. Thank you. Commissioner
- 3 Bernard.
- 4 COMMISSIONER BERNARD: Mr. Chairman, I'll wait
- 5 because my question is related to the same incident, so
- 6 that's fine.
- 7 CHAIRPERSON PRESSLEY: Any further questions? Thank
- 8 you so very much. And so now we'll invite the 8th
- 9 Precinct leadership to come forth and provide their
- 10 report as well.
- 11 CMDR LEVER: Alright. Good evening, everybody.
- 12 CHAIRPERSON PRESSLEY: Good evening.
- 13 CMDR. LEVER: I'm Dietrich Lever. It's my pleasure to
- 14 be the commanding officer of the 8th Precinct and serve
- 15 this community. This evening, I'm going to give you an
- 16 overview of our crime strategies, some community
- 17 programs, and our upcoming events in the 8thh Precinct.
- 18 So I can say at the 8th Precinct, I'm proud to say that
- 19 our crime is down. Now, overall crime is down. I can give
- 20 you exact numbers. Criminal homicides are down 36.4%. I
- 21 can tell you our non-fatal shootings are down 6.5%. Our
- 22 sexual assaults are down 11.5%. Our robbery, excuse me,
- 23 our aggravated assaults are down 6.6%. Our robberies are
- 24 down 7.4%. Our larceny is down 0.04%. We'll take a win
- 25 when we can get it. Our motor vehicle theft is down 4.7%



- 1 and our carjackings are down 55.6%. The only... yes? Yes,
- 2 that's right. The only uptick we have is in burglaries,
- 3 and we'll talk about that a little later. So overall, our
- 4 part one crime, and I'm just referring to part one crime
- 5 over last year. This is 2024, compared to 2023 is down
- 6 7.1%.
- 7 So our crime strategies, they're simple. We follow
- 8 the Chief of Police, Chief White's 5 and 12 point plans.
- 9 I can go over them, I know he's very public about them.
- 10 Increased deployment for rapid response, police presence,
- 11 community engagement, traffic enforcement, noise
- 12 enforcement, crowd management, and code enforcement;
- 13 community partnerships, drag racing and block party
- 14 suppression, street closures, Casper or undercover unit
- 15 engagements, open alcohol and curfew enforcement and eyes
- 16 in the sky policing. That would be our helicopters and
- 17 rooftop surveillance. And that's our approach. That's our
- 18 crime strategy appropriate as followed as the Chief laid
- 19 out. And we use data, technology and information to make
- 20 that come true. So overall, the 8th Precinct, our
- 21 strategy for our specific strategy, we use targeted
- 22 enforcement with that data, with that information, it
- 23 tells us where our crime is, where we're spiking.
- 24 So that's where we send our resources to deal with
- 25 that. We have high visibility traffic enforcement. My



- 1 traffic enforcement guys are out in the areas that we
- 2 have identified as our problem areas for either speeders
- 3 or accidents to enforce the law. We have restorative
- 4 order practices for violent crime suppression by our
- 5 special operations. We have an embedded crime unit, crime
- 6 intelligence unit right here in the 8th Precinct where we
- 7 have the big giant TV where we can watch with our
- 8 Greenlight partners, we can partner up and get real-time
- 9 information from them over real time right over the
- 10 radio. We are transparent with my community always and
- 11 forever. And we're part of our partnerships. We partnered
- 12 with the AUSA, the Assistant US Attorney. We have our
- 13 federal partners, FBIATF, to help us here.
- MDC, Michigan Department of Corrections help us as
- 15 well. We have our DPD specialized victims units here to
- 16 help us as well. We have our CVI Units, which is our
- 17 Community Violence Intervention Team, where we support or
- 18 support it by Detroit 300 and People's Action. We have
- 19 our building and safety engineers to help us out as well.
- 20 And our suburban law enforcement is actually partnering
- 21 with us to keep crime down. Our strategy results, again,
- 22 as I said, overall crime is down 7.1%. I can tell you
- 23 that our hardworking officers have taken 141 guns off the
- 24 street year to date.
- 25 Speaking of transparency, we do have 2 crime trends



- 1 that I wanted to talk about. We have our robbery crime
- 2 trend. We had 6 in the last month, which is more than we
- 3 were expecting. So that's an uptick. However, they are
- 4 being addressed by our detective unit. We have made 2
- 5 significant arrests: one for a robbery of a person at a
- 6 gas station. He's in custody. We made another arrest for
- 7 a robbery of a business that he's in custody as well. So
- 8 we have partnered with our FBI and told you about our
- 9 partnership. What we did is, we came out, they talked to
- 10 some business owners and we have signage up to let you
- 11 know that it's a federal crime to rob these stores. So
- 12 we're looking for the results of that to be positive. And
- 13 we have a burglary trend.
- I know I talked in my community extensively about
- 15 the burglary trend we had. We all partnered together in
- 16 the partnership, the police and the community, and we
- 17 were able to be successful. But in the last 28 days,
- 18 we're up. We have five. I can tell you this, I want to
- 19 share this with you. We were up like 75% where I had to
- 20 literally go down and make a presentation in front of the
- 21 Chief of Police. We're still up 5.8%, but they haven't
- 22 stopped. We're persistent. And we're still talking about
- 23 our breaking and entering. We're still following our
- 24 strategy. So we're down about 70%, which is good. They're
- 25 still being tracked. I still have a breaking and entering



- 1 team active. Again, we collaborated with the community.
- 2 As a matter of fact, we got our largest tip to make our 4
- 3 significant arrests from a community member who was out
- 4 walking their dogs. Our surveillance operations continue.
- 5 We have one. We still have one that was identified that
- 6 was out. We had locked him up, and they released him.
- 7 We're still on his trail right now. And we're persistent.
- 8 We'll continue. We're not going to stop. We're not going
- 9 to stop until we feel that we have everybody in custody
- 10 who's responsible for victimizing our citizens.
- We're not all about enforcement here. And we are
- 12 addressing quality of life issues right now. You should
- 13 see my team out. We're addressing blight complaints,
- 14 click fix complaints right now and safe driving. I'm
- 15 almost finished in our community. We have community
- 16 programs. We have an embedded social worker who works
- 17 with us every day. She's not here today. I was going to
- 18 invite her out. But we have immediate access to
- 19 counseling. We have immediate access to counseling,
- 20 resources and services. And she does it after an action,
- 21 follow up. She does a 4 or 5 day review, and she keeps me
- 22 posted as well. We have a ceasefire program, and that's
- 23 run through our special operations. And again, we're more
- 24 than enforcement. They run a brotherhood program where
- 25 they up youth and teens, they take them to play



- 1 basketball with them. They box, they have one-on-one
- 2 mentoring sessions with them. We do our restorative
- 3 practices to try to repair families through our ceasefire
- 4 program. We're on anti-gang, anti-bullying presentations
- 5 at schools. We have police counter education at schools.
- 6 And one success story I'd like to tell, we have one
- 7 troubled youth who participated in our ceasefire program.
- 8 He actually joined DPD. Moreover, he actually works in
- 9 the 8th Precinct.
- 10 VICE CHAIR SMITH: Wow. Awesome.
- 11 CMDR LEVER: So we have our Neighborhood Police
- 12 Officers. I talk about them a lot. I'm out there with
- 13 them a lot. And with them, there are non-emergency police
- 14 resources. We do see what they do, or we do, I'm sorry.
- 15 We do senior citizen enrichment events, neighborhood
- 16 mediation and conflict resolution. We have school safe
- 17 zones where we follow the kids to school. We know where
- 18 they are. We make sure they get safe, get there safe. We
- 19 have our prescription disposal program. We have gun lock
- 20 safety programs, community recognition programs, much
- 21 like tonight. But we have our very own in-house safety
- 22 assessments as needed. We offer them out when we are
- 23 having a breaking and entering problem, and we have our
- 24 chaplain services to support us, the police officers and
- 25 the community. Last thing on the agenda, upcoming events.



- 1 We have a walk a mile with the Chief, to be determined.
- 2 I'm told it's sometime in June. I asked today, they told
- 3 me sometime in June. So please stay tuned. I'll let
- 4 everybody know as soon as I know. We have our monthly
- 5 council meetings here at the 8th Precinct. The last
- 6 Monday of the month. This month it'll be on May 27th,
- 7 2024. If I'm not mistaken, it is Crystal Johns, are you
- 8 in the back? What time would that go off?
- 9 6:30, May 20th. Oh, well, Ms. Gail Tubbs here. I
- 10 apologize. It's May 20th and it starts at 6:30. We have a
- 11 District 1 monthly meeting there on Saturdays, and
- 12 they're with Councilman Tate. That will be to be
- 13 determined. We have the AUSAP Peacenik walk in
- 14 presentation in June to be determined. I don't have the
- 15 exact date, but I know it's going to be in June. As soon
- 16 as I know everybody else will know. Police Week is next
- 17 week. Our auditorium is stage, our beautiful auditorium
- 18 stage and lighting. We still have more lighting available
- 19 for our community events, graduations, and recitals. Just
- 20 call my front office at (313) 596 5810. We'll get a
- 21 reserve for you. Again, (313) 596 5810. We'll have that
- 22 reserved for you. And follow us on Facebook for the stuff
- 23 that I told you. We are at DPD 8th Precinct and that'll
- 24 give you some of the dates that I was talking about. And
- 25 last, but very, but absolutely, positively not least, I



- 1 would be remiss if I didn't thank the 8th Precinct
- 2 officers for their hard working dedication to make sure
- 3 that our community is safe and to keep our crime down.
- 4 And that's it for the 8th Precinct.
- 5 CHAIRPERSON PRESSLEY: Thank you. Any questions?
- 6 Commissioner Moore?
- 7 COMMISSIONER MOORE: Thank you, Mr. Chair. I just
- 8 want to say thank you, Commander for you and your team.
- 9 I've forwarded you several complaints since you've been
- 10 Commander of the 8th Precinct. I'm not even the police
- 11 commissioner at the 8th Precinct, but you've knocked them
- 12 out, you and your team. So I just want to say thank you
- 13 and your staff for having the most complaints. Thank you.
- 14 CMDR LEVER: Thank you, sir.
- 15 CHAIRPERSON PRESSLEY: Commissioner Hernandez.
- 16 COMMISSIONER HERNANDEZ: Thank you. Through the
- 17 Chair, I'll just add a little bit more to that. I'm not
- 18 surprised with the approach that you're taking based on
- 19 the work that you did when you were in Risk Management.
- 20 In particular, I have to publicly thank you for a
- 21 critical incident that occurred a few weeks ago that you
- 22 were very hands-on and empathetic with specifically with
- 23 the family. So I appreciate that.
- 24 CHAIRPERSON PRESSLEY: Any further questions,
- 25 comments? Commissioner Woods?



- 1 COMMISSIONER WOODS: He's the reason why I was late,
- 2 for real.
- 3 CHAIRPERSON PRESSLEY: Commissioner Bernard.
- 4 COMMISSIONER BERNARD: A quick question, Commander,
- 5 and congratulations again on your success, and the
- 6 success of this Precinct. We have in our materials and
- 7 everything; everything is listed of course, as a homicide
- 8 or if it's a crime. But my question to you is this, how
- 9 do you define homicide versus "What is called a
- 10 justifiable homicide?"
- 11 CMDR LEVER: So that would be a classification for
- 12 me. That would be our data quality. So I take the
- 13 information statistically that gives us, so I wouldn't
- 14 make that determination because at the 8th Precinct, we
- 15 don't handle homicides per se. We are responding units.
- 16 However, the homicides are handled by the homicide
- 17 section.
- 18 COMMISSIONER BERNARD: Okay, thank you.
- 19 CHAIRPERSON PRESSLEY: Commissioner Woods.
- 20 COMMISSIONER WOODS: You have something called self-
- 21 defense, do you? It's justifiable homicide in the book. I
- 22 know you have the self-defense law. But do you categorize
- 23 homicides by justifiable homicide?
- 24 CMDR LEVER: Again, that would probably be that... so
- 25 if we are going to say categorize and you say justified,



- 1 that would probably be Wayne County Prosecutors because
- 2 we don't charge. So we'll be with the responding unit for
- 3 my officers at number 8th. We'll respond, we'll protect
- 4 our rights. We'll gather information.
- 5 COMMISSIONER WOODS: But you guys present the
- 6 charges?
- 7 CMDR LEVER: Yes. Well, no, that would be homicide,
- 8 but yes...
- 9 DC PRITCHETT: Through the Chair, if I may.
- 10 CHAIRPERSON PRESSLEY: Go right ahead.
- 11 DC PRITCHETT: But when a crime has occurred in the
- 12 8th Precinct, some crimes are handled by the precinct
- 13 detectives and the precinct detective unit. Homicides are
- 14 handled by a unit downtown. However, there are certain
- 15 instances in certain cases where the homicide might be
- 16 deemed by Madam Kym Worthy's Office, that it was self-
- 17 defense, which makes it justifiable. We don't make those
- 18 determination. The Wayne County Prosecutor looks at the
- 19 facts that were presented with the actual incident and
- 20 makes that determination. But some homicides are backed
- 21 out because they are deemed justifiable or self-defense
- 22 and are not charge for that crime.
- COMMISSIONER BERNARD: Mr. Chairman, just to follow
- 24 up quickly. So our homicide report would not include
- 25 "Justifiable homicides."

- 1 DC PRITCHETT: That is correct, ma'am.
- CHAIRPERSON PRESSLEY: Commission Moore. 2.
- COMMISSIONER MOORE: Oh, I mean, just to clarify, 3
- Chief. All homicides are initially... all deaths are 4
- 5 initially handled as they are homicide, whether it's
- 6 suicide or what have you. And then once it's submitted to
- the Prosecutor's Office, that's when it's determined what
- it actually is. 8
- 9 DC PRITCHETT: It is correct. Through the Chair, that
- 10 is correct.
- 11 COMMISSIONER MOORE: Thank you.
- 12 CHAIRPERSON PRESSLEY: Right. Any further questions?
- My question again, today's Precinct is we have had our 13
- 14 chief investigator provide us a report on the work that
- 15 our OCI Office is doing. There is a breakdown in his
- 16 presentation for community, citizen community report
- allegations by precinct. And while there's been such 17
- amazing news that has been shared with the precinct, I do 18
- want to draw to your attention that at least in the month 19
- of April the 8thh Precinct is leading in the number of 20
- CCRs that have been found against officers with them 21
- ranging from service to procedure to demeanor. Is there 22
- any response you would have about what maybe you might be 23
- doing or communicating to ensure that officers' 24
- 25 engagement with citizens don't lead to complaints?



- 1 CMDR LEVER: That's a good question, and thank you
- 2 for your question. I apologize. I missed this report, so
- 3 I don't know what it said. However, I expect
- 4 professionalism out of my officers. I'm here from 6
- 5 o'clock in the morning, usually to 6 o'clock at night. So
- 6 I see all 3 shifts. I talk to them, I mentor them. And
- 7 the people that I identify who may have problems, I
- 8 literally bring them into my office and I talk to them
- 9 personally. So I expect my community to be, excuse me. I
- 10 expect my community to be leased with dignity and
- 11 constitutionally. However, sometimes I will say this,
- 12 sometimes people don't want to go to jail. I did take a
- 13 look at the complaints that were outstanding because we
- 14 have CompStat and I have to answer for those as well.
- So a lot of them were pending. So I couldn't give
- 16 you an exact answer on the ones that are current. So for
- 17 the ones from May for this month, a lot of them will
- 18 probably still be pending when I look in my system.
- 19 However, if it's a person that I recognize that needs
- 20 some extra assistance, I'll have them ride with a
- 21 sergeant. I'll talk to them myself. But again, I'm at
- 22 roll calls probably 3, 4 times a week as the commanding
- 23 officer passing the message that we are going to police
- 24 constitutionally, we're going to be respectful to
- 25 citizens.



- 1 CHAIRPERSON PRESSLEY: Thank you. And just to be
- 2 clear, for the citizens, again, these are allegations
- 3 that have been made, and not that the cases have been
- 4 sustained or the officers have been found in wrongdoing.
- 5 But yet with the number of allegations that have been
- 6 made the 8th Precinct is number one with 35, the 12th
- 7 Precinct is number 2, with 31, and then the 6th Precinct
- 8 is number 3 with 23. Just for your...
- 9 CMDR LEVER: Through the Chair, may I add. This is
- 10 not an excuse. However, we are the biggest and the most
- 11 populated city Precinct in the City of Detroit and
- 12 probably make some of the most contact with citizens.
- 13 CHAIRPERSON PRESSLEY: And that's an important
- 14 context. Thank you for that clarification.
- 15 CMDR LEVER: But I still expect it to be
- 16 professional.
- 17 CHAIRPERSON PRESSLEY: Thank you. Any further
- 18 questions or comments?
- 19 DC PRITCHETT: Through the Chair.
- 20 CHAIRPERSON PRESSLEY: Yes.
- 21 DC PRITCHETT: Commissioner Moore, I have your
- 22 questions. I mean, answer to your question regarding how
- 23 many arrests were made during the Draft. Inside the
- 24 footprint, there were two arrests that were made, a male
- 25 and a female. And there were 2 juveniles detained for



- 1 fighting. Outside of the footprint, there were 18. And
- 2 those consisted of fighting MDP and trespassing with some
- 3 of the charges for the 18 outside of the footprint.
- 4 COMMISSIONER MOORE: So thank you. Through the Chair.
- 5 So you say outside of the footprint. Outside of the
- 6 footprint could literally mean where we are right now. So
- 7 when you mean outside the footprint, what do you mean?
- 8 DC PRITCHETT: No, outside, through the Chair.
- 9 Outside the footprint downtown, you know, where it's
- 10 campus Marshalls at the theater and where the Evolves
- 11 were. If you go outside that area, like Greektown up by
- 12 Wayne State, up by LCA, those areas were also considered
- 13 outside the footprint. And so during the Draft, there
- 14 were 18 arrests that were in the area of the Draft, but
- 15 not in the...
- 16 COMMISSIONER MOORE: Understood. Thank you Chief.
- 17 CMDR LEVER: Through the Chair.
- 18 CHAIRPERSON PRESSLEY: Yes. Go right ahead.
- 19 CMDR LEVER: Excuse me. Sorry for this.
- 20 CHAIRPERSON PRESSLEY: Yeah, no problem. That's what
- 21 we're here for.
- 22 CMDR LEVER: So if you take a look over to your
- 23 right, my left, we have Captain Brian Bowser here. I'm
- 24 going to put him on the spot. He is one of the reasons
- 25 that... he's my second. I mean, he's one of the reasons why



- 1 crimes are down. He's a crime guru. This is probably
- 2 going to be his last Board of Police Commissioners
- 3 meeting. Put him on the spot now and if he'd like to come
- 4 up and say something on his way out.
- 5 CHAIRPERSON PRESSLEY: Please do.
- 6 CMDR LEVER: We would love to hear from him. It's,
- 7 so... it's okay.
- 8 CHAIRPERSON PRESSLEY: Excellent. After how many
- 9 years? 28 years. Thank you for your service. Thank you.
- 10 Anything further? Alright, hearing none, we thank
- 11 everyone for their questions for the Chief of Police
- 12 Report and the 8th Precinct Report. And now we'll move
- 13 forward to oral communications. And again, for those who
- 14 would like to make public comments, and you're in the
- 15 room, there should have been public comment cards at the
- 16 door when you came in that you could turn in. And then
- 17 those who are on the zoom, you can identify yourself as
- 18 we move forward in public comment. Mr. Brown, who do we
- 19 have?
- MR. BROWN: Good afternoon, Mr. Chair. We currently
- 21 have 13 speakers. I call those in attendance. First, Ms.
- 22 Charnita Williams, followed by Minister Eric Blount,
- 23 followed by Ms. Bernie Smith.
- MS. WILLIAMS: Hello everyone.
- 25 CHAIRPERSON PRESSLEY: Hello.



- 1 MS. WILLIAMS: And I like to say this. Everything
- 2 that I'm getting ready to say is from my heart. Okay? I
- 3 cannot speak about the 2000 police officers, but I can
- 4 speak about the police officers. And it's ironic that I'm
- 5 here at the community center concerning, you know, my
- 6 issue I've been going through and the officers that came
- 7 out to the police, I mean out to the hospital, came from
- 8 the 8th. So as I discovered a lot of people, like
- 9 Fernandez just said, thank you very much. Apparently I'm
- 10 not special enough for them to do their job correctly,
- 11 because it looks like a lot of people are calling in
- 12 favors to cover up this rape. And if they were doing
- 13 their job correctly, this person that raped me should
- 14 have been locked up. So when I say this, this is coming
- 15 from my heart, and I mean this. I know for certain,
- 16 certain police officers, they act like they're the black
- 17 mafia family with badges. That's how I feel. They
- 18 disrespect, they badge, they steal dope from the evidence
- 19 room, stealing money, and then stealing money from the
- 20 casinos. So how can I respect anybody like that? And at
- 21 the bottom line, I've been coming here over a year, and
- 22 if you all choose not to do your job correctly, it's
- 23 accountability. You always say accountability,
- 24 transparency, I can't tell. And whoever is calling in
- 25 these favors have a lot of power, from the hospitals all



- 1 the way down. And at this point in time, I don't know
- 2 what to believe or who to believe, but I know my body
- 3 can, you can't put a price tag on that. And where they're
- 4 getting this money from to be able to play for DoorDash,
- 5 Cash App gift cards. You tell me they have a hotline for
- 6 me to take pictures and post them. That's how they keep
- 7 track of me. So you say it's no undercover officers where
- 8 I live, just like the woman who was undercover, who
- 9 abused her daughter got dropped off by transit police.
- 10 Transit police didn't give me a ride after they towed my
- 11 car.
- 12 CHAIRPERSON PRESSLEY: Thank you.
- MS. WILLIAMS: Okay.
- MR. BROWN: Minister Blount.
- 15 MINISTER BLOUNT: I don't want anyone to be deceived
- 16 even by the written statements of this board. On the
- 17 second page of your agenda, it says falsely that this
- 18 board acts as the final authority in imposing and
- 19 reviewing discipline of DPD employees. That is not true.
- 20 So many of these officers that are voted to be
- 21 disciplined, not just keep their job, but they get their
- 22 back pay through binding arbitration. Not only that, the
- 23 2022 contract negotiated under Chief White, requires that
- 24 discipline cannot be used in determining an officer's
- 25 promotion. So where is the accountability? Hard, hard to



- 1 find. And yes, Commissioner Bernard, I must once again
- 2 read into the record your statements on this meeting,
- 3 March 2nd, 2023, page 32, when you said, "I request that
- 4 everyone in this room be promoted, would you please
- 5 stand?" You went on to say, "I am Attorney Linda Bernard,
- 6 if there's anything I can do for you as a lawyer or
- 7 personally or professionally, please feel free to contact
- 8 me." If that's not solicitation, I don't know what is
- 9 COMMISSIONER BERNARD: Mr. Chairman. If I may, with
- 10 the permission of the Chair. That was a remark. It was
- 11 not a legal solicitation by any interpretation, by any
- 12 court or other body. It was a remark that I made ladies
- 13 and gentlemen to young people that I was looking at who
- 14 had just been promoted as officers. And when I say that
- 15 to people, I say it to citizens all the time. When I talk
- 16 to you, I tell people, my name is Linda, you can call me
- 17 if you have some problem. Usually the questions relate to
- 18 child support. What do I do about this? What do I do
- 19 about that? I don't think I've ever gotten a question
- 20 about a criminal law matter or a matter that would be a
- 21 disciplinary matter. But I'm proud of my reputation. I'm
- 22 proud of what I've achieved.
- 23 I'm the only African American with a master's of
- 24 law, the first one to graduate from the University of
- 25 Pennsylvania. I earned my JD from Wayne State University



- 1 and my bachelor's in 3 years from Wayne State
- 2 University's Monteith Honors College. I've argued and won
- 3 3 precedent setting cases in the Michigan Supreme Court,
- 4 which changed the law for everyone, all of us in this
- 5 room. I'm not going to go into detail, my Chairman would
- 6 have a fit. But I want you to understand, and I'm
- 7 licensed in 5 federal courts, including the US Supreme
- 8 Court. I have nothing to be ashamed of as a professional.
- 9 And you cannot and will not shame me by my remarks, which
- 10 were quite frankly charitable in nature to young people
- 11 who don't know the legal system, particularly as it
- 12 relates to their family law issues and others, when I
- 13 made that remark. I'm proud of it. And I would say it
- 14 again and I say it to everyone in this room, if I can
- 15 help you, I'm on this earth to help you to serve. If I
- 16 can help you, please call me and I will do what I can to
- 17 help you negotiate or whatever it is you need or tell
- 18 you. Really, I just tell you the right direction to go
- 19 in. So thank you Mr. Chairman.
- 20 CHAIRPERSON PRESSLEY: Next speaker.
- MR. BROWN: Ms. Smith.
- MS. SMITH: Good evening to everyone here present.
- 23 CHAIRPERSON PRESSLEY: Good evening.
- MS. SMITH: I didn't think I was going to make it
- 25 because you were so far out and then I have my cane. But



- 1 Linda, let me tell you something. When you are doing a
- 2 good job, you are getting criticized all the time. I was
- 3 accused of hitting people with my cane and I was ready to
- 4 go to court and then I talked to the Lord. That's
- 5 something most of us need to do. We need to talk to the
- 6 Lord and being a minister, he comes here every week and
- 7 complains about somebody...
- 8 CHAIRPERSON PRESSLEY: Be sure that your comments are
- 9 to commissioners and to the board.
- 10 MS. SMITH: But the fact is, I'm going to speak to
- 11 the commissioners, I want to let you know the members up
- 12 there are doing a hell of a good job. I know it because I
- 13 was number one under Coleman Young. So I know what you're
- 14 going through.
- So Linda, don't worry about it, look up to the man.
- 16 He'll take care of everything. Believe me, he will. Now
- 17 to my police department, I want you to know I love you. I
- 18 told everyone that I saw since the weekend, you did a
- 19 hell of a job for this city. I'm going to the convention
- 20 next month or this month rather, which is in Chicago, my
- 21 home. I've been here for 70 years and I love it here. I
- 22 was born and raised in Chicago and I want you to know,
- 23 I'm going to brag my behind off when I go over there and
- 24 talk about my police department here because you know why
- 25 when you put that uniform on, you're protecting me and



- 1 everybody else in this auditorium. And I want everybody
- 2 to understand, this is your life and you have extended to
- 3 save us every day that you put that uniform on. I happen
- 4 to be 71, 79, damn, I don't even know, 91 years old. I
- 5 will be 92 on May 31st. And I hope the good Lord, let me
- 6 stay here so I can talk some more, and especially at the
- 7 Convention in Chicago. Take care everyone, and bless you,
- 8 Mr. Chair. Your next 3 speakers would be Xavier
- 9 Cuevas, followed by Ms. Lydia Maciel, followed by Mr.
- 10 Joshua Media.
- 11 MR. CUEVAS: Good evening everyone. My name is Xavier
- 12 Cuevas. Nice to see all of you. Always a pleasure to see
- 13 some familiar faces from the lovely Media Services
- 14 Department. This past Sunday was Cinco de Mayo. I was
- 15 present working at an event I've covered for the last few
- 16 years. This year, however, was slightly different as I'm
- 17 sure many of you have already been made aware. There was,
- 18 of course, a large police response to "Overcrowding,"
- 19 resulting in the dispersing of a vast number of visitors
- 20 and residents. The closing of a number of businesses and
- 21 the detainment of 7 individuals, one of which was myself.
- 22 Now, I'm not here to ask you all particularly any
- 23 questions or for an apology, nor am I here to antagonize
- 24 you. I've heard the responses, I understand people were
- 25 doing their jobs and following orders.



- I am however here to of course encourage you all to
- 2 do a better job as well as you know, the residents of
- 3 this area and just throughout the city to become educated
- 4 and informed on the rules and regulations and processes
- 5 of organizing community events so that our celebrations
- 6 can be as respected and protected as events that attract
- 7 thousands of non-residents to our beautiful city. While
- 8 the developments and improvements occurring in Detroit
- 9 have been exciting to see, I hope we can continue to
- 10 ensure that there is always a place for the diverse
- 11 people who call the city home for generations and
- 12 continue to live here. And I'm also here to extend an
- 13 invitation to a community meeting tomorrow May 10th at
- 14 4:00 PM in Southwest Detroit regarding some of those very
- 15 issues and questions and events that occurred on Sunday.
- 16 So if you would like to hear more, I'll be there and, and
- 17 several other officials will be there as well. So thank
- 18 you.
- 19 CHAIRPERSON PRESSLEY: You know where?
- MR. CUEVAS: Oh, yes. Here, let me grab the address
- 21 real quick. That would be 7752 West Vernor, Detroit,
- 22 Michigan, 48209. So thank you.
- 23 CHAIRPERSON PRESSLEY: Thank you. Commissioner Woods.
- 24 COMMISSIONER WOODS: Deputy Chief Pritchett, do you
- 25 have any insight as it relates to this matter that



- 1 happened at Cinco de Mayo?
- 2 CHAIRPERSON PRESSLEY: Well, let's hold off on that
- 3 because I believe maybe the next few public commenters
- 4 have likewise grievances. And so that way you can be
- 5 comprehensive in your response.
- 6 MR. BROWN: Ms. Lydia Maciel, followed by Josh Media.
- 7 MS. MACIEL: Good evening, everyone.
- 8 CHAIRPERSON PRESSLEY: Good evening.
- 9 MS. MACIEL: I actually wasn't going to speak because
- 10 there was somebody here that said that we're going to be
- 11 here, but they're not. And I decided to speak because I
- 12 see my community here with me as well. And I think it's
- 13 extremely important that you guys hear us when we speak.
- 14 It kind of was a smack in our faces to say that the
- 15 police do a very good job within all of Detroit, because
- 16 that's not true. And we have seen it thousands and
- 17 countless of times how we are treated once we're outside
- 18 of the beautification of Detroit. I also want to address
- 19 that there are officers who did assault me, never
- 20 arrested me, but assaulted me. I have my scratches on my
- 21 side, my bruises, and I still have a sore bruise and a
- 22 bump on my arm from holding me down. I also want to
- 23 address that Officer 1154 must, but I mean, must be
- 24 investigated.
- 25 There were officers there that didn't have a badge.



- 1 And he told me, he told me, "I have 300 complaints
- 2 against me, one won't be more" When I went to the 4th
- 3 Precinct, and I decided to make my reports, I was greeted
- 4 very nasty, and I even have it recorded. He decided to
- 5 take his body cam and record me as if the cameras inside
- 6 the Precinct weren't enough. That didn't intimidate me.
- 7 Nothing intimidates me because Detroit built me. And I
- 8 want the very best for my community and for my officers
- 9 as well. My uncle is an officer. I helped him study. I'm
- 10 very proud of my uncle. But what I don't agree with is
- 11 the nastiness that a lot of these officers have. And a
- 12 lot of these officers who are chiefs do not see it, they
- 13 don't. They want to protect them. And I understand it's
- 14 their blue color code. When I was in the truck, I asked
- 15 him, can you buckle me? Because I was having a panic
- 16 attack in the back of the truck, and I hit my head going
- 17 back and forth. I was ignored completely, besides one who
- 18 decided to open his mouth. I have a recording. When I was
- 19 in the back of the truck, he was talking smack with me. I
- 20 was...
- 21 CHAIRPERSON PRESSLEY: Sorry that's your time. But I
- 22 do want to point your attention. I'm having a hard time
- 23 seeing with the lights. A supervising investigator is
- 24 back there with her hand raised, can you see her?
- 25 Alright, so if you can go to her. So again, we do have



- 1 our limitations as commissioners but some of the
- 2 allegations you made is the responsibility of our Office
- 3 of Chief investigator to investigate matters of demeanor
- 4 and force, which I heard in your comments. And so if you
- 5 don't mind if you can share that information with our
- 6 chief investigator, we will indeed do a thorough
- 7 investigation on your behalf.
- 8 MS. MACIEL: And it's much deeper than an
- 9 investigation.
- 10 CHAIRPERSON PRESSLEY: Yep. I hear that. I definitely
- 11 hear that.
- MR. BROWN: Josh Media, followed by Armando Perez,
- 13 followed by Miss Lory Parks.
- MR. MEDIA: Like, you all know how to celebrate
- 15 yourselves. I mean, I'm here for a whole hour, awards for
- 16 this, award for that. But there seems to be a disconnect
- 17 between what the community members are coming up here and
- 18 saying, and how you guys are talking about yourselves.
- 19 There's a disconnect between how you enforced the law at
- 20 the Draft and how you came to our community, realize our
- 21 community members during a celebration of our heritage
- 22 during, and our day.
- I want to know why that is. Help me understand why
- 24 that is. Why you were brutalizing my community members,
- 25 why you were dispersing our celebration. Was there a



- 1 problem? Was there a danger? Why is there such a
- 2 juxtaposition between how you guys were behaving there
- 3 and at the Draft. I didn't see any of that in the Draft.
- 4 There were 2 arrests, right, in the shoe. So please help
- 5 me to understand why you feel the need to come to a
- 6 Latino community, a black and brown community, and treat
- 7 us like that. Help me understand that. Another thing I
- 8 want you to educate me on is civilian oversight and
- 9 accountability. Help me understand what kind of direct
- 10 measures the community has on you guys to help you guys
- 11 serve us, right? What accountability measures and what
- 12 power does the community have to dictate what you're
- 13 going to enforce and your police policy. So if you could
- 14 answer those two questions, I would very much appreciate
- 15 that. Thank you.
- 16 CHAIRPERSON PRESSLEY: Thank you.
- 17 MR. BROWN: Armando.
- 18 CHAIRPERSON PRESSLEY: So I mean, to answer the first
- 19 part of your question, this is an 11 member board, where
- 20 7 of our members are elected. And so that's your first
- 21 level of accountability, is, you know, paying attention
- 22 to who's representing you, and you have the right to vote
- 23 for who you think best represents you. And then also
- 24 there are always openings and opportunities for you to
- 25 participate. And so, as you talked about policies, the



- 1 Chair of our Policy Committee, Commissioner Linda
- 2 Bernard, you can intend those meetings. You can give
- 3 suggestions on policies that we're reviewing. You can
- 4 provide feedback on whether or not you feel like those
- 5 are accurately representing the community needs. But
- 6 those are primarily the two ways that you'll be able to
- 7 engage with the civilian oversight board in holding us
- 8 accountable as it relates to what it is that you're
- 9 desiring to see in your community. Go right ahead, sir.
- 10 MR. PEREZ: Thank you. I, like my peers, wasn't going
- 11 to speak, but I'm going to just tell my story. So you
- 12 have just another perspective. Born and raised in
- 13 Detroit. Love my city. I think overall you guys do a good
- 14 job, but then there are moments like Sunday Cinco de
- 15 Mayo. That just doesn't make sense. Very little
- 16 explanation, very little communication, frustration from
- 17 everybody because we are just enjoying our holiday like
- 18 we do every year. And then you have cops that are
- 19 disrespectful, and are the aggressors for no reason. They
- 20 don't even communicate. They don't talk to you as they
- 21 should if you are just a civilian. And the thing that
- 22 triggered me was, there's a shooting on Michigan and
- 23 33rd. And so you would've think all of the Precinct, all
- 24 of the cops are just on Vernor to stop my people from
- 25 enjoying the day, and instead deal with the issues that



- 1 are happening on Michigan, deal with the actual problems
- 2 that are going on in the city instead of taking down an
- 3 event where we're just trying to enjoy.
- 4 There were more people last year than there were
- 5 this year, but they were saying that there were capacity
- 6 issues. None of it makes sense. My home girl here, she
- 7 got hurt. My one friend, he got arrested me. I almost got
- 8 arrested just by stating my piece, saying my voice,
- 9 what's the problem? Why don't you go take your attention
- 10 where it belongs? And so we get taken down. Half of us
- 11 have to leave the other half not knowing how to get home.
- 12 He said, grow up and figure it out. That's what we're
- 13 trying to do. But that's my piece. That's my 2 cents.
- 14 CHAIRPERSON PRESSLEY: Thank you.
- MR. BROWN: Mr. Parks.
- 16 CHAIRPERSON PRESSLEY: And again, I don't want you to
- 17 think that we are not being responsive. There are two
- 18 things that I do want to make clear. That, again, as the
- 19 Board of Police Commissioners, we are the Civilian
- 20 Oversight Board. We don't speak for the police
- 21 department. But again, I will provide DC Pritchett an
- 22 opportunity to respond to many of the grievances that
- 23 have been lifted. I just wanted to get them all so that
- 24 she can be comprehensive in her response. Our next public
- 25 commenter.



- 1 MR. BROWN: Ms. Parks, followed by Mr. Ronald Foster,
- 2 followed by Ms. Cynthia West.
- 3 MS. PARKS: Good evening.
- 4 CHAIRPERSON PRESSLEY: Good evening.
- 5 MS. PARKS: Last week, Attorney Hawkins was
- 6 interviewed by the board who is qualified to be the
- 7 Acting of the board. Did you guys get a legal opinion on
- 8 whether or not Attorney Hawkins can be the Acting of the
- 9 board? That's one question. My next question is, how many
- 10 of you board of Police Commissioners are appointed by
- 11 Duggan? The next one is the community still wants to know
- 12 where or when you will have the complaints or the
- 13 citations that were given to you, maybe a year or two ago
- 14 for the officers who were called the booty boys. These
- 15 officers were going around the City of Detroit doing body
- 16 cavity searches without any warrants or anything. So
- 17 that's another question. And I know you guys know that he
- 18 was also the chief of police, chief of staff, the number
- 19 one booty boys. Citizens and District Council for several
- 20 of them across the city, and several across the city. I
- 21 would like to all come to the Board of Police
- 22 Commissioners meeting, but a lot of people in the
- 23 community don't attend when they are at the headquarters.
- 24 Why? Because a lot of people are intimidated by going to
- 25 the headquarters to tell all the police about what



- 1 happened to them in the communities. That's another one.
- 2 Last of all, do you guys know why the Board of Police
- 3 Commissioners was created in this city? I don't know
- 4 about any other city, but I can tell you about this city.
- 5 And if you don't know, you need to read up on why Coleman
- 6 Young had this Board of Police Commissioners created. If
- 7 you don't know, none of the Board of Police Commissioners
- 8 should be police officers.
- 9 CHAIRPERSON PRESSLEY: Thank you.
- 10 MS. PARKS: Thank you.
- 11 CHAIRPERSON PRESSLEY: That's your time. And again,
- 12 yes, we did get a legal opinion relative to the potential
- 13 candidate for the Board of Police Commissioners
- 14 secretary's position. Four commissioners are appointed by
- 15 the mayor, unless there's an elected member who vacates
- 16 their position, then the mayor has the opportunity also
- 17 to appoint them in duration. And if you have the citizen
- 18 complaint number for those officers you were referring to
- 19 we can get a status update on that. Go right ahead. I'm
- 20 sorry.
- 21 COMMISSIONER WOODS: It's like a criminal matter as
- 22 well, but you need to check with the Wayne County
- 23 Prosecutor on that.
- 24 CHAIRPERSON PRESSLEY: Yeah. But again, if her
- 25 statement is accurate, and I don't have any belief that



- 1 it is not, that a citizen complaint was filed, I think
- 2 her question was where we are on that investigation. So
- 3 whatever that can be. Yeah, we'll give her that update.
- 4 Go right ahead.
- 5 MR. FOSTER: Good evening.
- 6 CHAIRPERSON PRESSLEY: Good evening.
- 7 MR. FOSTER: Through the Chair. First thing I wanted
- 8 to say is I just stand in support with our District 6
- 9 community. I will firmly say that bigotry, under any
- 10 circumstances, should not be allowed within the city.
- 11 Secondly, if we listen to the community, one of the
- 12 things they highlighted is, they don't believe that the
- 13 higher command knows what goes on. So I think it'd be
- 14 beneficial if we acknowledge that we have potential
- 15 problems within a rank and file, and then we can start
- 16 working on policies to address those things. But we have
- 17 to acknowledge the damage that has been done or potential
- 18 damage that has been done to our community members.
- 19 Thirdly, across our city, I'm here to advocate for black
- 20 men to be held accountable for their role in our
- 21 community and society. It is not the government's job to
- 22 feed our children. It's not the government's job to
- 23 protect our grandparents. It's not the government's job
- 24 to do any of these things.
- It's the black man's job to protect this family and



- 1 do that. And it's been too long that we have not held the
- 2 black man accountable in this role within our society. We
- 3 go straight to the police and we do all these other
- 4 things. We as black men, have to stand up and take our
- 5 responsibilities, let down your shame, do what you have
- 6 to do, and contribute within our communities and uplift
- 7 thoroughly. I appreciate the work of ceasefire. They
- 8 stand out, obviously different from the other
- 9 organizations with character and a lot of other things.
- 10 So I do appreciate the work that they do. A couple of
- 11 people that I see in the community events all the time, I
- 12 see Commissioner Moore at all the community events. I see
- 13 the commander here at all of the community events, which
- 14 is accessible to us as citizens. So I do appreciate that.
- 15 I got a lot more to say, but I have previously advocated
- 16 for active recruitment in District six, and that was last
- 17 year sometime. If we are in our community, then a lot of
- 18 times we are in a better place to prevent things from
- 19 happening. Thank you all.
- MR. BROWN: Ms. West.
- MS. WEST: Good evening. My name is Cynthia Kylian
- 22 Marie West, and I would like to speak about the events of
- 23 Cinco de Mayo. I have some, some statements from the
- 24 community that I think are very important. What
- 25 protection were the police providing when they shut down



- 1 multiple Latino owned businesses in Southwest Detroit on
- 2 Cinco de Mayo, taco trucks, Fiesta vibes at El Club
- 3 shutting down burner. Multiple people couldn't get home
- 4 and had to park their cars and walk around. Multiple
- 5 businesses missed out on income revenue on a day the
- 6 community had been planning for. Artists came together to
- 7 celebrate a day of pride with our community, and they
- 8 closed everything down with no threat present. It's hard
- 9 for our people and for the community to say that this
- 10 wasn't racially motivated or that this wasn't done with
- 11 prejudice. My question is, how many protests, how many
- 12 posts, how many riots will it take before we actually
- 13 feel like we are heard and we are seen and we are
- 14 protected? There's only so much a person can take before
- 15 they feel they have to take matters into their own hands.
- 16 So when will we actually be seen and heard and to feel
- 17 safe? An incident that happened in Southwest Detroit
- 18 would not be going on in Sterling Heights, would not be
- 19 going on in Royal Oak, and would not be happening in
- 20 Birmingham. When do we as Detroit residents actually get
- 21 to feel that piece of security? And that's it for me.
- 22 CHAIRPERSON PRESSLEY: Thank you.
- MR. BROWN: Mr. Chair, your next speaker will be
- 24 Minister Bey. While he's coming up, I got two late cards,
- 25 okay?

- 1 CHAIRPERSON PRESSLEY: Yes.
- MR. BROWN: Minister Bey, followed by Julia 2
- Fernandez, followed by Emilio Fernandez. 3
- MINISTER BEY: Good evening. 4
- 5 CHAIRPERSON PRESSLEY: Good evening.
- MINISTER BEY: To the board here. I see we have a 6
- major problem out there. And I would suggest, why don't 7
- 8 you all go out there and have a meeting with the people.
- Be transparent, let them know we are here for you and
- hear those complaints. That will be something that will 10
- be monumental just to do that alone, so you could add. 11
- 12 But I had a couple of concerns or questions. Is marijuana
- 13 still considered a drug? I just wanted to know, is it
- 14 still considered a drug on the federal level?
- 15 COMMISSIONER BERNARD: What?
- 16 MINISTER BEY: Is it? I just want to know. Is it not
- 17 still considered a drug on the federal level? Is it
- considered a drug on the... 18
- 19 CHAIRPERSON PRESSLEY: Yes.
- MINISTER BEY: Okay. That's why I wanted to know. 20
- 21 Okay. So I wanted to get that out the way because we have
- 22 problems with our youth in the community, period. Let's
- 23 take that gateway drug along with other things that we
- 2.4 need to address. I hear a lot of statistics up here. I
- 25 don't know what they are talking about. This is down 7,



- 1 that's up 9. Give me some base numbers. What do we have?
- 2 A hundred, now we are down to 77. Let's come with base
- 3 numbers, because people can always blame you with
- 4 statistics. Some people may not speak on it. I'm speaking
- 5 on it because I'm hearing it's up 3.2, it's down 6.1, but
- 6 we're not at a jockey race or auction or something like
- 7 that. Talk to the people you know, in plain language.
- 8 Now, I heard this...
- 9 CHAIRPERSON PRESSLEY: DC Pritchett.
- 10 MINISTER BEY: Pardon me, DC Pritchett giving us all
- 11 these statistics. I hear it all the time, people like
- 12 they really know. How many of you all are here really
- 13 know about those statistics. How many of you all really
- 14 know what it is saying? There you go. How many of you all
- 15 would like to know what it's saying when they're saying
- 16 all these 7, 2, 3. Give us the number, then we can really
- 17 see what's going on in our committee and our community. I
- 18 appreciate that. We had something going on over here with
- 19 the inspectors they hired. You say you hired some more
- 20 inspectors.
- 21 CHAIRPERSON PRESSLEY: Investigators. Yeah,
- 22 MINISTER BEY: Investigators. But now you said
- 23 something about it, you can get through the job quicker
- 24 because they are doing what, what did you say they were
- 25 doing? You told me they were doing something.



- 1 CI WARFIELD: Through the Chair. What we're doing,
- 2 we're doing several things. One of the things we're doing
- 3 is that we automated our reports. That...
- 4 MINISTER BEY: What does that mean?
- 5 CI WARFIELD: That literally means that the report
- 6 now, it takes about an hour and a half...
- 7 MINISTER BEY: Just tell me what it means, sir. It
- 8 means you can speak to it ...
- 9 CHAIRPERSON PRESSLEY: So your time is expired, but
- 10 I'll allow him to respond to you.
- 11 MINISTER BEY: The only reason why I'm asking that is
- 12 because I called in for the job. They told me you had to
- 13 be a typist and you had to type so fast. I said, we're in
- 14 an animated age right now where we could just speak to
- 15 texts and it'll put it on the paper. They say they didn't
- 16 want to spend the money.
- 17 CHAIRPERSON PRESSLEY: Yeah. Duly noted. But again...
- 18 MINISTER BEY: So now we are doing it.
- 19 CHAIRPERSON PRESSLEY: Your time has elapsed so...
- MINISTER BEY: Oh, oh, oh, okay.
- 21 CHAIRPERSON PRESSLEY: To be fair to the other public
- 22 commenters, but we...
- 23 MINISTER BEY: I want to address those concerns.
- 24 CHAIRPERSON PRESSLEY: Yeah. Got you.
- 25 MINISTER BEY: I want somebody to speak on, just like



- 1 you spoke on some of that.
- 2 CHAIRPERSON PRESSLEY: I got you. Yep, indeed. Yep.
- 3 And there are some standardized practices that go into
- 4 hiring that's even beyond our office, that's done by the
- 5 city's HR process. And so that's, you know, a part of the
- 6 parcel about how we hire investigators. But, you know,
- 7 there could be a conversation had regarding that. And
- 8 thank you. I mean, again we don't want to just be here to
- 9 be here particularly since we are volunteers. We want to
- 10 be effective. And so to your recommendation about using
- 11 the base numbers over the percentages can help the
- 12 information to be more accessible to our communities. And
- 13 so we'll take that to heart. Yeah. Yes, ma'am.
- 14 MS. FERNANDEZ: My name is Julie Fernandez. I'm a
- 15 Mexican American girl. I'm 21 years old. So for, as you
- 16 know, a lot of small owned businesses were shut down by
- 17 the Detroit Police just raiding in like the military,
- 18 telling us that we didn't have permits overhearing them
- 19 that were illegals. I just think that was honestly a very
- 20 racist crime that I experienced. I honestly never thought
- 21 I would experience that with my life. I was actually one
- 22 of the artists at a club.
- There were also 40 artists, probably more that were
- 24 going to perform at a club. Everything just went downhill
- 25 when the police just came in, and just told us a whole



- 1 lot of racist stuff. And after I was done with my show,
- 2 and went outside to get some food with my brother,
- 3 actually. And as I went outside, that's when I saw Lydia.
- 4 She was speaking right now, detained by 4 police officer
- 5 guys against one woman. I have never seen that in my
- 6 life. I never thought I would. I really think that is
- 7 social injustice right there.
- 8 Then I went outside, police officers were just
- 9 blocking roads. They were just blocking roads. This is
- 10 from what I heard, they were knocking on people's doors
- 11 trying to shut down small Latino owned businesses. This
- 12 is a holiday that we celebrate every year. I'm
- 13 celebrating my culture. And if I can do that within my
- 14 community, then I honestly don't feel welcome here. I was
- 15 born and raised here. This is my home. Thank you.
- 16 CHAIRPERSON PRESSLEY: Thank you.
- 17 MR. BROWN: Mr. Emilio Fernandez.
- 18 MR. FERNANDEZ: One concern I do have with the
- 19 Detroit Police Department is its use in collaboration
- 20 with surveillance technology, especially with one called,
- 21 let's see what it's called. It's one formerly known as a
- 22 ShotSpotter, now known as a, let's see what's it called?
- 23 Yeah. Now it's known as Sound Thinking. It's a
- 24 surveillance technology that is also being used in
- 25 collaboration with other surveillance technology, like



- 1 also in countries like in Israel as well that uses this
- 2 technology to like unlawfully detained Palestinian in the
- 3 West Bank. And the same technology used in poor black and
- 4 brown neighborhoods in Detroit. I just asked, like for
- 5 the Detroit police department to cut ties with the Sound
- 6 Thinking Corporation, to no longer collaborate with them,
- 7 and to immediately end its program. And that's my main
- 8 concern about that. And is funding still is... are you guys
- 9 still collaborating with the Sound Thinking Corporation
- 10 with the formerly known as ShotSpotter?
- 11 CHAIRPERSON PRESSLEY: Are you asking, do we still
- 12 use ShotSpotter technology?
- 13 MR. FERNANDEZ: Yeah.
- 14 CHAIRPERSON PRESSLEY: Yes, we do.
- MR. FERNANDEZ: Yeah. Just the real concern,
- 16 basically, I have major concerns with that technology as
- 17 it's already been used to unlawfully detain 6 Detroit
- 18 residents as well too. And it's used at that technology
- 19 is also used by an illegal apartheid regime as well too.
- 20 And this kind of technology should not be operated inside
- 21 the city.
- 22 CHAIRPERSON PRESSLEY: Thank you.
- MR. BROWN: Mr. Chair, your next set of speakers will
- 24 be on Zoom Mr. Meeko Williams, followed by Ms. Betty
- 25 Varner. Mr. Williams.

- 1 MR. WILLIAMS: Yes. Hi. Can you hear me?
- 2 CHAIRPERSON PRESSLEY: Yes, we can. Go right ahead.
- 3 MR. WILLIAMS: Yes. Hi. I would like to know if this
- 4 question can be responded to. What is the qualification
- 5 and the professional resume of the secretary? I'm really
- 6 confused as to how you all are doing this process. Can
- 7 you please lay that out for me, clearly? Also, I want to
- 8 give my statement of concern about the Mexican town raid
- 9 by Detroit Police. This is a 55% white police force that
- 10 was barely out. That is very much misrepresentation. They
- 11 also shut down some of the businesses that were unlawful
- 12 because I'm sure that events had permits and licensing
- 13 that have been held up by the city. All of the events are
- 14 basically held up because of city dysfunction. That is
- 15 unacceptable. And you should apologize to all of those
- 16 people and release those that you've arrested with no
- 17 fines. It is unacceptable for this police department to
- 18 really come to the Gestapo. That is Gestapo panic. It's
- 19 unacceptable, and it shouldn't be tolerated because you
- 20 made those people feel in their own community. It is
- 21 almost as bad as the ice raid. Thank you for taking my
- 22 comment. Please answer my question from before. What is
- 23 the qualification of this board secretary? Please lay it
- 24 out for me, Mr. Chairman. Thank you.
- 25 CHAIRPERSON PRESSLEY: Right, and so my response to



- 1 that would be that the responsibilities of the board
- 2 secretary is enumerated in our city's charter, but as it
- 3 relates to the responsibilities as we are now under
- 4 deliberations about hiring a board secretary is under
- 5 review. So we're trying to get a description that is more
- 6 accurate to the role. Our challenge has been that because
- 7 it's called the secretary to the board most believed that
- 8 it's a clerical role. However, the secretary to the board
- 9 is more like an executive director. Not only do they
- 10 serve as the liaison between the Board of Police
- 11 Commissioners and our Office of the Chief Investigator,
- 12 but they also serve as a liaison between the Board of
- 13 Police Commissioners and the Detroit Police Department
- 14 overseeing a substantial amount of staff committee
- 15 structures and the like. And so we're hoping to again
- 16 rewrite the job posting so that it can be more accurate
- 17 to what the role of the board secretary is. But as it is
- 18 stated in the City Charter you can find the
- 19 responsibilities of the board secretary.
- 20 MR. BROWN: Ms. Varner.
- 21 MS. VARNER: Good evening to all within the sound of
- 22 my voice. I'm Betty A. Varner, the president of the
- 23 DeSoda Ellsworth Block Association. I first wanted to
- 24 start off by saying congrats to the Detroit Police
- 25 Department for the successful work they did for the NFL.



- 1 In regards to the issues for the event with the parade
- 2 and the community in Southwest Detroit, the Detroit
- 3 Police Department needs to work with that community to
- 4 bring some peace so that whatever happens, there needs to
- 5 be some peace so the people will feel comfortable in
- 6 having events in their community. And I'm in support of
- 7 my police department, but this is my opinion and what I
- 8 feel. Congrats to the work that the 8th Precinct is doing
- 9 in their community. I'm going to talk about my 10th
- 10 Precinct. I want to talk about and brag about our NPOs
- 11 Officer Sumpter, Officer Parker, Officer Barry, Officer
- 12 Rogers and Officer Barber.
- 13 My direct NPO is Officer Sumter. Whatever I need,
- 14 she steps up to the plate and helps me to get our issues
- 15 resolved. But if she is not available, which is what I
- 16 like about our NPOs, any one of the ones that I listed
- 17 will step up and make sure the problem is resolved. Kudos
- 18 to our NPOs. I also want to say we are participating in
- 19 Feed the Police this week? We are feeding our 10th
- 20 Precinct on Friday, May 17th. We're going to be feeding
- 21 all shifts. That's 12000 Livernois. If you'd like to
- 22 donate, please bring your food, good food to our
- 23 Precinct, Livernois and Amherst. And last but not least,
- 24 I want to say kudos to my Police Commissioner Ricardo
- 25 Moore. He is so on point...



- 1 MR. BROWN: Mr. Chairman, the last 2 speakers will
- 2 be, One of the Coldest, followed by former Commissioner
- 3 William Davis.
- 4 CHAIRPERSON PRESSLEY: Caller, are you there?
- 5 ONE OF THE COLDEST: Can you hear me clearly?
- 6 CHAIRPERSON PRESSLEY: Yes, go right ahead.
- 7 ONE OF THE COLDEST: Okay. To all the police
- 8 officers, sworn officers in presence right now. To the
- 9 Hispanic brothers and sisters there, police, you took an
- 10 oath to protect and serve the citizens of the City of
- 11 Detroit. The oath you took, you gave your word when you
- 12 gave that oath, uphold it. Commissioner Bernard,
- 13 impressive resume Minister Eric Blount, I've heard you
- 14 numerous times say disparaging things about Commissioner
- 15 Bernard. You are a man of the cloth, man of the clergy,
- 16 and that goes out to all the black Hispanic pastors,
- 17 ministers, bishops in the City of Detroit. The Detroit
- 18 city clerk has been caught blue handed lying on public
- 19 record in regards to an investigative report about
- 20 allegations of absentee ballot voter fraud. We have
- 21 Detroit trap houses here in the City of Detroit. That's
- 22 right. Detroit trap houses. Our regular trap house slangs
- 23 dope. These particular trap houses slangs votes, they
- 24 slang votes are the houses here in the City of Detroit.
- 25 There's no bigger issue than the right to free and fair,



- 1 open, honest elections here in the City of Detroit. Now,
- 2 this report that was proffered by the Department of
- 3 Elections puts the nail in the coffin, clearly
- 4 demonstrates that not only do we have absentee ballot
- 5 voter fraud here, we have international absentee ballot
- 6 voter fraud happening. It occurred in the 2024 United
- 7 States Presidential Primary election from 12842 Sussex
- 8 Street over in District 1, James Tate Junior's District,
- 9 one of the Detroit City...
- 10 MR. BROWN: Former Commissioner Davis.
- 11 FMR. COMMISSIONER DAVIS: Good evening. Can I be
- 12 heard?
- 13 CHAIRPERSON PRESSLEY: Yes, you can go right ahead.
- 14 FMR. COMMISSIONER DAVIS: I'd like to start off by
- 15 saying I believe that the Board of Police Commissioners
- 16 budget should be increased, especially as we find more
- 17 and more police officers on the force of a different
- 18 demographic than what the City of Detroit has, and it
- 19 has continued to evolve with. In 1973, during that
- 20 election, when Coleman Young was elected to the Board of
- 21 Police Commissioners, the City Charter was changed to
- 22 create the Board of Police Commissioners. There were a
- 23 lot of problems in Detroit because the police force was
- 24 predominantly Caucasian, and the city was becoming more
- 25 and more black. Now the city is even more black. And the

- 1 police force that was in balance for a while, it's
- 2 returning back to being more and more white. I know I got
- 3 a lot of complaints about Cinco de Mayo Day and about a
- 4 lot of people in Southwest Detroit.
- 5 I think that the board should have a town hall
- 6 meeting in Southwest Detroit. I think the board should be
- 7 a little bit more proactive, and the board should
- 8 recognize that people feel like they are not being
- 9 treated properly. And maybe something's right and
- 10 something's wrong, you know, and that something needs to
- 11 be done. We need to make sure everybody feels comfortable
- 12 in our city. I know for a fact most of the time when you
- 13 have even more people downtown Detroit at like Tiger
- 14 Opening Gang, where you got a whole lot of white people
- 15 down there drinking you know, drinking, urinating on the
- 16 street, but very few people get arrested. But in
- 17 Southwest Detroit, you have majority Hispanic and
- 18 minority communities where it's not as big of a crowd
- 19 because I've seen big crowds out there, unlike some of
- 20 you I worked in Southwest Detroit for 34 years. So I
- 21 think something needs to be done. Something needs to be
- 22 done to straighten this out. You know, we do not want
- 23 conditions to get worse this summer. Thank you.
- 24 CHAIRPERSON PRESSLEY: Thank you. Alright, DC
- 25 Pritchett.



- 1 DC PRITCHETT: Through the Chair. I have invited the
- 2 4th Precinct Command team who were out there Friday,
- 3 Saturday and Sunday to approach the board and tell the
- 4 board what they did, what they saw, and some of the
- 5 reasons why some of the things happened.
- 6 CHAIRPERSON PRESSLEY: Alright, please come forward.
- 7 CMDR HOLDERBAUM: Good evening, honorable board.
- 8 CHAIRPERSON PRESSLEY: Good evening.
- 9 CMDR HOLDERBAUM: I am Commander Shelley Holderbaum
- 10 of the 4th Precinct. This is Captain Brandon Lewis. Cinco
- 11 de Mayo was a 3 day celebration. This year was a little
- 12 different. Cinco de Mayo fell on the same day as the
- 13 parade. We had over 50,000 people from Vernor to Woodmere
- 14 to Vernor 21st, which is over a 2 mile stretch. The
- 15 parade lasted 3 hours and ended at 3:00 PM, and that is
- 16 when the extended celebration started. 8 people were
- 17 ticketed and released. There were no arrests. Nobody went
- 18 to the DDC. No Baber (phonetic)incidents were on Vernor.
- 19 We closed down a non-permanent outside illegal event at
- 20 El Club. It had a wrestling ring in it, a stage and two
- 21 food locations would diminish the actual capacity of the
- 22 location. I did receive an email from the city that was
- 23 not permanent, it was an illegal event. We also shut down
- 24 a non-permanent mechanical bull stage. A lot of people
- 25 towards the end in the evening hours, a lot of public



- 1 drinking, marijuana smoking, loitering, and we attempted
- 2 to move the crowds and attempted to clear the streets so
- 3 we could open them up and make it safe for the public. It
- 4 did become a public safety issue. We have room for
- 5 improvement and we will be working with the businesses
- 6 and the communities next year to make sure that it's a
- 7 safe event for everybody.
- 8 CHAIRPERSON PRESSLEY: Alright. I'm going to ask that
- 9 the public commenters, please maintain your decorum. Are
- 10 there any questions or comments for commissioners
- 11 relative to that report? Excuse me. Again, public
- 12 commenters. I'm going to ask that you would do your best
- 13 to maintain your decorum. My question is, you know, I
- 14 think you stated the fact that the parade and the Cinco
- 15 de Mayo observance fell on the same day. But I mean, this
- 16 celebration has been going on for years. What made this
- 17 year different?
- 18 CMDR. HOLDERBAUM: I think sir, that the difference
- 19 was Cinco de Mayo will happen and we get folks from all
- 20 over and outside in the suburbs, and everybody comes in
- 21 on May 5th. And generally then the parade is on a Sunday.
- 22 The parade is always on a Sunday. This time, the parade
- 23 and Cinco de Mayo fell on the exact same day. So it
- 24 brought in a lot more people. We had well over 50,000
- 25 people. And just from the perspective of me and Captain,



- 1 on Friday and Saturday, we did get a lot of calls and
- 2 complaints from actual legal businesses and folks who,
- 3 you know, have their businesses and it is a big event for
- 4 them. And then folks coming up and setting up illegal
- 5 vending places and selling the same things that they were
- 6 selling. So we did have a city license person with the
- 7 officers, so we did shut down illegal vending people who
- 8 did not have their permits to do that on Friday and
- 9 Saturday. And the 2 events that we shut down on Sunday,
- 10 one of them was El Club, we shut the outside event down,
- 11 but we did not shut the club down.
- 12 CHAIRPERSON PRESSLEY: And I can imagine again,
- 13 public commenter's community, I'm going to ask again,
- 14 that you maintain your decorum? So 2 things in that, one,
- 15 and I think that you mentioned it, you know, obviously it
- 16 doesn't resolve the harms that have already been done,
- 17 but to be more proactive next year, because again, when
- 18 it came to the NFL Draft or the fireworks or any of these
- 19 other events, we can predict the population that's going
- 20 to be out there. And as a result, there are plans and
- 21 measures that are often put in place prior to so that any
- 22 police intervention is not taking them off guard or
- 23 surprising. It seems as if this one may have caught us
- 24 off quard.
- 25 Is it?



- 1 CMDR. HOLDERBAUM: Well, I don't think so, sir. I
- 2 think we had more than enough officers. I and the captain
- 3 were out there from 8:00 AM to midnight. And the
- 4 celebration didn't stop. It went on to all hours of the
- 5 night. Unfortunately, I could not open the streets up.
- 6 That's how many pedestrians we had. The streets were
- 7 full, and so we couldn't open up for vehicular traffic.
- 8 On Monday, I myself, with the captain, requested a
- 9 meeting that we had today with the event coordinator
- 10 because we want to do better. We want to work with the
- 11 community. We don't want to have to shut things down, but
- 12 there are laws and there are rules. And as the police,
- 13 that's what we have to do. We have to enforce the law.
- 14 CHAIRPERSON PRESSLEY: And then obviously there has
- 15 to be some level of repair and reconciliation, because as
- 16 you stated that you didn't shut down the event on the
- 17 inside, but I can imagine with the kind of police
- 18 presence that was there, there may have been some level
- 19 of intimidation that might have caused people to disperse
- 20 regardless of whether or not the inside was still open.
- 21 And so again, repairing that sense of trust and
- 22 relationship in that community, I think is going to be
- 23 paramount to again, moving forward. Commissioner Woods.
- 24 COMMISSIONER WOODS: Yeah. How you doing, Commander,
- 25 right?

- 1 CMDR. HOLDERBAUM: Yes, sir.
- 2 COMMISSIONER WOODS: Is it possible that you guys can
- 3 engage... I lost my voice... to engage with this particular
- 4 community, to have a conversation with them to see if
- 5 there can be some mediation with the situation?
- 6 CMDR. HOLDERBAUM: There's a meeting tomorrow at 4
- 7 o'clock that I know they've already mentioned, that I
- 8 will be present, along with Councilwoman Santiago Romero.
- 9 And you know, sir, just so you know, I lived in this
- 10 community for a long time. My children went to school in
- 11 the Catholic schools here. I've always worked for 26
- 12 years, DPD. Coming to Southwest Detroit was a dream job
- 13 for me because yeah, [foreign phrase]. But definitely yes
- 14 sir, we're going to work with them. I feel like this is
- 15 my family, you know, my children are Mexican American
- 16 and...
- 17 CHAIRPERSON PRESSLEY: Excuse me. Again, I ask the
- 18 public commenters, please maintain your decorum. Thank
- 19 you.
- 20 COMMISSIONER WOODS: Did you guys identify anything
- 21 that was alarming to you guys, as far as officers wise?
- 22 CMDR. HOLDERBAUM: I and the captain have been
- 23 watching the body cameras. You know, it's hard because
- 24 all officers are wearing their body cameras and mics.
- 25 Because it was such a long event, it takes a minute for



- 1 them to download. But we have been watching.
- 2 COMMISSIONER WOODS: And so you guys are taking a
- 3 deep dive into the situation, and are going to deal with
- 4 any bad actors if you identify though.
- 5 CMDR. HOLDERBAUM: Absolutely, sir.
- 6 COMMISSIONER WOODS: Okay. Thank you.
- 7 CHAIRPERSON PRESSLEY: Any further...? Commissioner
- 8 Moore?
- 9 COMMISSIONER MOORE: Yes. I don't have a question for
- 10 the captain and commander. More so for our chief
- 11 investigator. During public comment, the badge number
- 12 1154 came up. Can you look into that and share with the
- 13 board what your findings are?
- 14 CI WARFIELD: Yes, sir.
- 15 CMDR. HOLDERBAUM: I'm pretty sure the young lady did
- 16 file a complaint at the Precinct, and it was taken by the
- 17 watch commander on the desk. Well, we'll get
- 18 Back...
- 19 CHAIRPERSON PRESSLEY: But then, and I think I'll
- 20 make a connection here tonight. And any comment that is
- 21 made during public comment is a matter of public record
- 22 and we make CCRs based on that as well. So I'm confident
- 23 that it has been recorded, and if not, we'll ensure that
- 24 it has been. Any further questions or comments? I don't
- 25 know how we'll do this. I mean that meeting tomorrow at 4



- 1 o'clock, if we can get an investigator there somehow so
- 2 that whatever might be mentioned, if there are some
- 3 complaints, some allegations of misconduct that are
- 4 lifted, we can follow up on that as our role and
- 5 responsibility in this affair. Yes.
- 6 COMMISSIONER BERNARD: Mr. Chairman, because the
- 7 community is tremendously actively involved in this
- 8 meeting this evening, I've asked our Acting Board
- 9 Secretary, Mr. Brown, to provide me a copy of the written
- 10 testimony, if you will, of everyone that's spoken today
- 11 during public comment. And I'm sure he will share that
- 12 with the rest of the board so that we can follow up
- 13 appropriately. Thank you for your patience with us.
- 14 CHAIRPERSON PRESSLEY: Vice Chair Smith.
- 15 VICE CHAIR SMITH: Yes, through the Chair, and just
- 16 to reiterate with the ones that complained today, the
- 17 proper process for them to make their complaint is not
- 18 through the police department, but the proper channels.
- 19 Could you please explain that to them again please?
- 20 CHAIRPERSON PRESSLEY: Yep. Chief investigator, what
- 21 ways can individuals file CCRs
- 22 CI WARFIELD: Through the Chair.
- 23 COMMISSIONER BERNARD: A civilian complaint.
- 24 CHAIRPERSON PRESSLEY: A citizen complaint report?
- 25 CI WARFIELD: Thank you. Through the Chair. There are



- 1 several ways that citizens can do that. Our number at the
- 2 Office of the Chief Investigator is area code (313) 596
- 3 2499. Again, (313) 596 2499. You also can file a
- 4 complaint right online on the Board of Police
- 5 Commissioners online page, and you can go right on there
- 6 and file the complaint there. You can also fax that
- 7 comment in, as well as you can email it to us as well.
- 8 And we did give out several brochures tonight for members
- 9 who had spoken during public comment. We already have
- 10 received some complaints in our office concerning the
- 11 Cinco de Mayo event, and some of the complaints regarding
- 12 how officers interfaced with some of the citizens. So our
- 13 investigators are well aware of some of the concerns of
- 14 the citizens.
- 15 CHAIRPERSON PRESSLEY: Commissioner Hernandez.
- 16 COMMISSIONER HERNANDEZ: Thank you. Through the
- 17 Chair. I'll be entirely brief and I think there are still
- 18 facts that need to be submitted and I look forward to
- 19 every resident who feels unsafe that they have a
- 20 platform; they feel they have a platform to actually be
- 21 able to file those complaints independent of, of what
- 22 that process might look like. I think my colleagues have
- 23 expressed the need for repair to occur. I think there's
- 24 always going to be ongoing relational buildup that needs
- 25 to happen. The job that Commander Shelly Holderbaum and



- 1 her team are leading at the 4th Precinct is not an easy
- 2 one. I will say though, as a lifelong resident of
- 3 Southwest Detroit more needs to be done in the sense of
- 4 just bringing people together. It's not just the fact of
- 5 submitting a complaint, it's the fact of the follow-up
- 6 work that needs to happen, that responsibility falls on
- 7 this board. And I think that our team has been doing good
- 8 work. And it's not to put anyone on the spot, including
- 9 our chief investigator, but there needs to be additional
- 10 format, and I think the gentleman who was here, who
- 11 stated before, there needs to be statistics that are
- 12 digestible by the community so that we know that
- 13 improvement is being made and that oversight is properly
- 14 being delivered. So with that, I know that I've been in
- 15 communication with Commander Holderbaum every single step
- 16 of the way. She's been very cooperative. And with that,
- 17 I'll withhold any additional comments until I know more
- 18 of the facts that are happening and I look forward to
- 19 seeing and reviewing the body worn camera personally. And
- 20 I know that you've always been helpful. So I appreciate
- 21 the work that you're doing. I also appreciate all the
- 22 residents that have come out, and I actually anticipated
- 23 and hoped for more residents to be here from Southwest
- 24 Detroit. I know that it's a little bit of a drive, but
- 25 either way, I appreciate you for showing up.



- 1 CHAIRPERSON PRESSLEY: Alright. Thank you. With that,
- 2 now we will move to the presentation to the board by the
- 3 8th Precinct Police Community Relations Council. So we
- 4 invite you to come forward now.
- 5 MS. TUBBS: I'm going to make this brief because
- 6 we've been here for a minute.
- 7 CHAIRPERSON PRESSLEY: Yes.
- 8 MS. TUBBS: I will say this, and I'm going to start
- 9 with this, and I'm going to do my welcome. And I'm going
- 10 to make sure you know, I'm a cheerleader for the 8th
- 11 Precinct. So, disclaimer, I'm a fan. Are we perfect? No.
- 12 Are we individually perfect? No. So, having said that,
- 13 I'm going to make this as short as I can, but I would
- 14 like to say a prayer of protection and a prayer of
- 15 healing for what occurred on Cinco de Mayo or for any
- 16 transgressions that you all may think have happened in
- 17 your past. It's always, get a sprinkling of healing,
- 18 protection, and know that you are valuable, you are
- 19 appreciated. We are all children of God. We are daughters
- 20 of a king. We are sons of a king. At the same time, we
- 21 all have to act like we are daughters of a king, and we
- 22 have to act like we are sons of a king at the same time.
- 23 All right, so let me get at it.
- 24 CHAIRPERSON PRESSLEY: Thank you.
- 25 MS. TUBBS: So I want to do a welcome real quick. I



- 1 want to welcome the Board of Police Commissioners to the
- 2 house of the 8th Precinct, and in our humble opinion, the
- 3 best of the best men and women in Blue. So where's my 8th
- 4 Precinct community? Listen, I'm a little biased, just a
- 5 little bit. We'd like to also acknowledge our
- 6 Commissioner from District 1, Tamara Liberty Smith, and
- 7 also Linda Bernard from District 2. I had the distinct
- 8 pleasure of sitting next to Miss Bernard at the Mayor's
- 9 State of the City address, and it was a pleasure to have
- 10 talked to her. And as far as Commissioner Smith, we are
- 11 out here on these streets constantly. So I know what she
- 12 does, I know what she stands for, and she has a lot of
- 13 passion for the people and doing the right thing at all
- 14 times.
- 15 And a heartfelt shout out to the commissioners over
- 16 the other districts and the staff members that fall under
- 17 you. It's a big task and responsibility. Thank you very
- 18 much for what you do. And again, welcome to the house of
- 19 the 8th Precinct. So, I wanted to say something about our
- 20 board of directors. Now, I have some of them here and
- 21 some of them are not here, so I'm going to go over them
- 22 pretty quickly. Yes, I'm president. My name is Gail
- 23 Tubbs, and yes, I actually hail from Honolulu, Hawaii. So
- 24 I'm going to give everybody one more time, an Aloha!
- 25 COMMISSIONERS: Aloha!



- 1 MS. TUBBS: Aloha means hello, goodbye, and I love
- 2 you all at the same time. One word.
- 3 COMMISSIONER WOODS: Aloha.
- 4 MS. TUBBS: So President, myself, Vice President is
- 5 Michelle Ruffin. She's not here tonight. Treasurer Val
- 6 Lever was the young lady that was here. We have recording
- 7 secretary Keita Walker. Wave to everybody, Keda.
- 8 Correspondence secretary, Harrison Shelby. He wasn't here
- 9 and he was also part of a Resolution. Sergeant at Arms is
- 10 vacant. Members at large, we have Rhonda Mitchell right
- 11 here. Peggy Noble, actually her birthday is today, so
- 12 she's celebrating with her family and Deborah Chapman. So
- 13 the mission I want to say is that this is a newly elected
- 14 board that was elected in November. So we are really
- 15 trying to make sure that we get the team together, get
- 16 the team dynamics together, and make sure we're in one
- 17 accord when it comes to the goal and the mission. So the
- 18 mission of the 8th Precinct Community Relations Council
- 19 is to promote a favorable relationship between the
- 20 community and law enforcement agencies, to initiate and
- 21 participate in educational programs that will enhance the
- 22 security and wellbeing of the community. To act as a
- 23 liaison between law enforcement agencies, citizens,
- 24 churches, business schools, and other civic
- 25 organizations.



- 1 And to disseminate information and to promote and
- 2 initiate programs that are beneficial to the community.
- 3 That's the mission of the council. The purpose, we as a
- 4 board came up with this in our planning meeting in the
- 5 early part of March. And all of us had a hand in these
- 6 pieces that we call the purpose. So our purpose is we are
- 7 committed to growth and to inspire our community with
- 8 vision, respect, exemplifying integrity, while engaging
- 9 with our police department. So that's our main purpose
- 10 for our council. Values, we picked 4. The first one was
- 11 respect. I want to sing RESPECT... But anyway, respect.
- 12 We will be kind, courteous, avoid interrupting or talking
- 13 over one another or causing disturbances. Think before we
- 14 speak and check our language and tone.
- Thank you, back there. Second, value, integrity. We
- 16 will be honest, accountable, reliable, transparent, and
- 17 ethical in all that we do. Third value, diversity. We
- 18 will promote the representation and participation of
- 19 different groups of individuals, and additionally, we
- 20 will embrace diverse points of view in order to come up
- 21 with sensible solutions to support our communities and
- 22 public safety. And our last value is inclusivity.
- 23 Inclusivity, which means making sure everyone feels
- 24 welcome, valued, and respected, no matter who they are or
- 25 where they come from. Thank you for the amen, back there.



- 1 All right, these are our 2024 goals. Develop the board
- 2 structure, increase membership, construct committees, and
- 3 enhance frequent communication between the 8th Precinct
- 4 and the board. And to plan a community event and holiday
- 5 function.
- 6 So some of the community led crime prevention
- 7 measures, citizens Radio Patrol, are in the Berg Lahser
- 8 community, Grandmont, old Redford and Rosedale Park. If
- 9 anyone here is interested in forming a radio patrol in
- 10 their community, please contact Myra Gracey, Detroit
- 11 Public Safety Headquarters, Chief's Neighborhood Liaison.
- 12 And the number is (313) 596 2520 or
- 13 graciem800@detroitmy.gov. Another community led crime
- 14 prevention measure is to reduce violent crime through
- 15 Community Violence Intervention (CBI), ShotStoppers, and
- 16 Detroit People's Action. Detroit 300 and New Era or ERA
- 17 and how you want to play it. Detroit People's Community.
- 18 There was a 26% decline from November 23rd through
- 19 January, 2024, which is a 3 month period. Detroit 300 in
- 20 the same 3 months did not have a decline. And my
- 21 understanding is they had to go back to the drawing board
- 22 to do some more strategic plan, some more strategic
- 23 measures to make sure that we move the dial in their
- 24 area. And lastly, New Era, well, New ERA, 35% decline in
- 25 the same period, the 3 month period between November,



- 1 2023 and January, 2024. So I'm getting ready to end this.
- 2 All you all could go eat, go home, and watch some TV,
- 3 what have you. But I'm going to say this last thing. We
- 4 do love our 8th Precinct, our beloved 8th Precinct. I'm
- 5 here. Start. We love our Commander Dietrich Lever. We
- 6 love our Captain Brian Bowser, who's going to retire. I
- 7 remember when he was a lieutenant, and then captain, NPO,
- 8 Sergeant Crystal Johns, come on now. NPO, Shawn Childrey
- 9 with that fine haircut she has. Yes. NPO Barron Coleman,
- 10 aka BC, aka Mayor of the 8th Precinct, NPO, Precious
- 11 Reid, NPO, Troy Wesley and NPO, Dario Sharp. We love you.
- 12 So our meetings here for the Community Relations Council
- 13 are generally the last Monday of each month at 6:30 PM
- 14 right here in this auditorium. However, in May we have a
- 15 Memorial Day Holiday. So it's going to be May 20th. June
- 16 is fireworks, so it'll be on June 17th. We convene, have
- 17 meetings from March to November, and then December our
- 18 meeting is the holiday event. We didn't have one last
- 19 year. We will have one this year.
- 20 All right, so we are going to eat good people. Okay.
- 21 Coffee with a Cop. We have here NPO Sergeant Johns, she
- 22 conducts that. That's at 10:00 AM Second Wednesday, bi-
- 23 monthly. The next one will be June 12th. After that
- 24 August 14th, October 9th and December 11th. That is a
- 25 great opportunity for all the individual communities that



- 1 the 8th Precinct serves. They come out and they get
- 2 updated on what's going on with our Precinct, what
- 3 they're doing in our neighborhoods, and bring issues to
- 4 light. So we continually communicate with our people,
- 5 it's a continual thing. And lastly, Commander Lever, he
- 6 did mention the upcoming events. We too are having our
- 7 police appreciation luncheon on May 17th. The Peacenik
- 8 comes back for the 3rd year in a row to my park, O'Hare
- 9 Park on June 29th. National Night Out, August 6th,
- 10 Halloween.
- October 31st is tentative. And again, we hope to
- 12 have that holiday celebration in December to be
- 13 determined on the date and exactly what that looks like.
- 14 So lastly, I'm closing now. I want to thank the Board of
- 15 Police Commissioners. This is the first time I've ever
- 16 experienced this. It is an experience. I want to make
- 17 sure I eat before I come, Okay? We have a little
- 18 something in the back there for you. Yeah, I don't know
- 19 if you guys do that, but here in the 8th Precinct, we eat
- 20 okay, we eat, and we make sure our people eat as well
- 21 because there's something about eating. My mother used to
- 22 say, baby, there are two times, two conditions when
- 23 people are more relaxed. And you can introduce an idea,
- 24 you can maybe even change their mind because they're in a
- 25 relaxed state. One, is at the table when they're eating,



- 1 the other one is on a personal level, but that would be
- 2 pillow talk.
- 3 CHAIRPERSON PRESSLEY: Amen.
- 4 MS. TUBBS: Okay. So I'm done with you all, thank you
- 5 so much for this little bit of time.
- 6 CHAIRPERSON PRESSLEY: Thank you. I really appreciate
- 7 your report. Any questions or comments? And hearing none
- 8 again, we thank you for your report and the amazing work
- 9 you're doing in this community. With that, now we will
- 10 move quickly to new business. Both of the reports from
- 11 our Citizens Complaint Committee and our Policy Report
- 12 have no action items. And so for the second time, I'll
- 13 ask that our colleagues read that. And if you have any
- 14 questions, be prepared to respond to those at our next
- 15 week's meeting. Is there any further new business,
- 16 Commissioner Bernard?
- 17 COMMISSIONER BERNARD: Most of our audience is gone,
- 18 but for those of you who are still here, and certainly
- 19 for my colleagues on the board and in the department, I
- 20 want to wish every woman in the room a Happy Mother's Day
- 21 and a Blessed Mother's Day. And for those persons who are
- 22 present, who are men who have served in the role of both
- 23 mother and father of their children, Happy Mother's Day
- 24 to you as well. Happy Parents' Day. Thank you.
- 25 CHAIRPERSON PRESSLEY: Any new business Commissioner



- 1 Moore?
- 2 COMMISSIONER MOORE: Yes. Very quickly, Mr. Chairman.
- 3 I know we accepted the resignation of Commissioner
- 4 Gamble.
- 5 CHAIRPERSON PRESSLEY: Yes.
- 6 COMMISSIONER MOORE: Has the mayor given any
- 7 timetable when he's going to replace?
- 8 CHAIRPERSON PRESSLEY: No.
- 9 COMMISSIONER MOORE: Thank you.
- 10 CHAIRPERSON PRESSLEY: Any further new business?
- 11 Hearing none, the Chair entertains a motion for
- 12 adjournment.
- 13 COMMISSIONER BERNARD: So move.
- 14 CHAIRPERSON PRESSLEY: Is there a second?
- 15 COMMISSIONER HERNANDEZ: It's been properly moved and
- 16 second. All those in favor, please signify by saying,
- 17 "Aye."
- 18 COMMISSIONERS: "Aye."
- 19 CHAIRPERSON PRESSLEY: All those opposed? "No." The
- 20 "Ayes" have it. This meeting is adjourned. Thank you.
